The ornamental design for a pillow blanket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and top perspective view of a pillow blanket, in accordance with an aspect of the new design;

FIG. 2 is a front elevation view thereof, the front elevation view being substantially the same as the left elevation view, rear elevation view, and right elevation view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top plan view thereof, in accordance with a second configuration of the new design;

FIG. 5 is a front and left perspective view thereof, in accordance with a third configuration of the new design;

FIG. 6 is a front elevation view thereof, in accordance with a fourth configuration of the new design;

FIG. 7 is a left elevation view thereof, the right elevation view being substantially the same as the left elevation view thereof;

FIG. 8 is a rear elevation view thereof;

FIG. 9 is a front and top perspective view of a pillow blanket, in accordance with a second embodiment of the new design;

FIG. 10 is a front elevation view thereof, the front elevation view being substantially the same as the left elevation view, rear elevation view, and right elevation view thereof;

FIG. 11 is a bottom plan view thereof;

FIG. 12 is a top plan view thereof, in accordance with a second configuration of the second embodiment;

FIG. 13 is a front and left perspective view thereof, in accordance with a third configuration of the second embodiment;

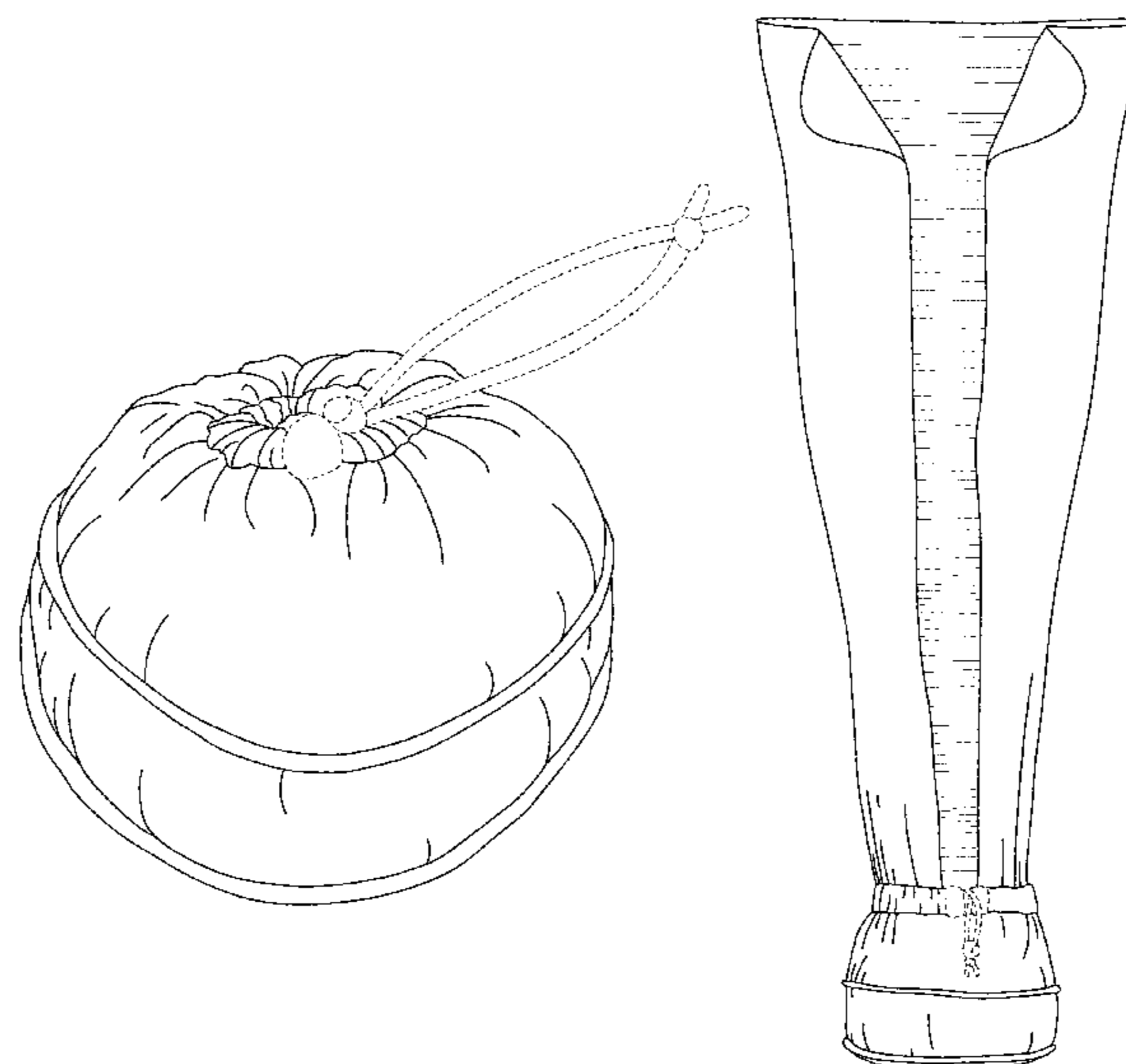
FIG. 14 is a front elevation view thereof, in accordance with a fourth configuration of the second embodiment;

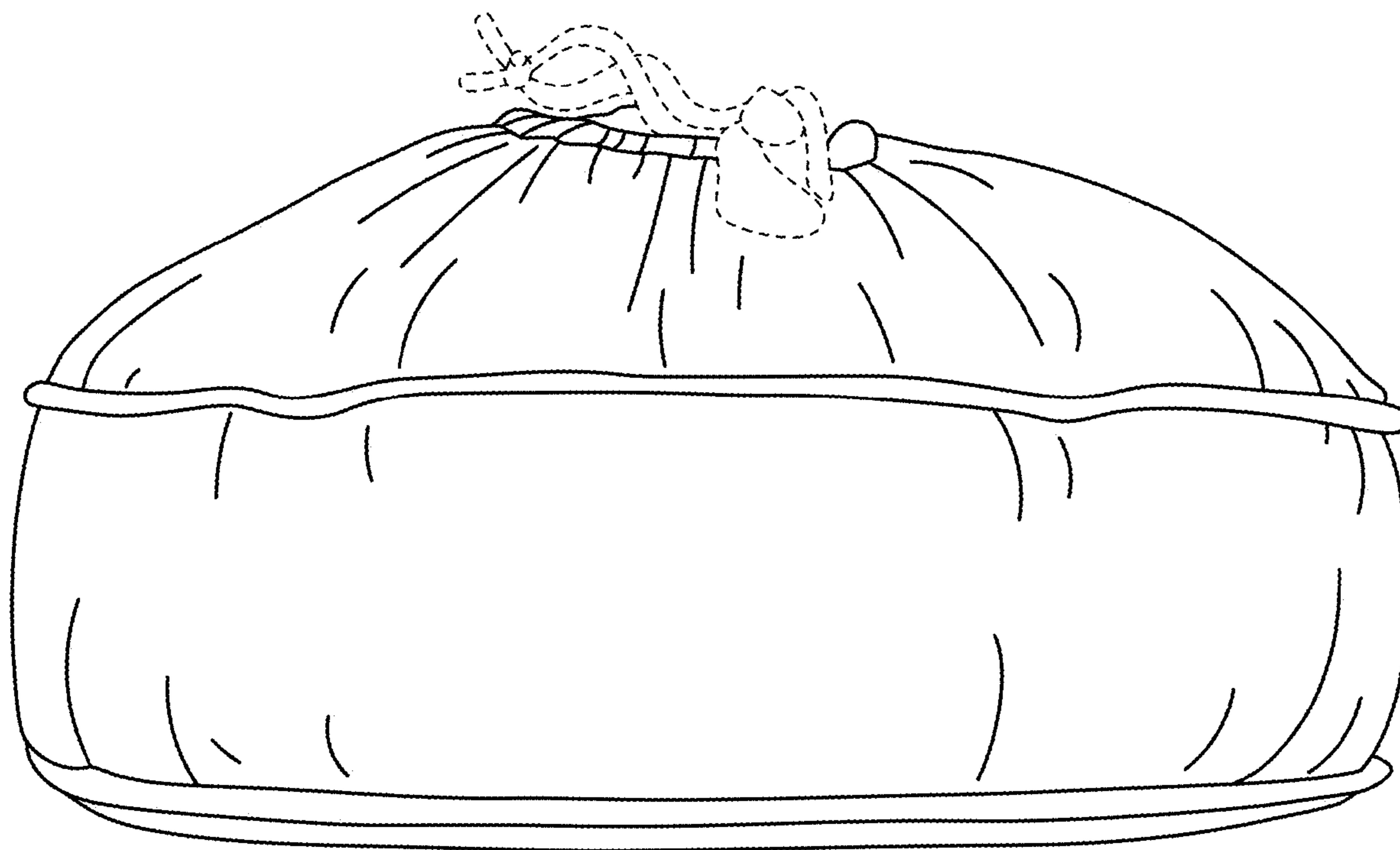

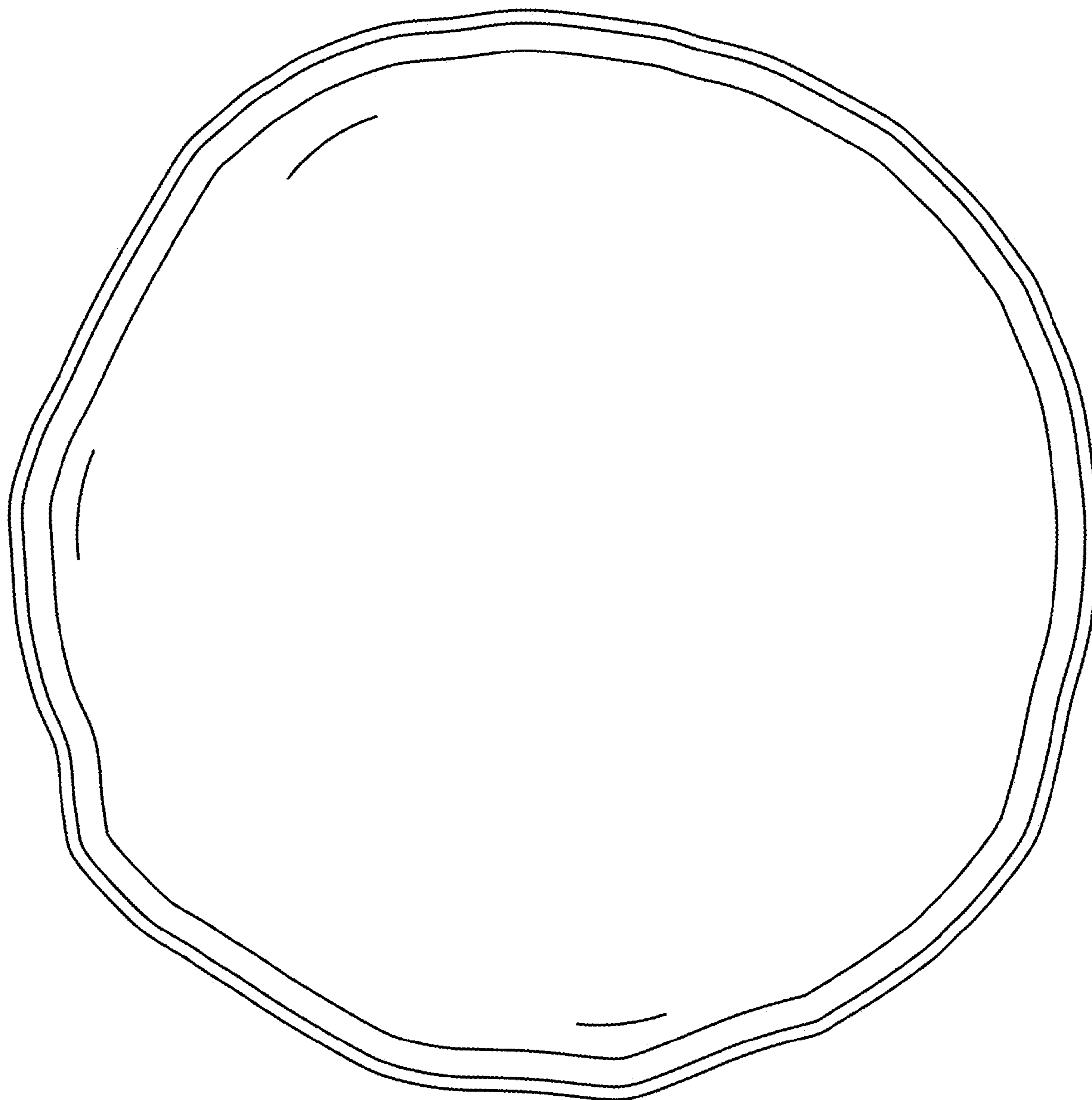

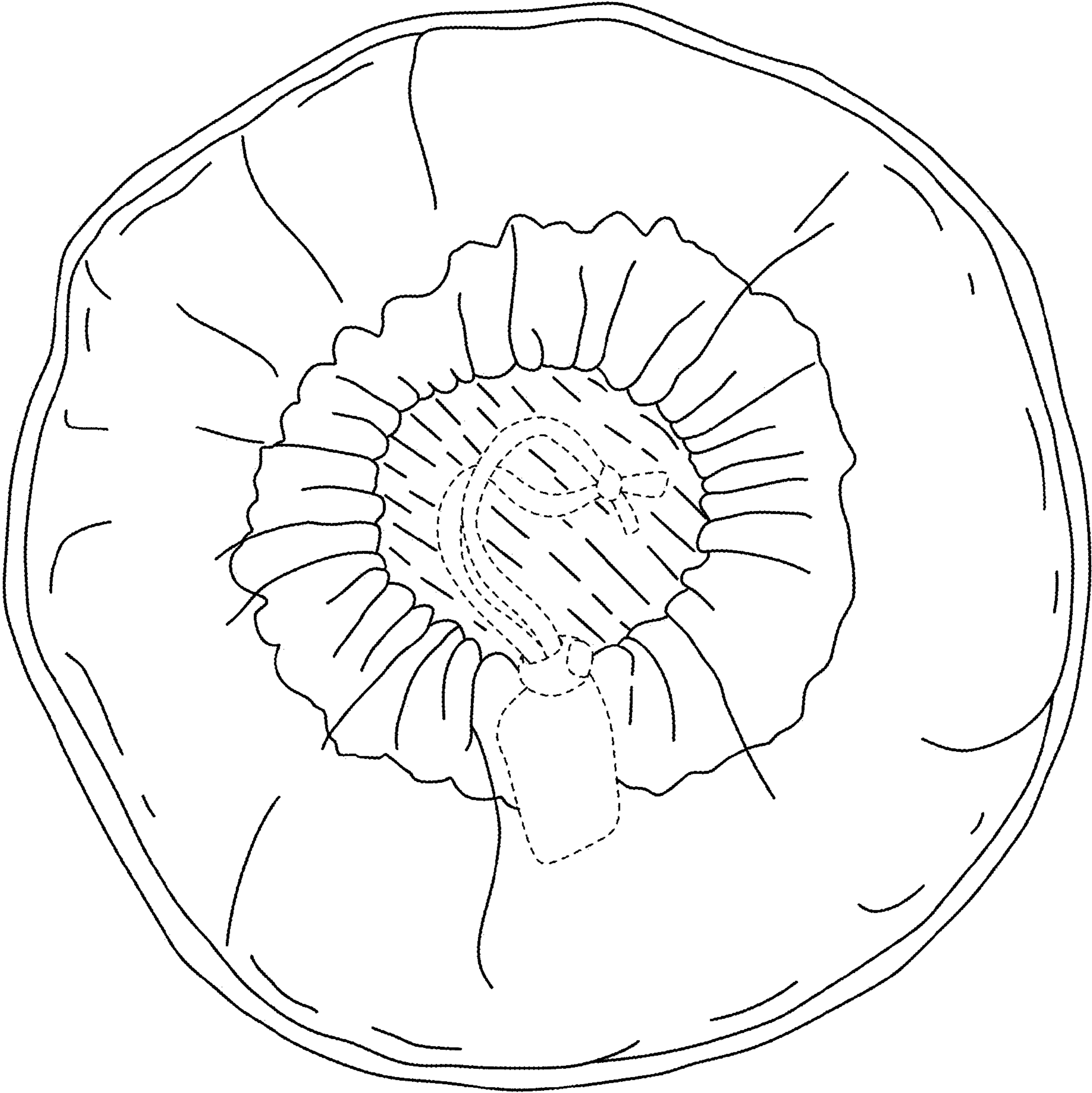

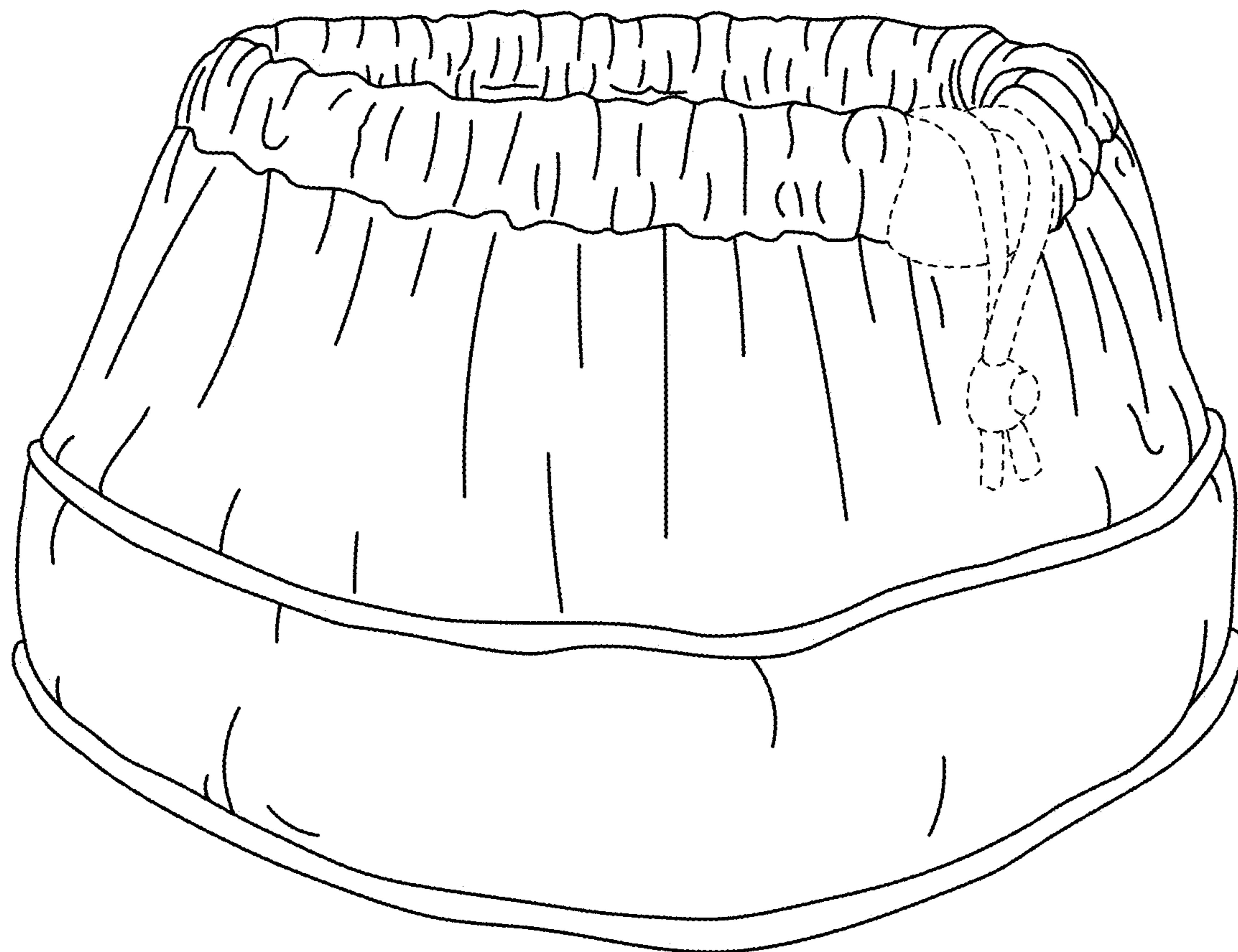

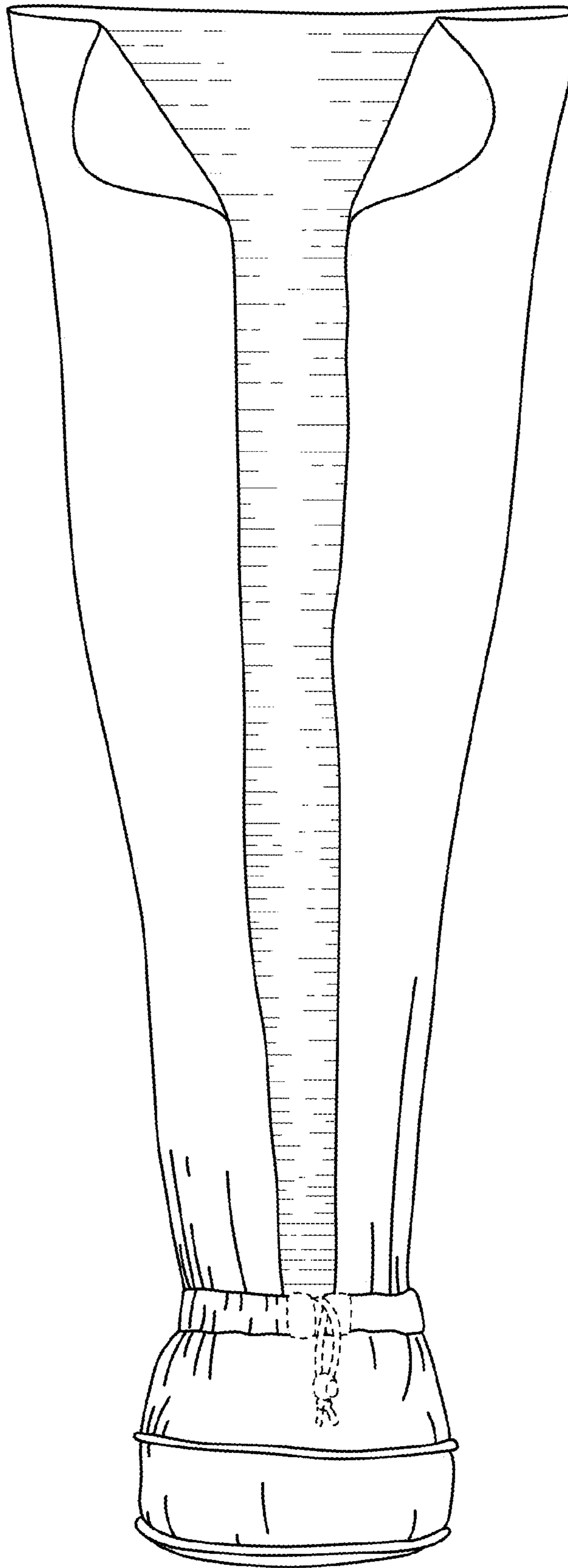

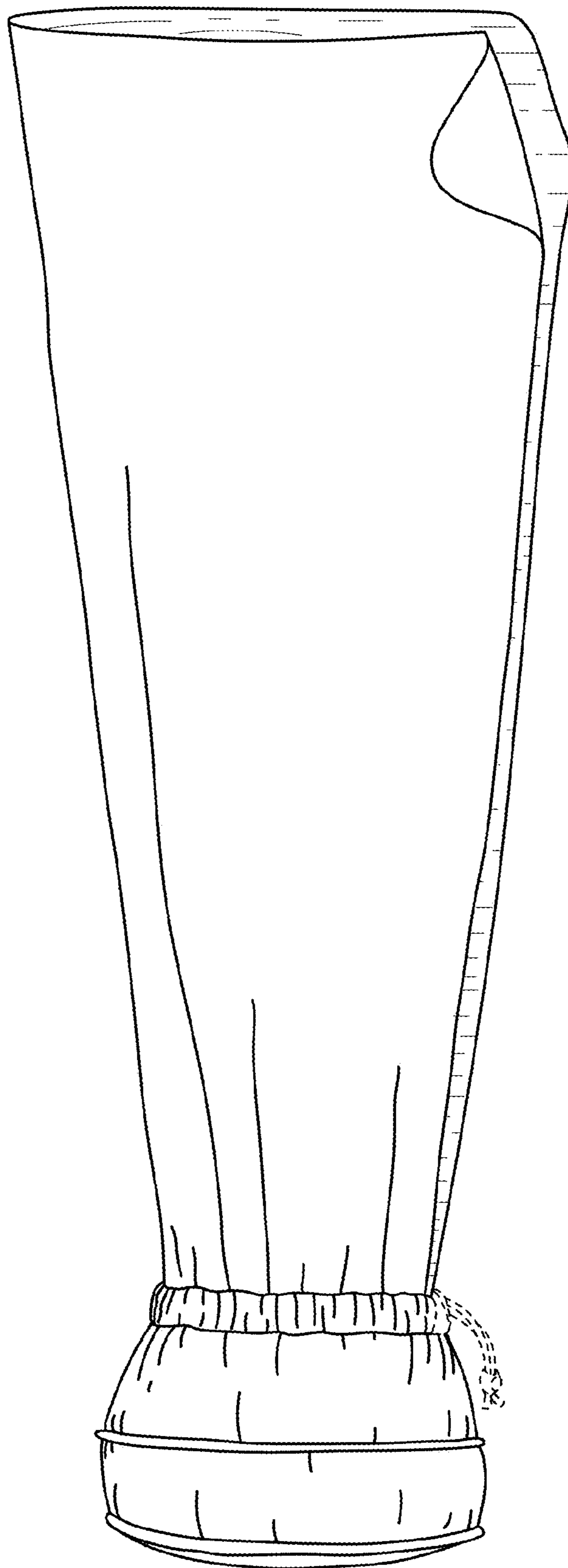

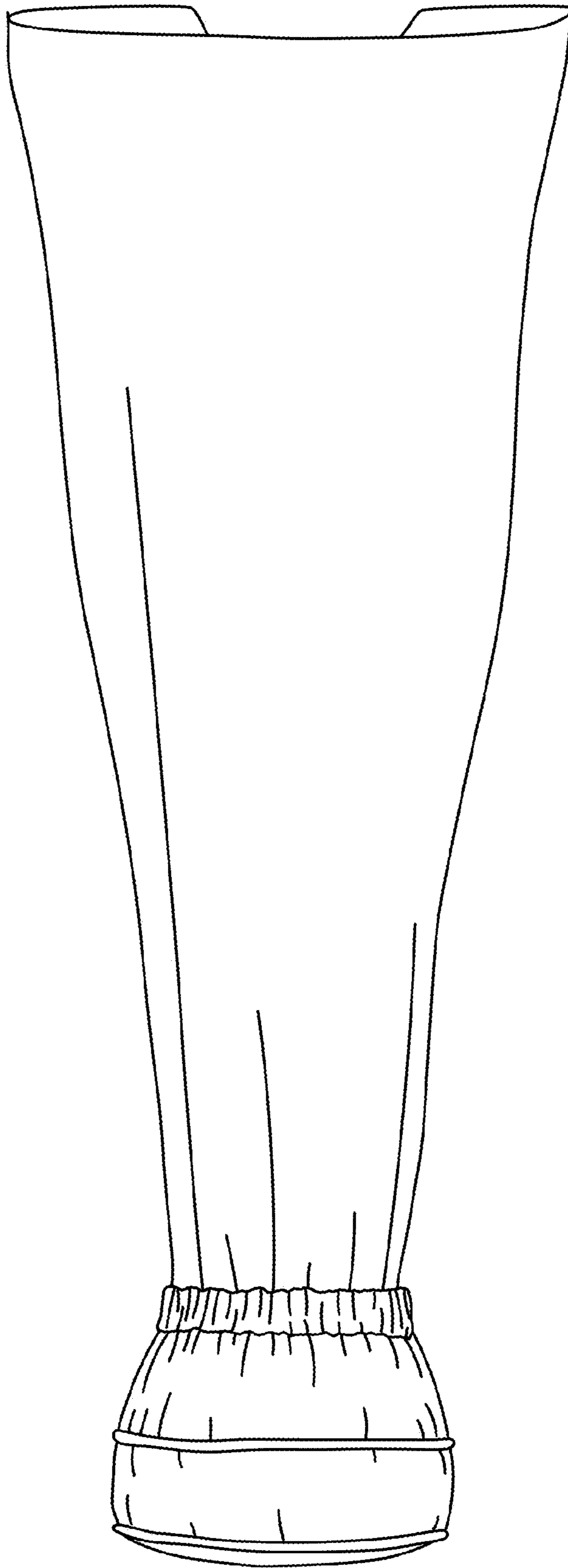

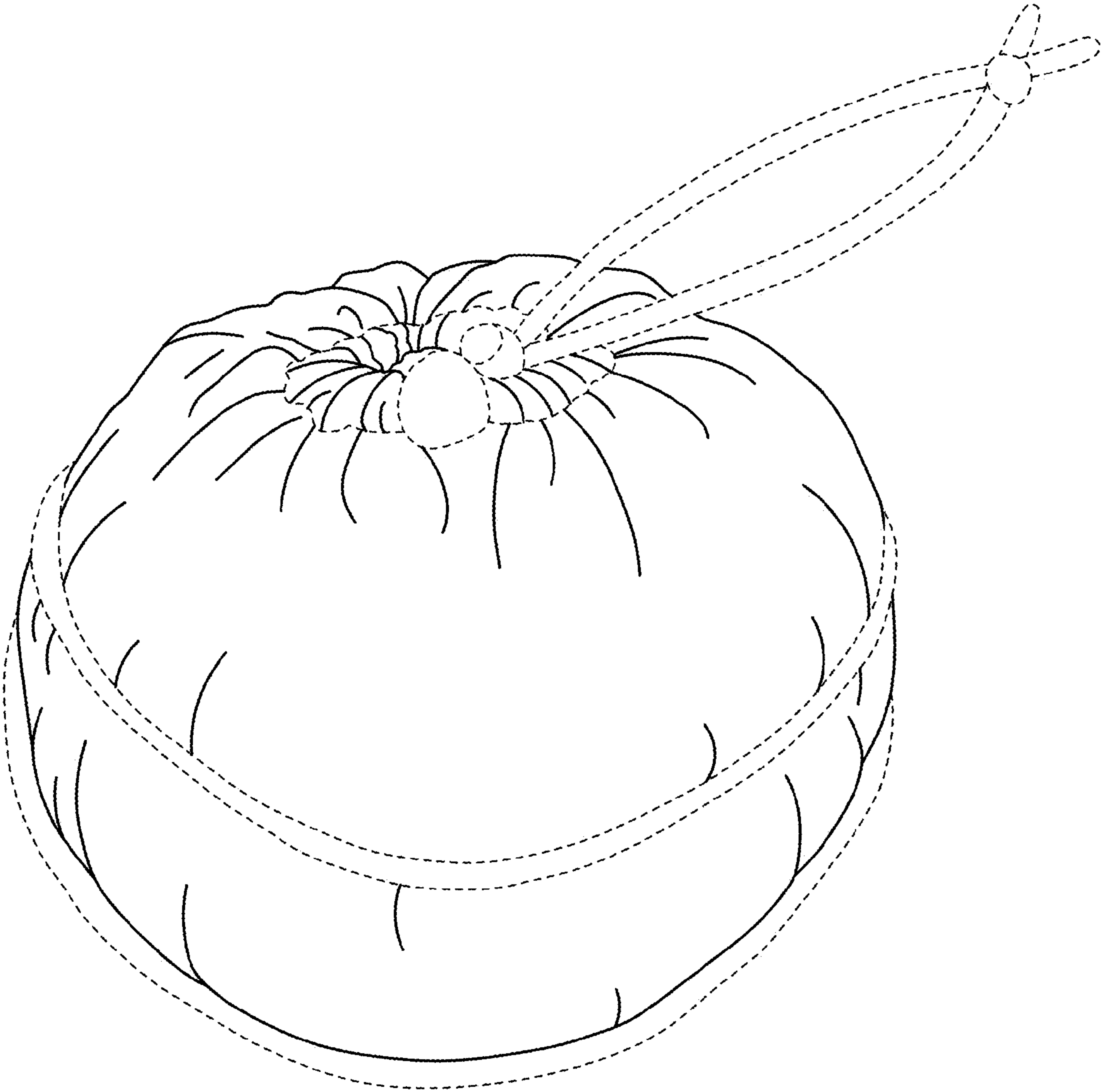




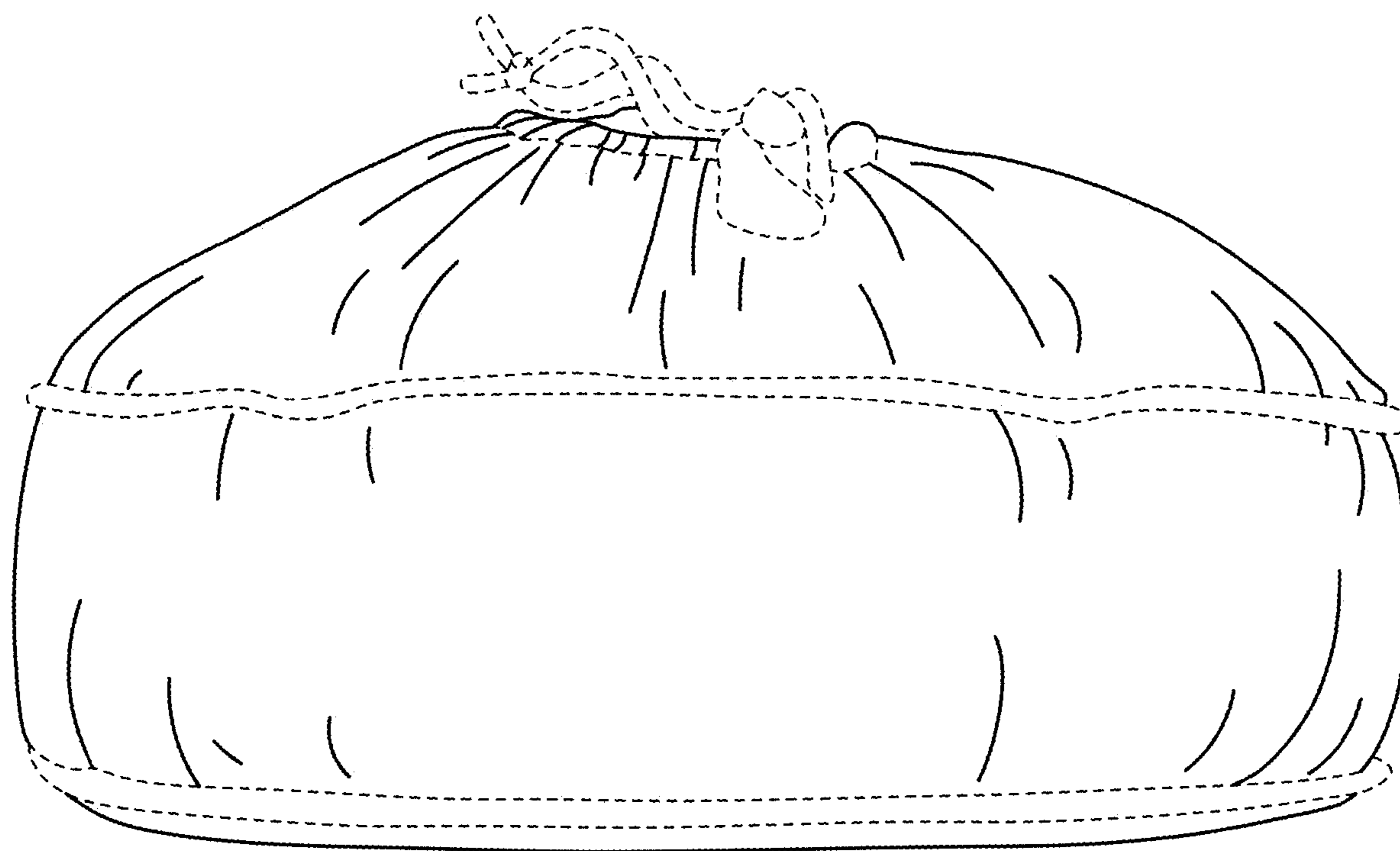

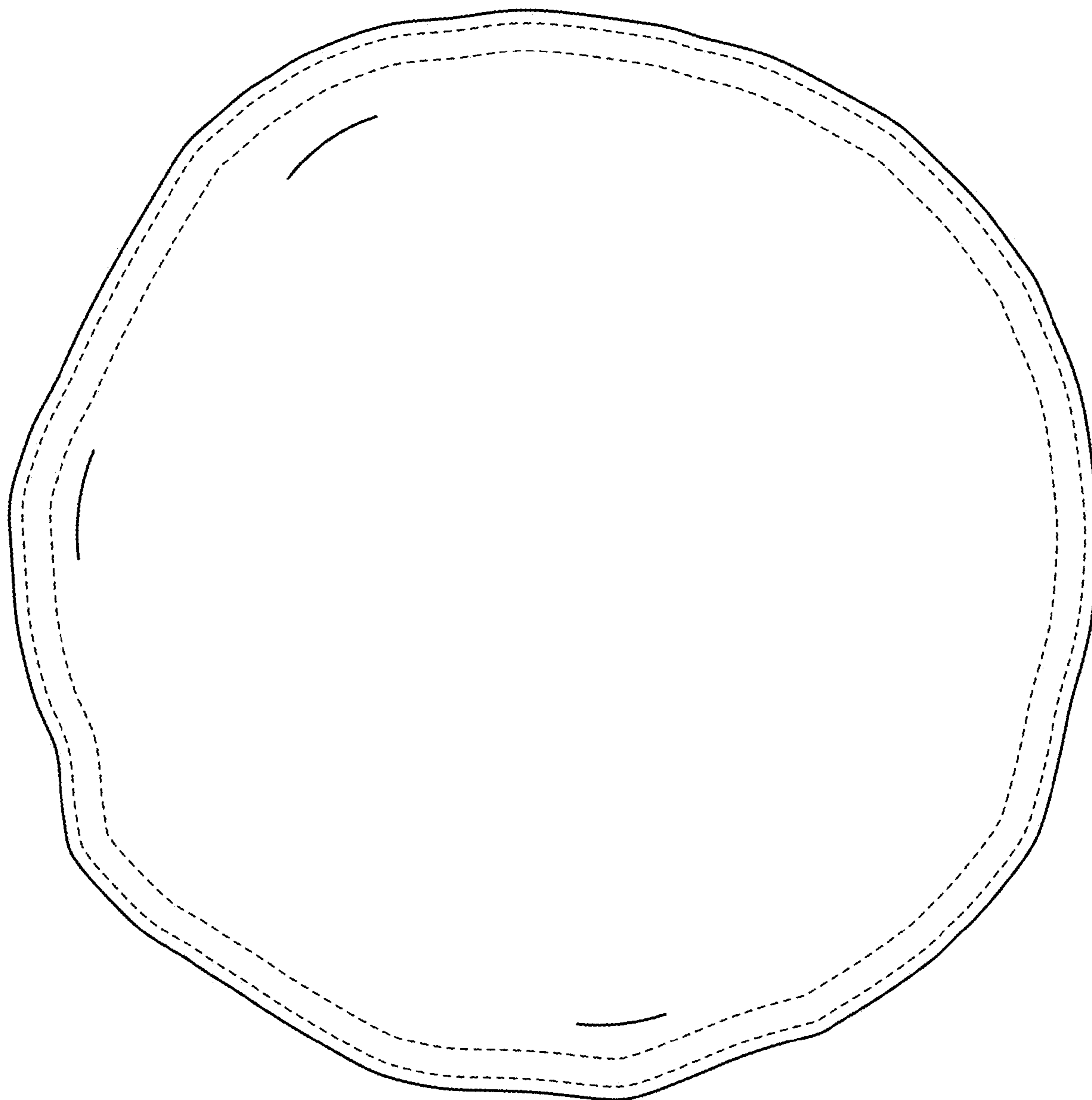

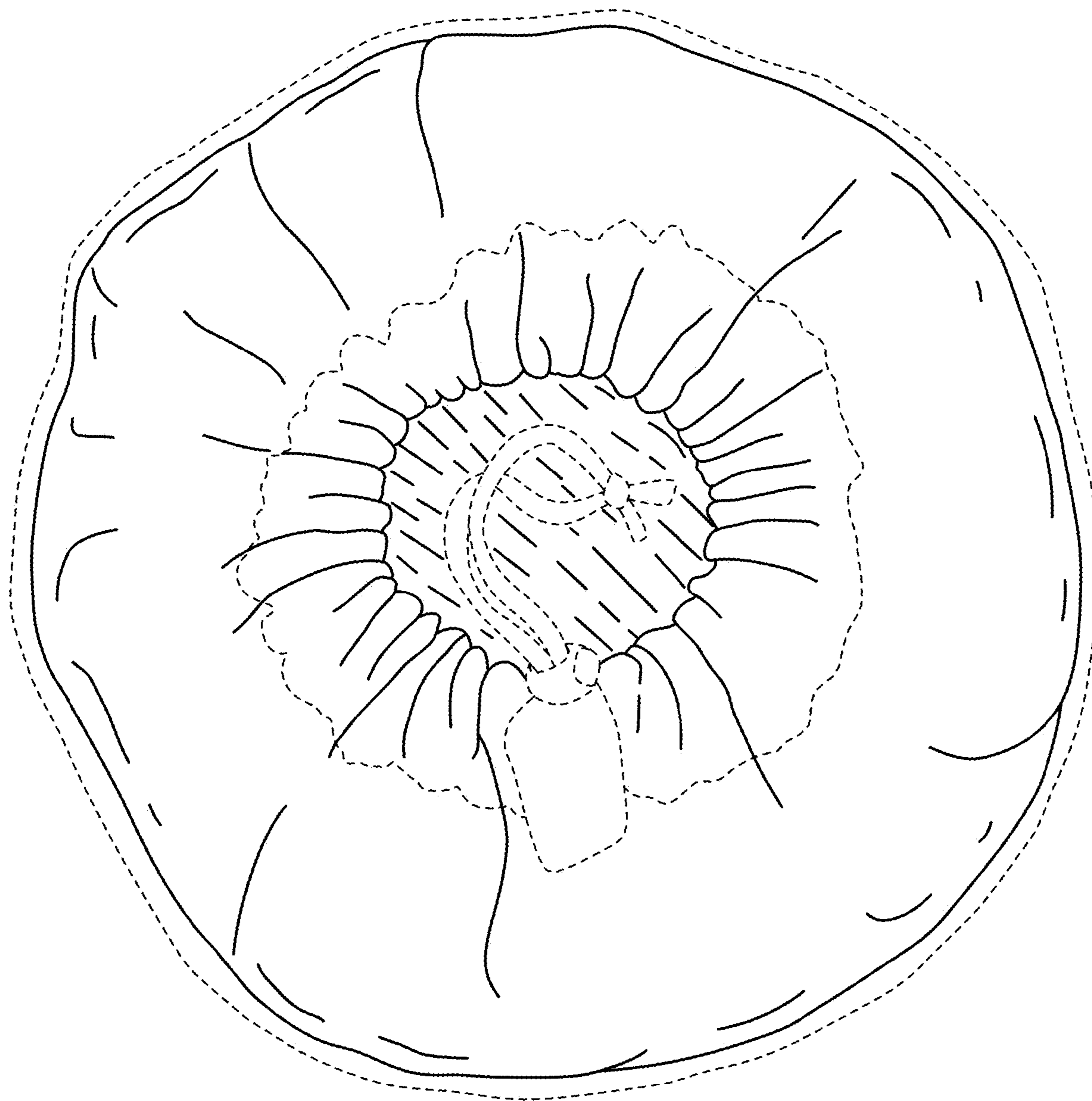

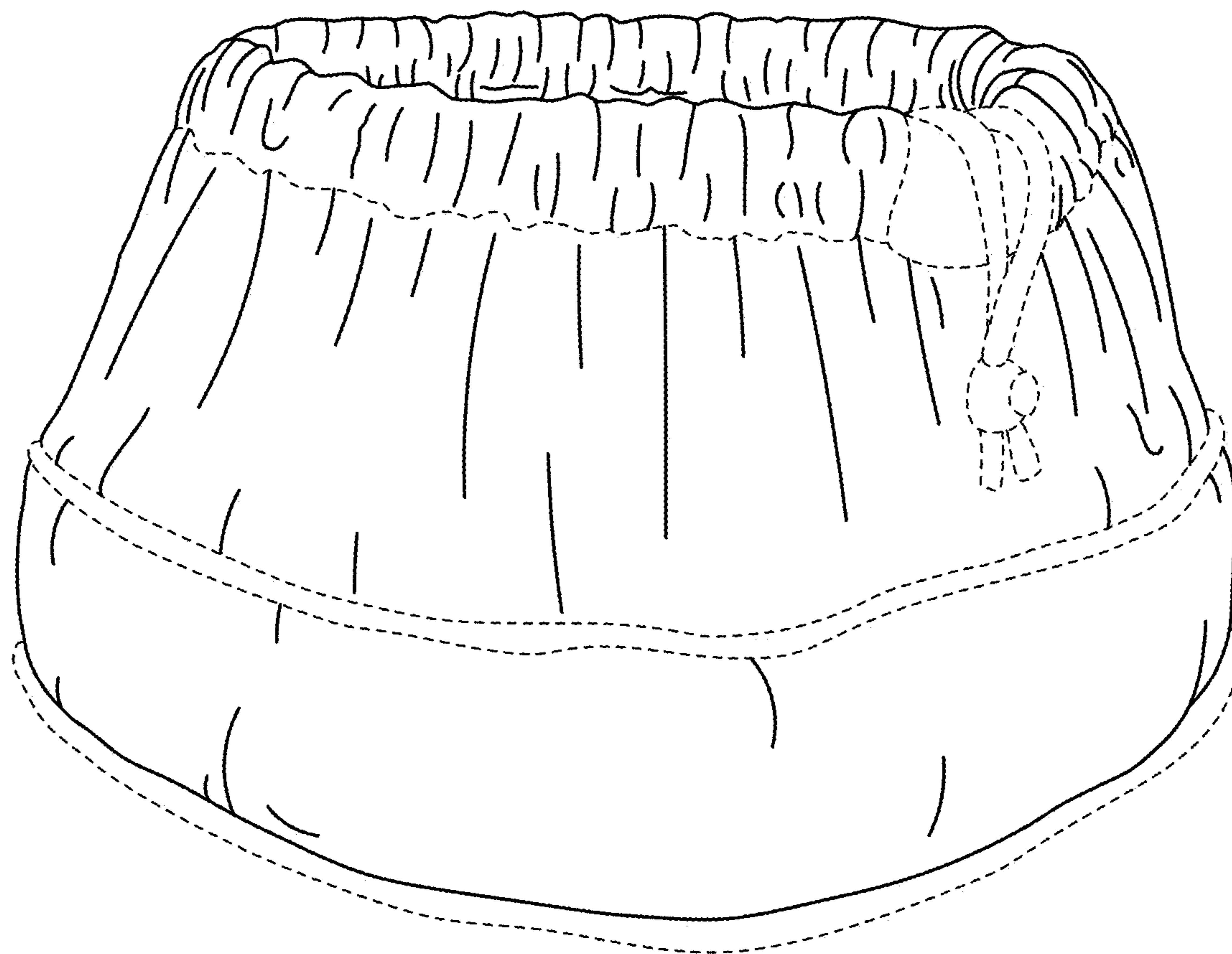

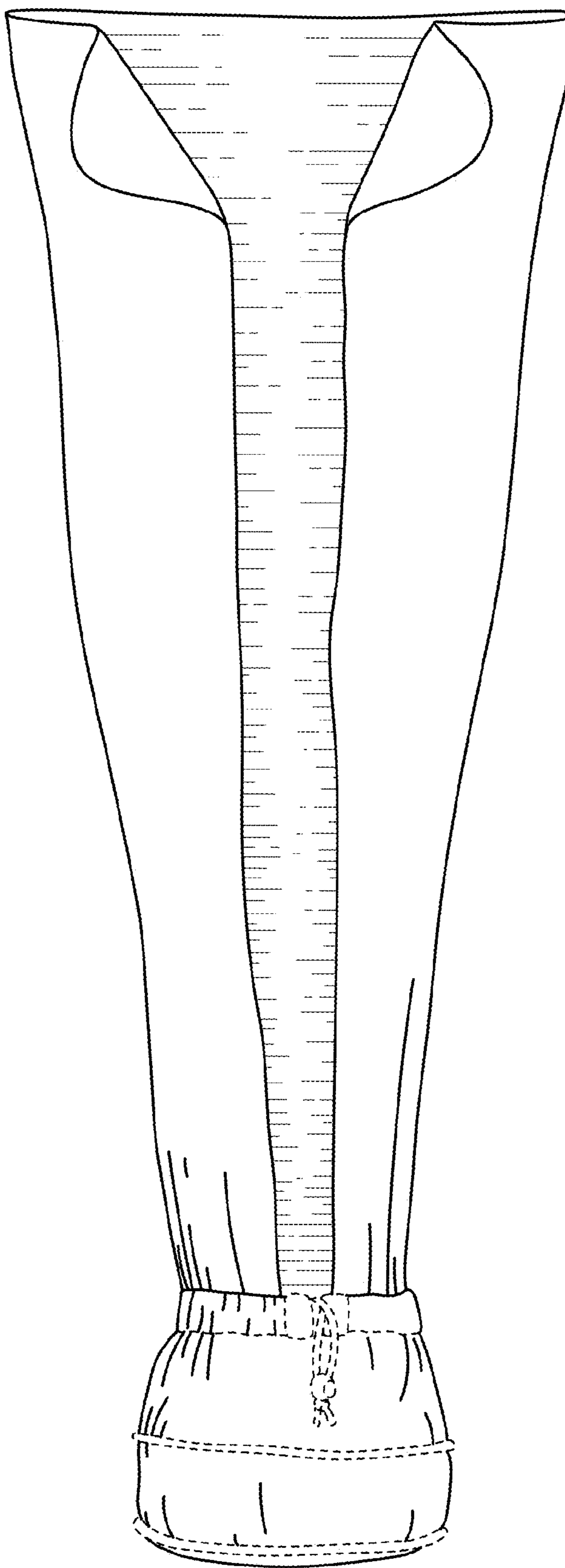




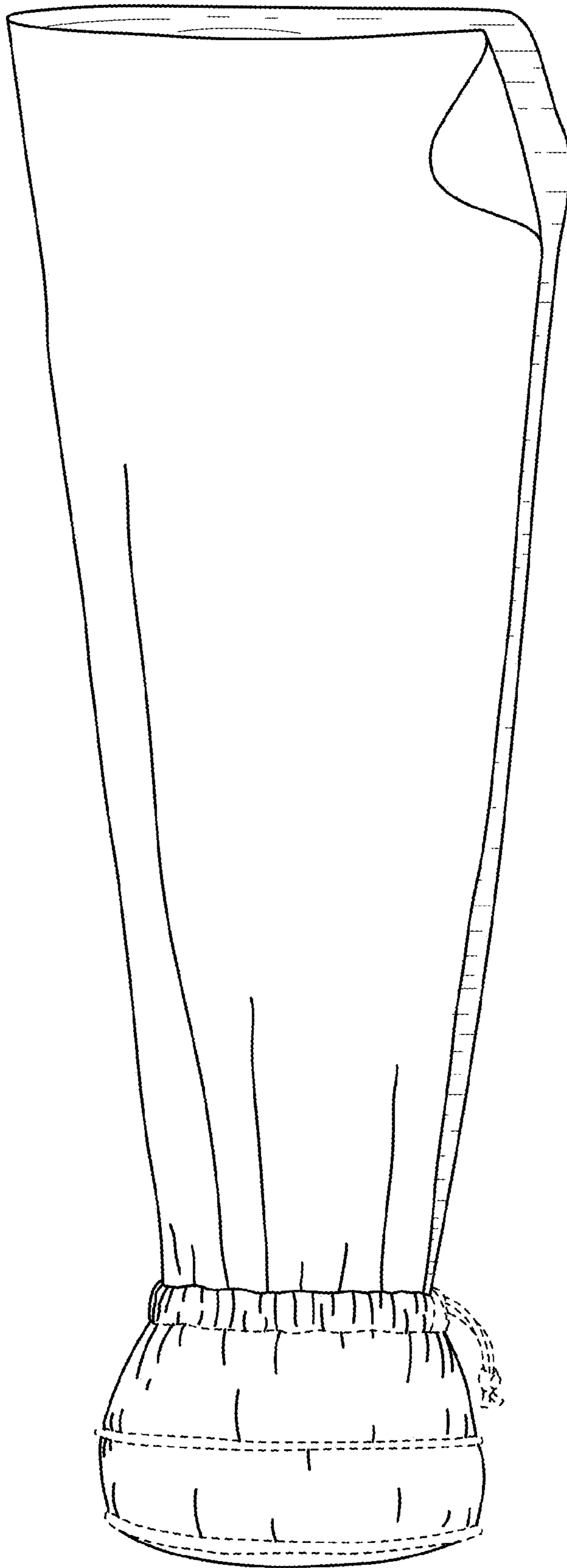

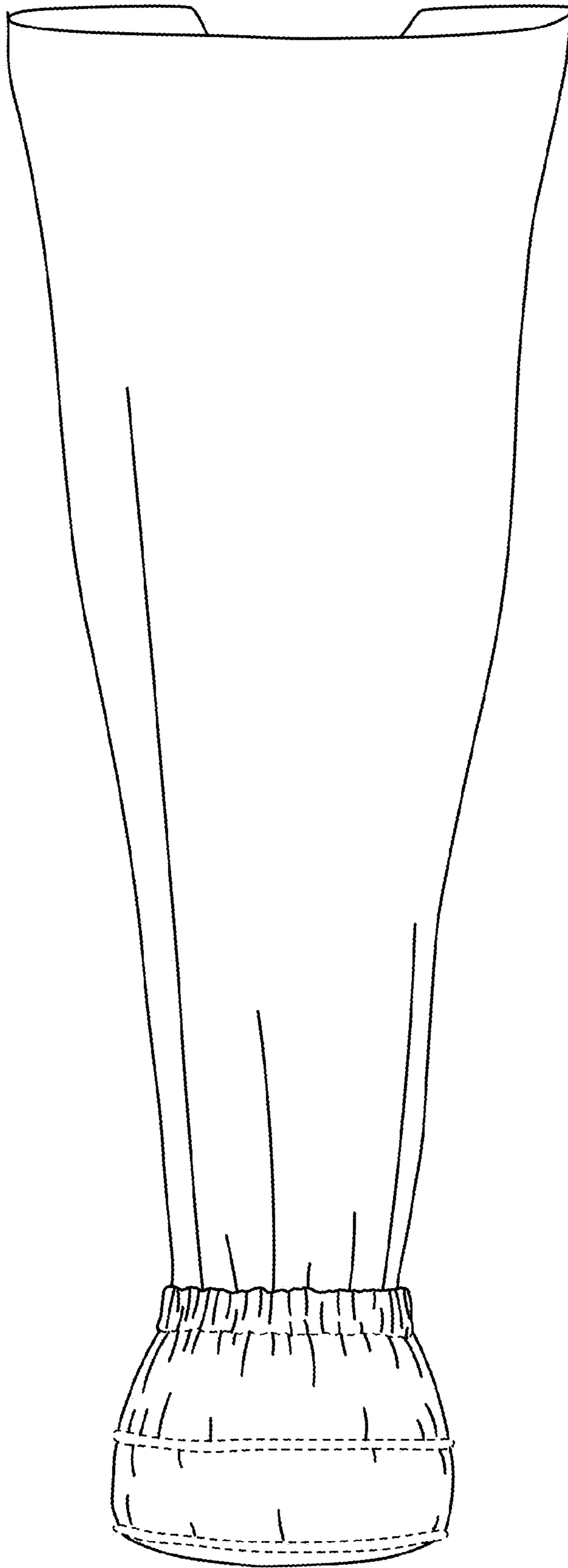
