**DESCRIPTION**

FIG. 1 is a front perspective view of a table according to the new design;

FIG. 2 is a rear perspective view thereof;

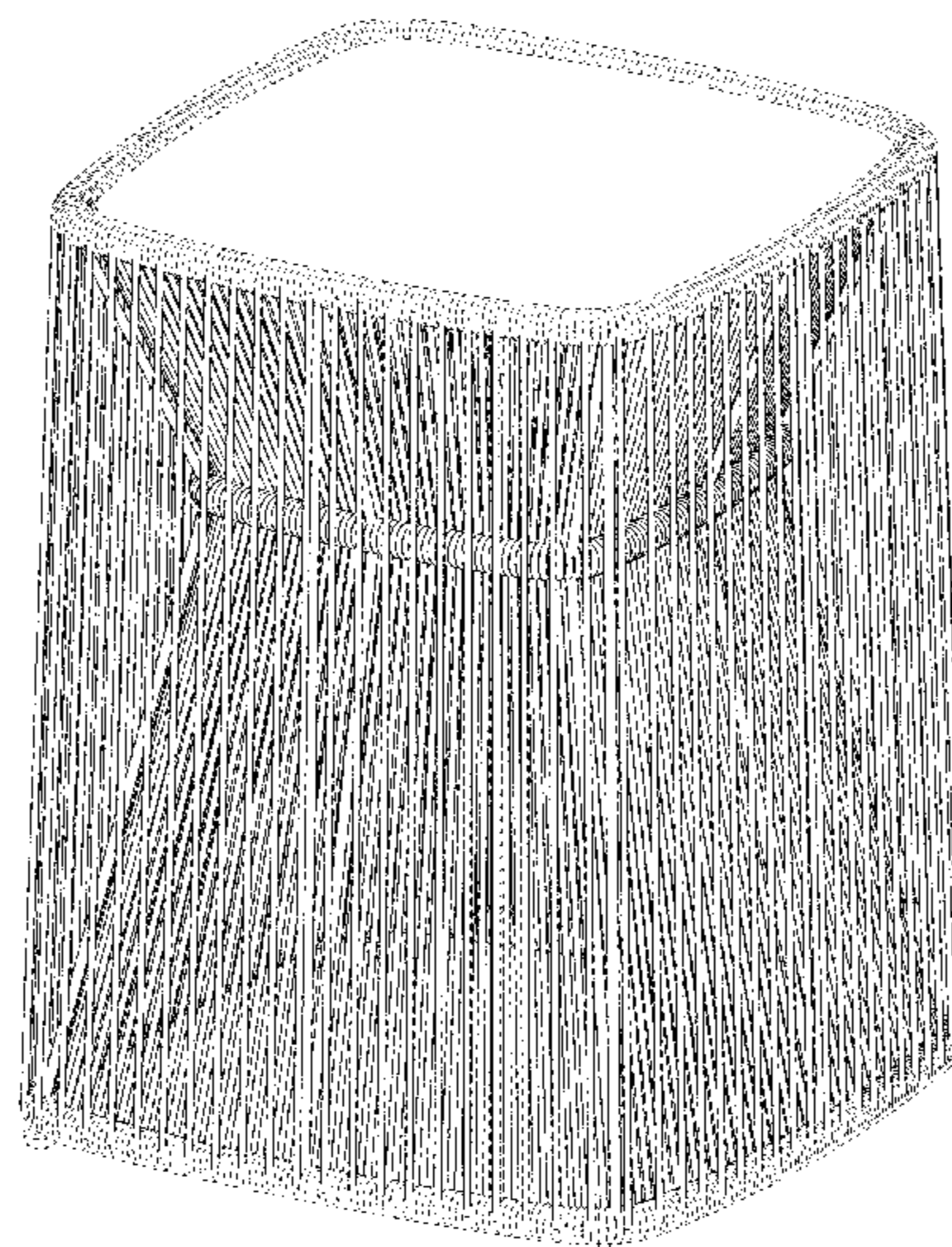
FIG. 3 is a front view thereof, the rear, left side, and right side views being identical to the front view;

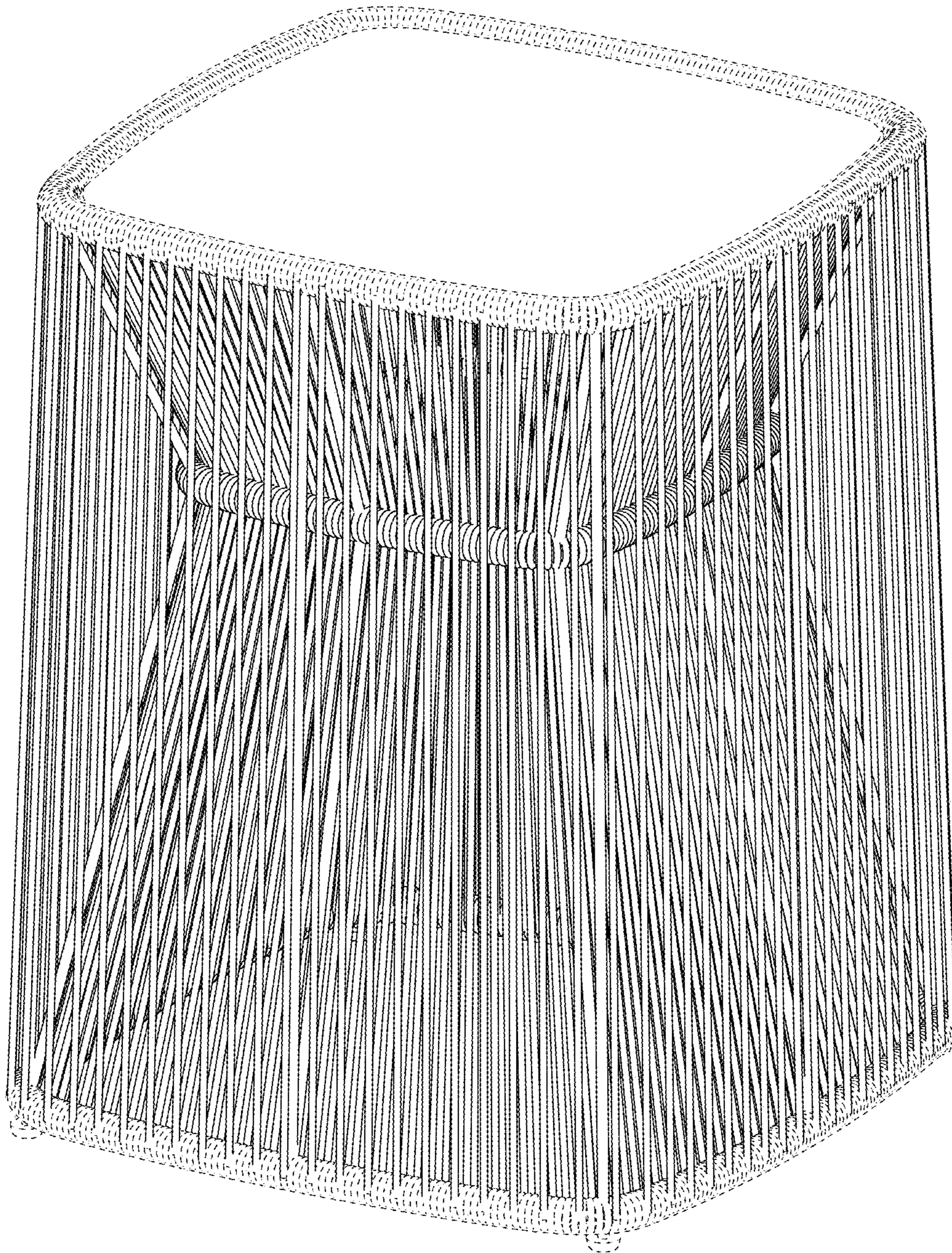

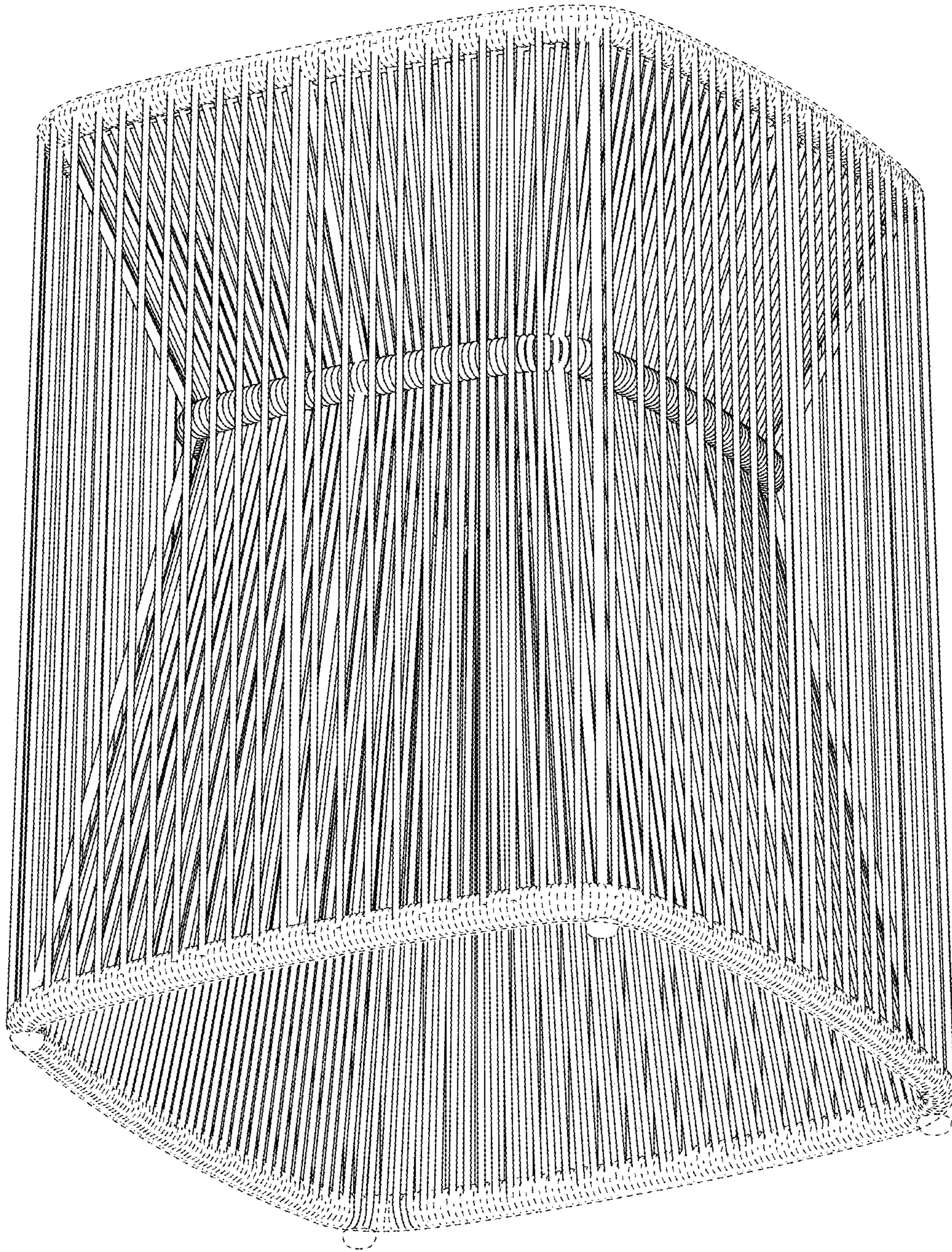

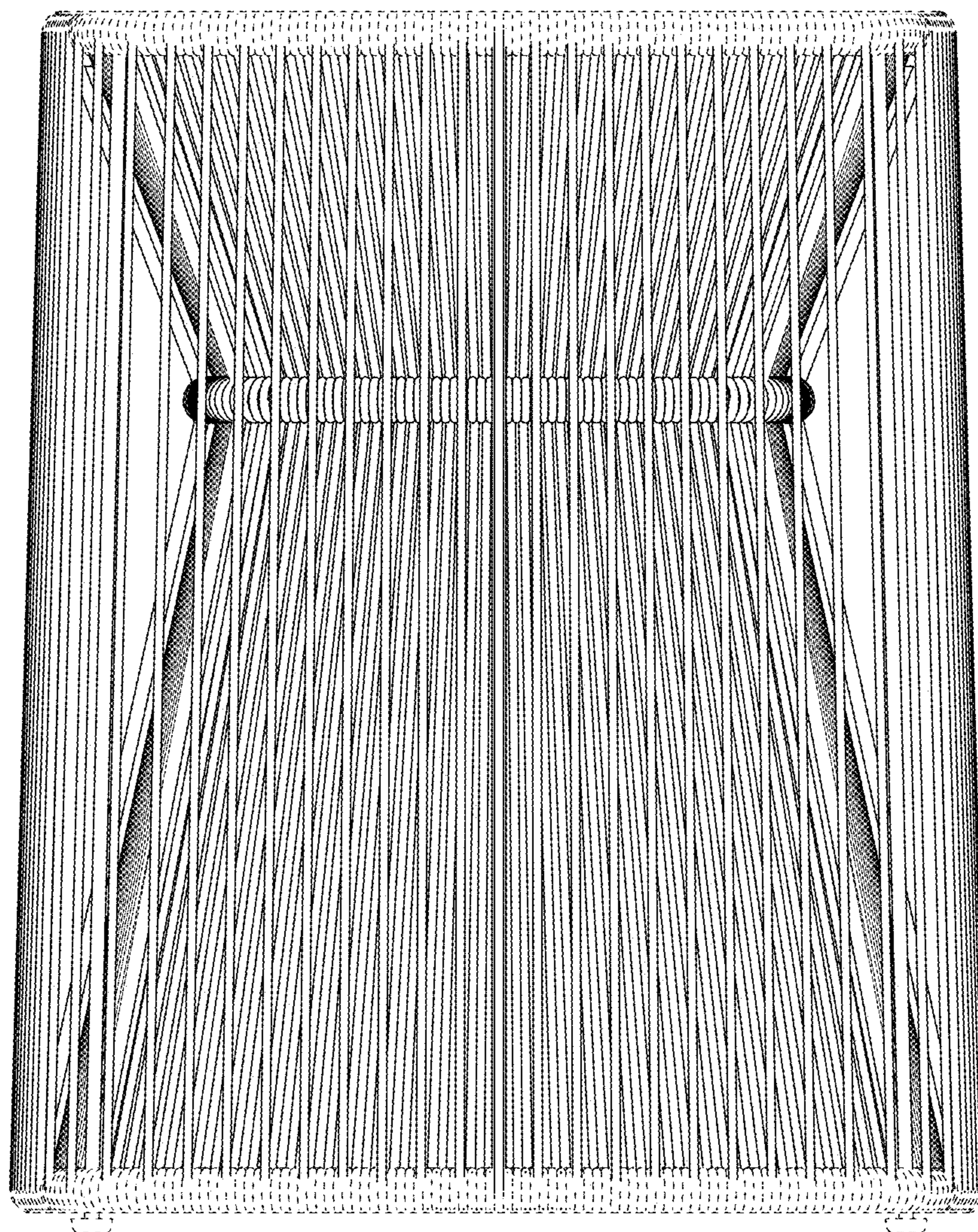

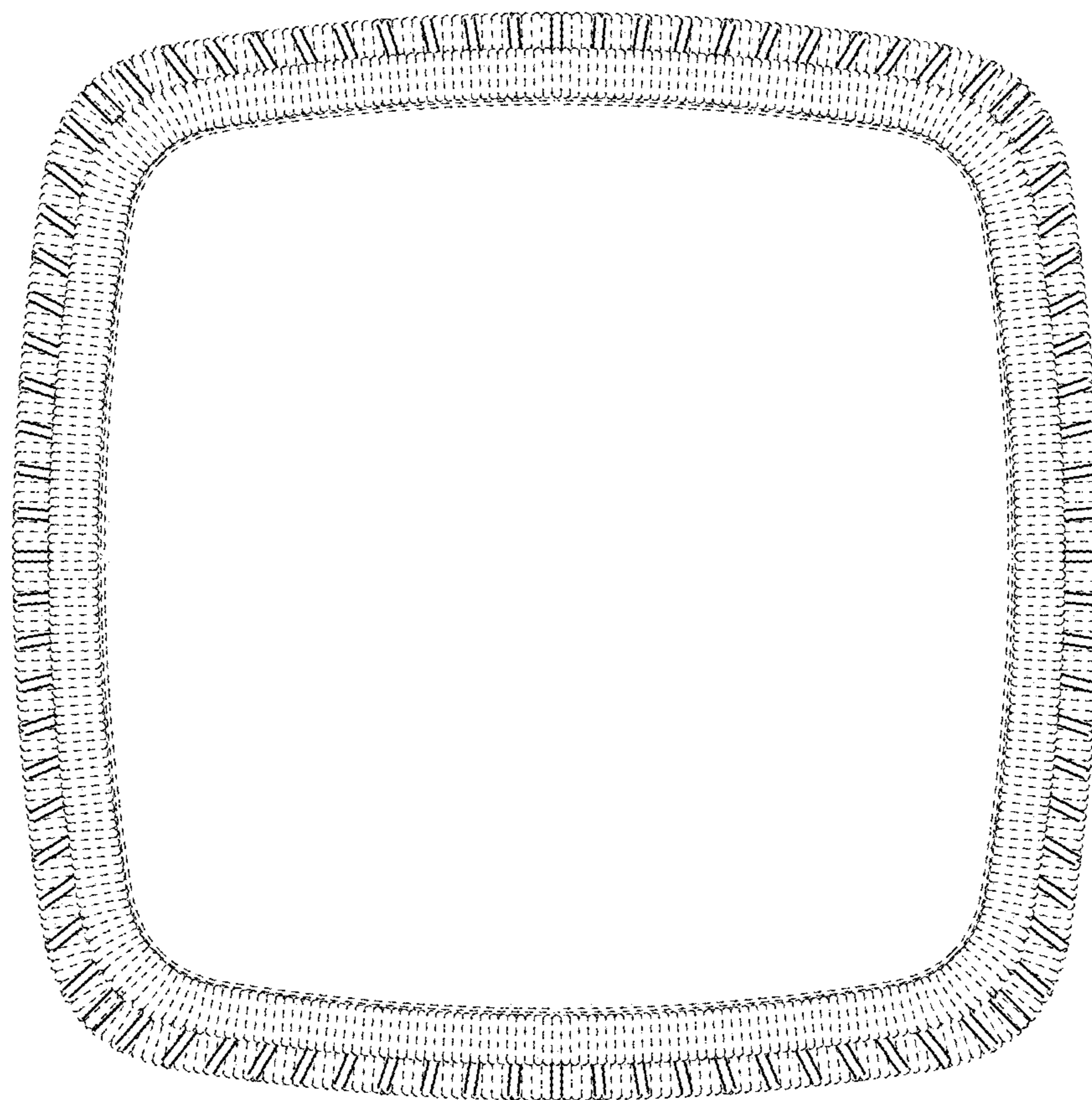

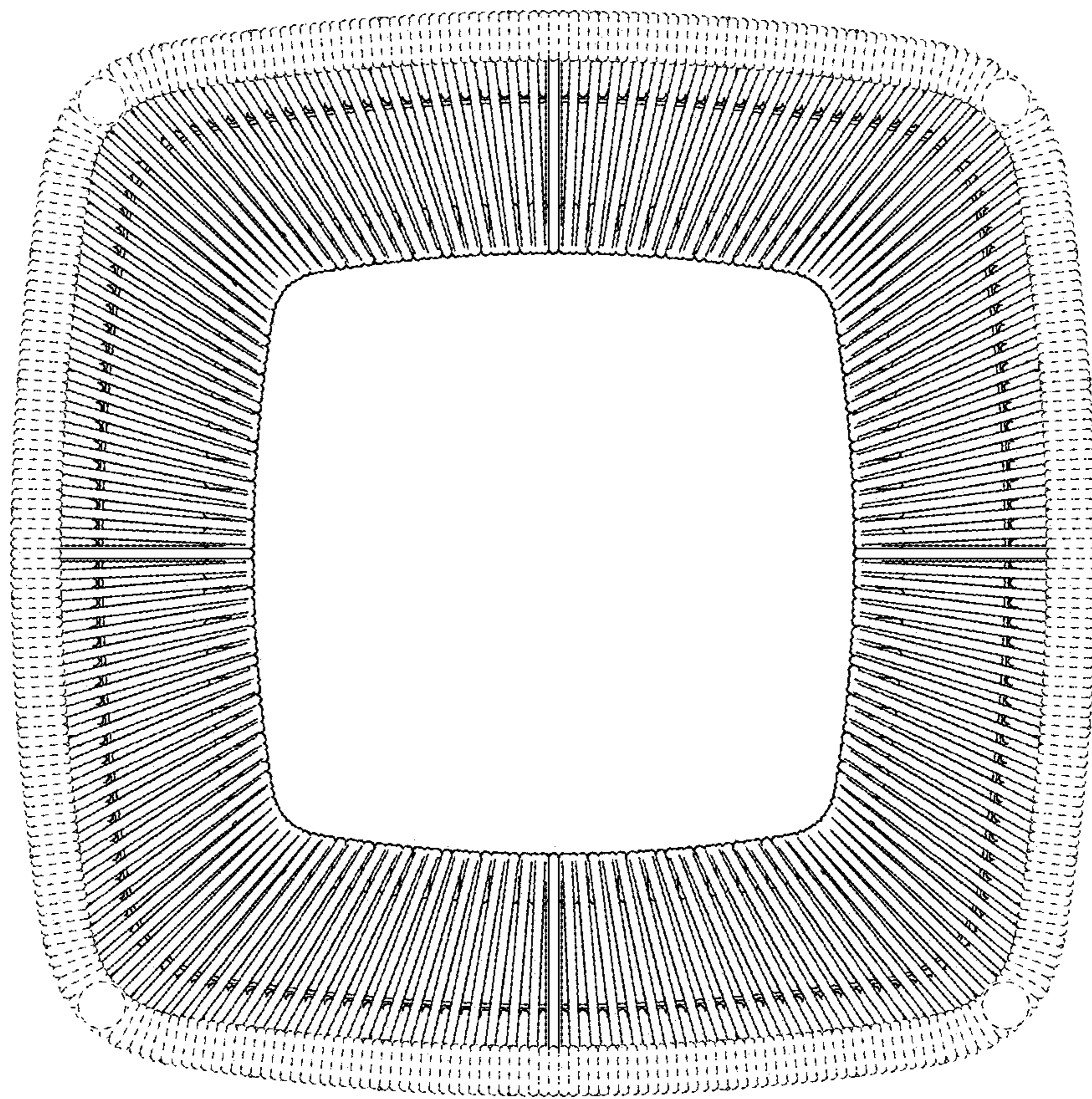
