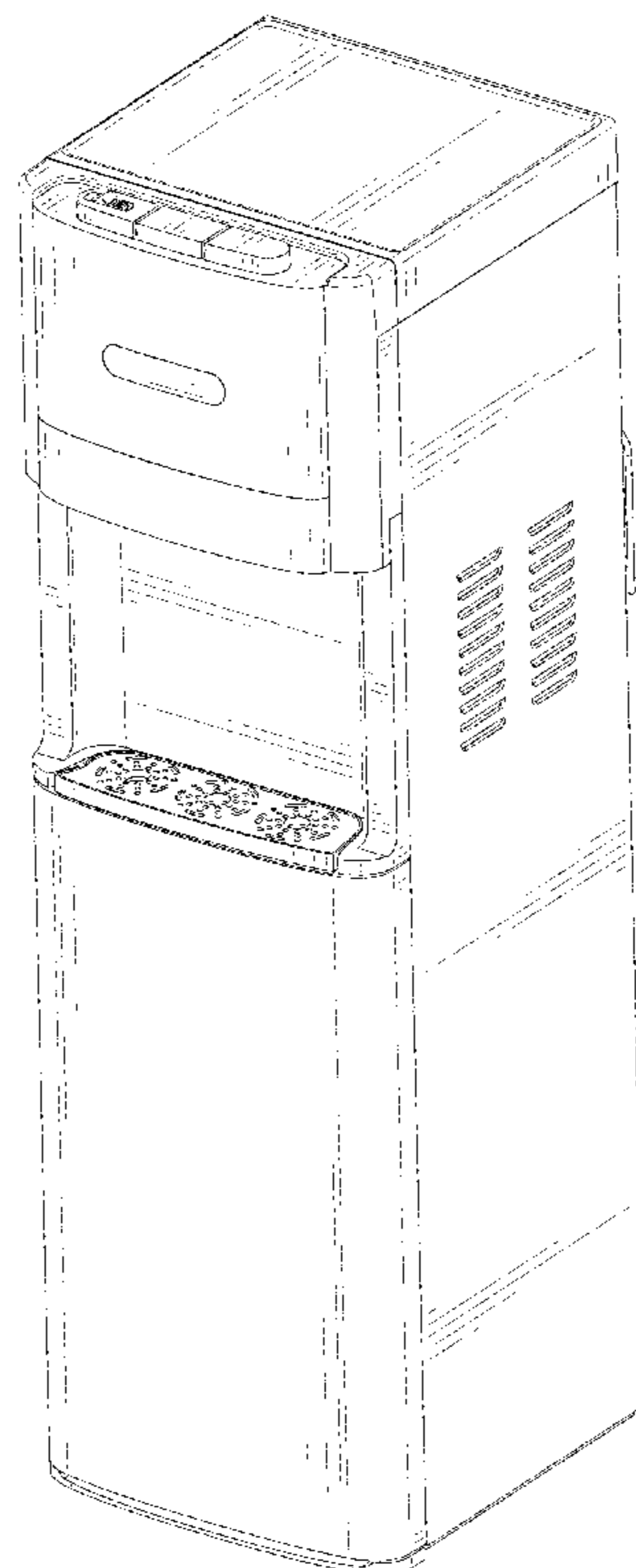
(57) **CLAIM**

DESCRIPTION

FIG. 1 is perspective view of a water dispenser, showing our new design;

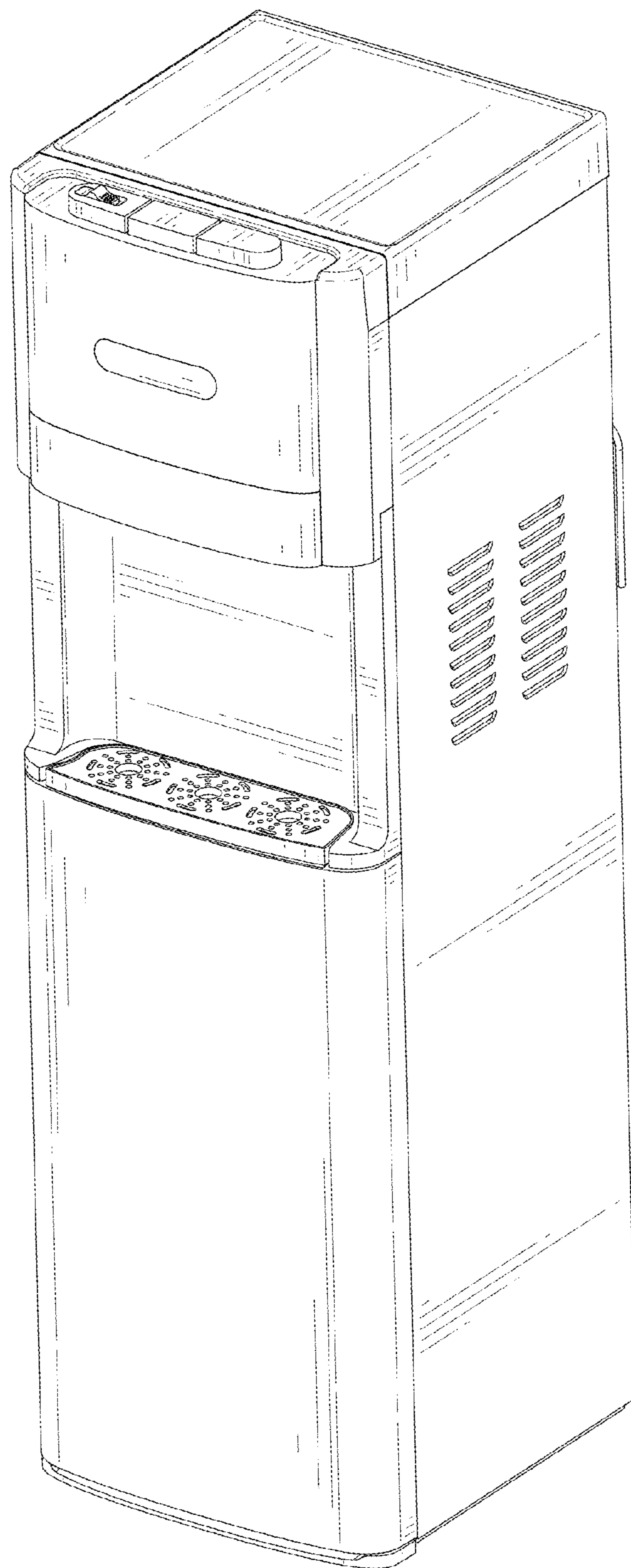

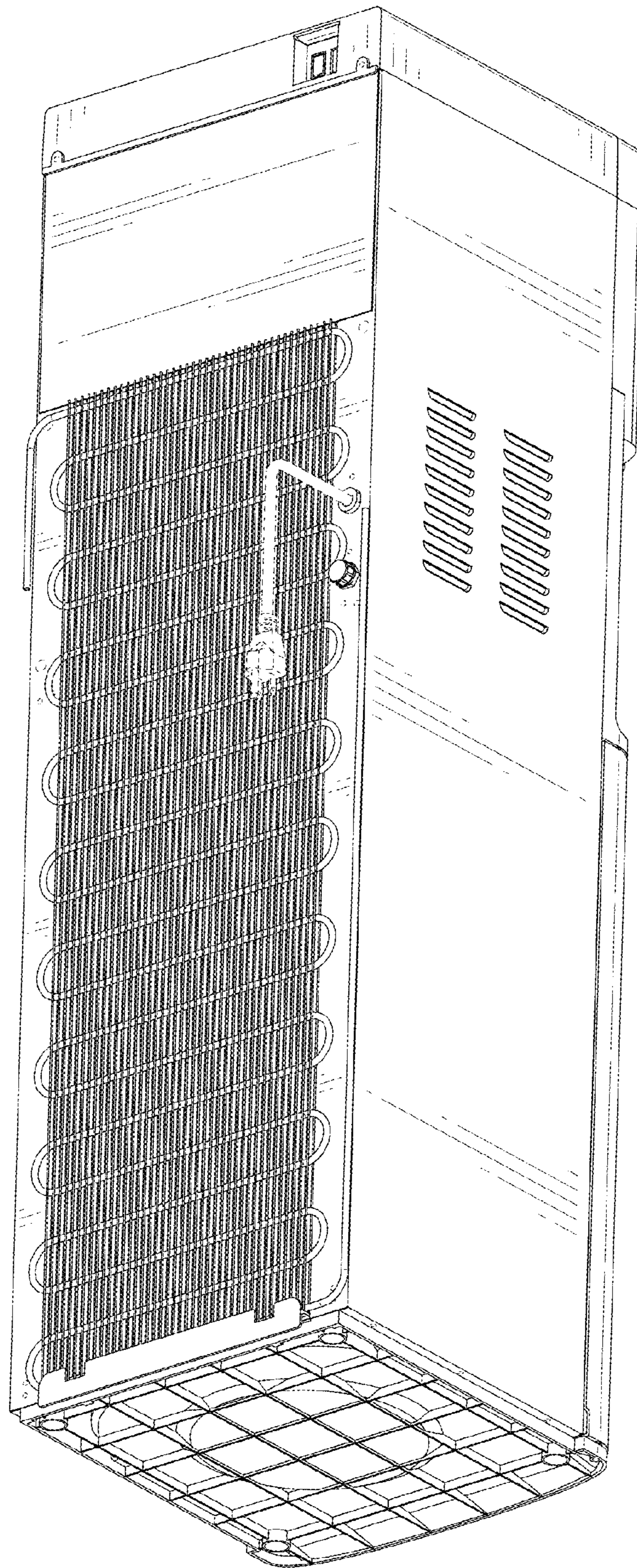

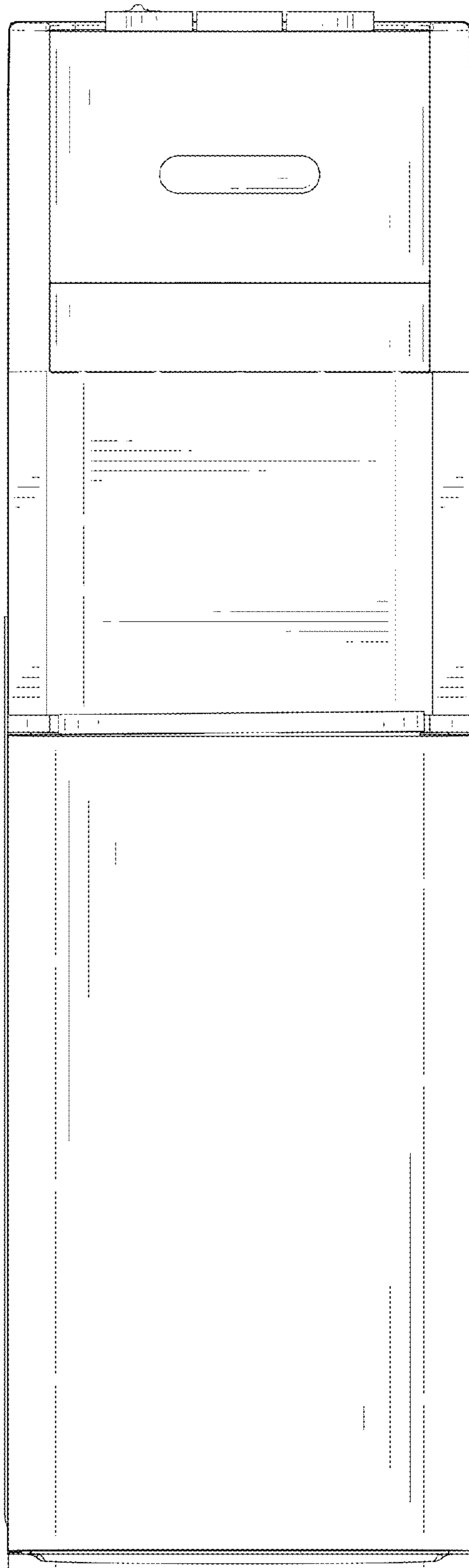

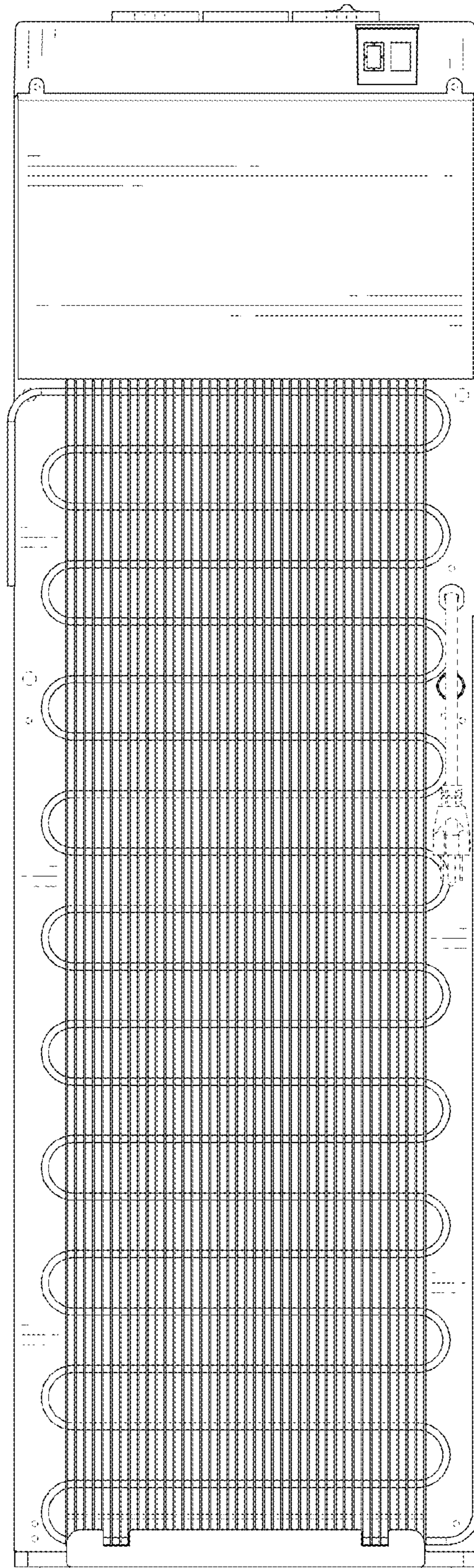

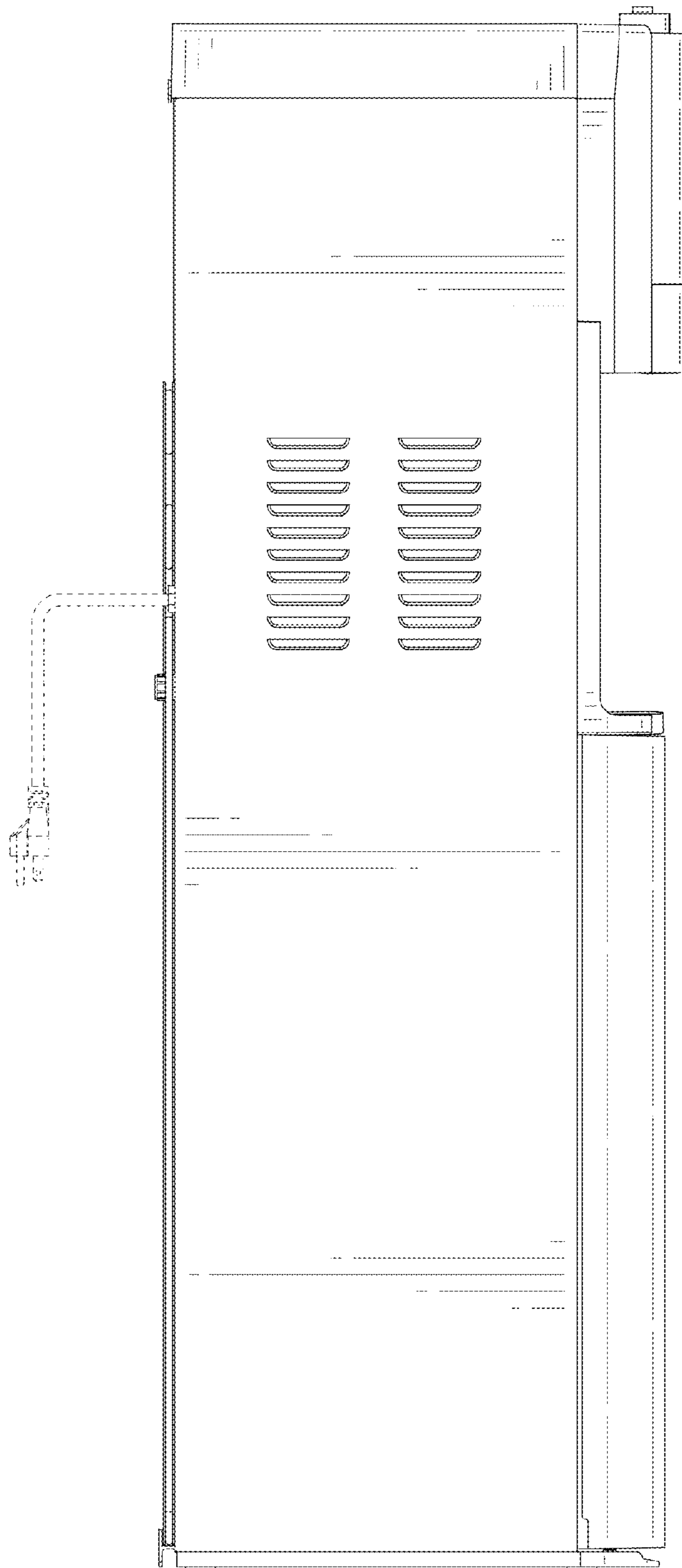

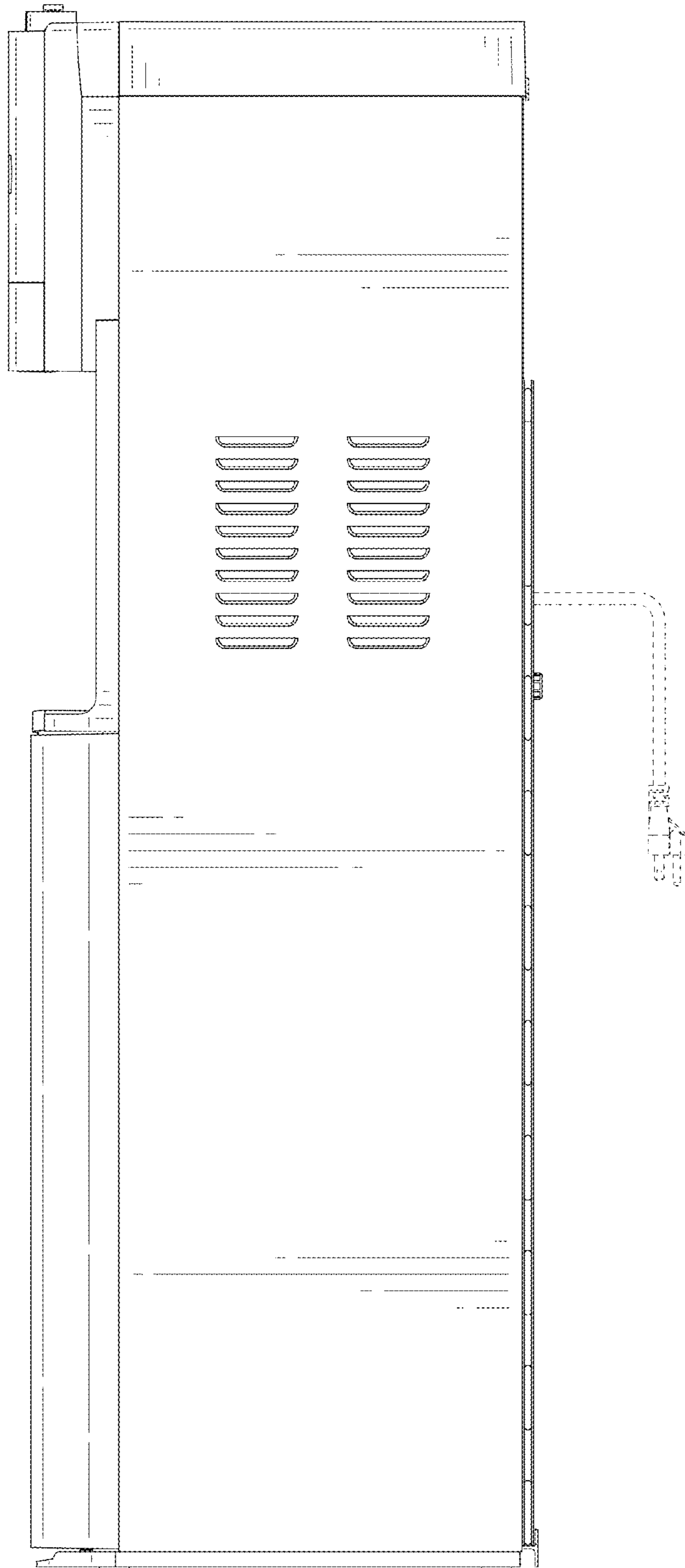

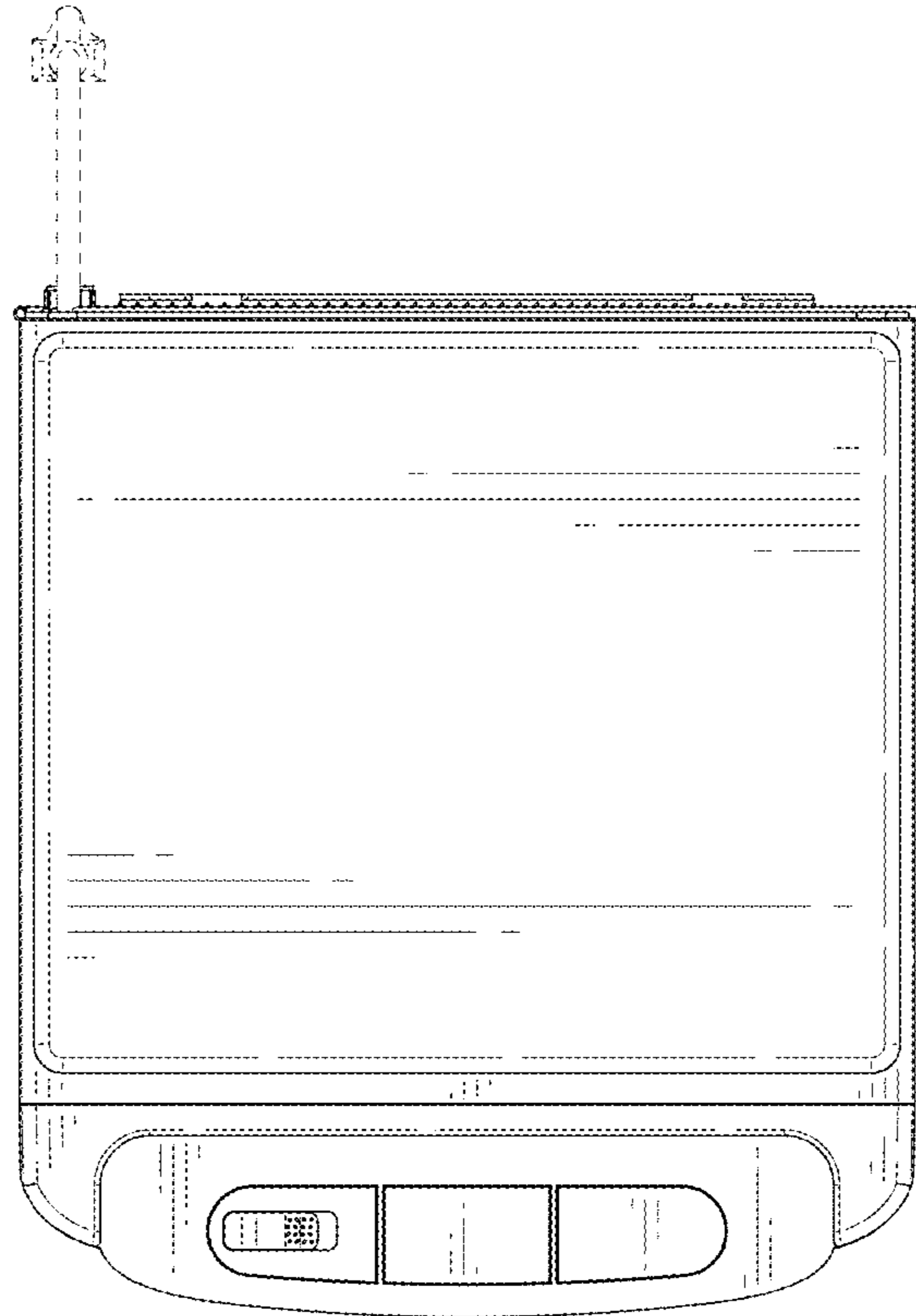

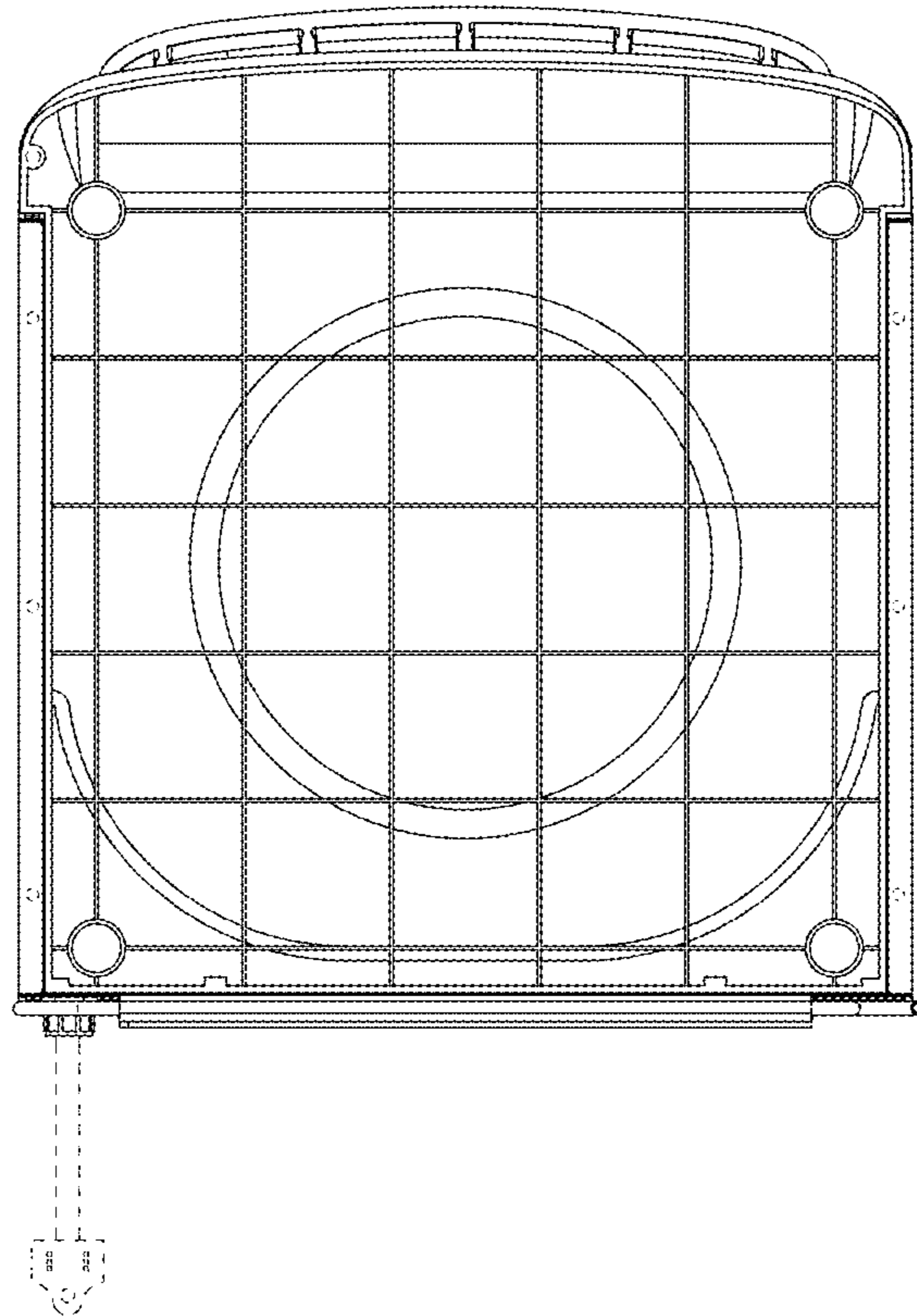
