FIG. 5 is front elevation view thereof;

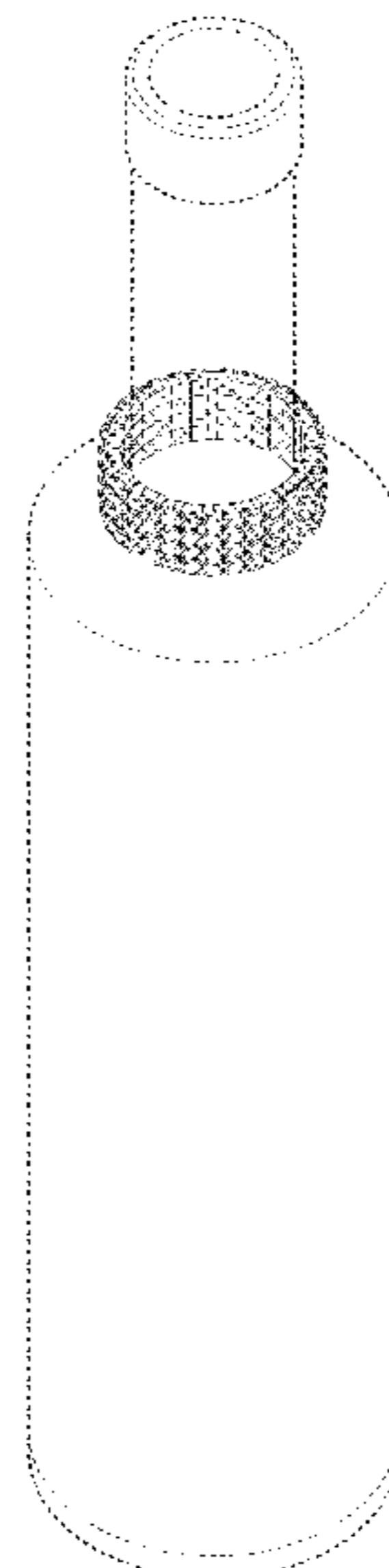
FIG. 6 is a rear elevation view thereof;

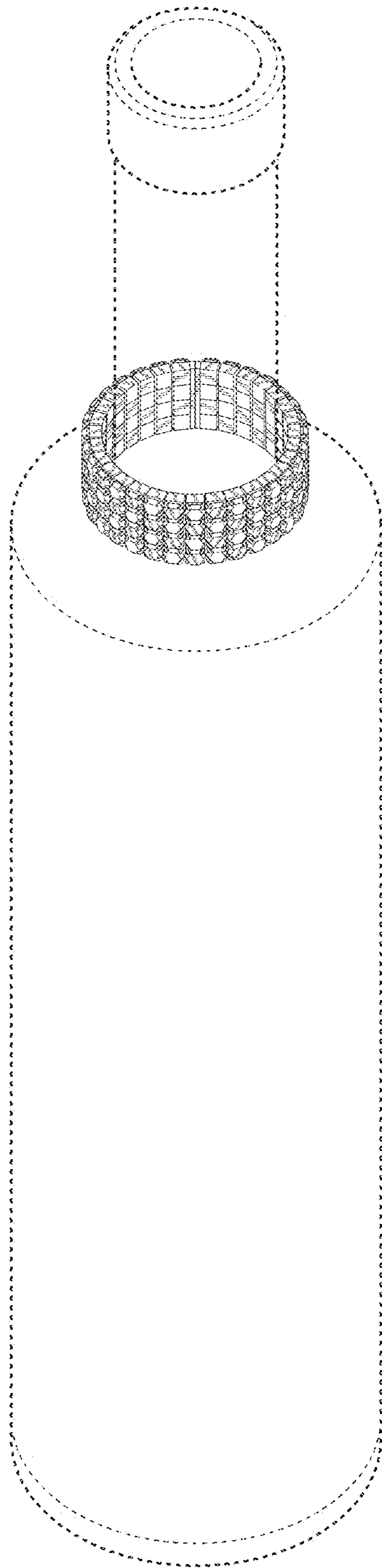

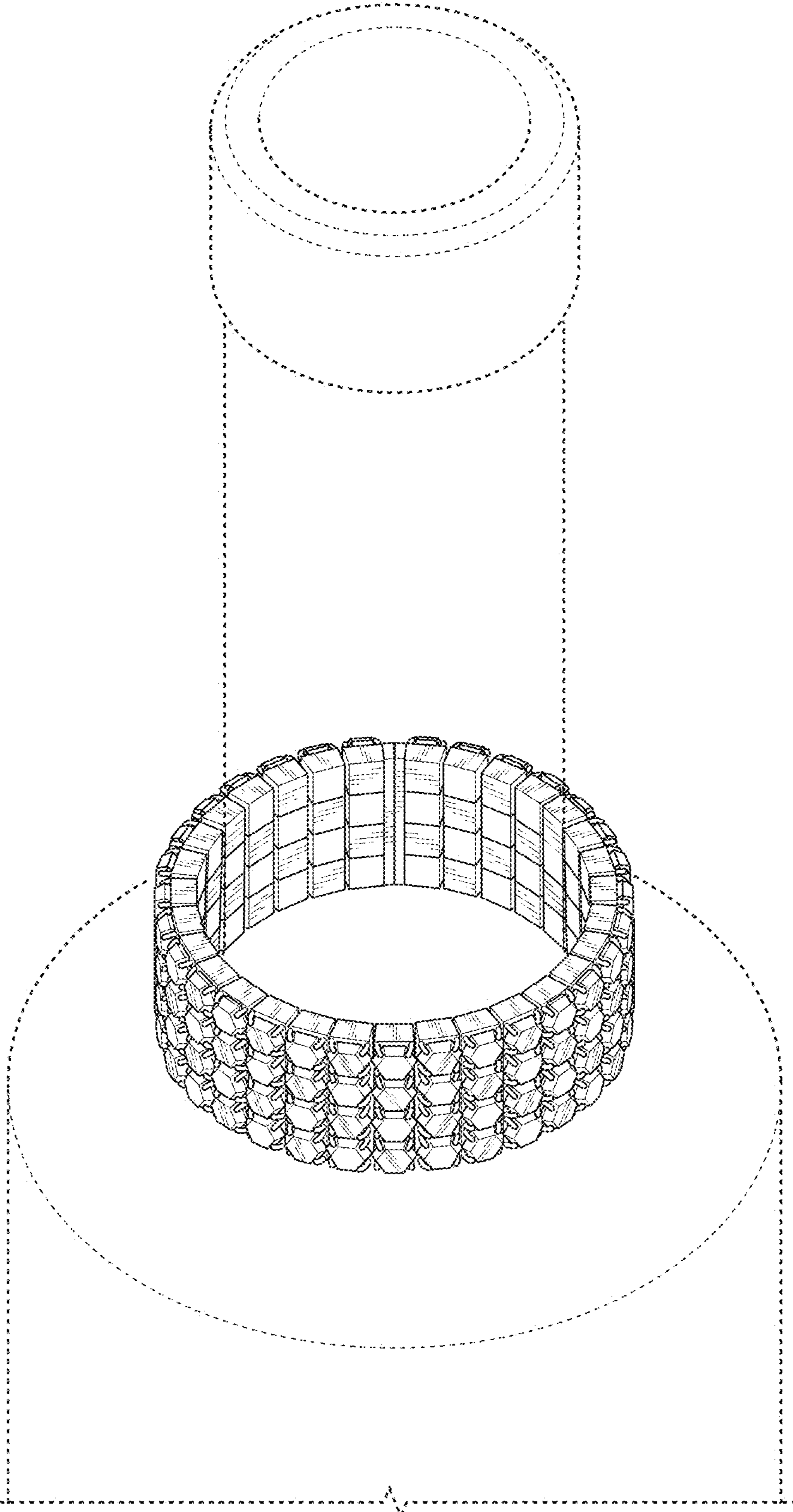

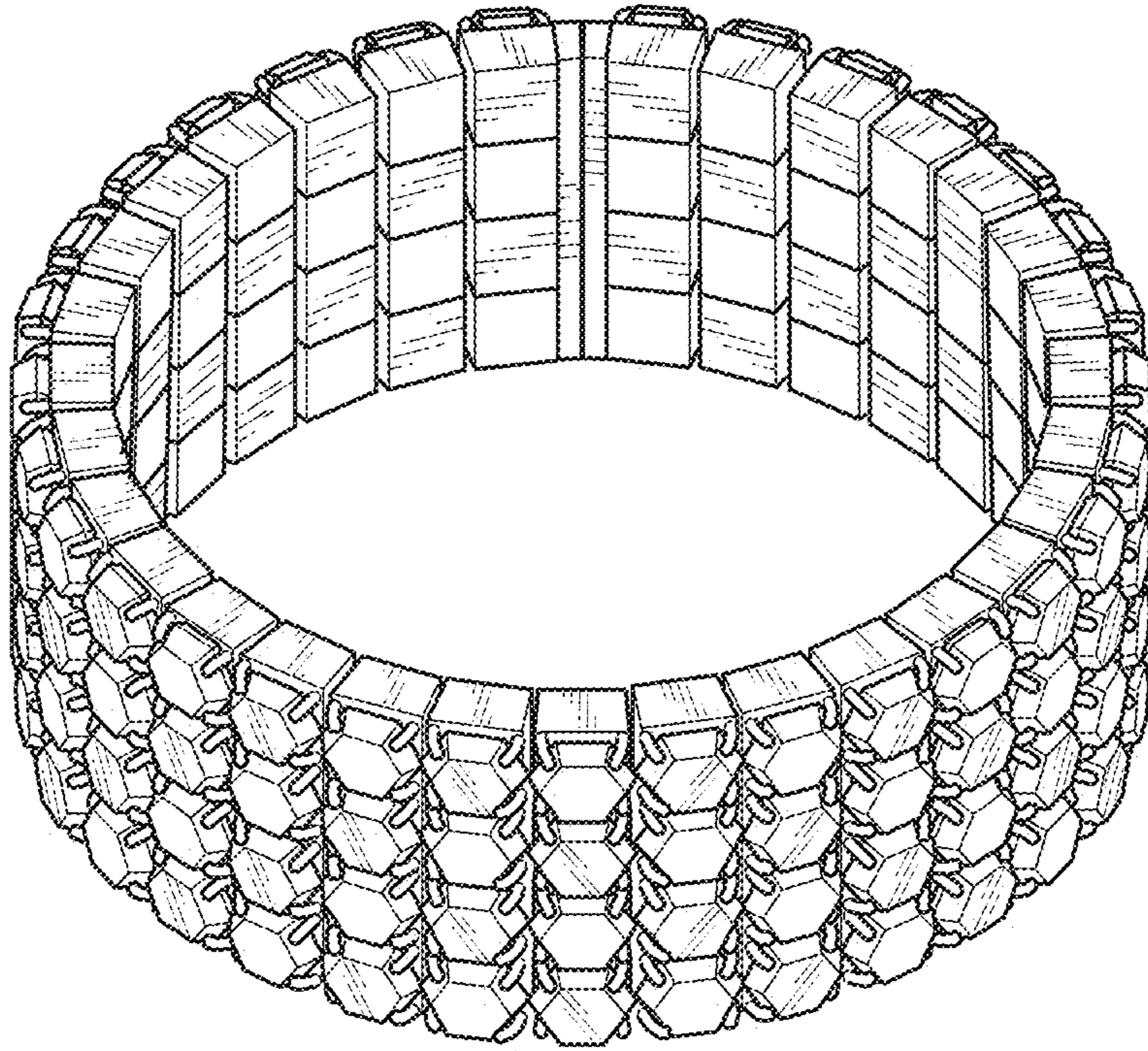

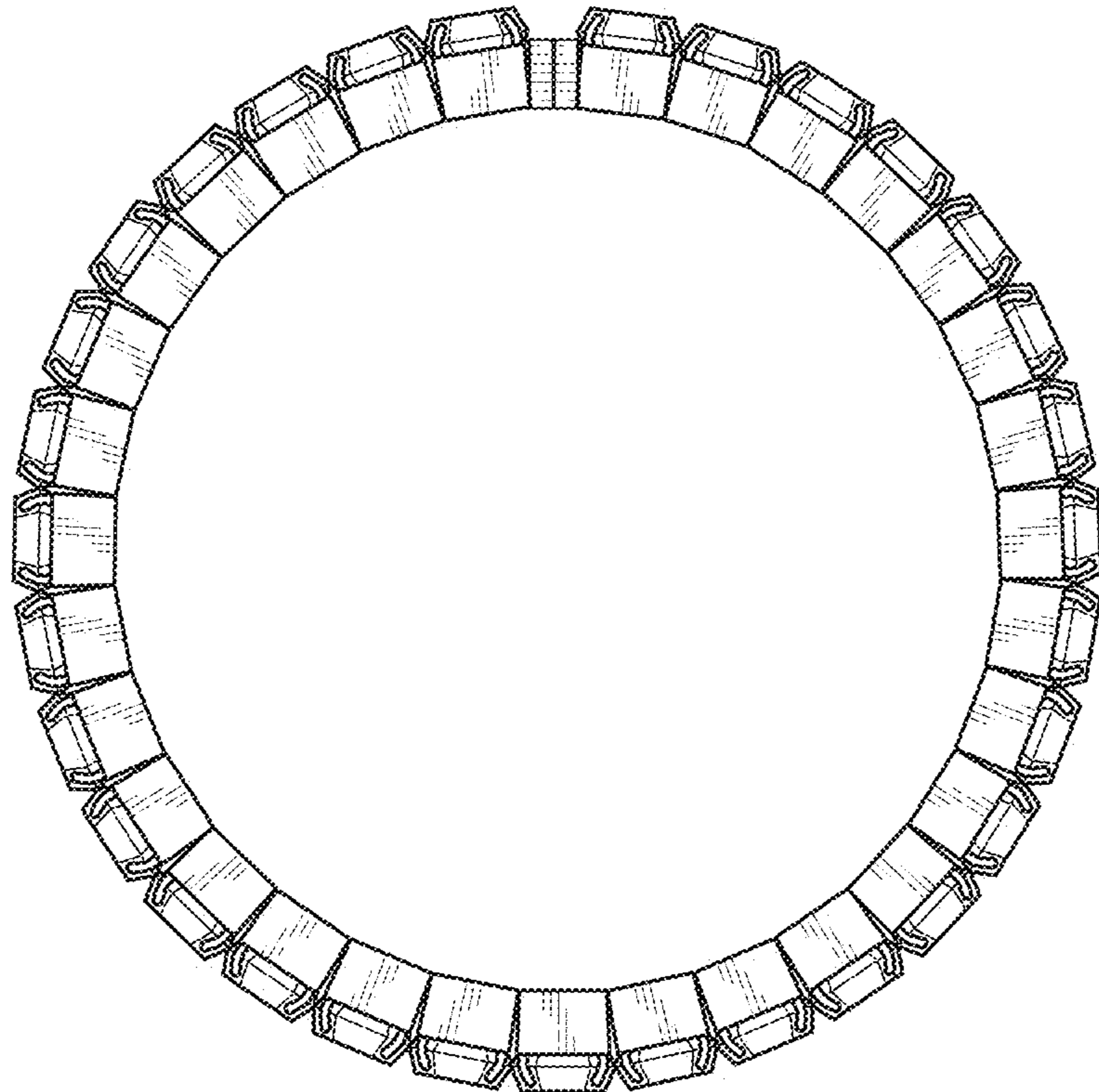

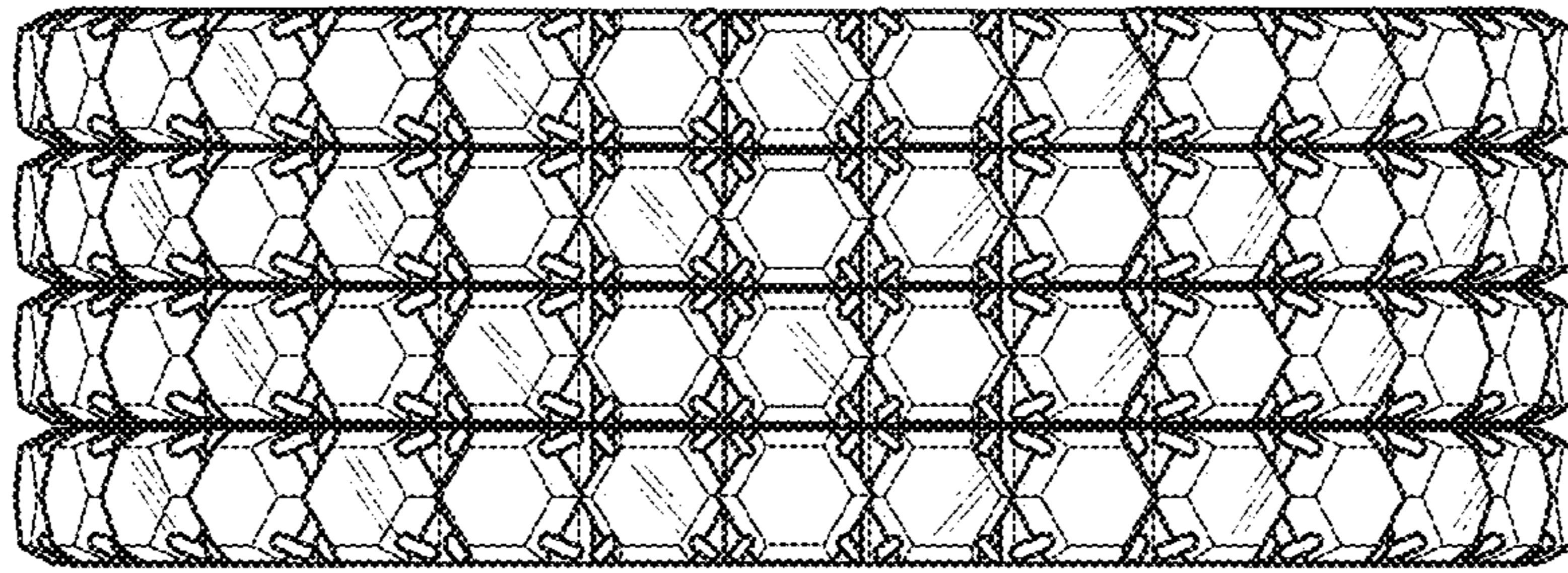

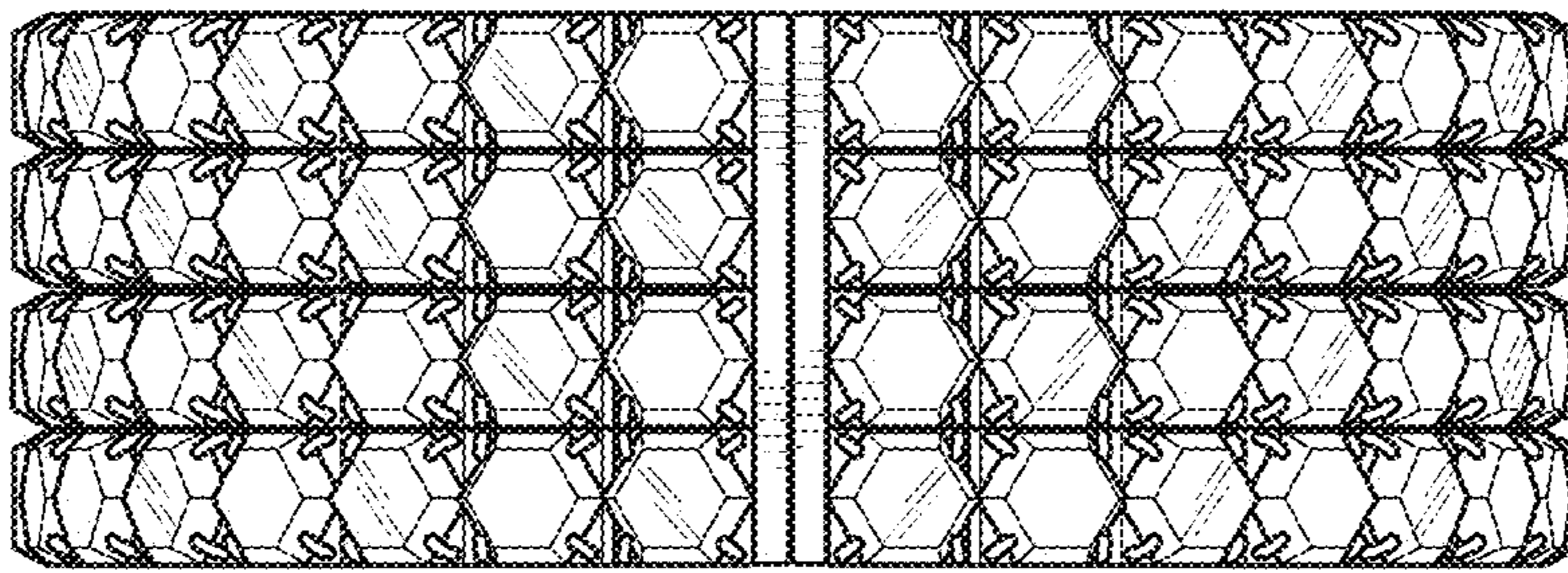

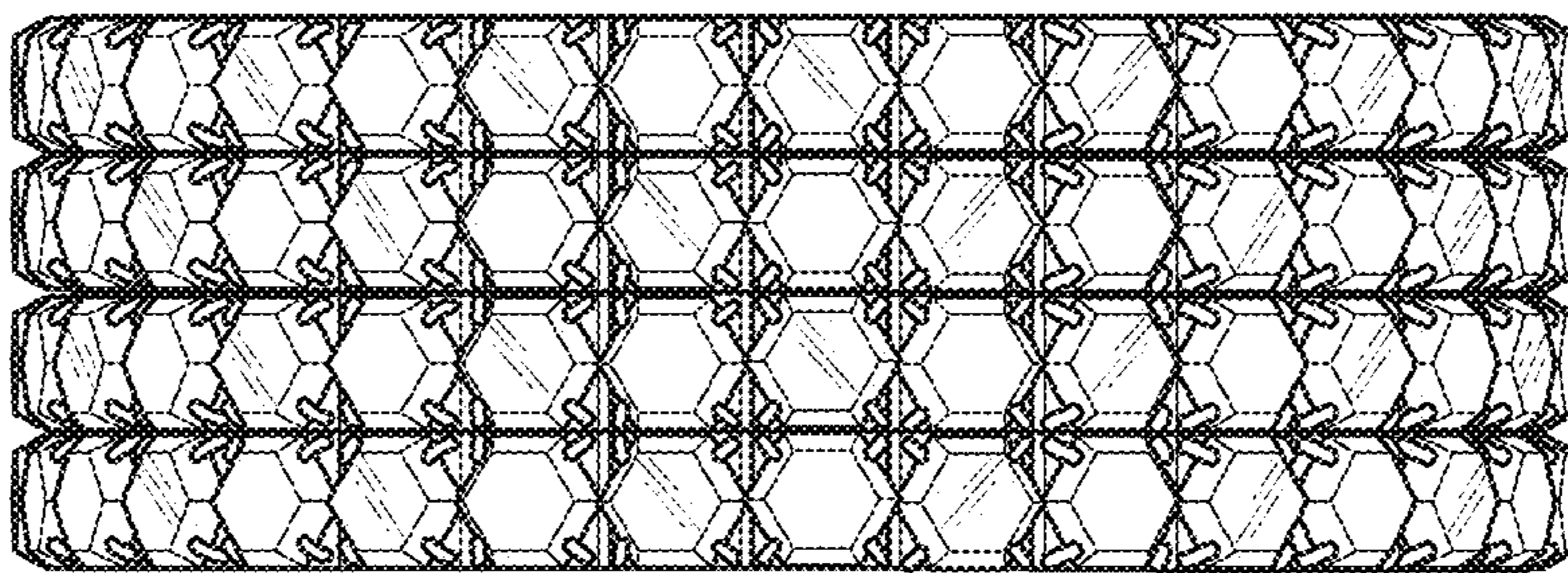

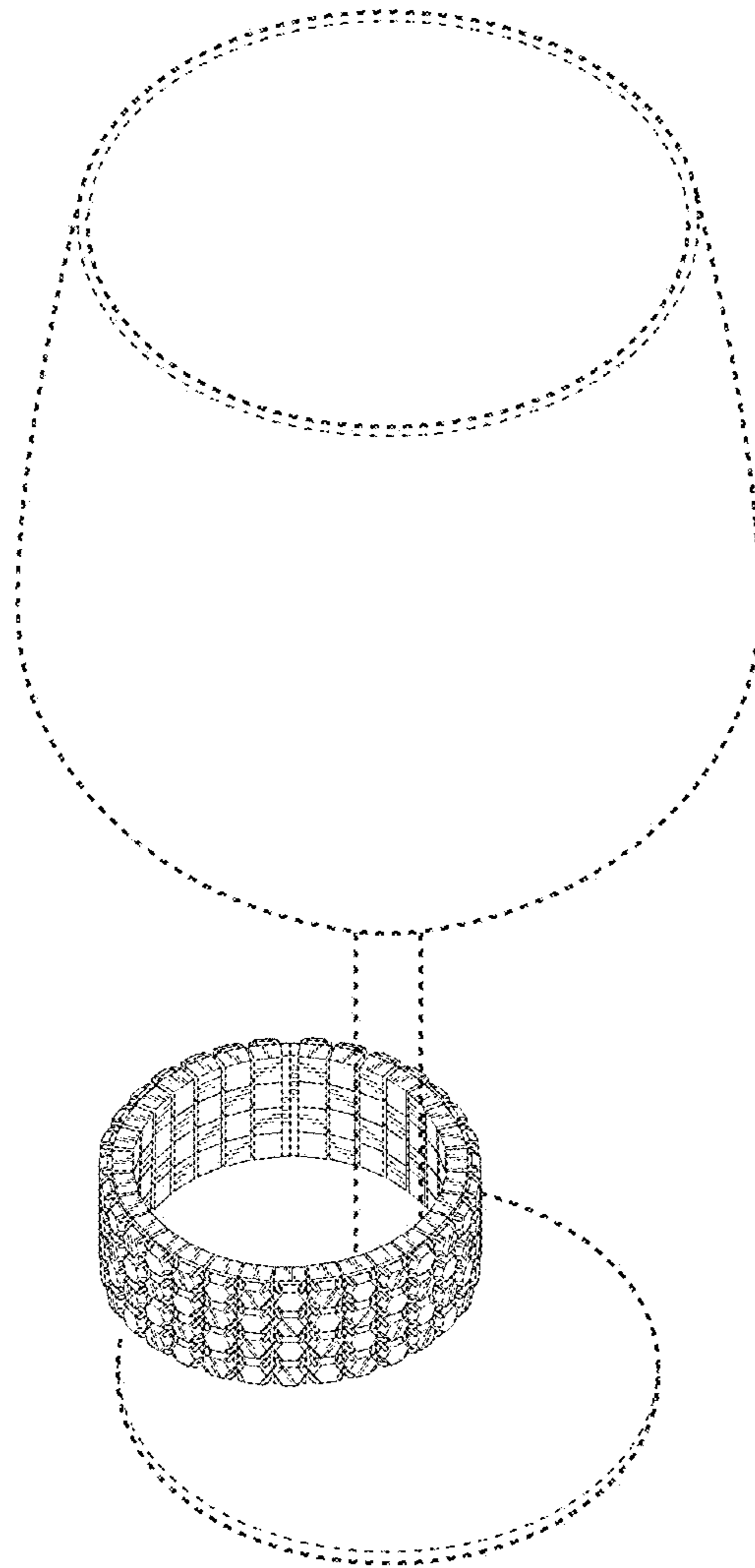
