FIG. 8 is a perspective view of the container in an environment of use.

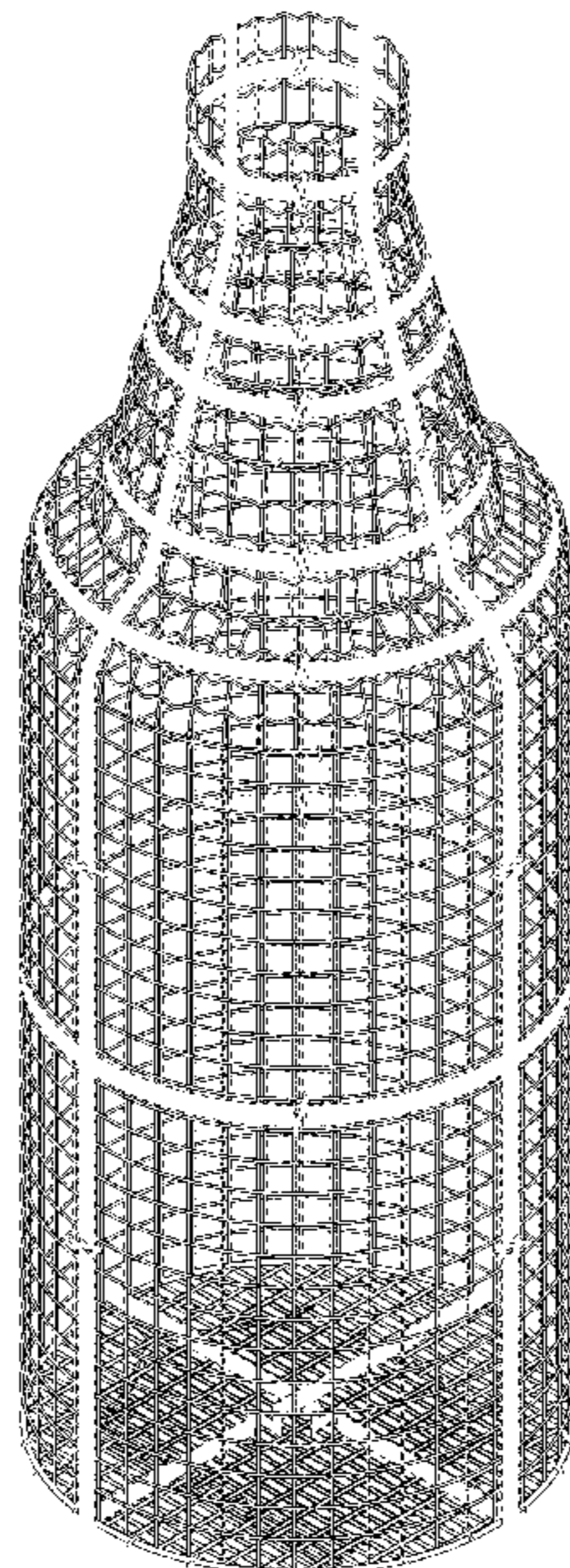

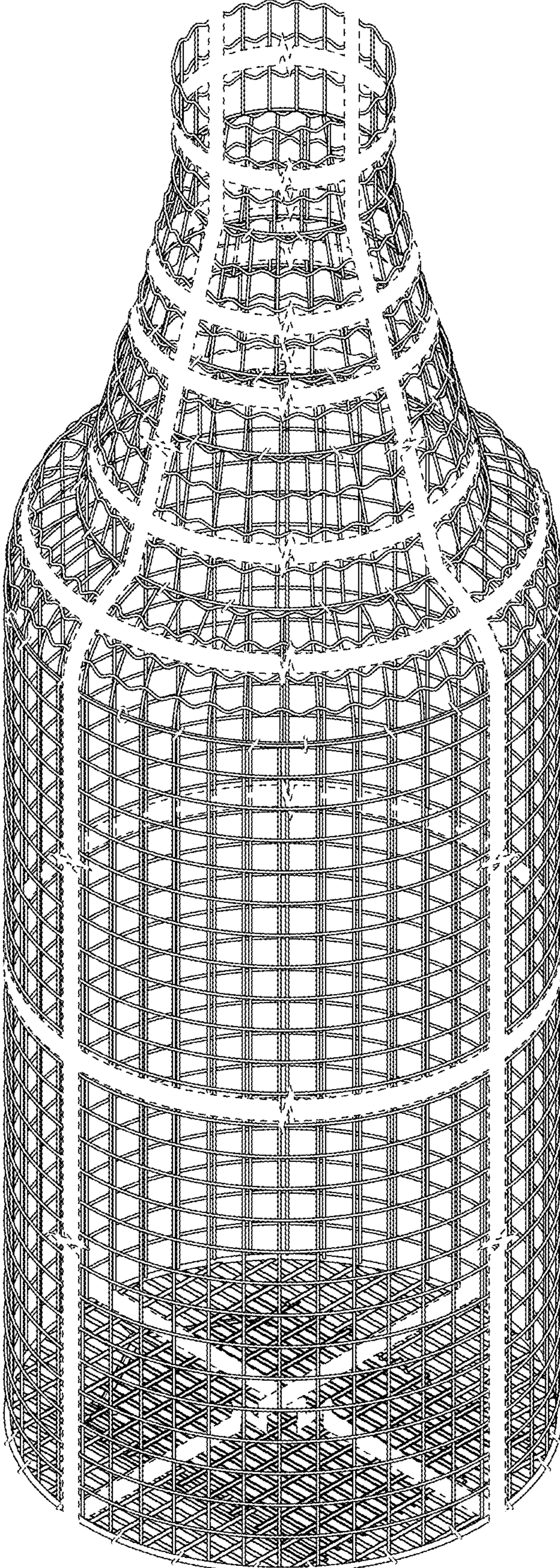

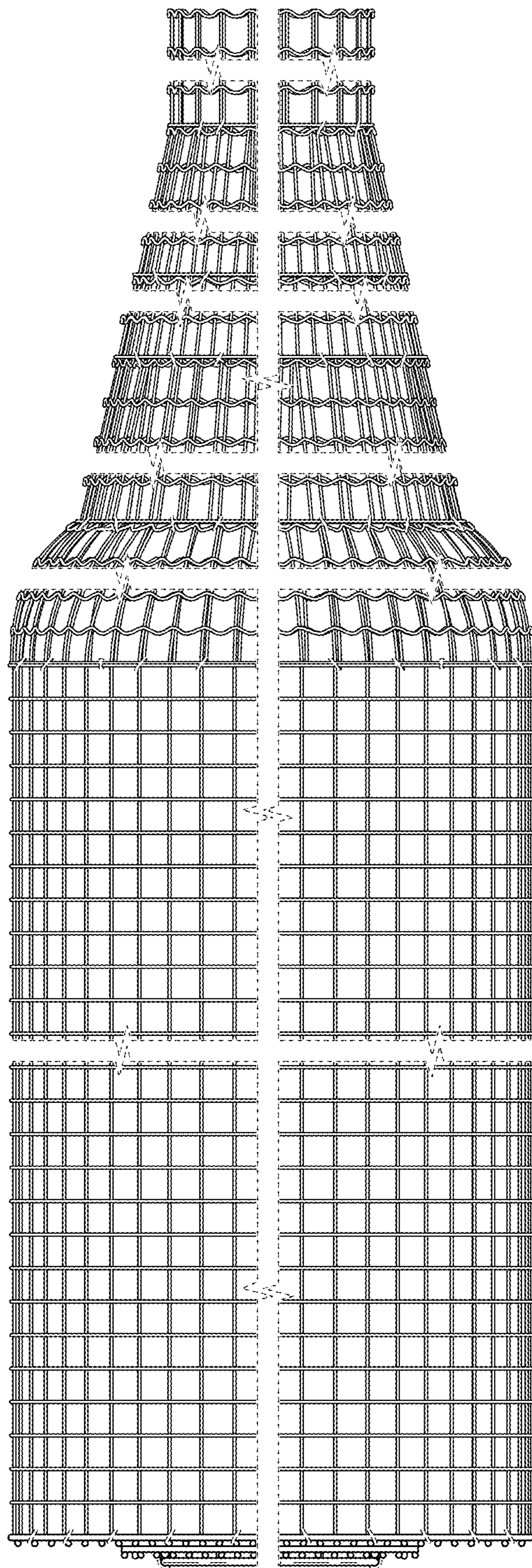

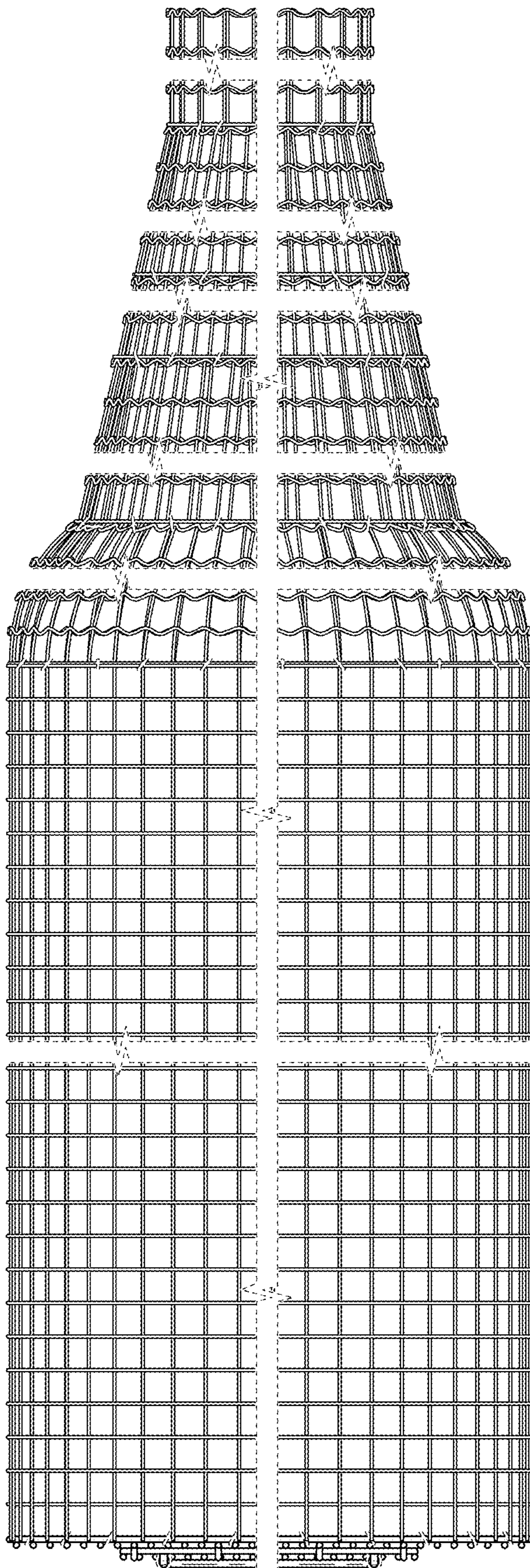

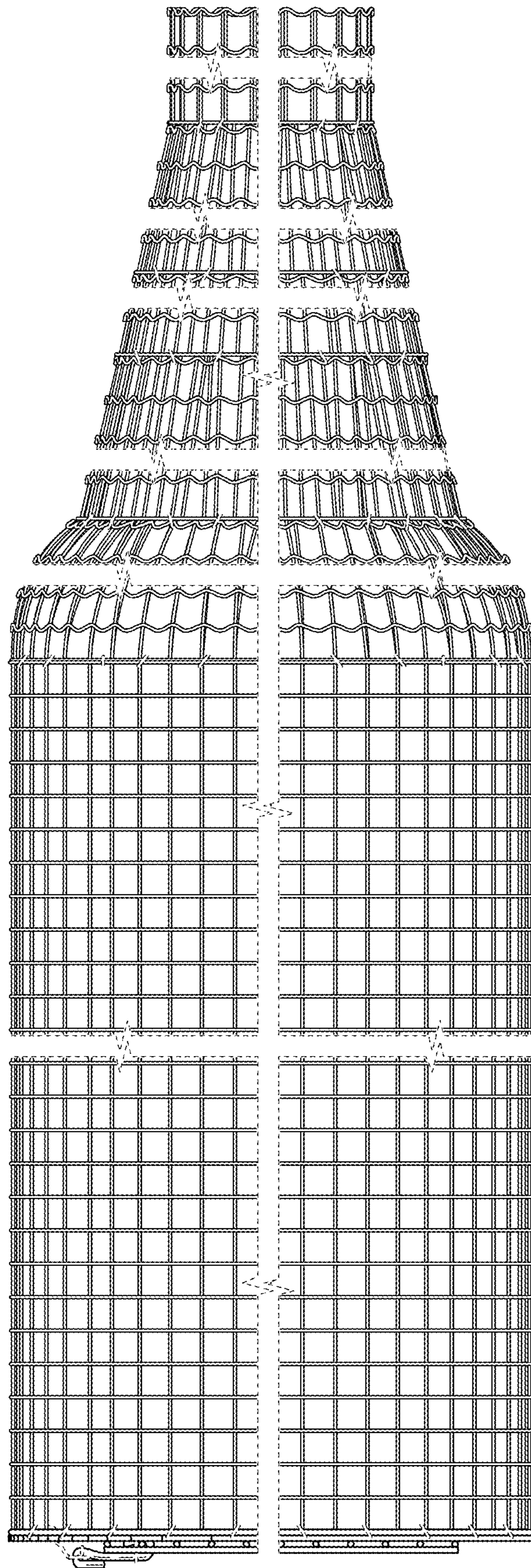

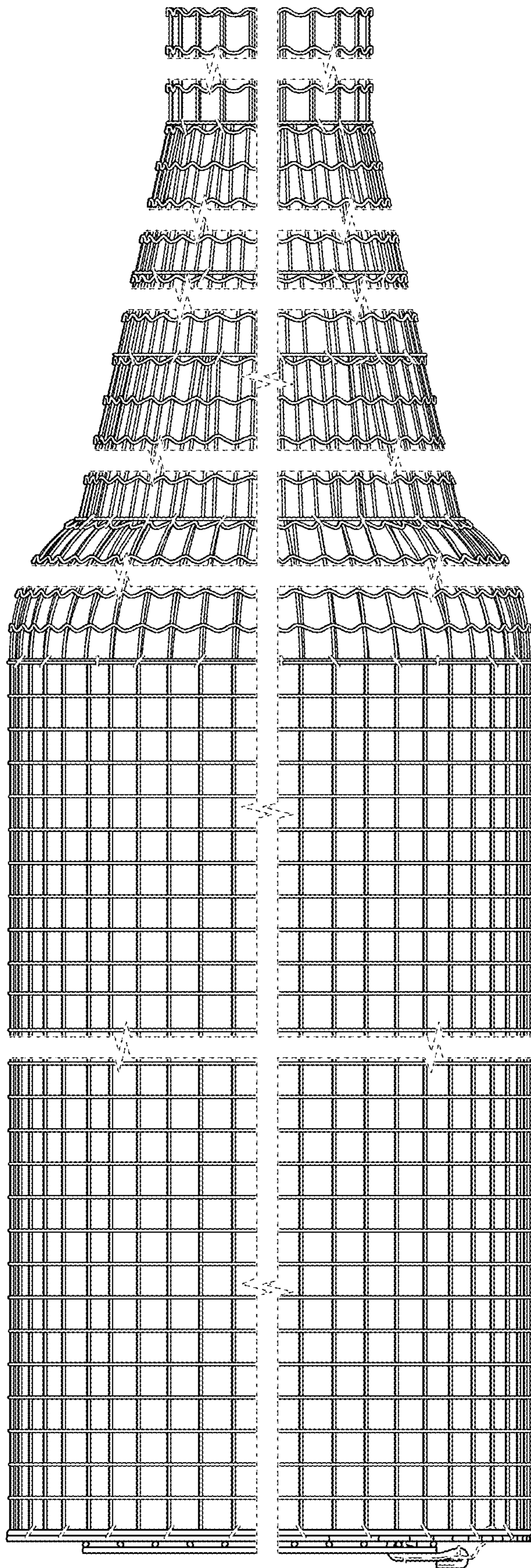

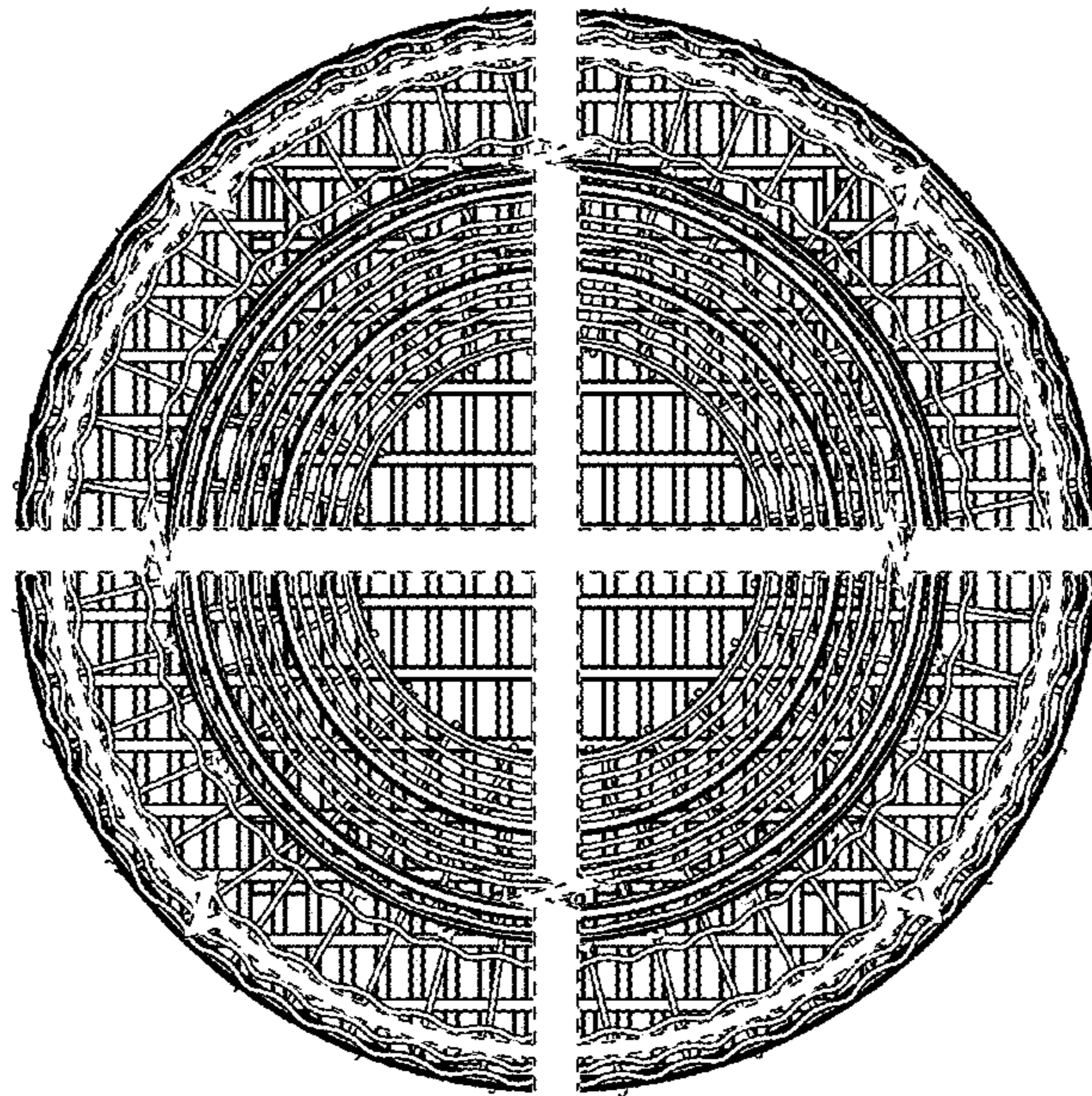

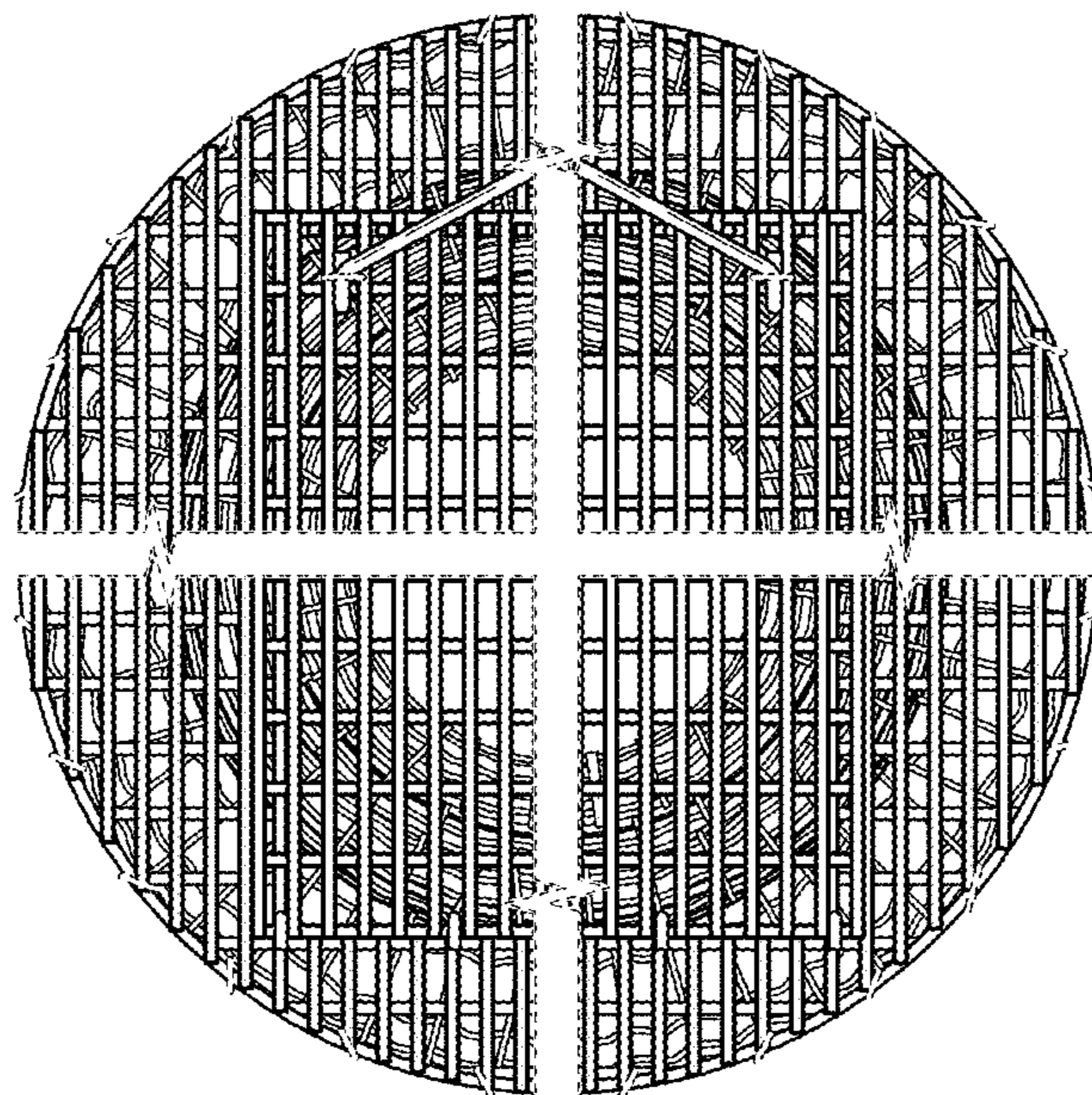

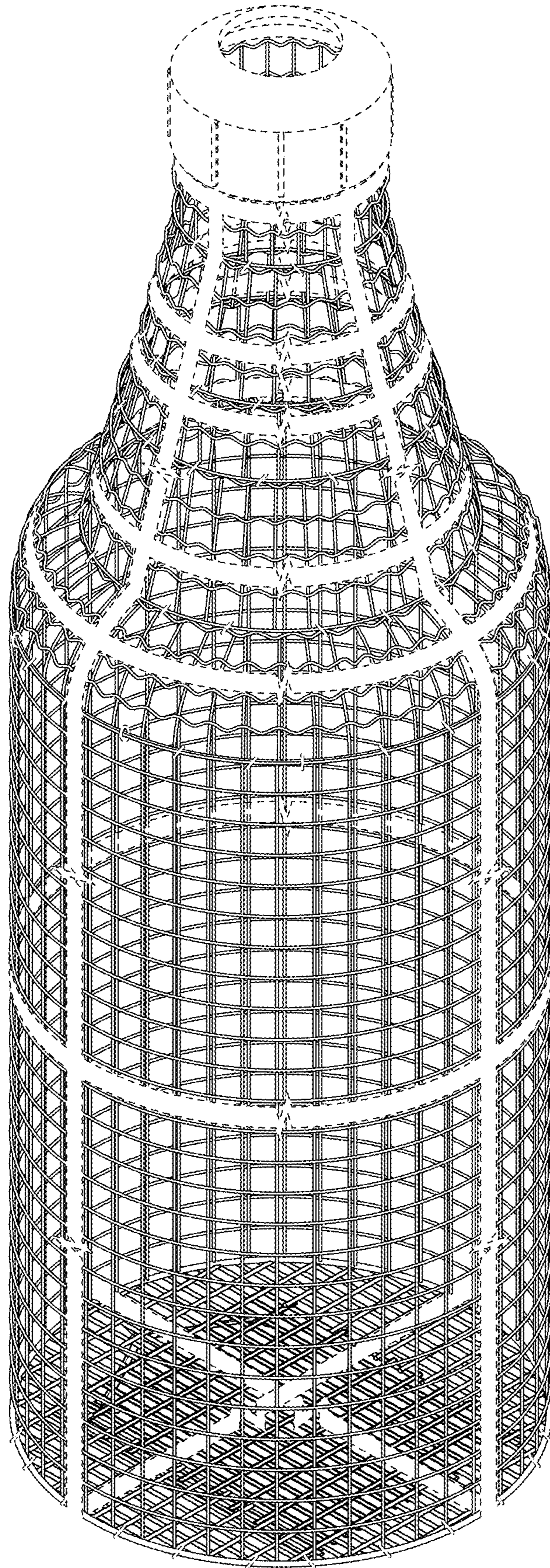
