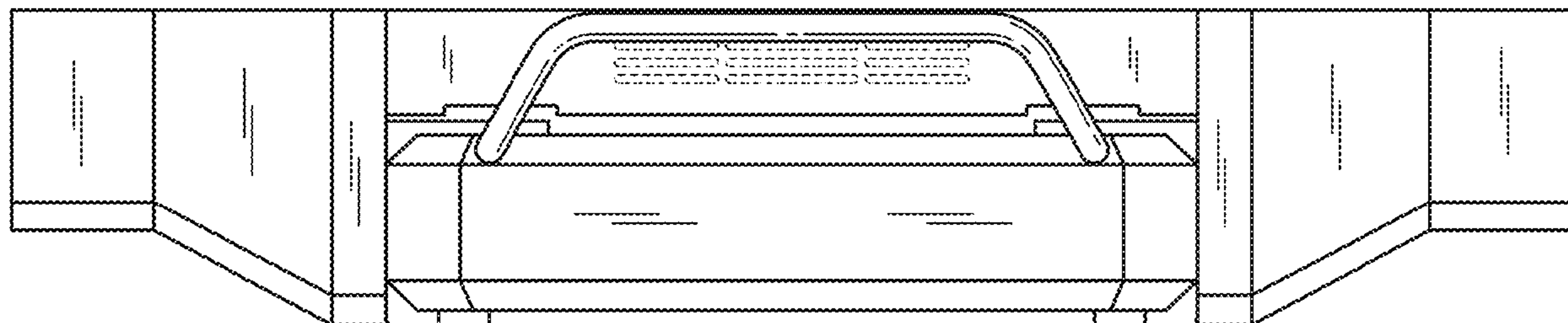
The ornamental design for a fuel hose reel mount, as shown and described.

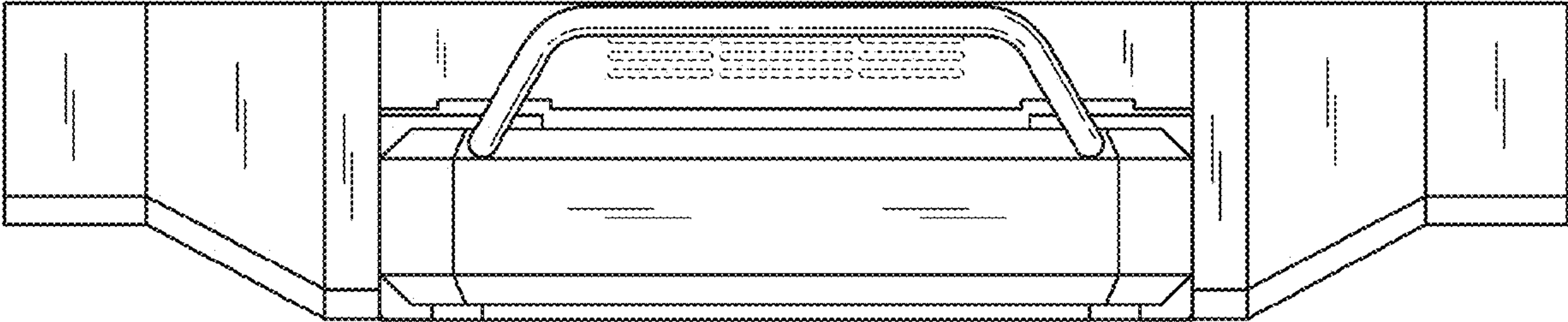

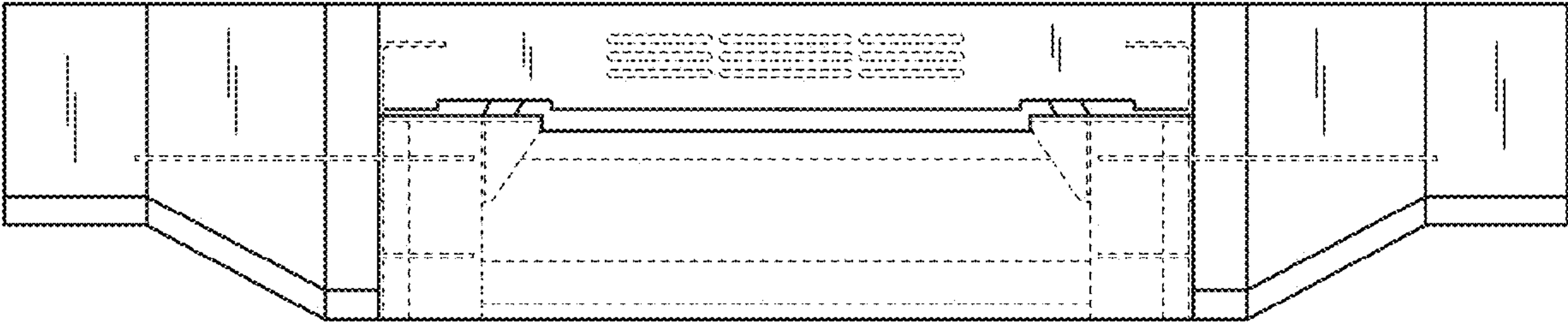
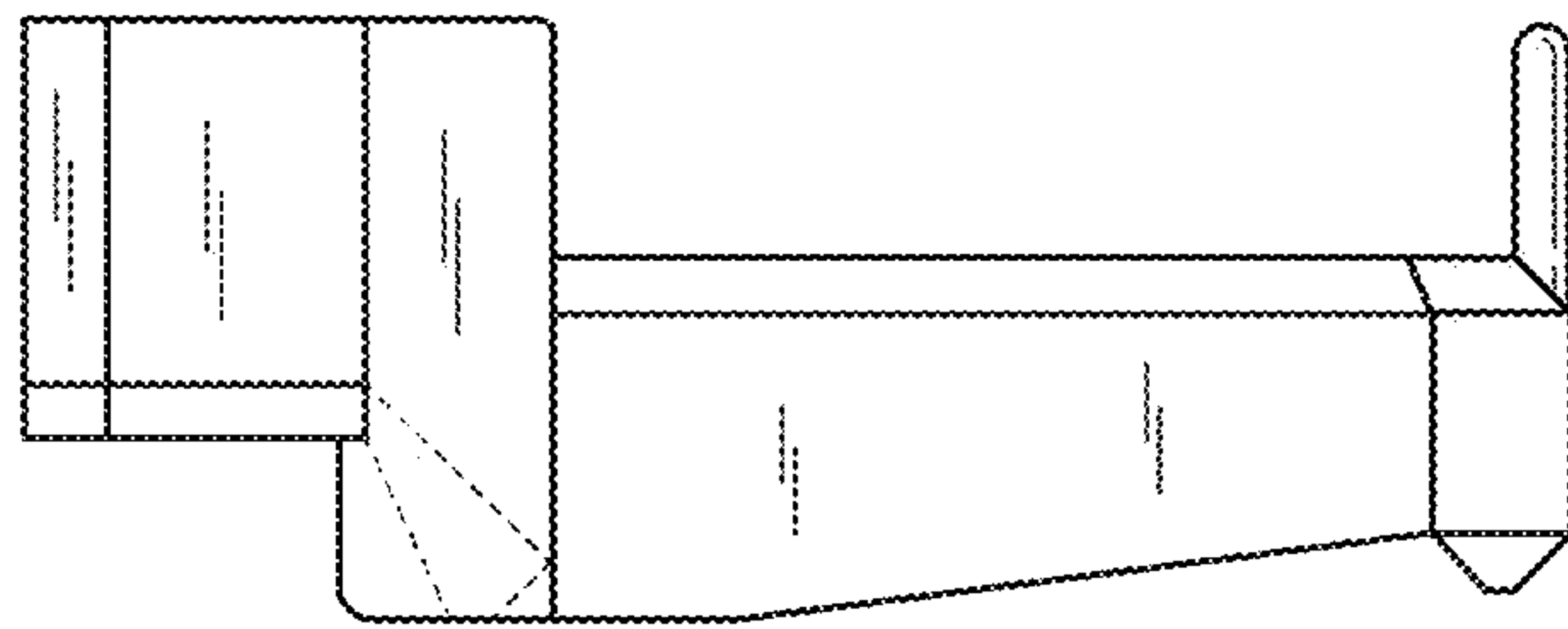

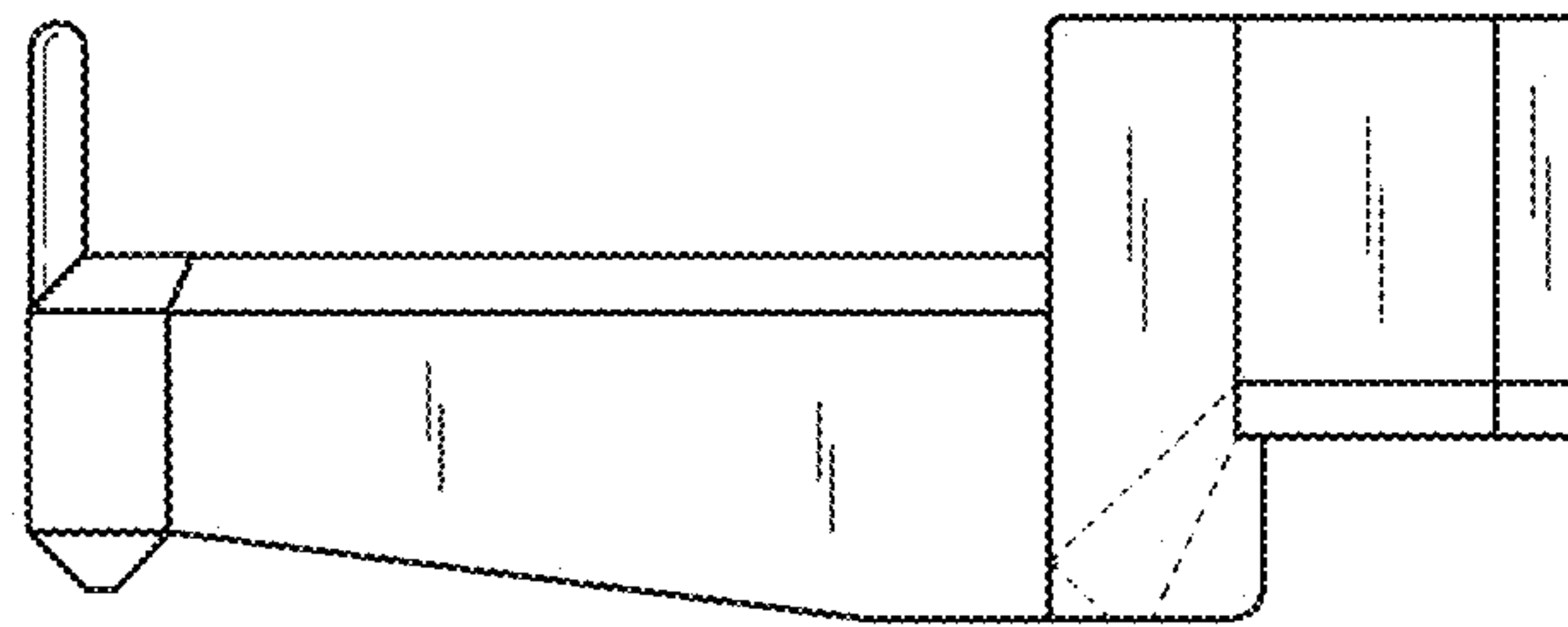

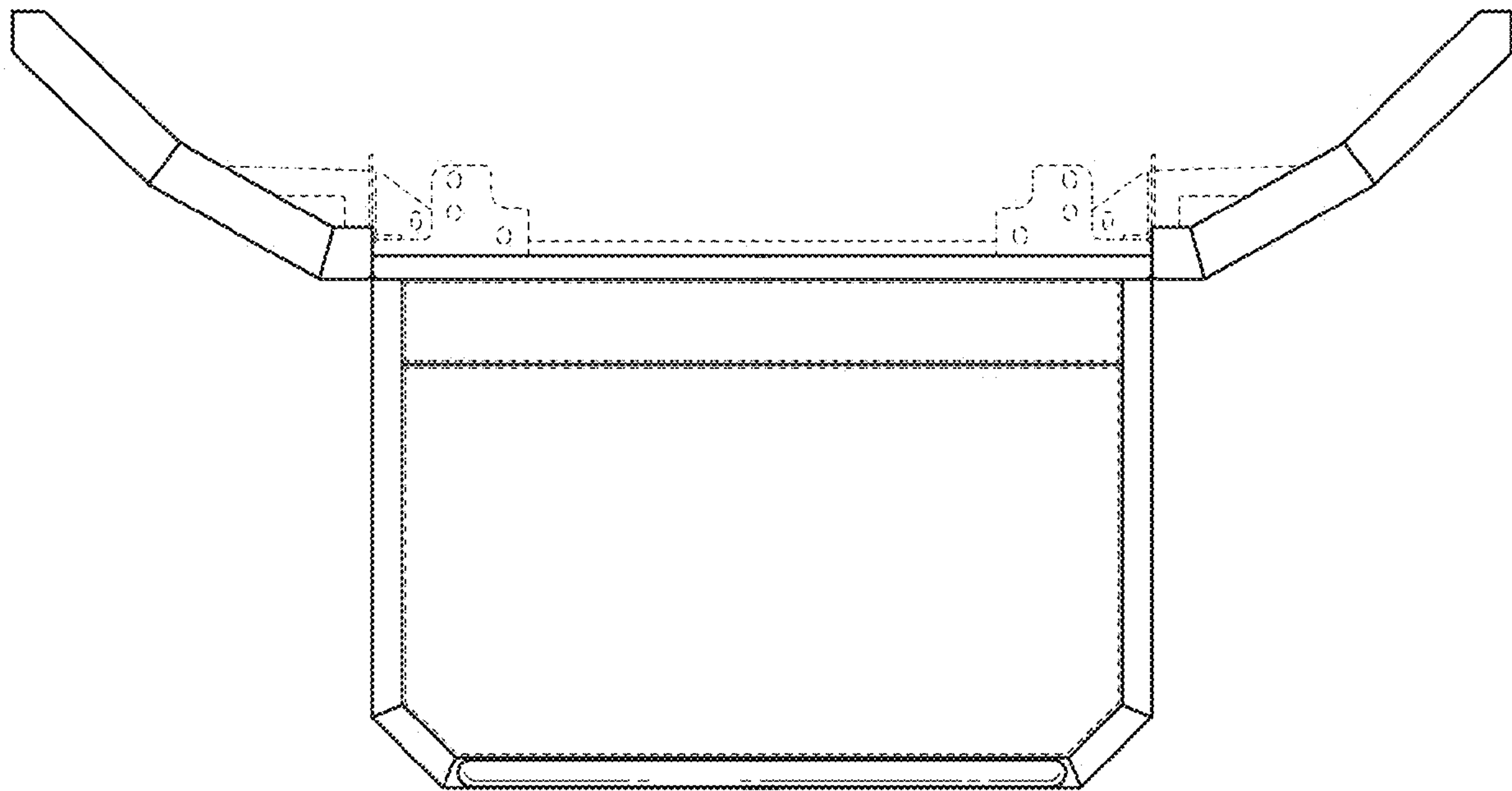

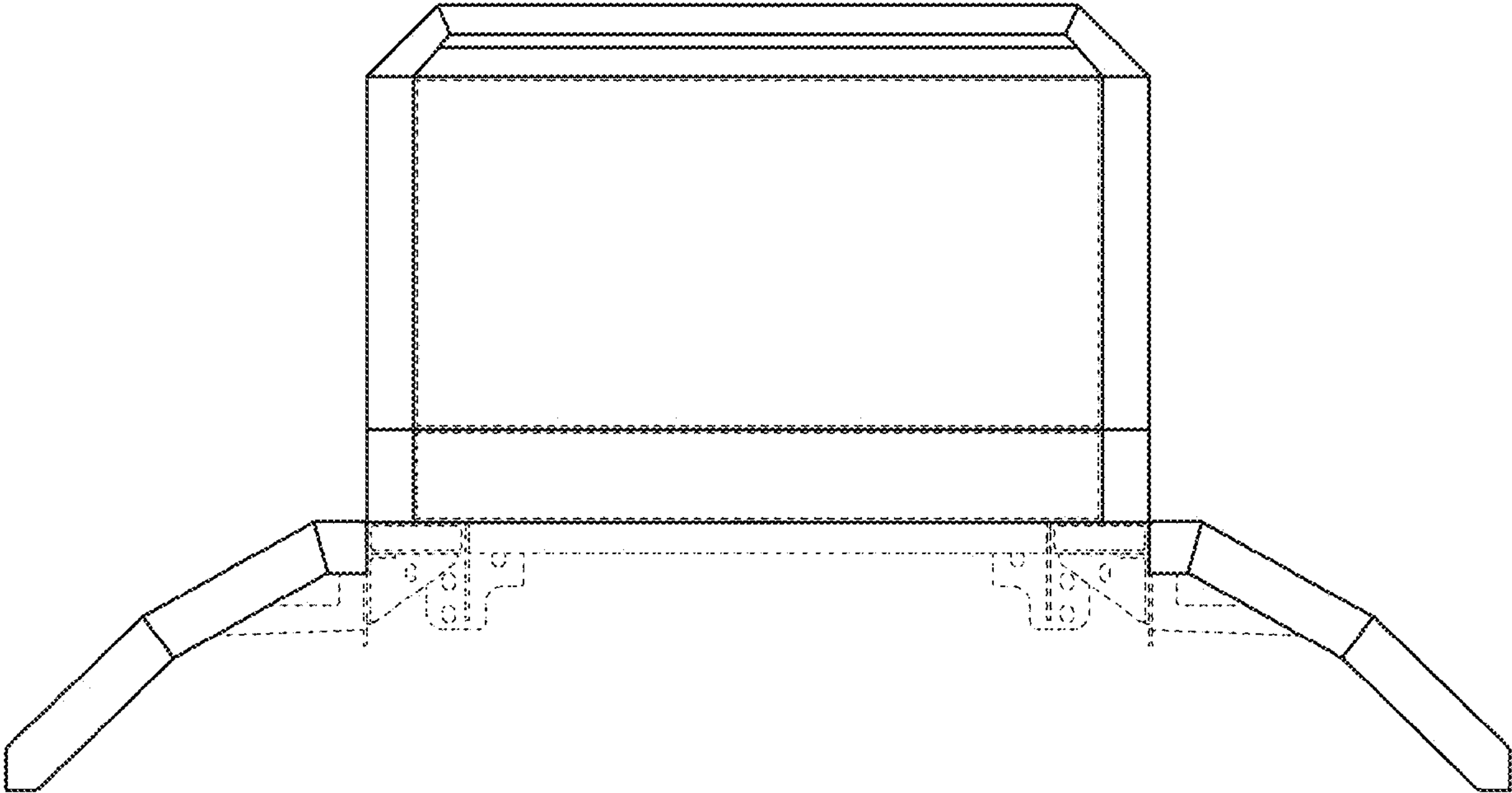
