**DESCRIPTION**

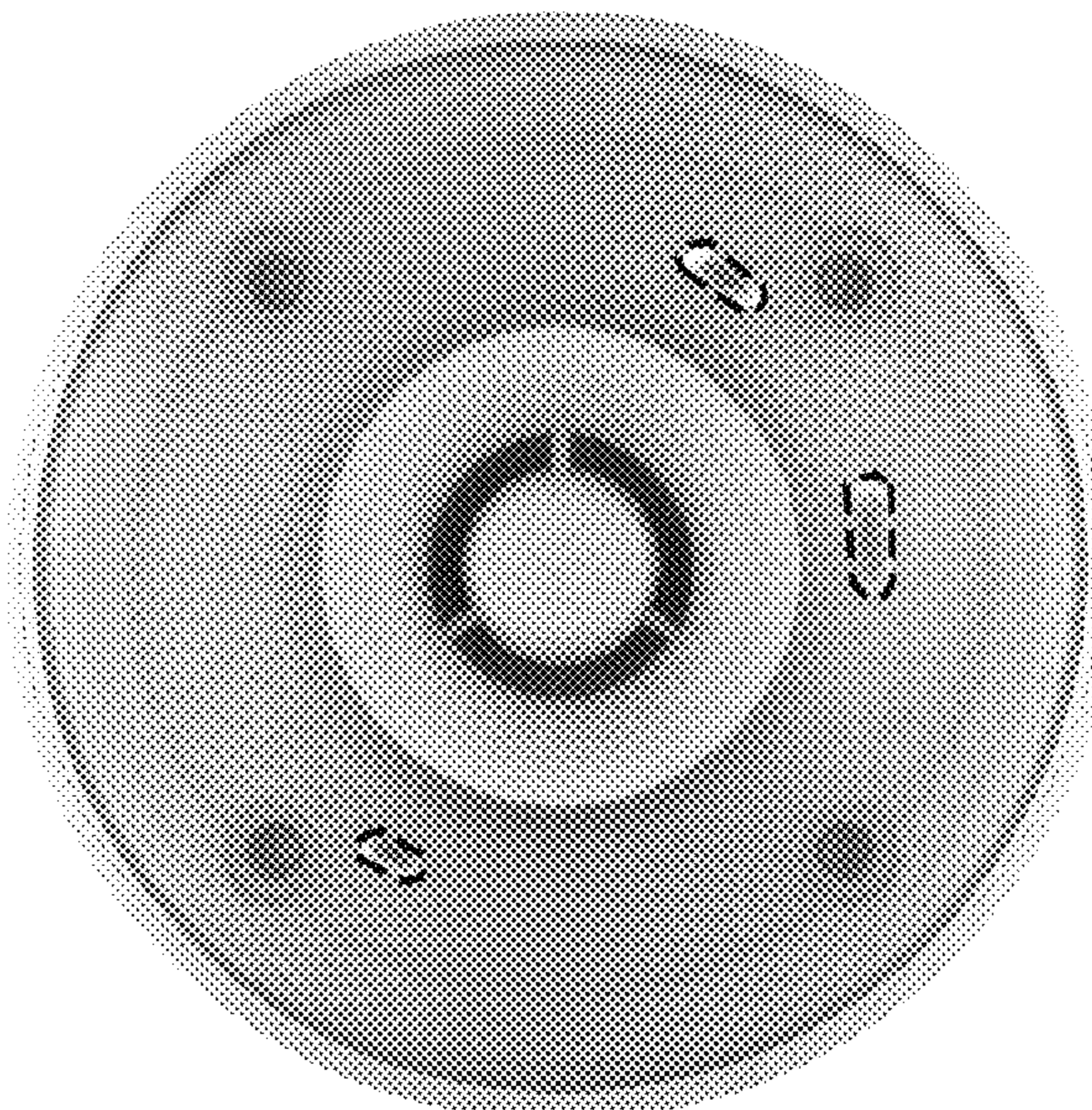
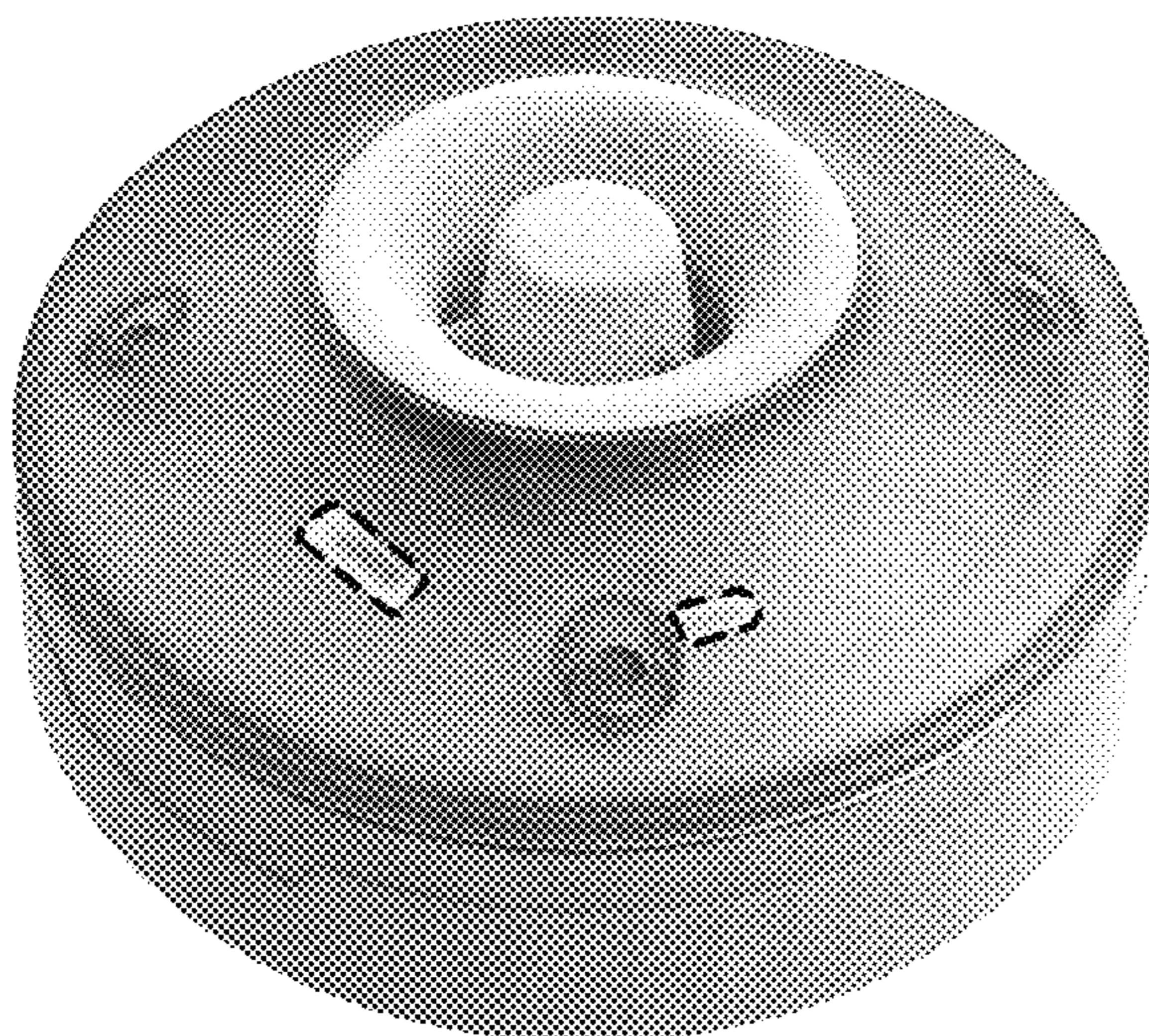

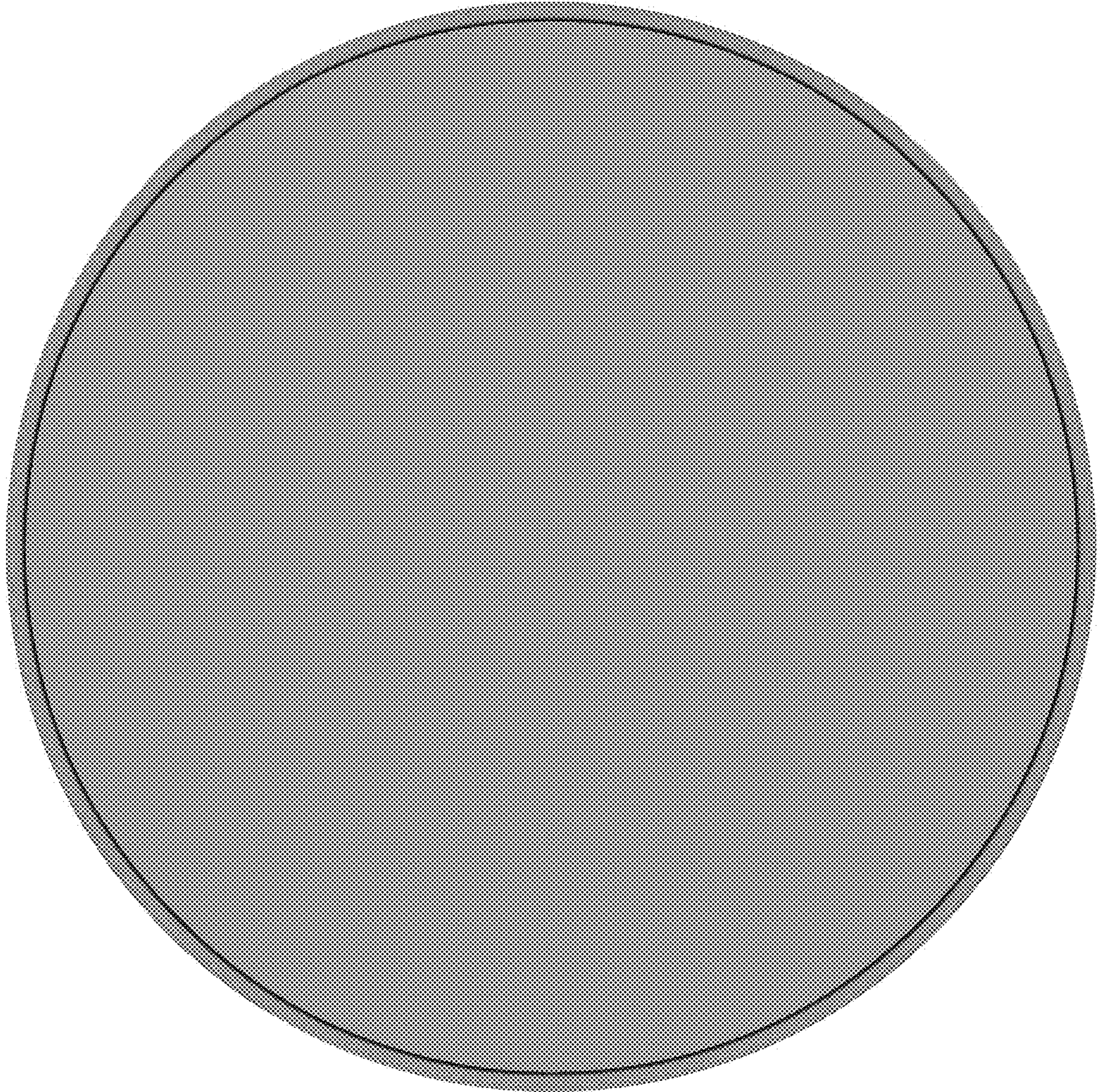

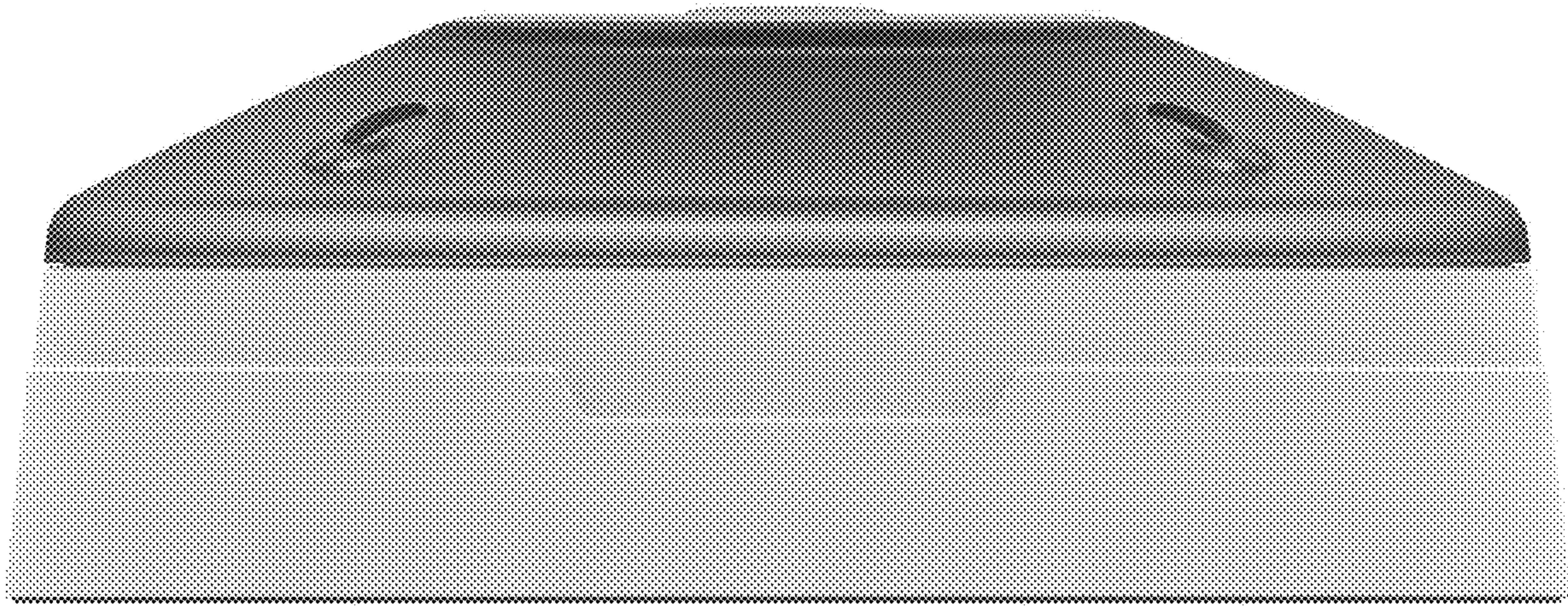

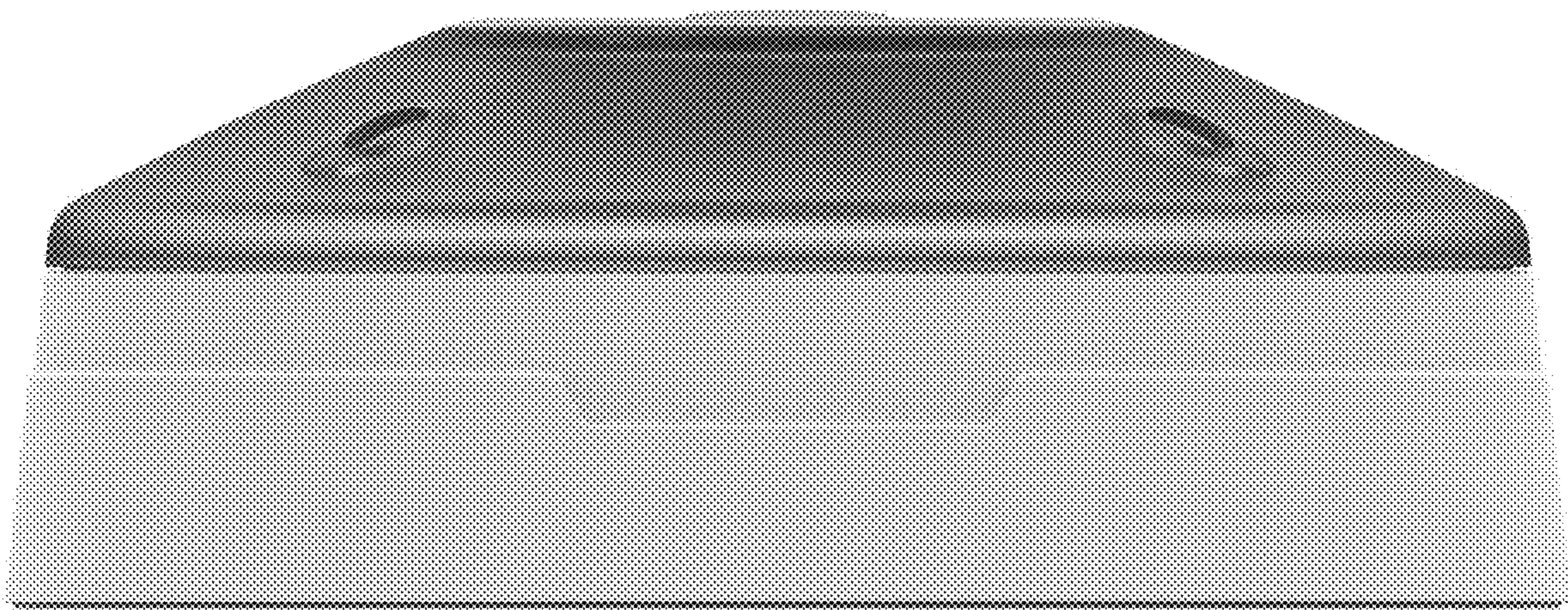

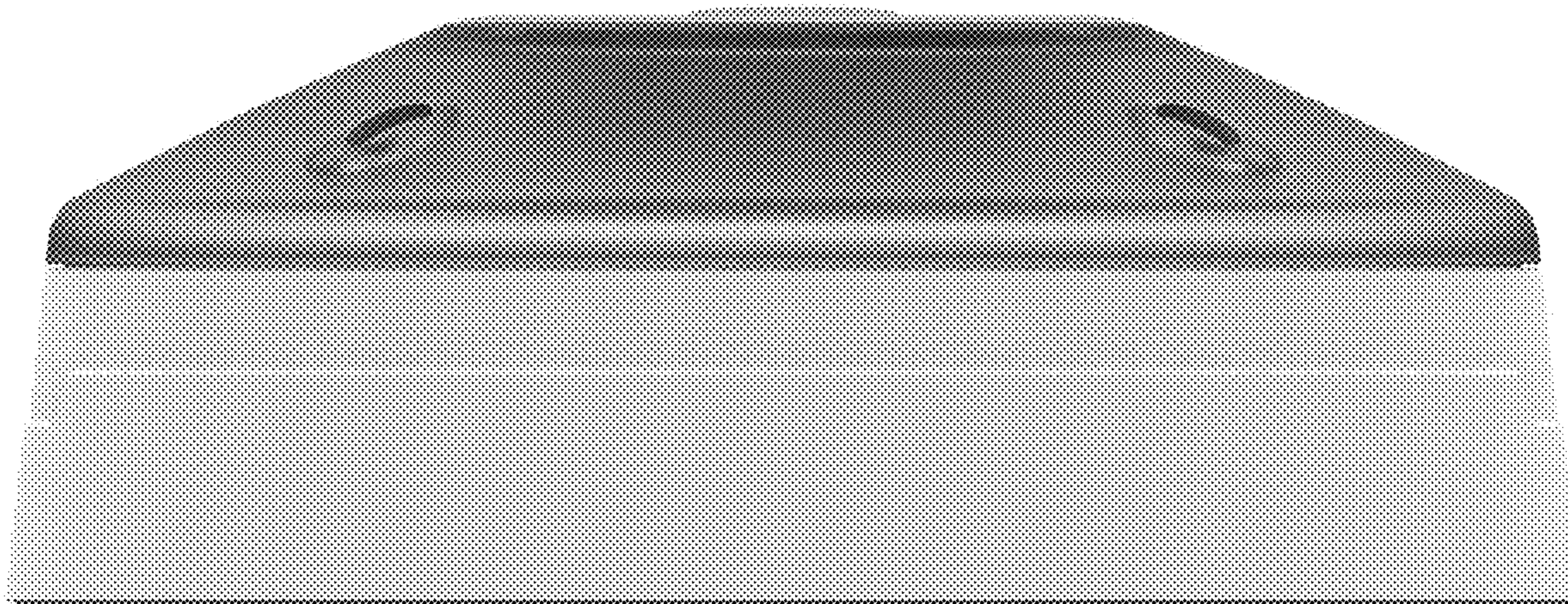

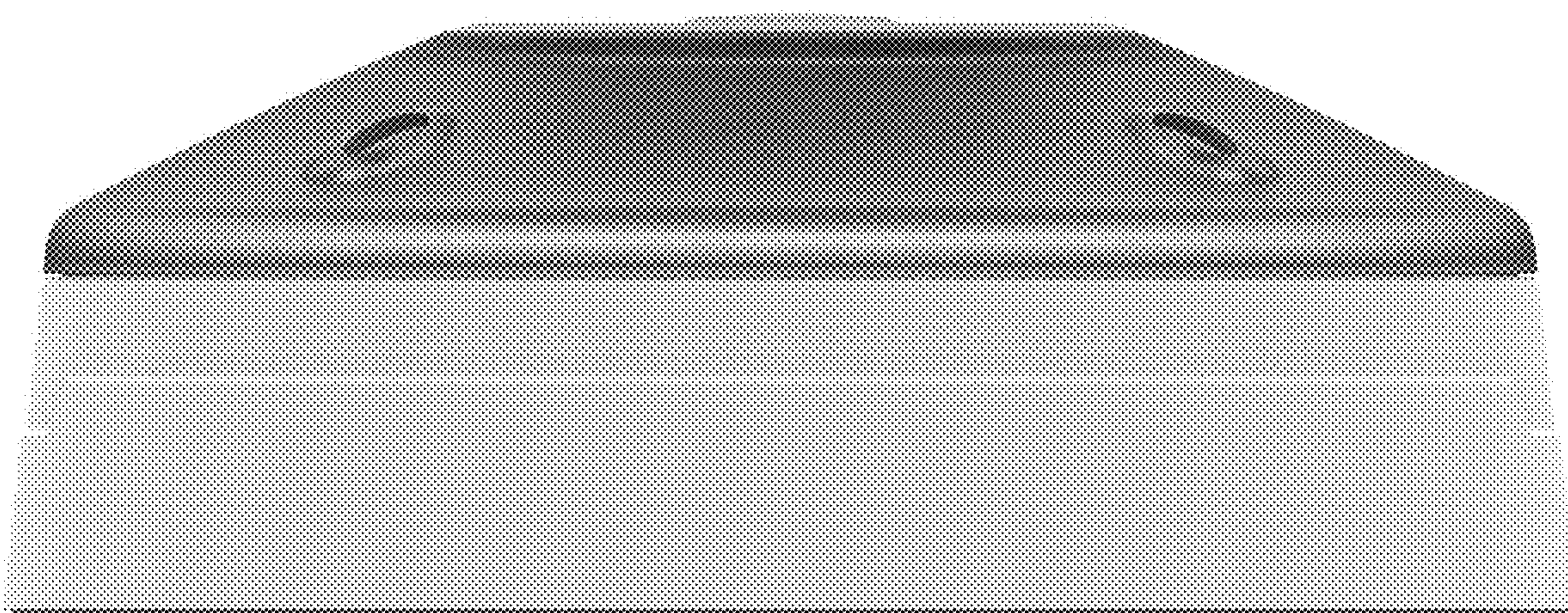
