The ornamental design for a notebook computer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a notebook computer showing our new design;

FIG. 9 is an enlarged view of an indicated portion of FIG. 1;

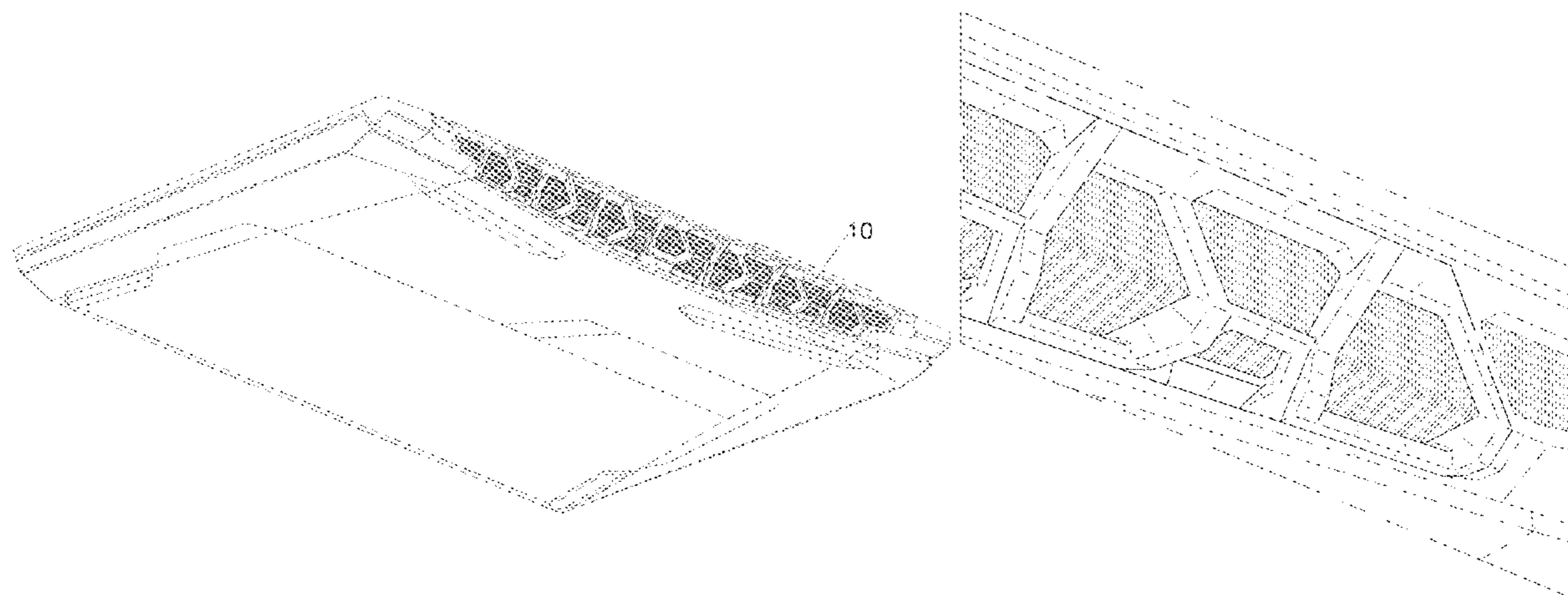
FIG. 10 is an enlarged view of an indicated portion of FIG. 2;

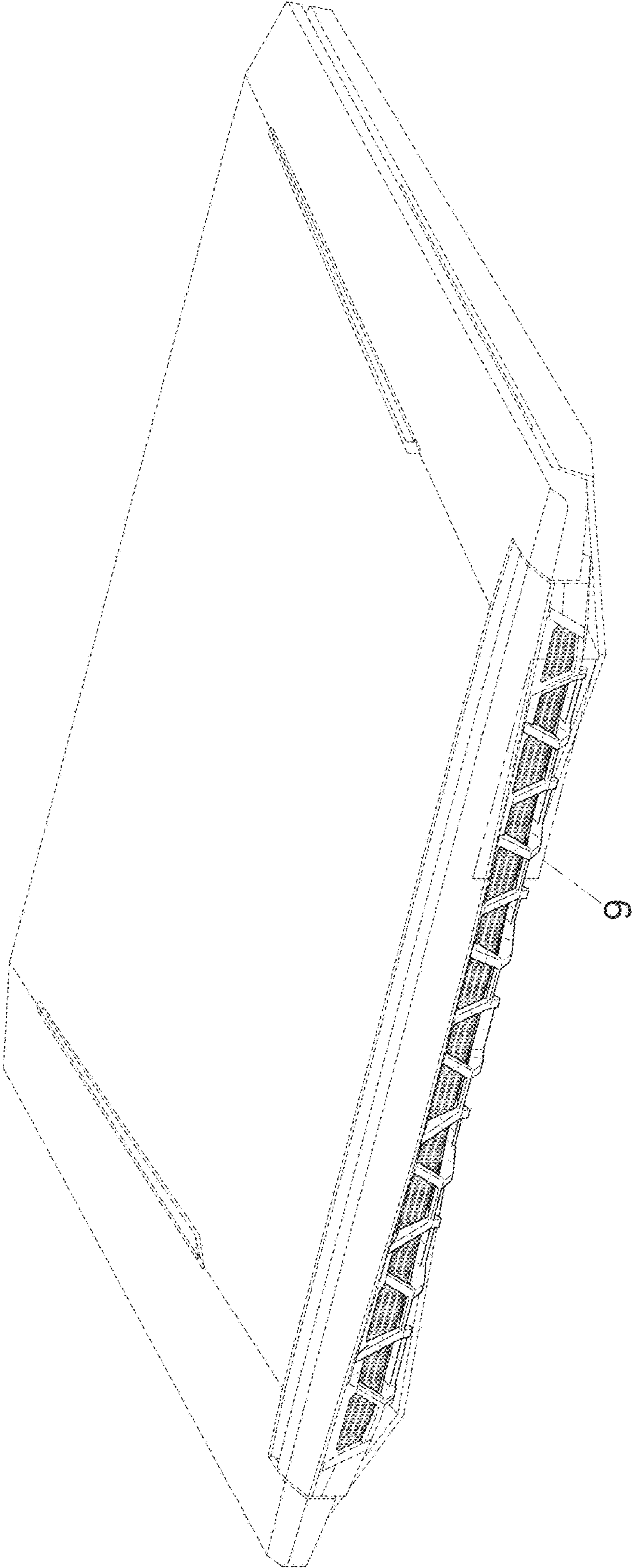

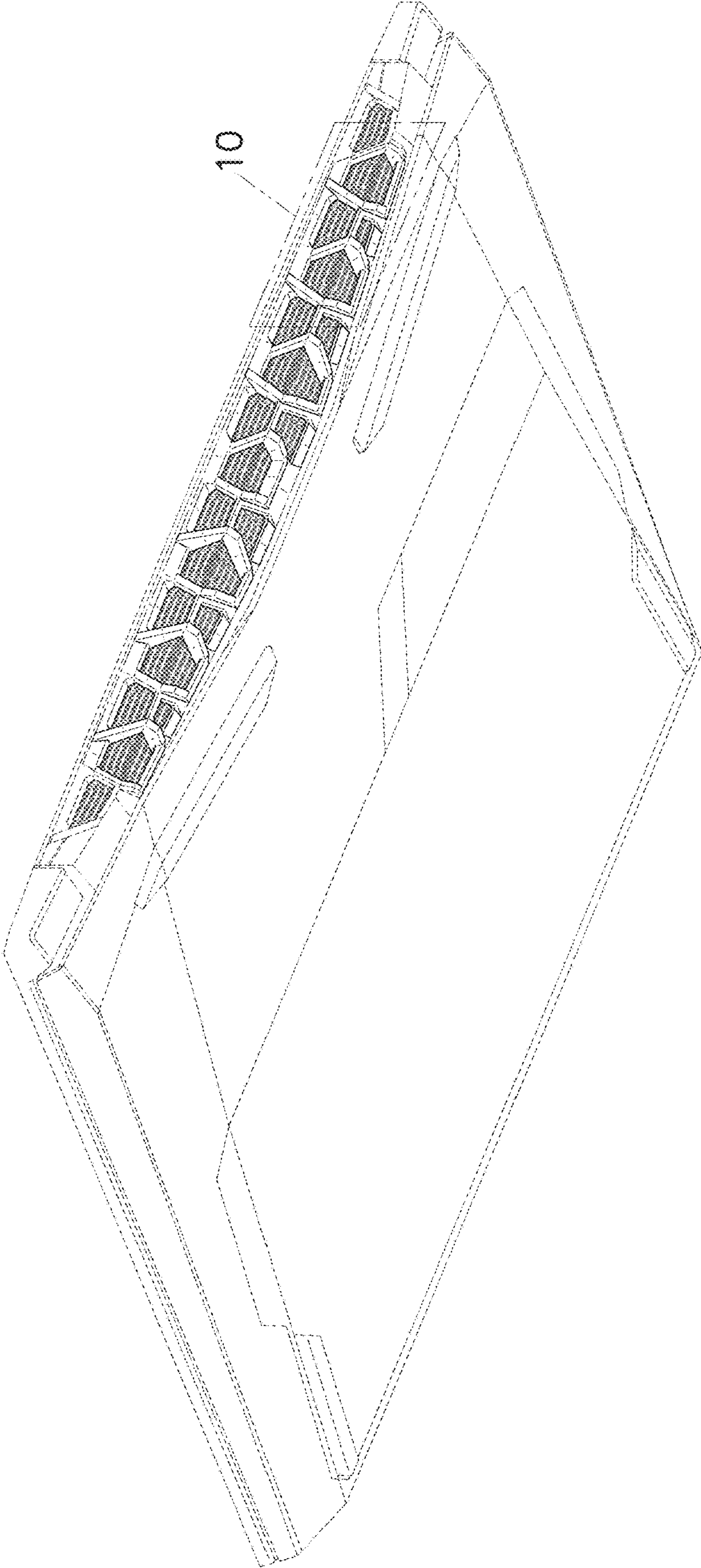

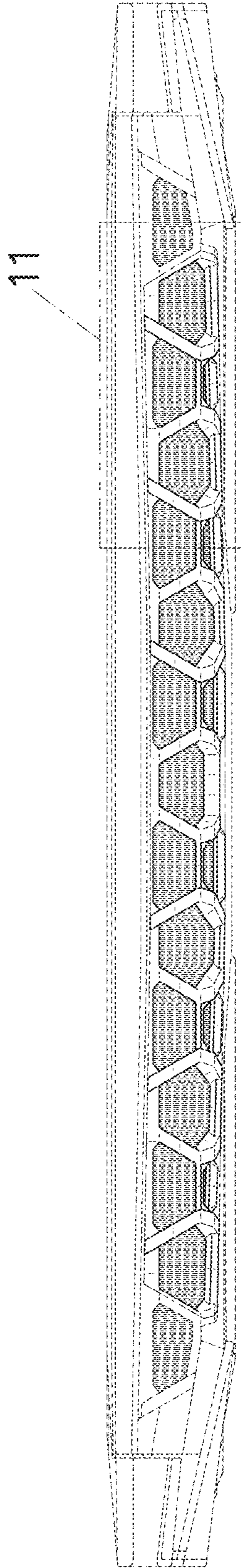

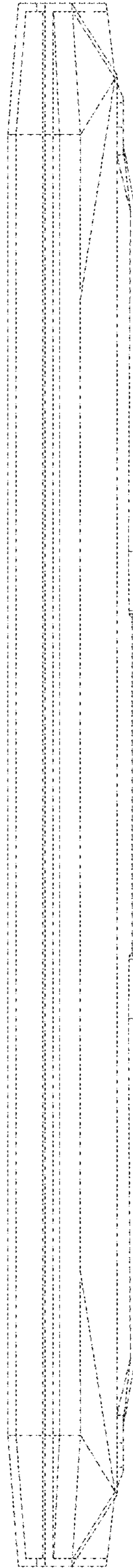

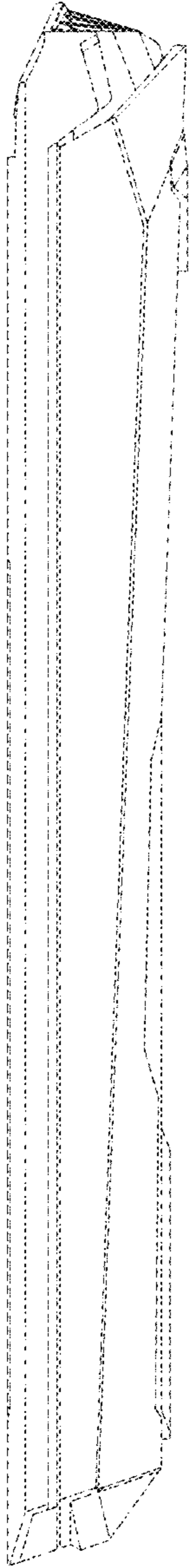

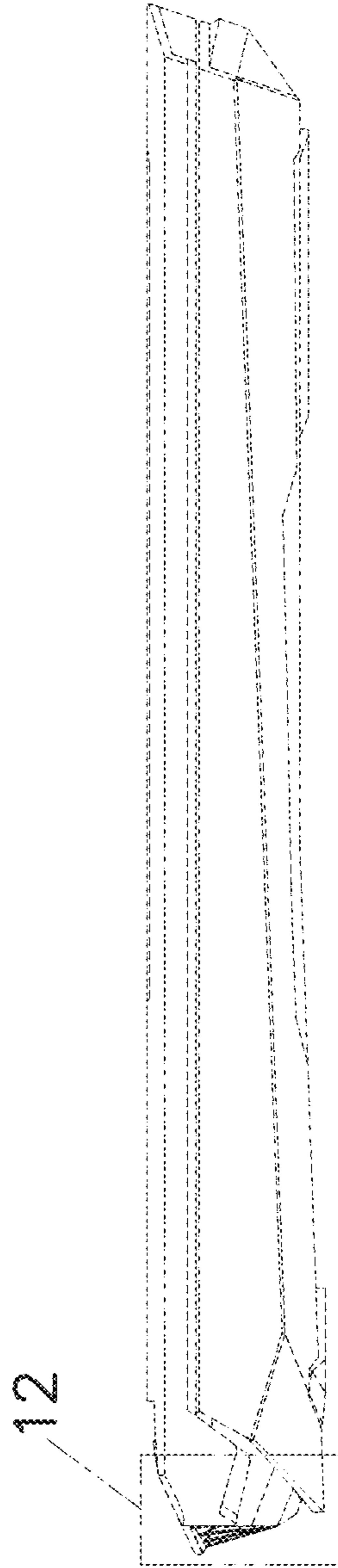

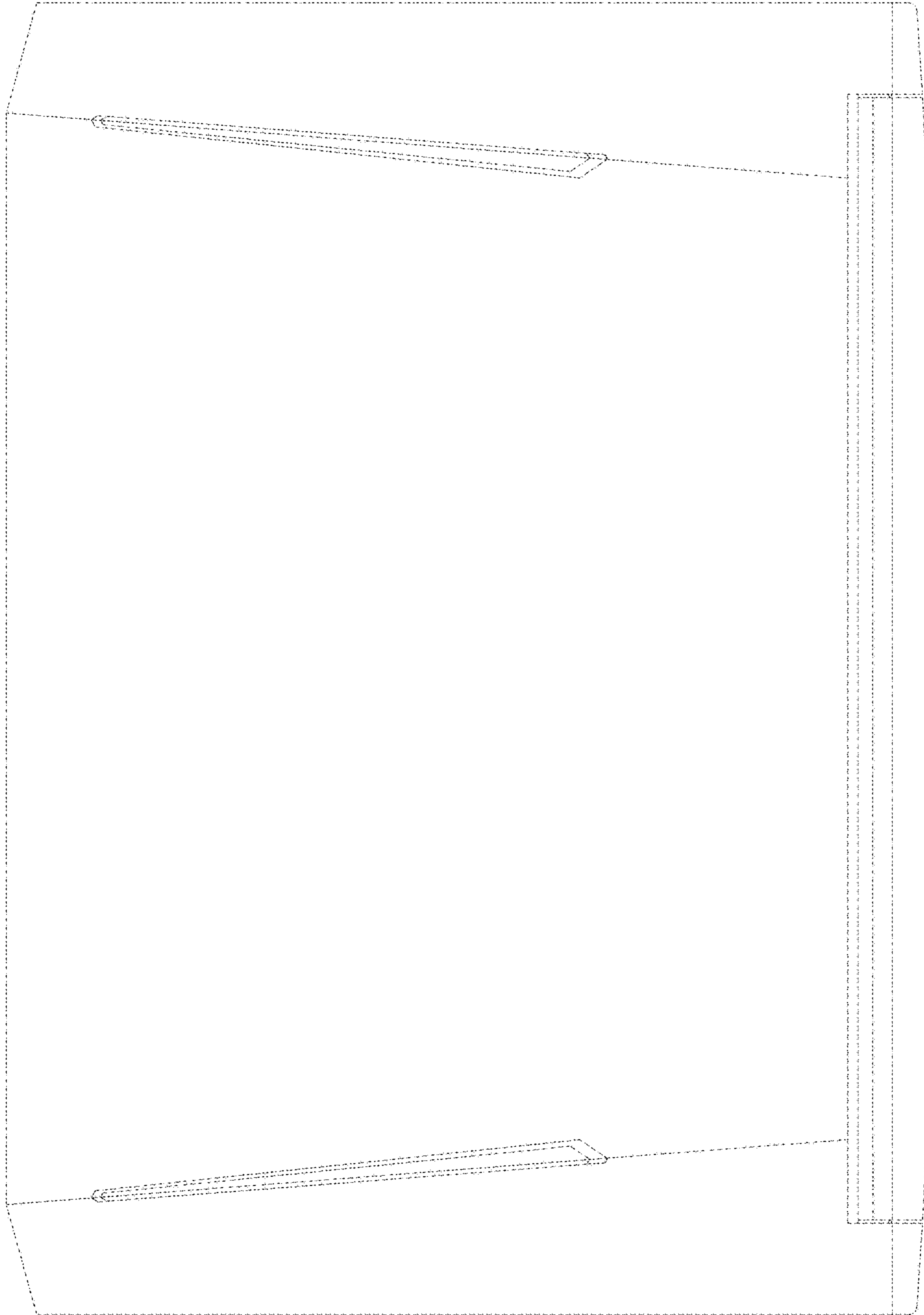

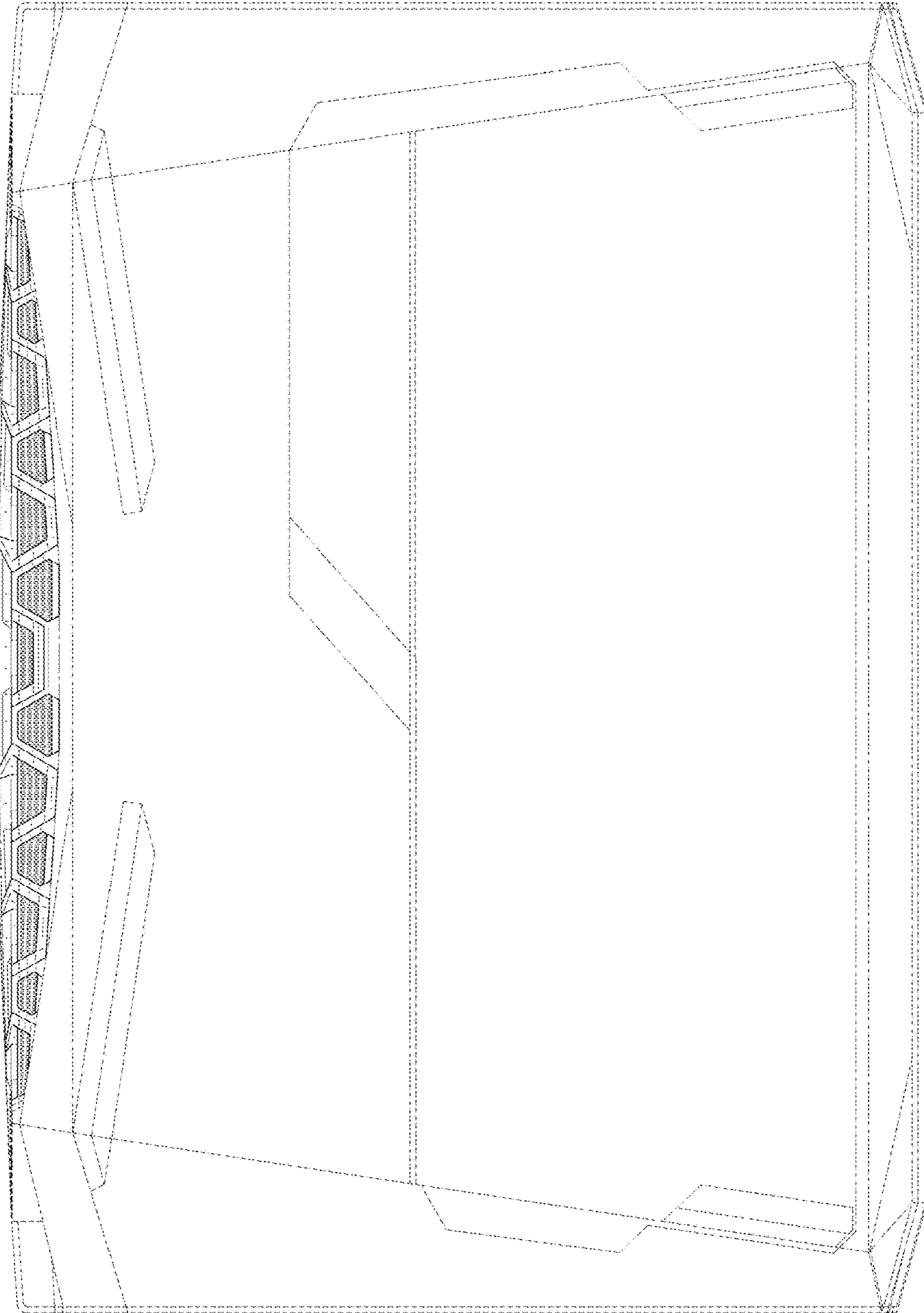

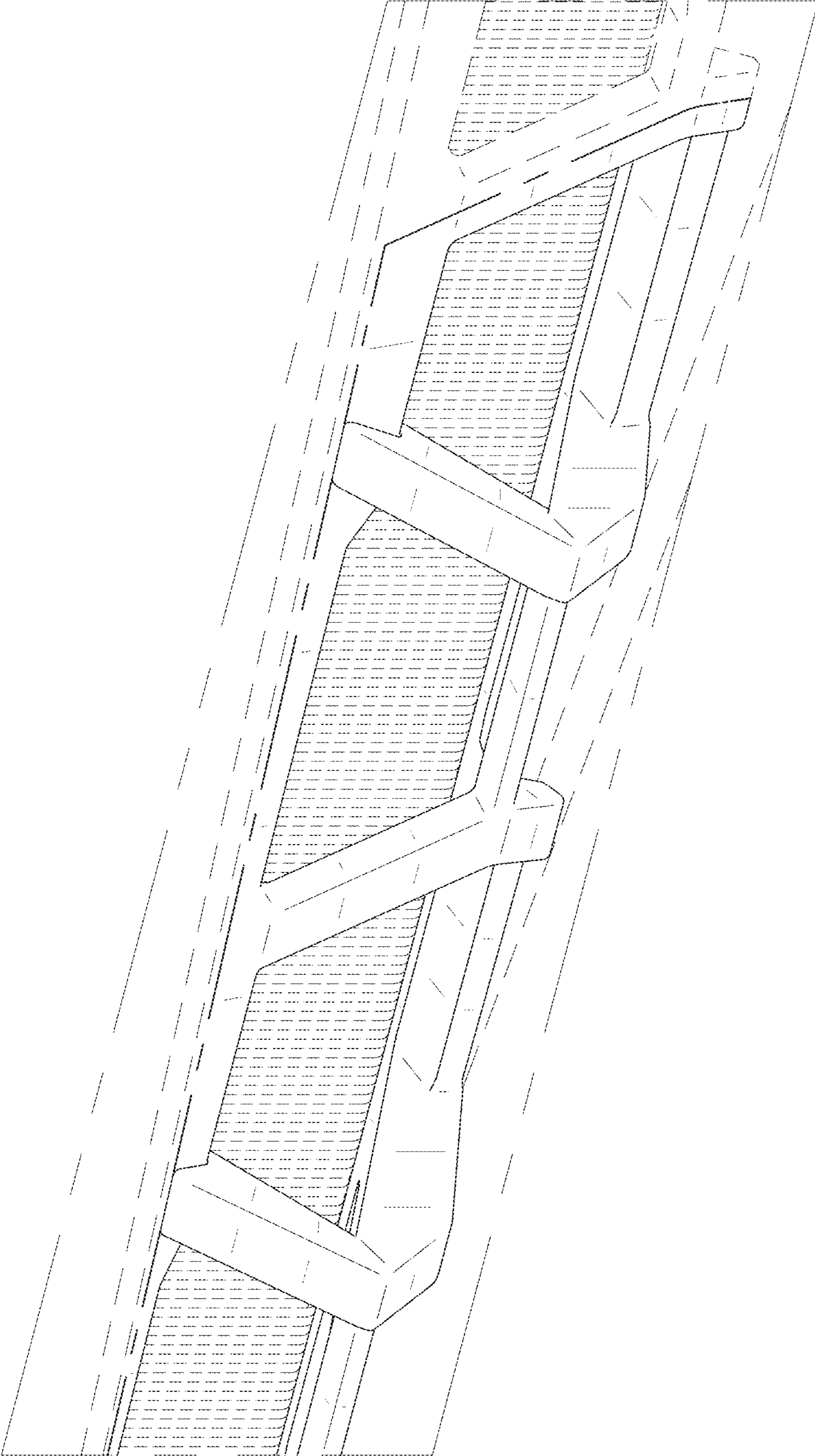

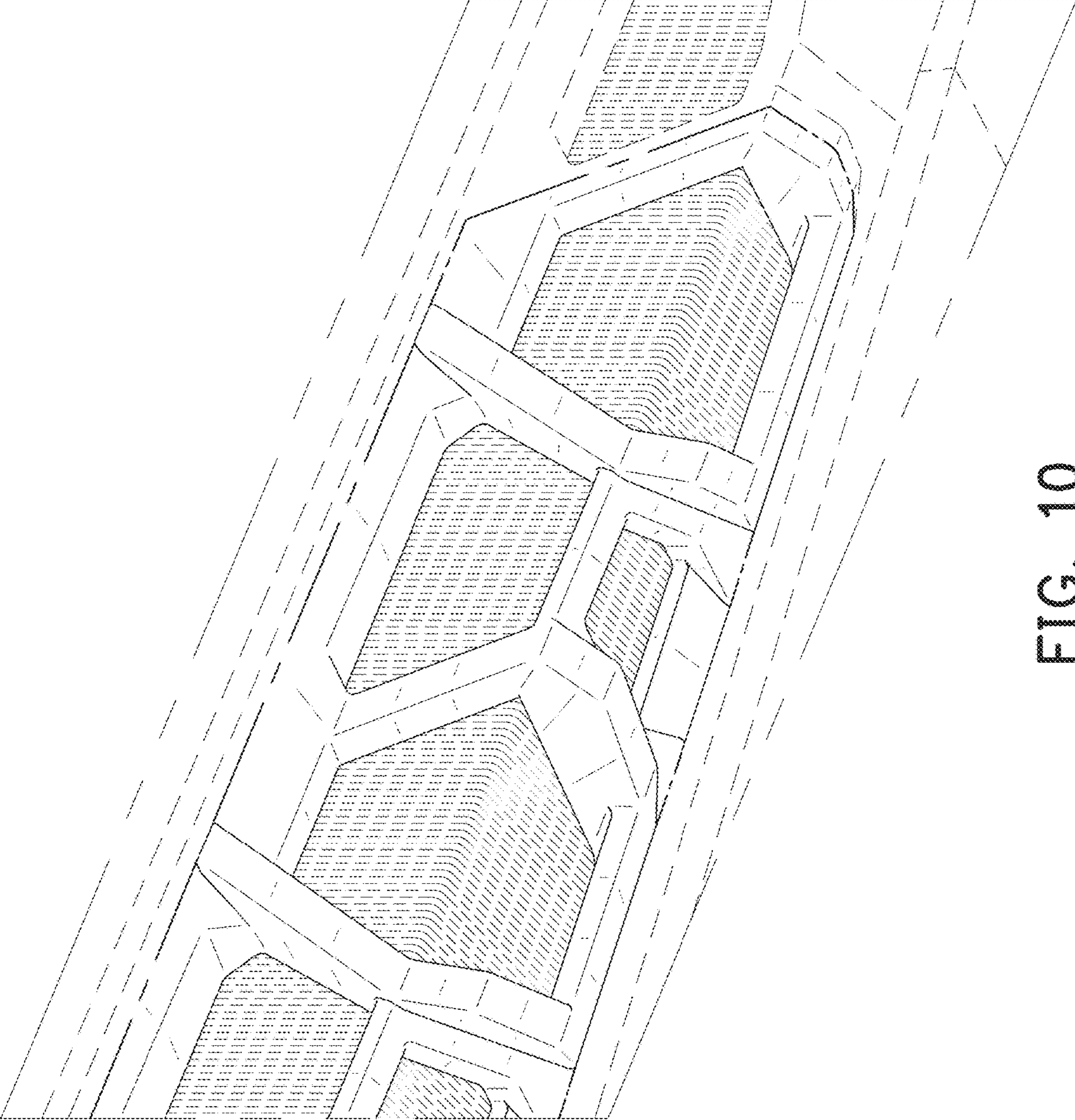

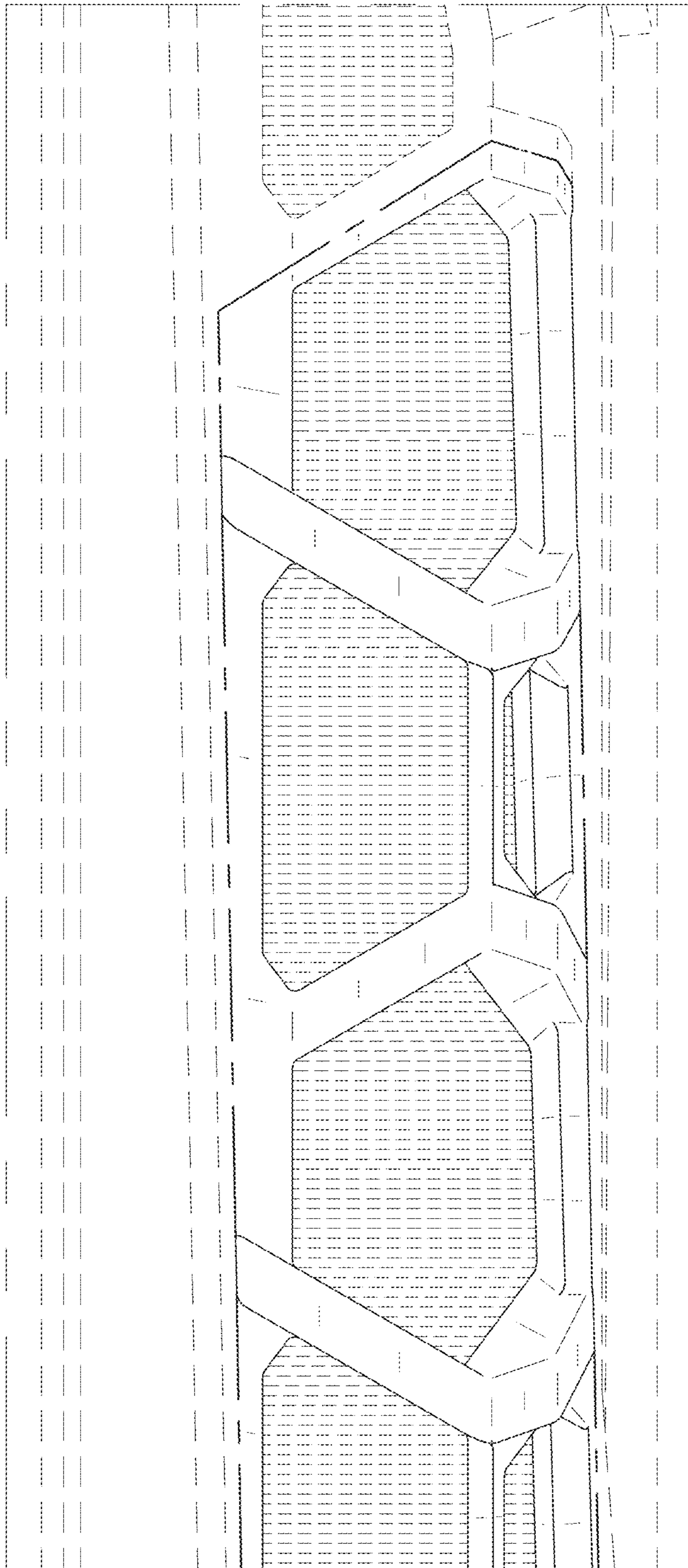

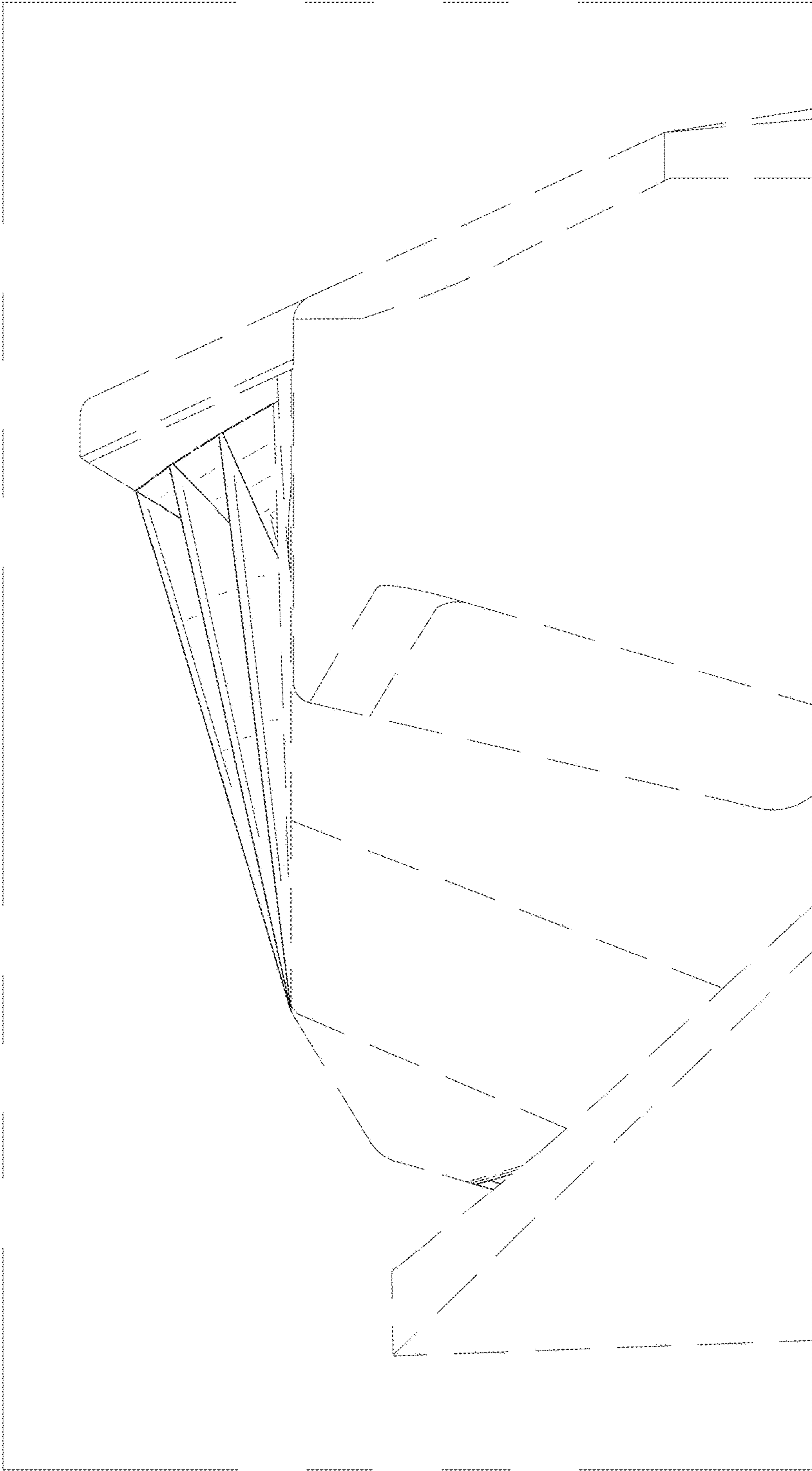
