FIG. 2 is a front view of a display screen or portion thereof with a graphical user interface, showing our new design, according to a second embodiment thereof.

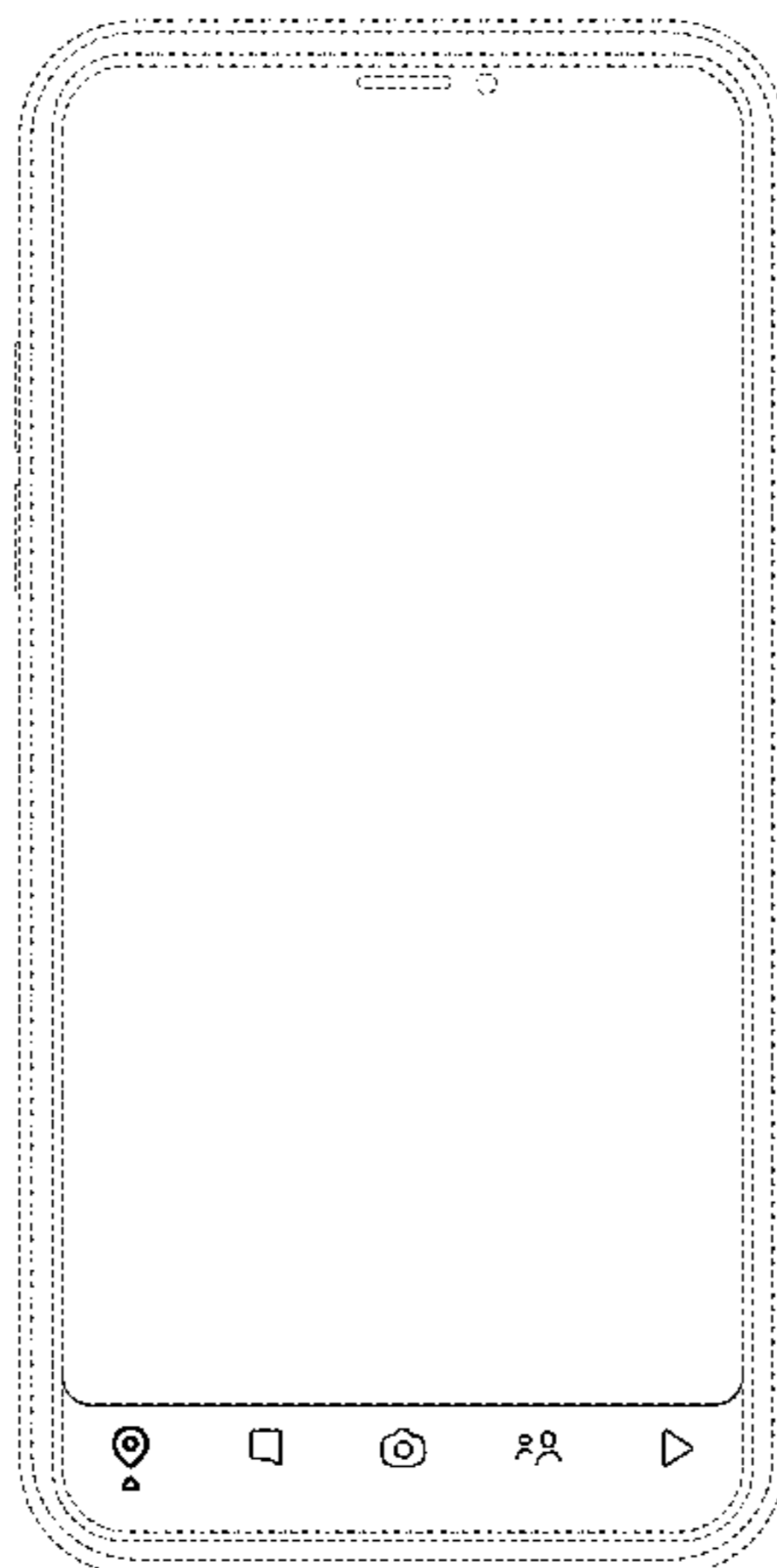
FIG. 3 is a front view of a display screen or portion thereof with a graphical user interface, showing our new design, according to a third embodiment thereof.

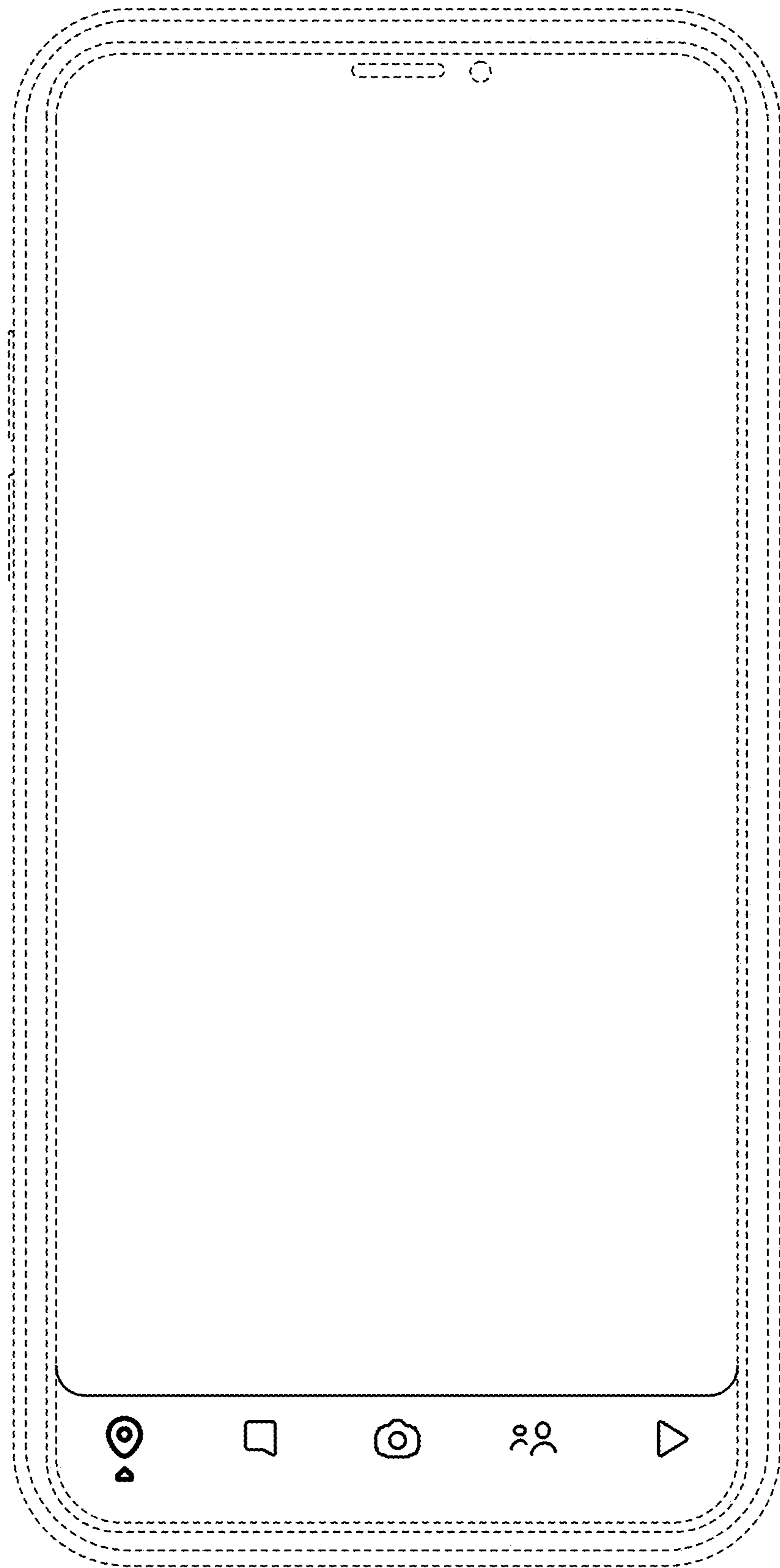

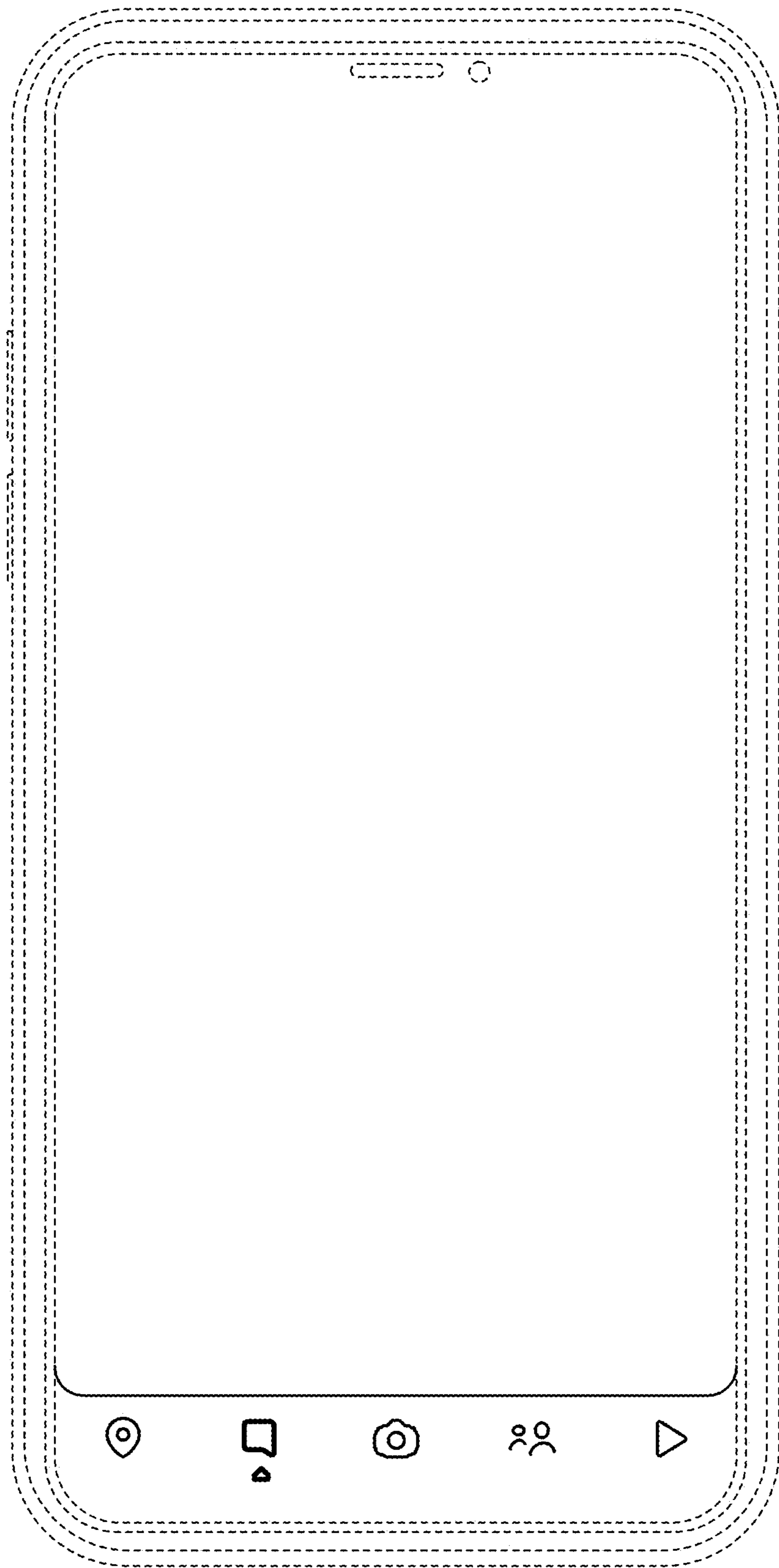

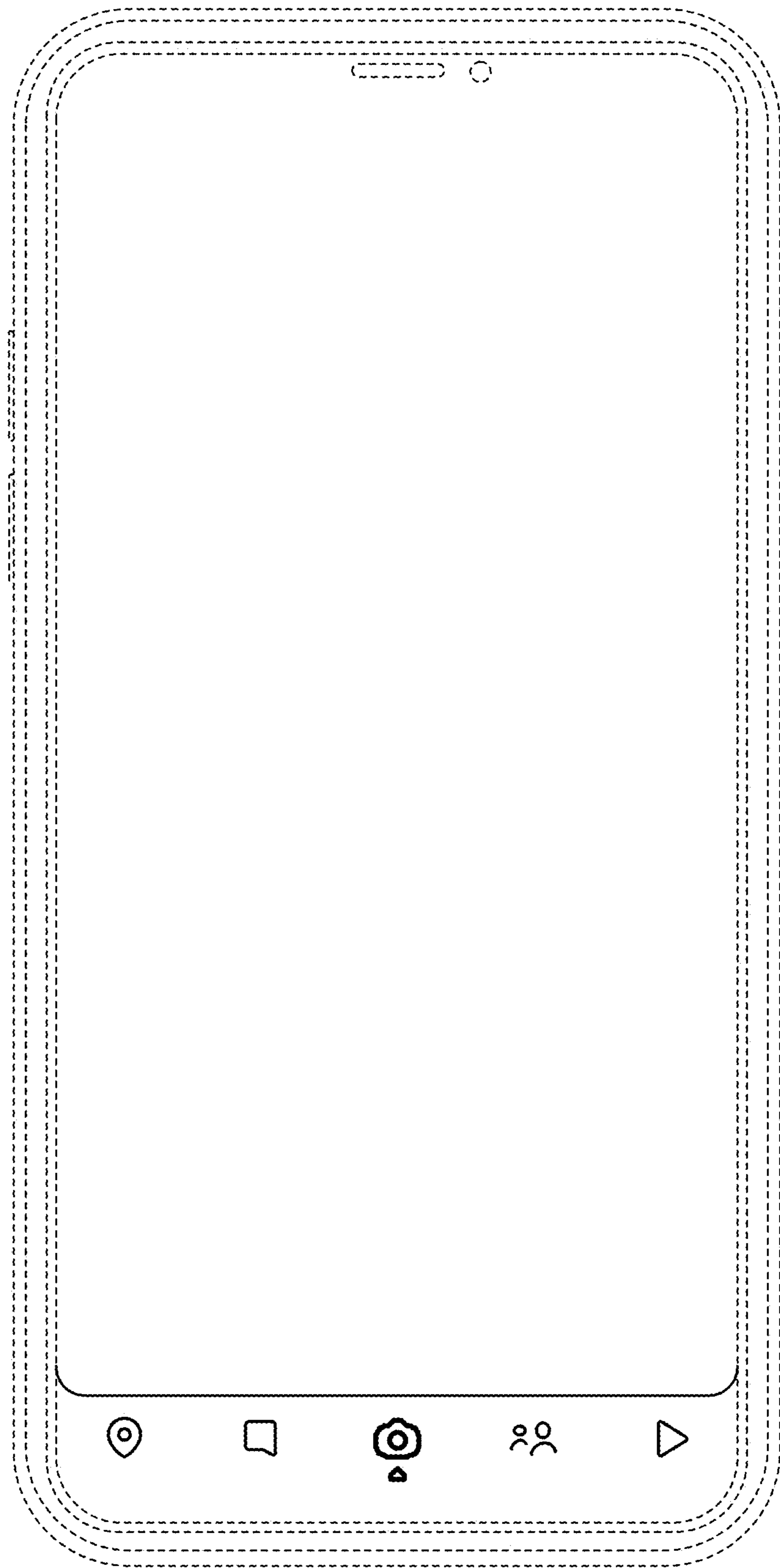

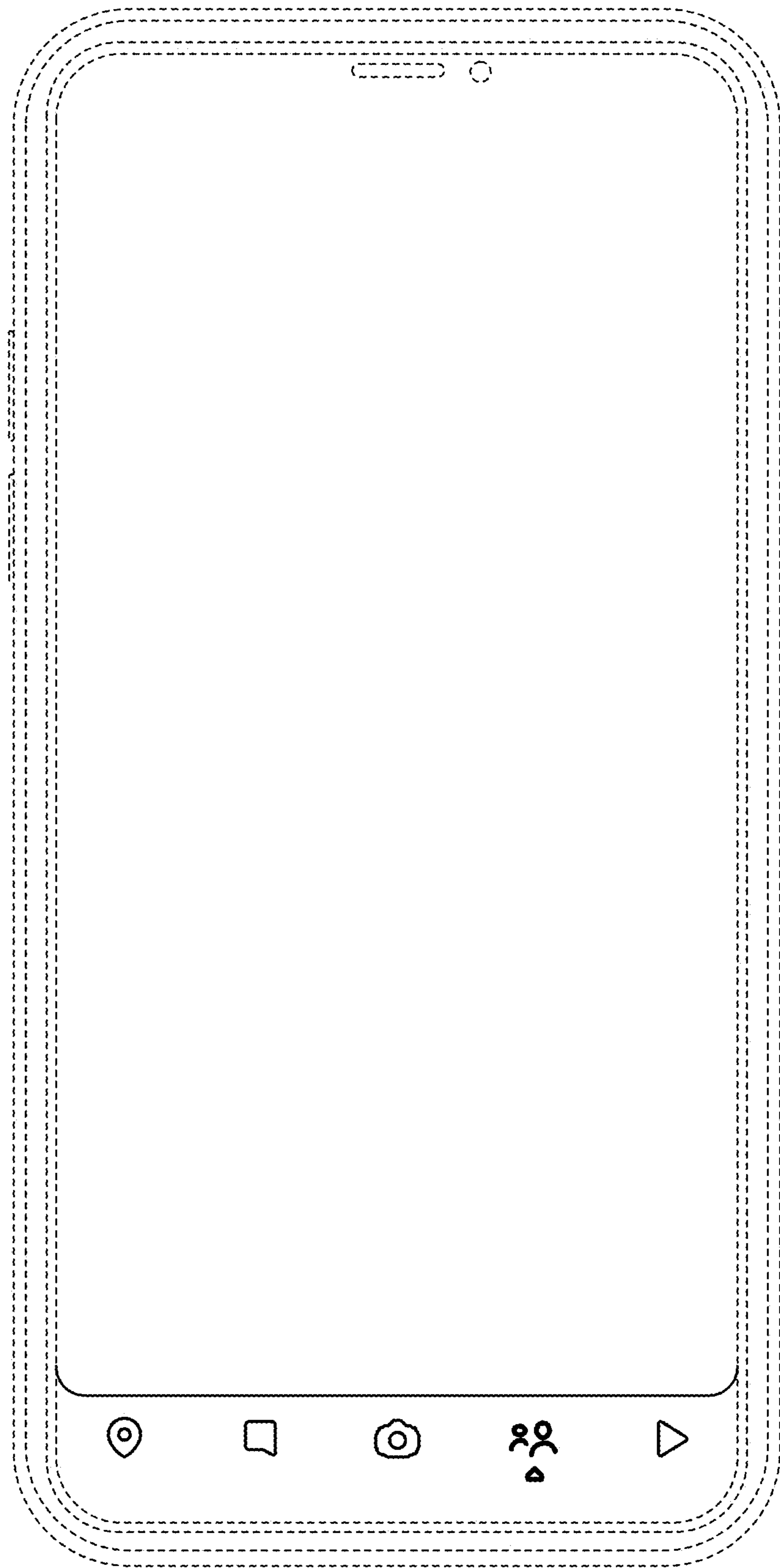

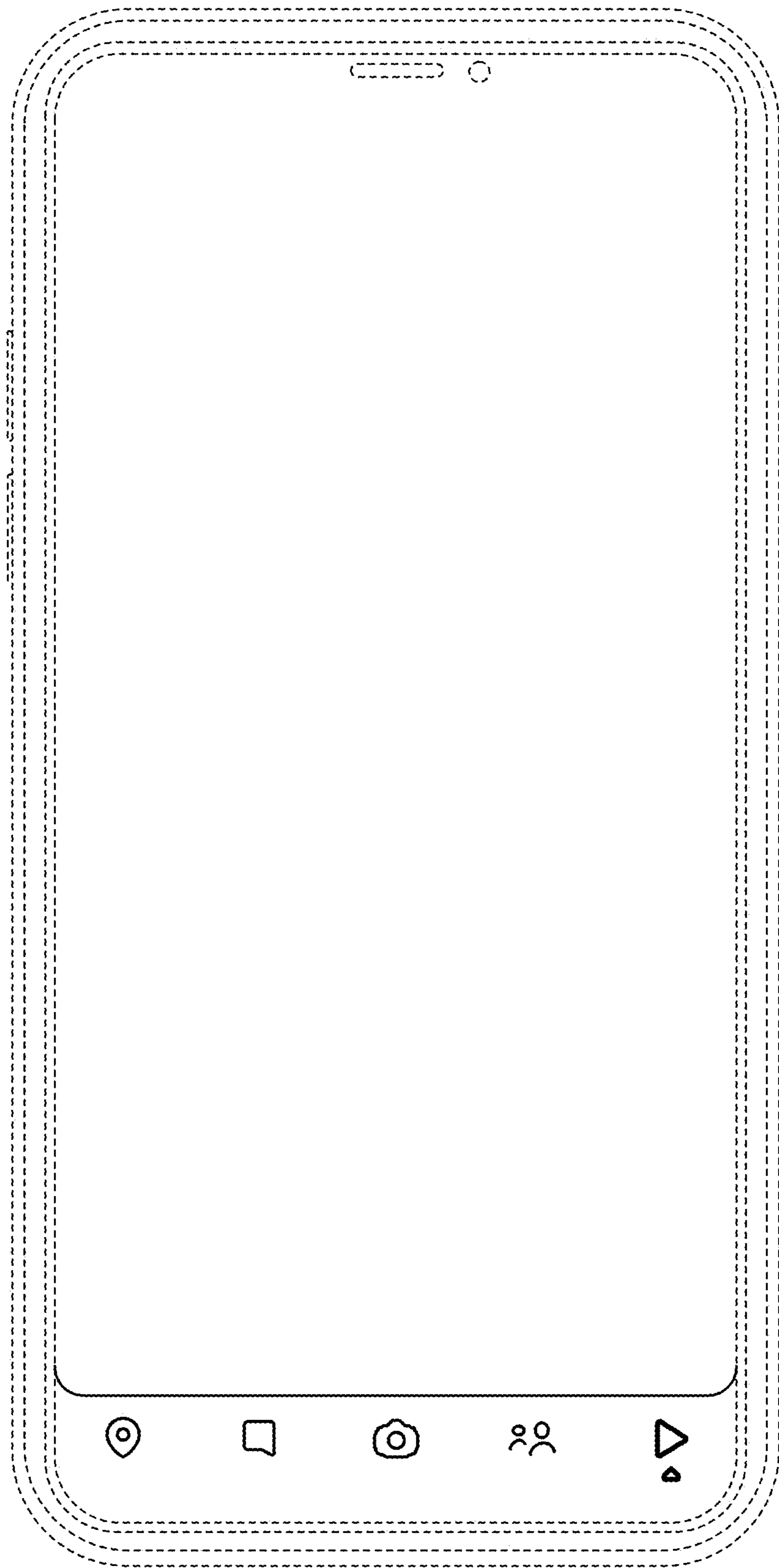
