FIG. 2 is a front view of a display screen or portion thereof with graphical user interface showing my new design according to a second embodiment.

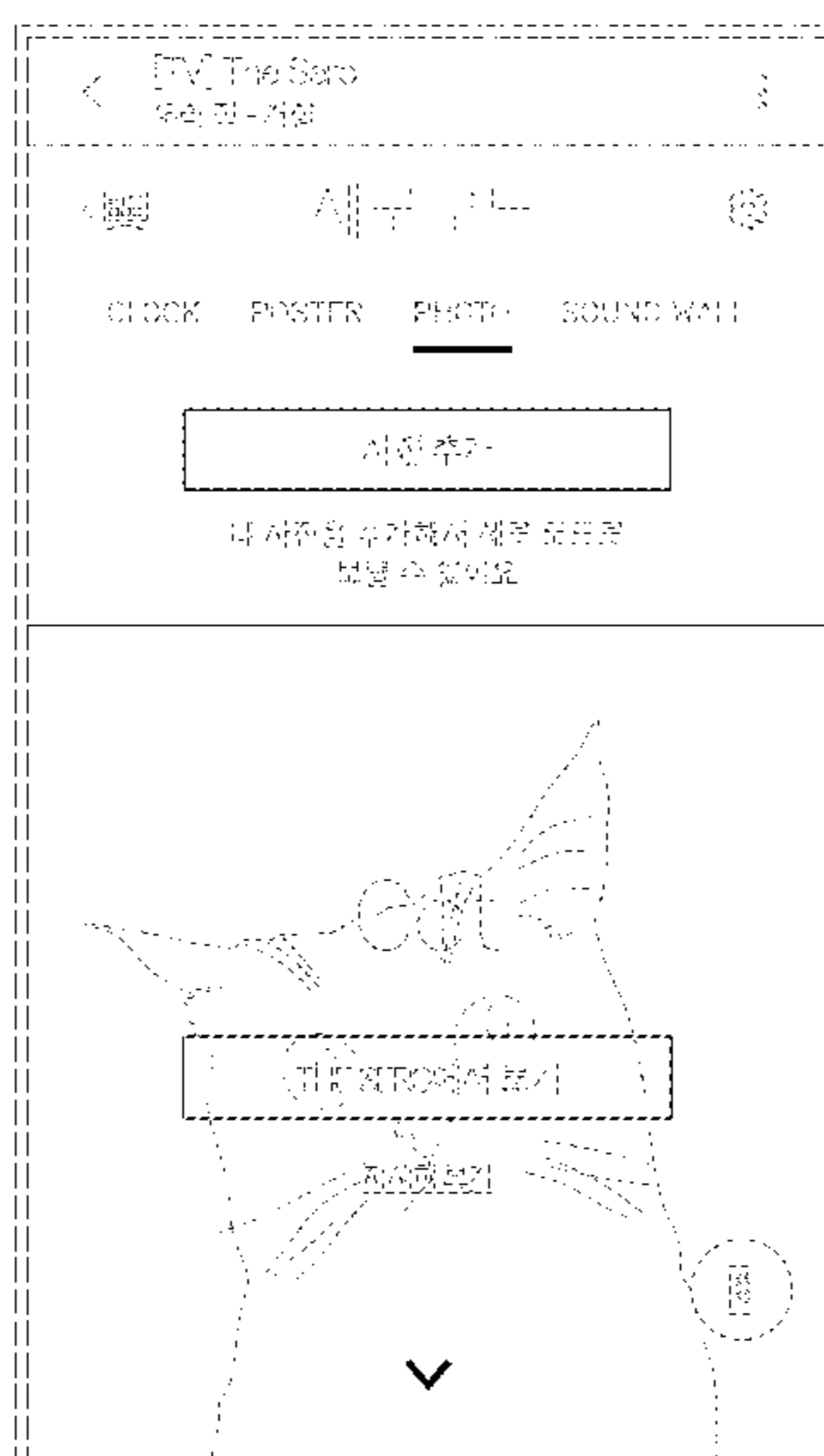

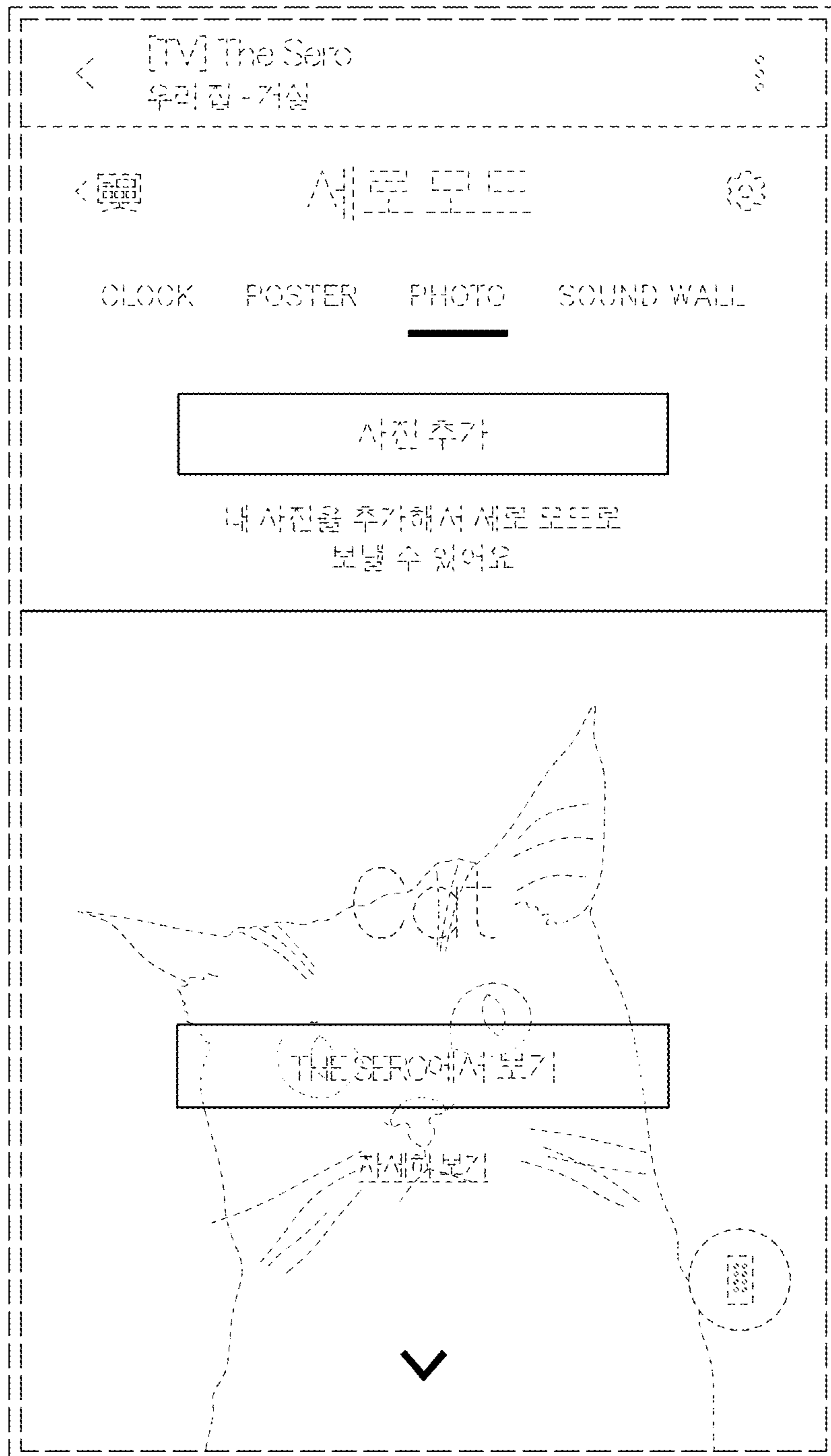
