FIG. 22 is a top plan view thereof;

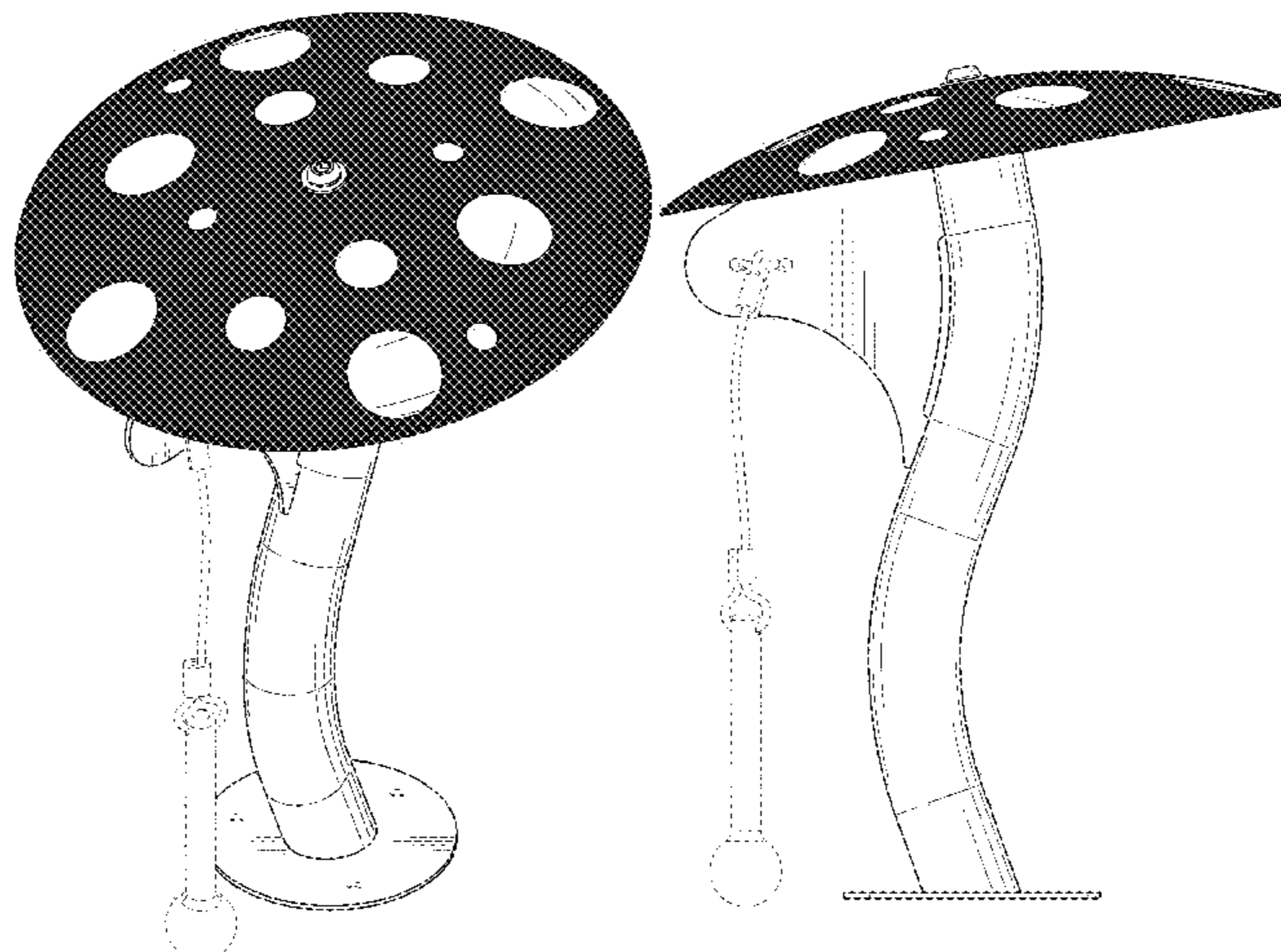
FIG. 23 is a bottom plan view thereof; and,

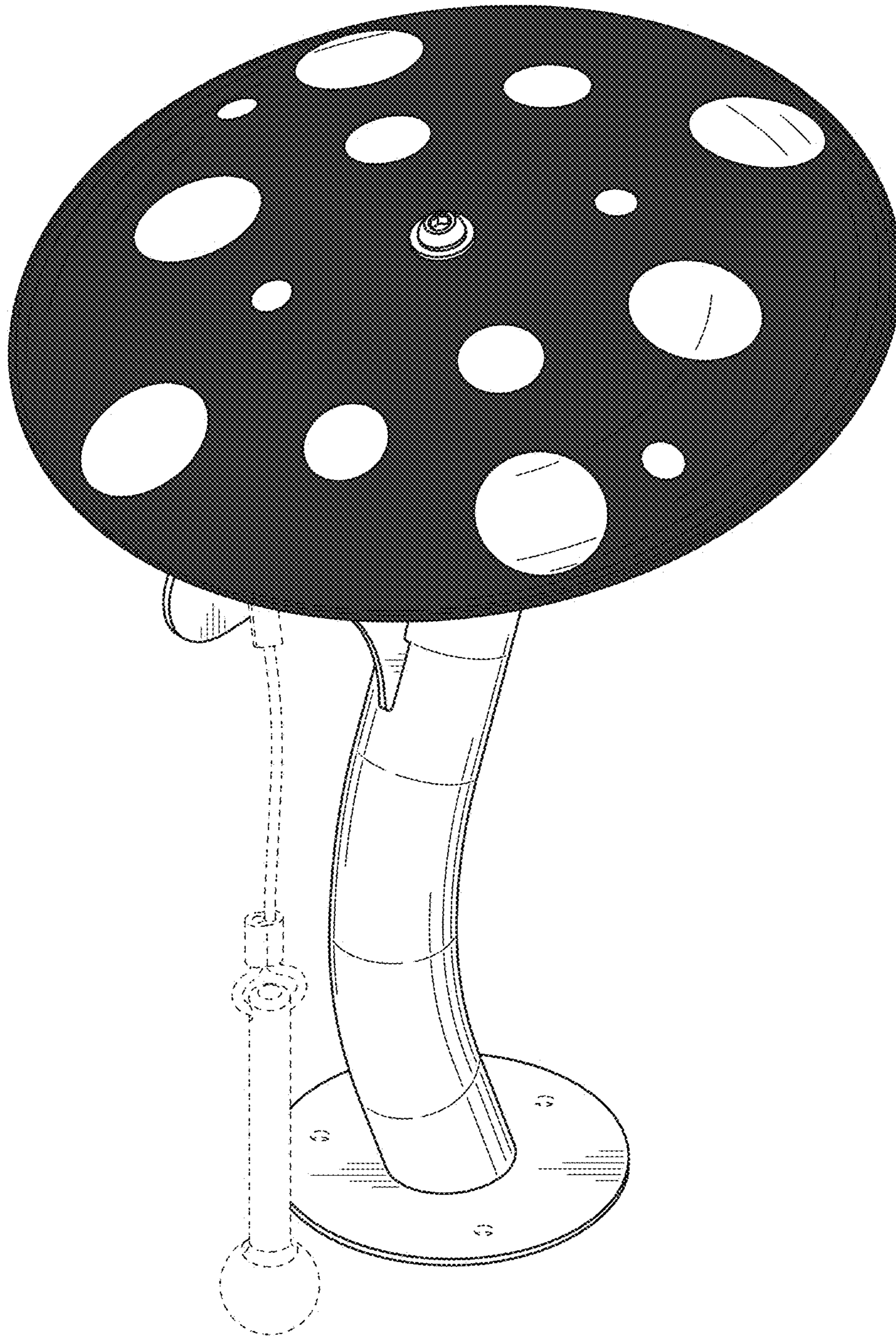

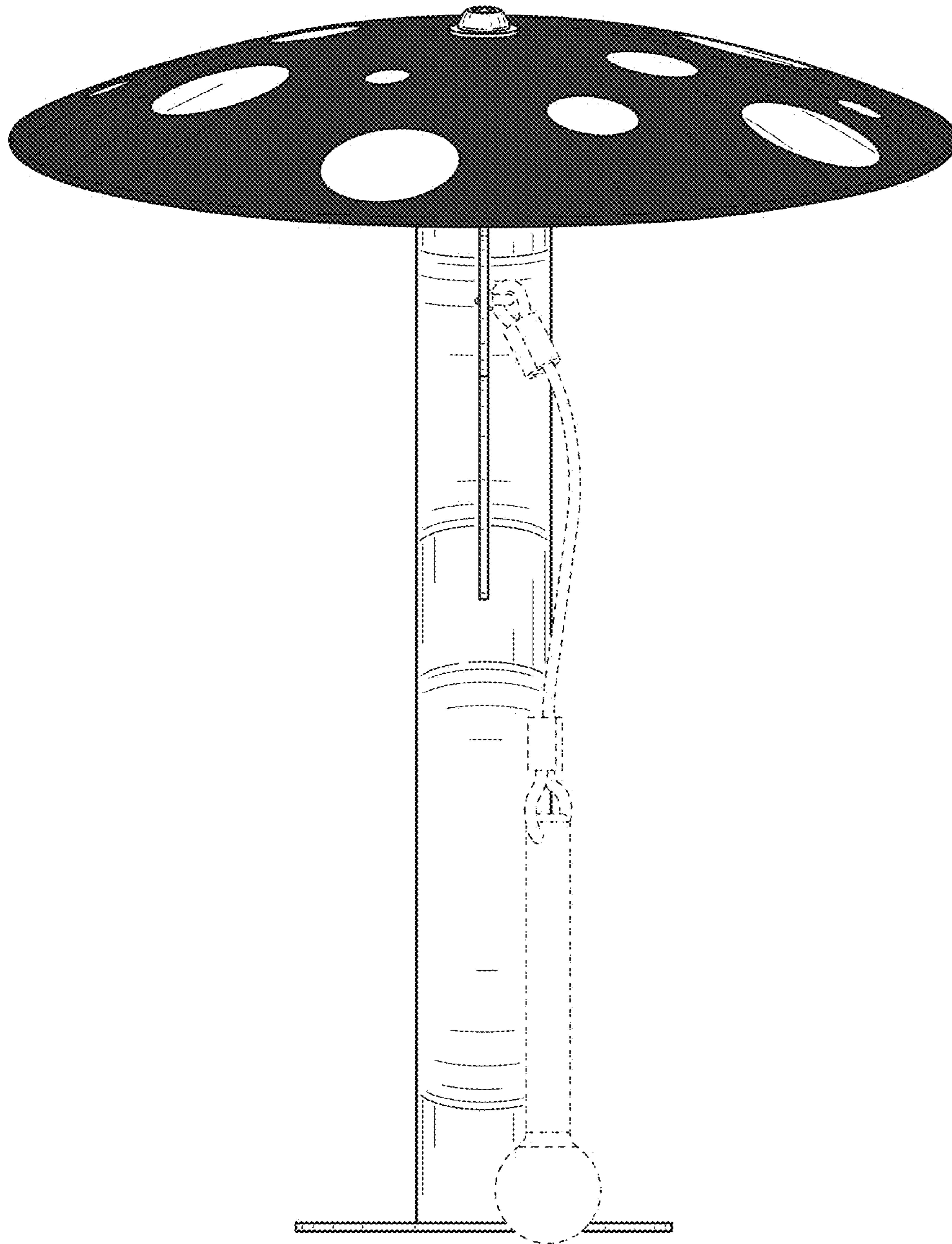

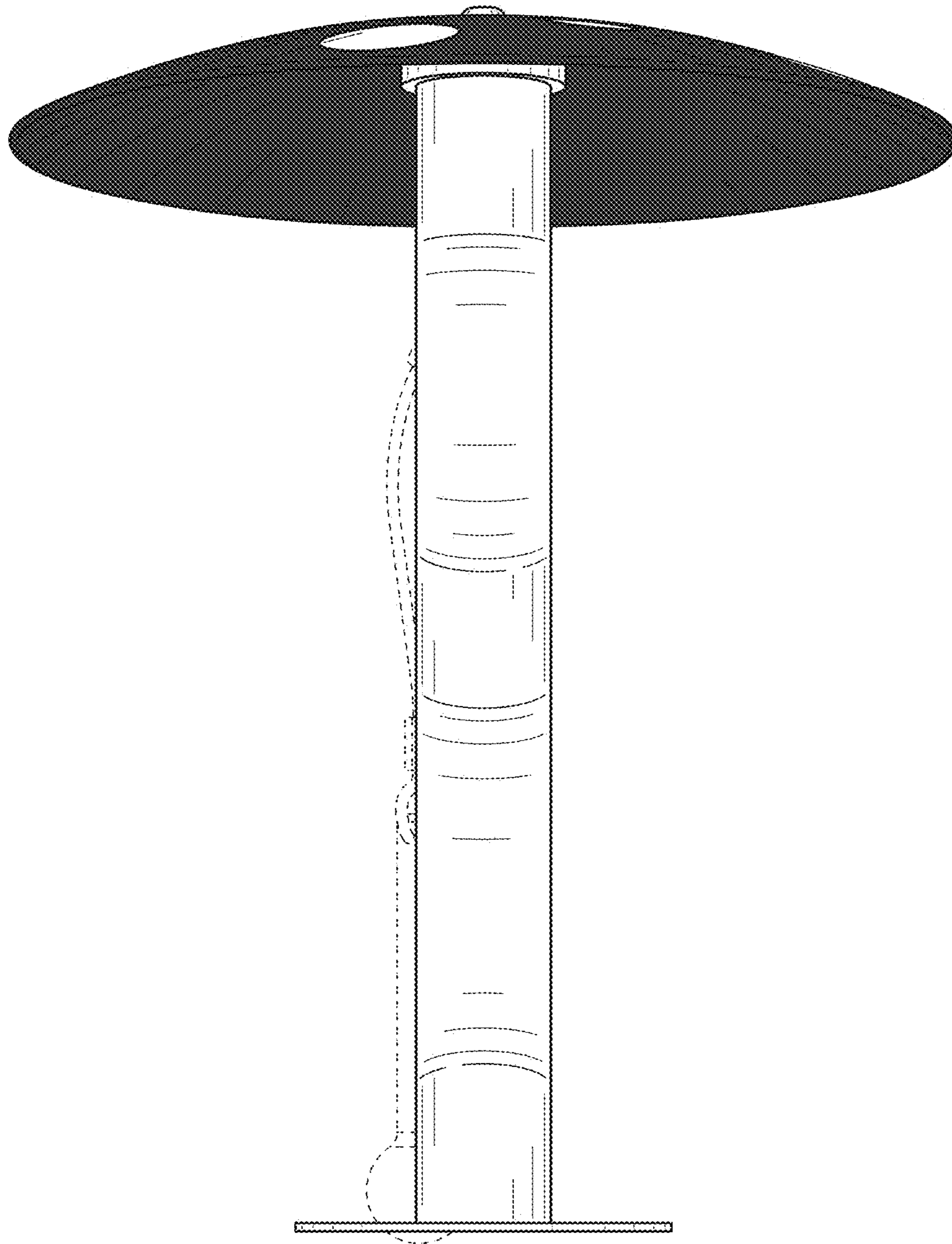

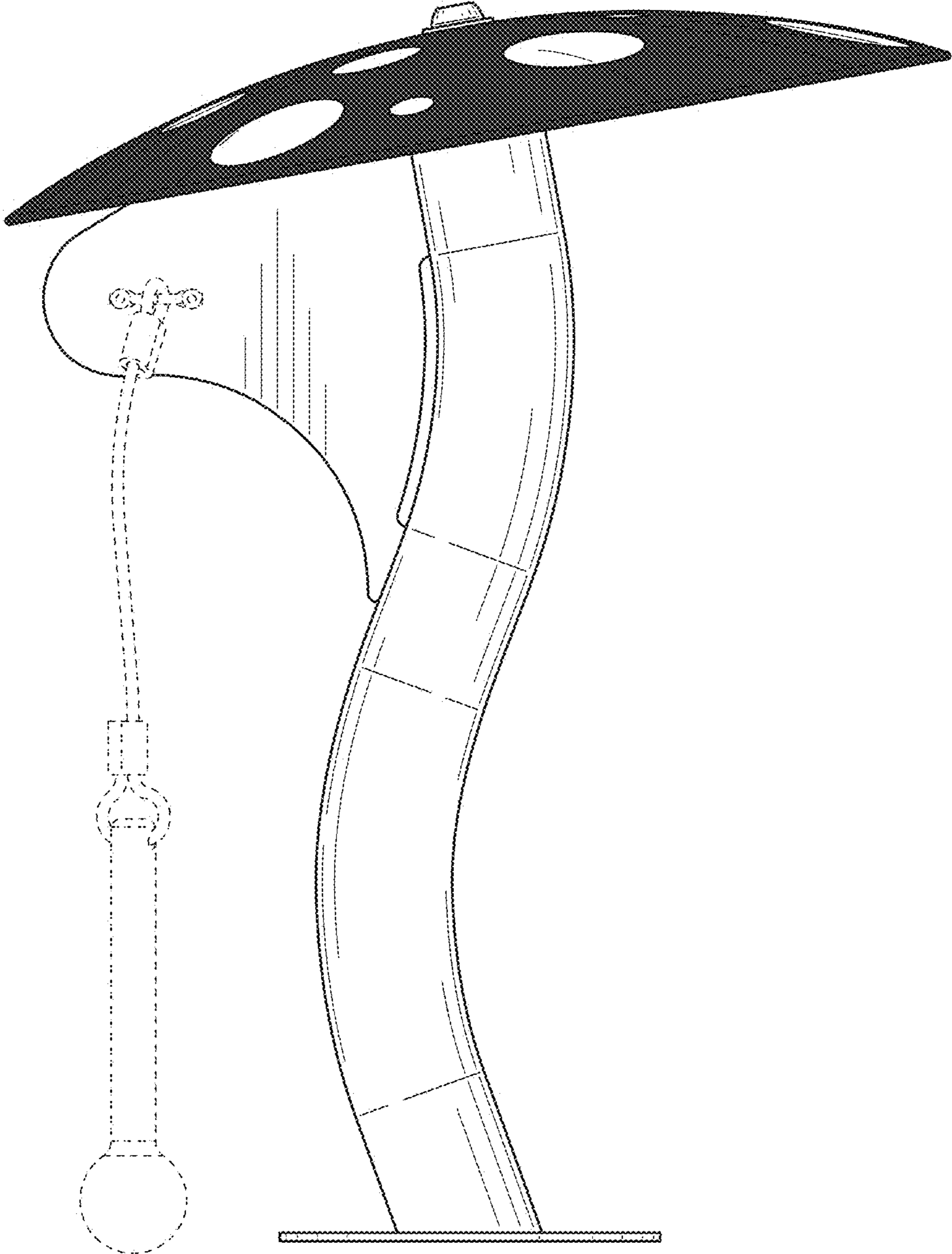

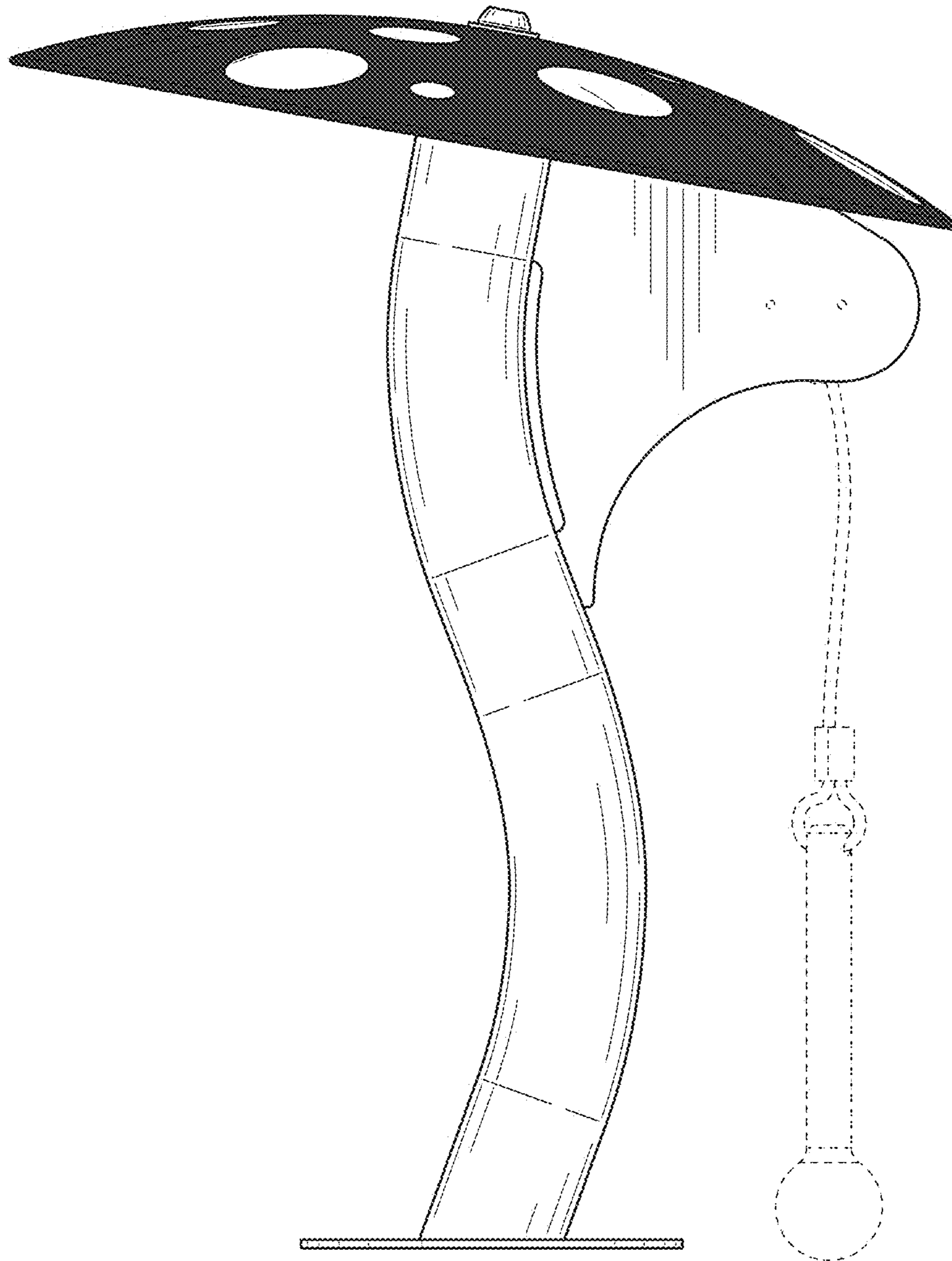

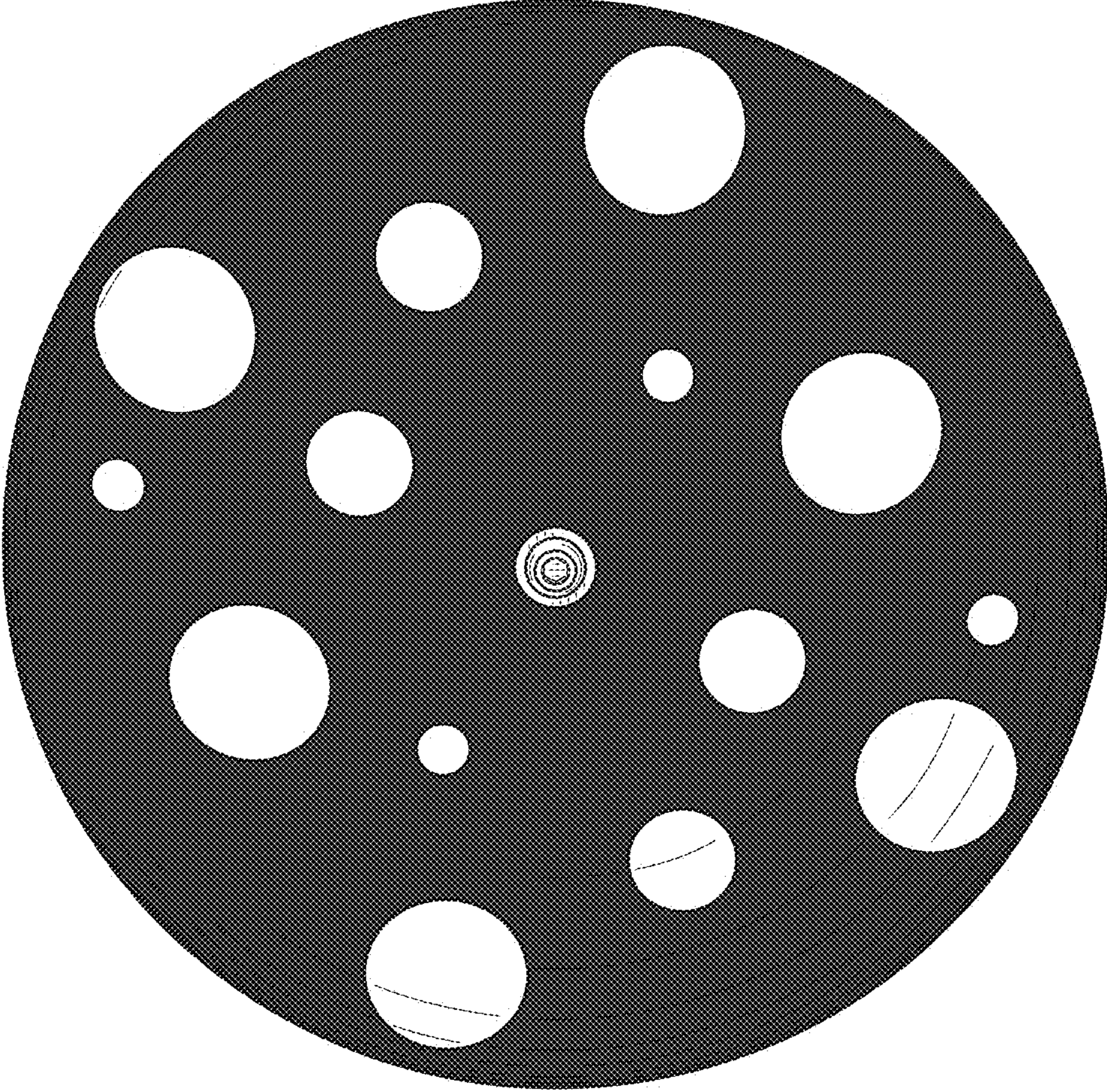

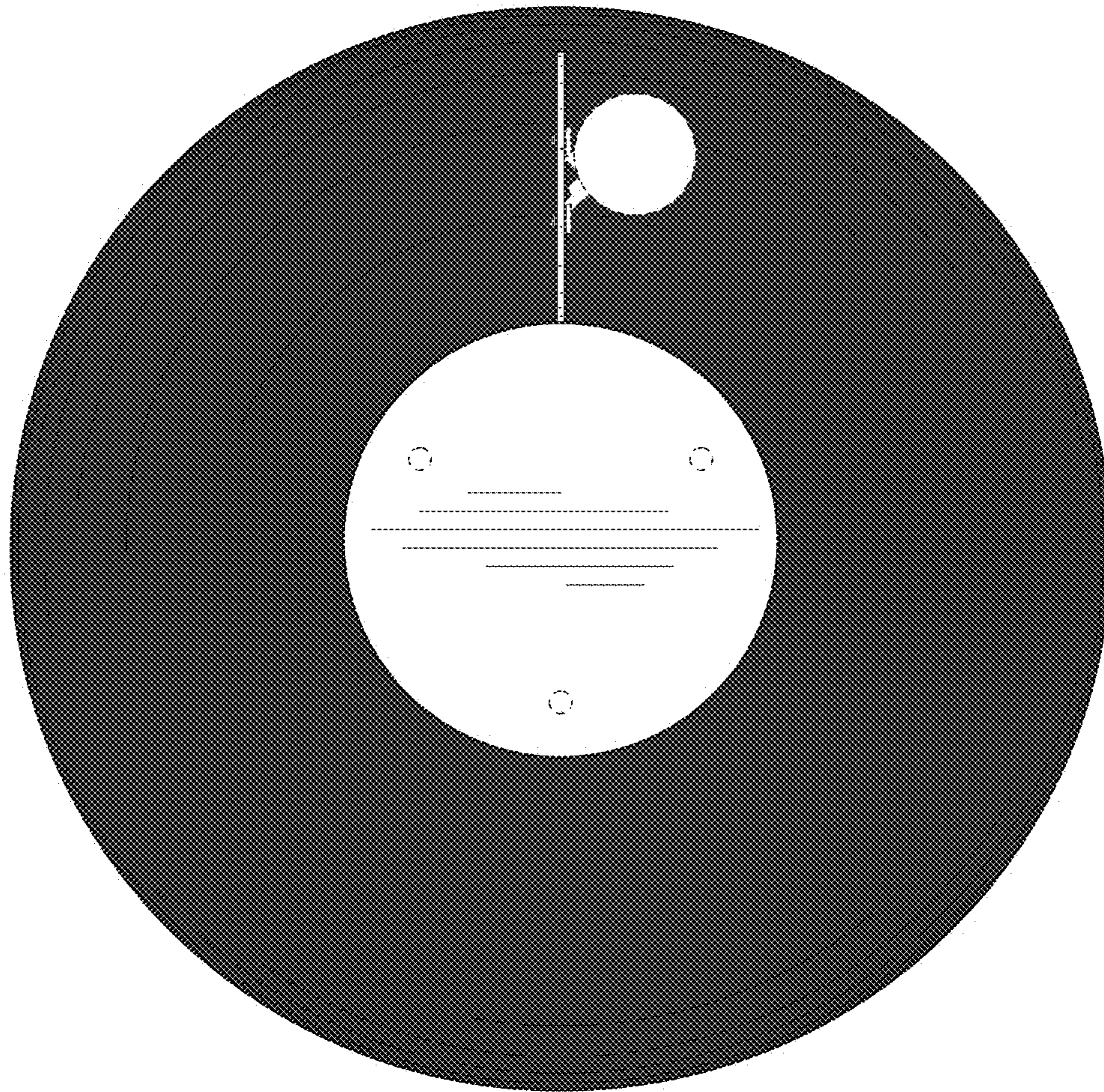

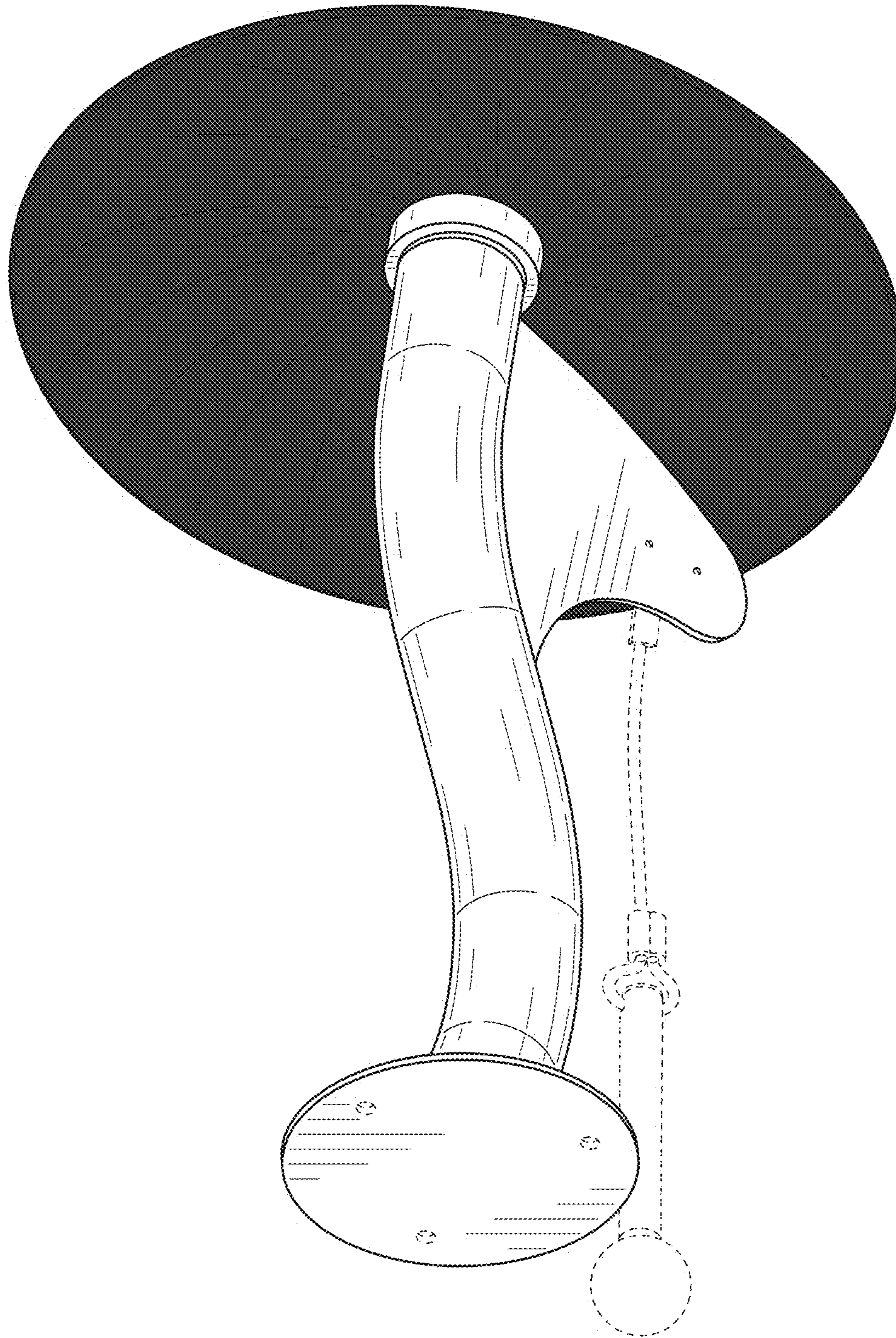

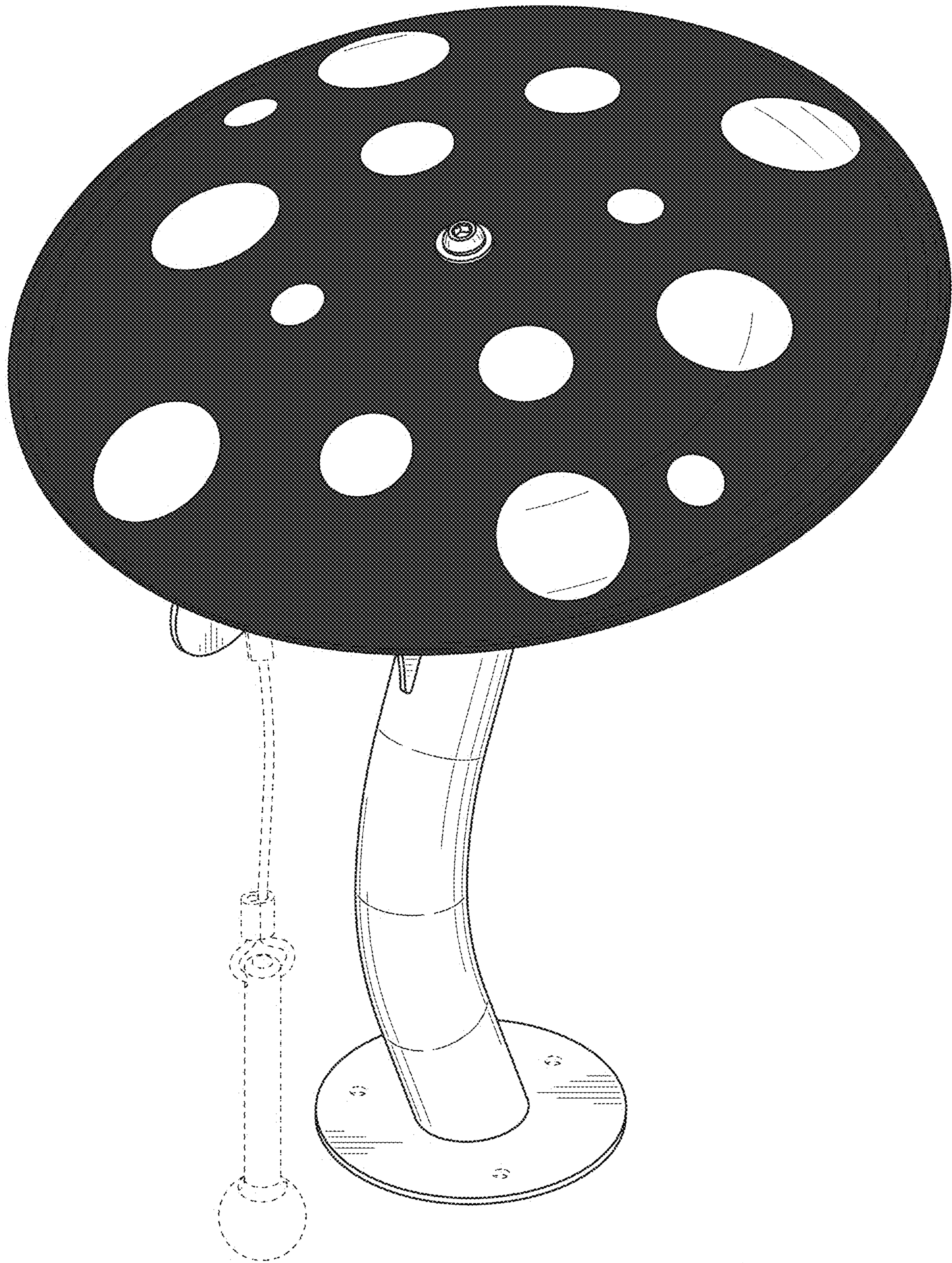

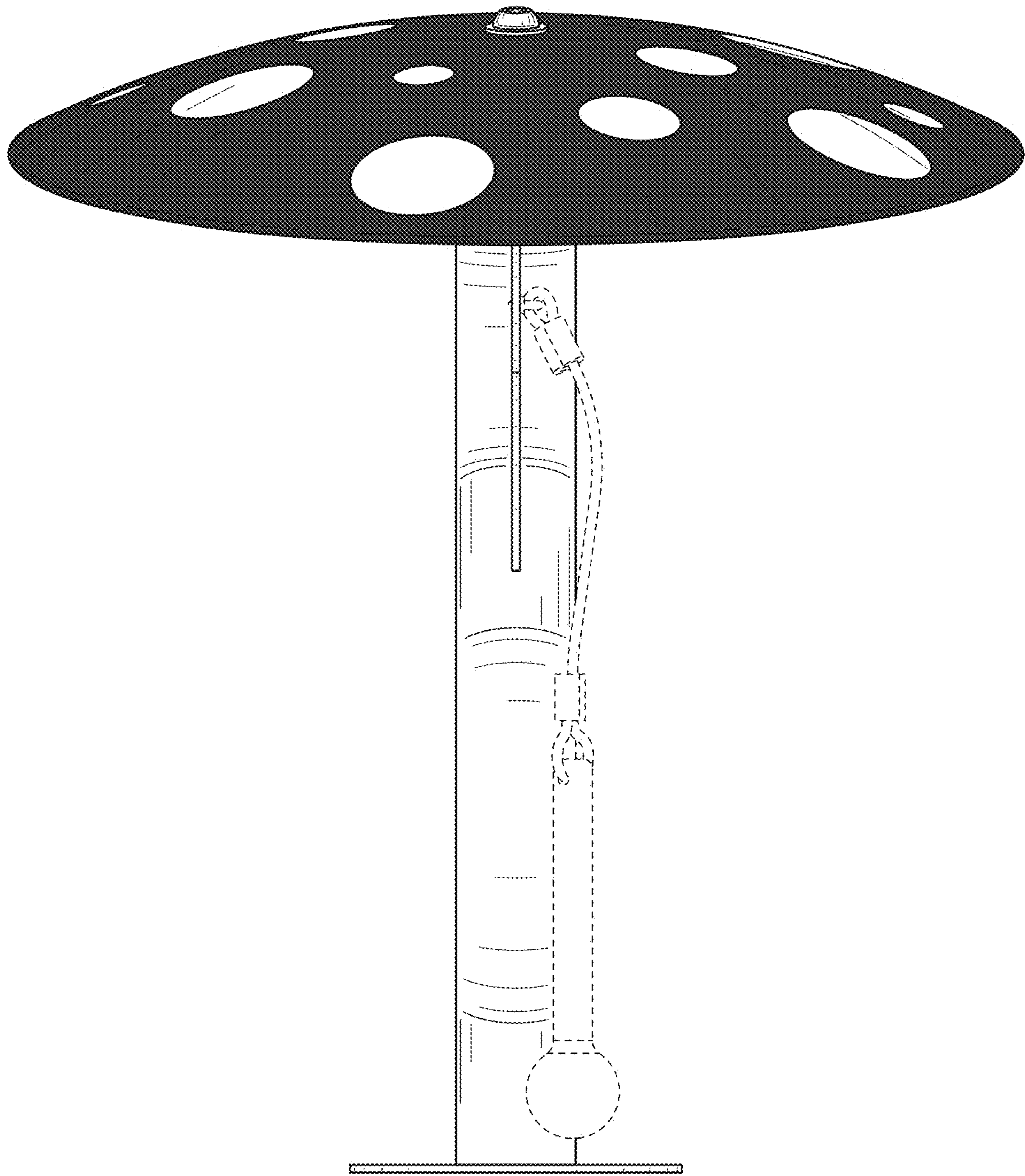

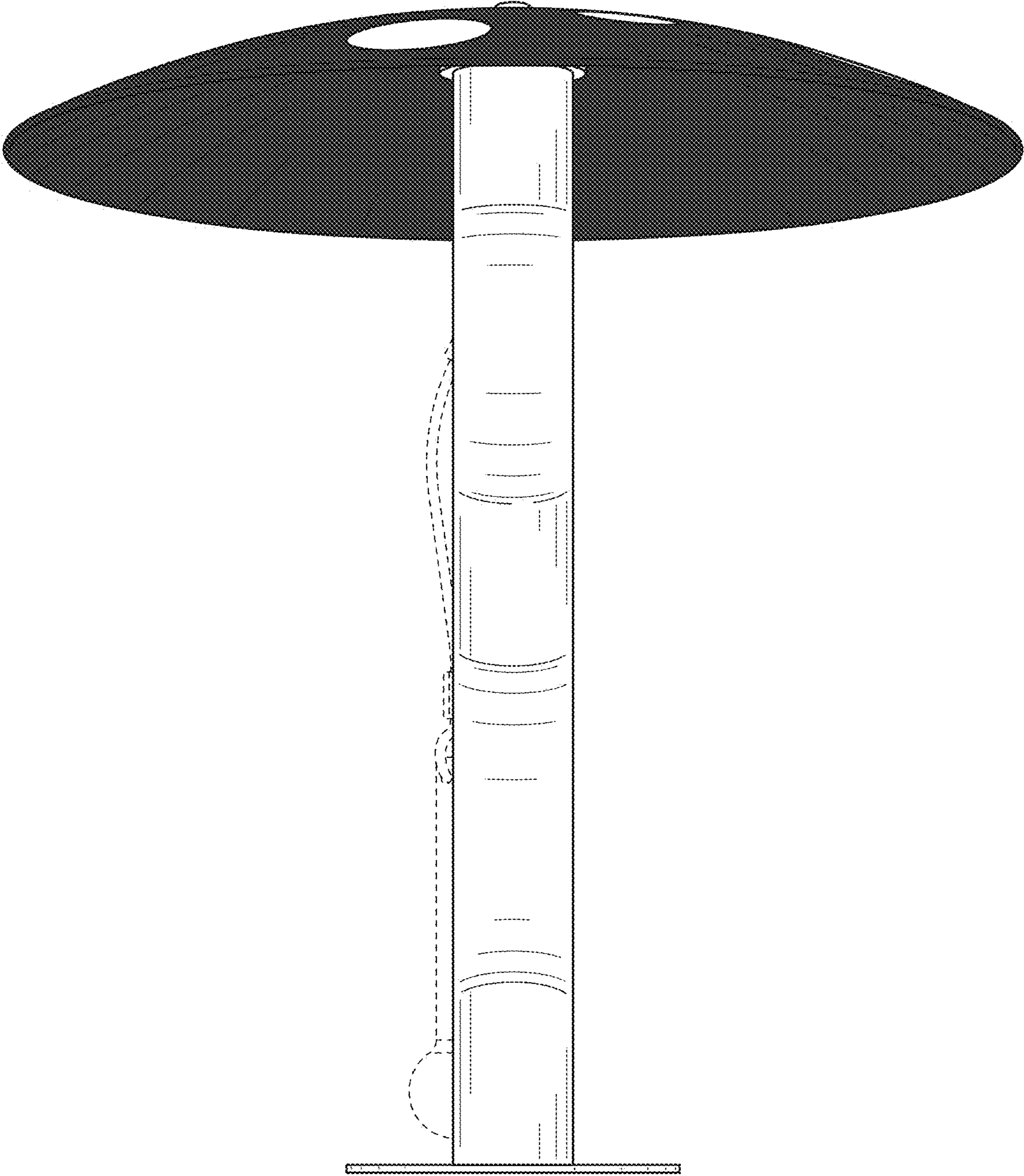

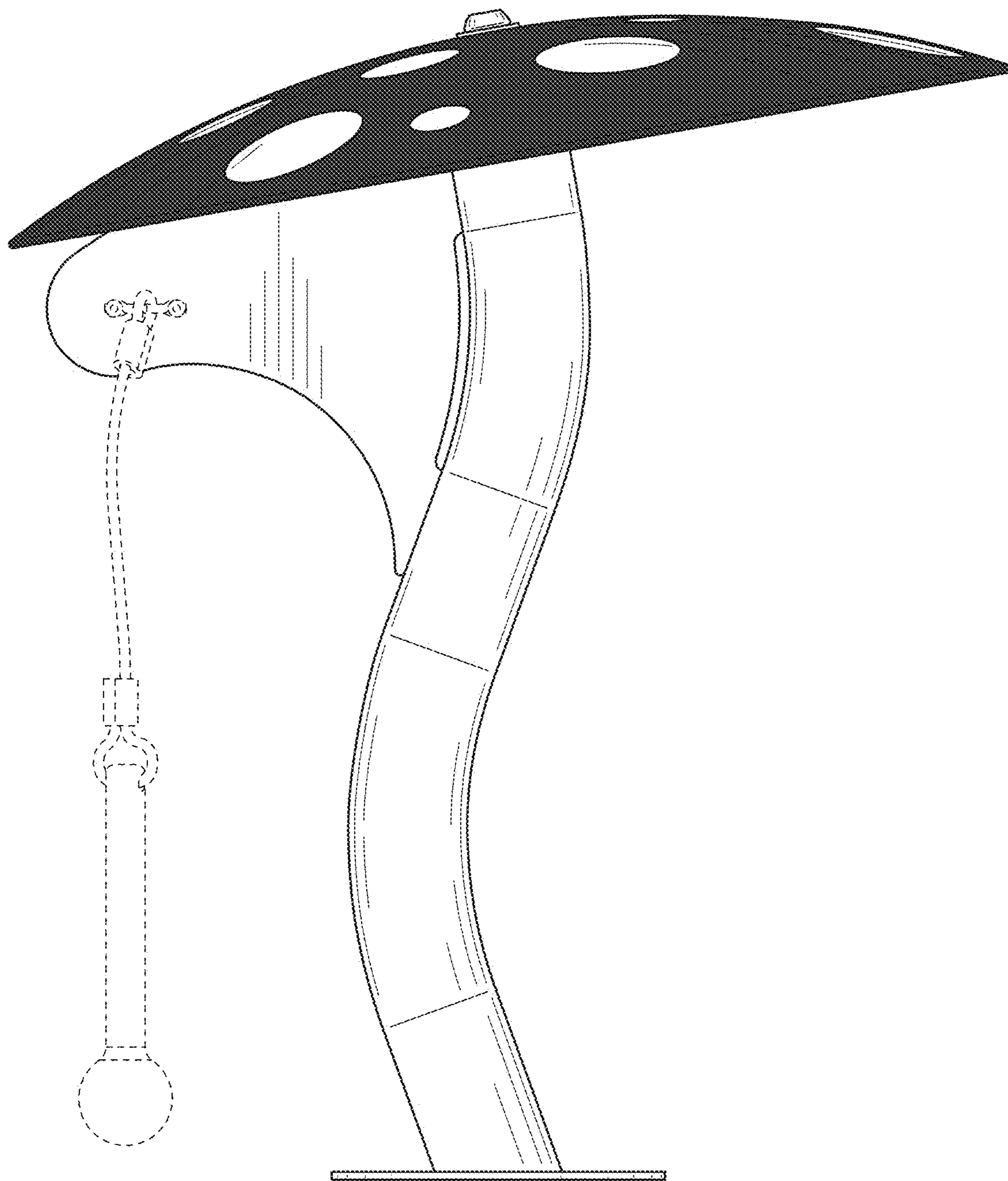

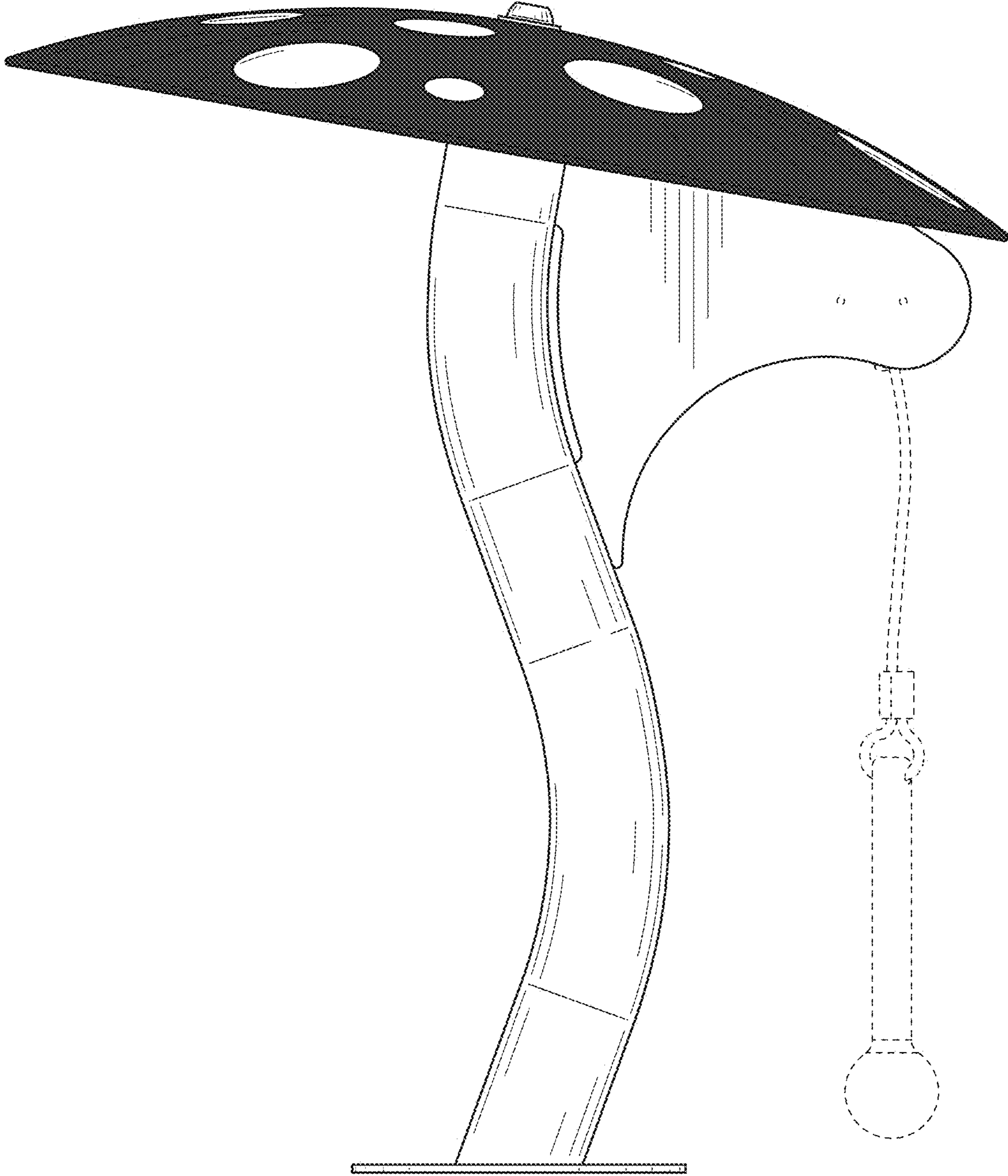

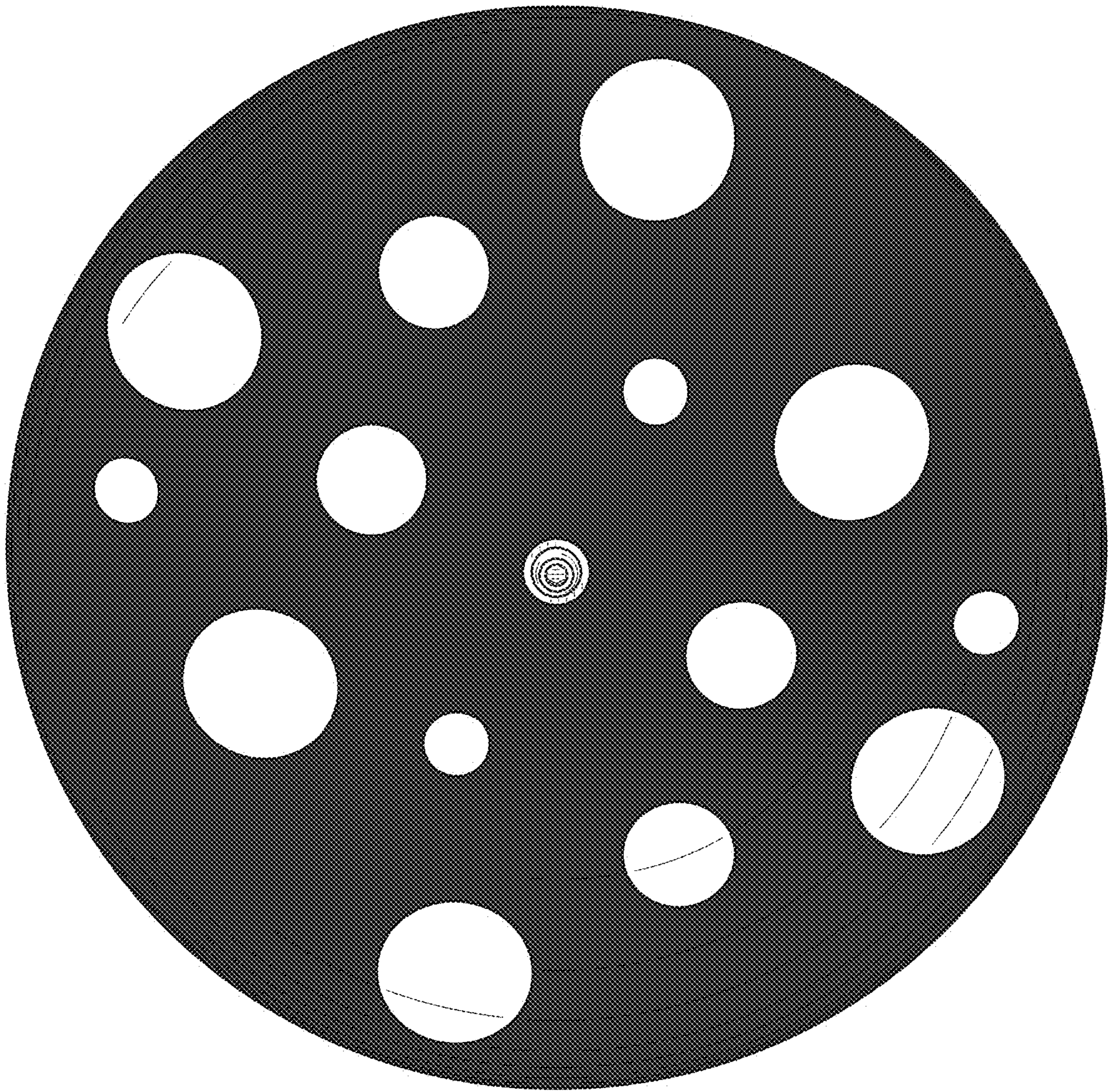

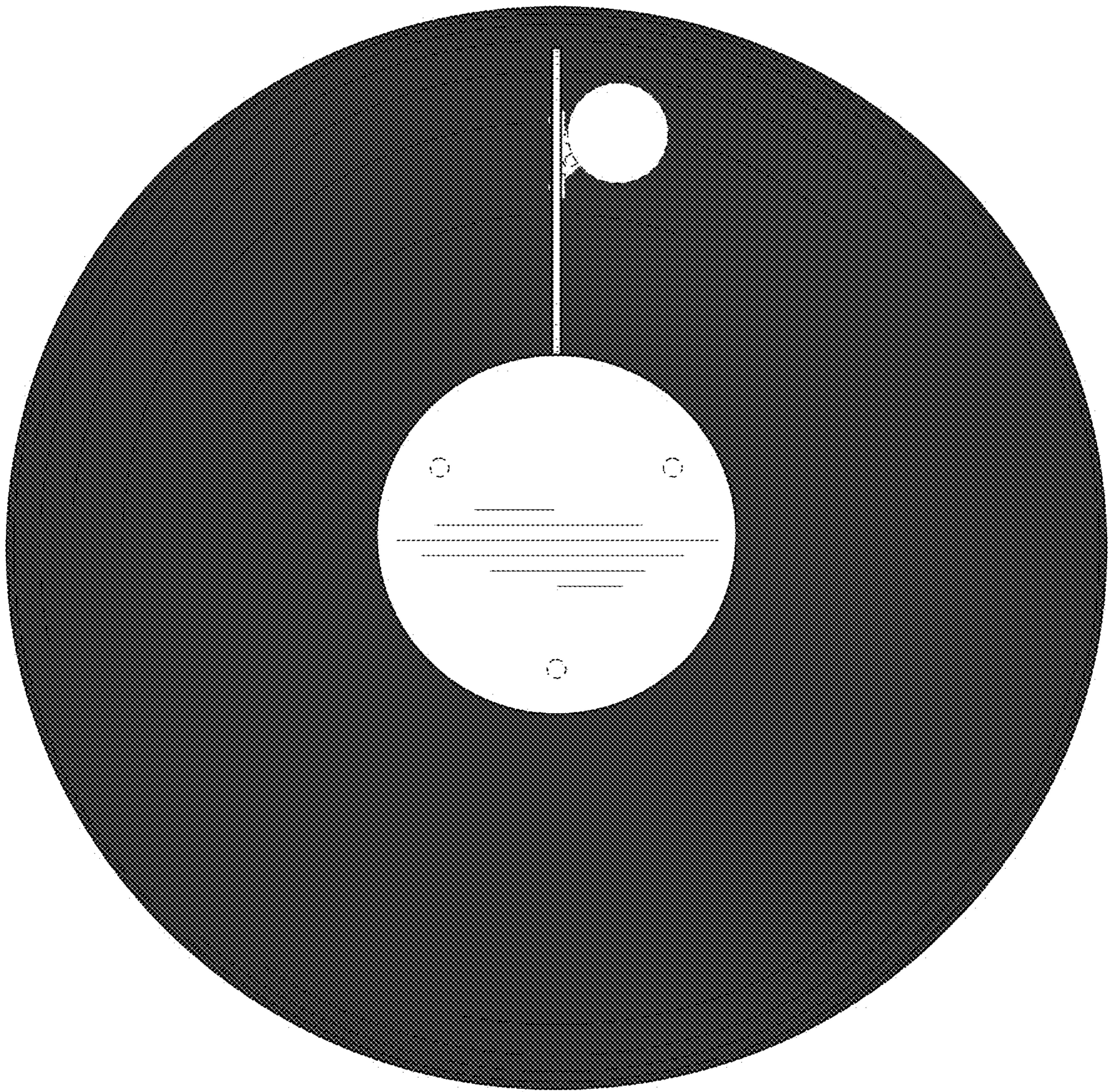

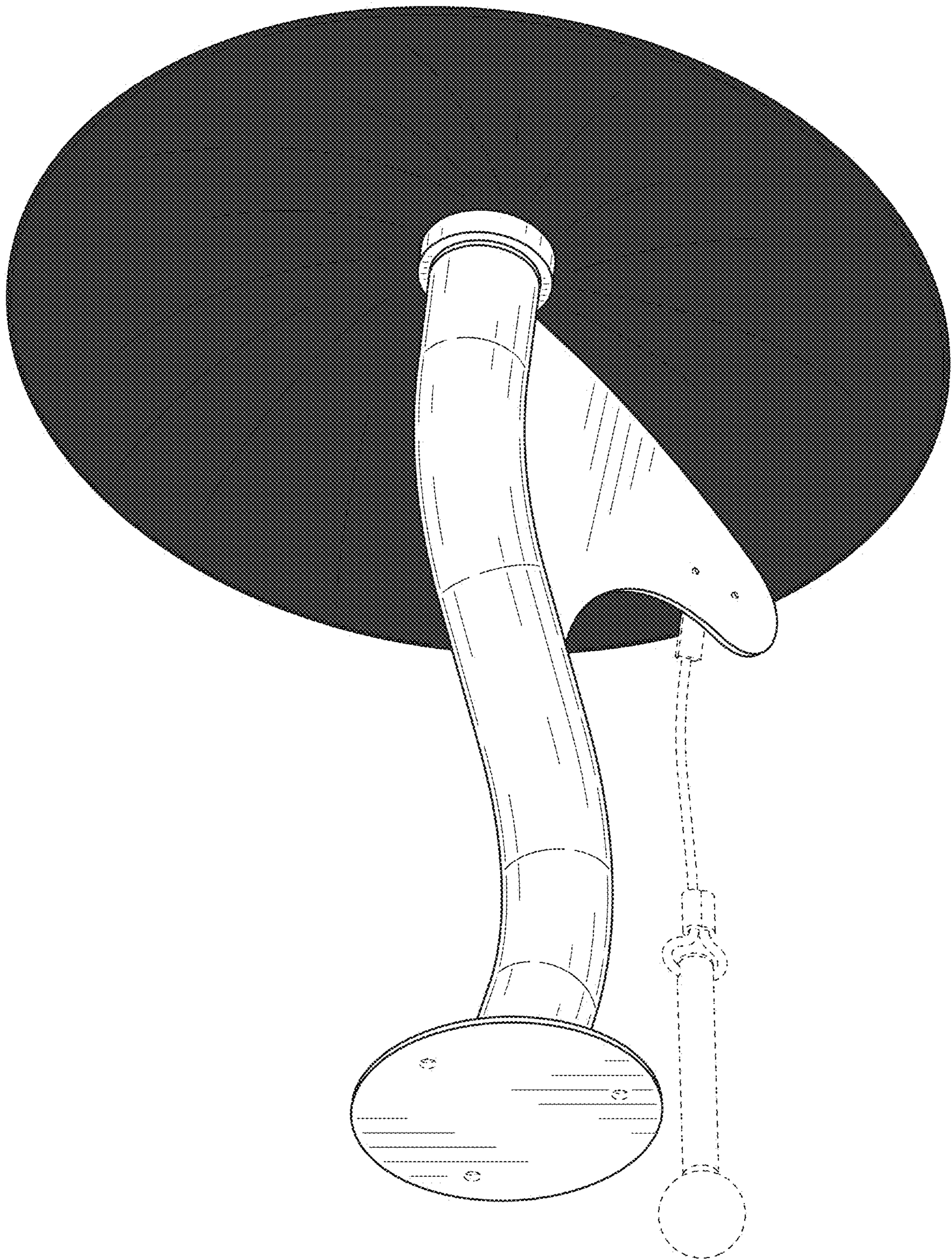

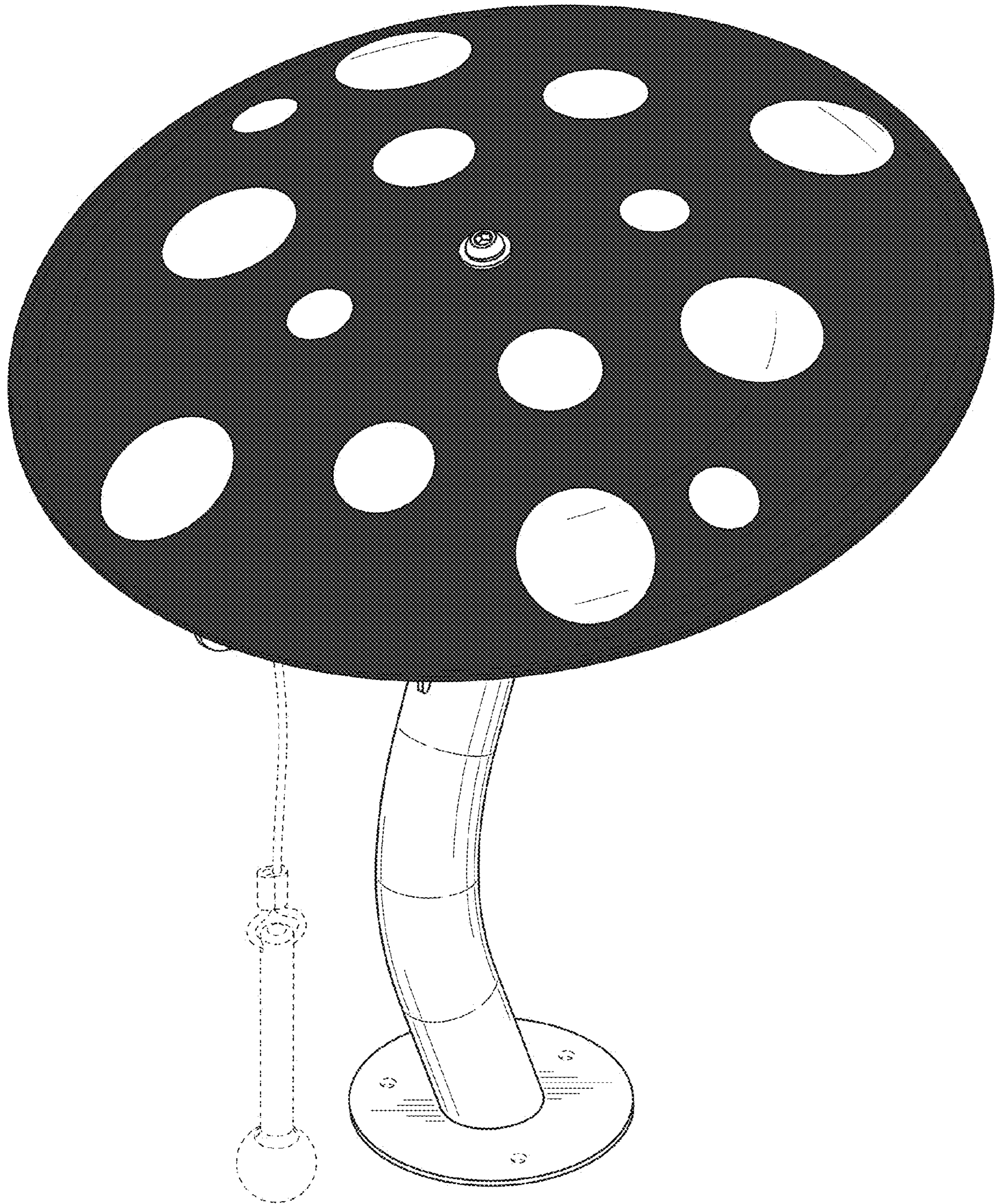

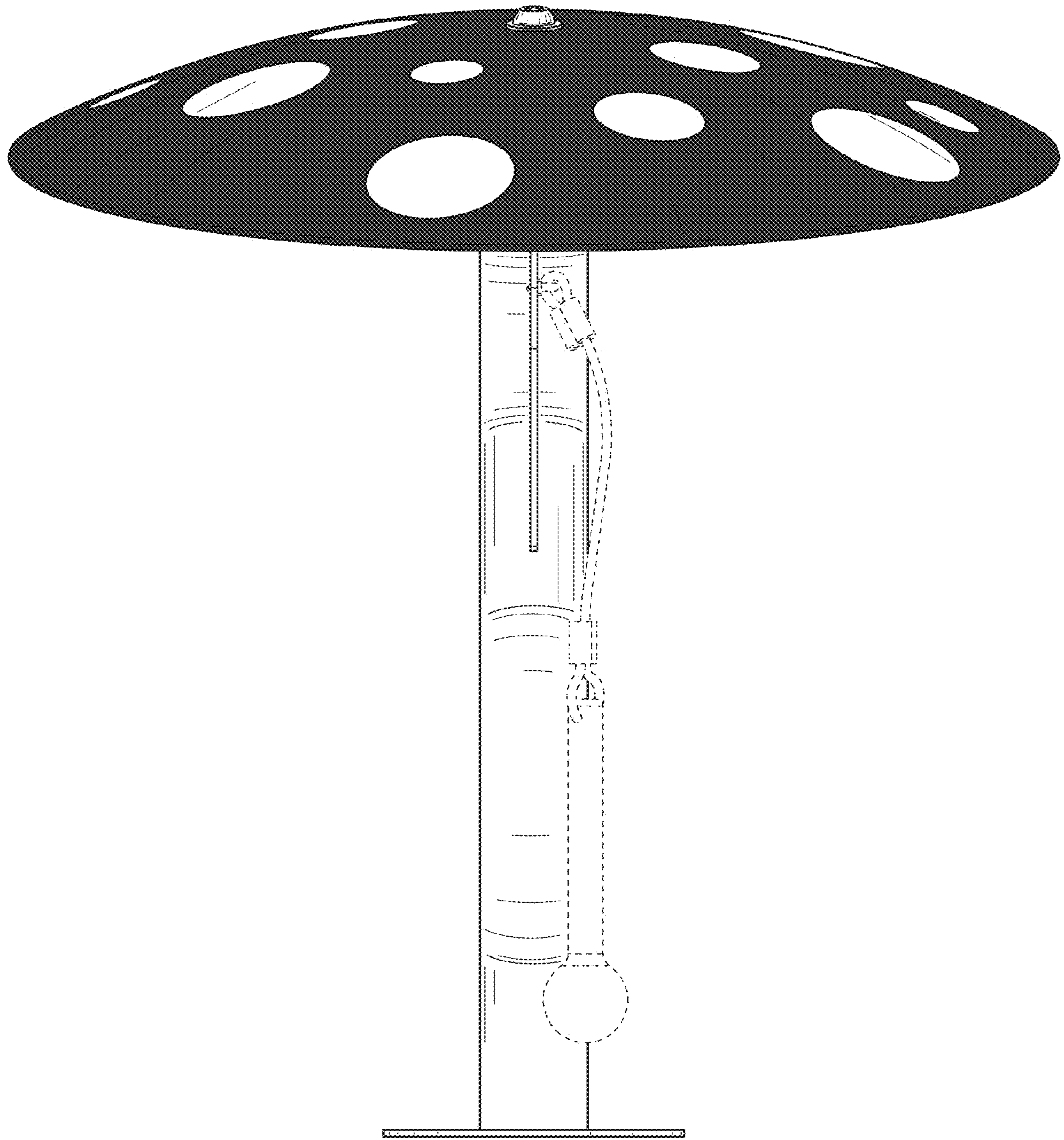

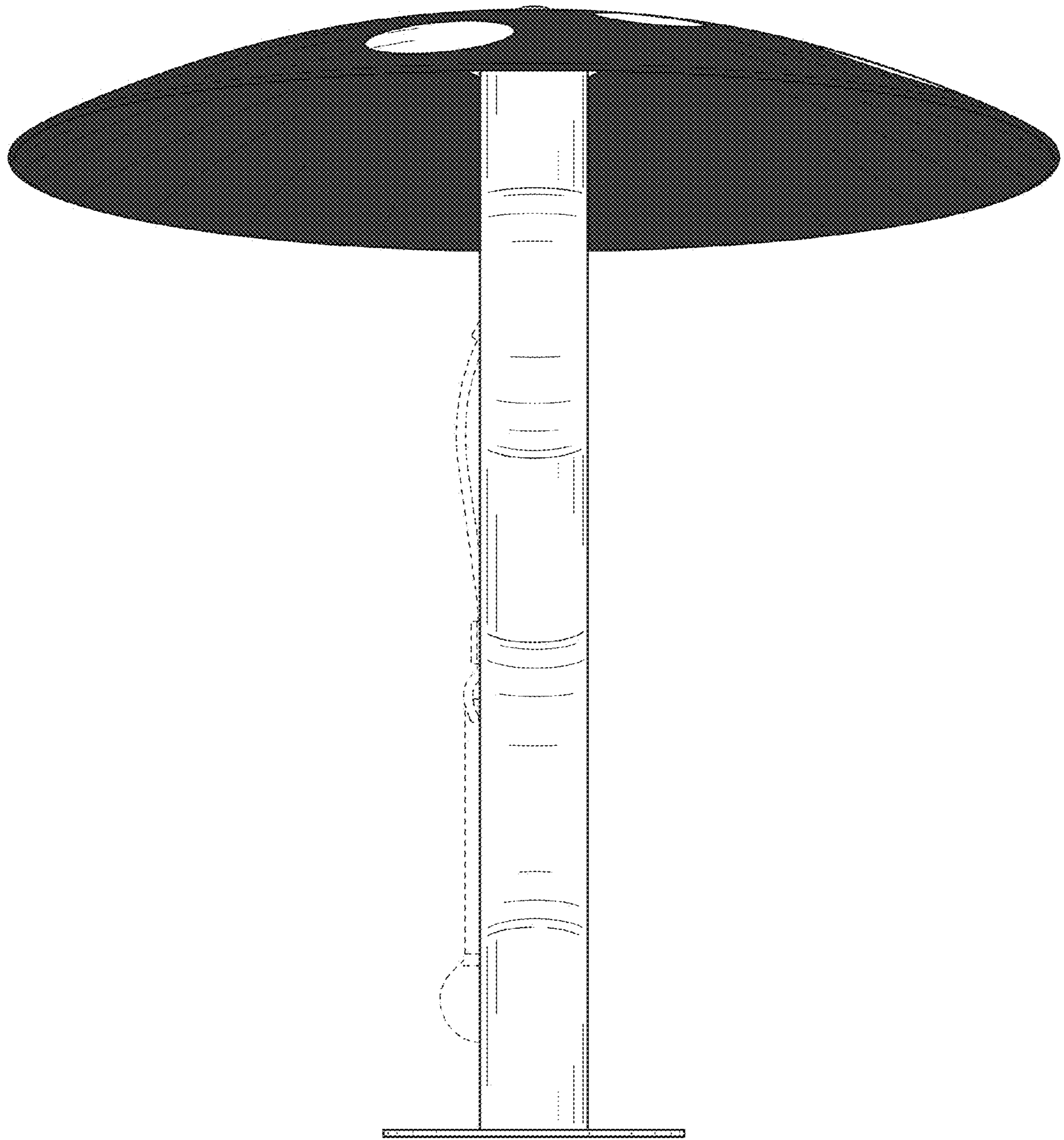

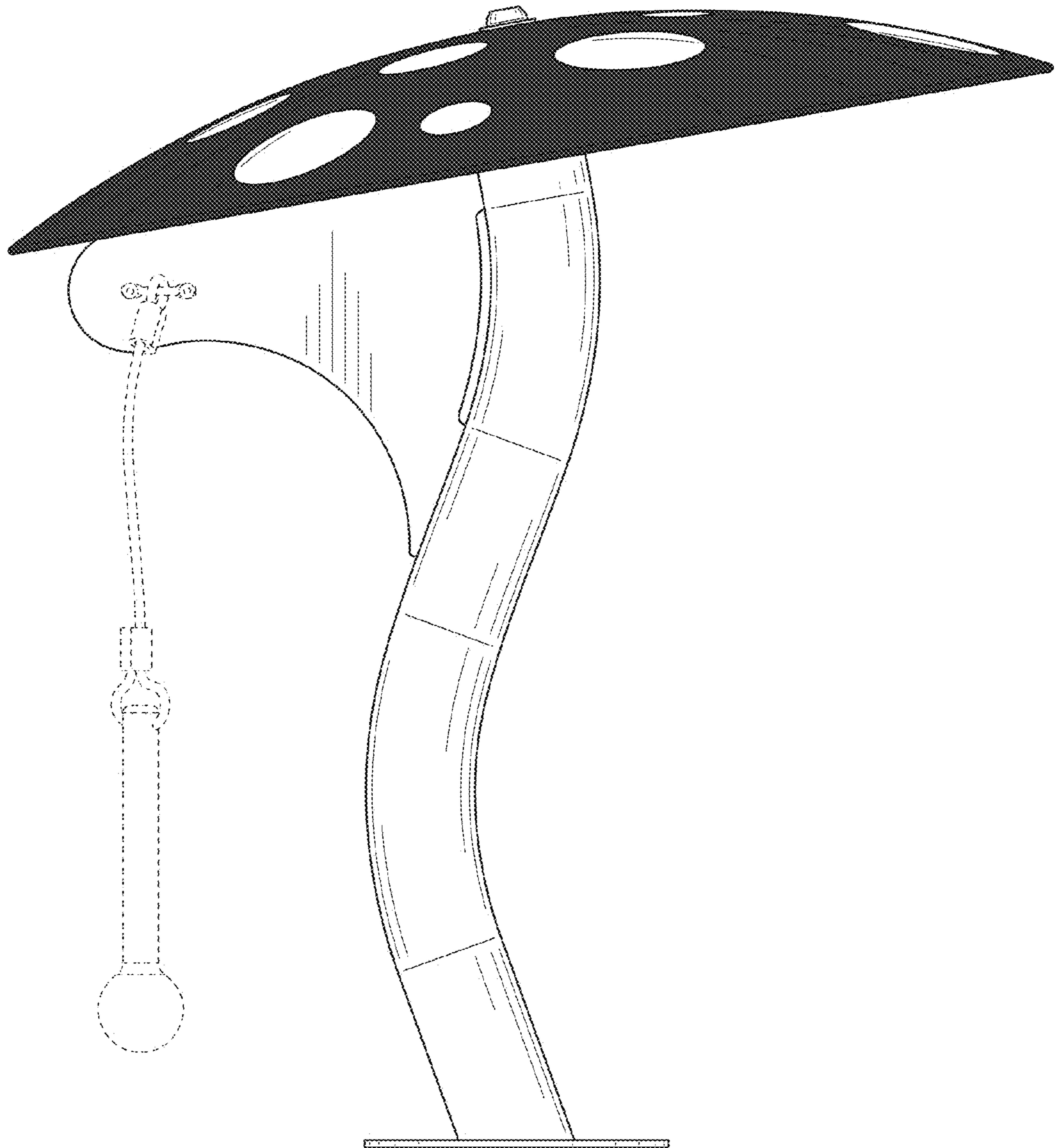

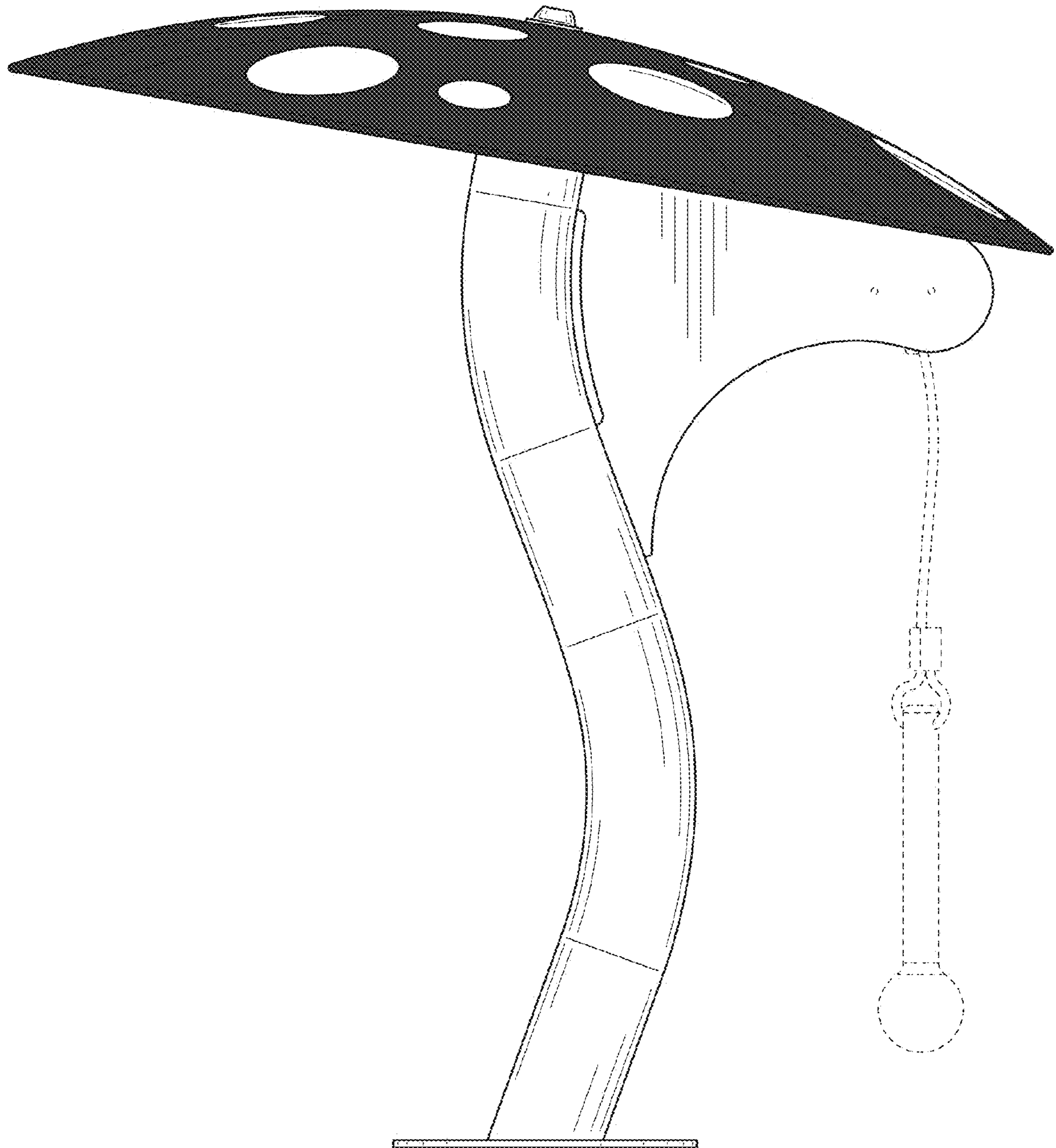

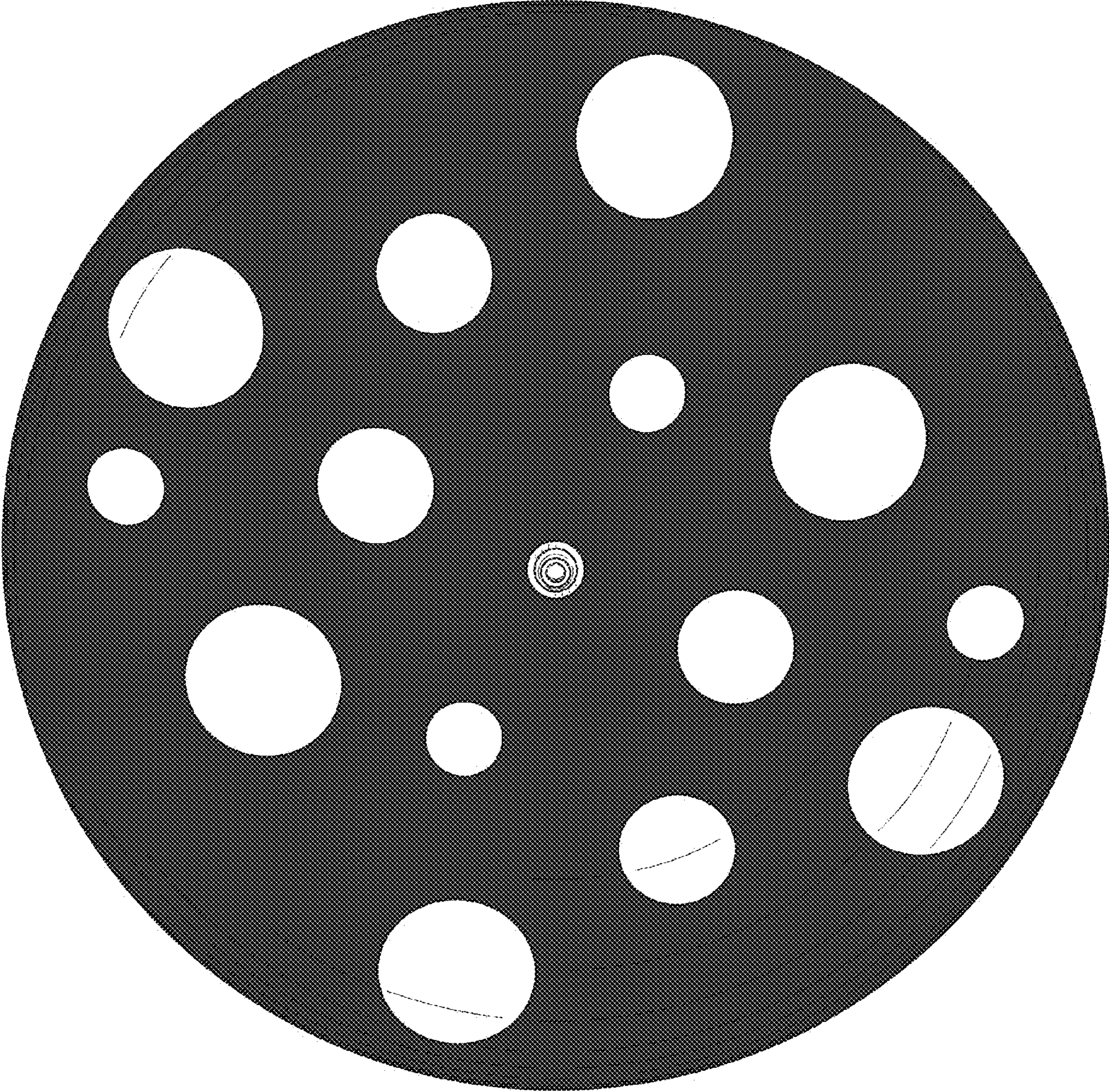

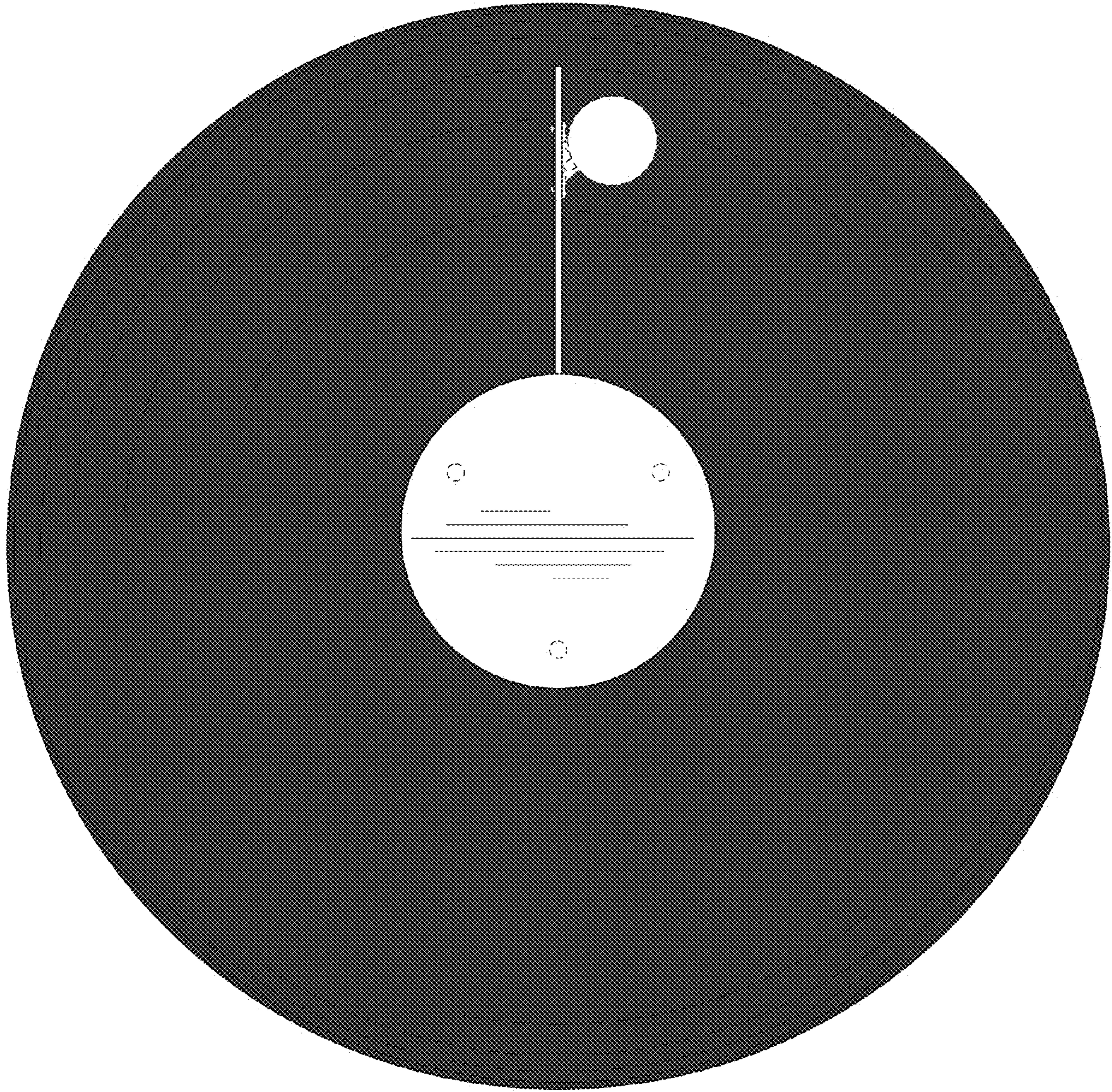

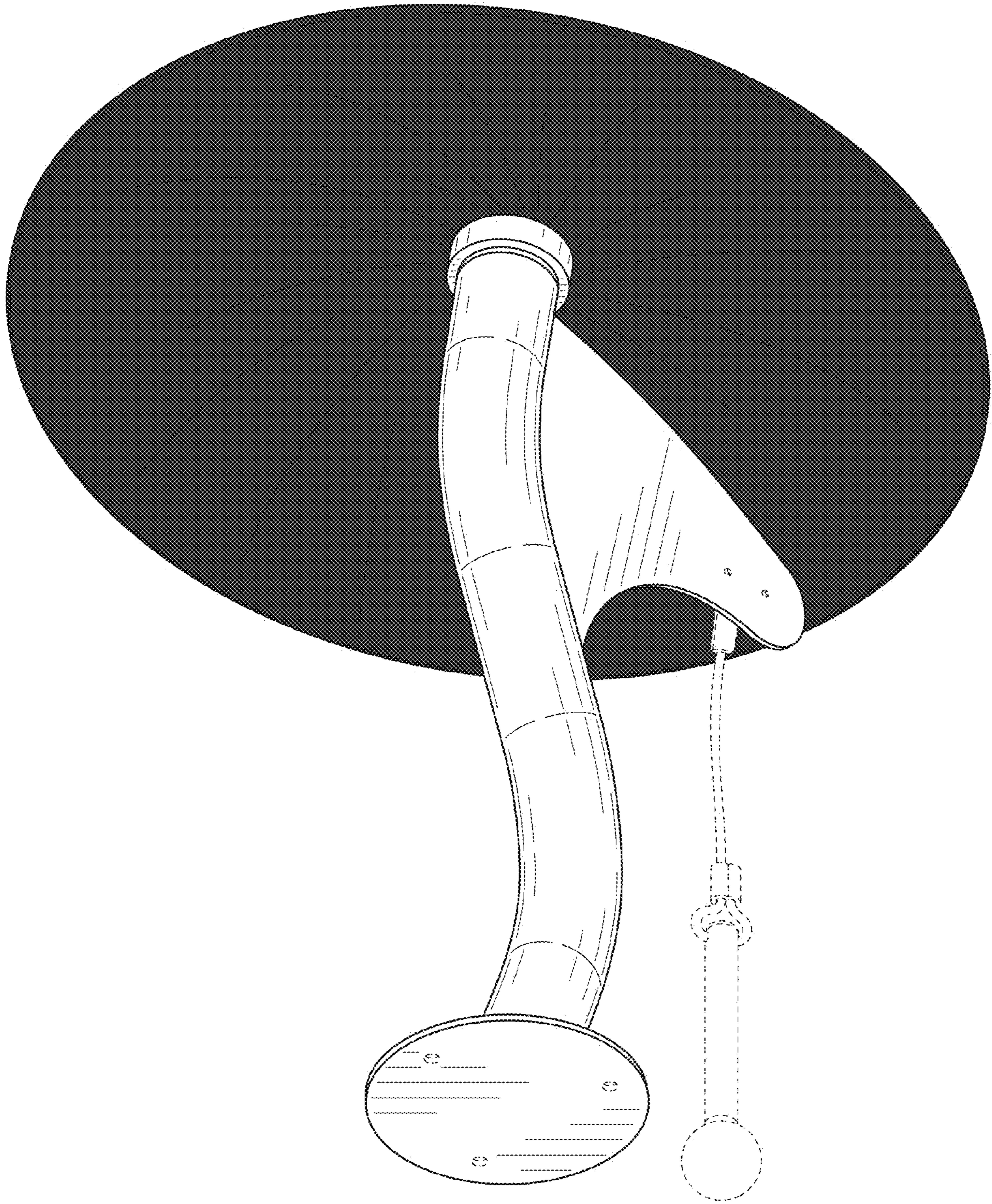
