DESCRIPTION

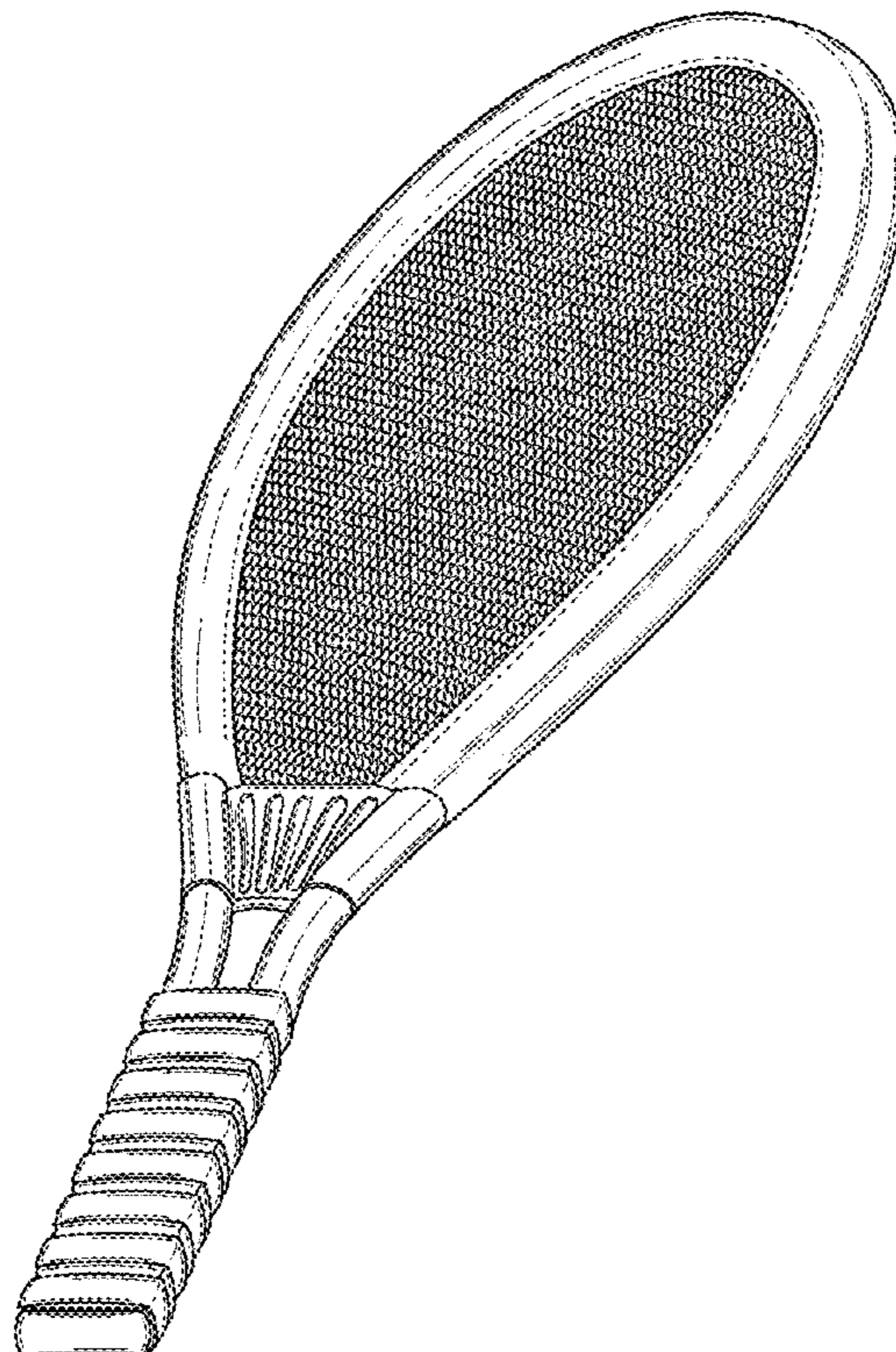
FIG. 1 is a front view of a racquet with mesh head;

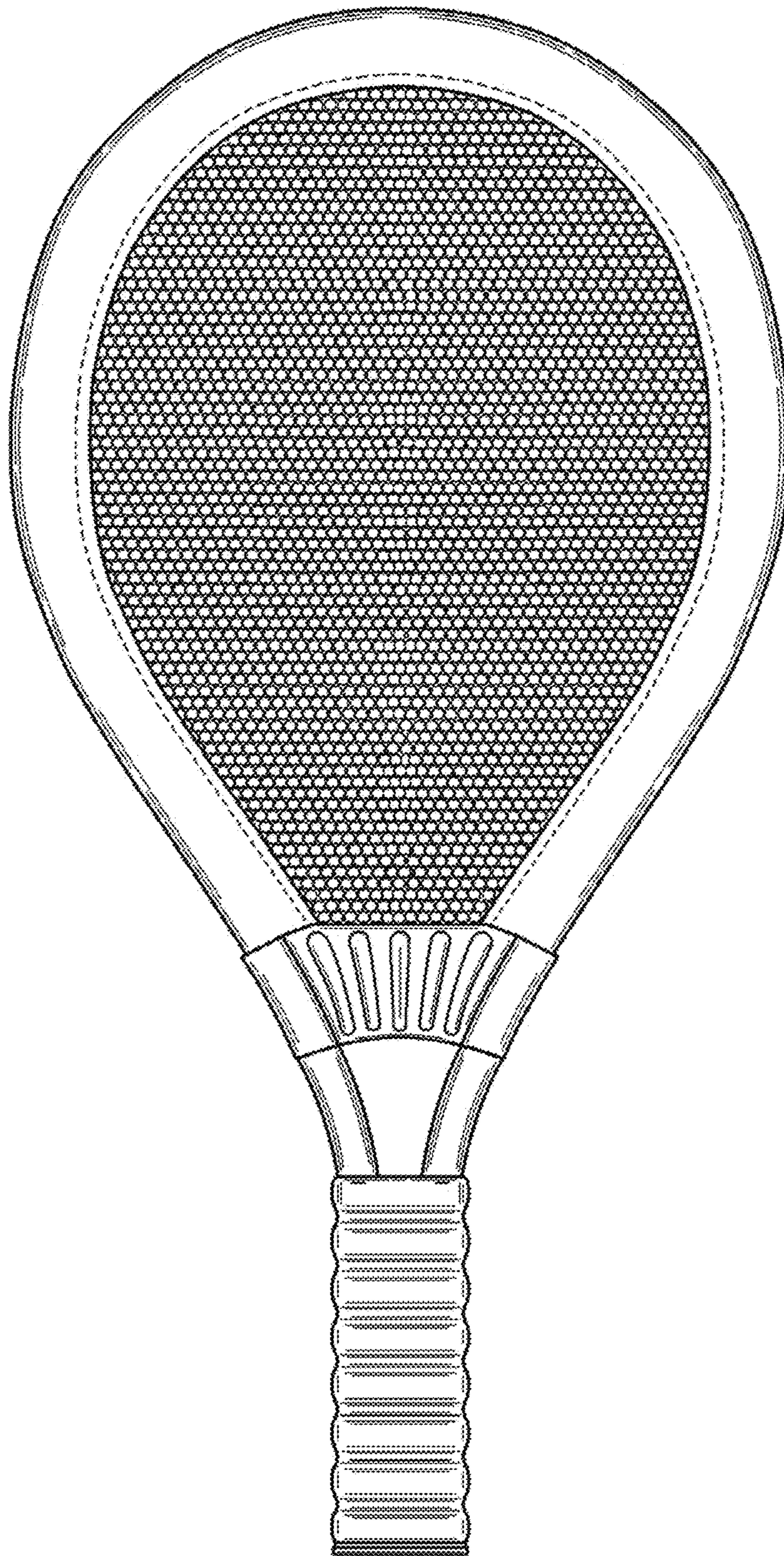

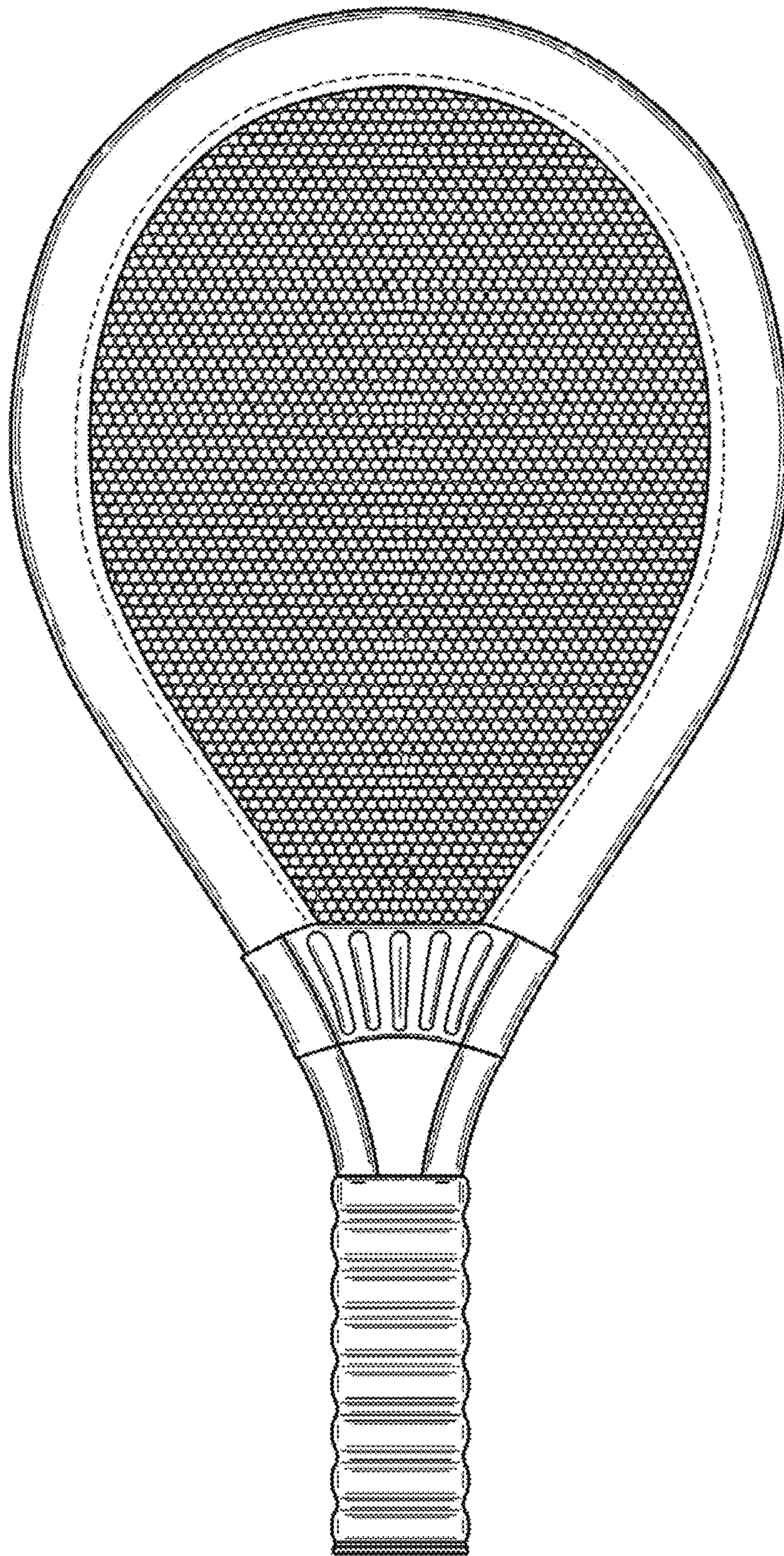

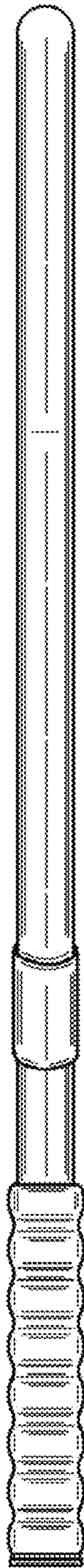

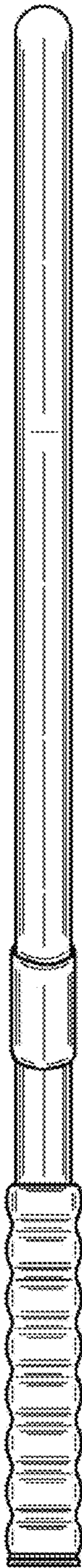

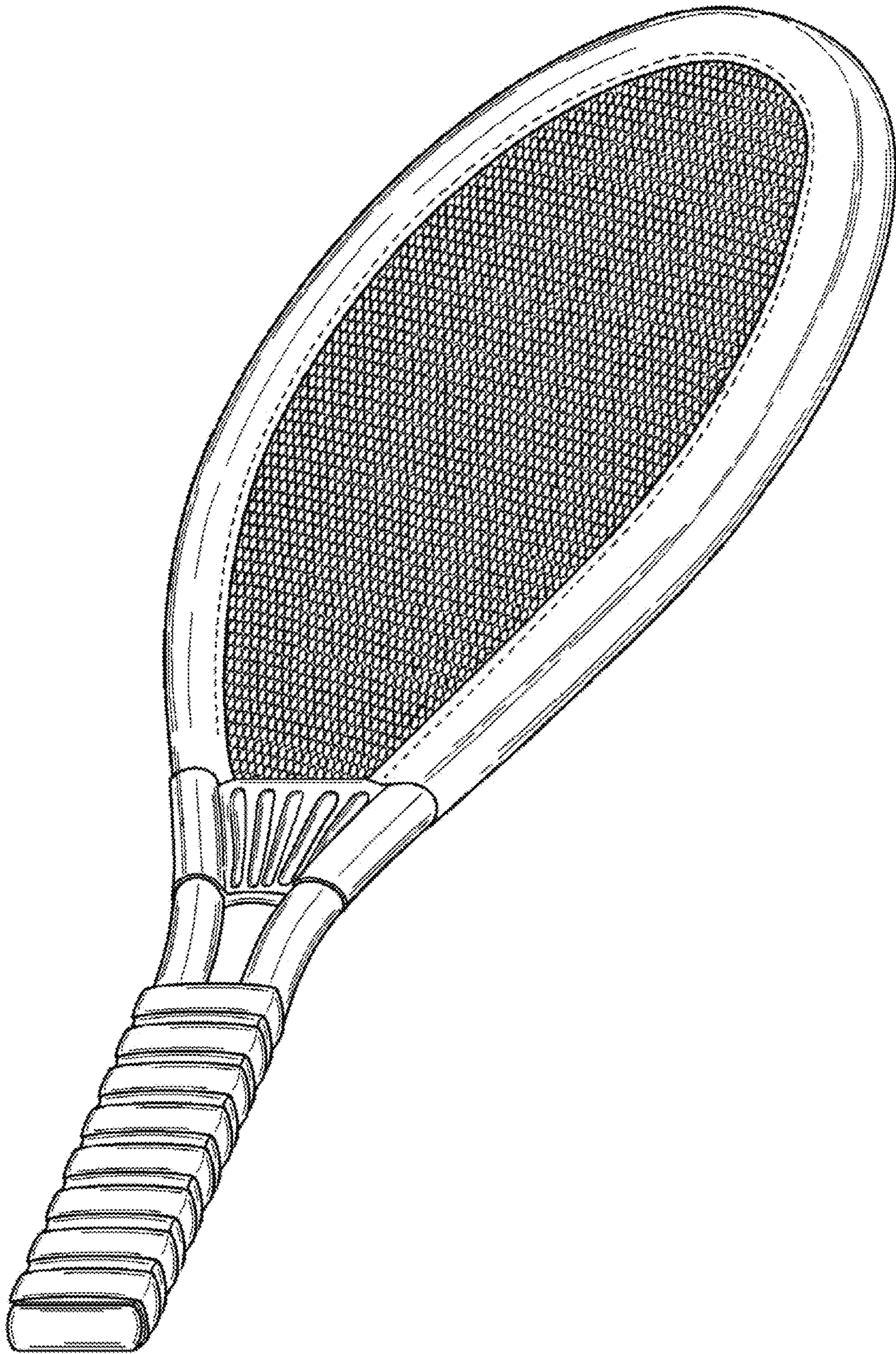
