FIG. 1 is a perspective view of a mouse cage showing my new design;

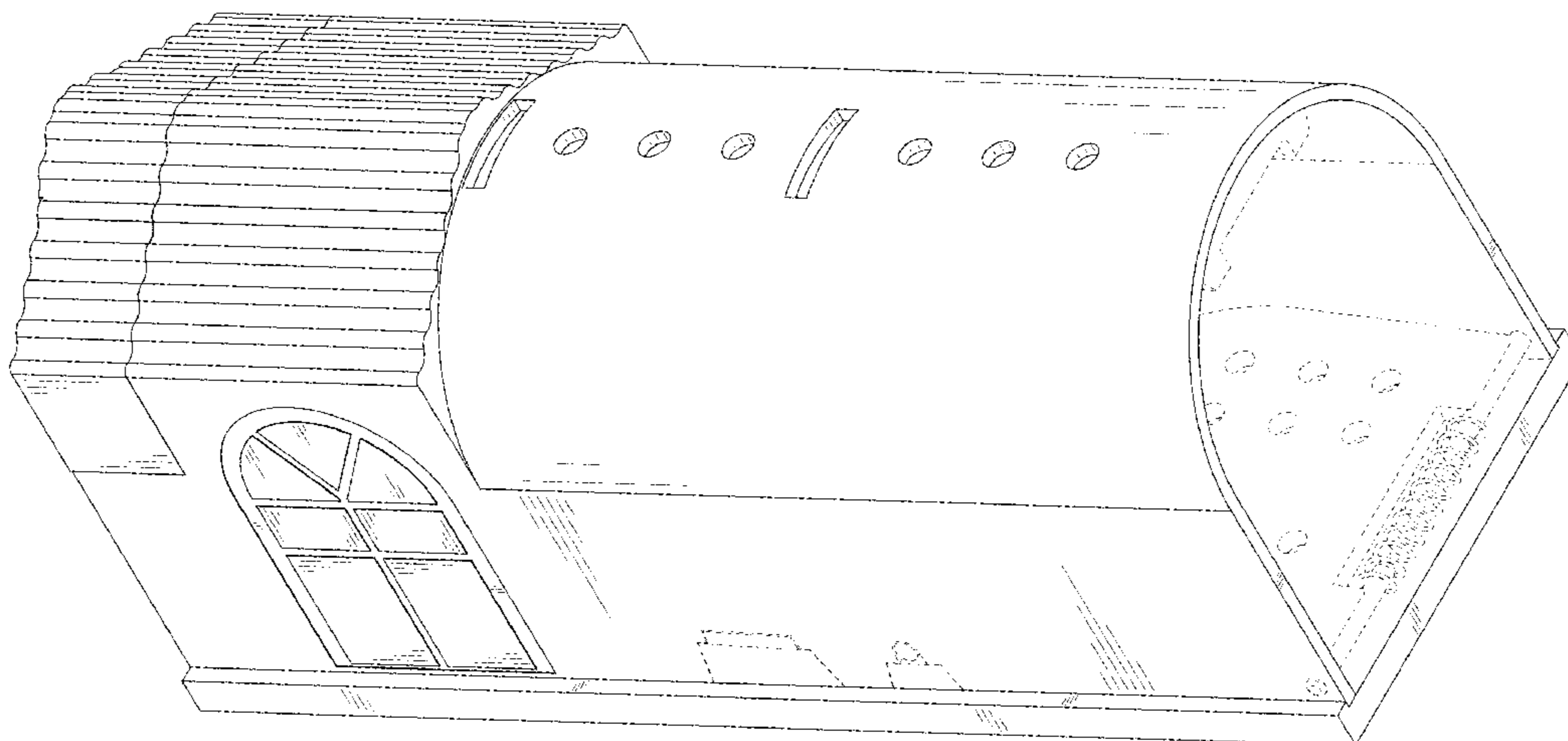


FIG. 2 is another perspective view thereof;

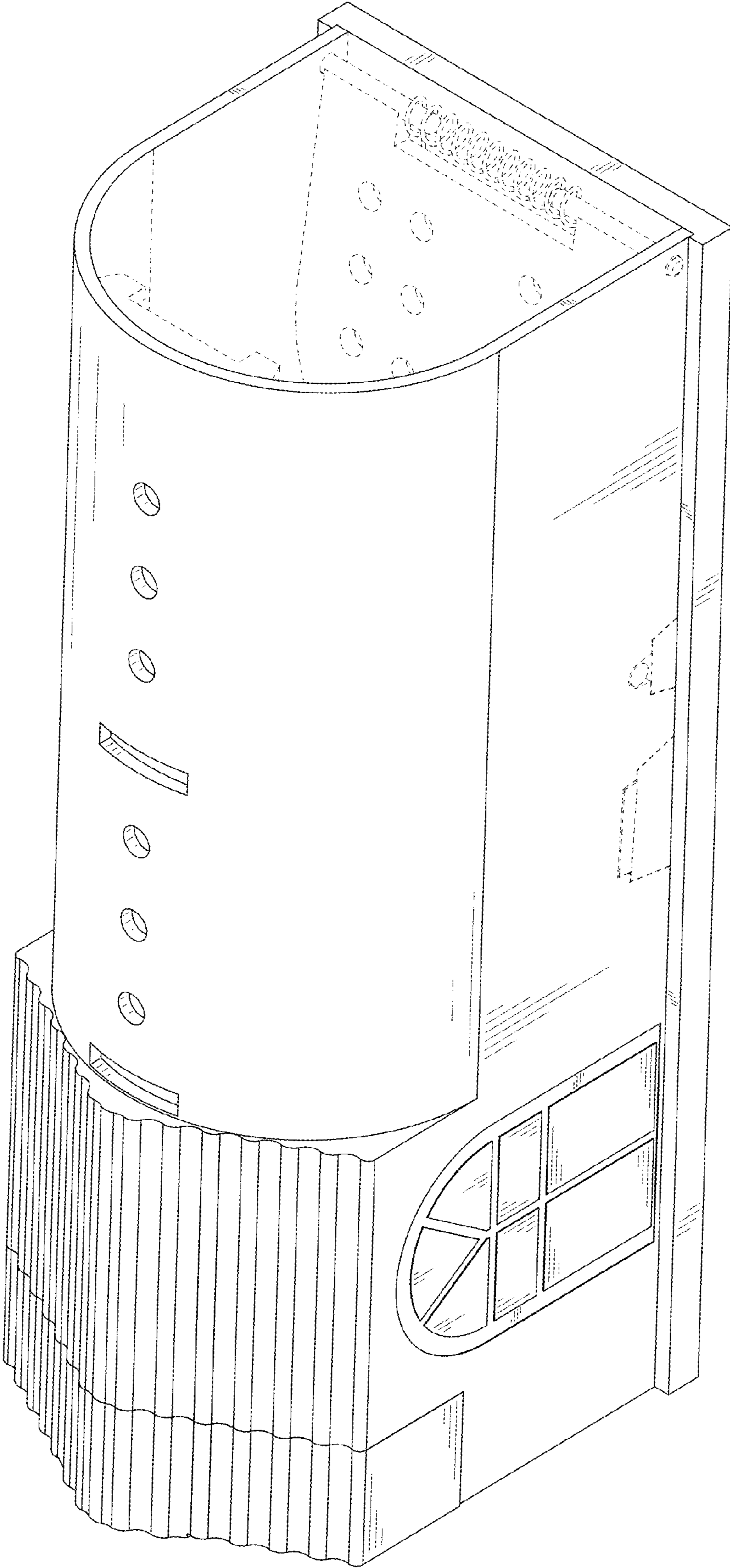

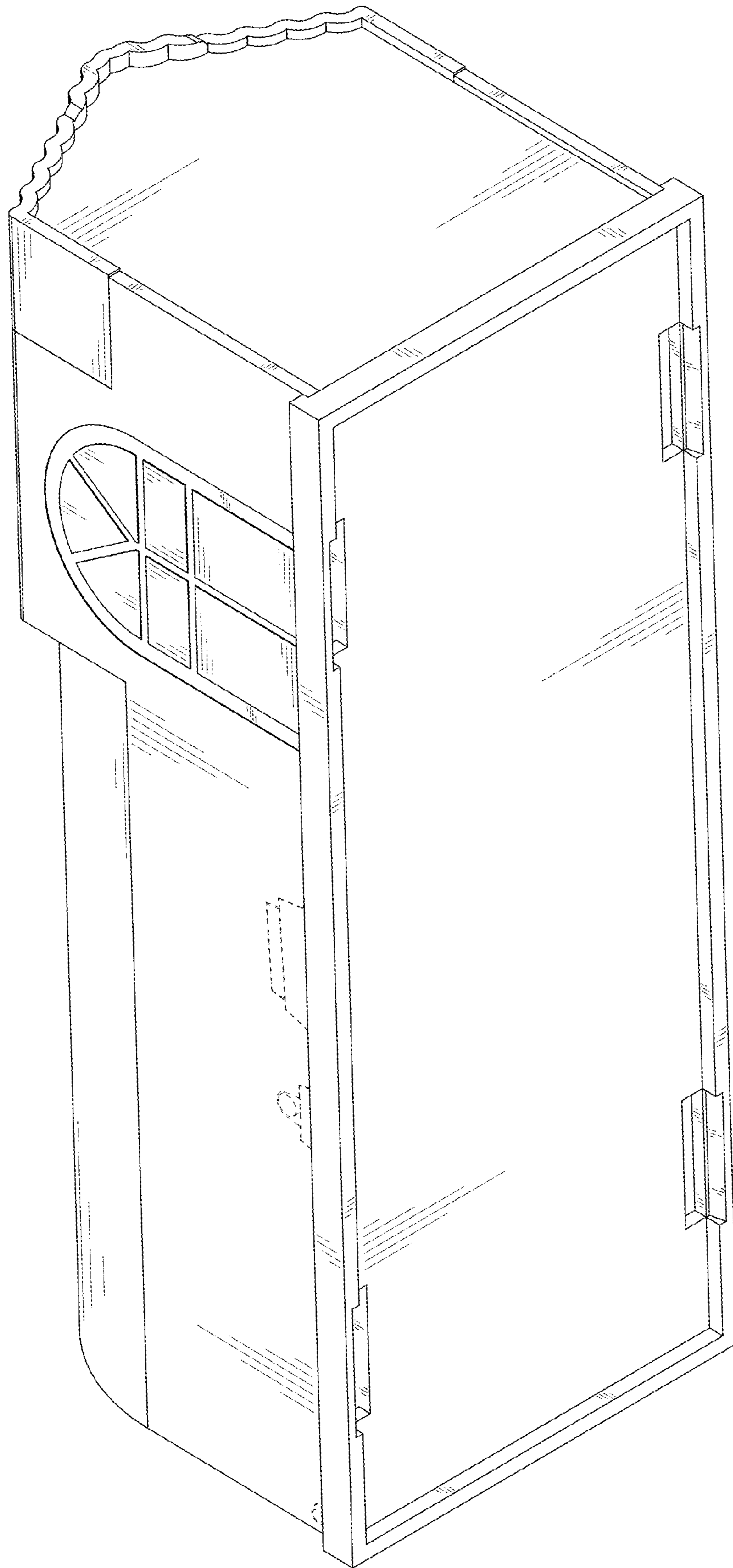

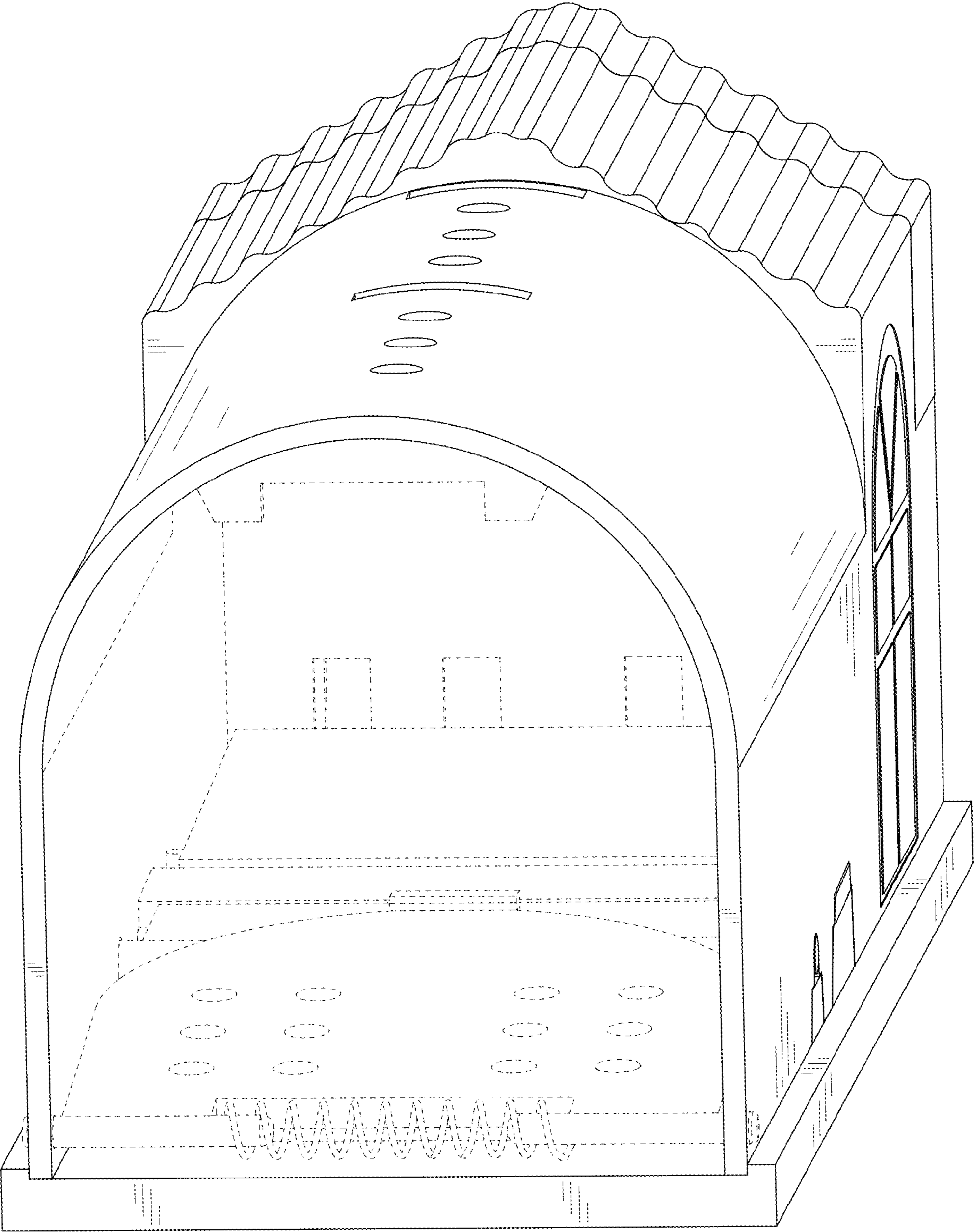

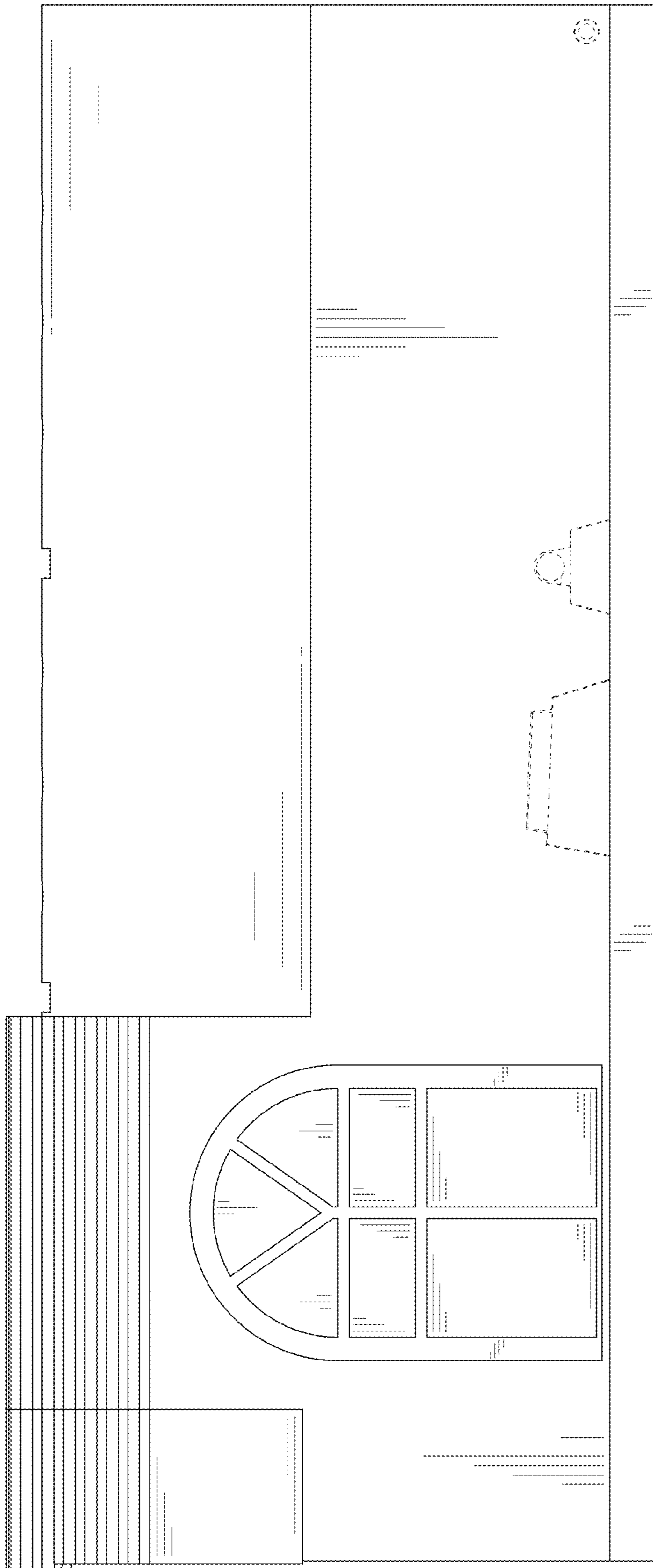

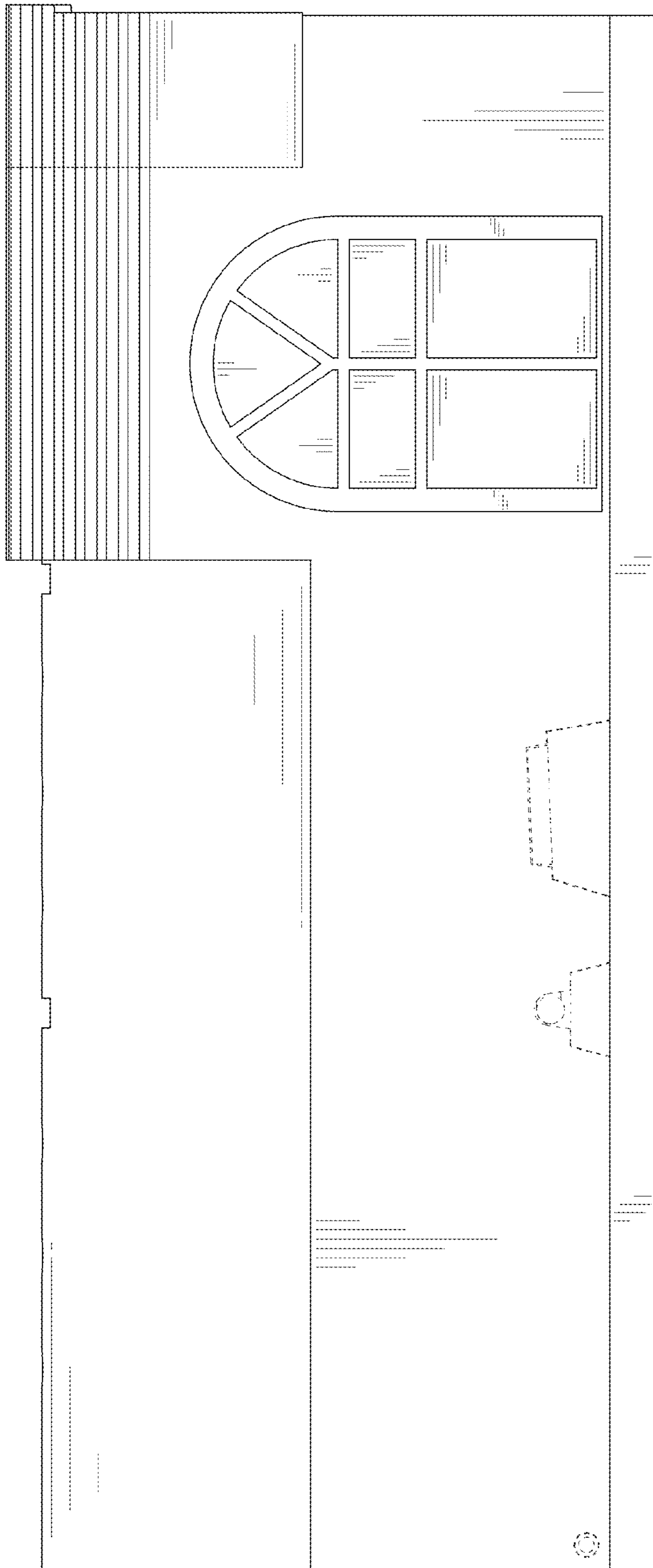

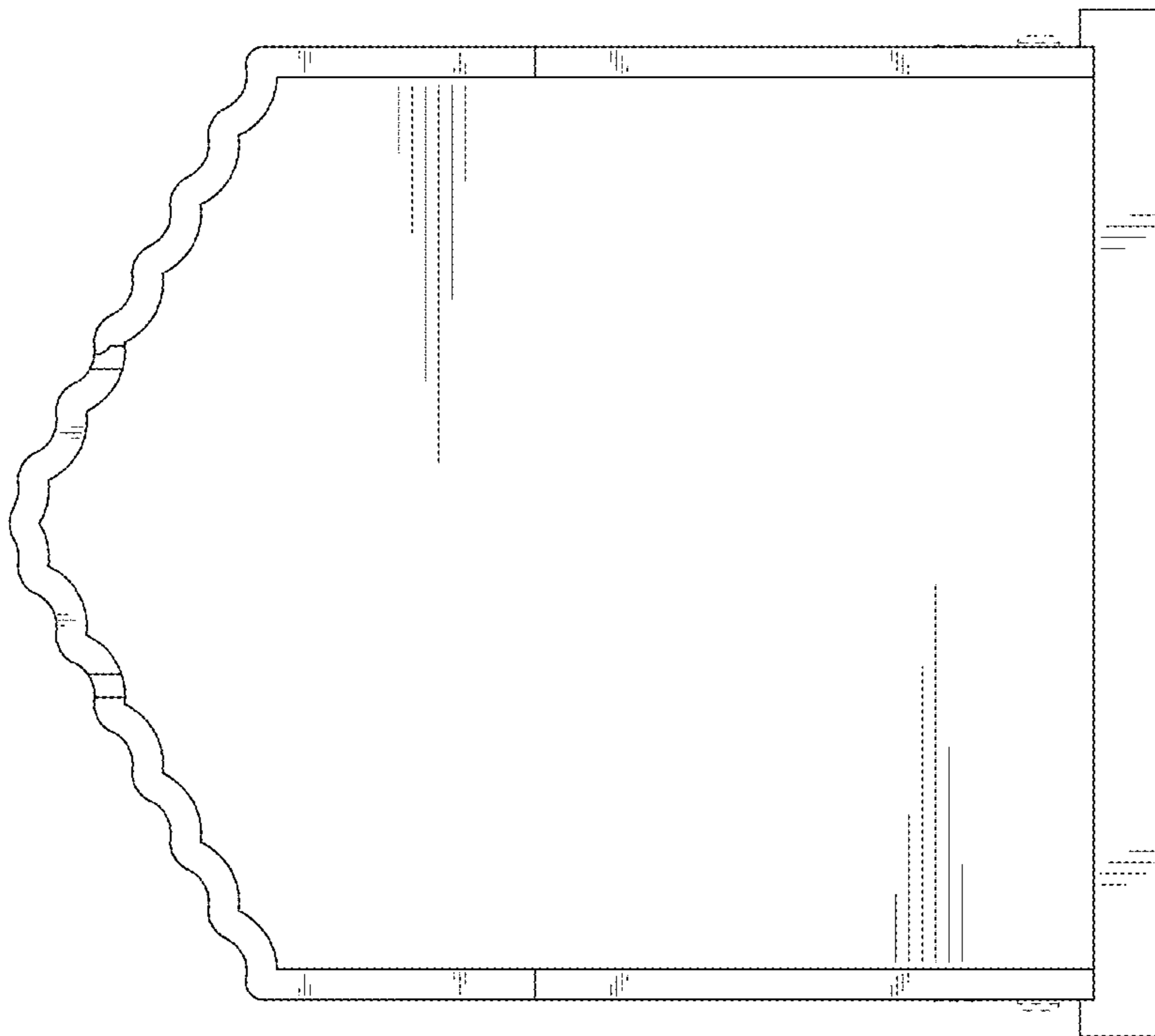

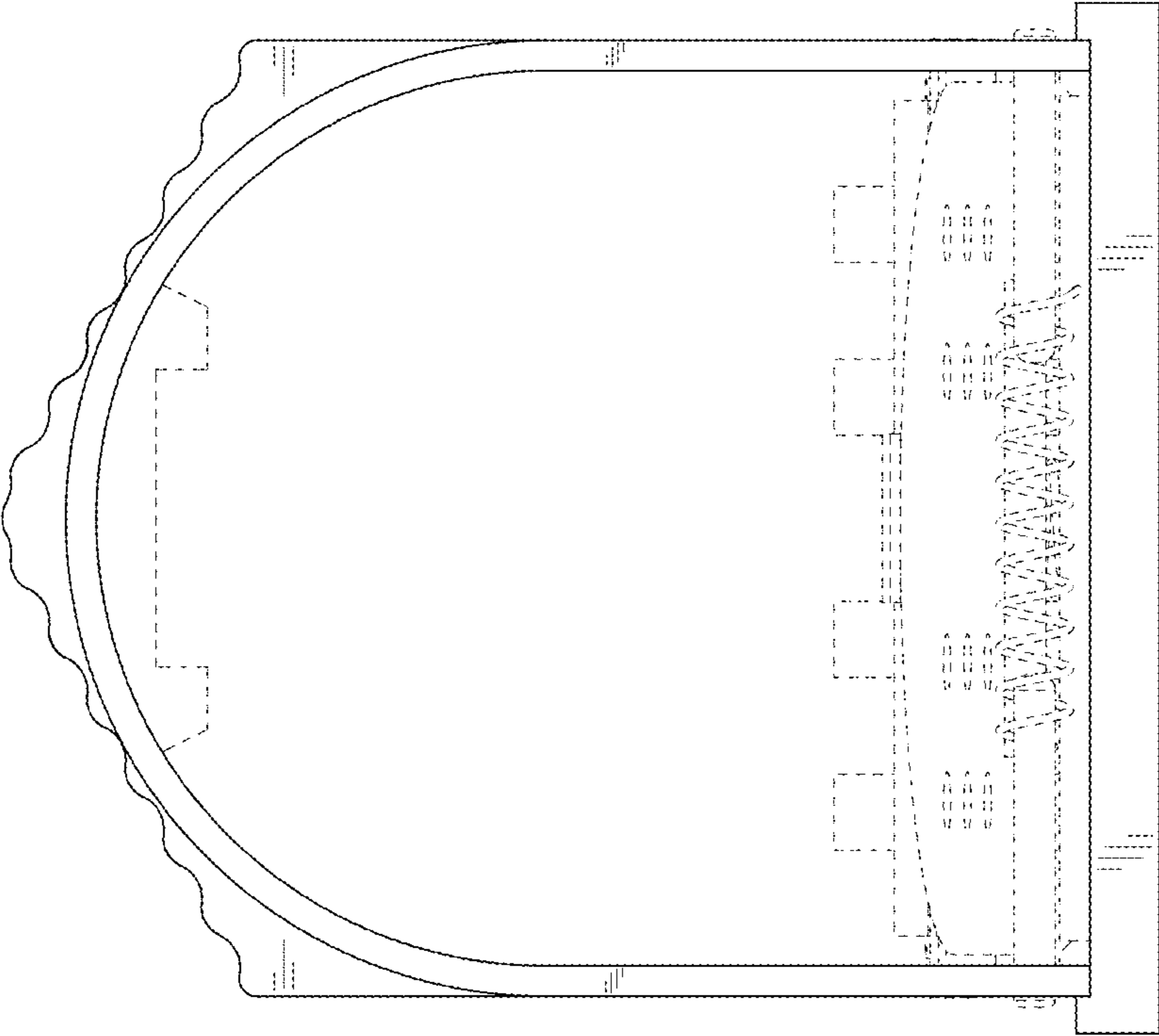

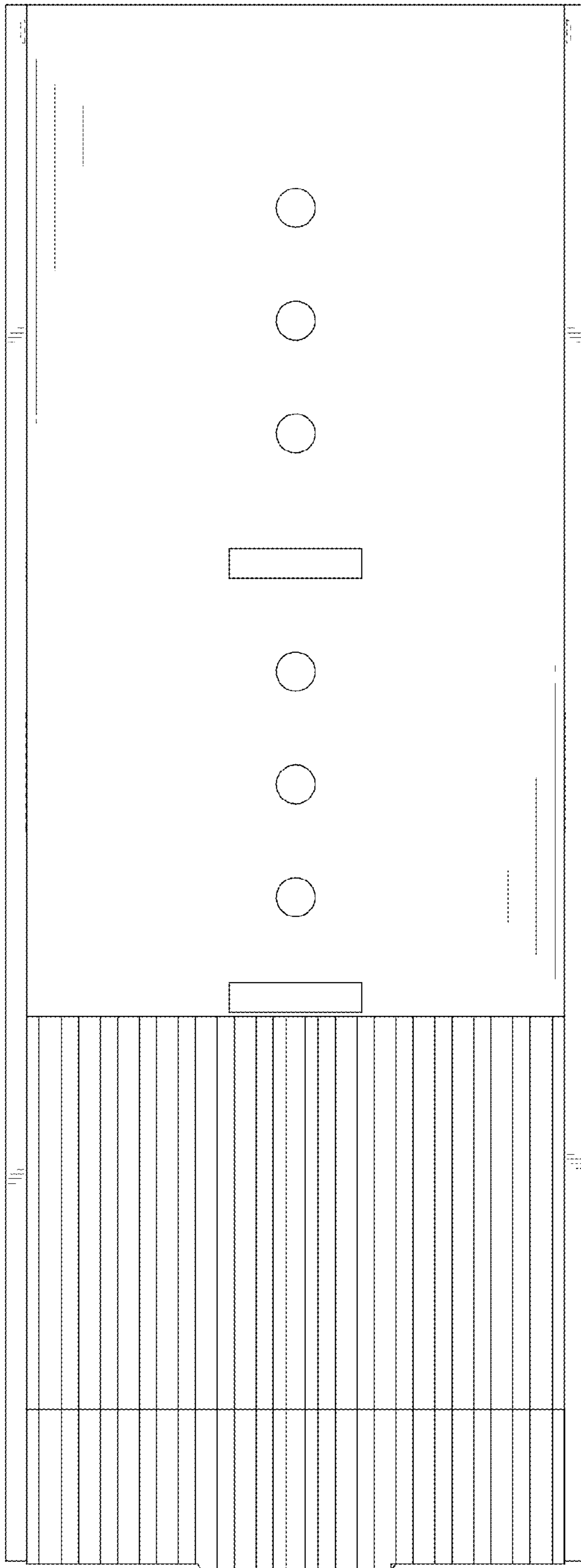

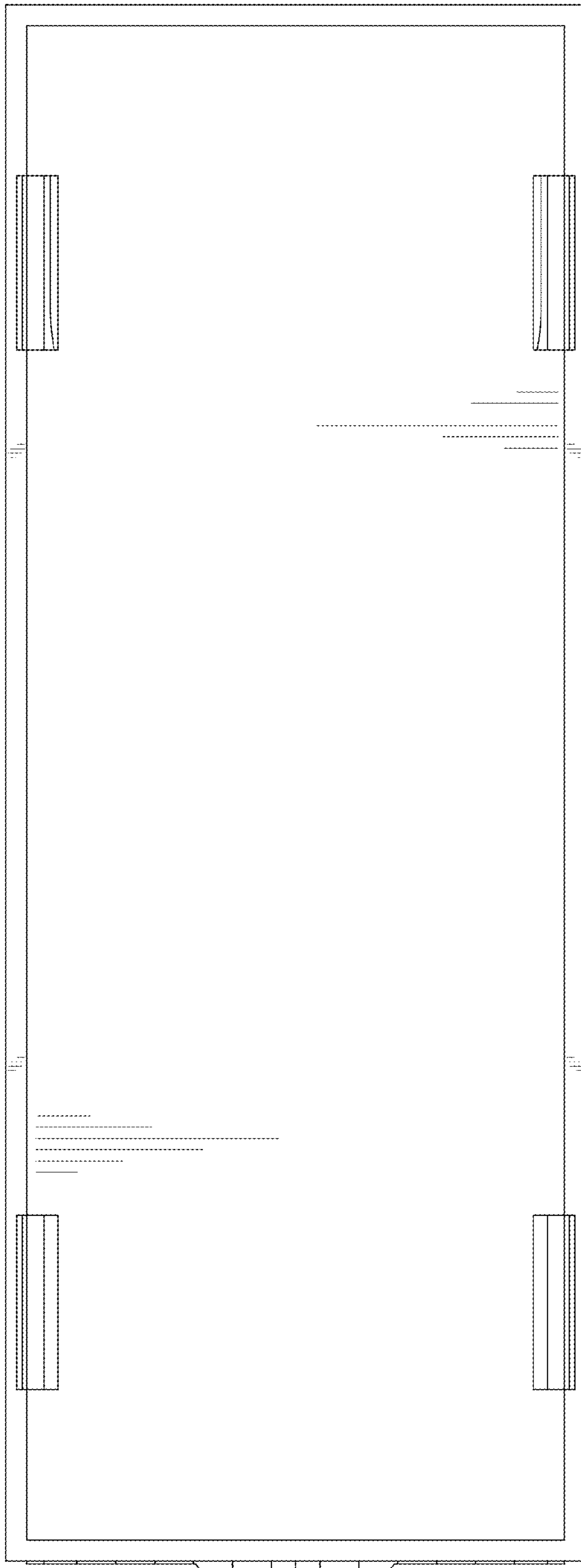

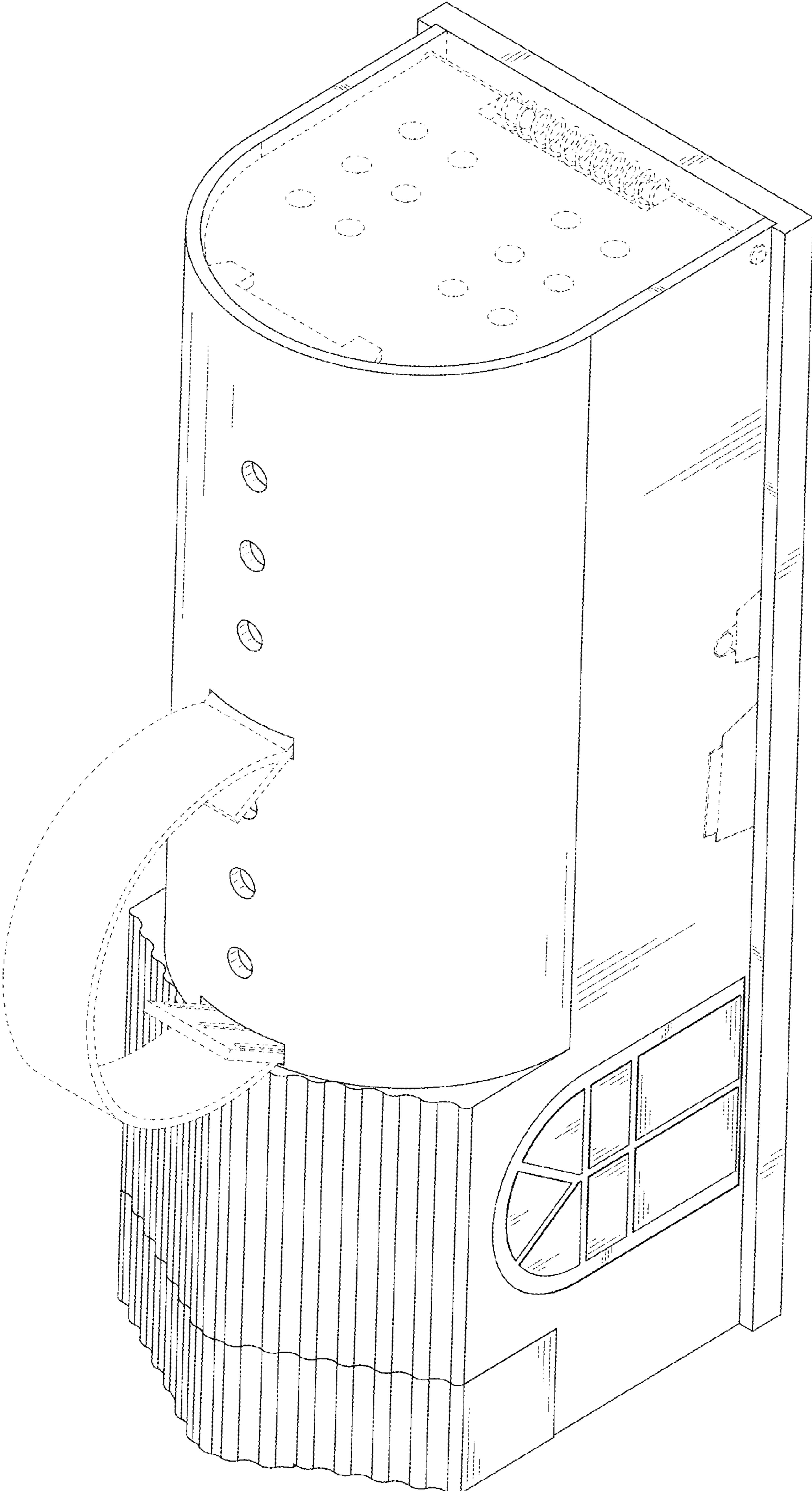

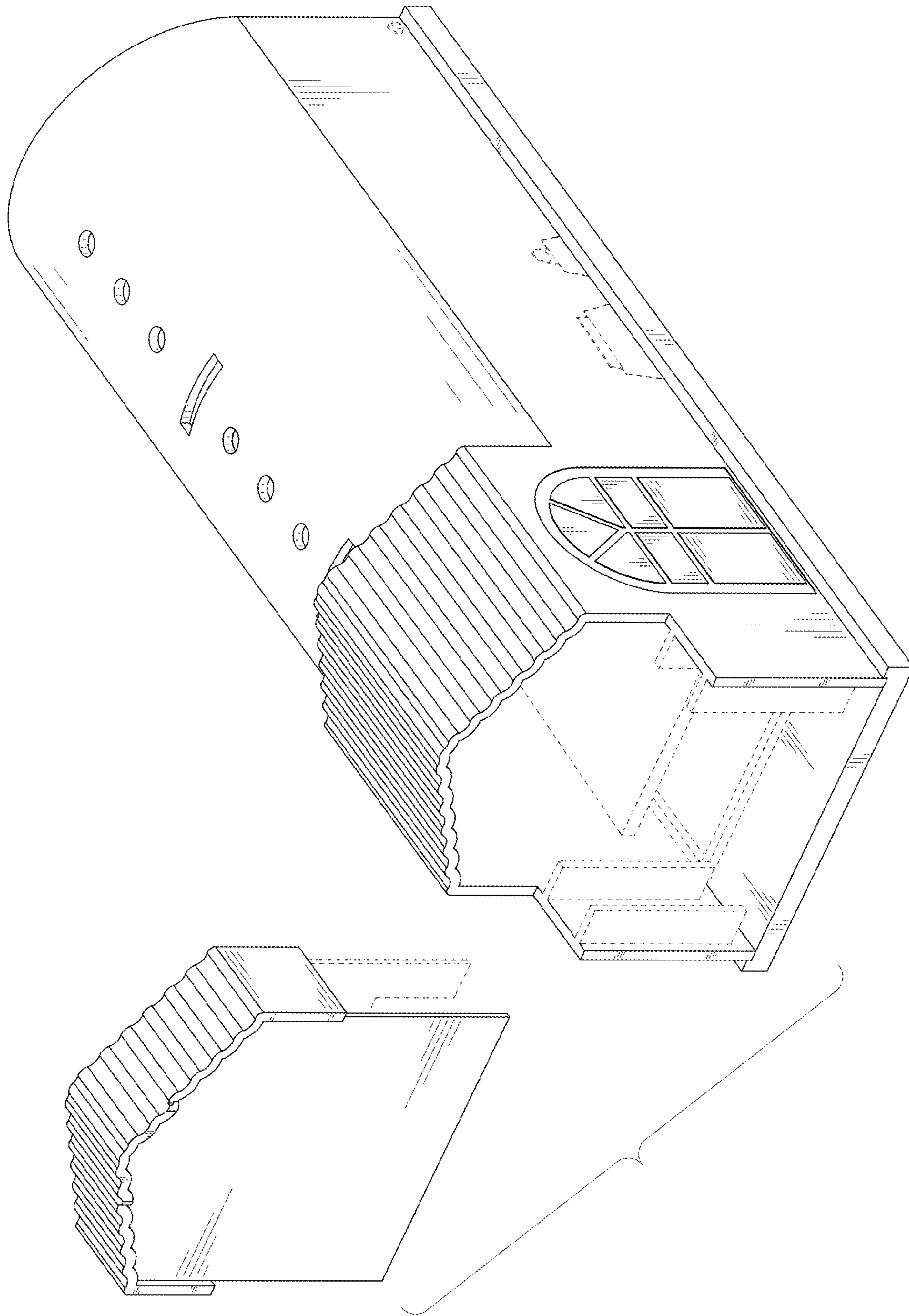
