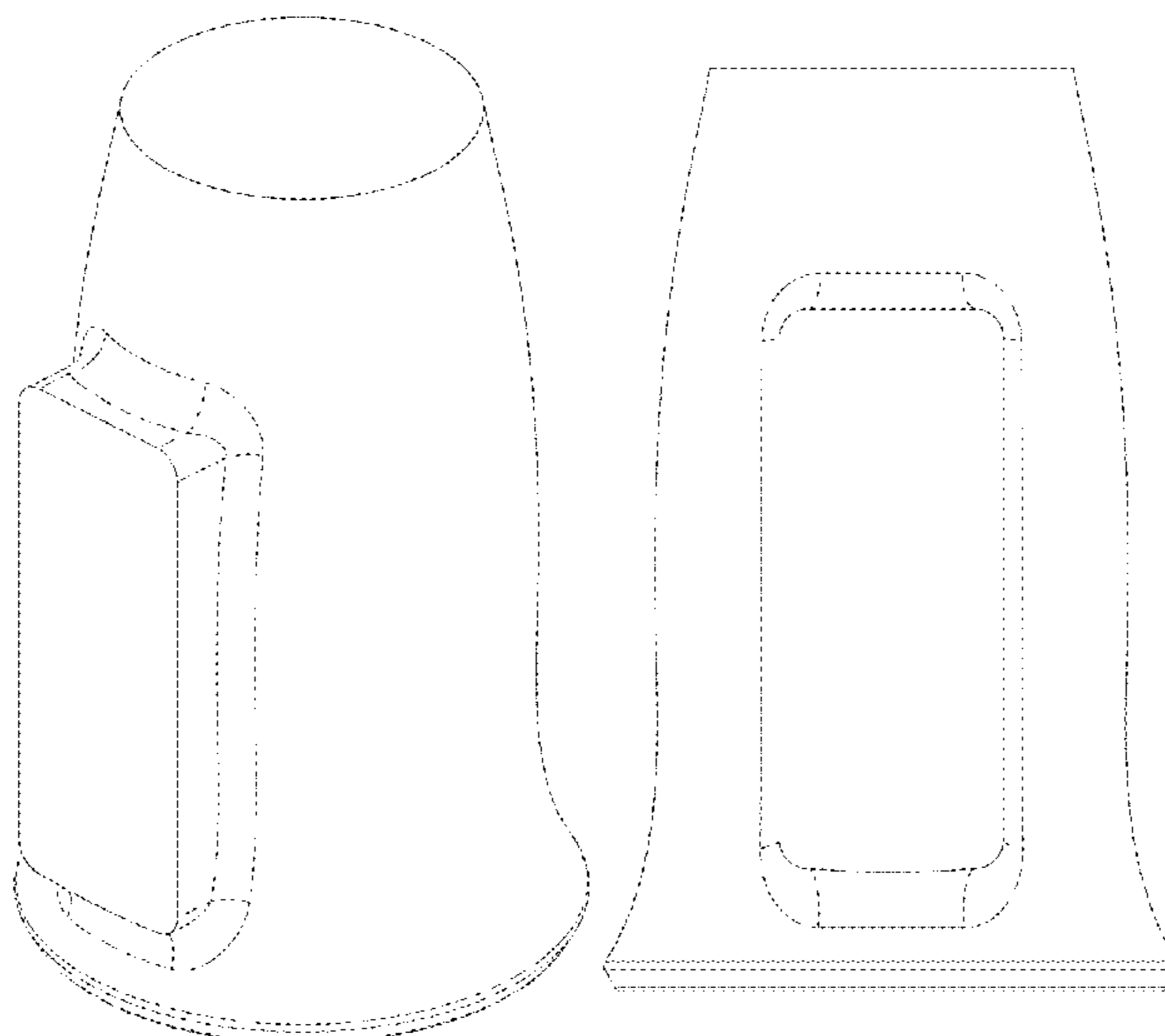
(57) **CLAIM**

The ornamental design for a faucet sprayhead, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a faucet sprayhead showing my new design;
FIG. 2 is rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom view thereof.
The broken lines shown in the figures depict portions of the faucet sprayhead that forms no part of the claimed design.

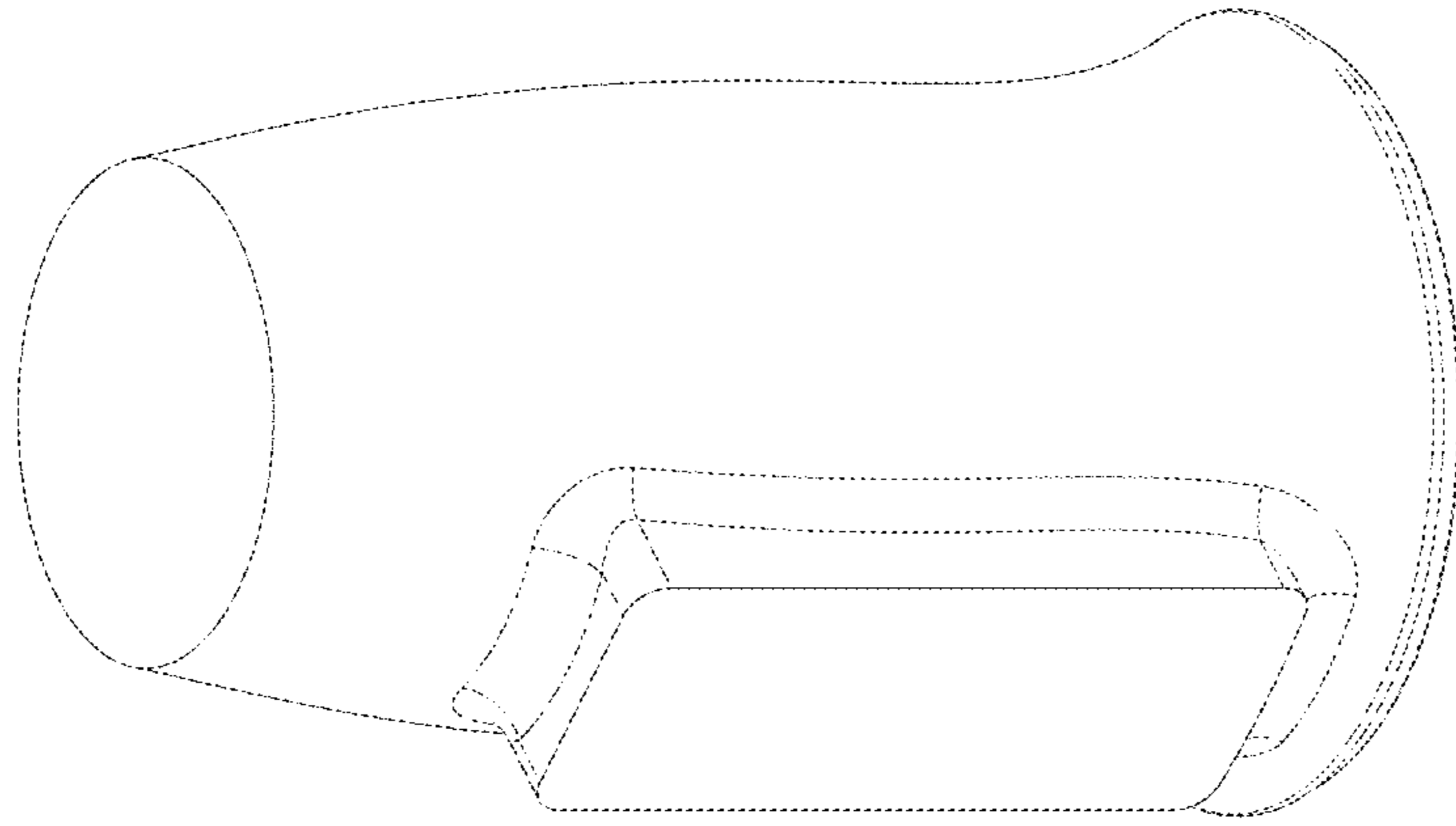

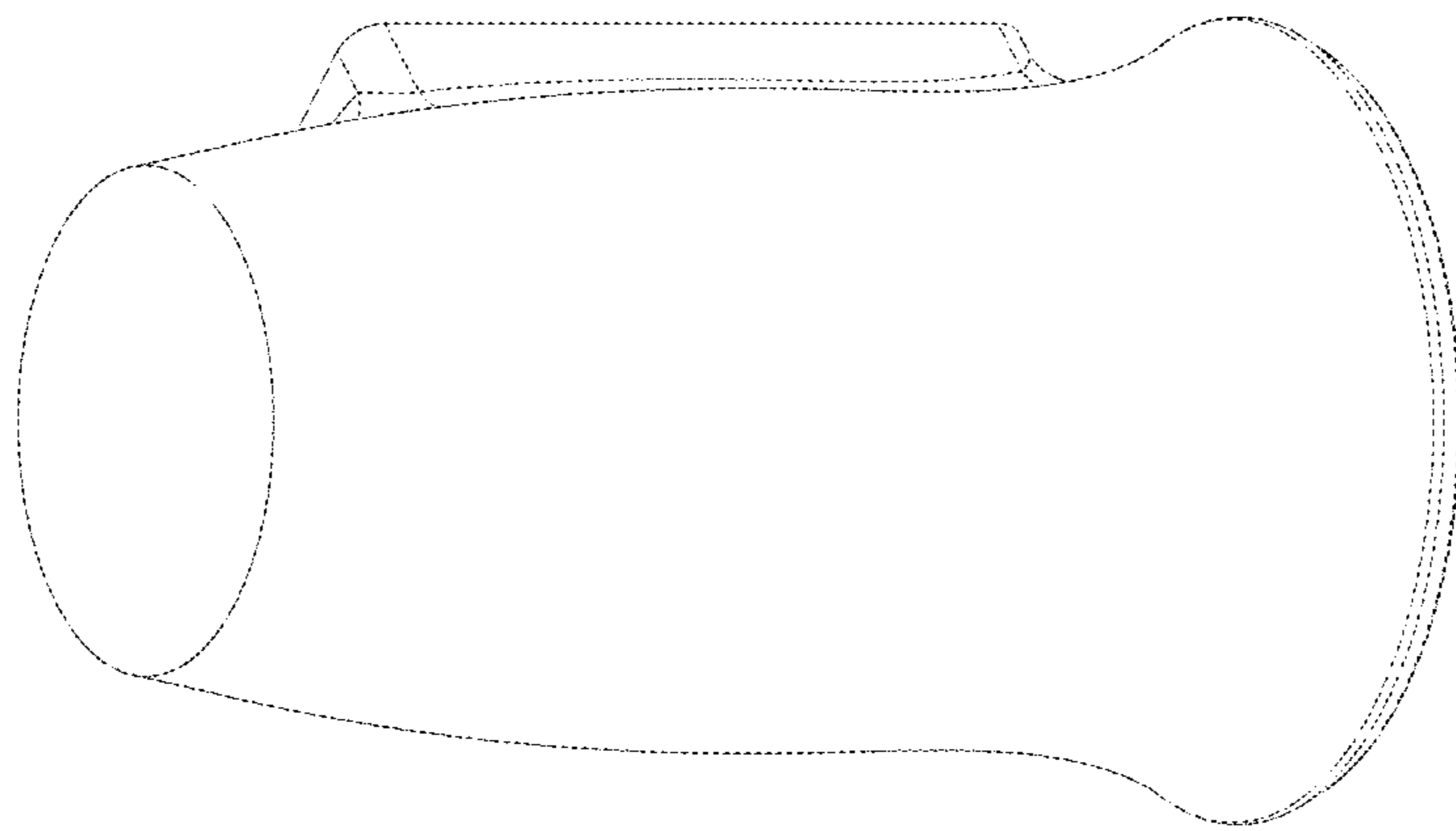

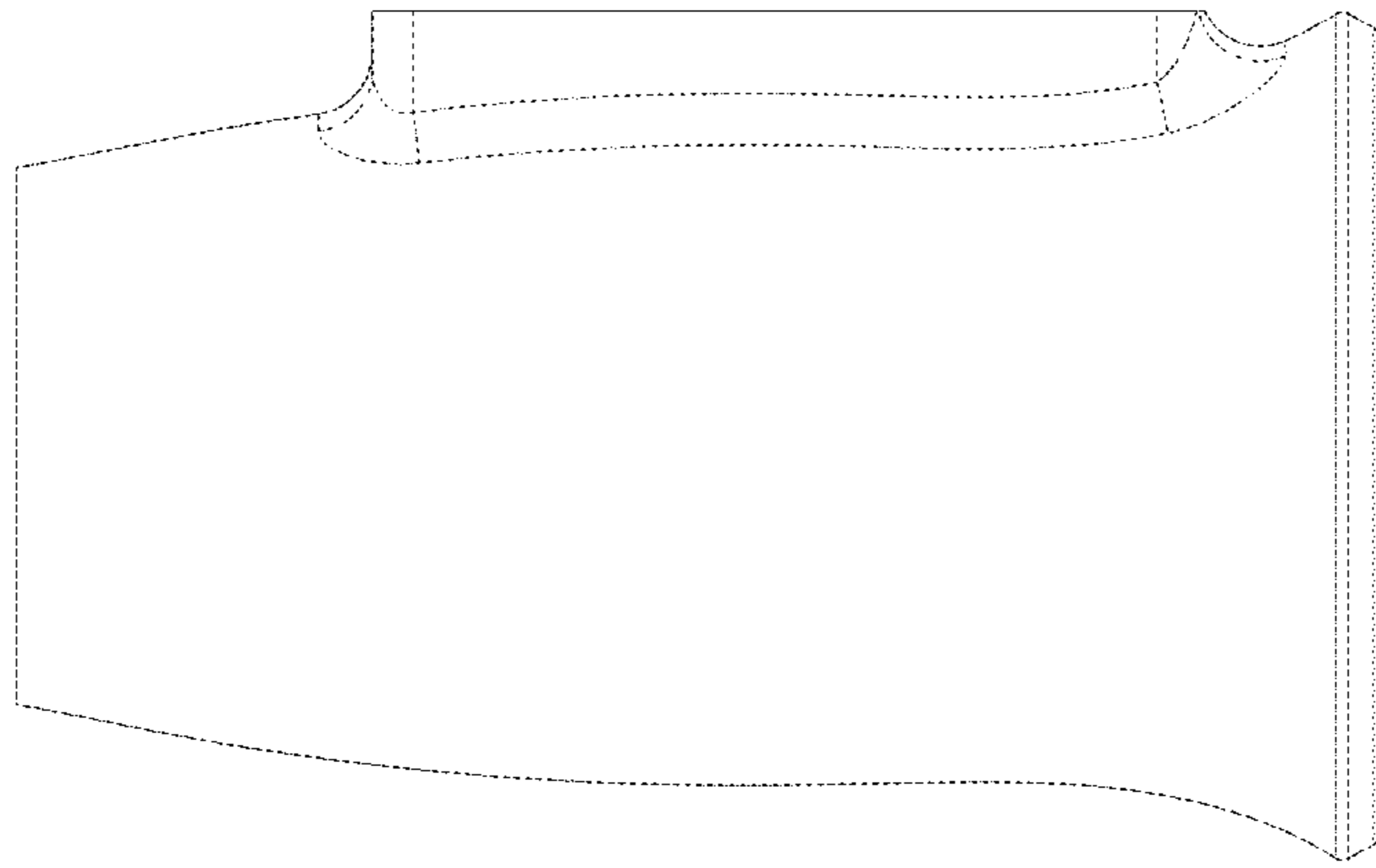

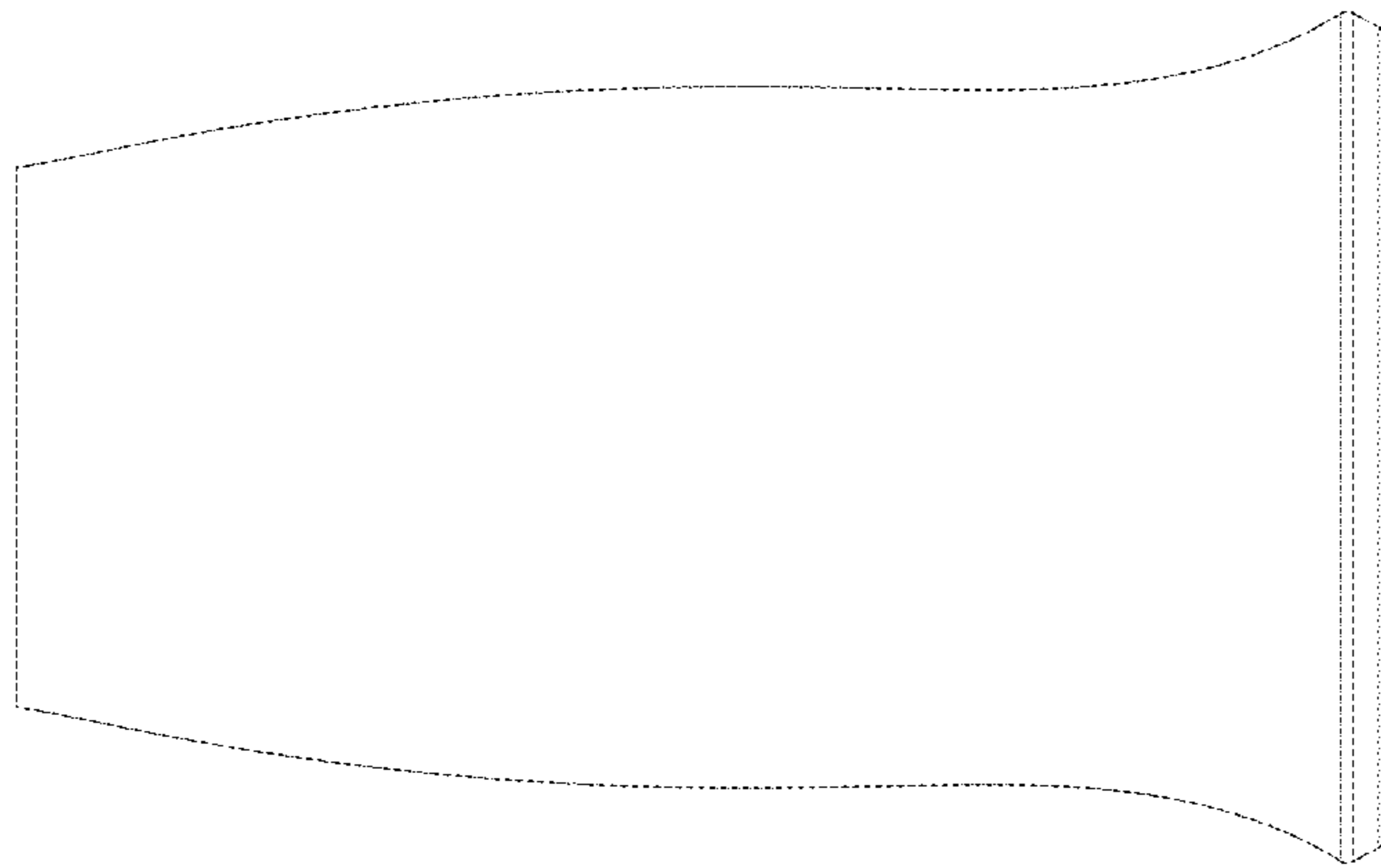

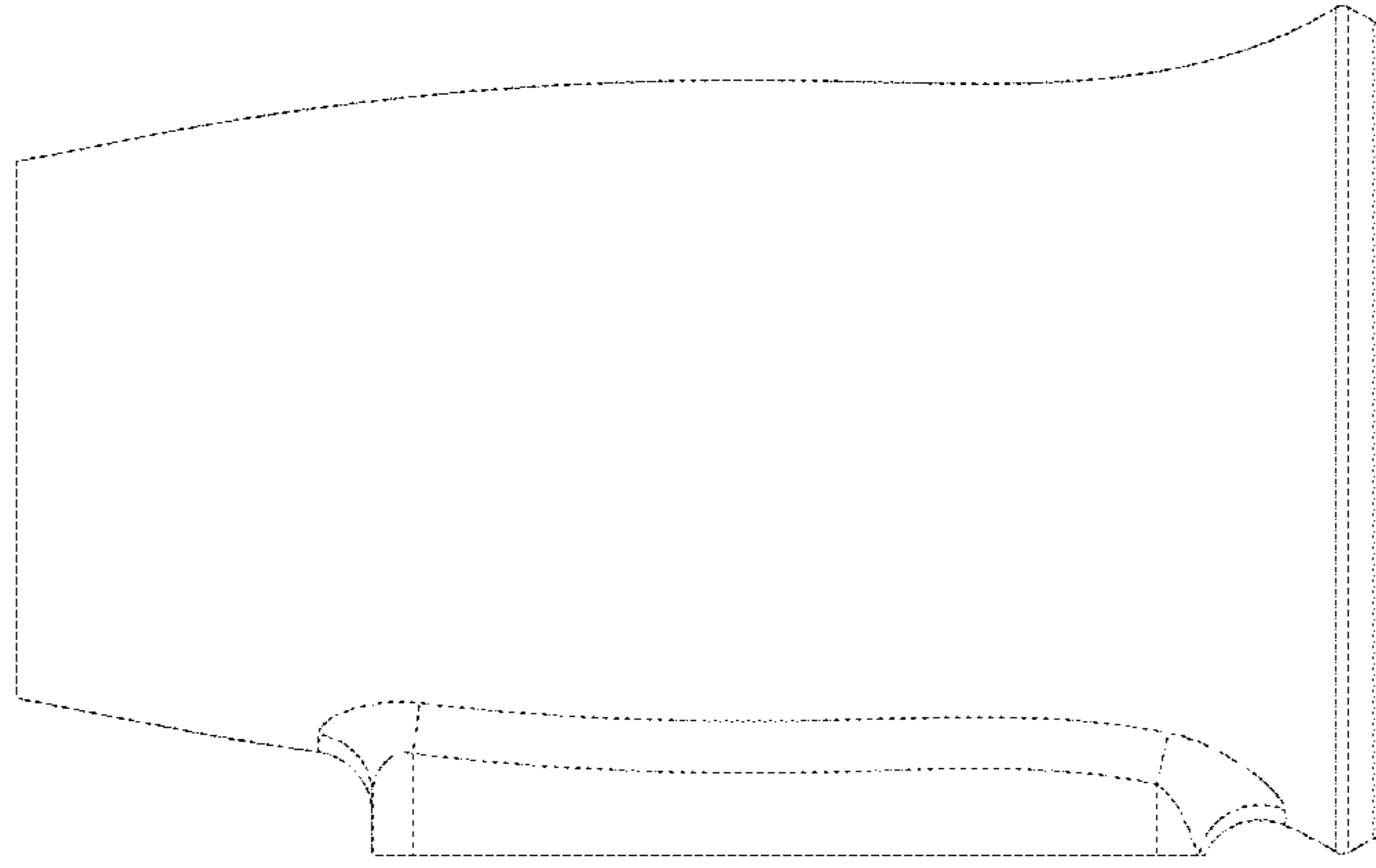

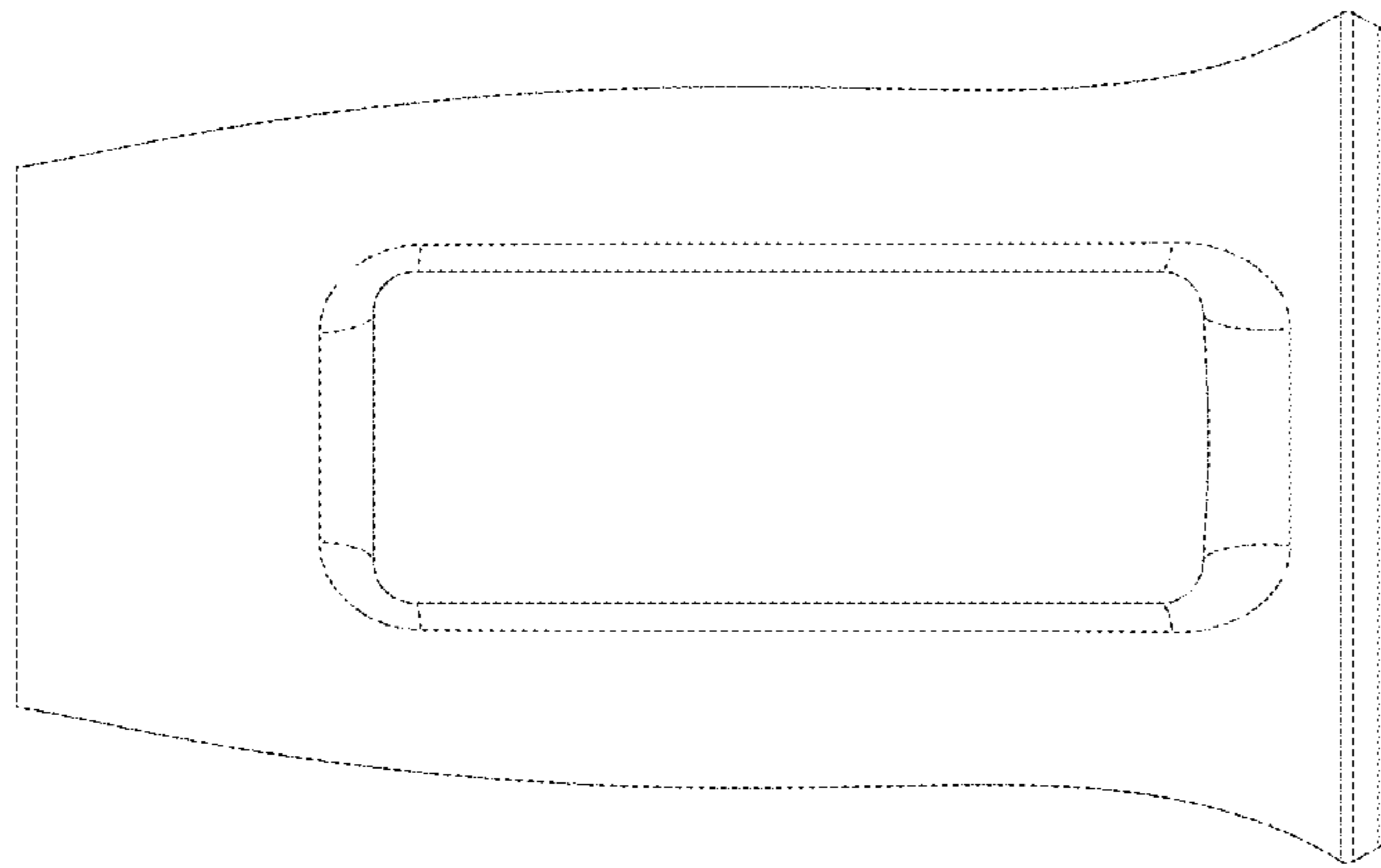

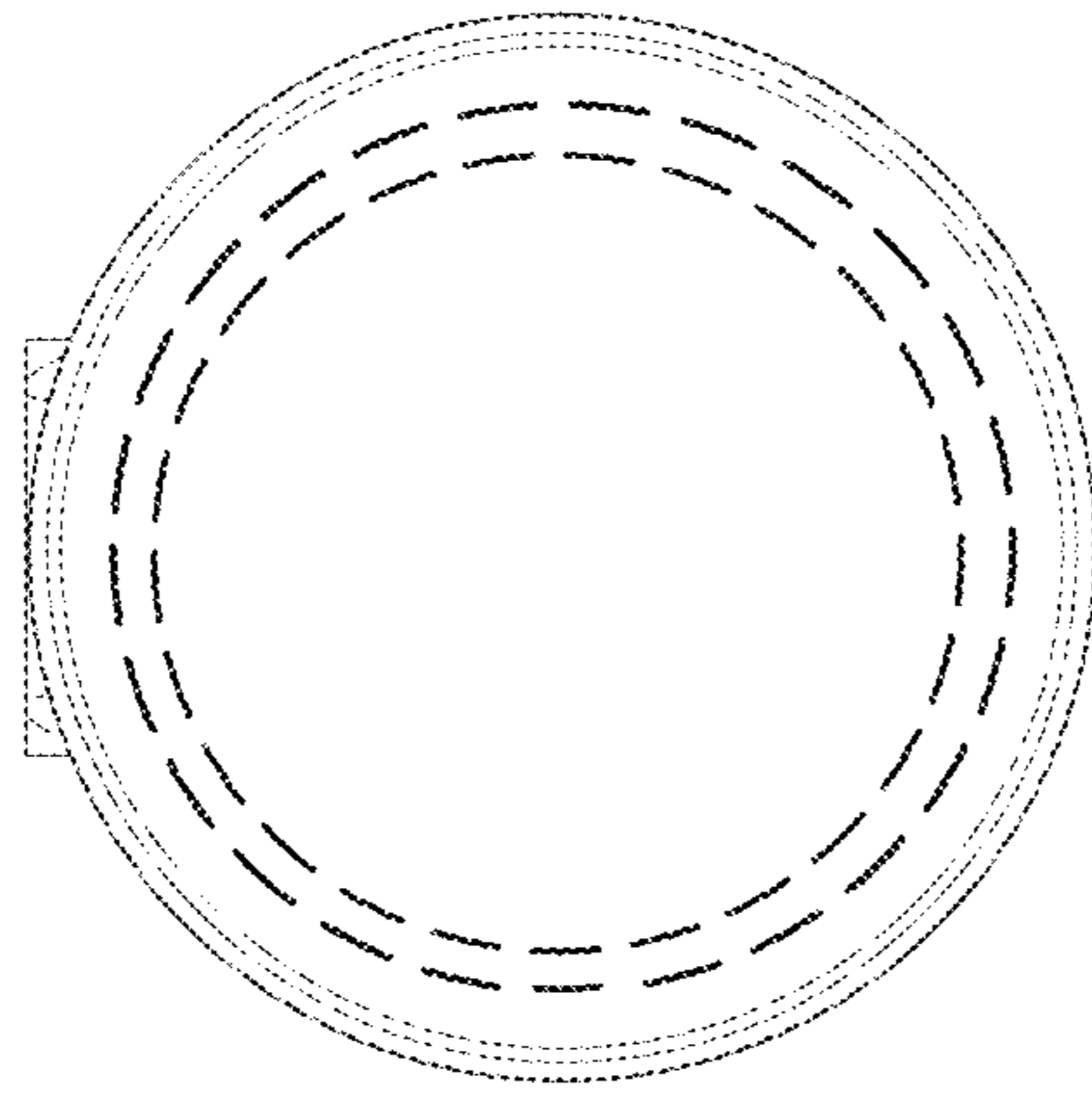

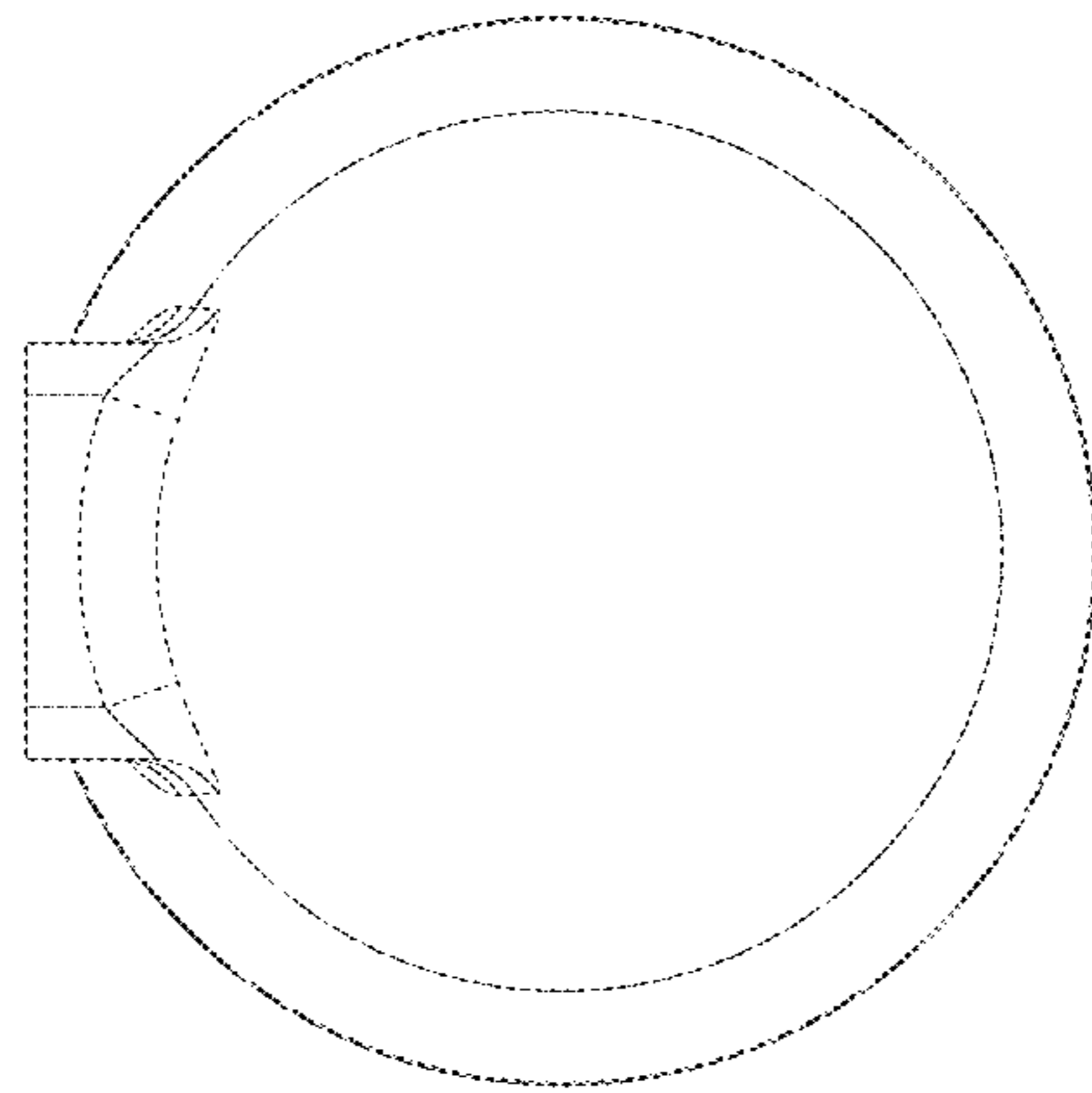
