The ornamental design for the electronic vaporizer, as described and shown.

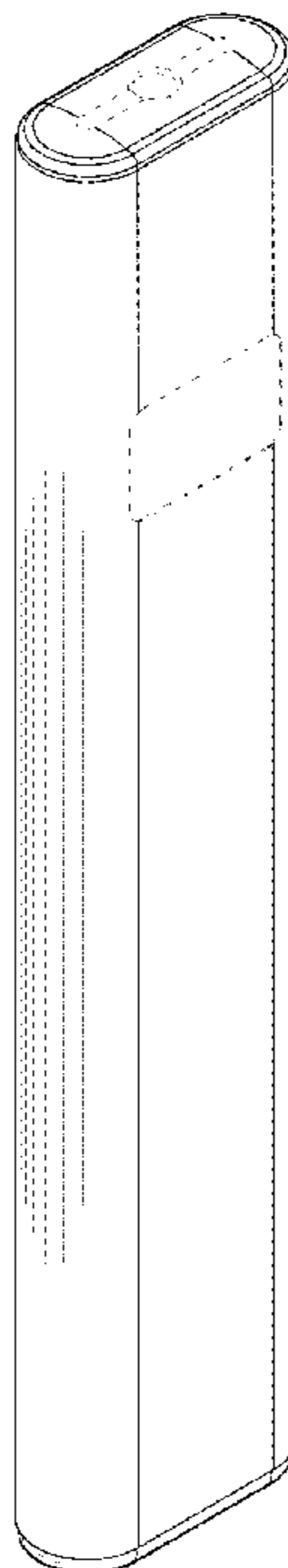
**DESCRIPTION**

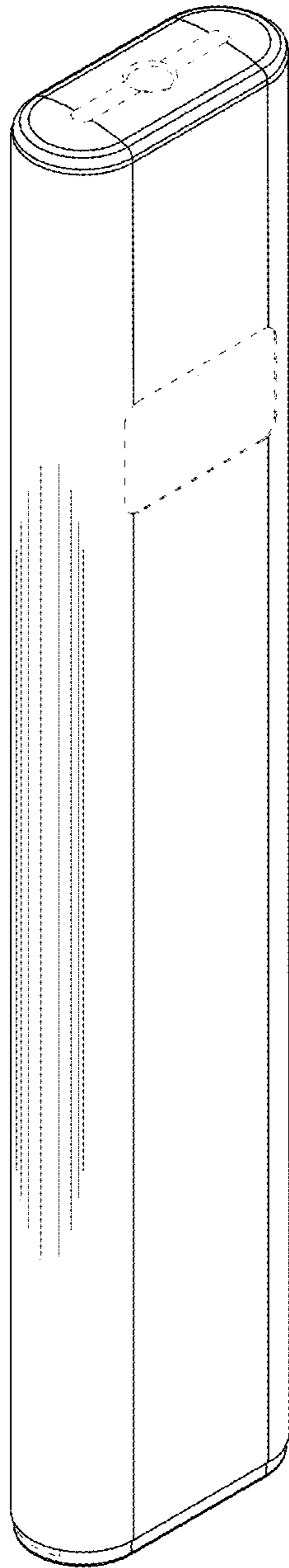

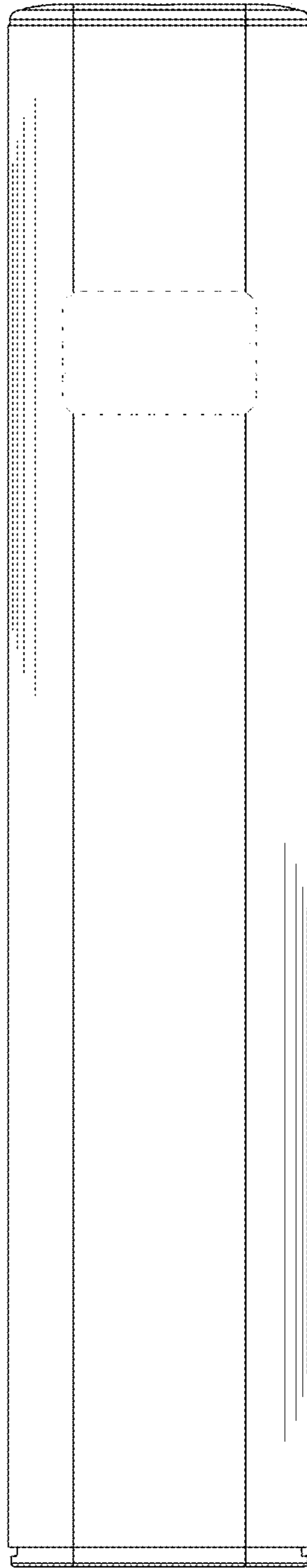

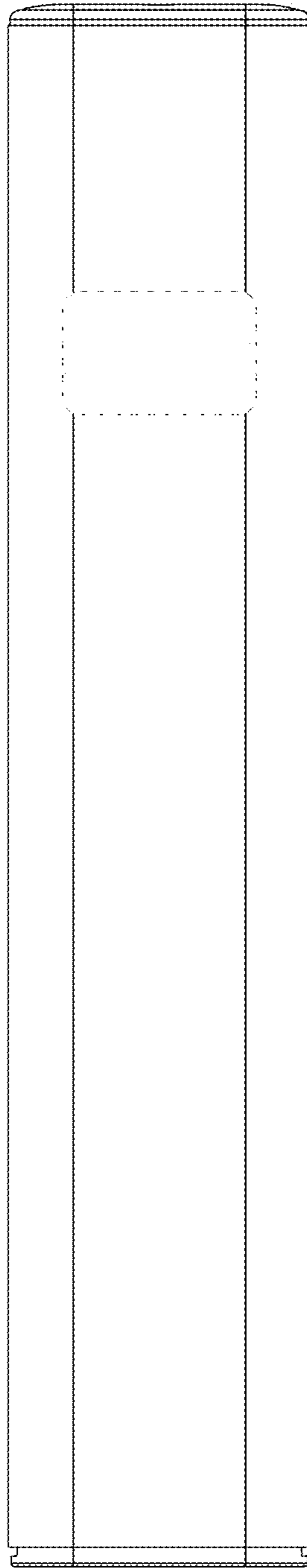

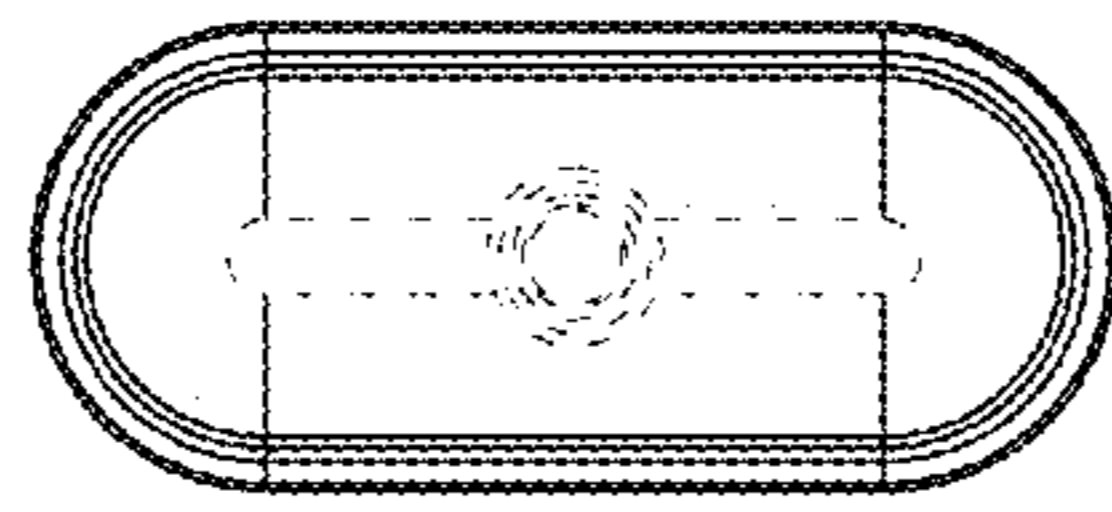

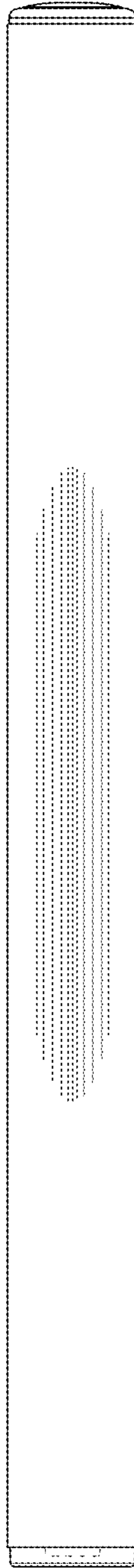

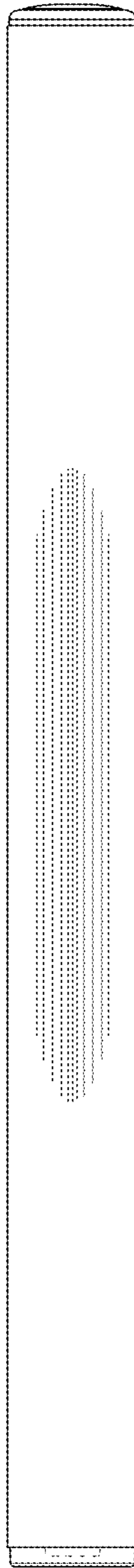
