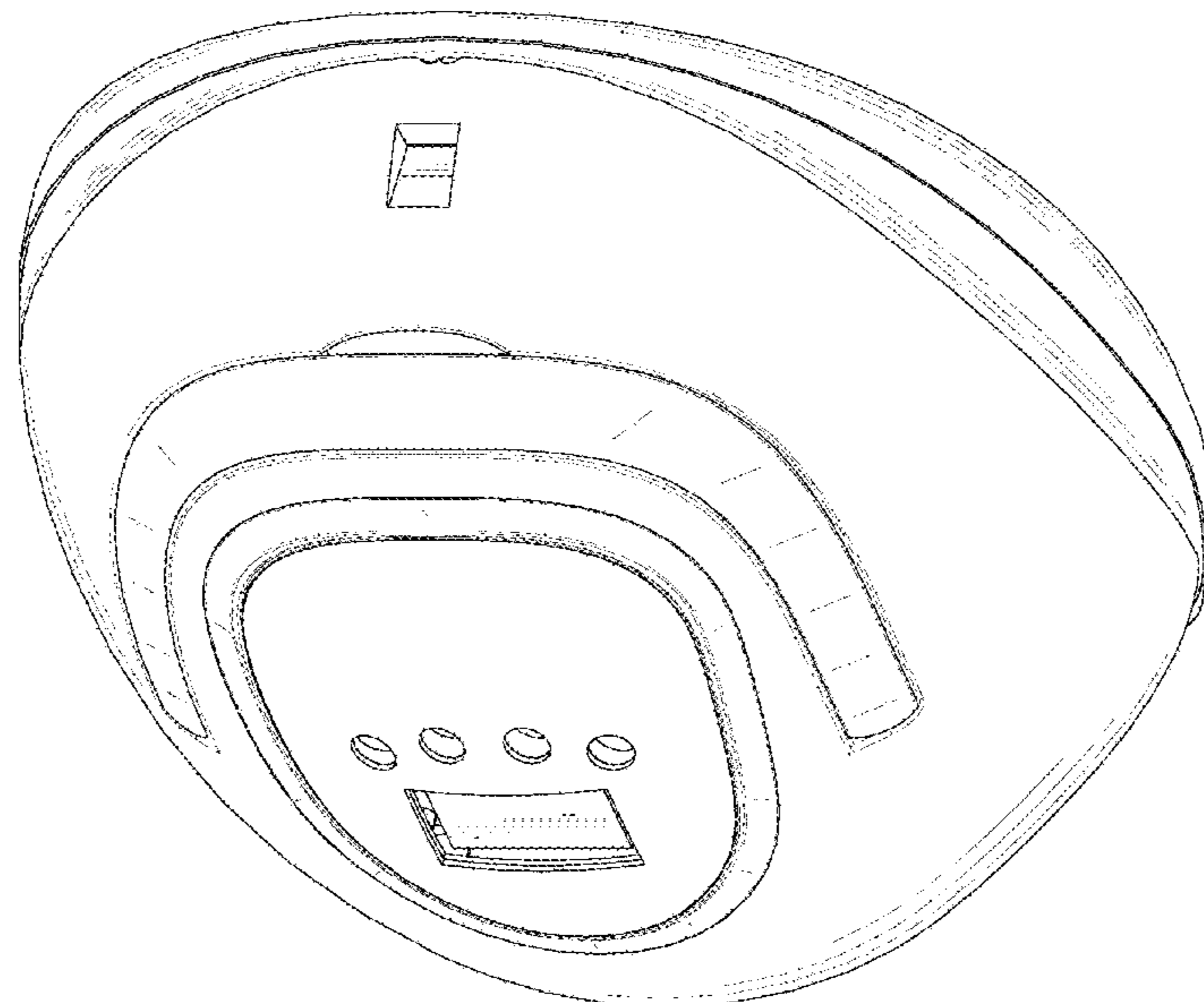
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of a nail dryer showing my design;  
FIG. 2 is a back elevation view thereof;

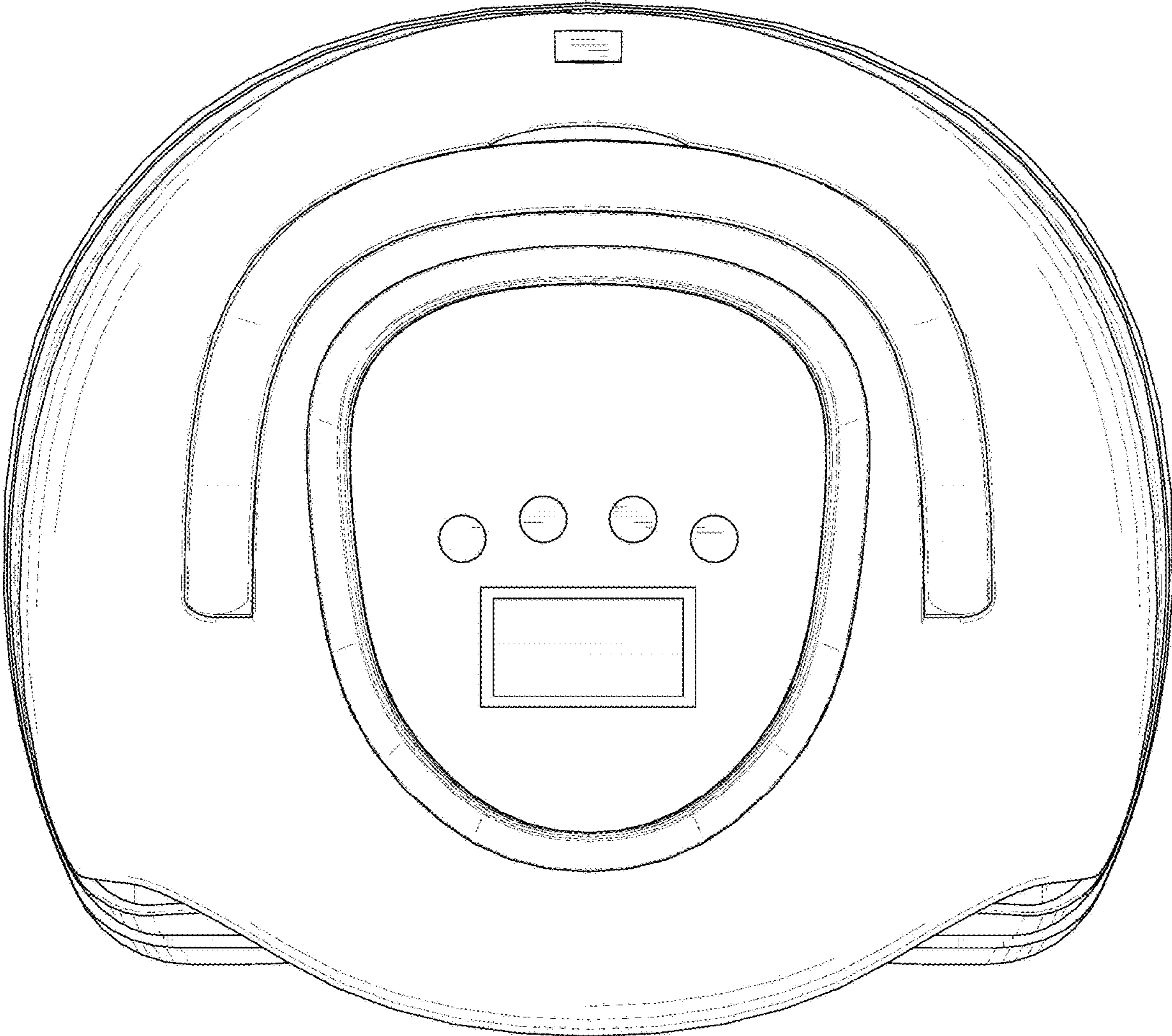

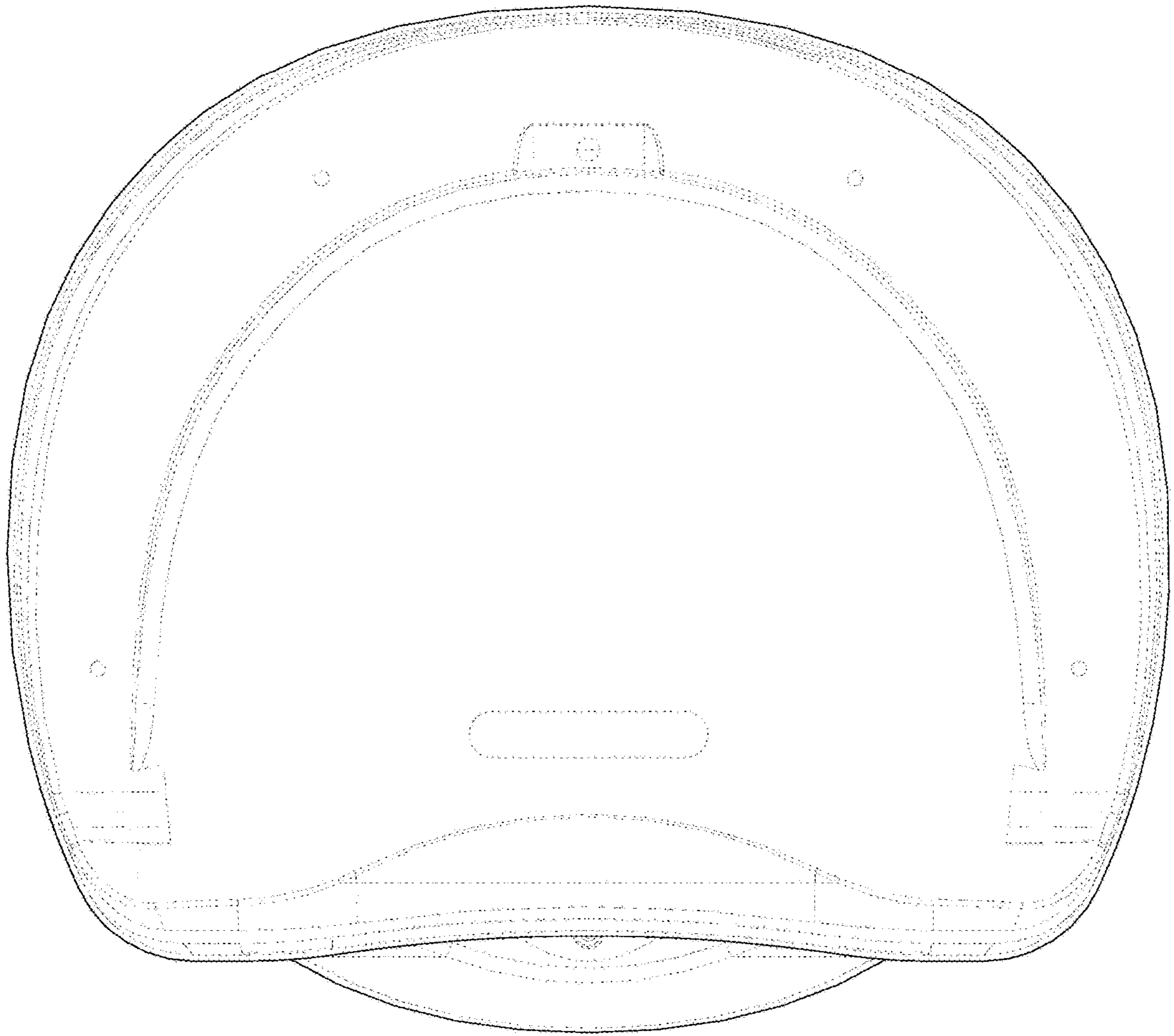
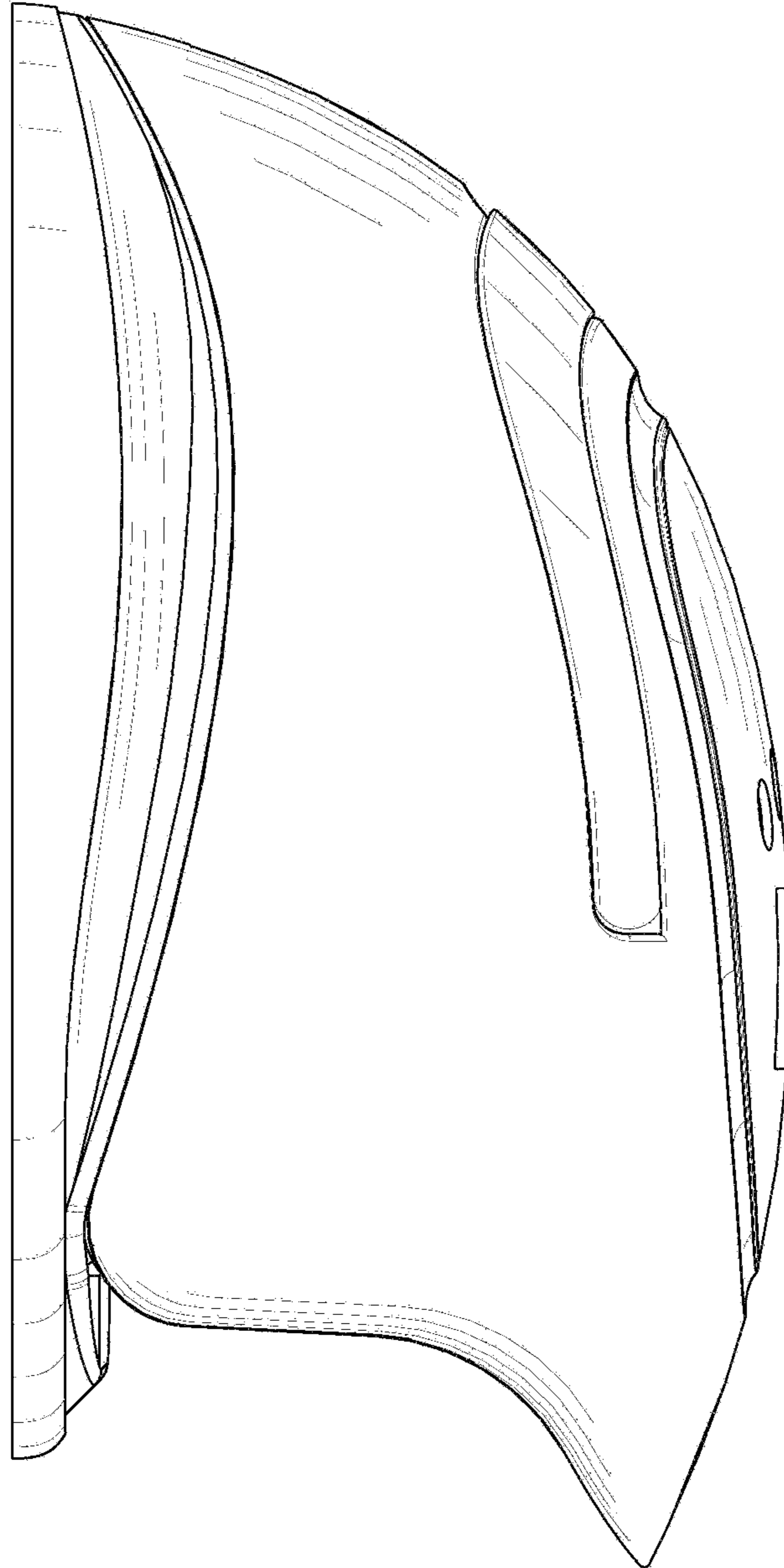
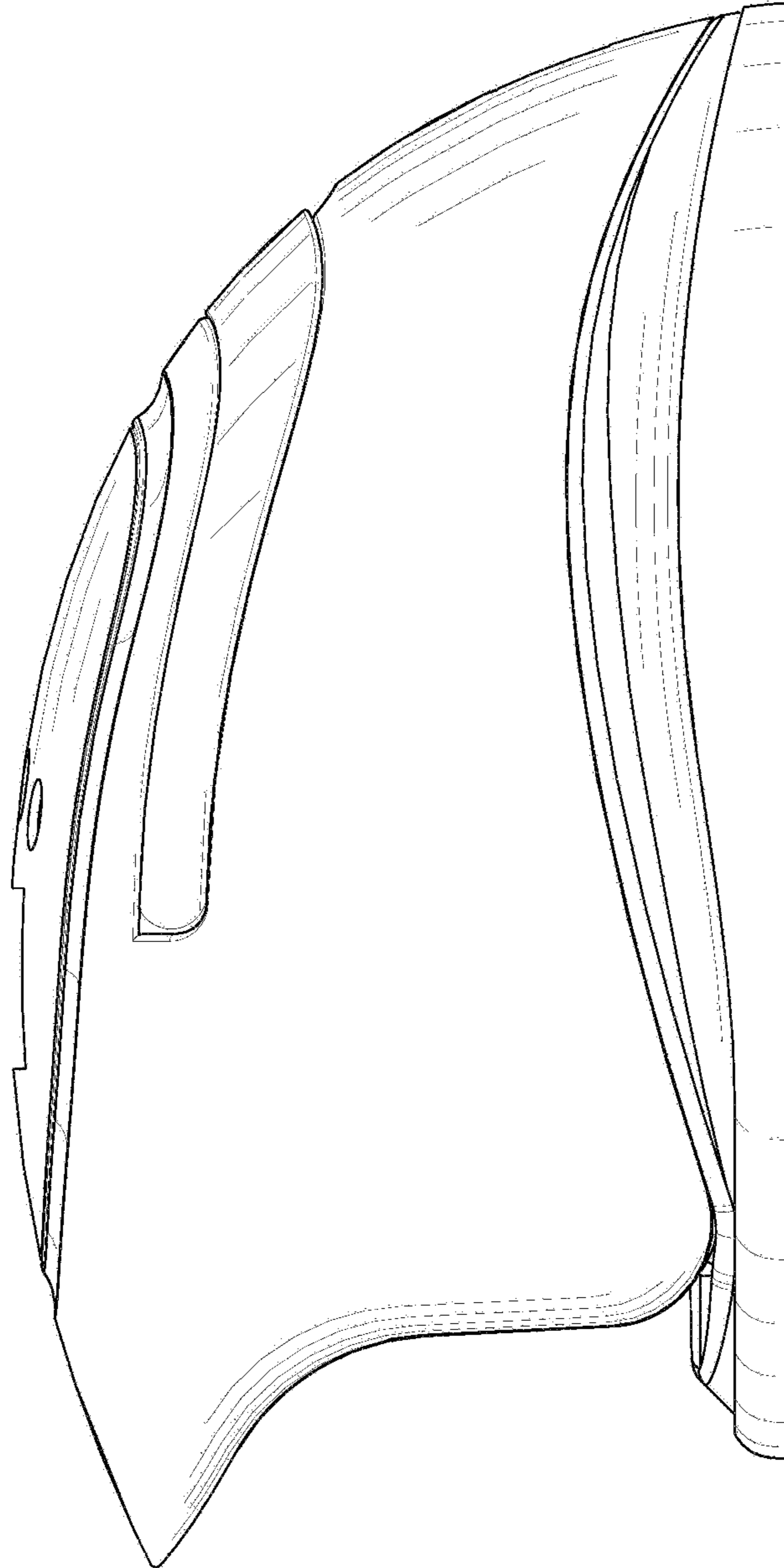

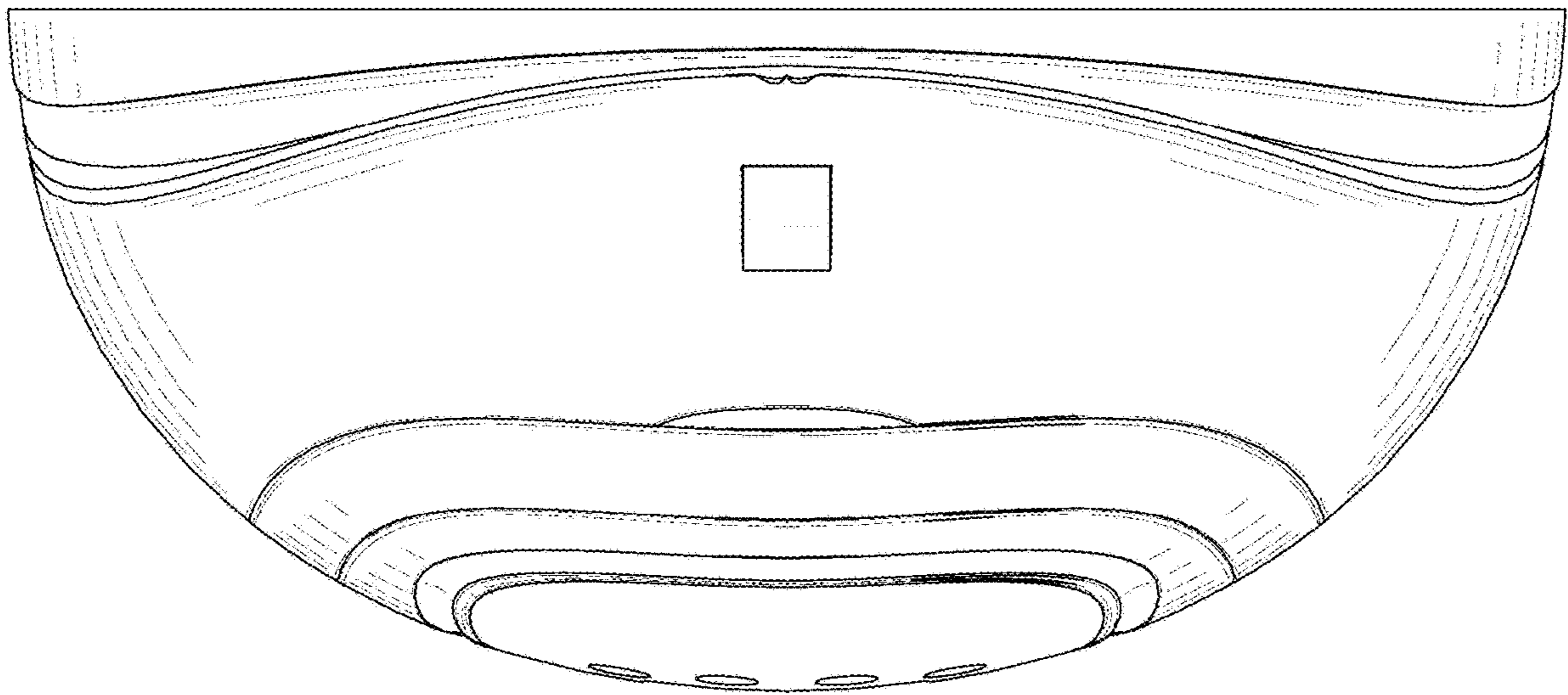

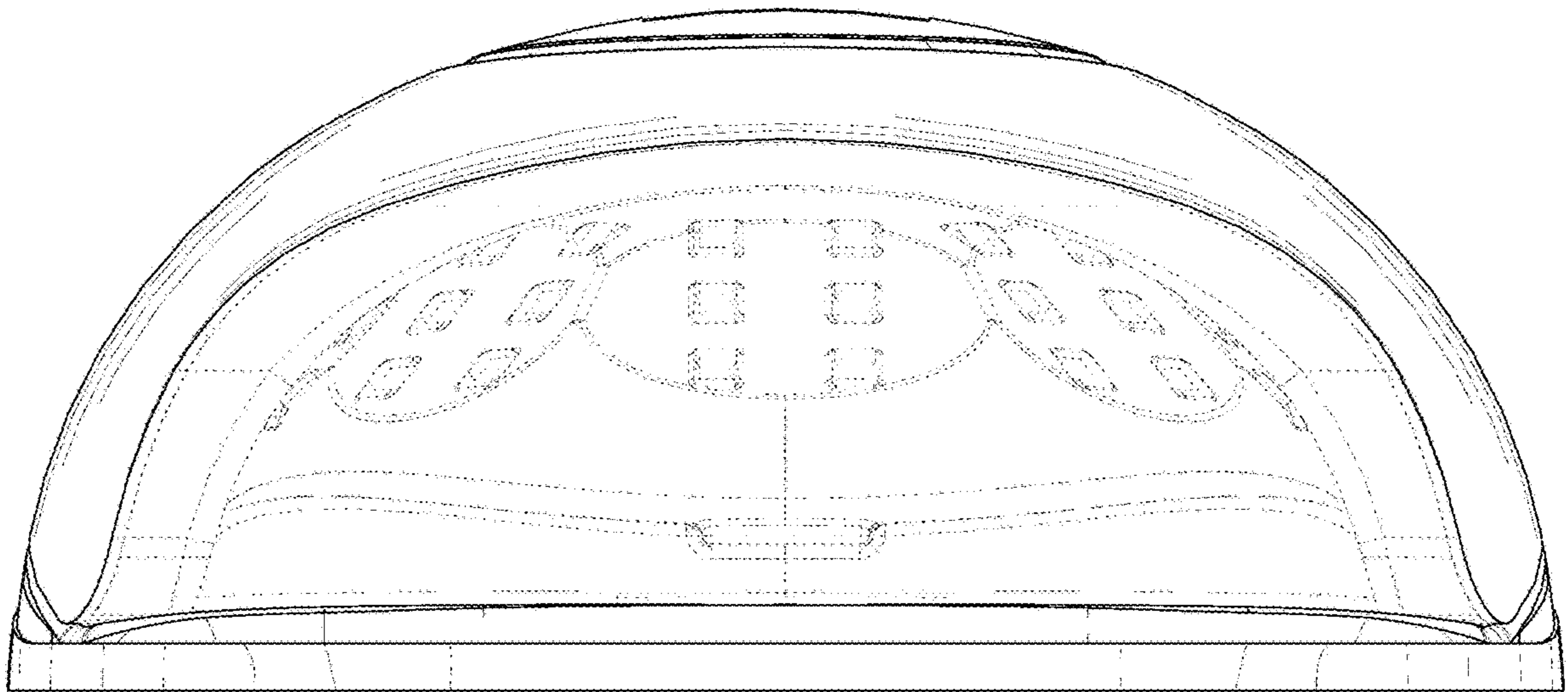

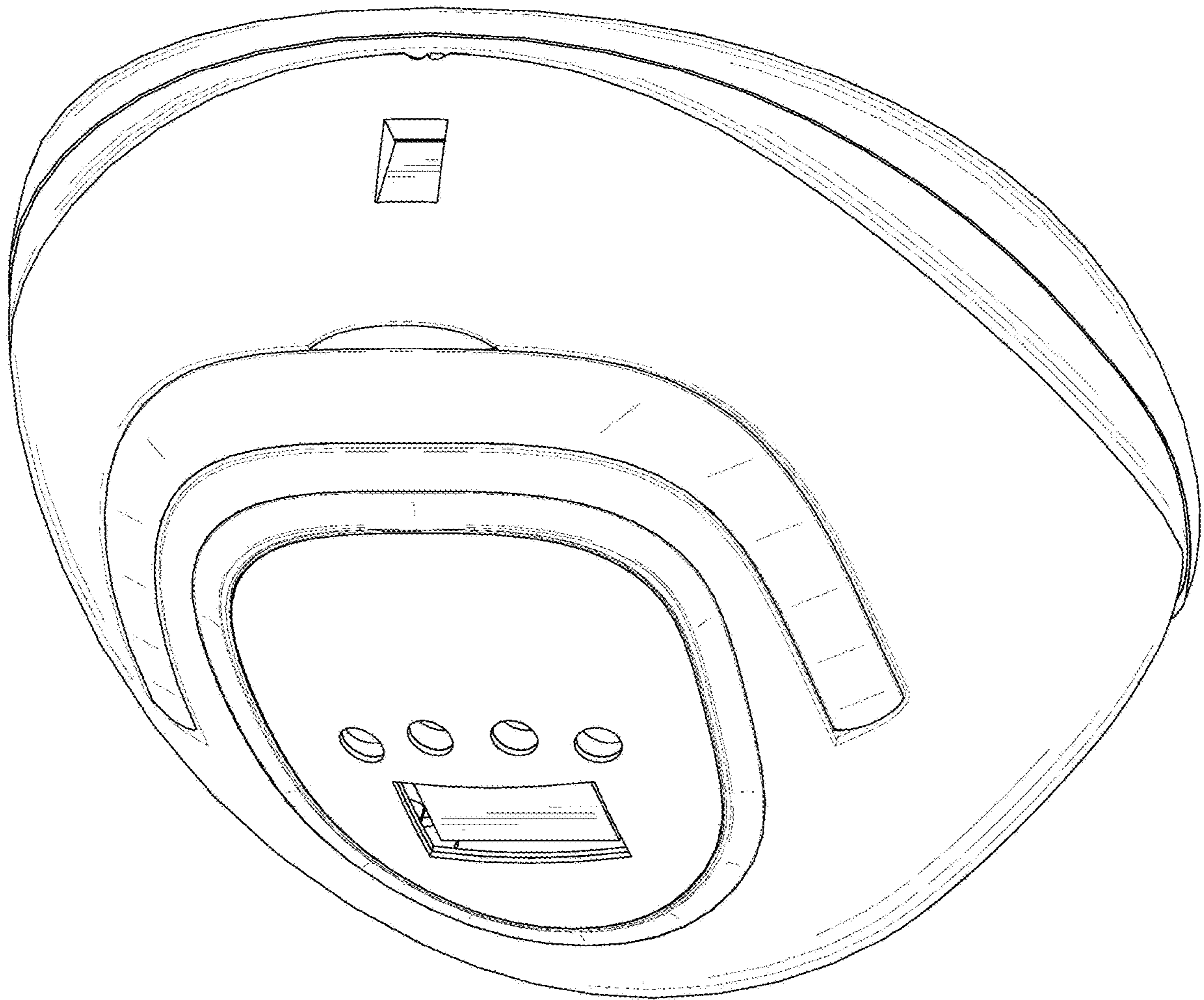
