DESCRIPTION

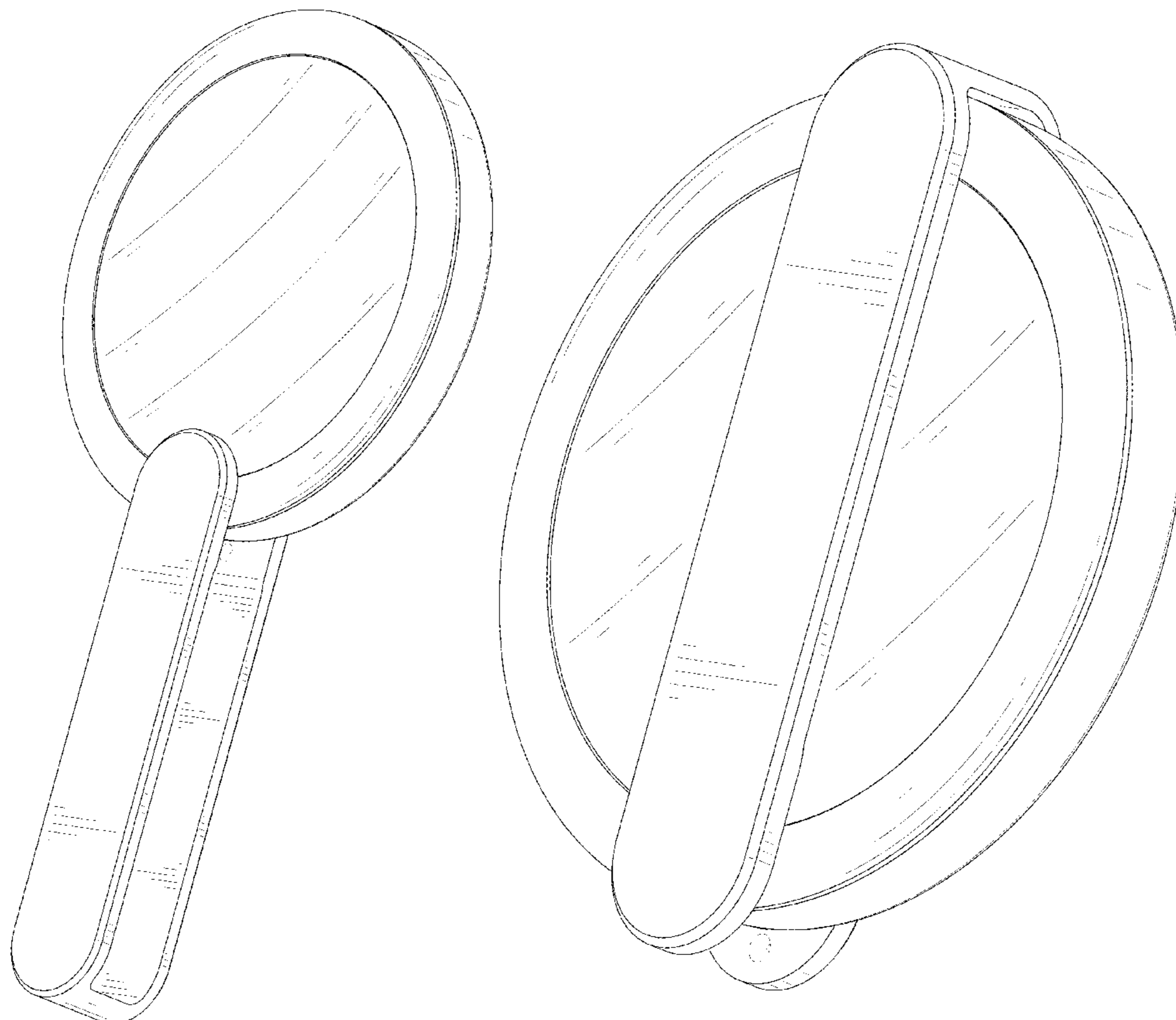
FIG. 1 is a perspective view of a mirror showing my new design;

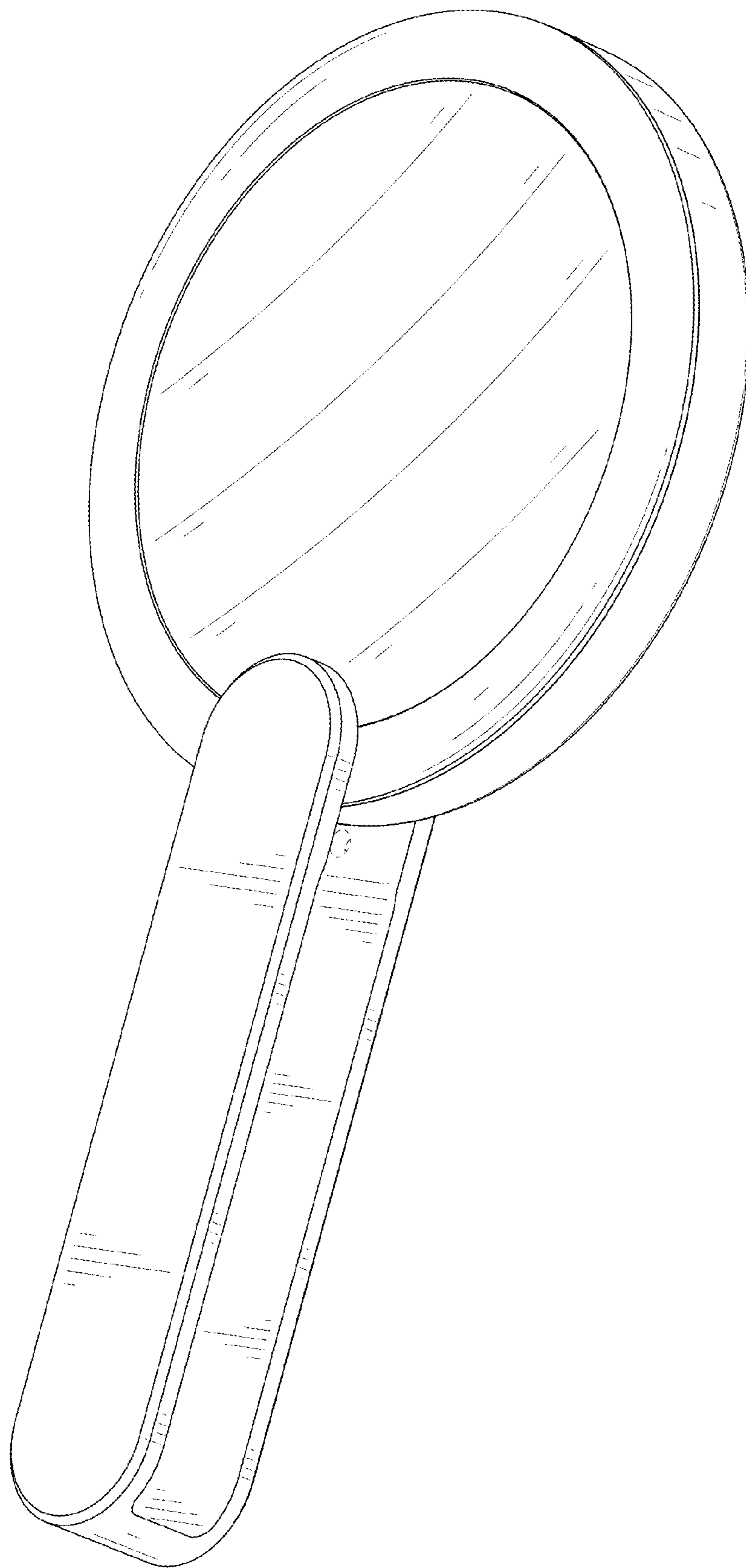

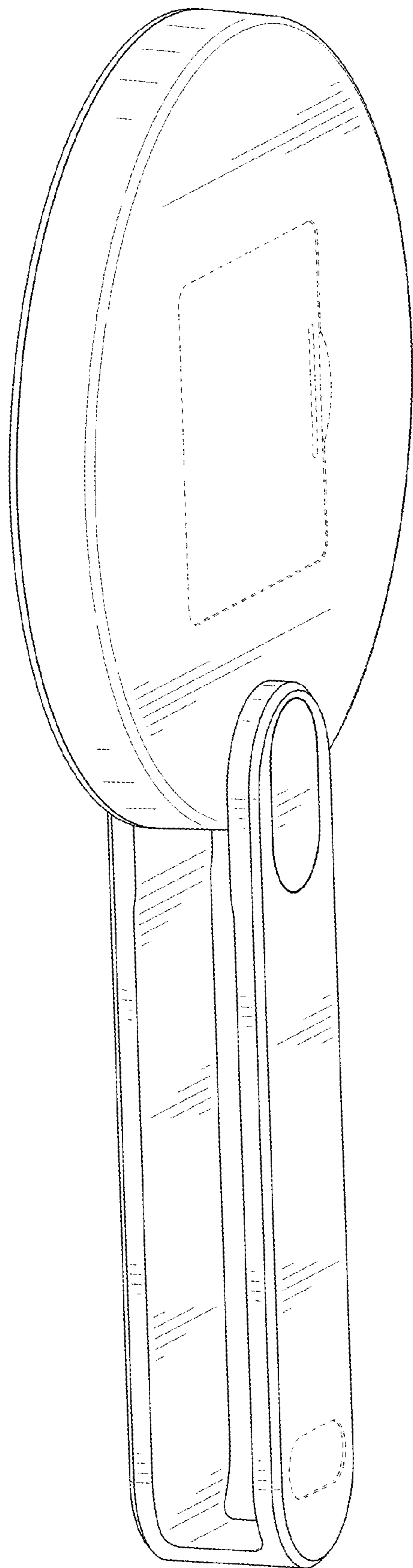

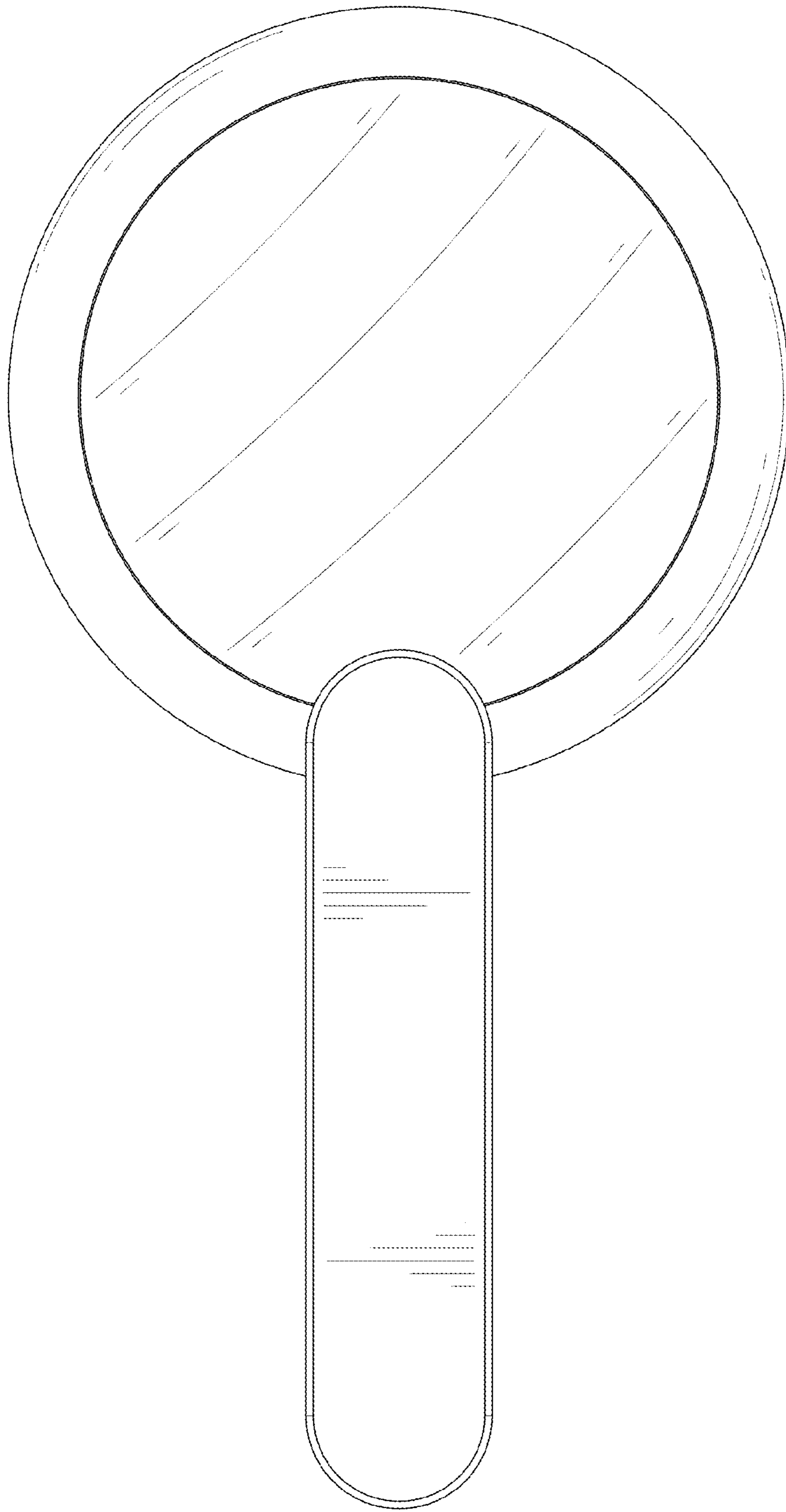

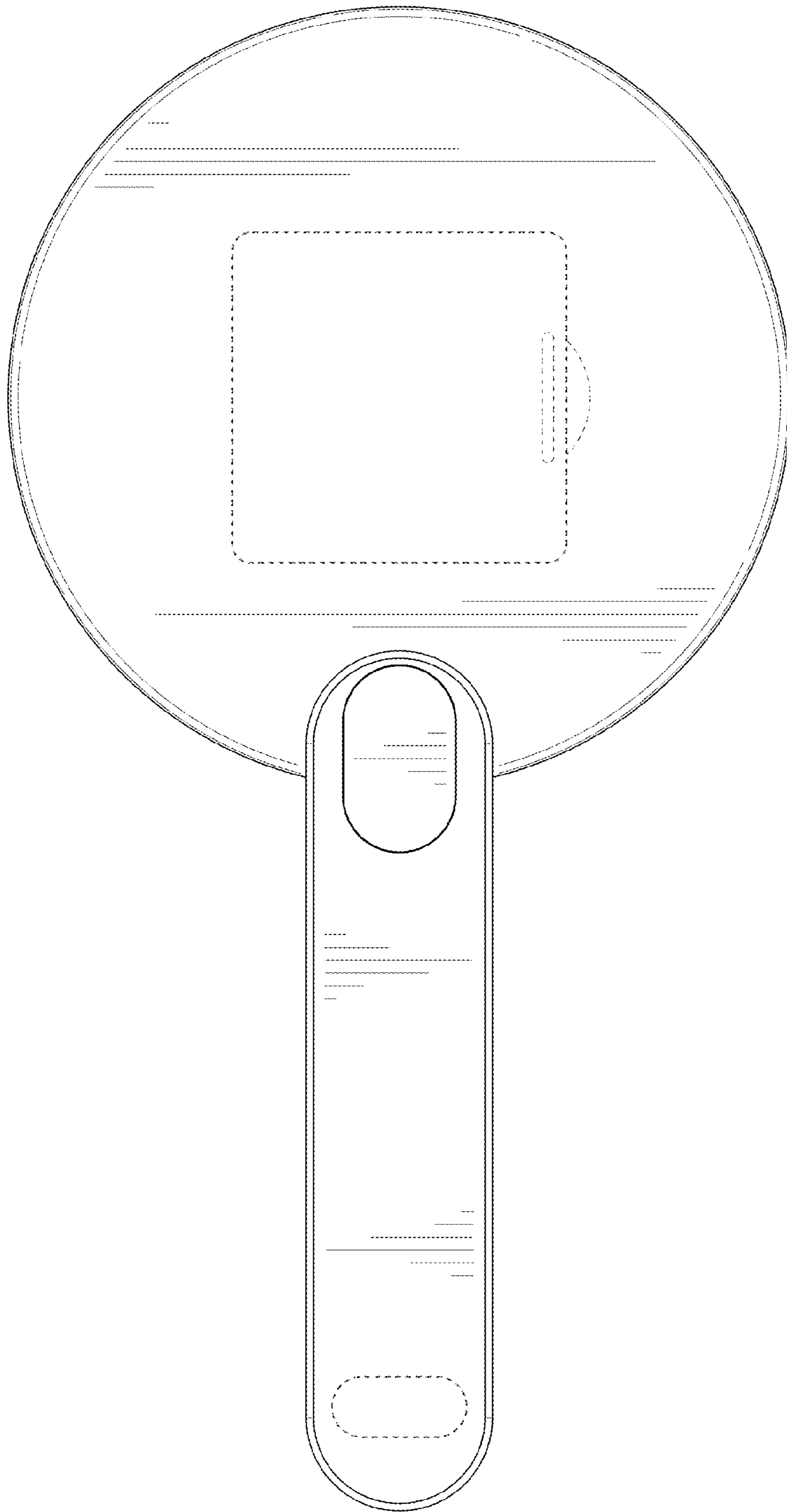

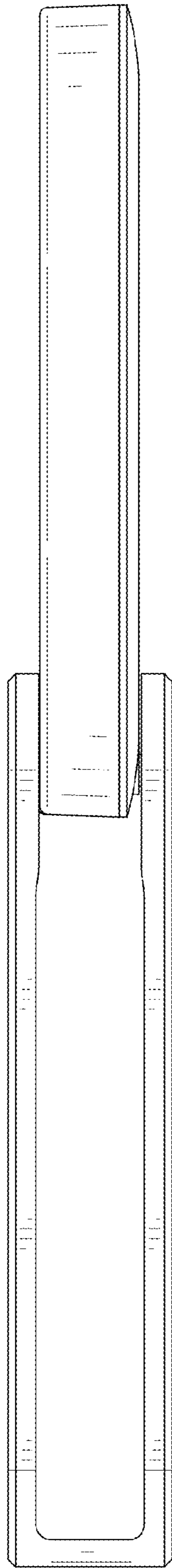

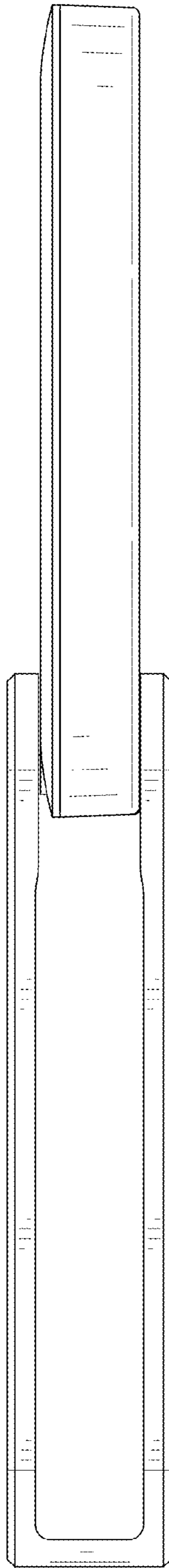

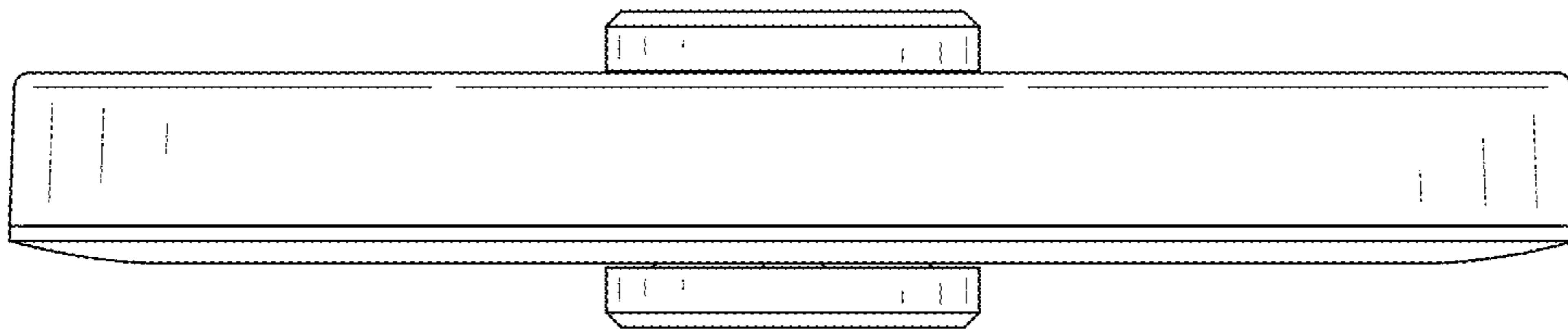

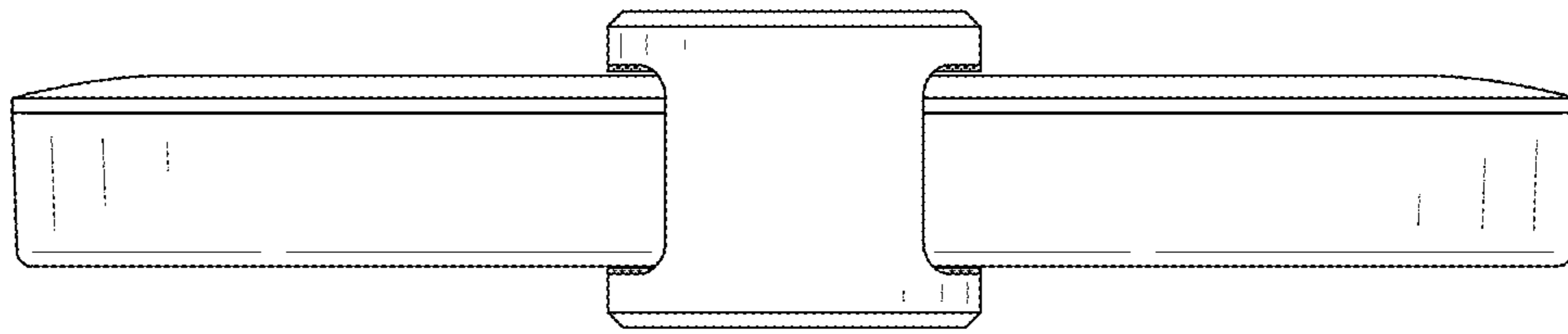

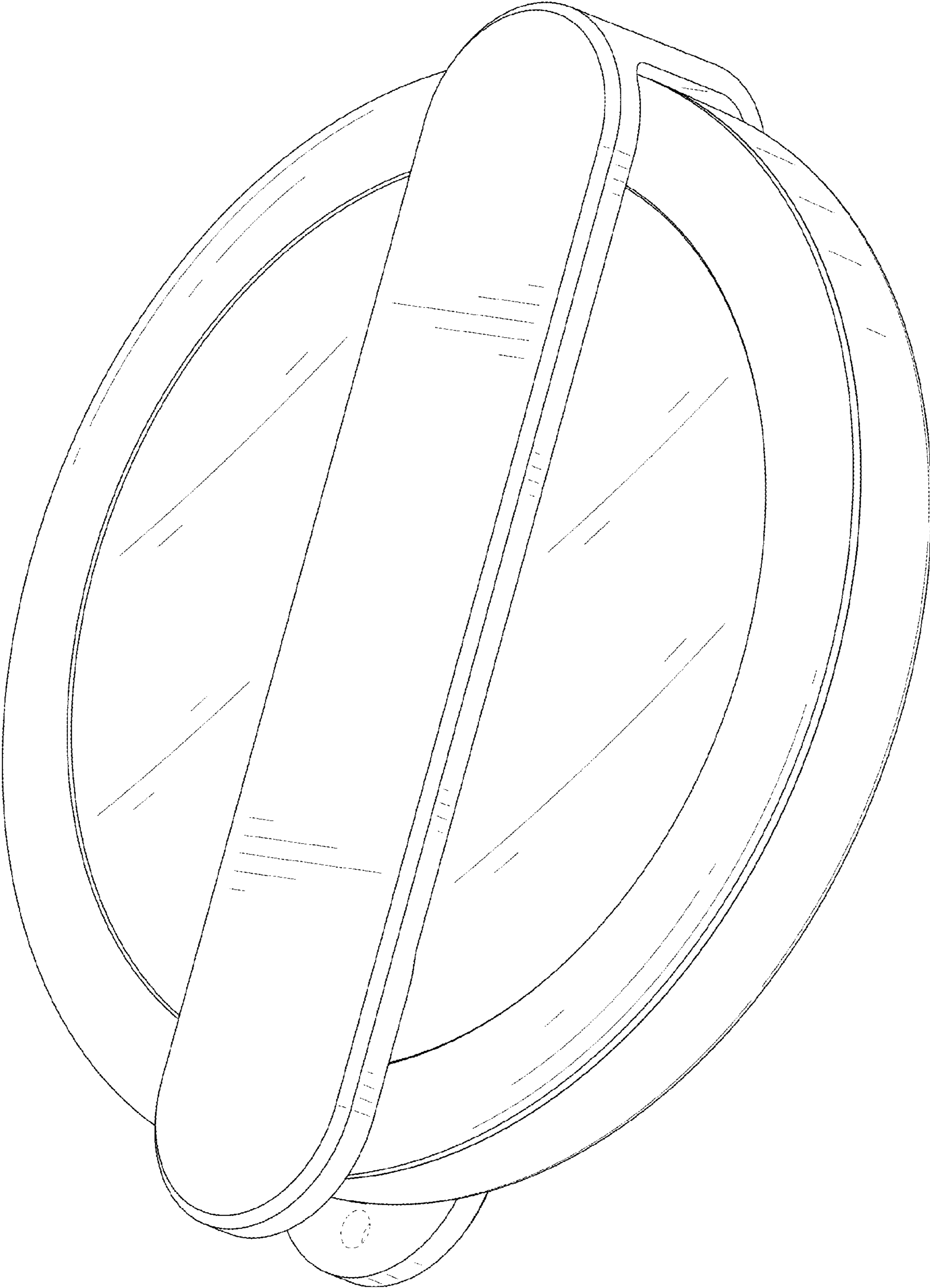
