(57) **CLAIM**

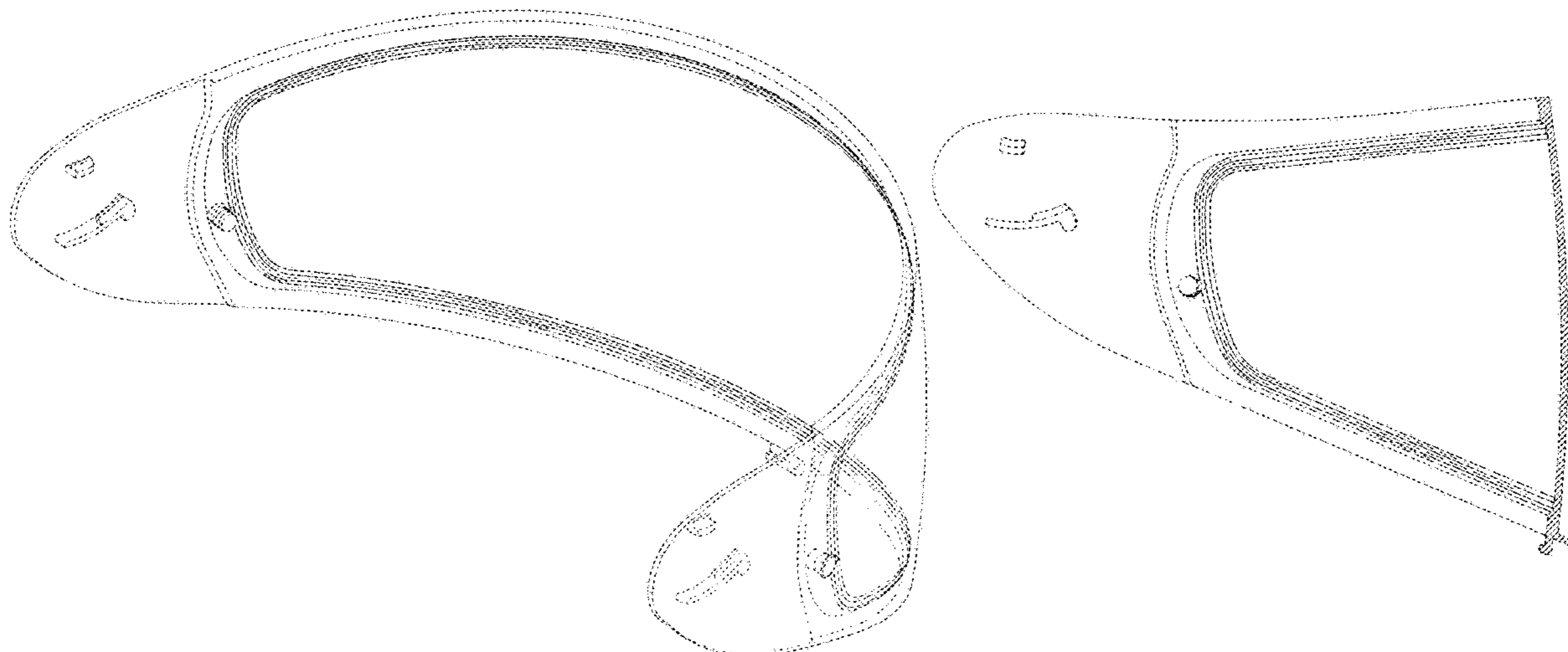
The ornamental design for a helmet shield, as shown and described.

**DESCRIPTION**

FIG. 1 is a back, top and left side perspective view of a helmet shield showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a right side view thereof, the left side view being a mirror image of FIG. 6; and,  
FIG. 7 is a cross-sectional view taken along line 7-7 in FIG. 3.

The broken lines illustrate portions of the helmet shield that form no part of the claimed design. The dash-dotted lines denote the boundary of the claim and form no part of the claimed design.

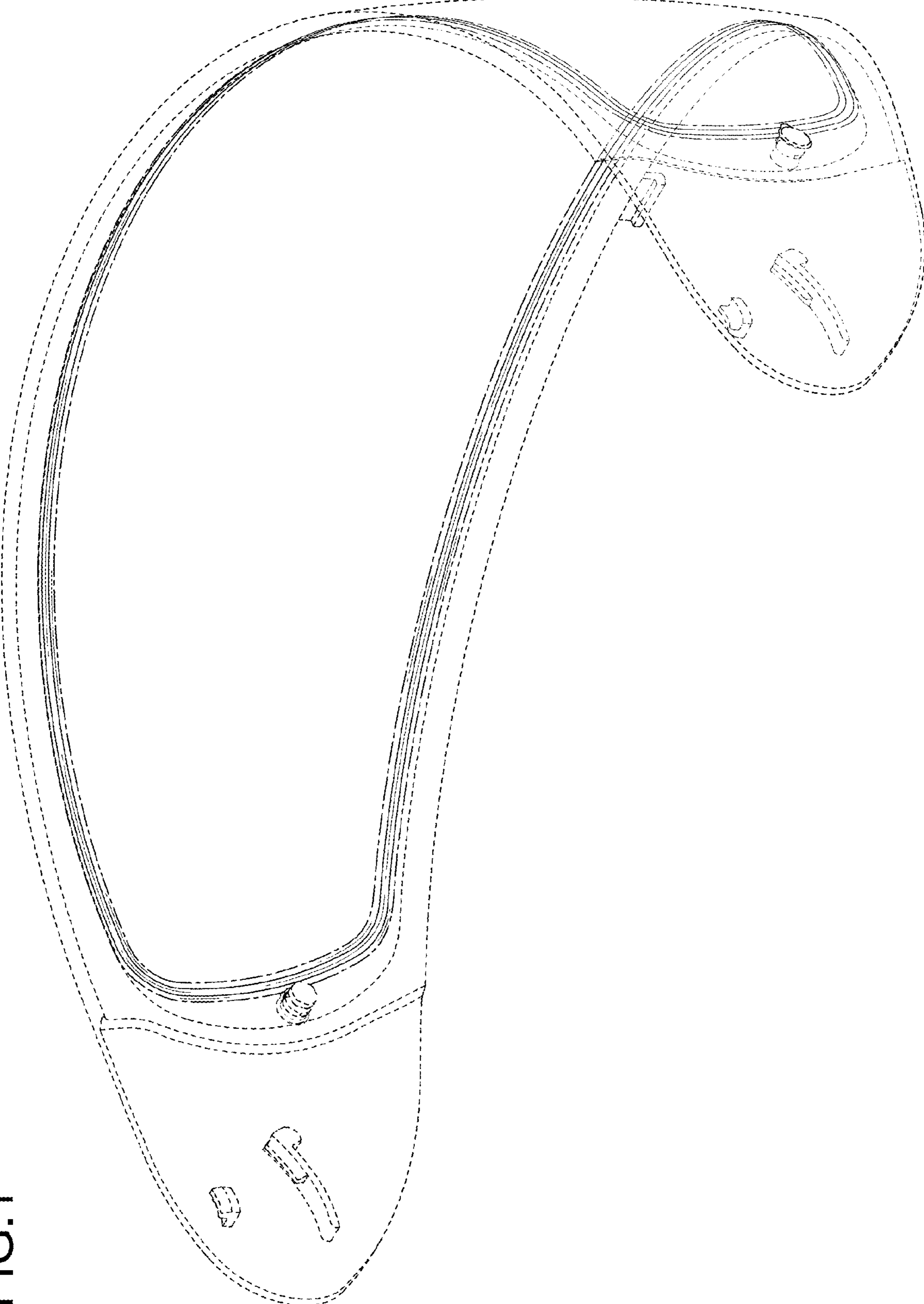
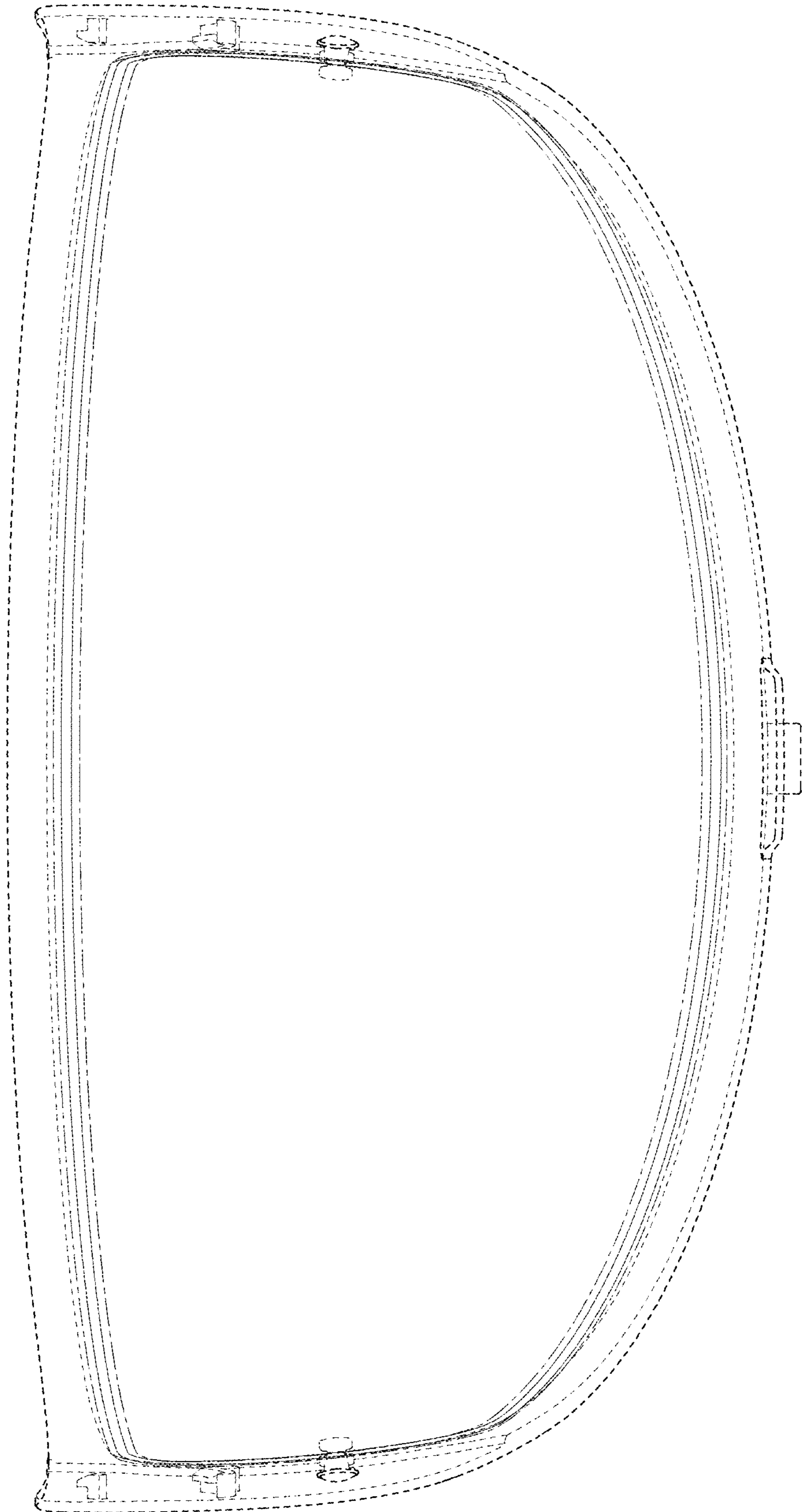

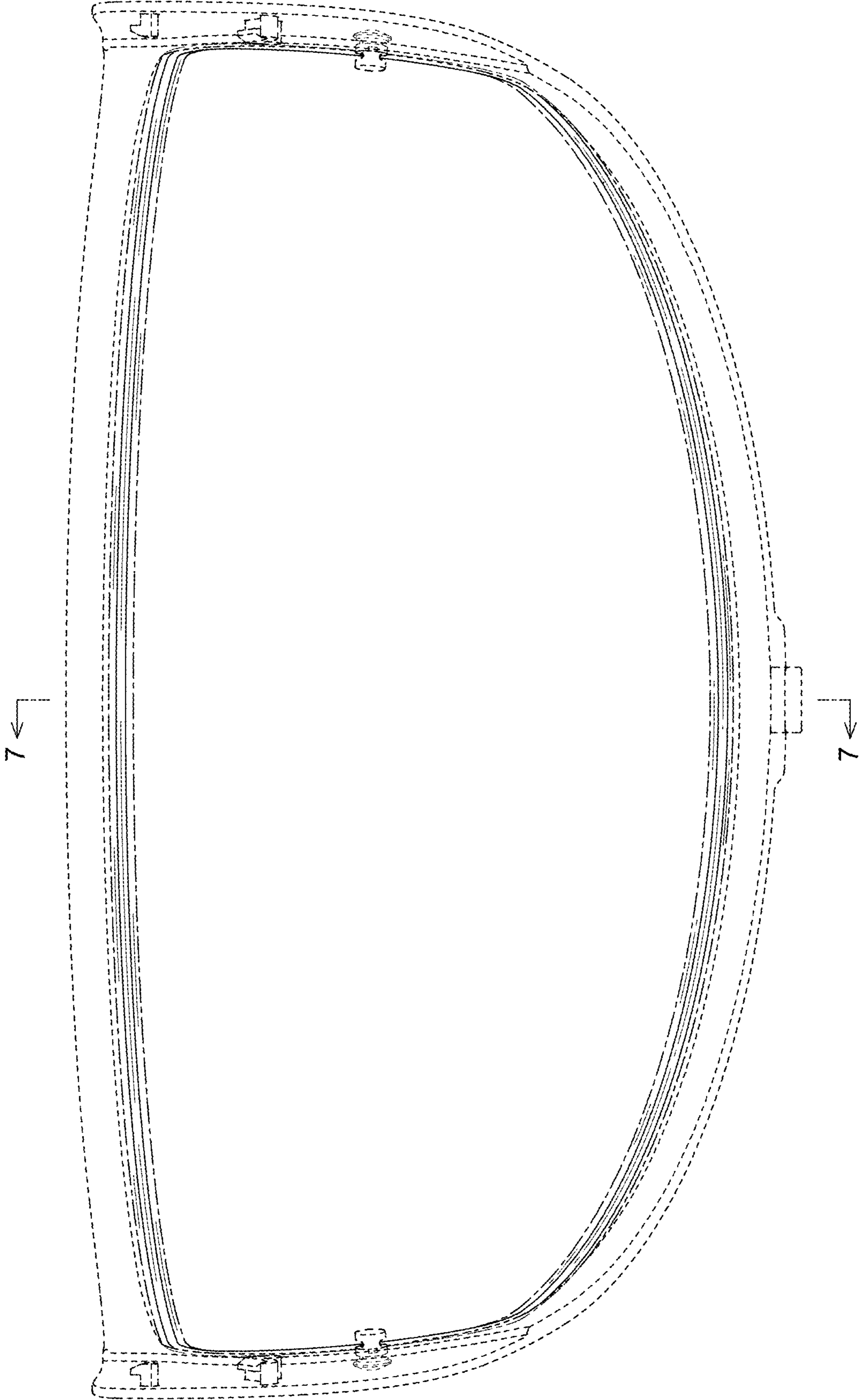

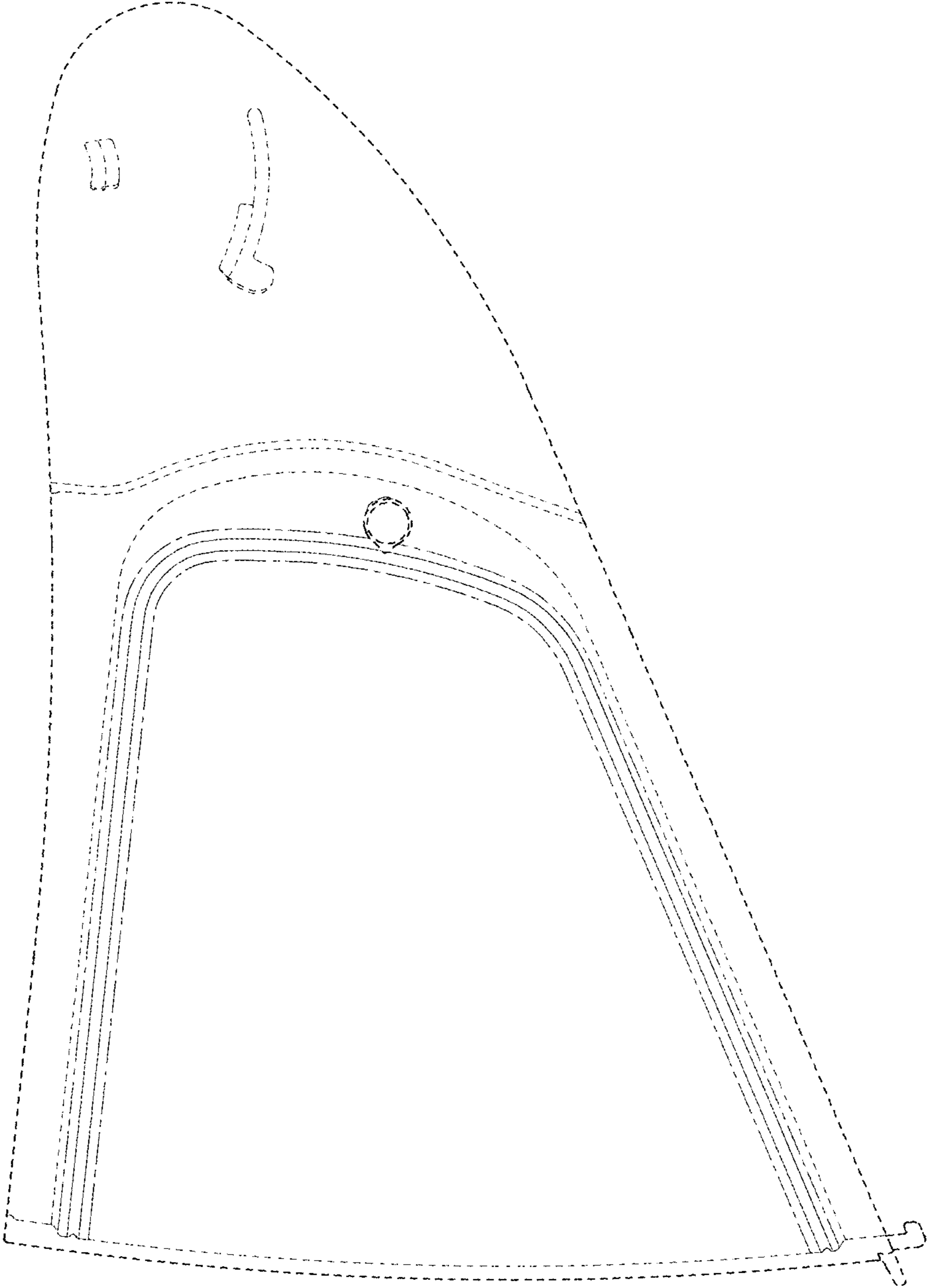

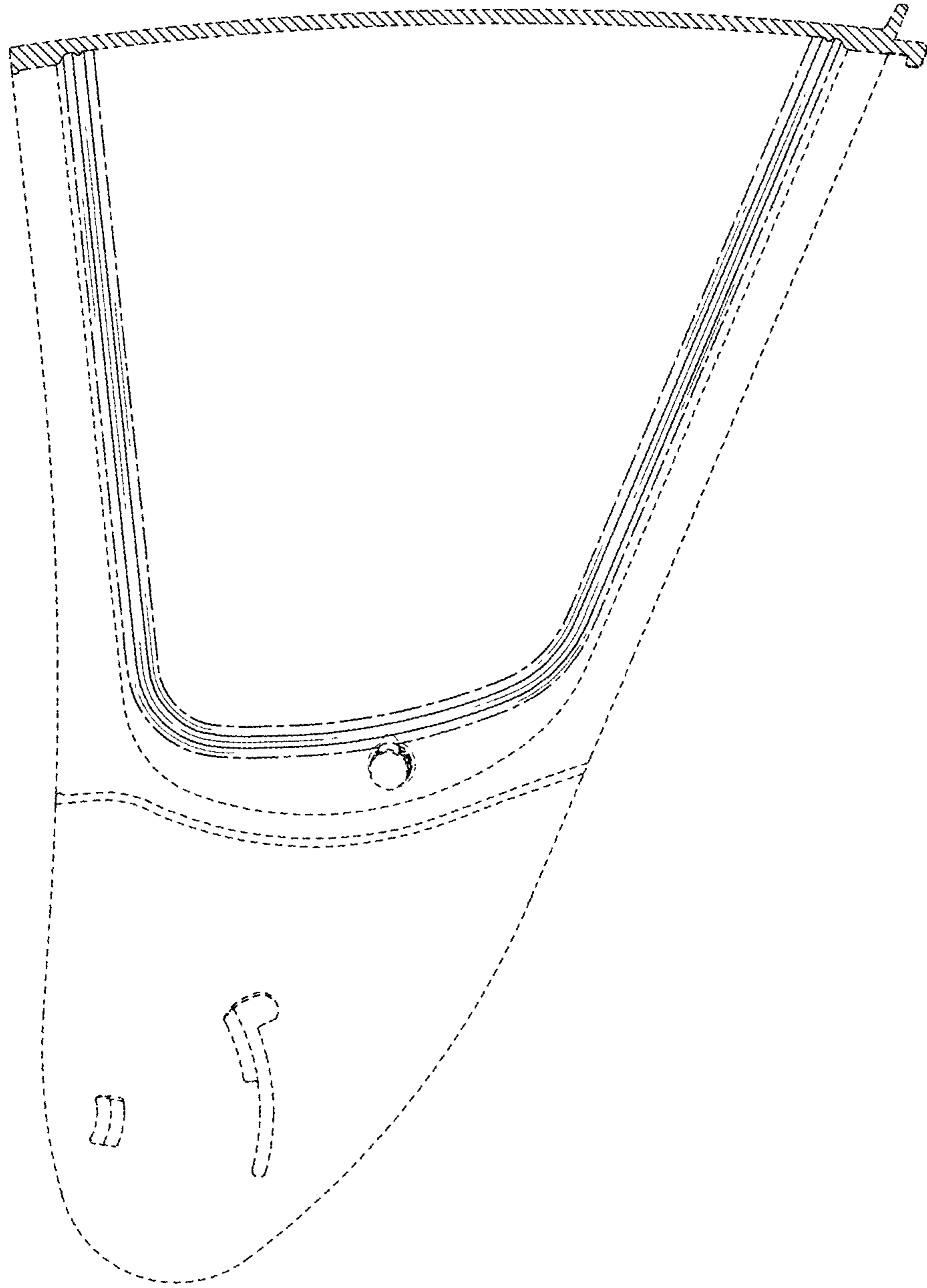
