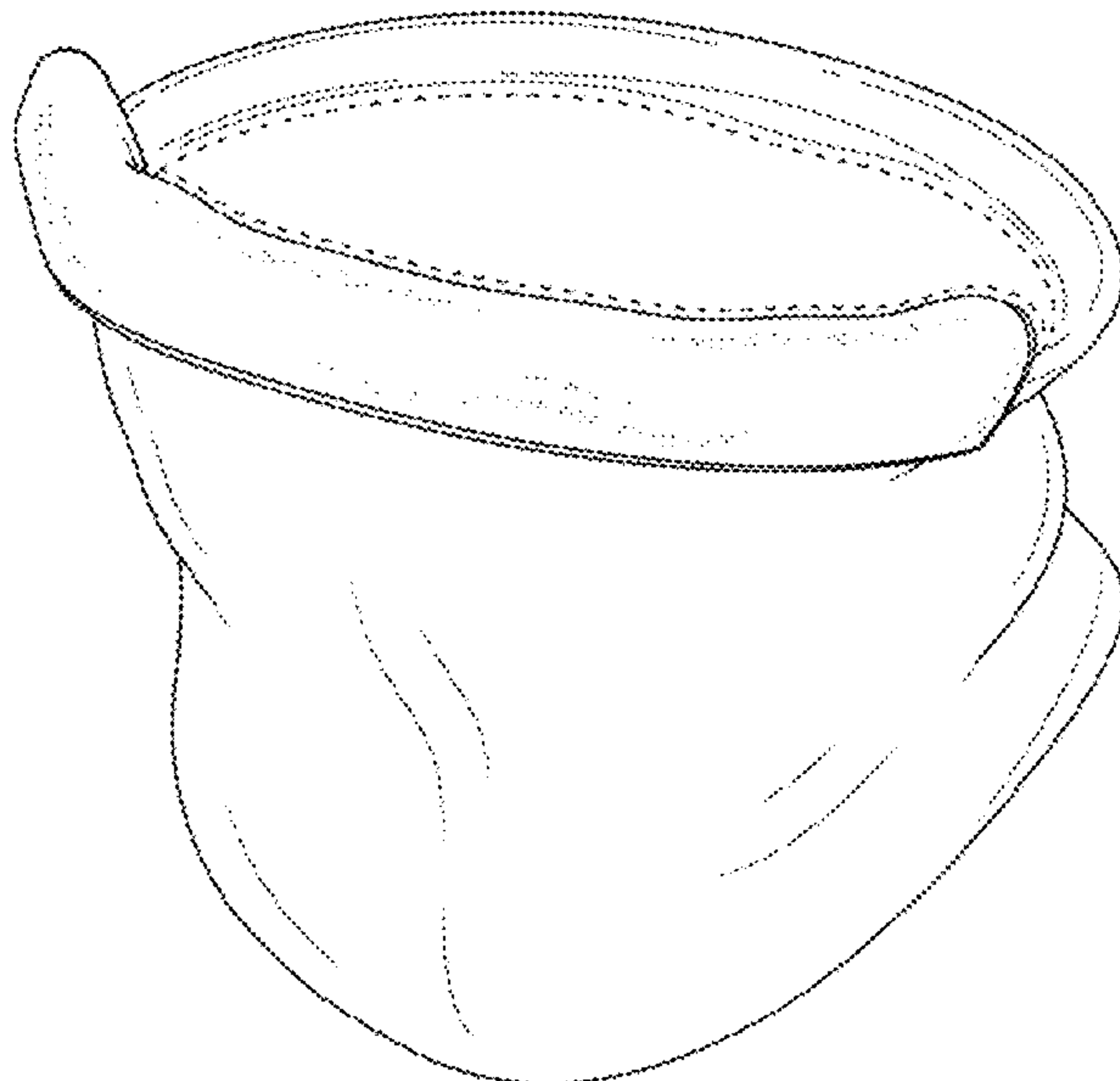
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top front isometric view of a neck gaiter; FIG. 2 is a bottom rear isometric view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a right elevation thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

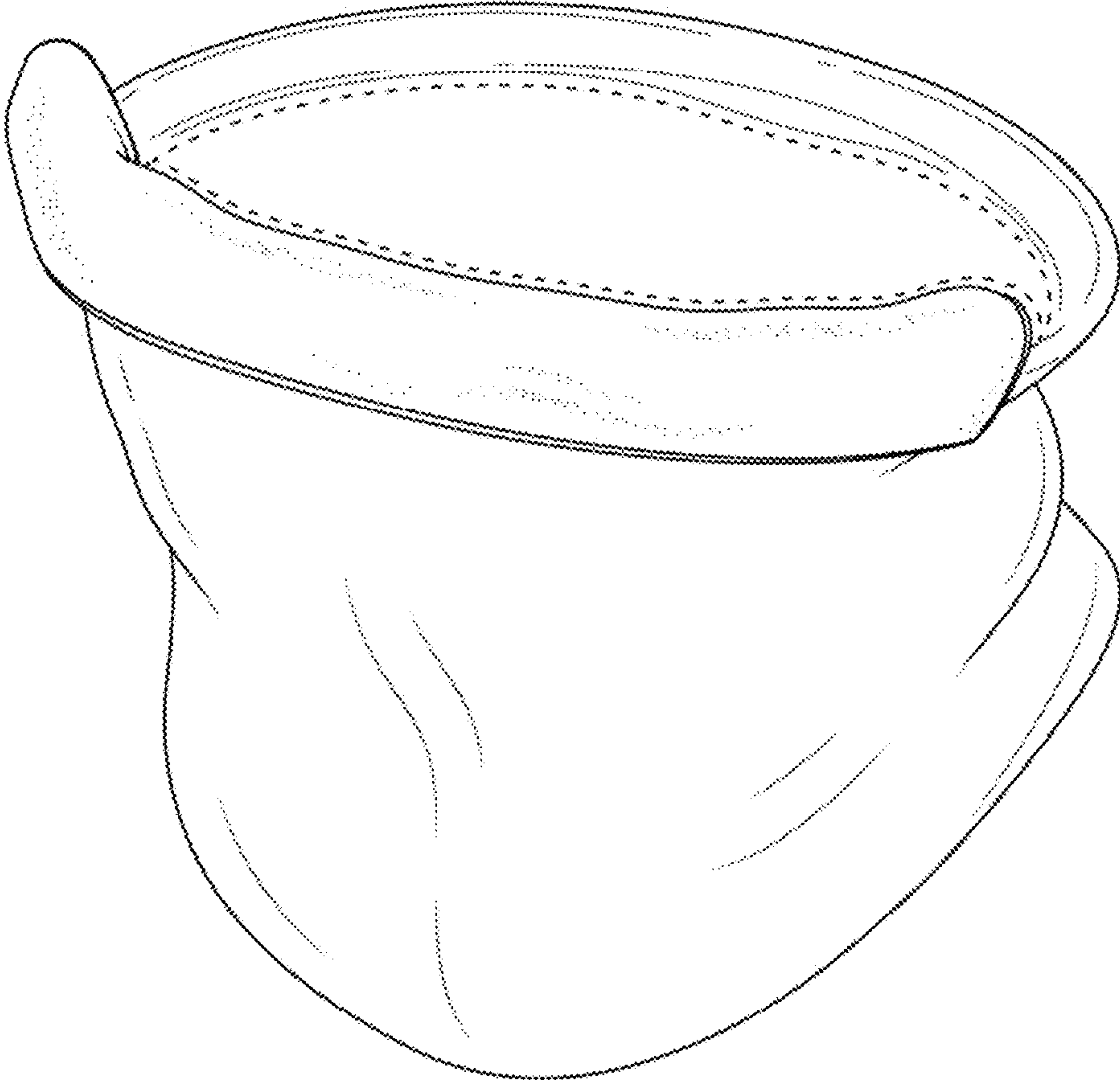

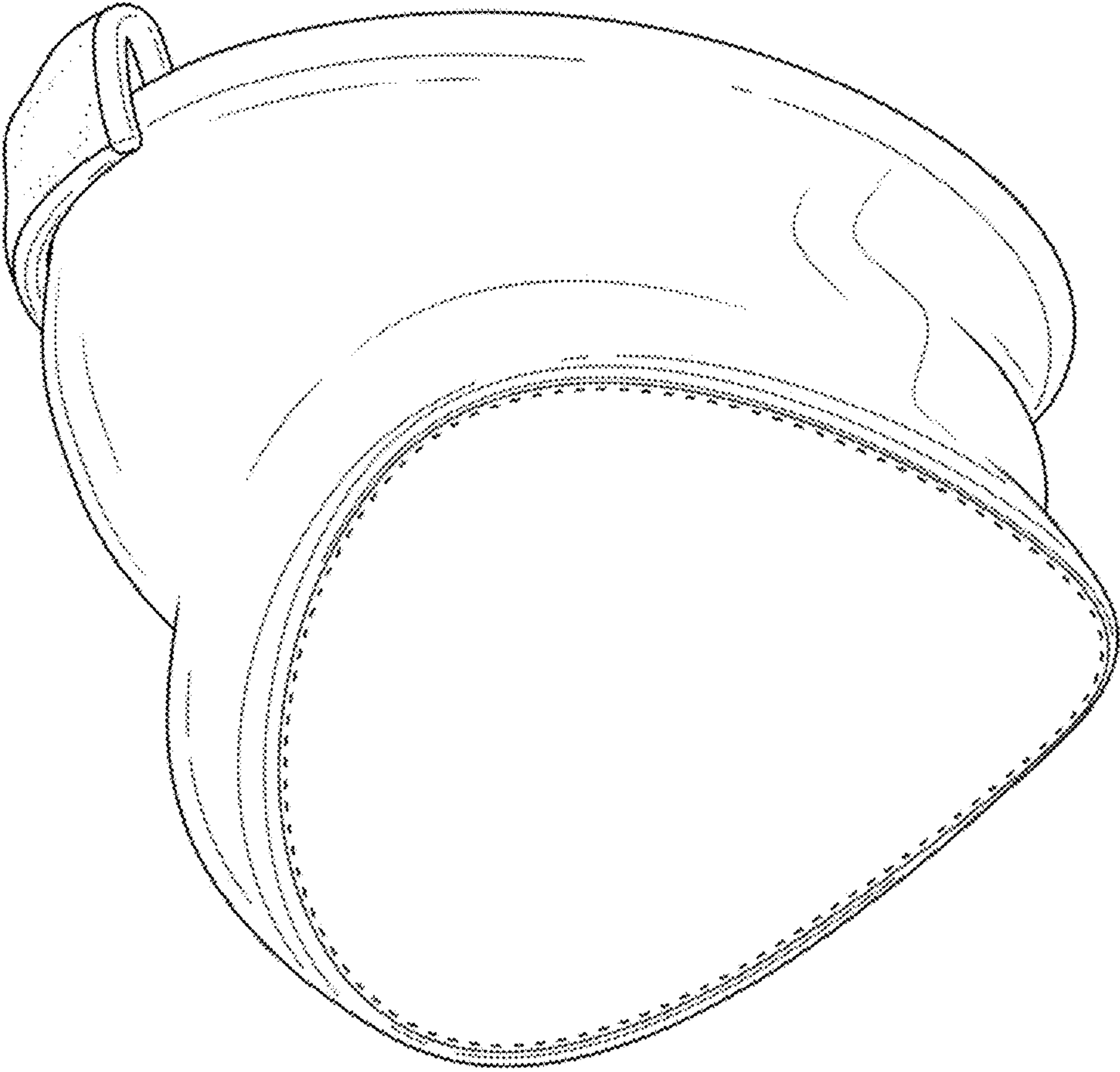

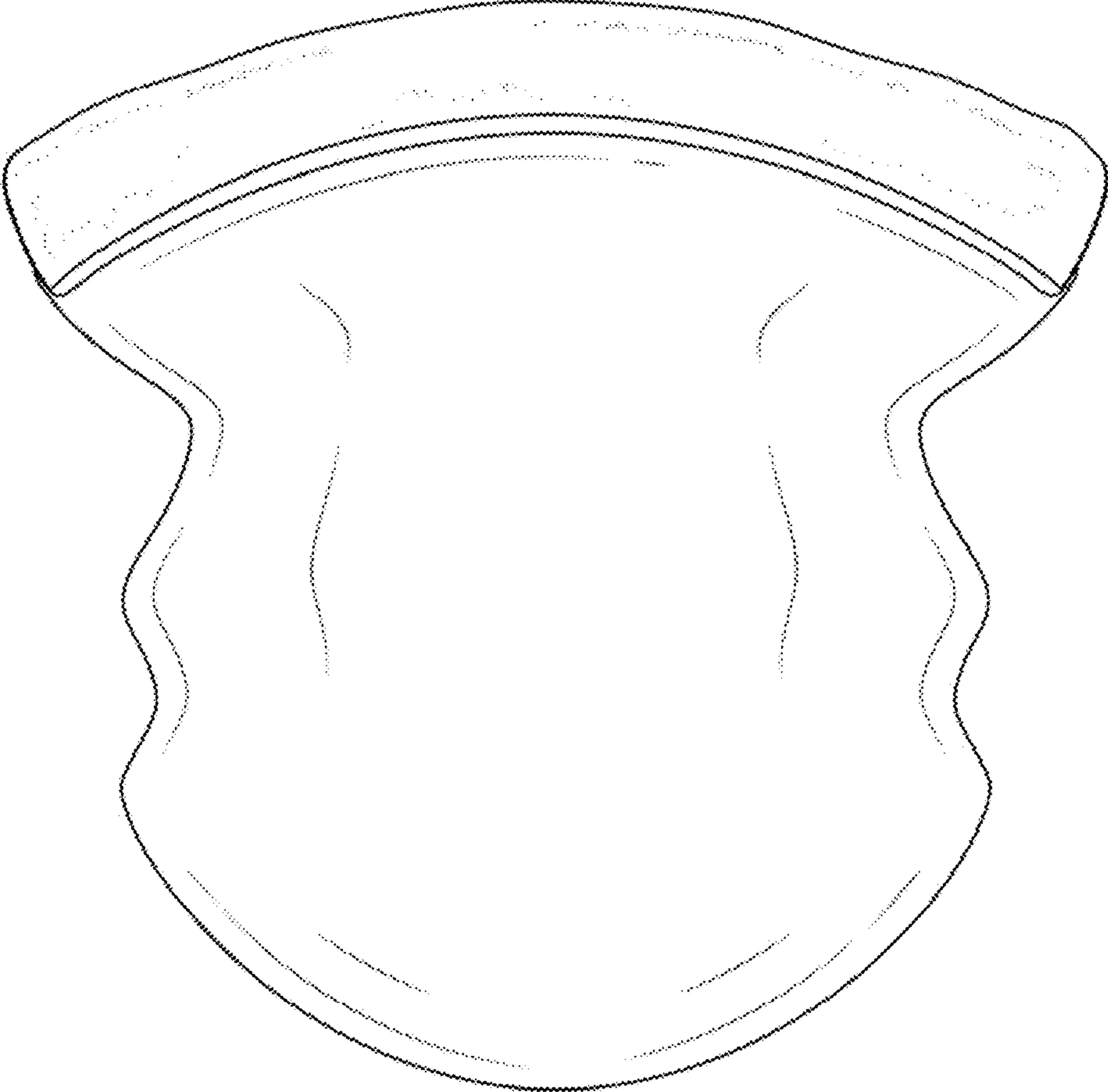

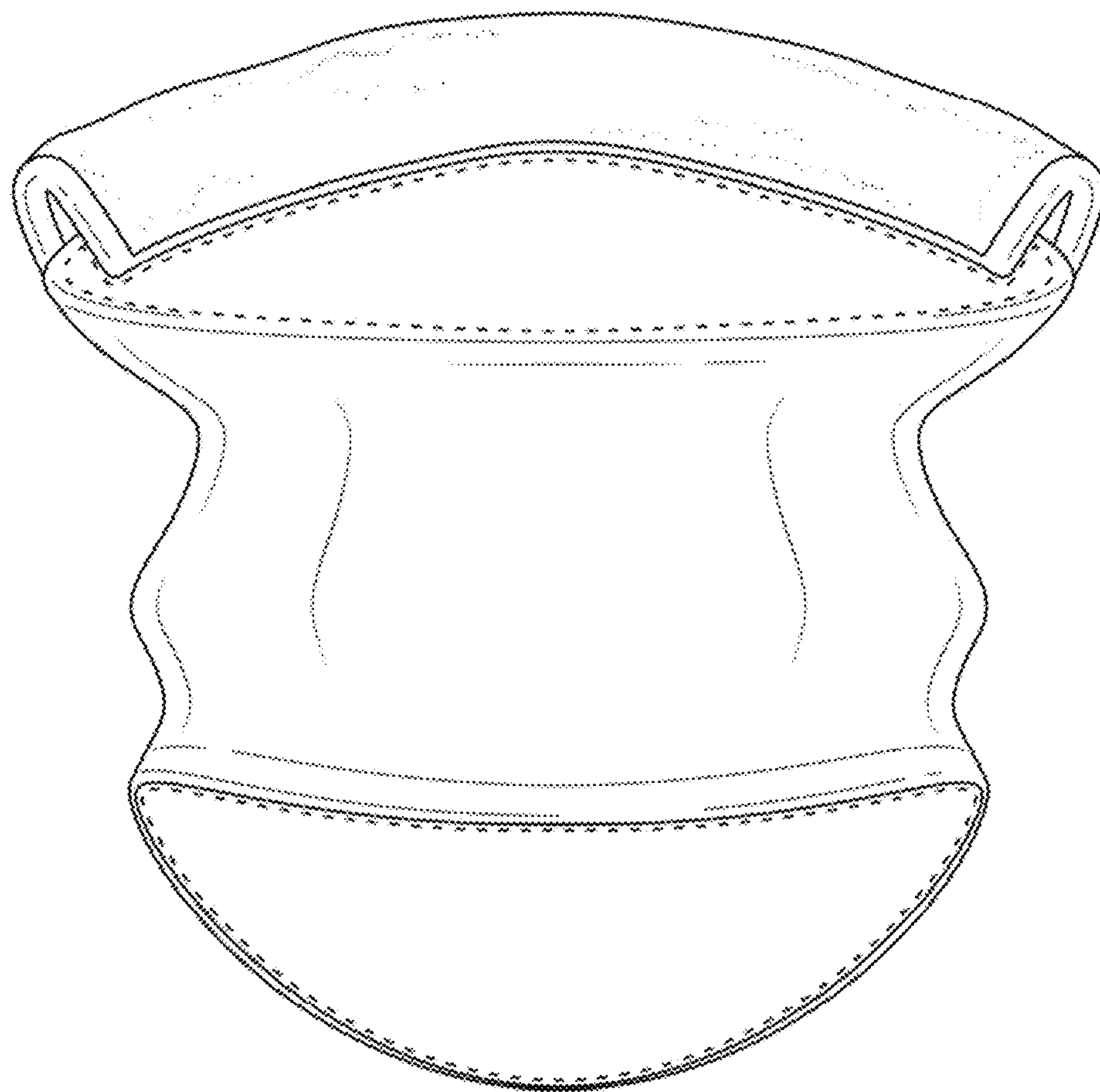

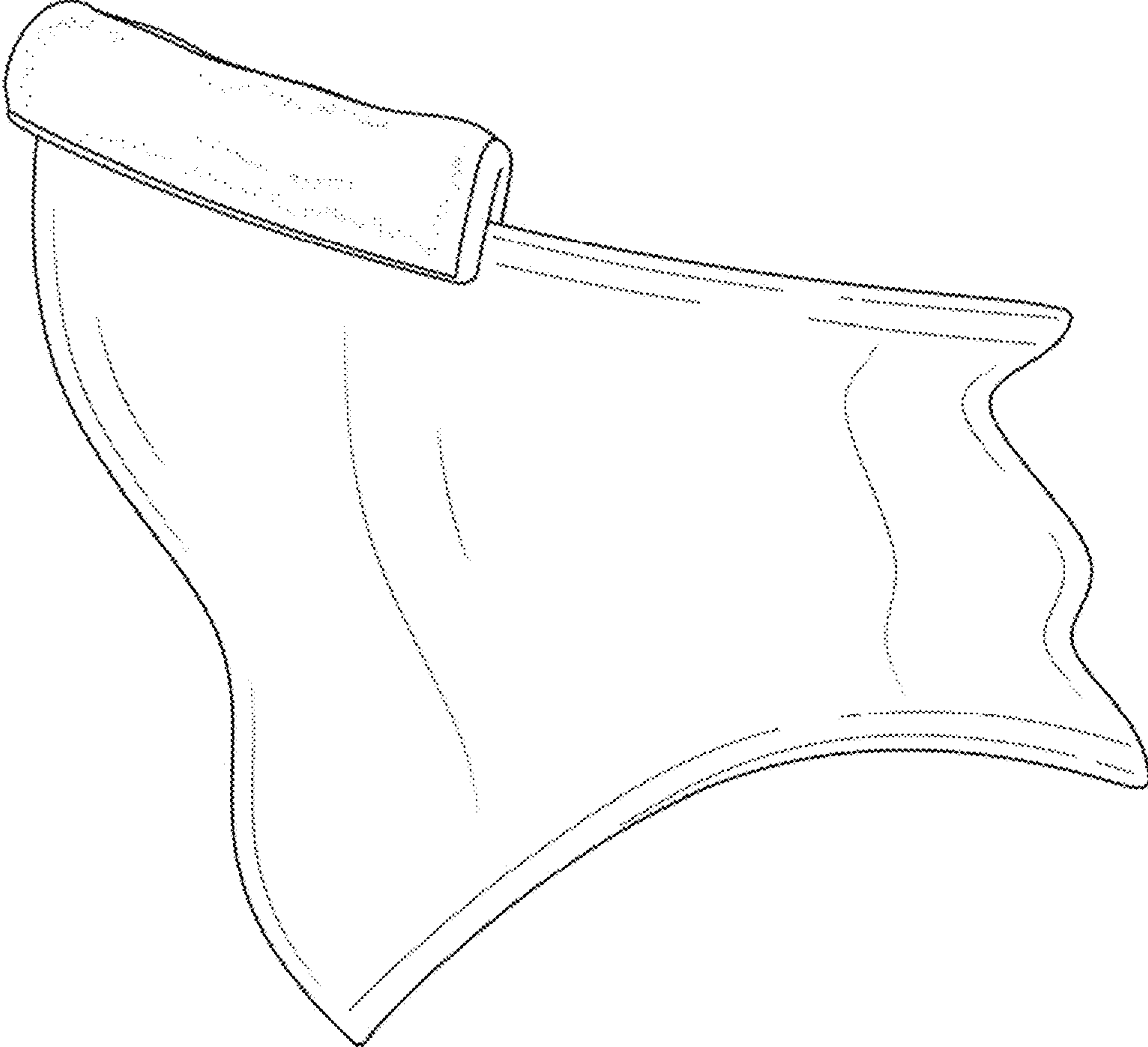

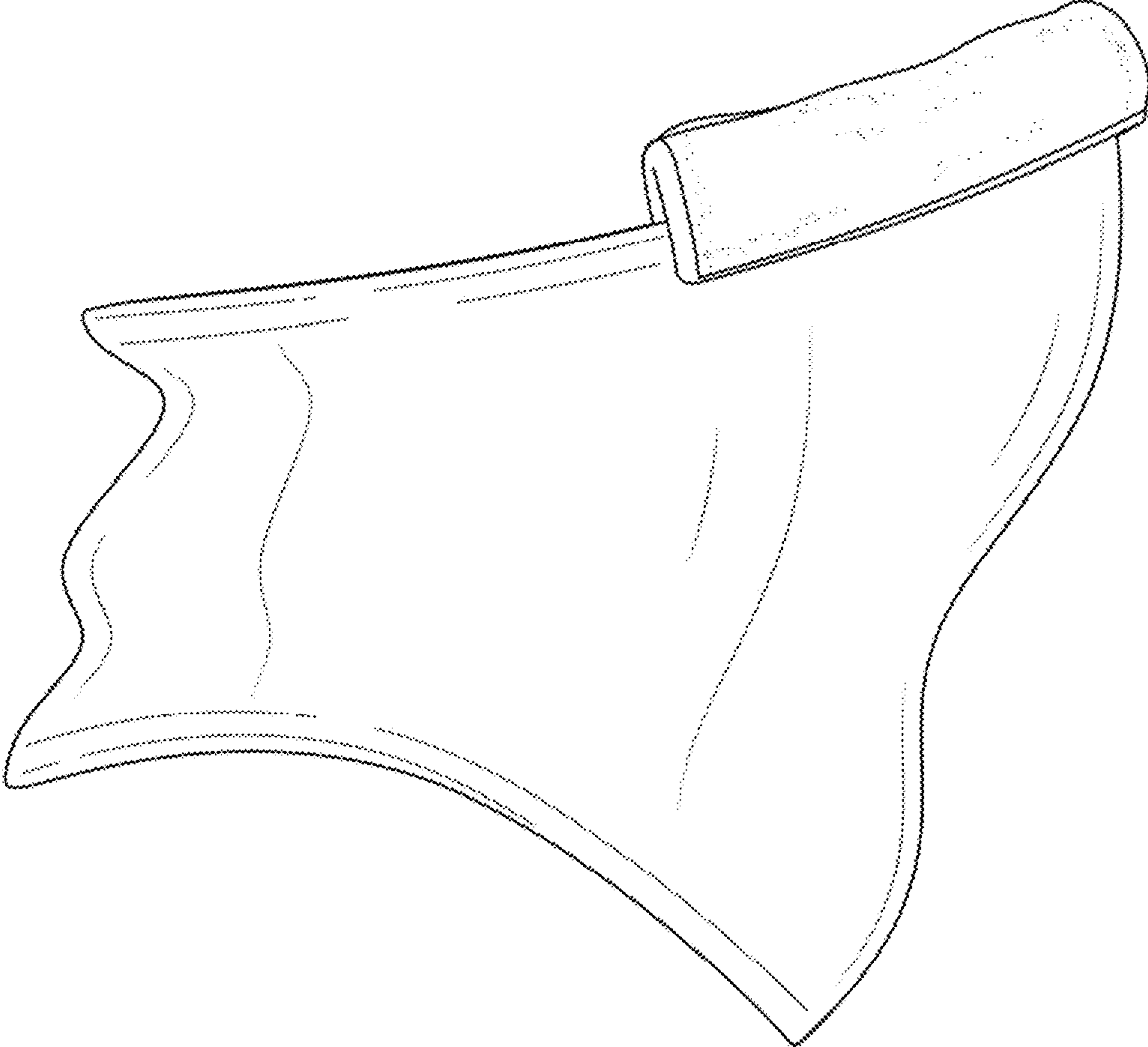

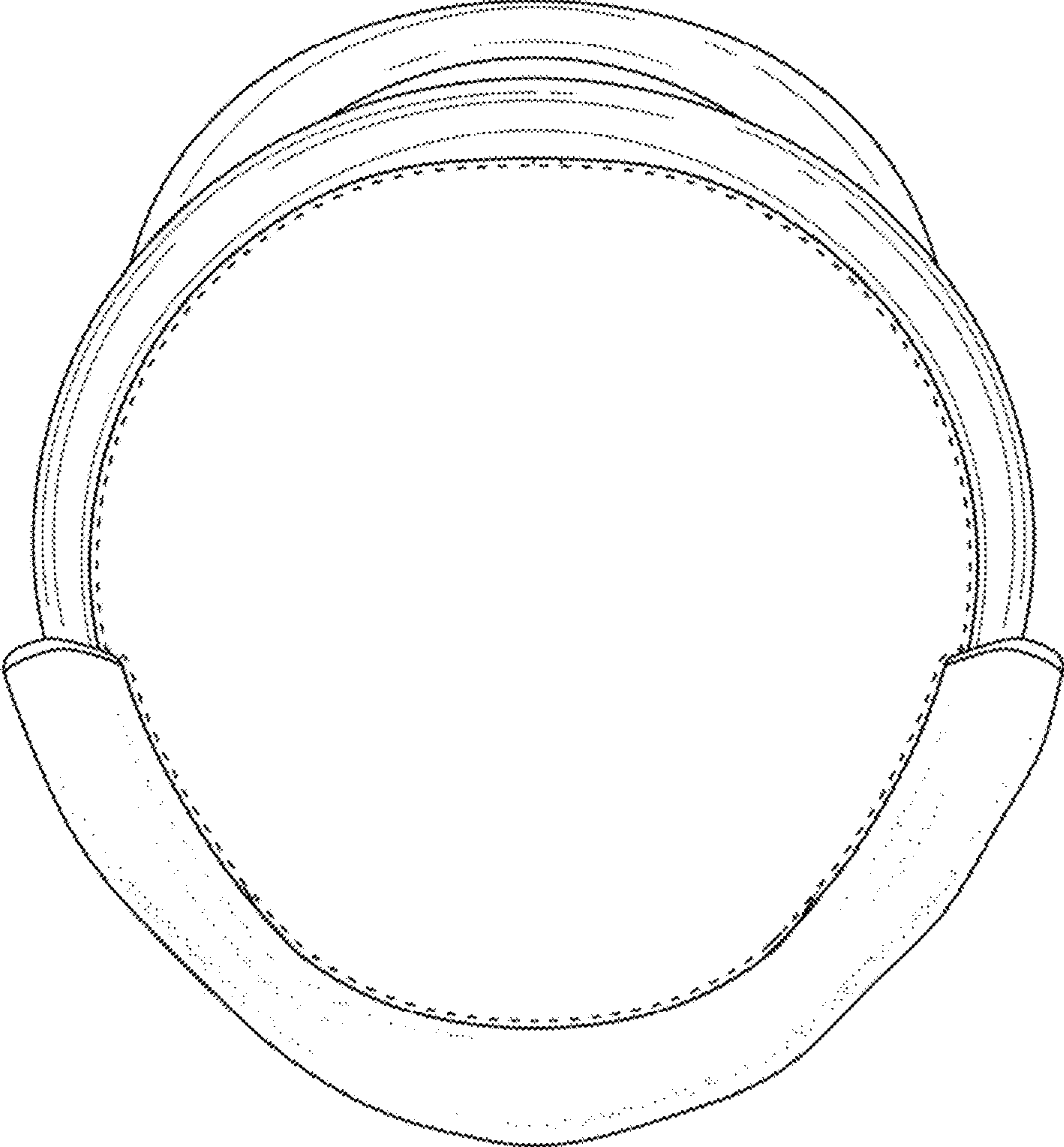

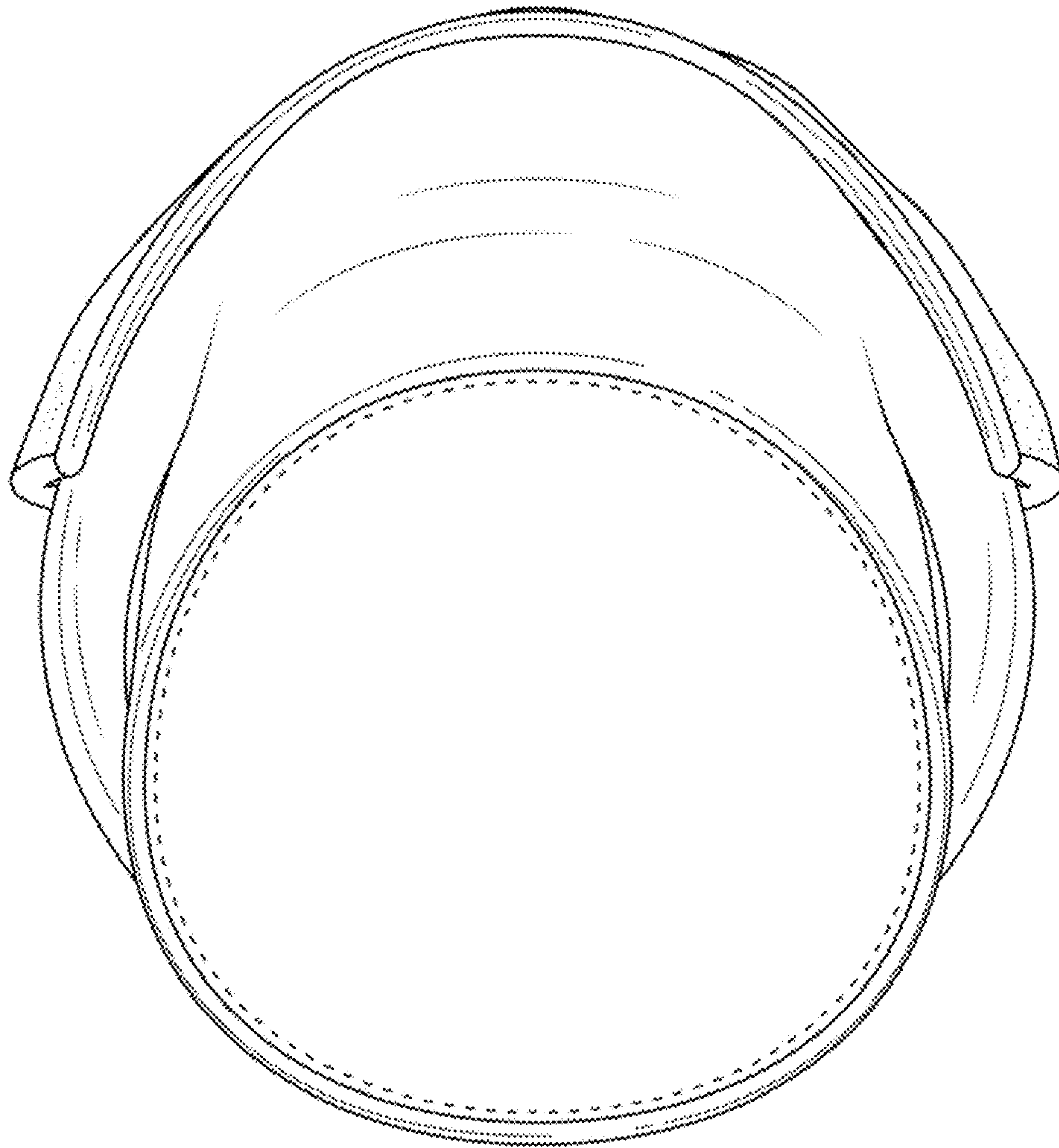
