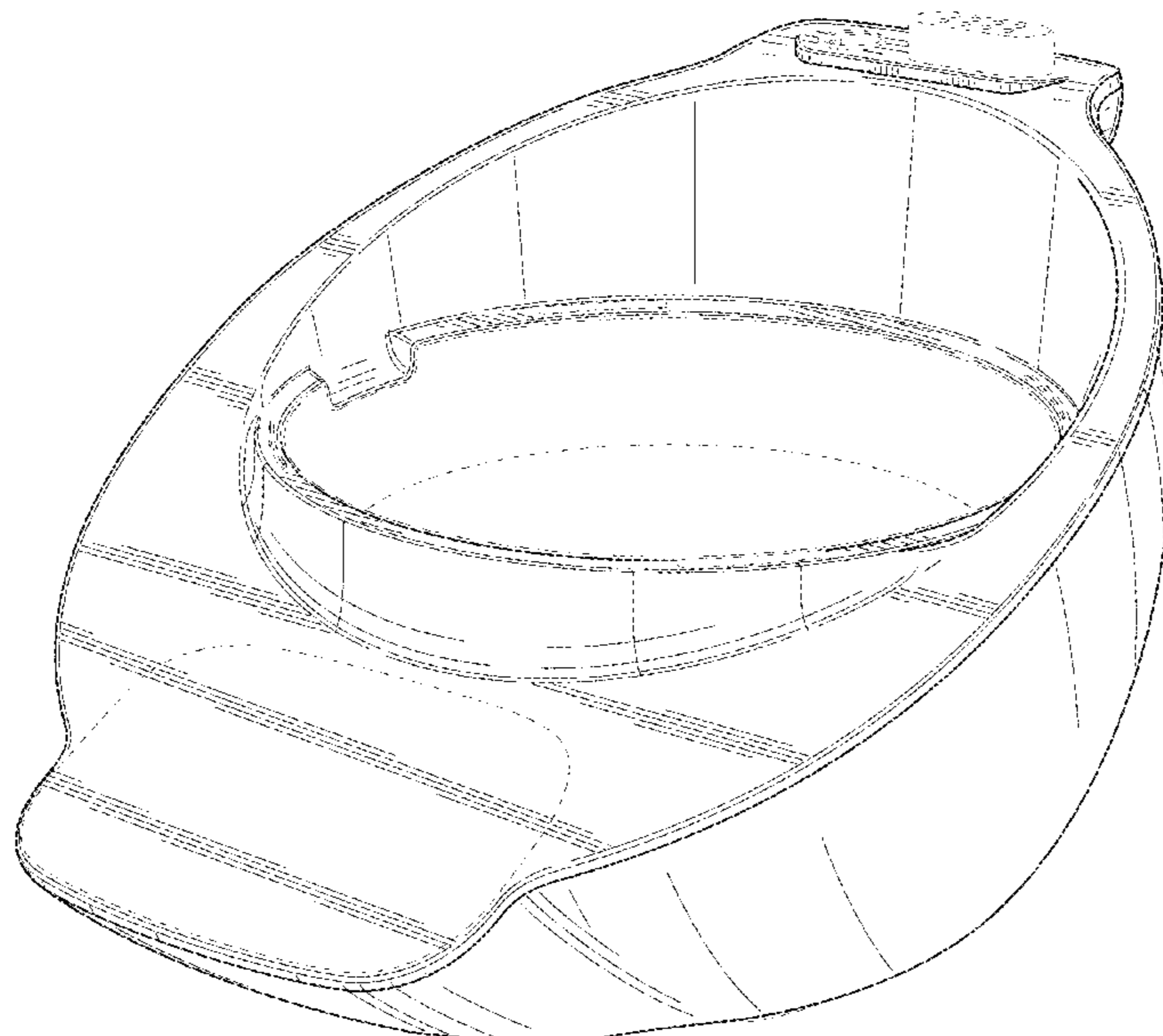

The ornamental design for a base for electric cooker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a base for electric cooker showing our new design;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a back elevational view thereof;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The even dash lines appearing in the figure drawings depict portions of the base for electric cooker that form no part of the claimed design.
The dot dash line appearing in the figure drawings is for the purpose of illustrating the bounds of the claim and forms no part thereof.

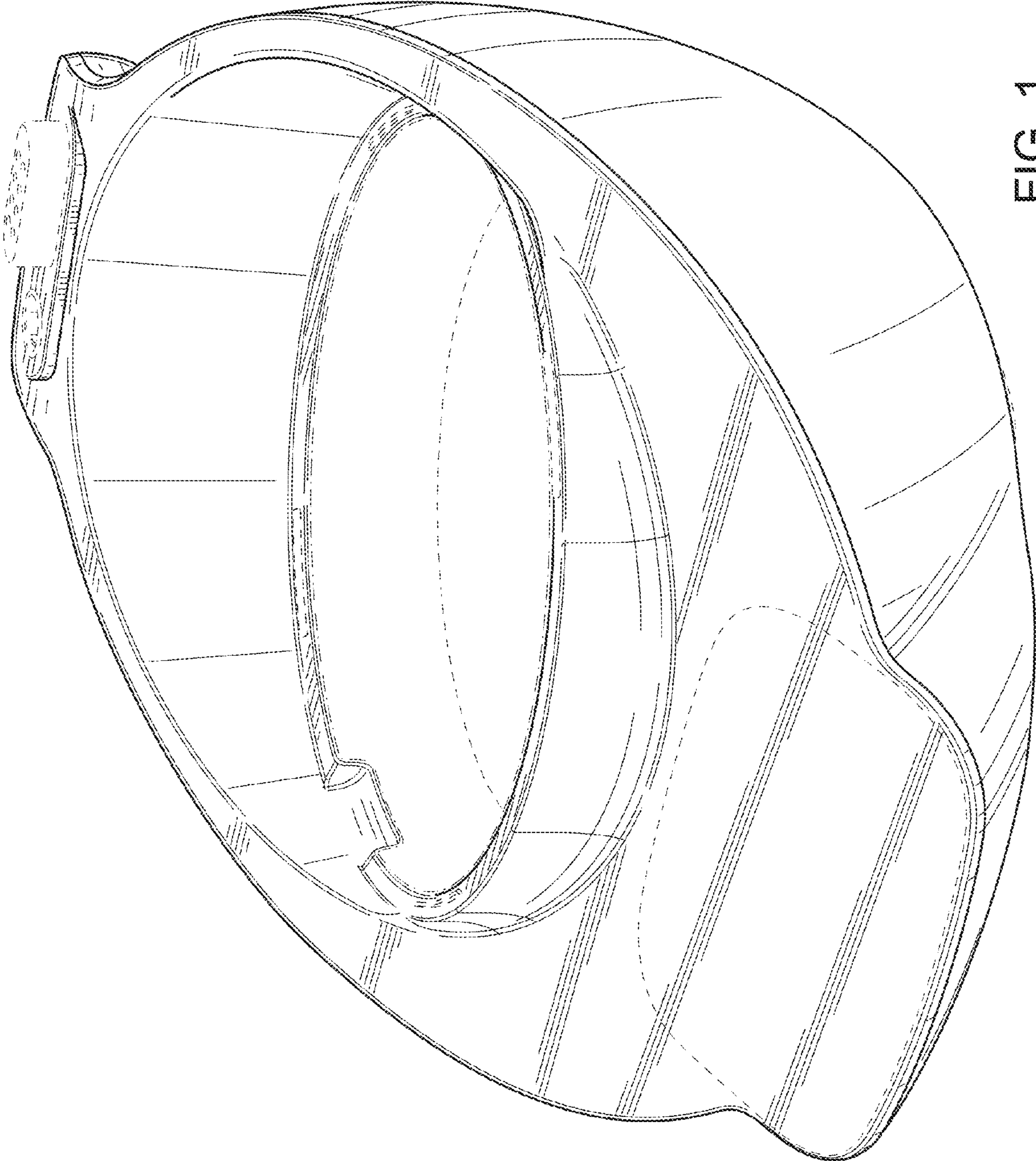

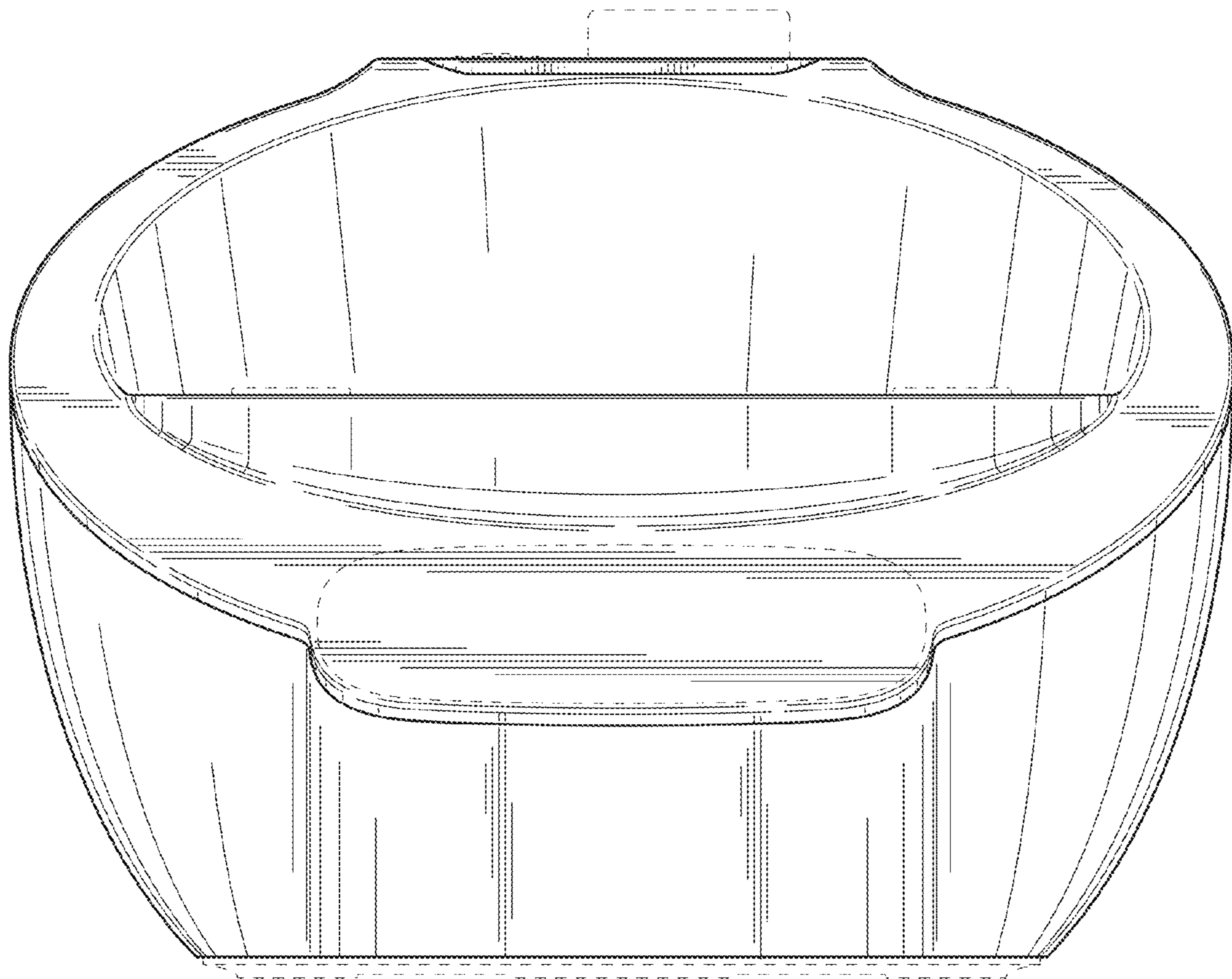

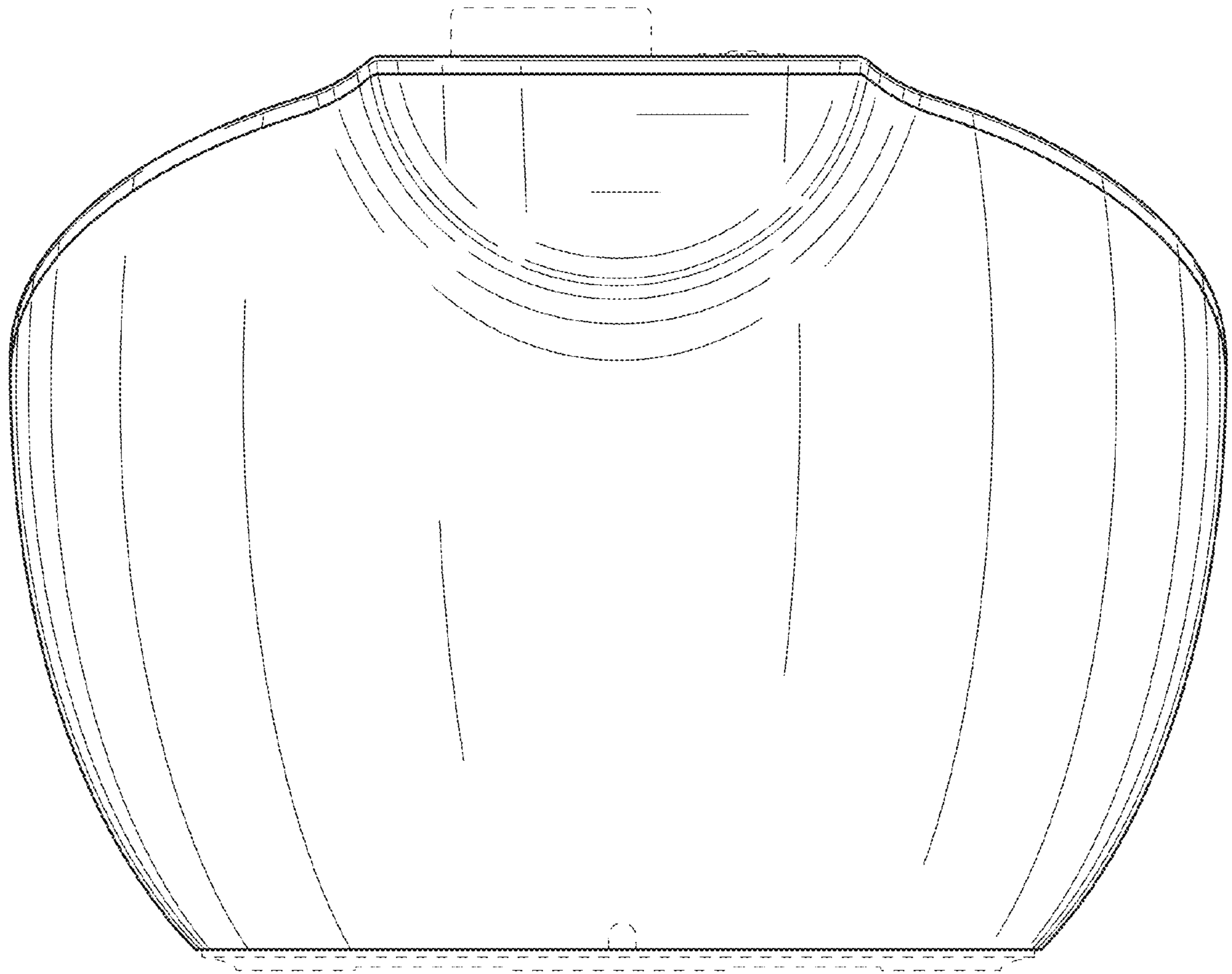

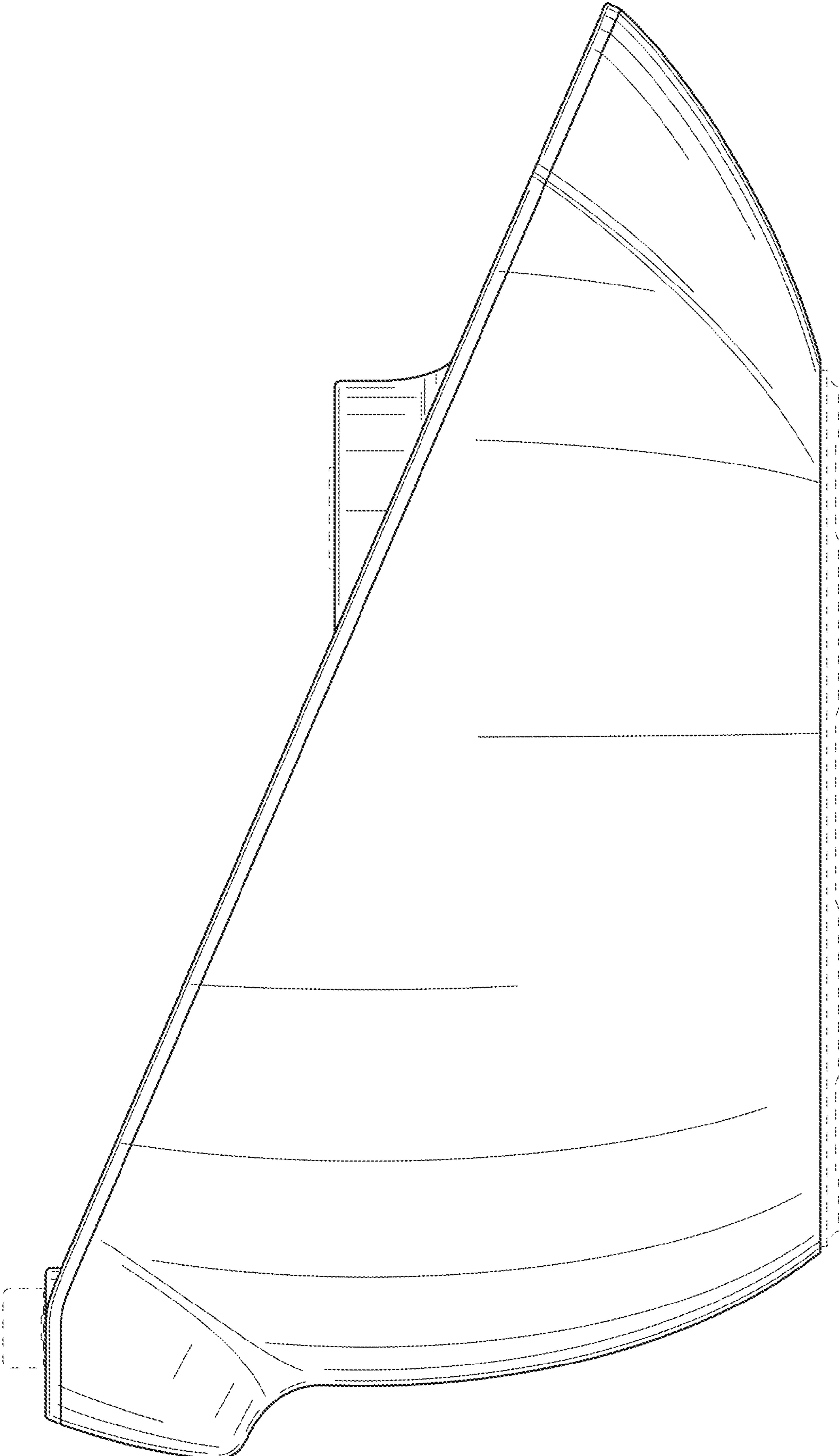

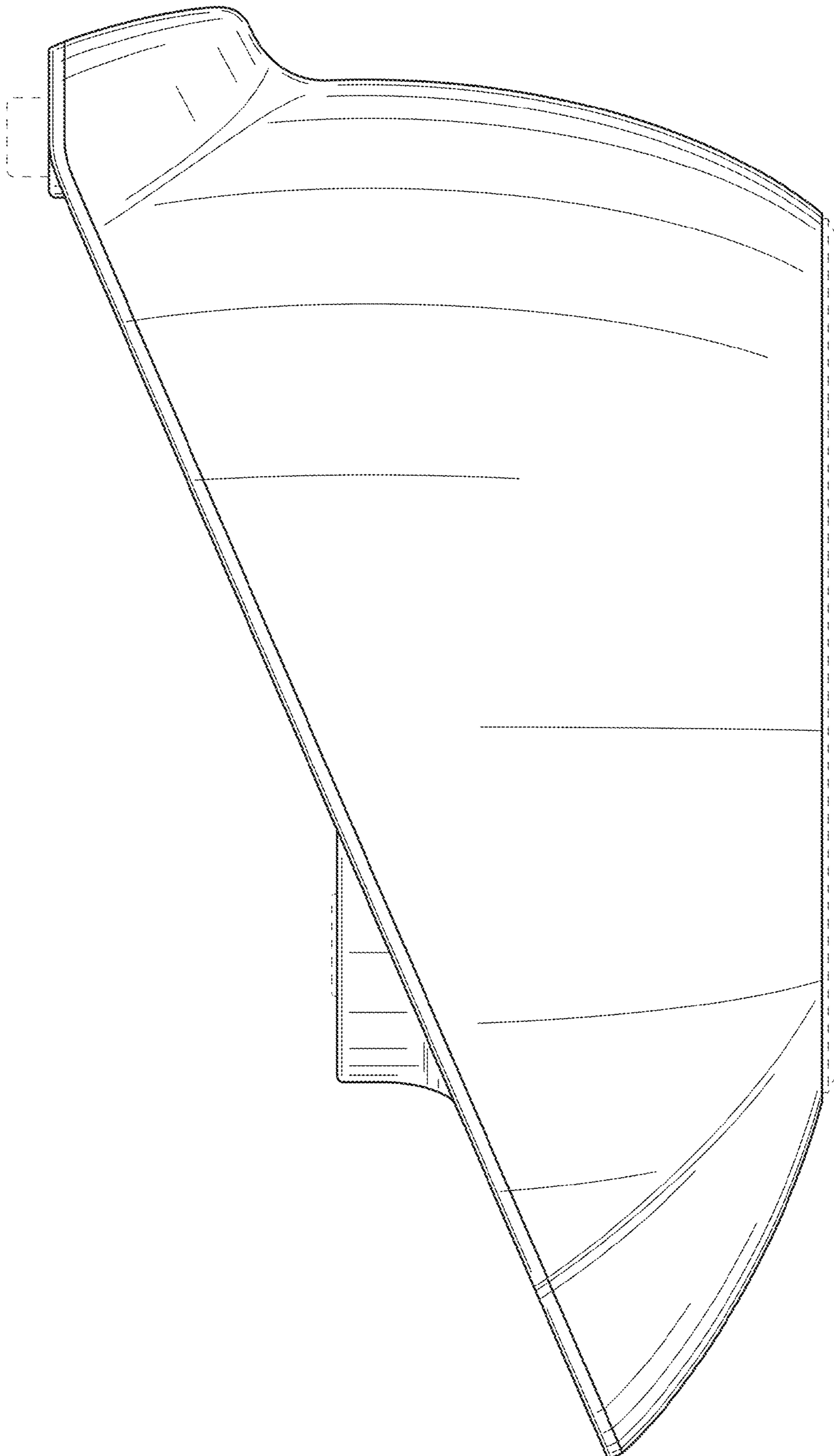

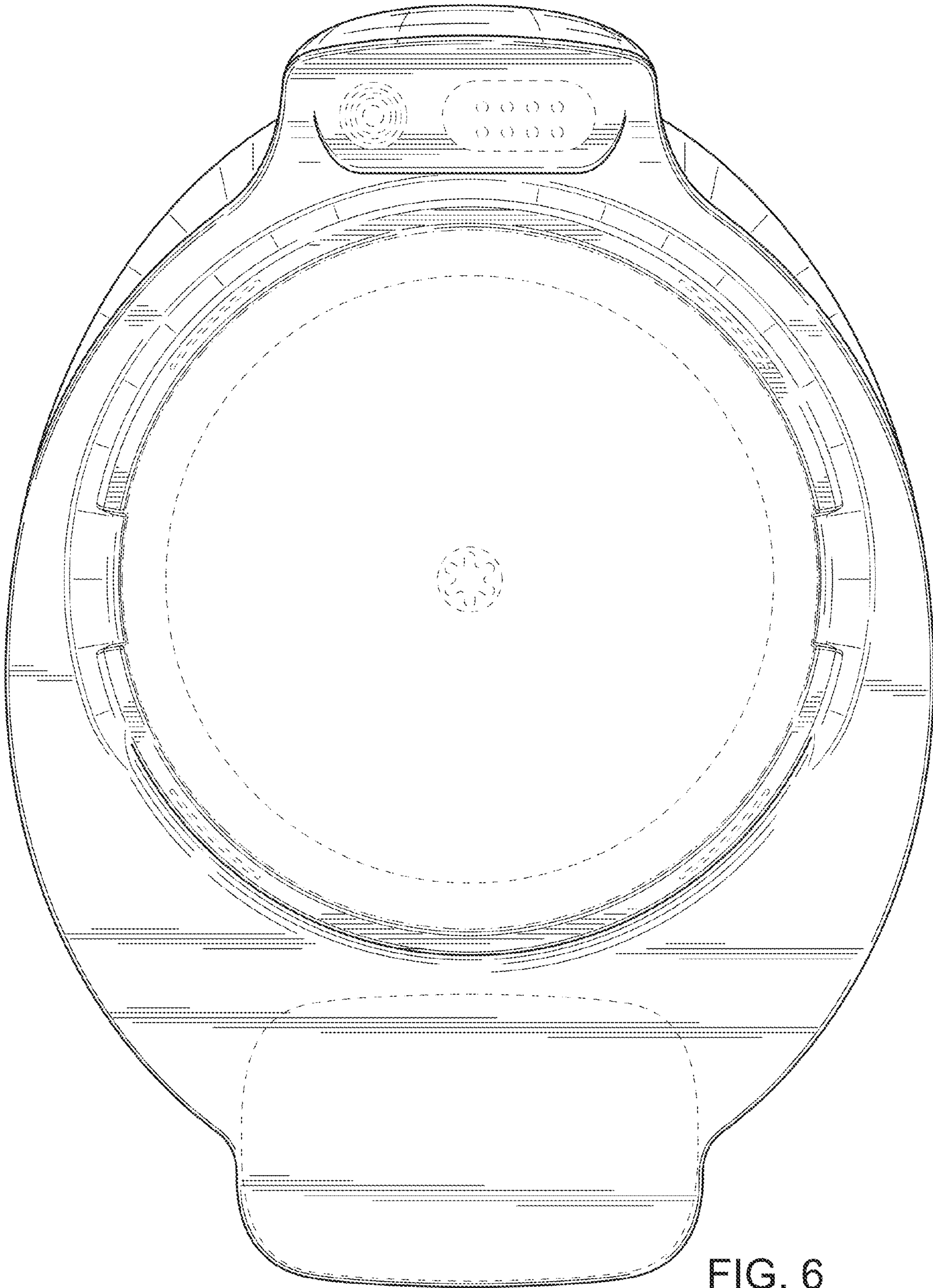

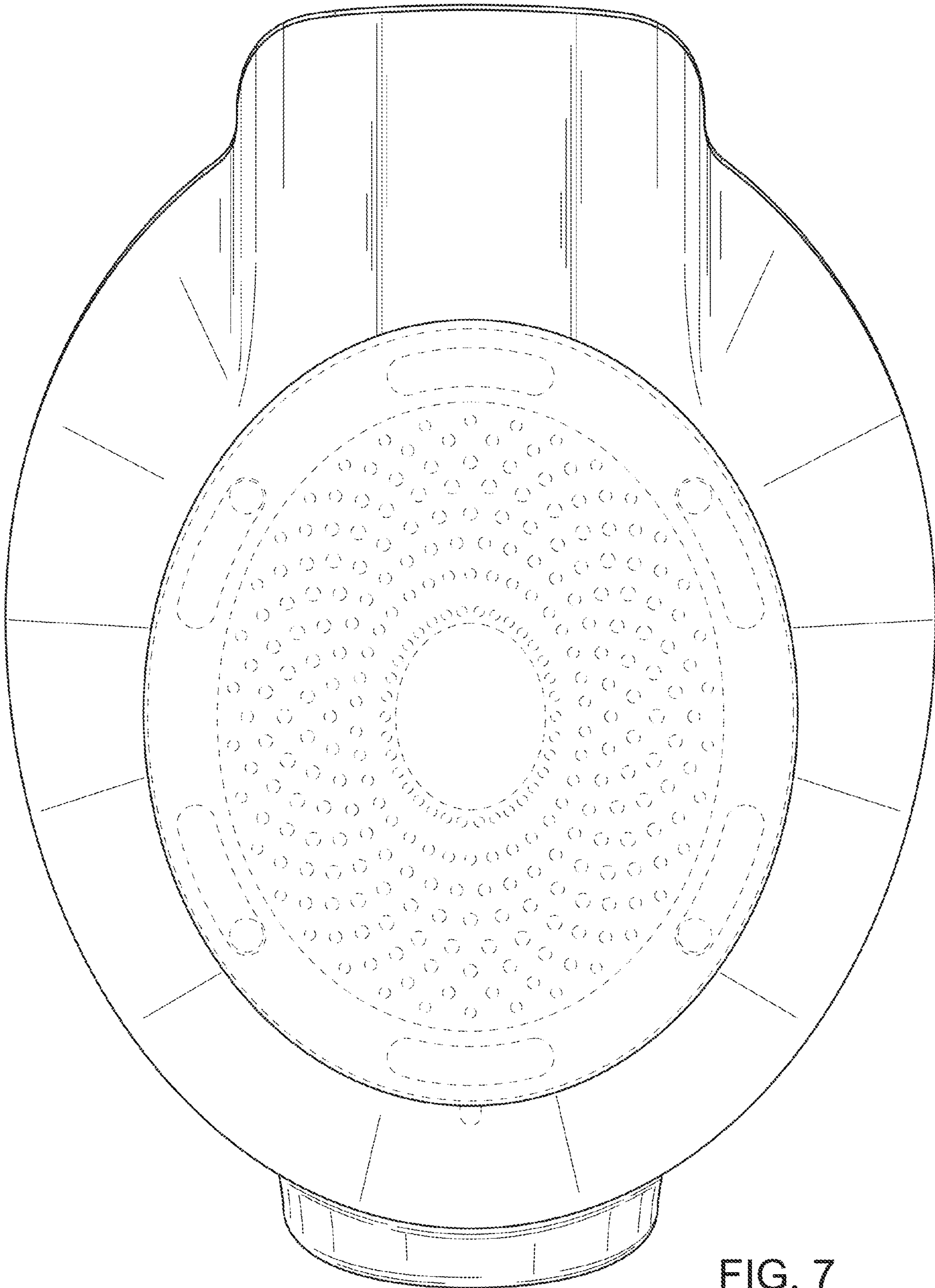
