(57) **CLAIM**

The ornamental design for a cover for a mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left-side, and top perspective view of a cover for a mobile phone showing our new design.

FIG. 2 is a back, right-side, and bottom perspective view of the cover for a mobile phone of FIG. 1.

FIG. 5 is a right-side view of the cover for a mobile phone of FIG. 1.

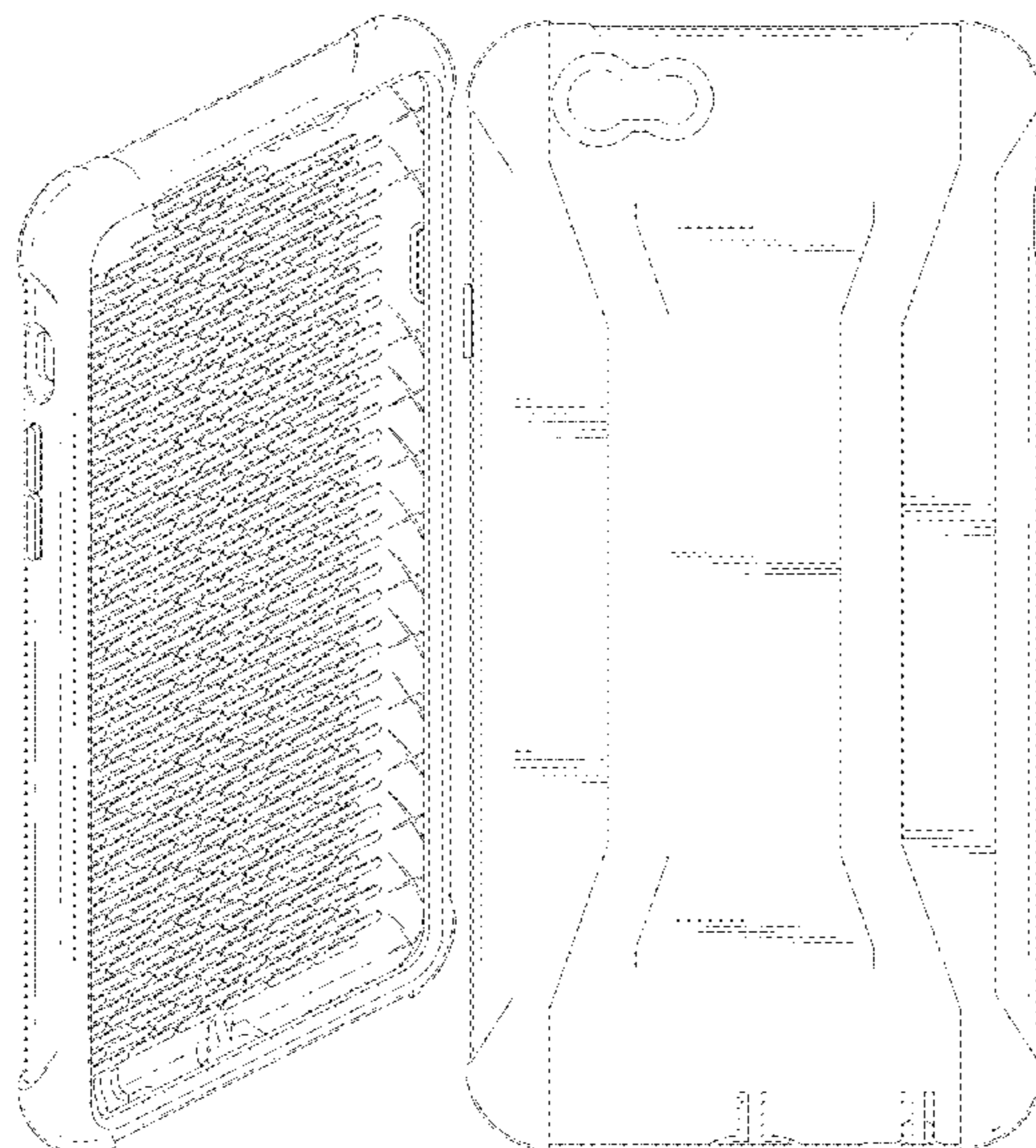
FIG. 6 is a left-side view of the cover for a mobile phone of FIG. 1.

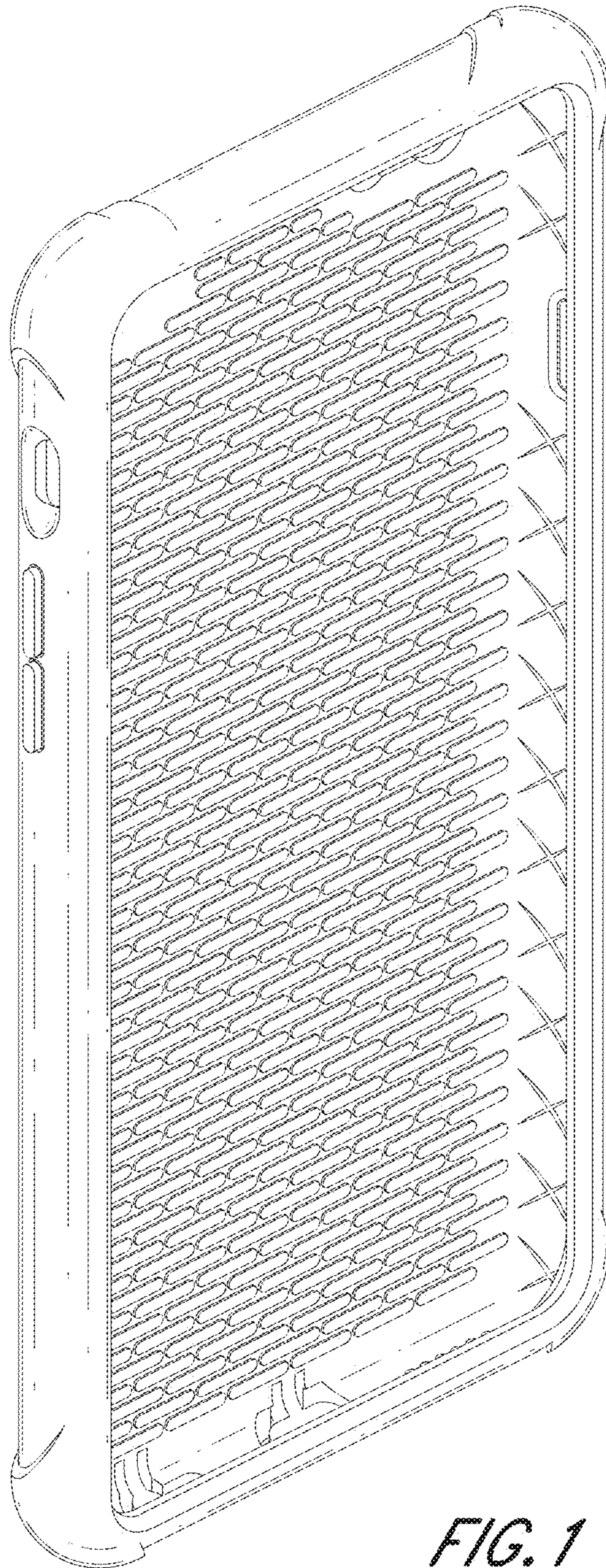

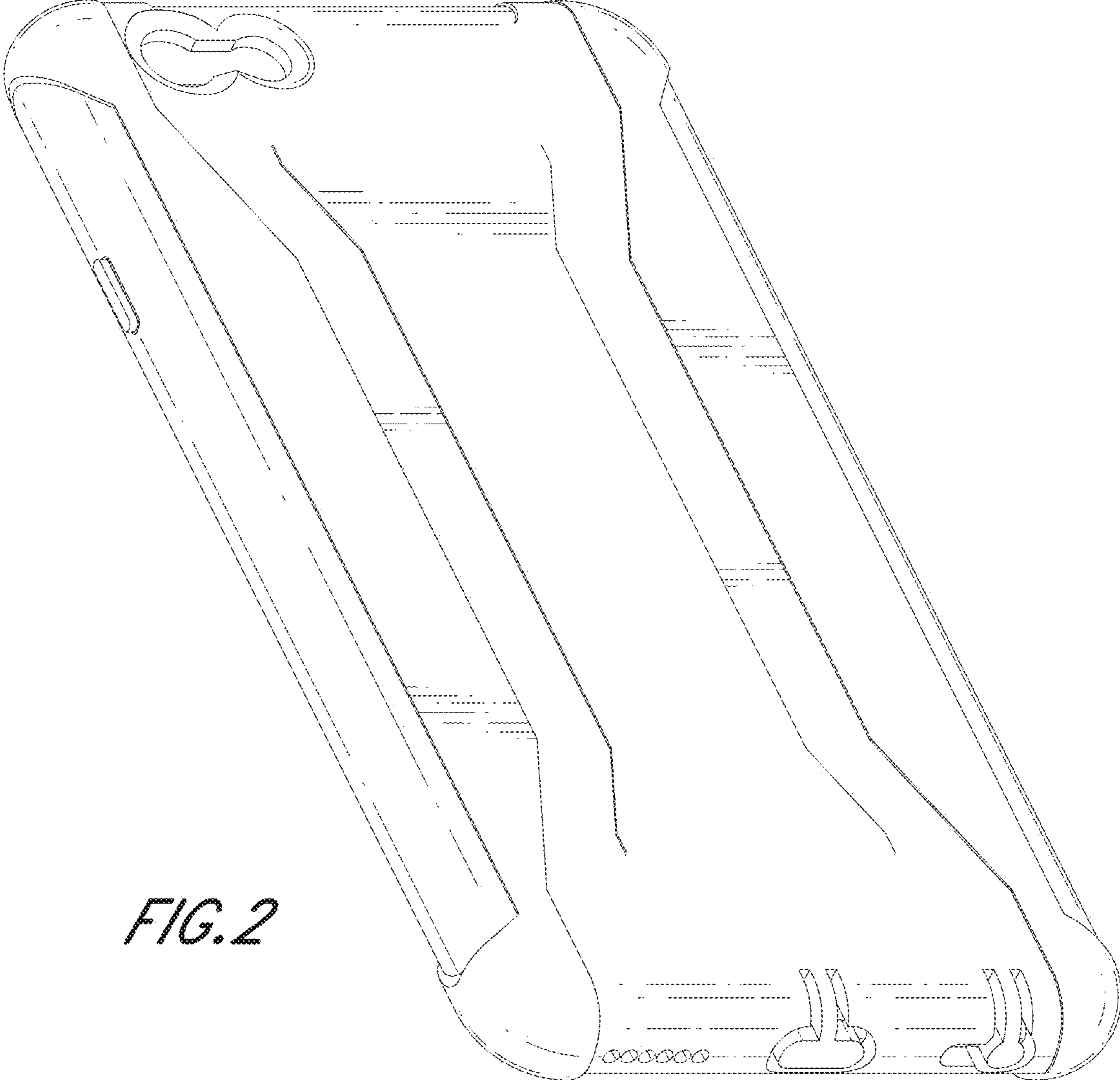

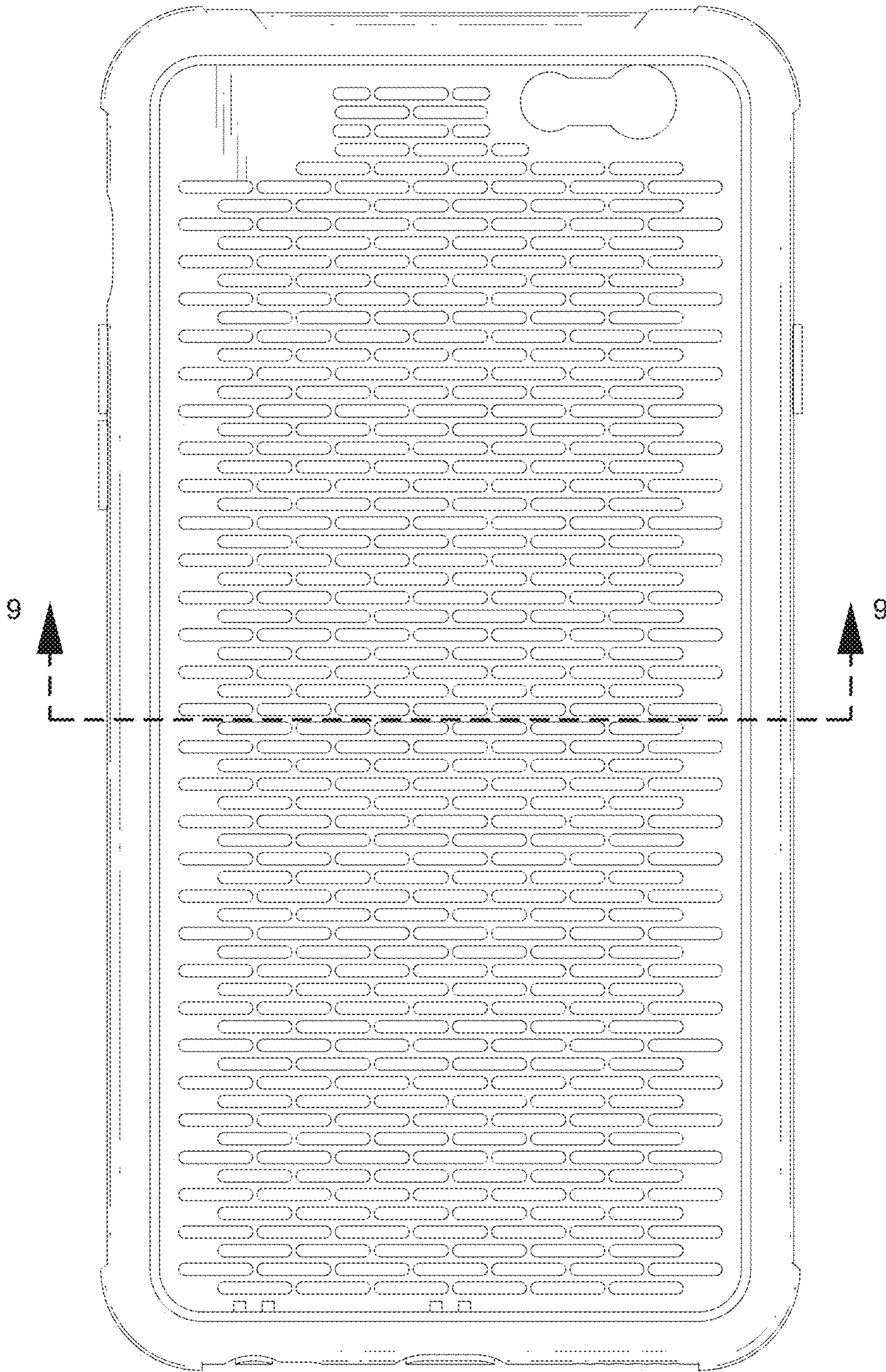
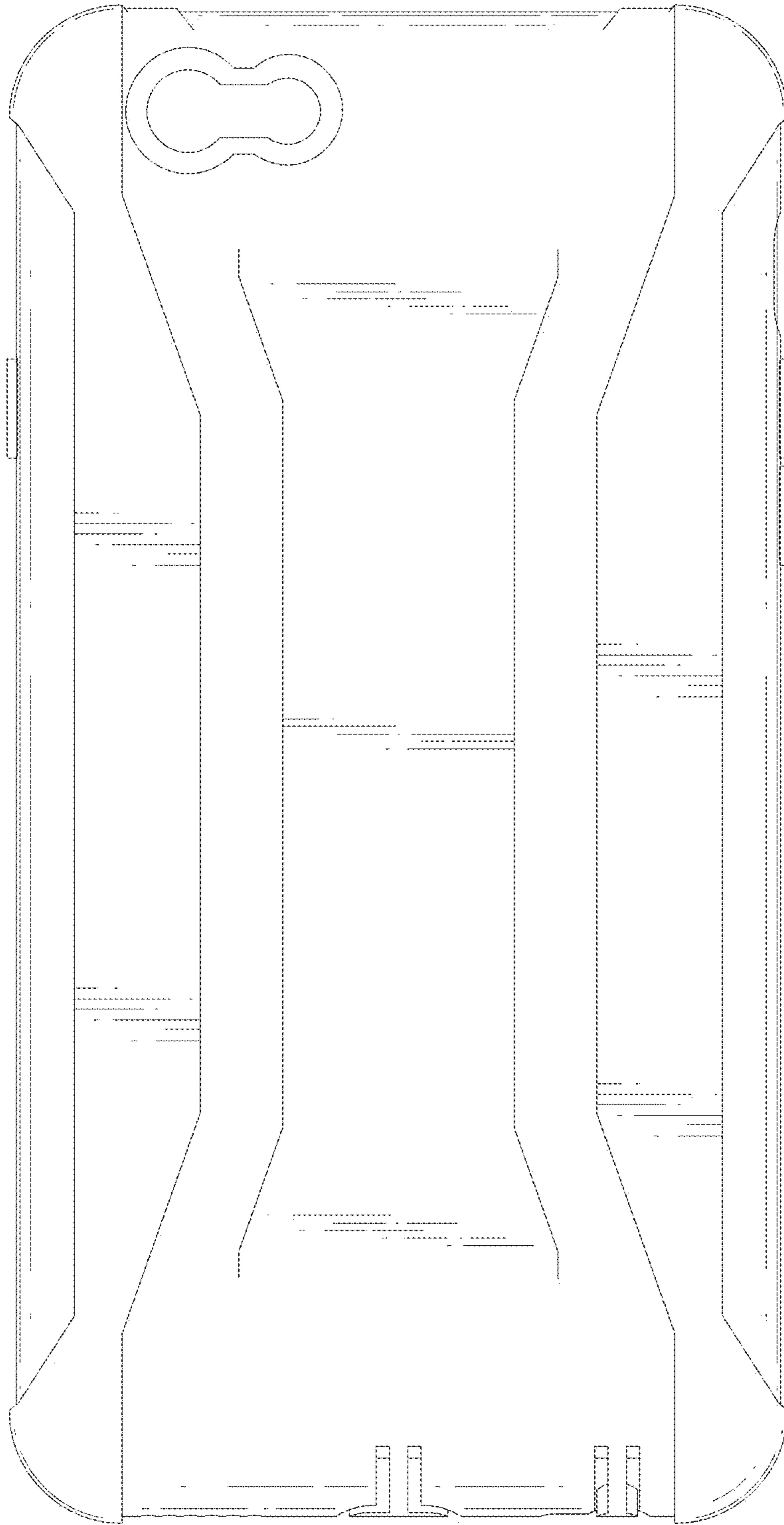
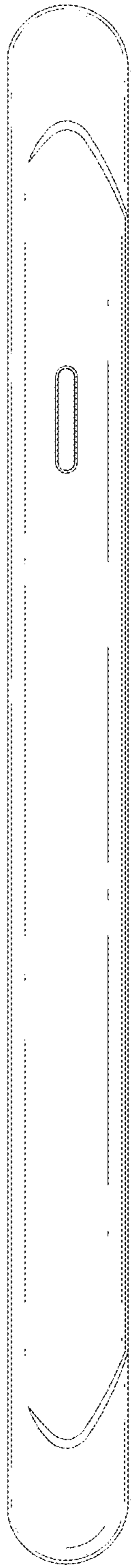


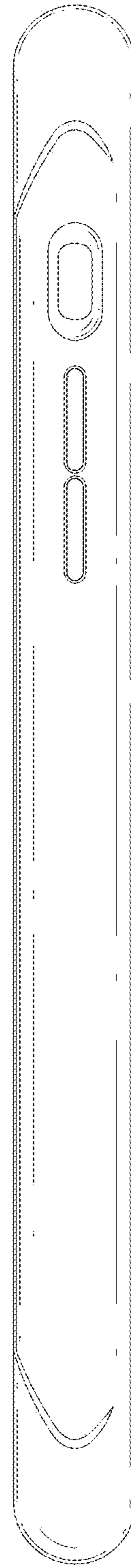

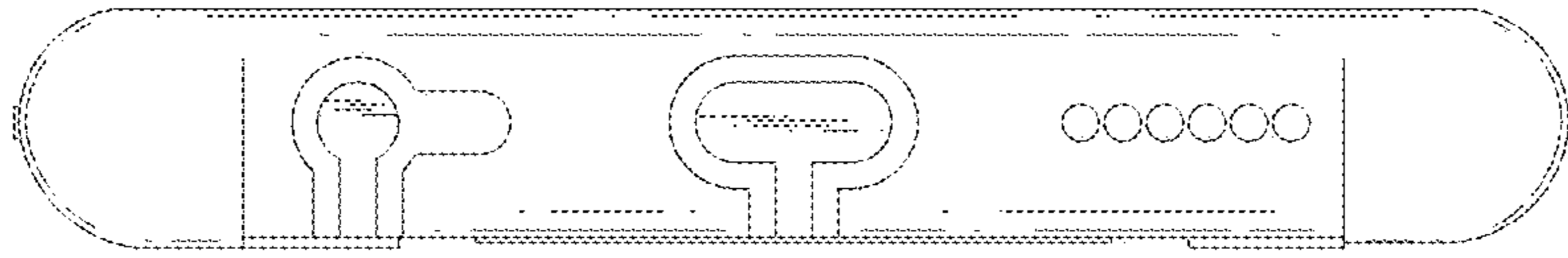

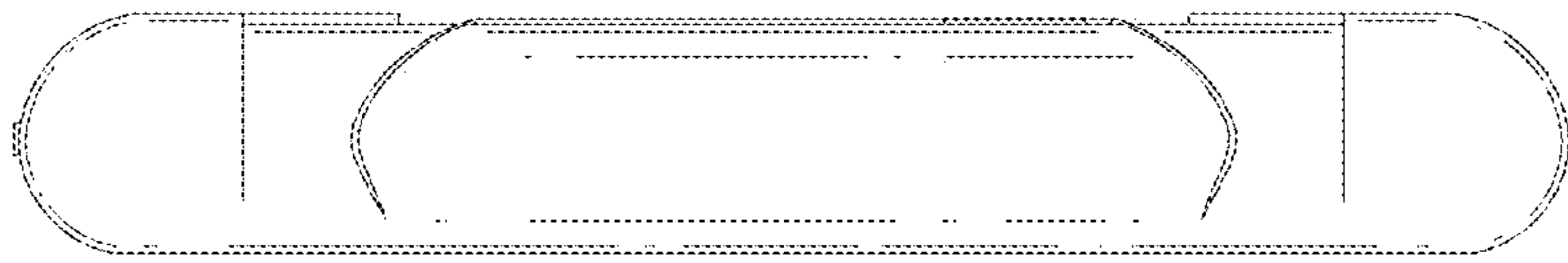

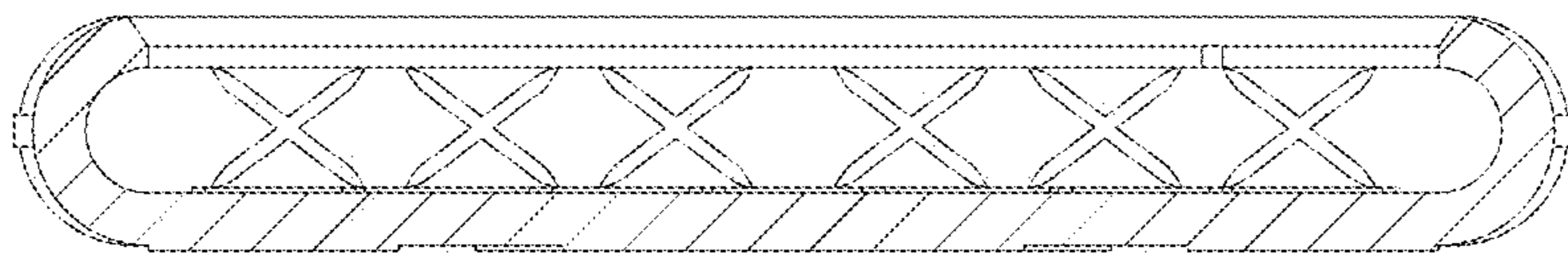
