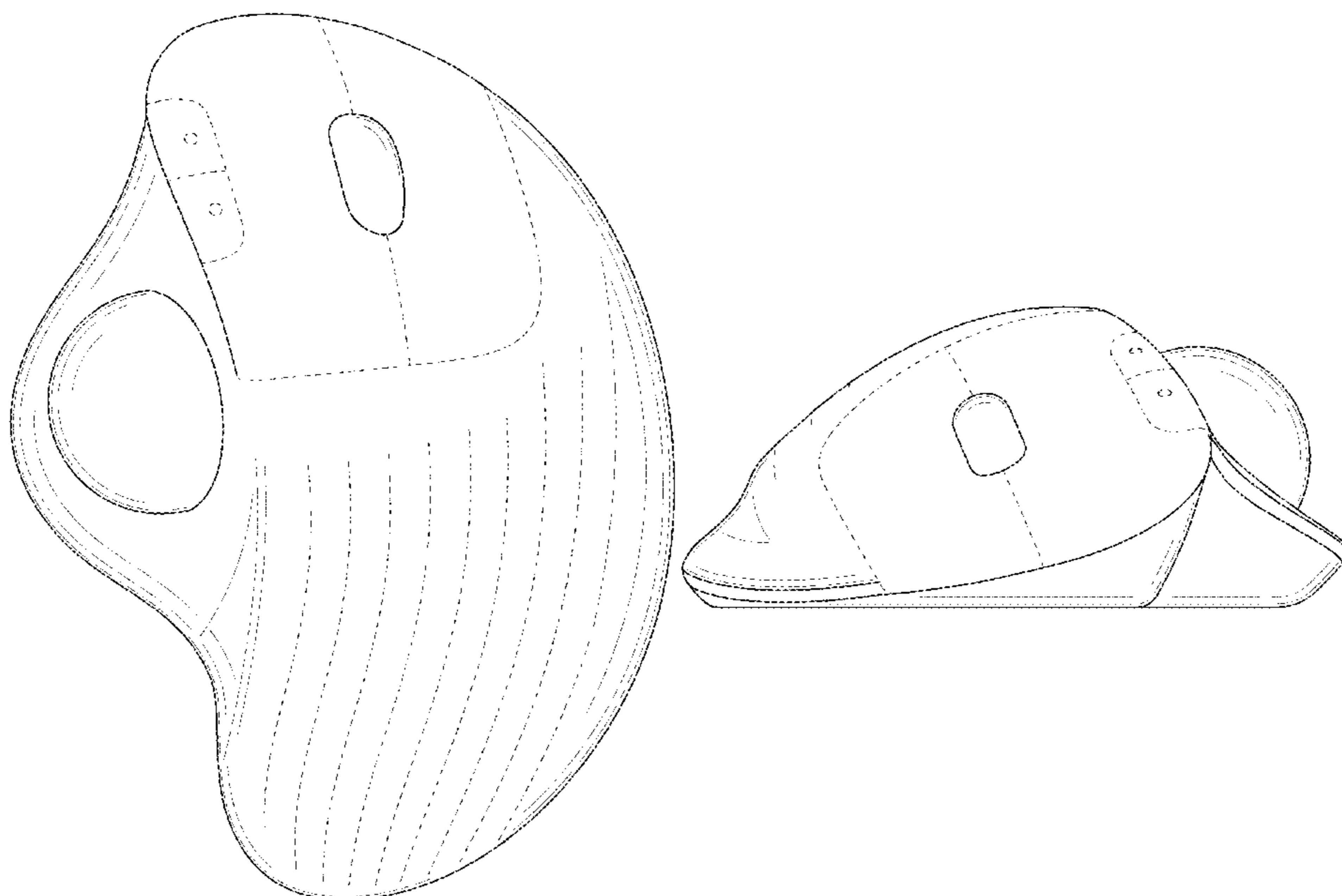
The ornamental design for input device with trackball, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear, and left side perspective view of our input device with trackball as shown and described;

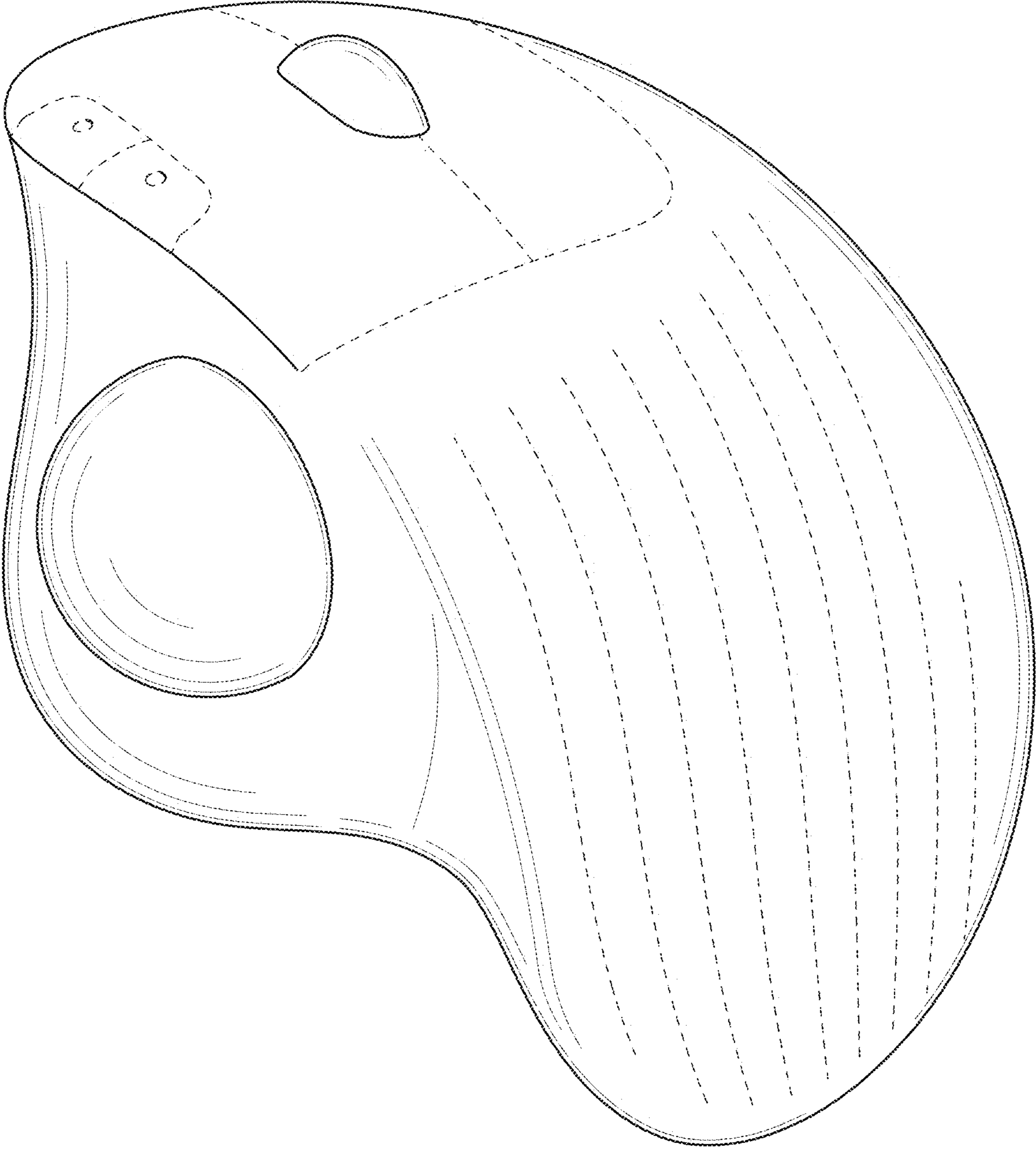

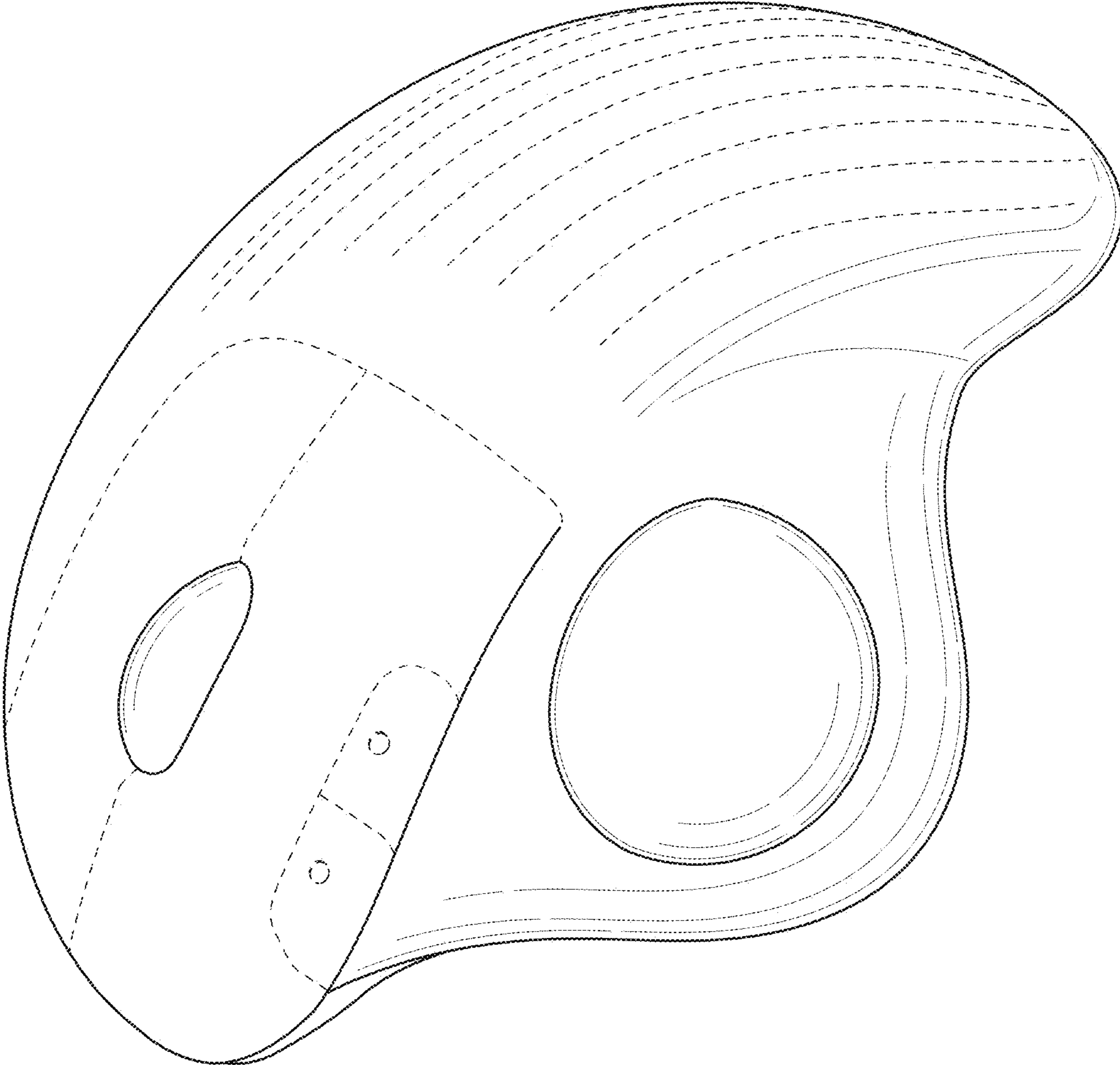

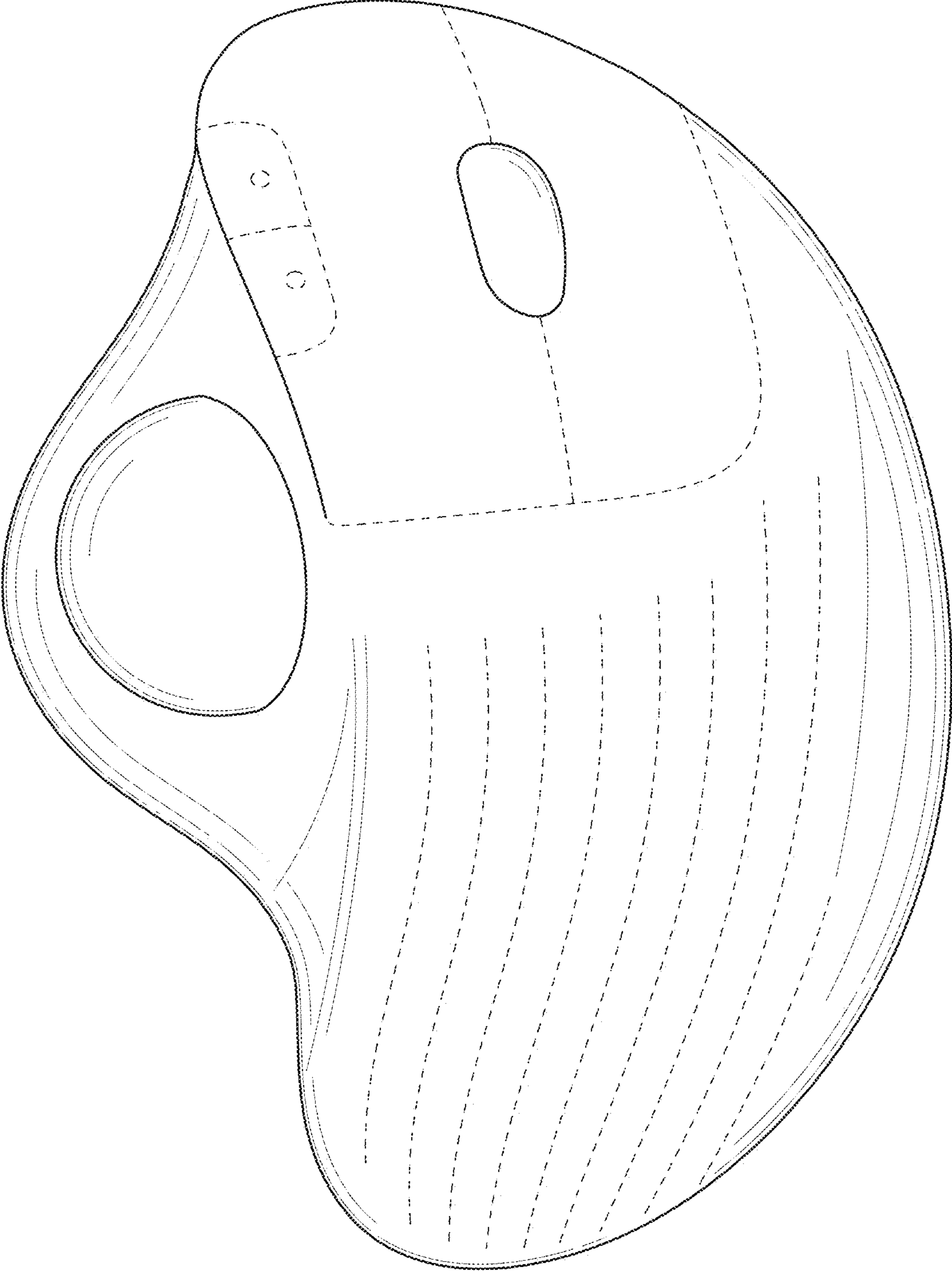

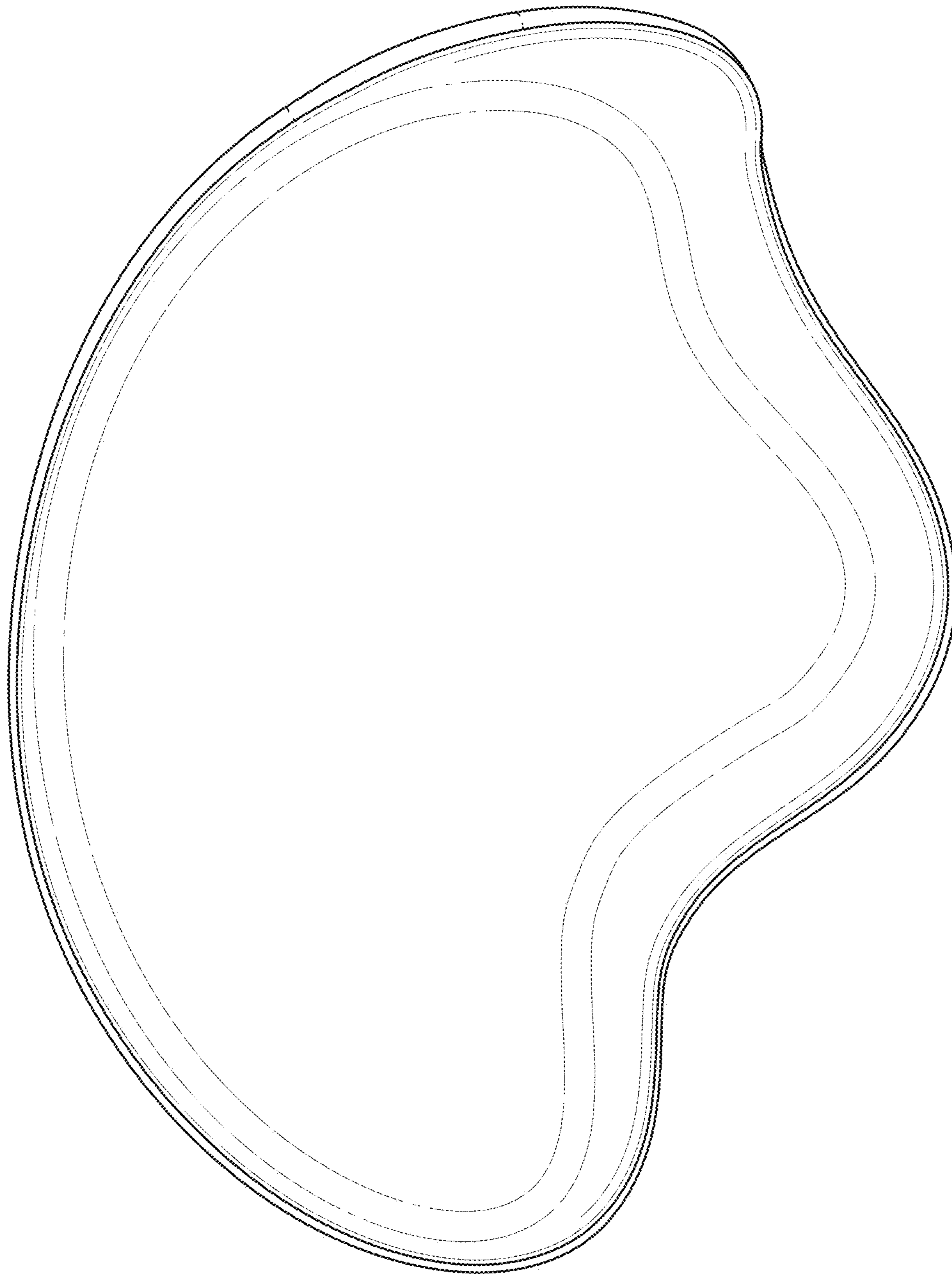

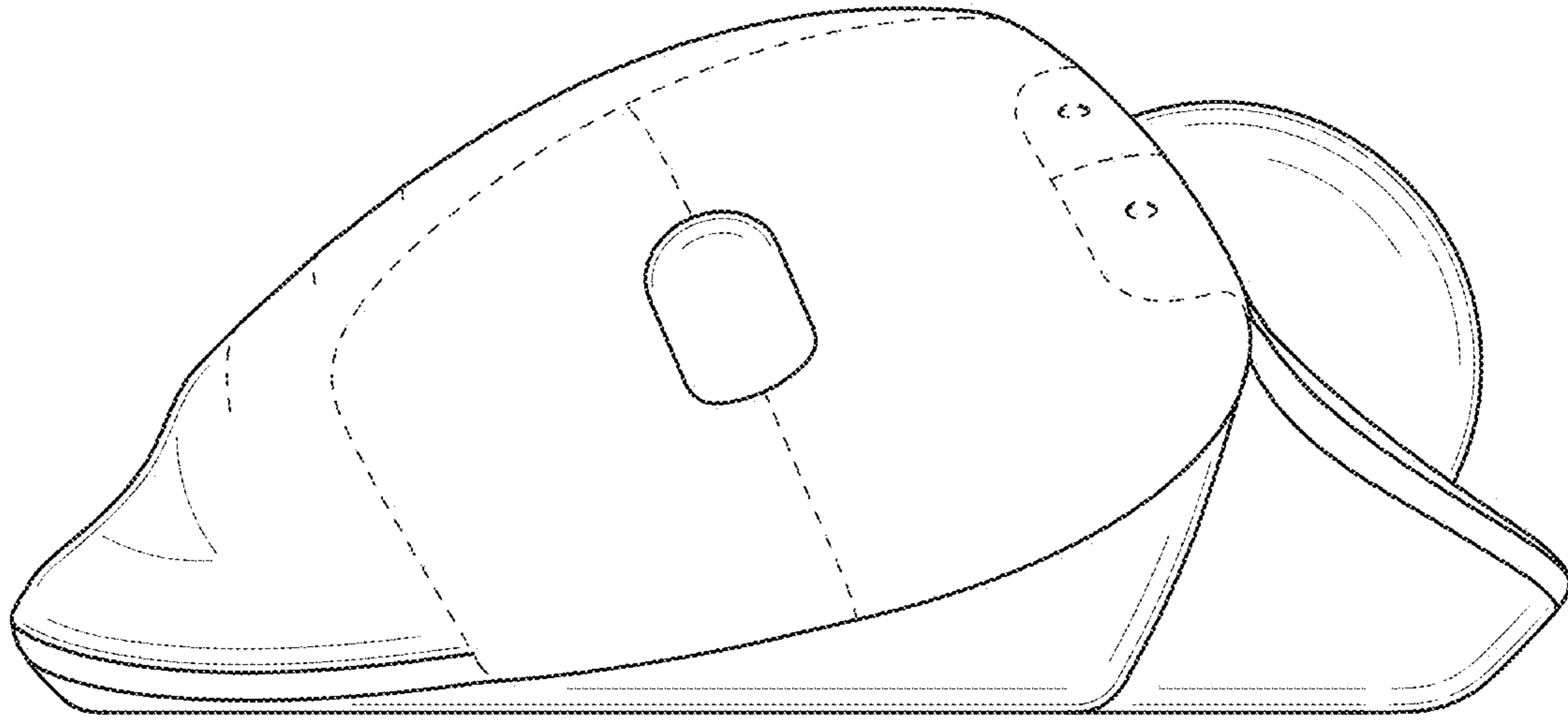

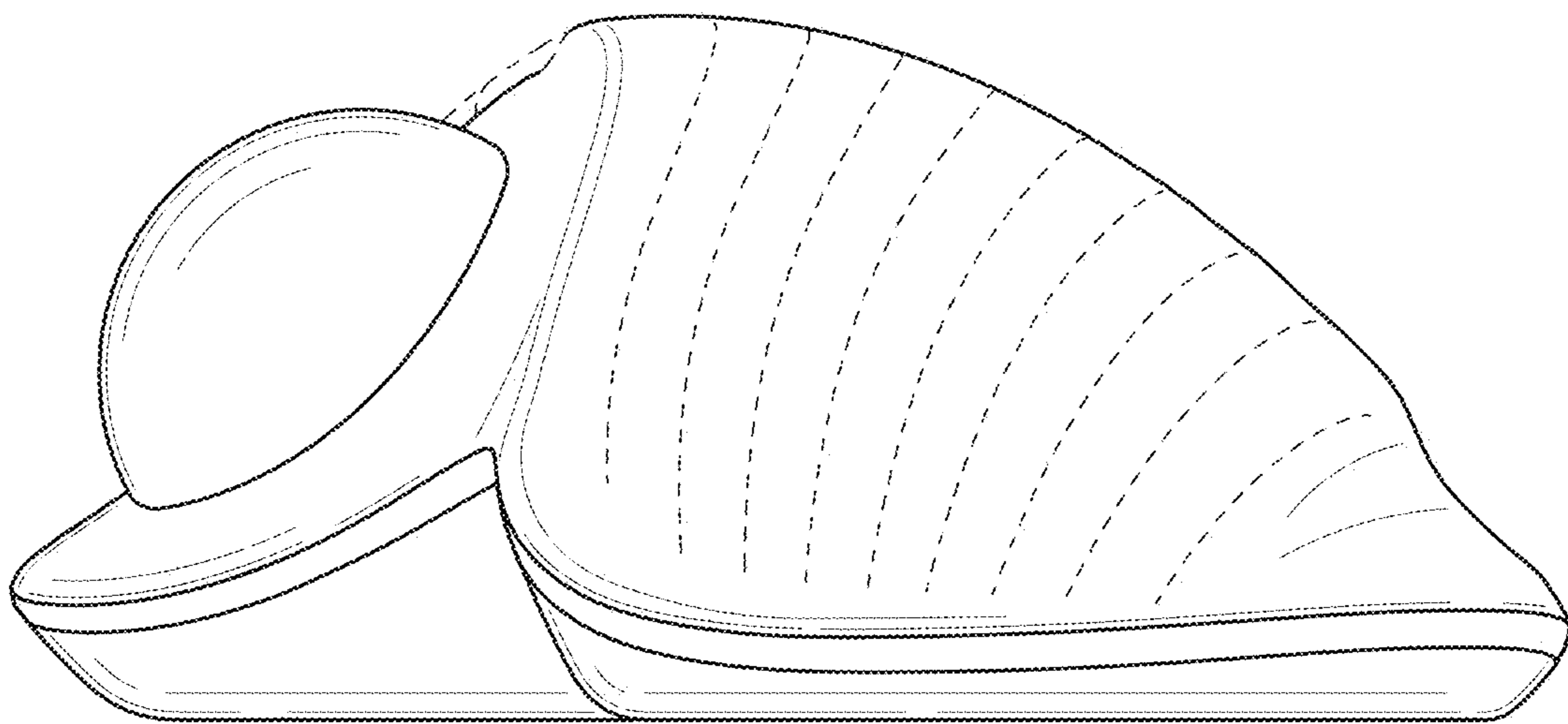

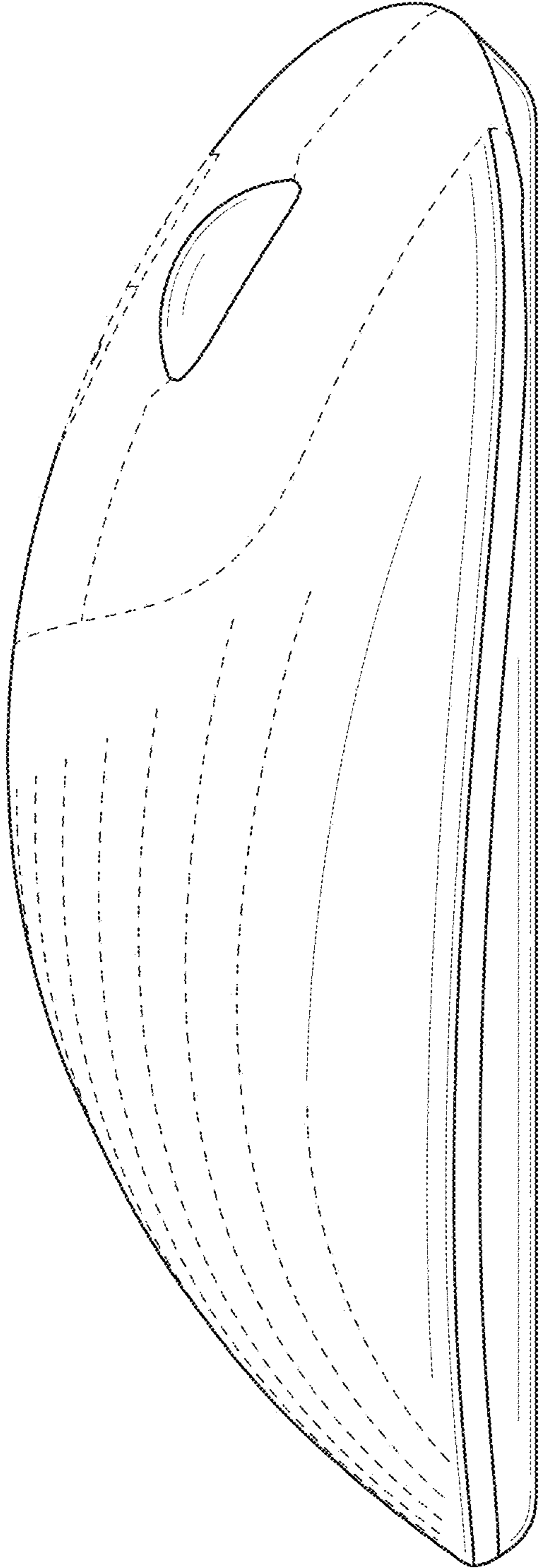

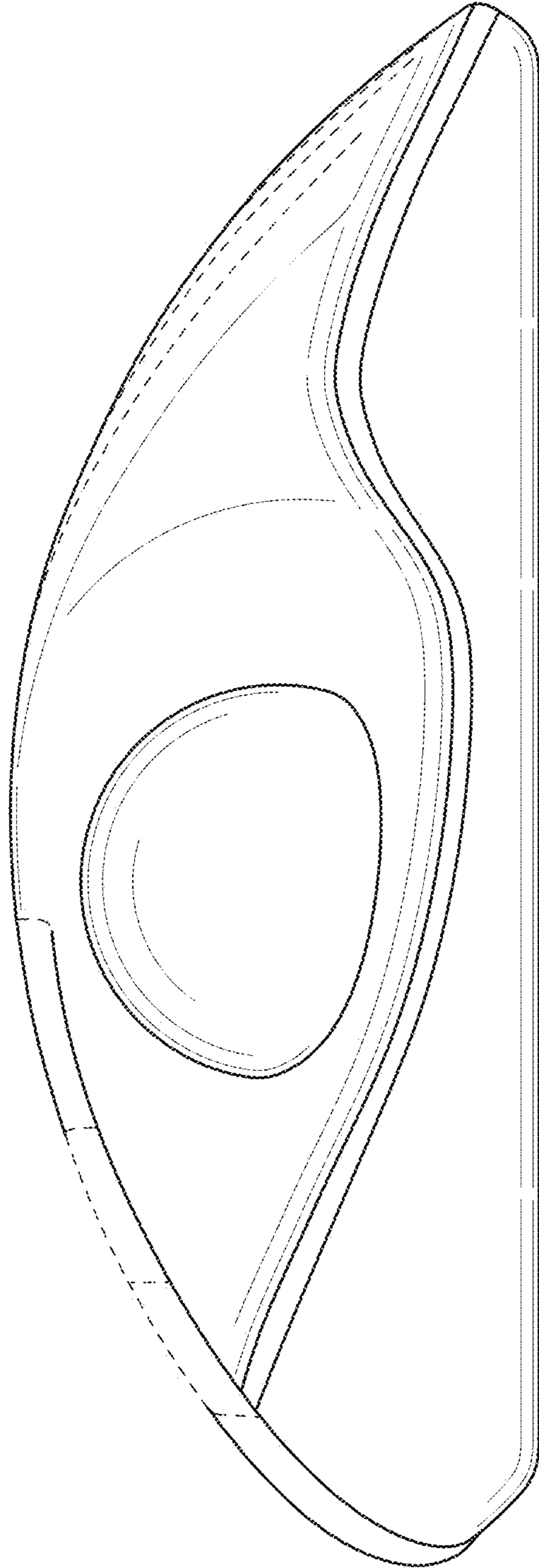
