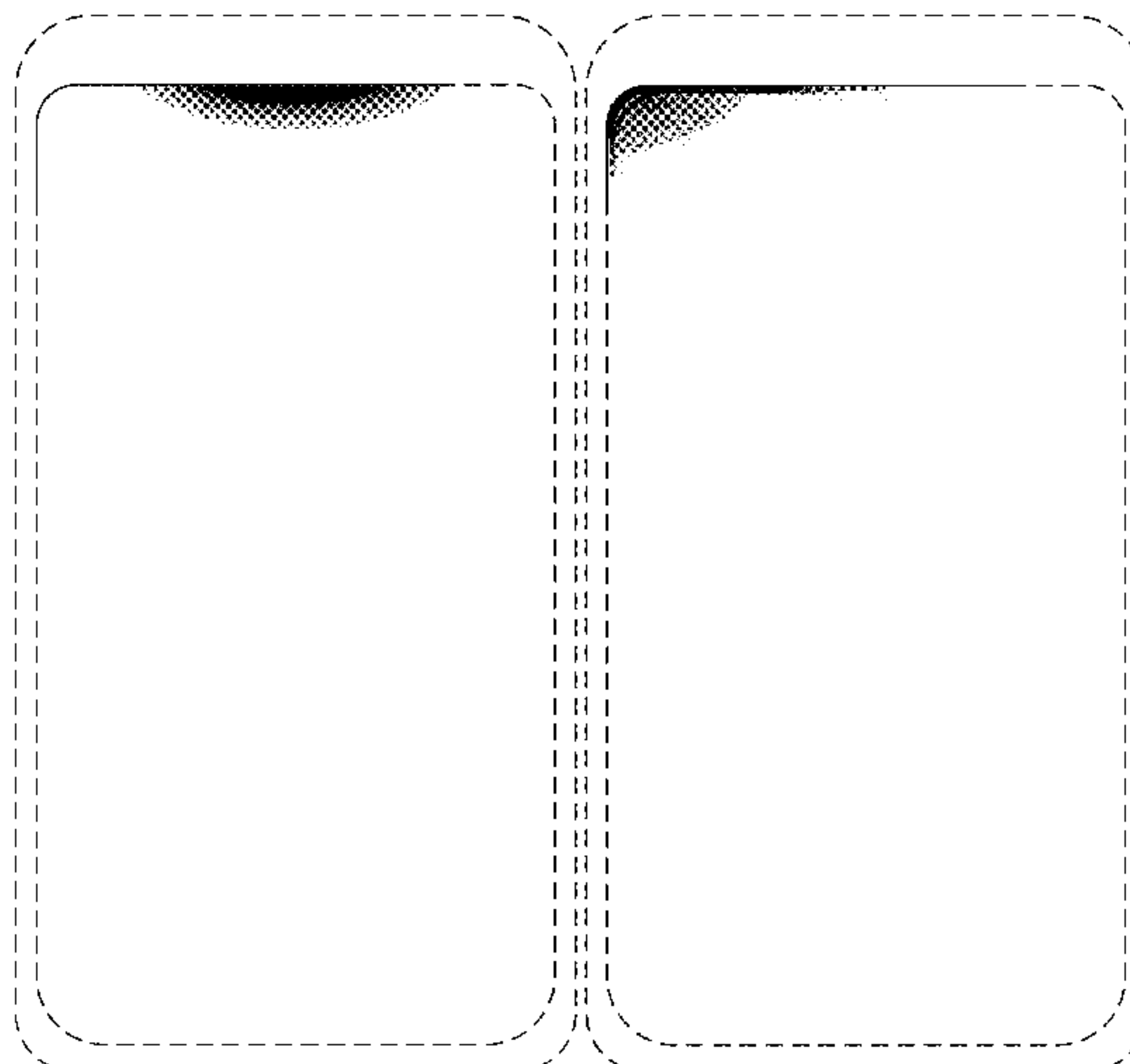
FIG. 4 is a fourth image thereof;

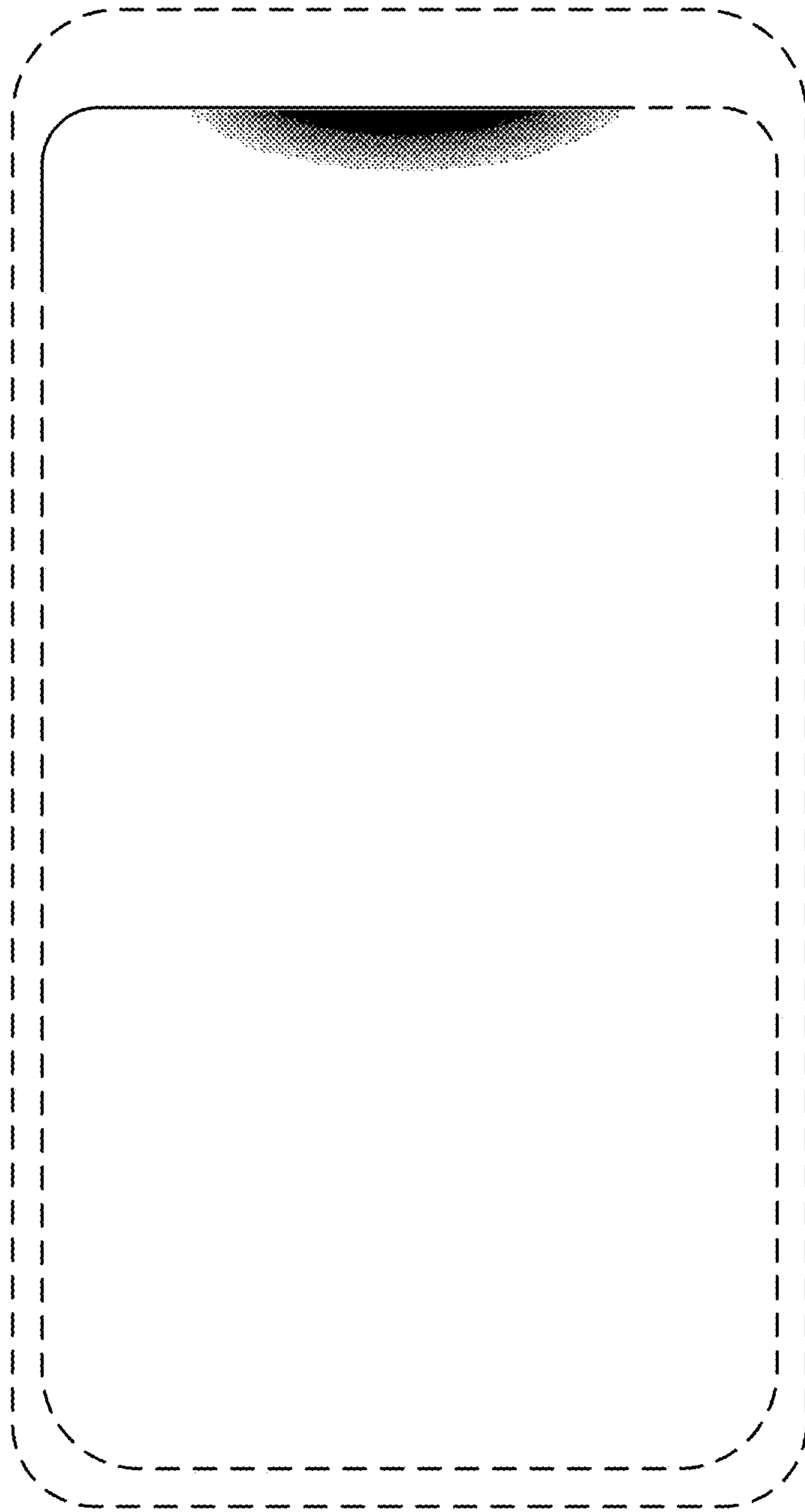

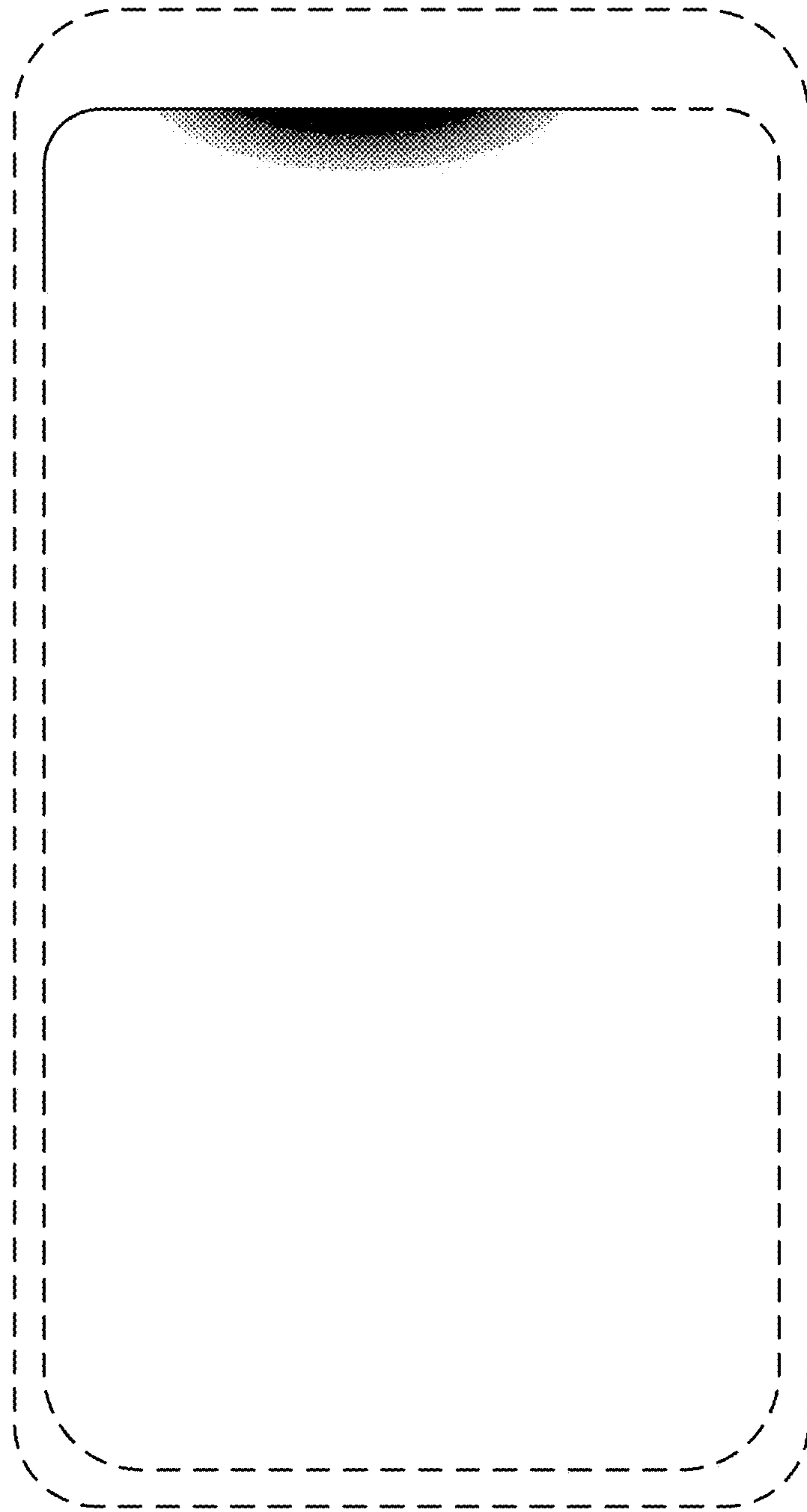

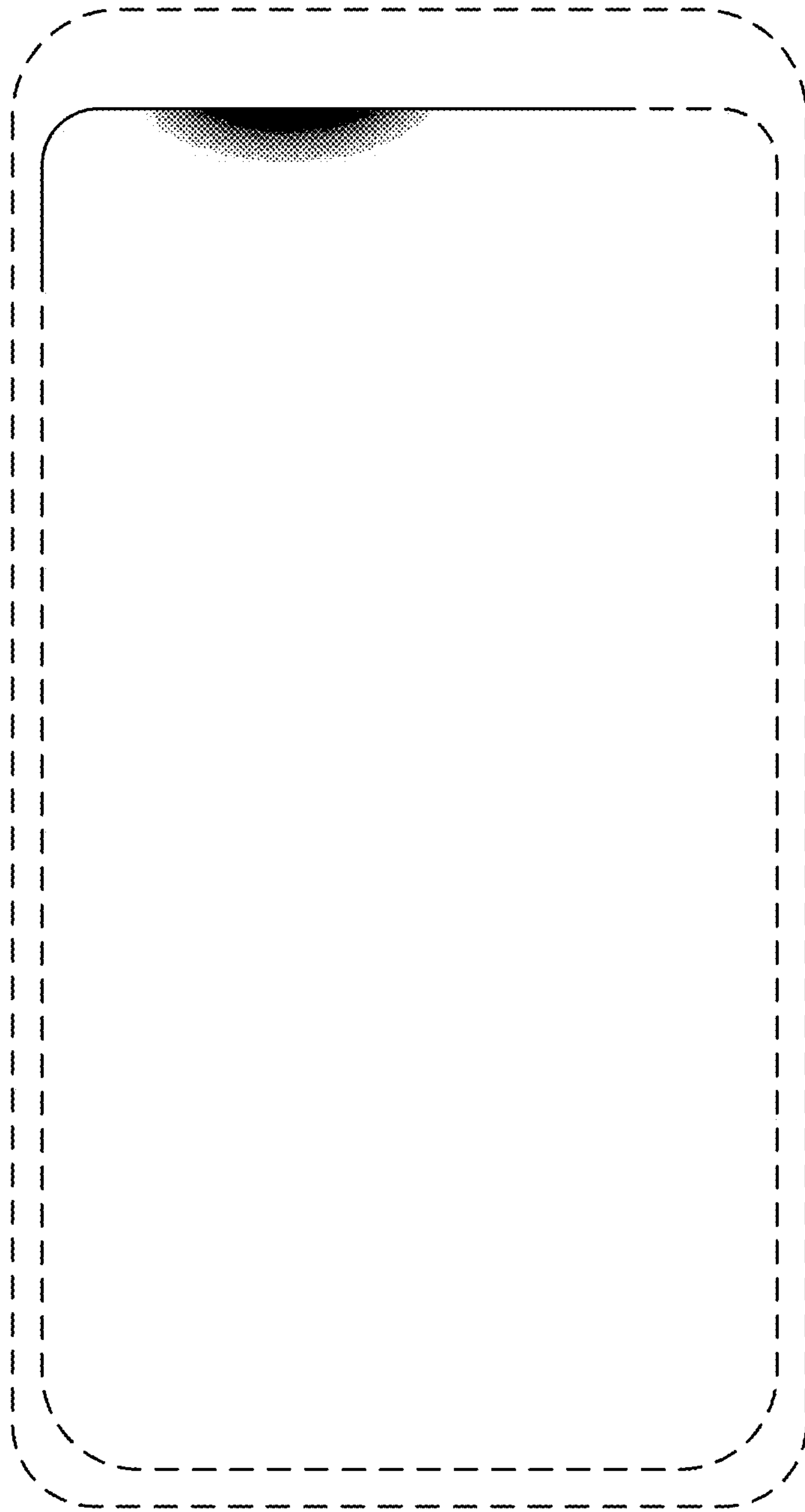

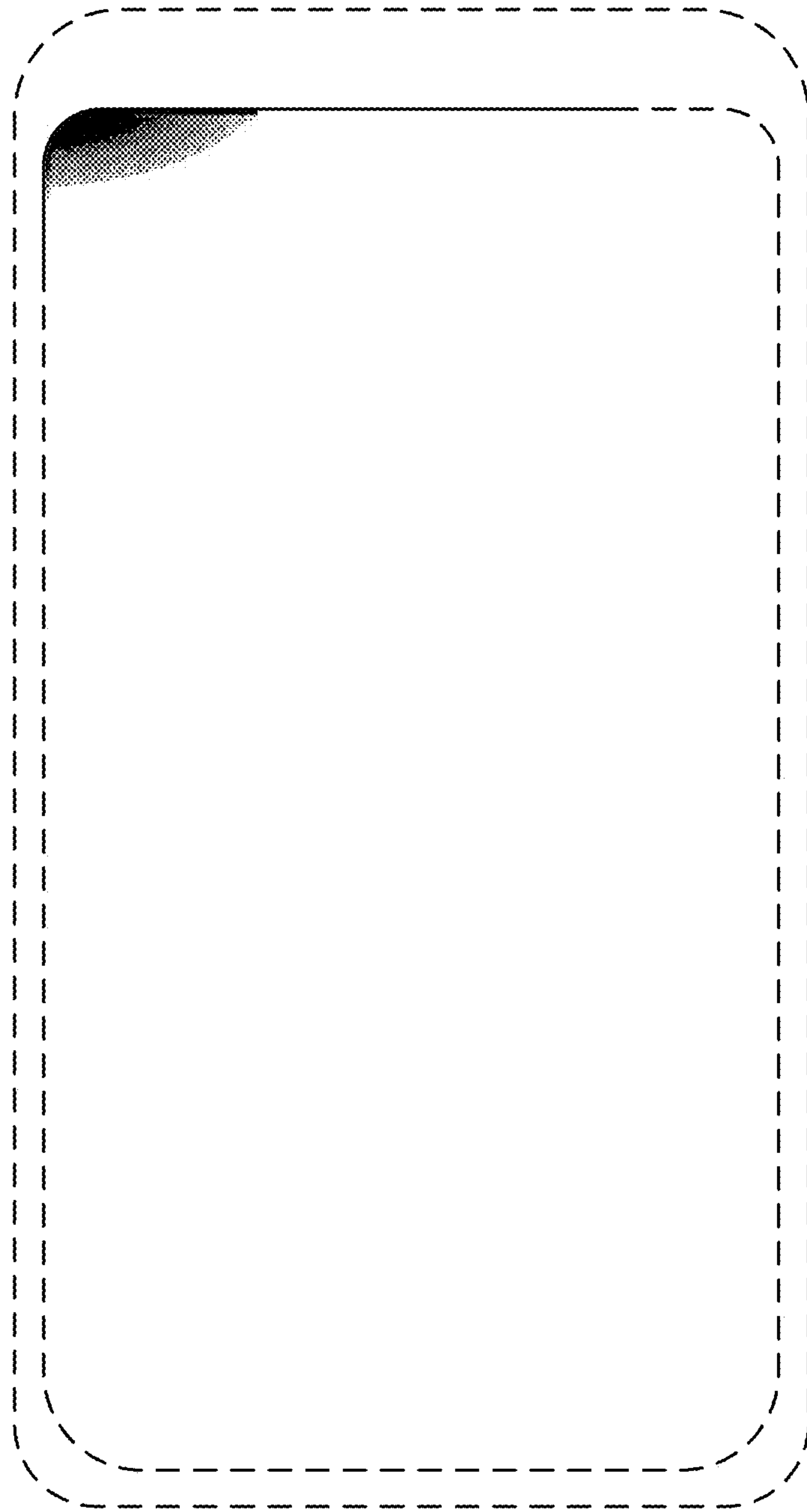

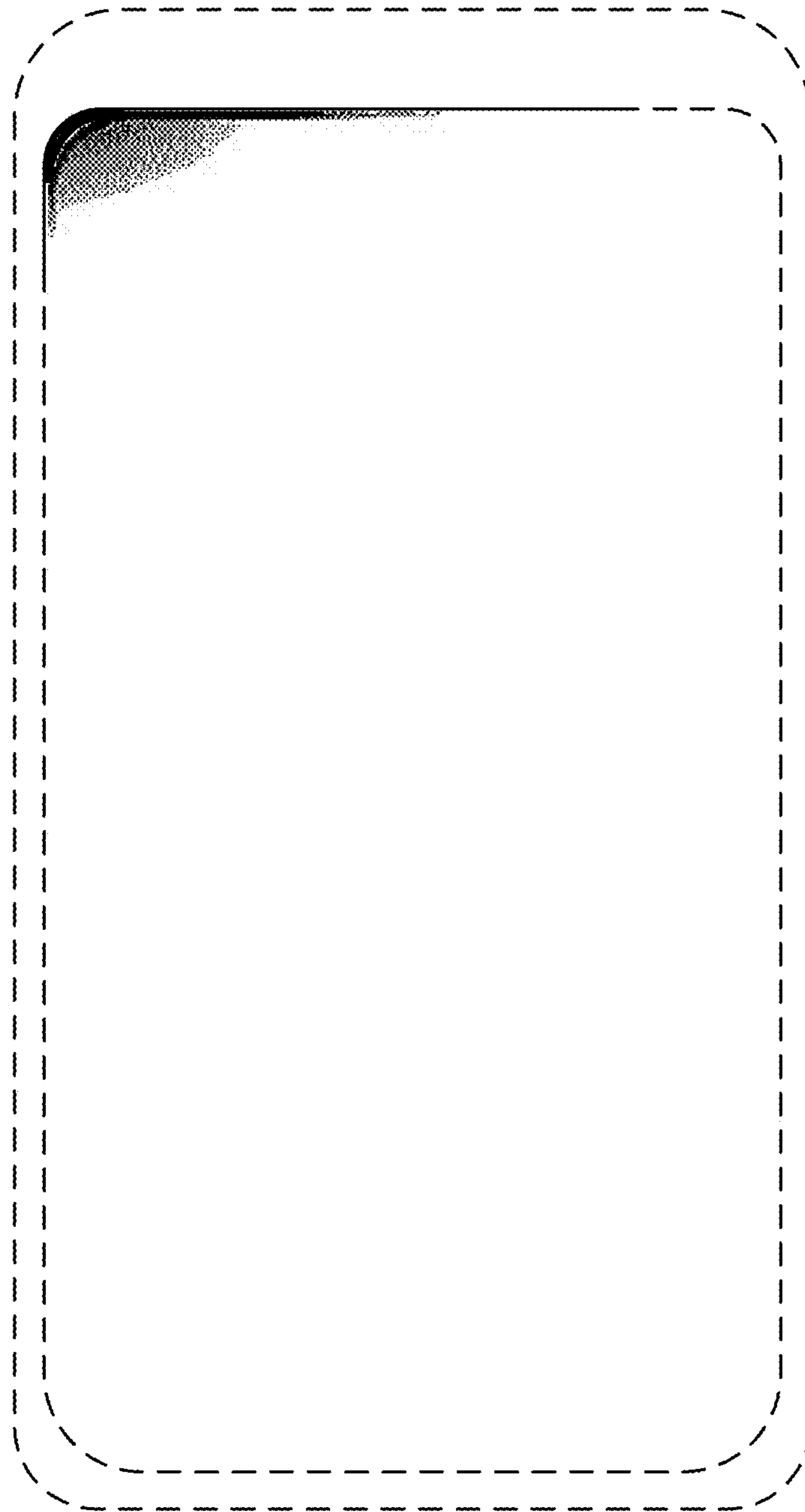

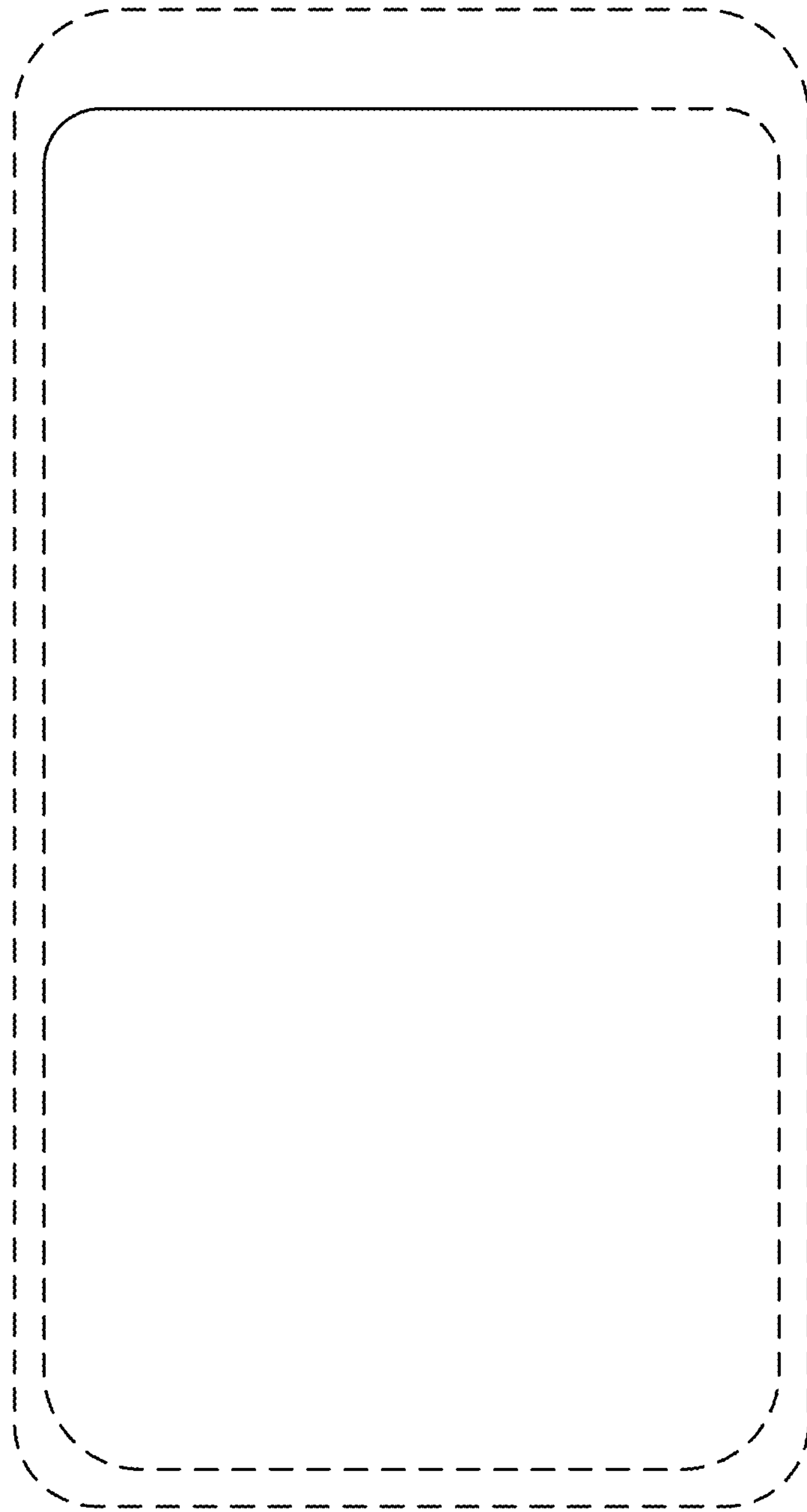
