DESCRIPTION

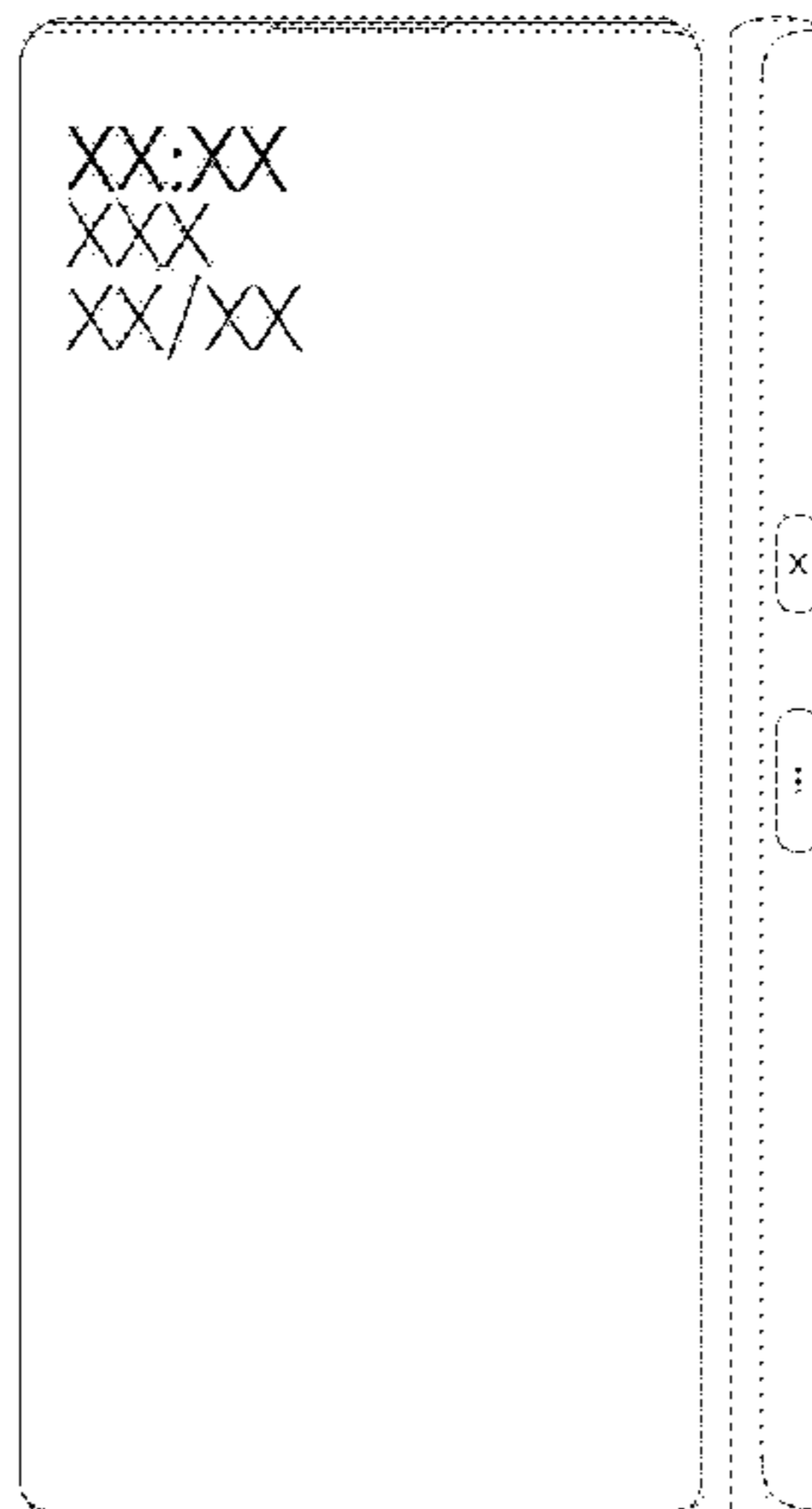
1.1 is a front view of a mobile phone with graphical user interface;

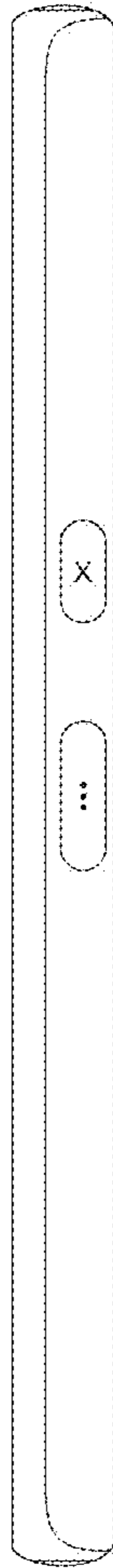
