The ornamental design for an induction station module, as shown and described.

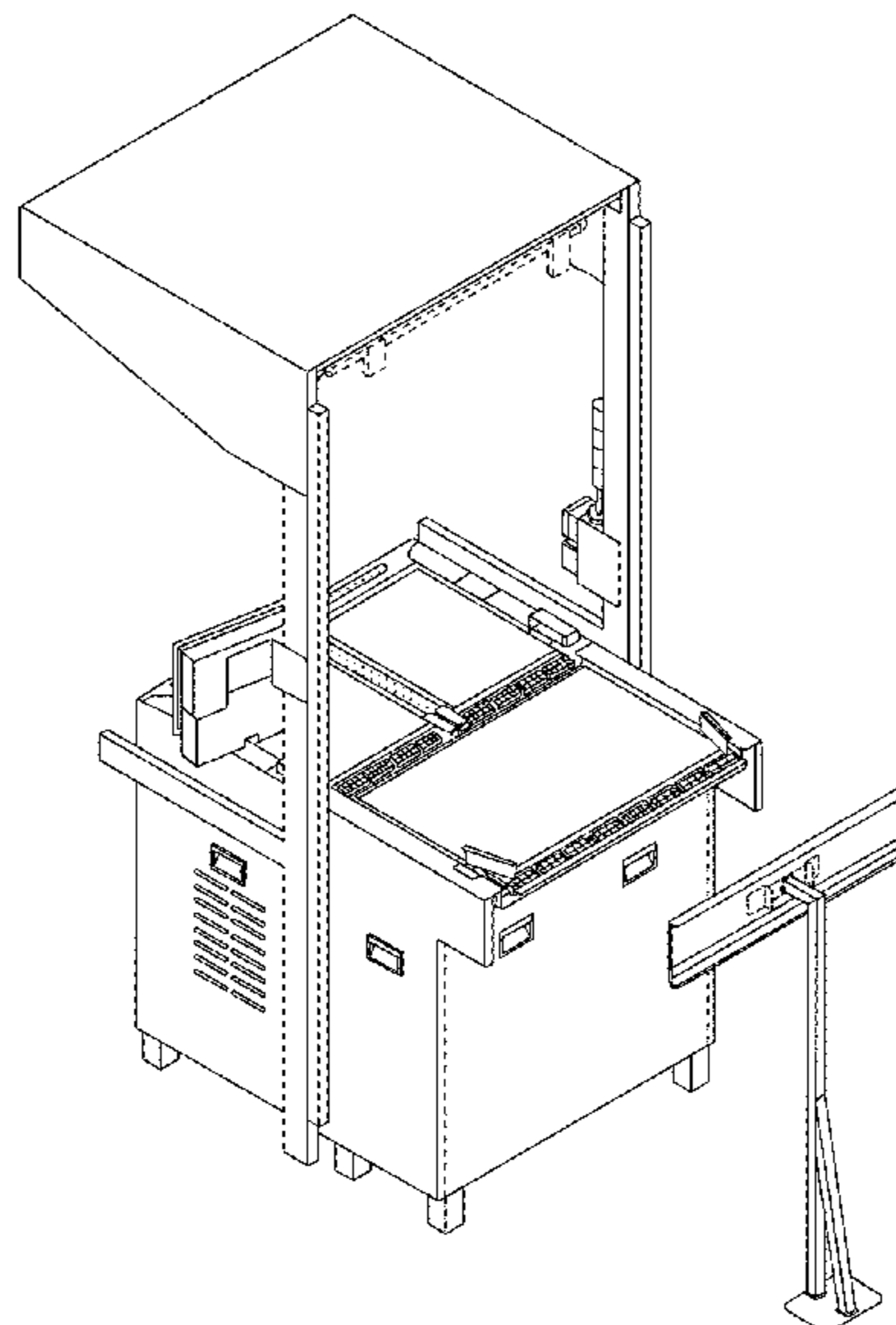
**DESCRIPTION**

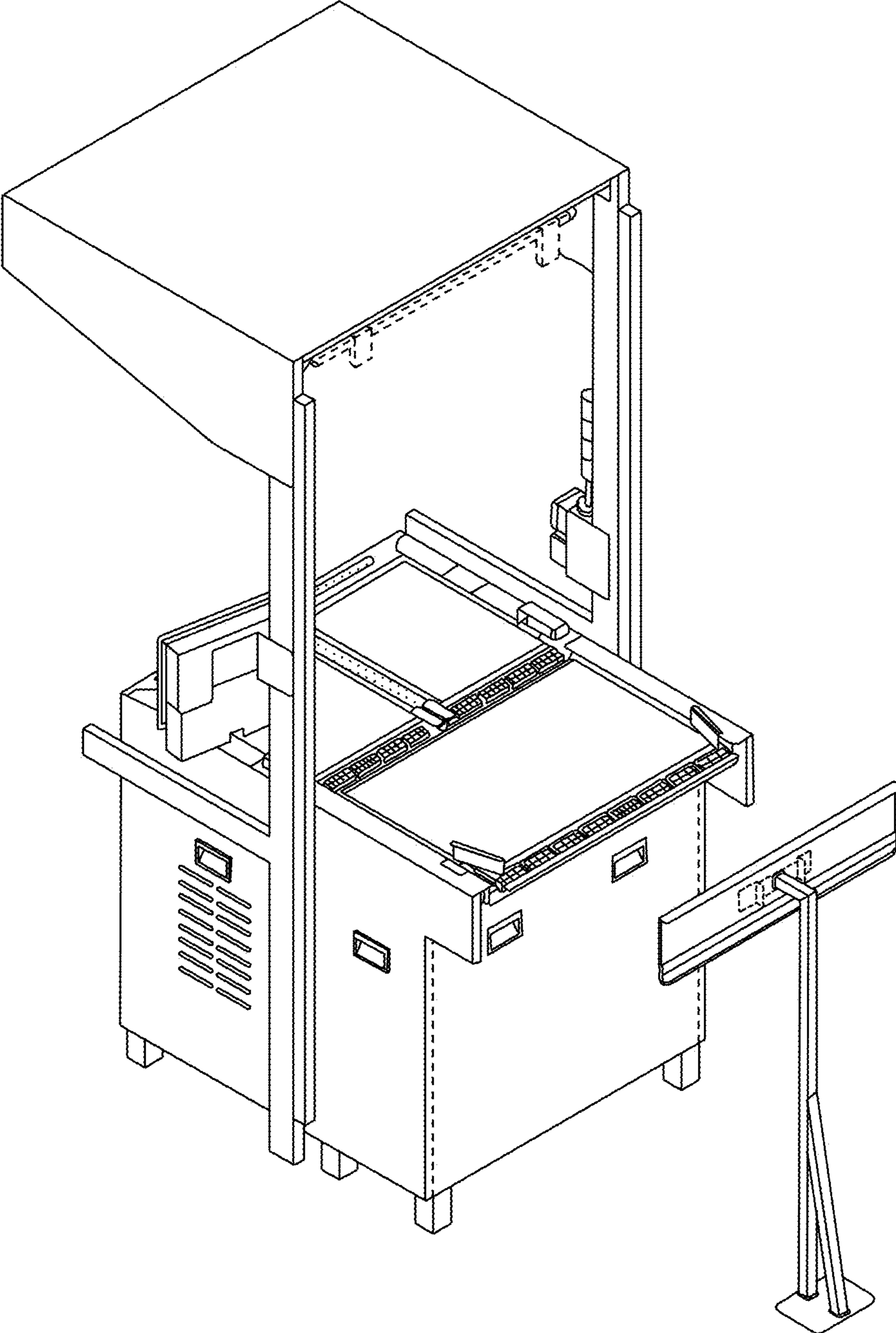

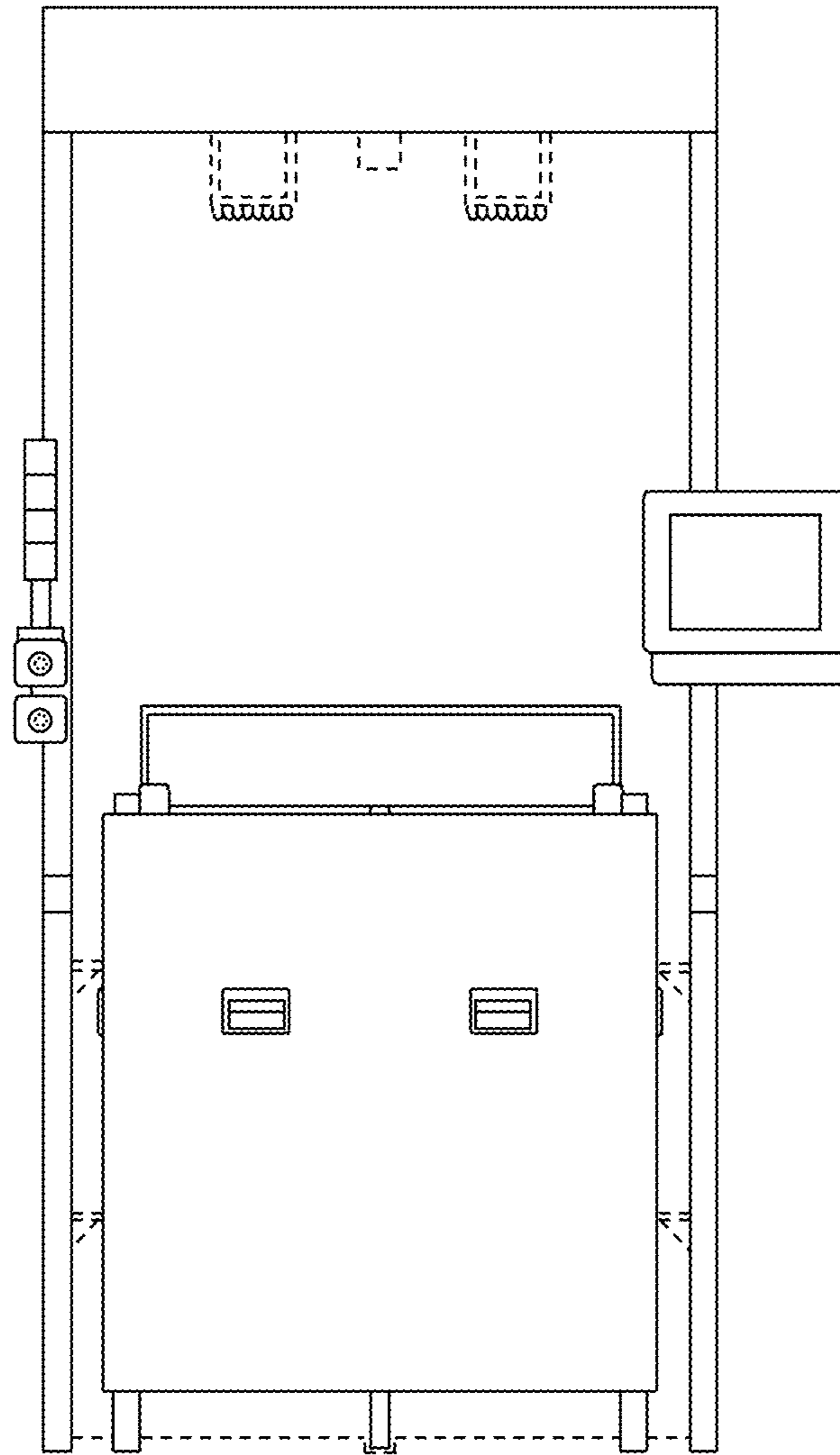

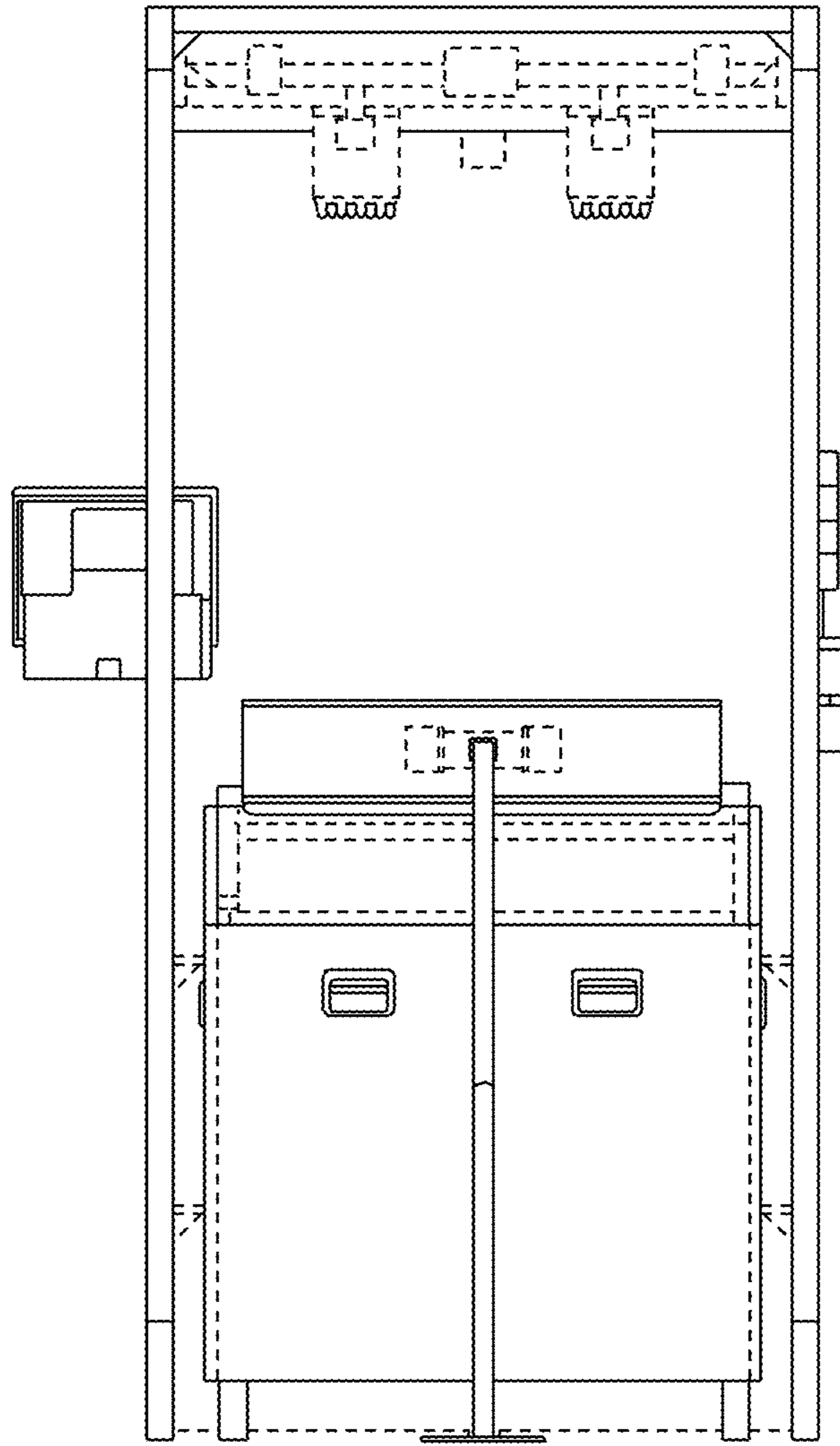

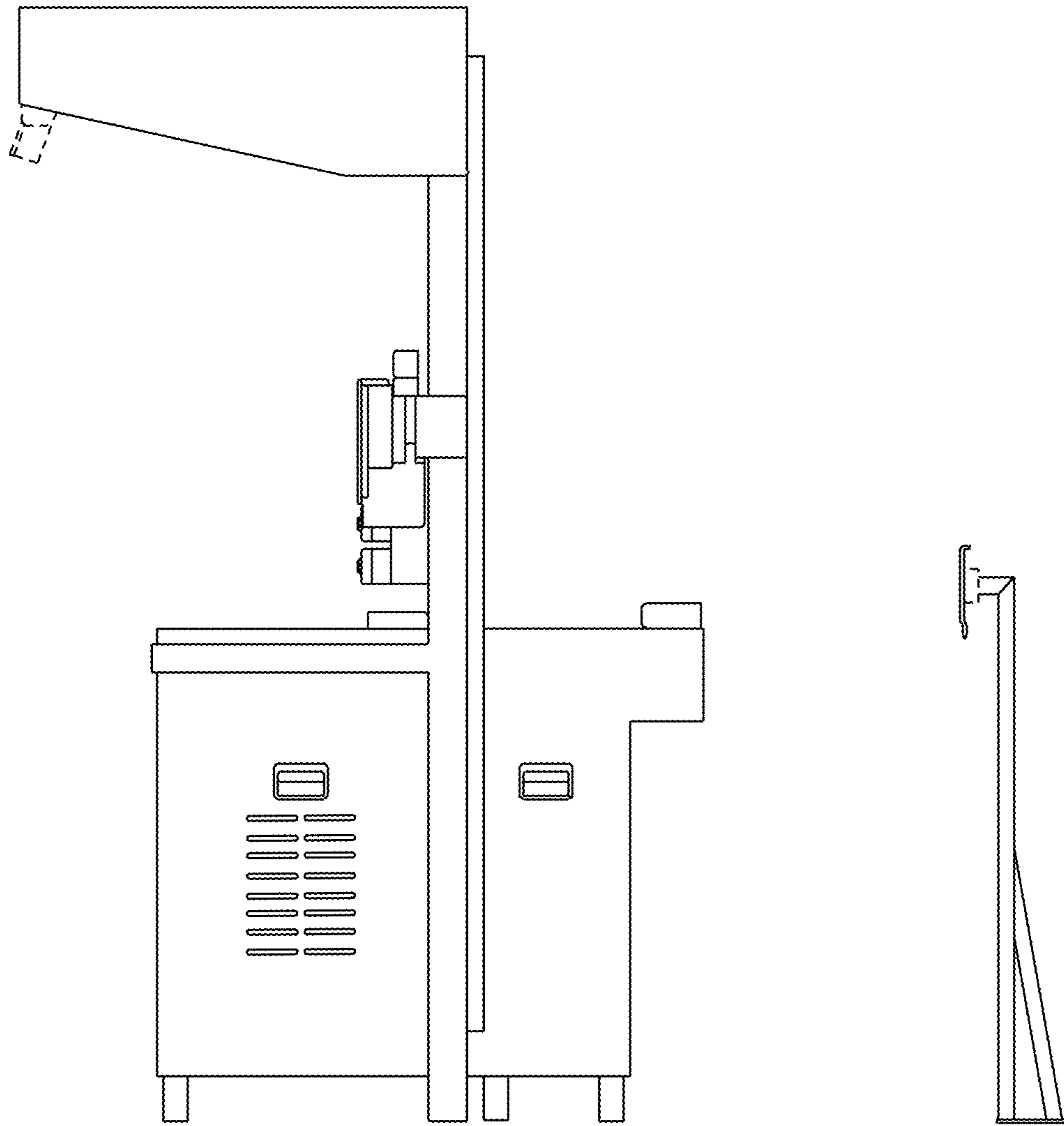

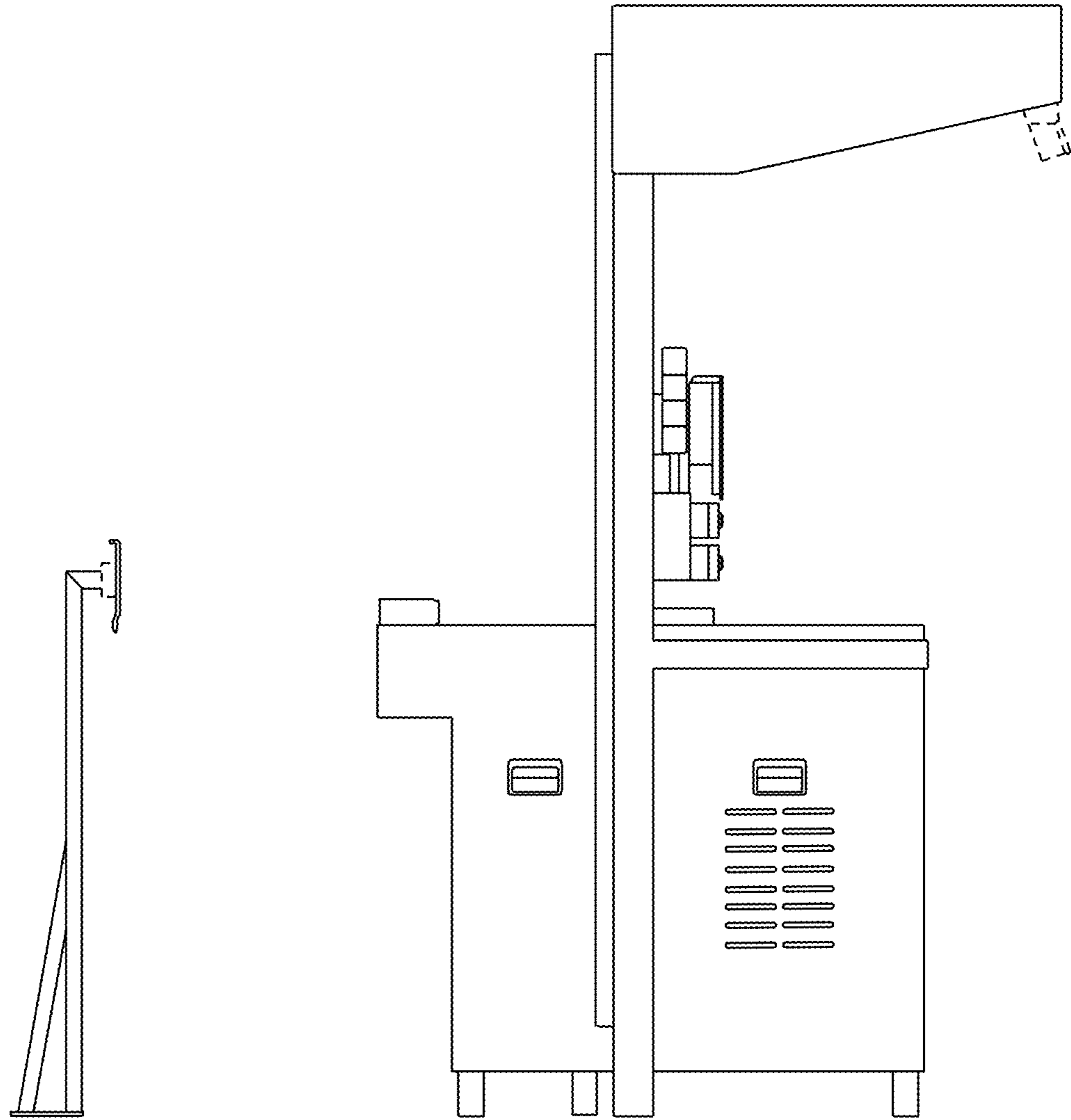

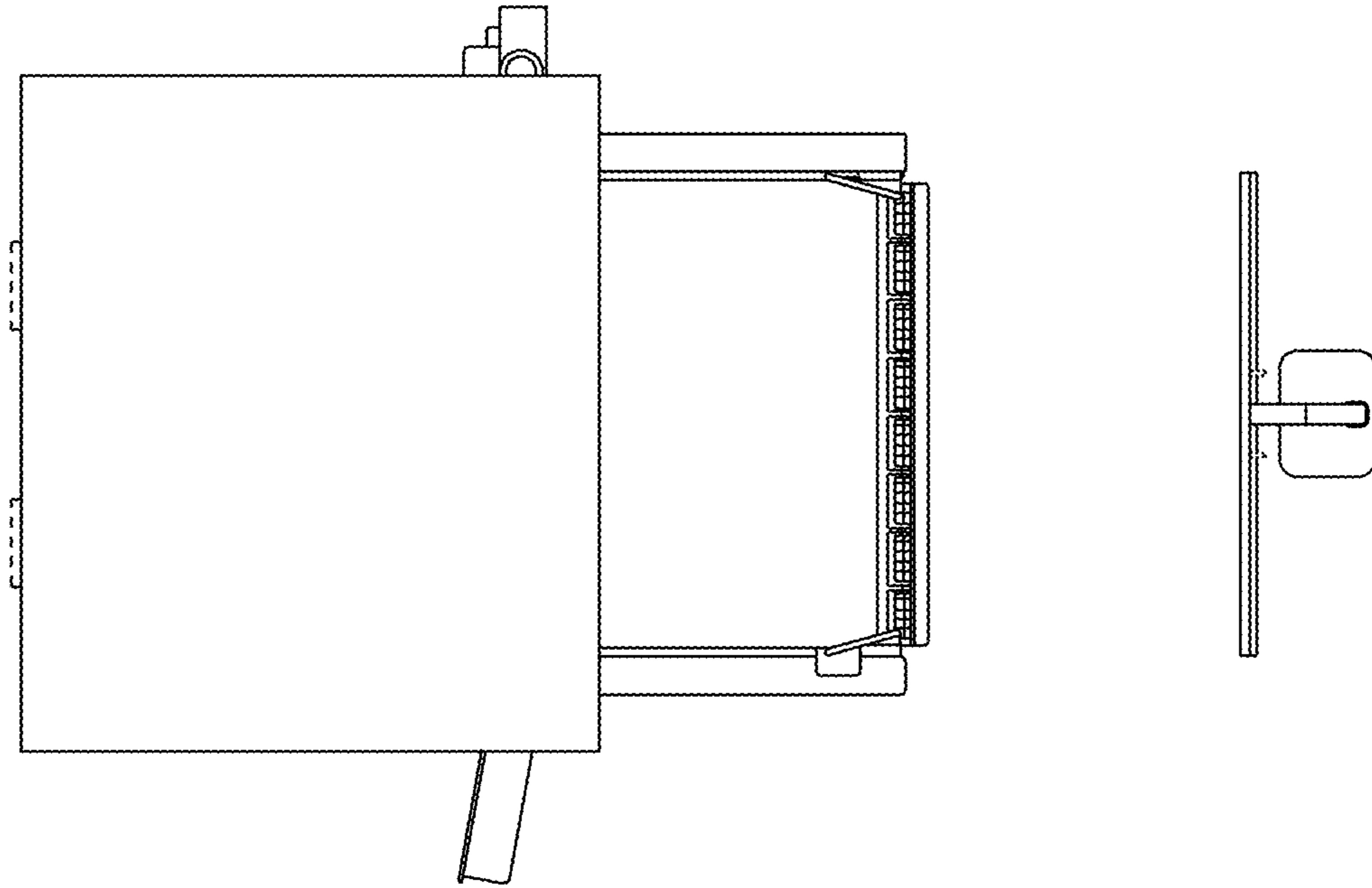
