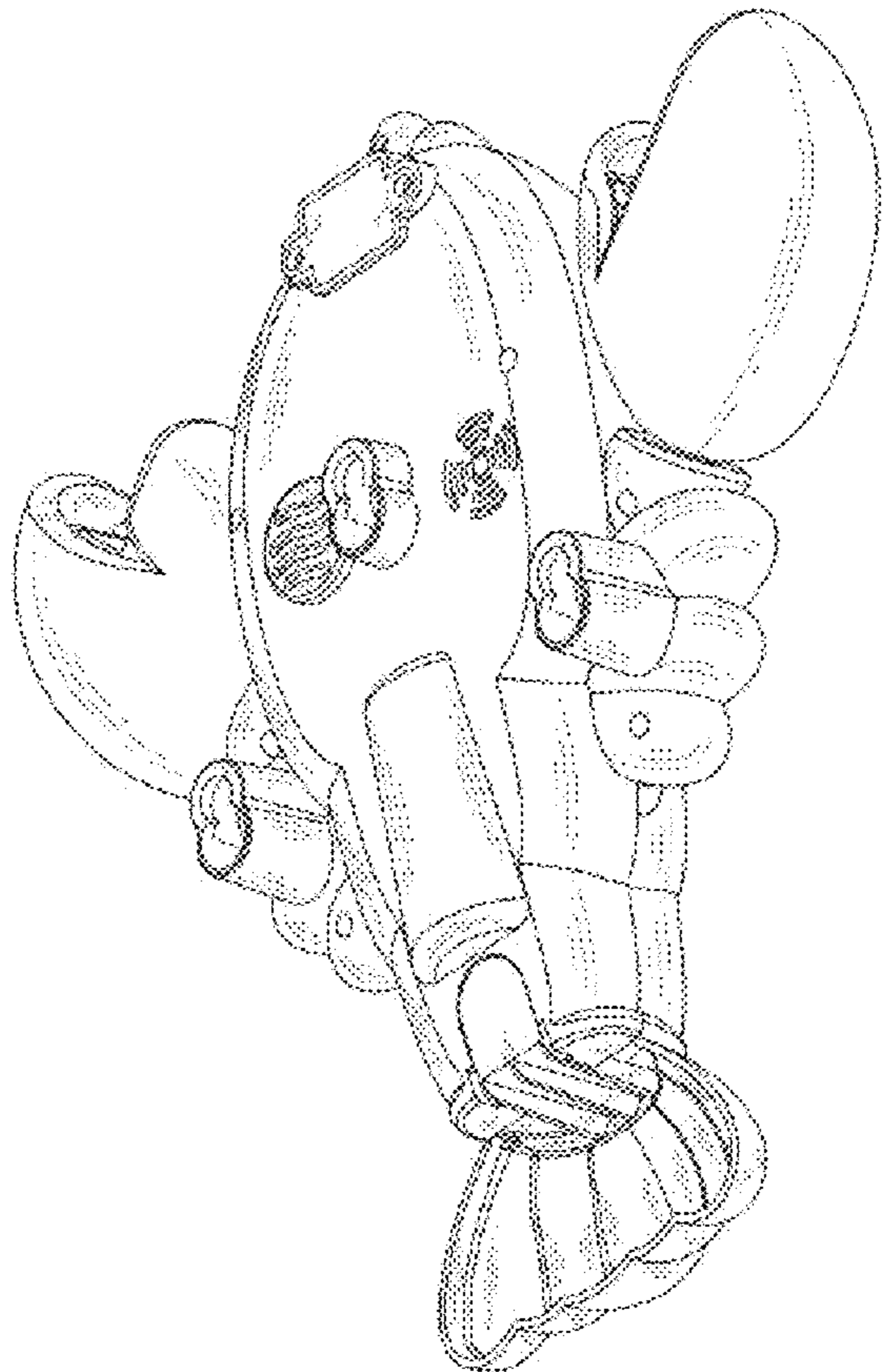
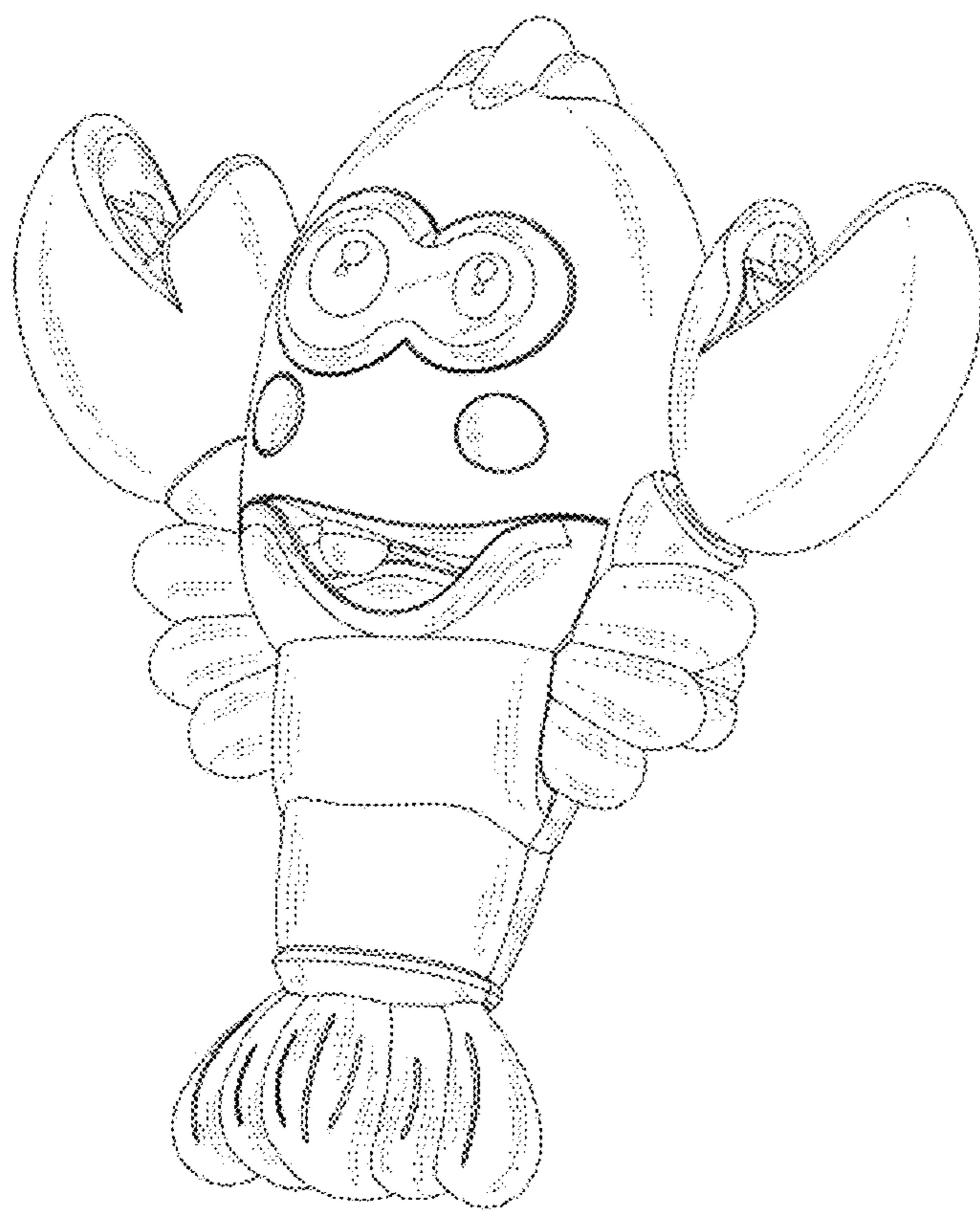

**DESCRIPTION**

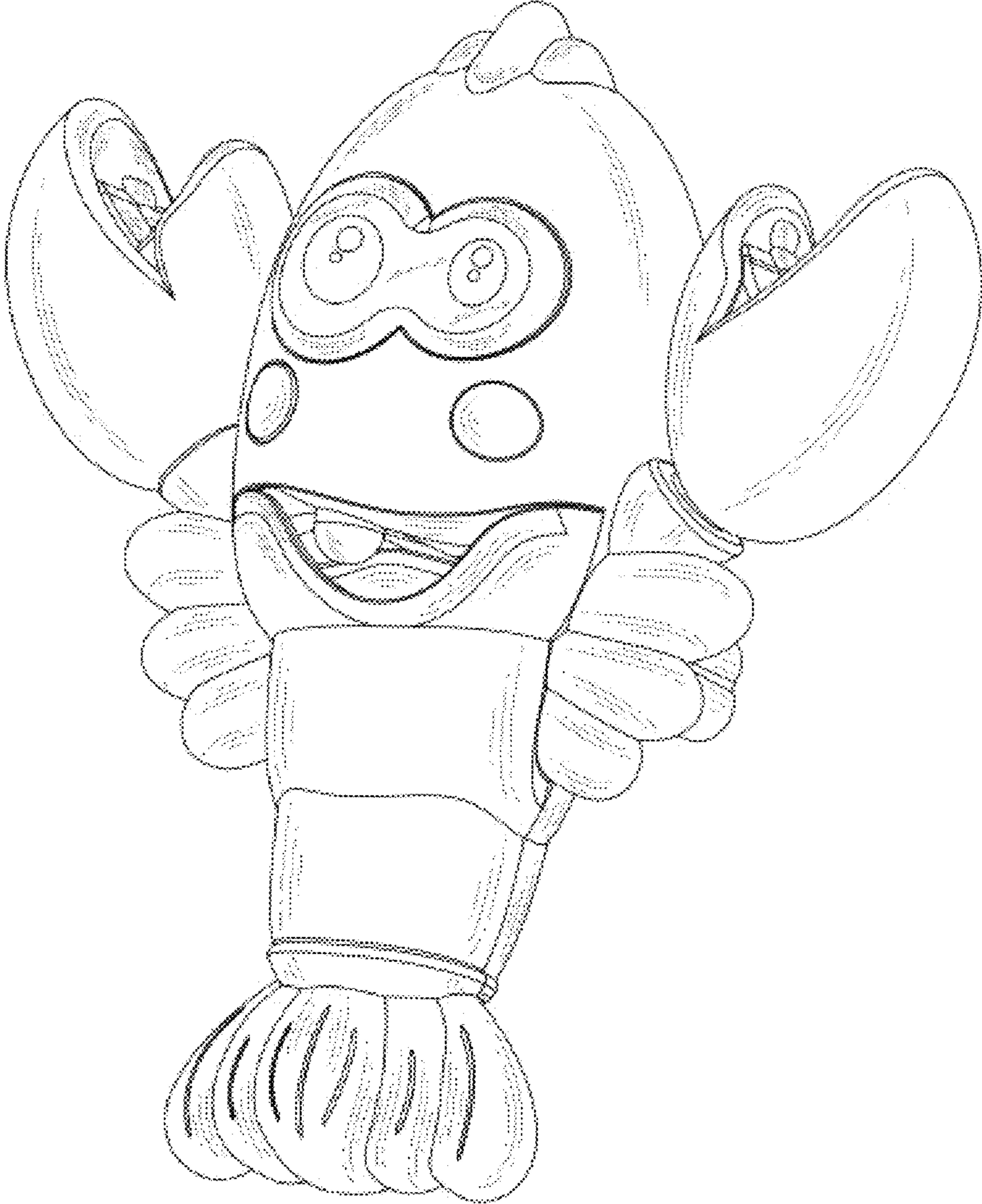

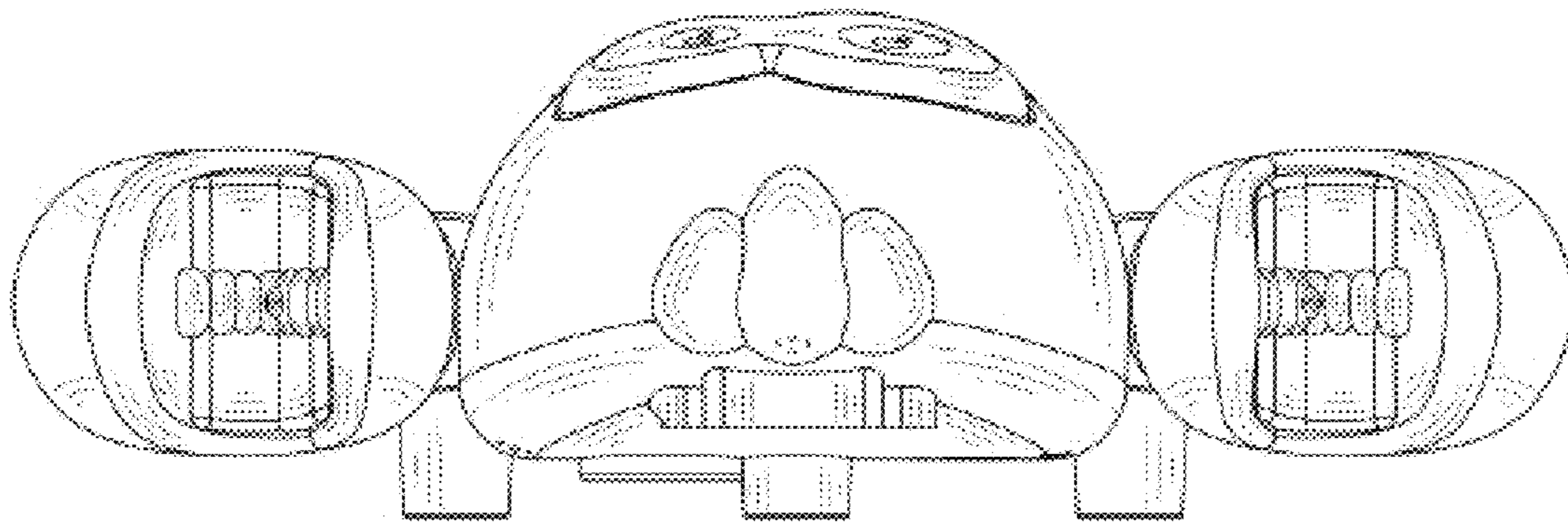

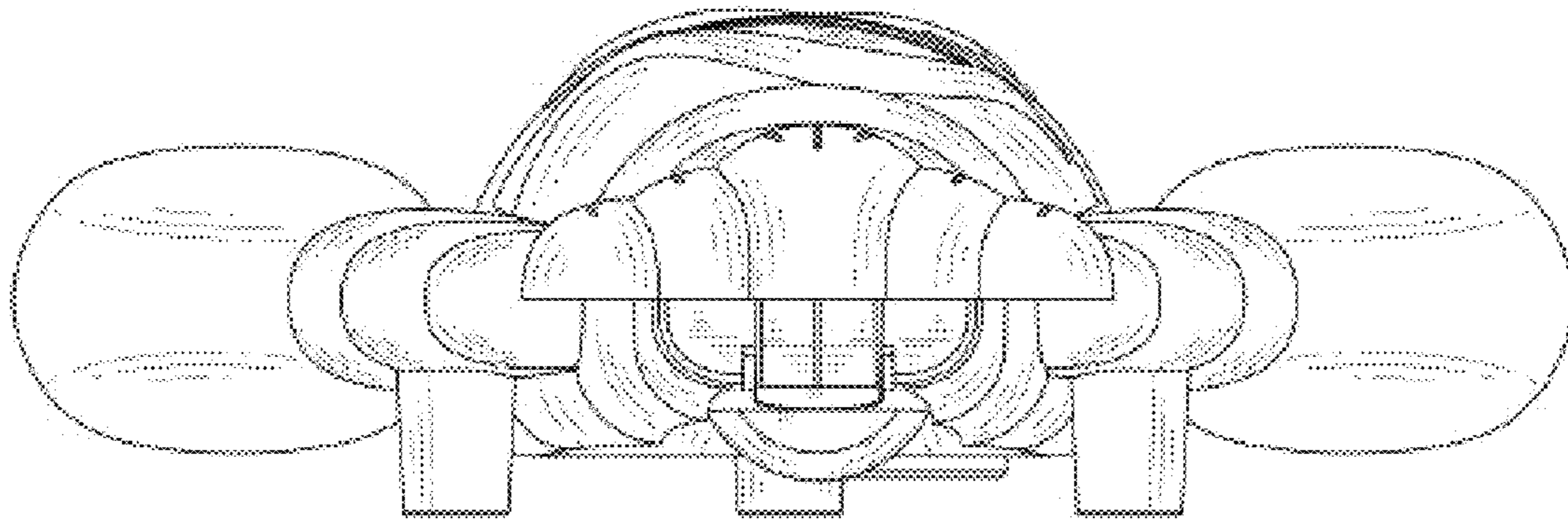

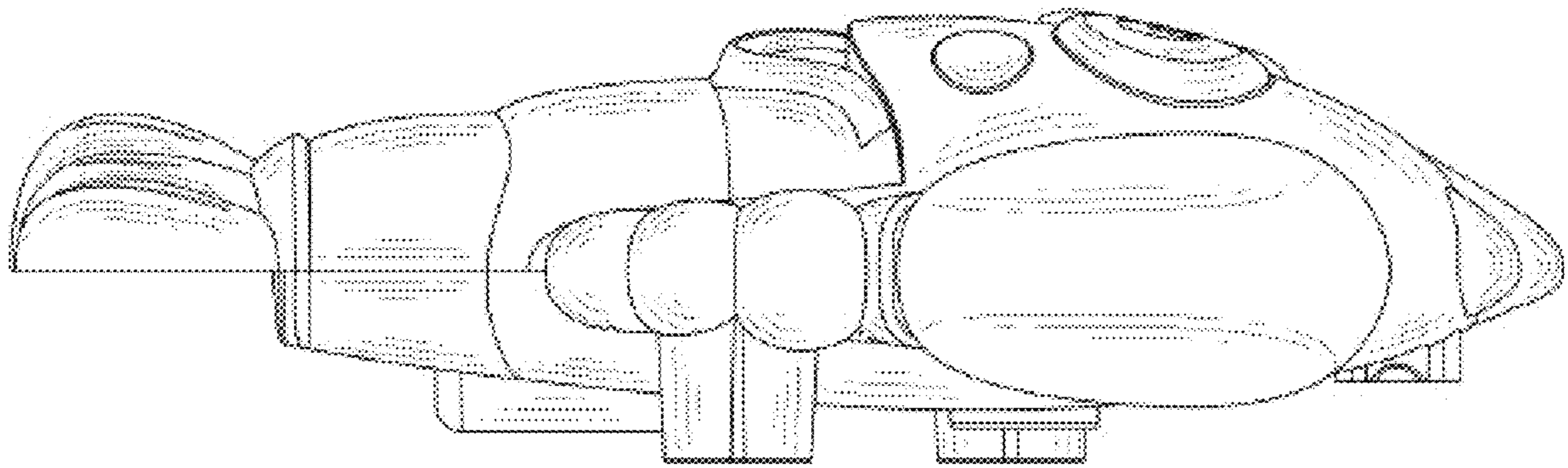

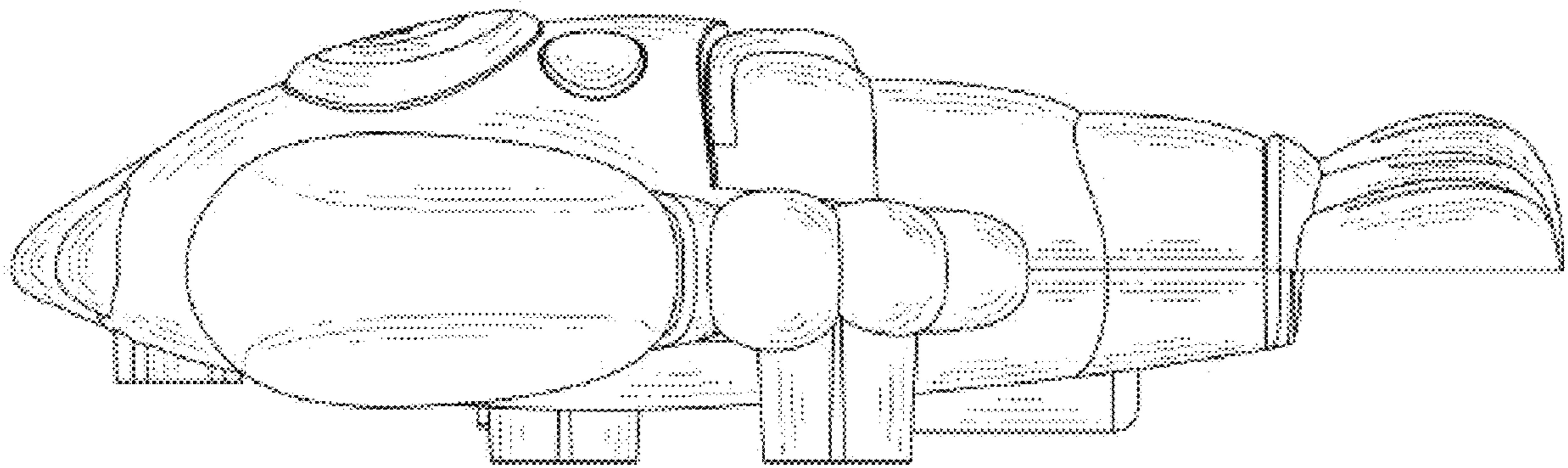

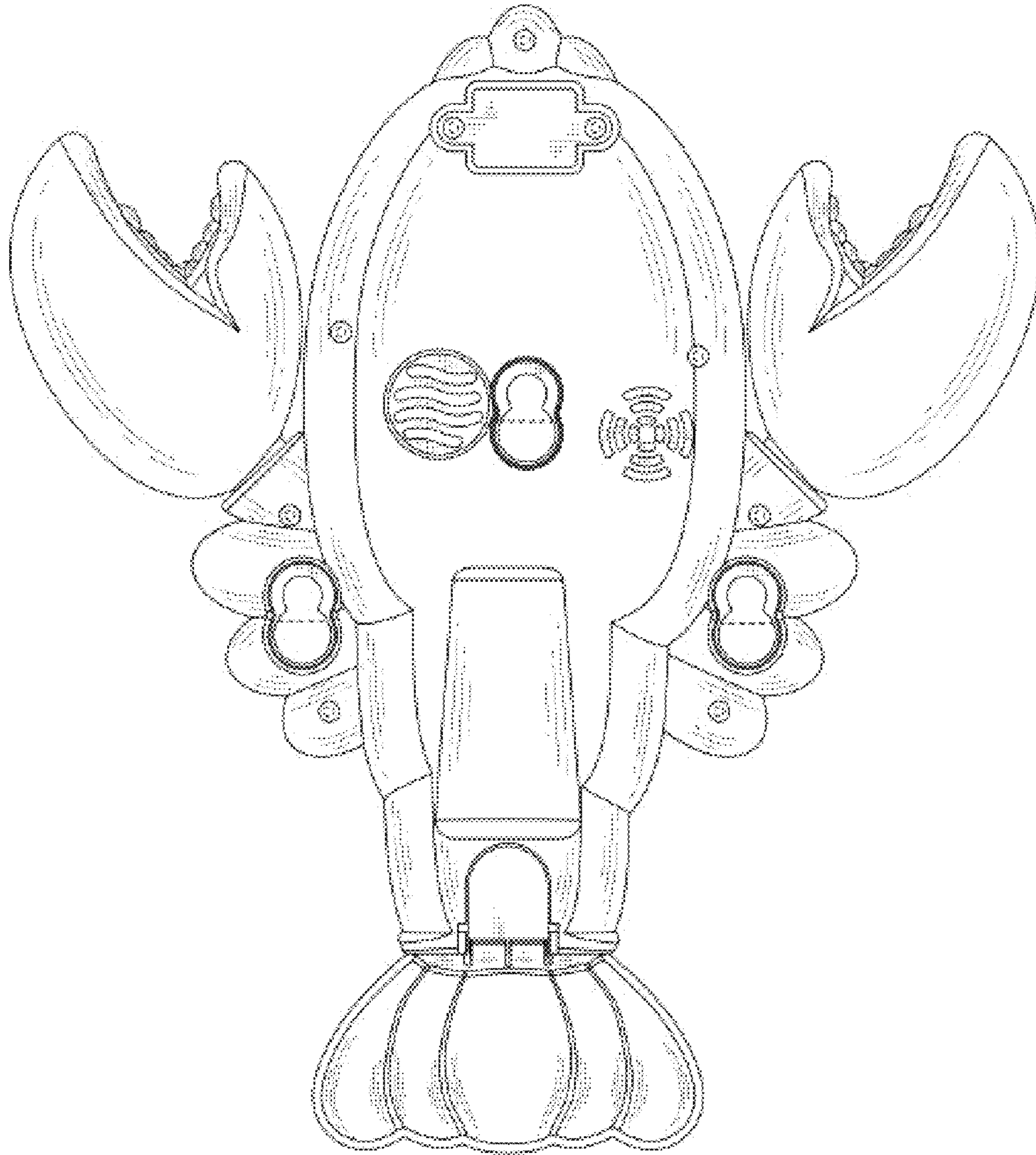

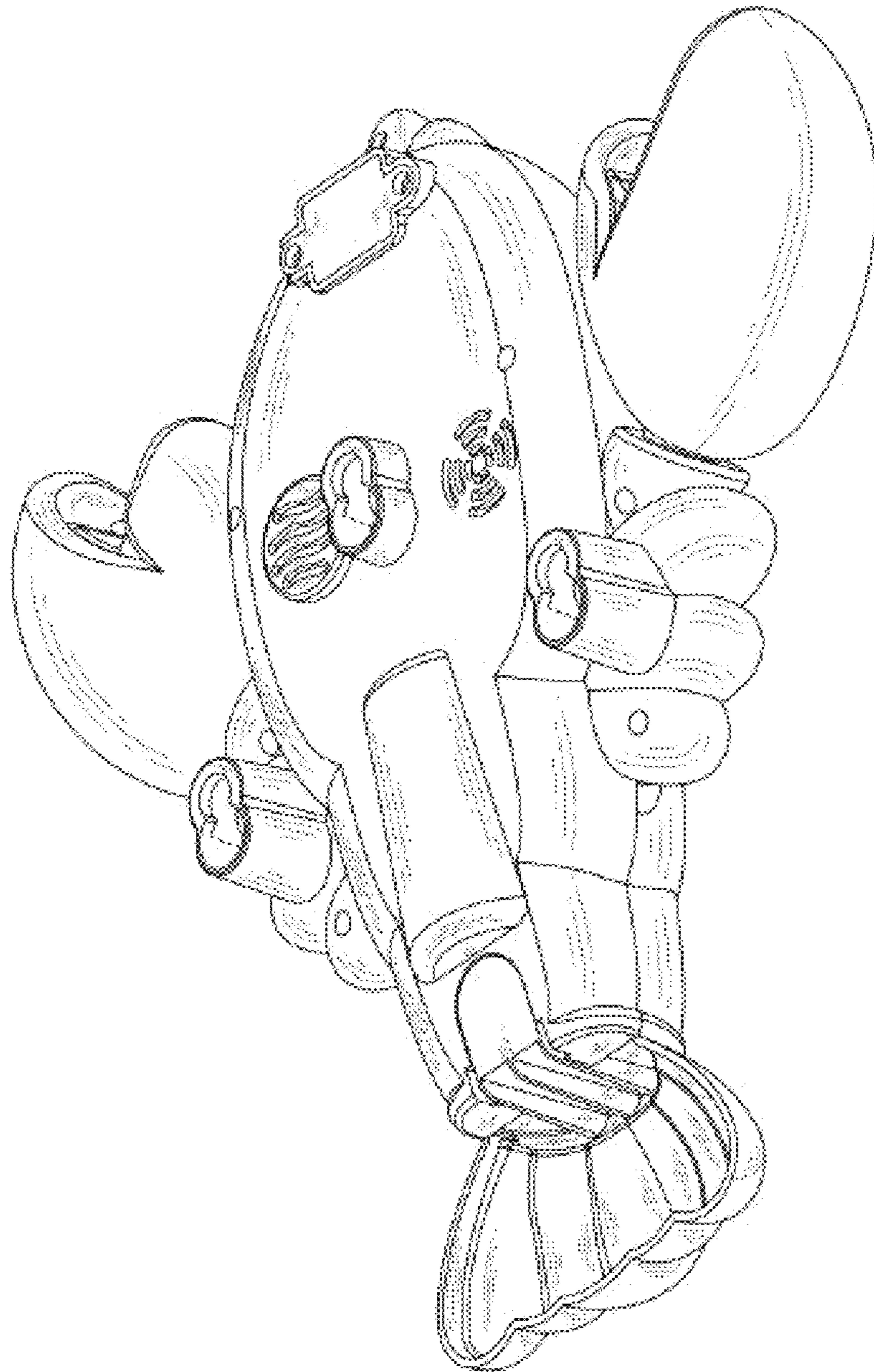
