(57) **CLAIM**

We claim the ornamental design for an ice skate blade holder, as shown and described.

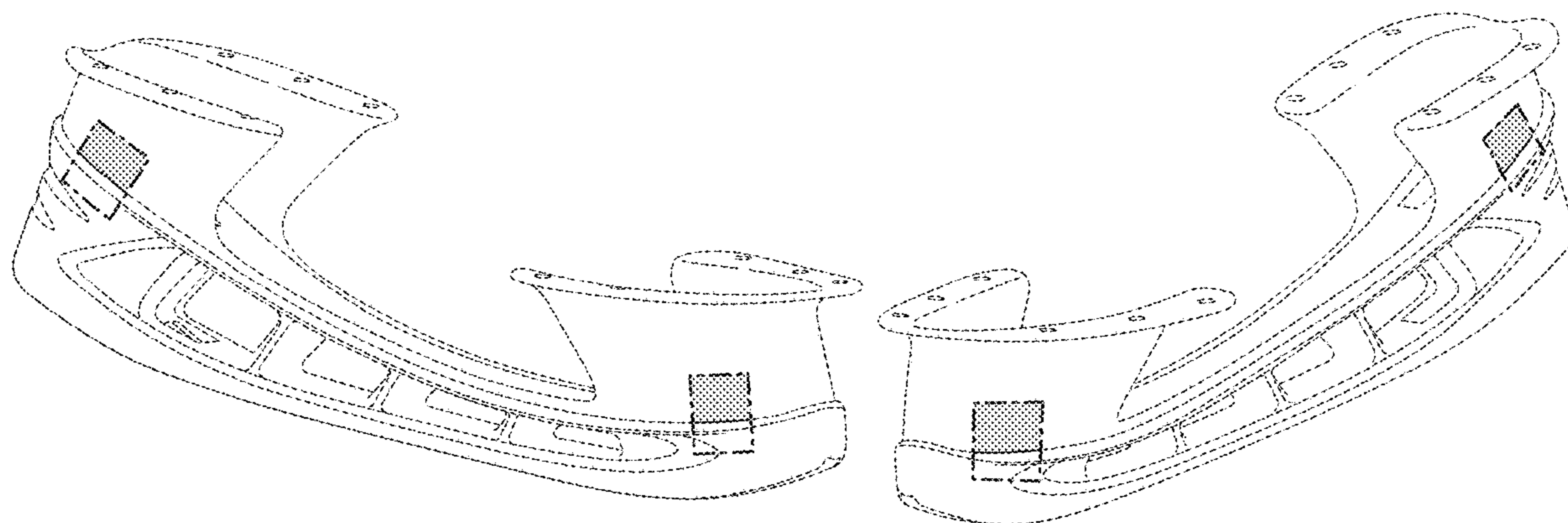
**DESCRIPTION**

FIG. 1 is a lateral side perspective view of an ice skate blade holder according to an embodiment of the present design; FIG. 2 is a medial side perspective view of the ice skate blade holder of FIG. 1; FIG. 3 is a lateral side elevation view of the ice skate blade holder of FIG. 1; FIG. 4 is a medial side elevation view of the ice skate blade holder of FIG. 1; FIG. 5 is a top plan view of the ice skate blade holder of FIG. 1; FIG. 6 is a bottom plan view of the ice skate blade holder of FIG. 1; FIG. 7 is a front elevation view of the ice skate blade holder of FIG. 1; and, FIG. 8 is a rear elevation view of the ice skate blade holder of FIG. 1.

Areas in contrasting colors represent areas of the ice skate blade holder that are coloured differently. Any suitable color may be used in each of these areas, including: white, black, and gray, which are considered colors herein; red, blue, yellow, etc.; and any shade thereof.

The broken lines represent portions of the ice skate blade holder and boundaries of the claimed design and form no part of the claimed design.

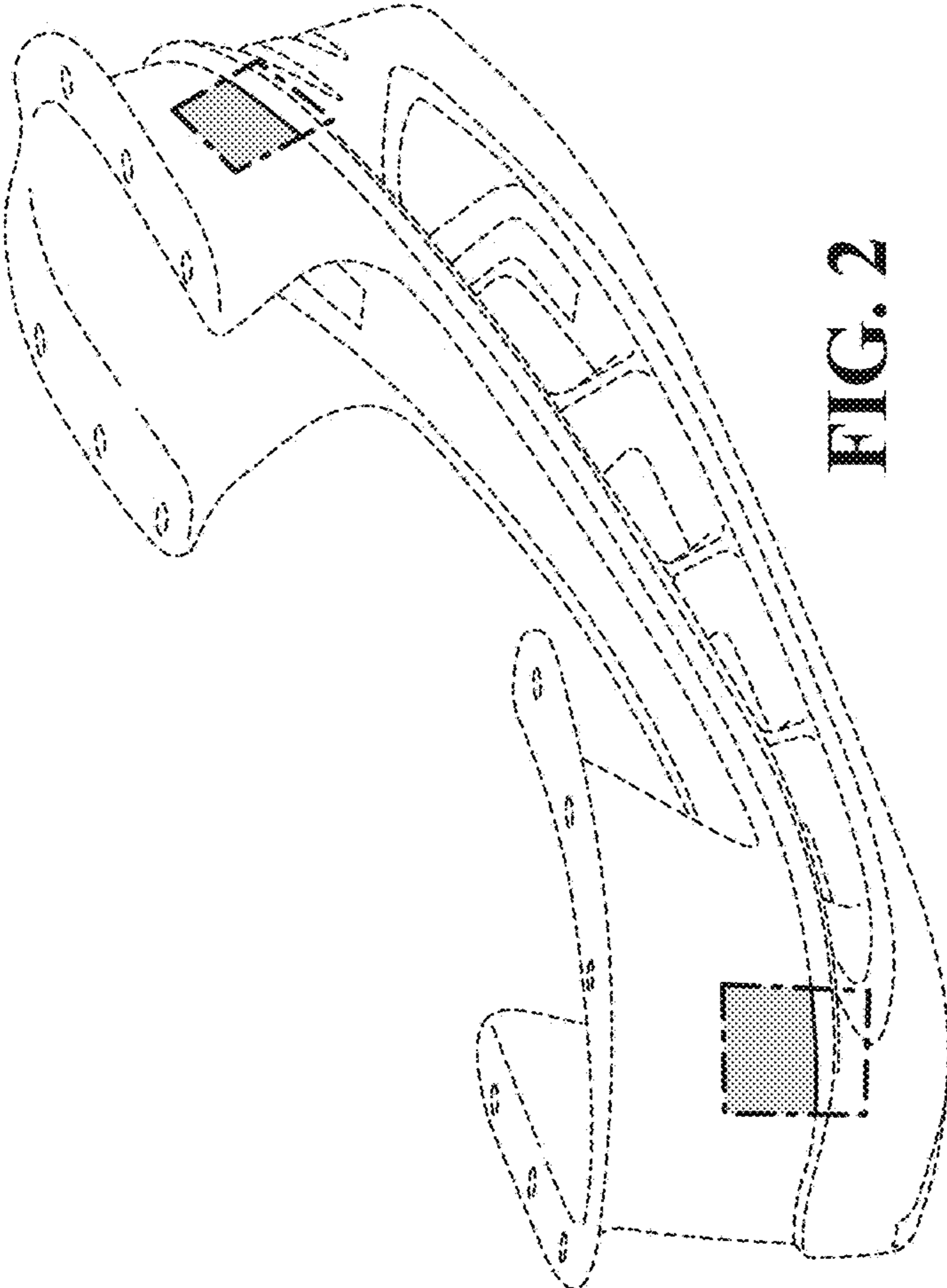

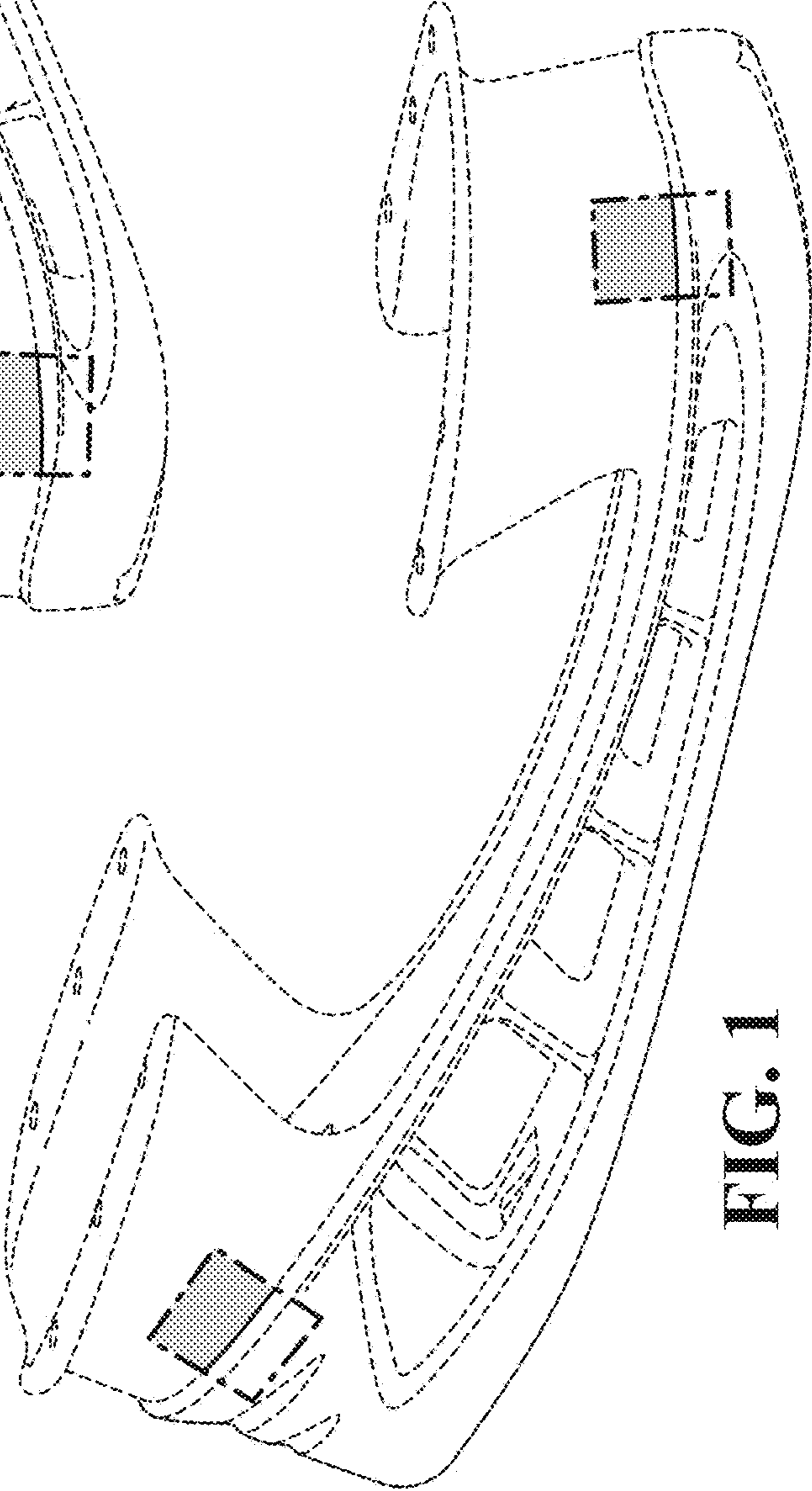

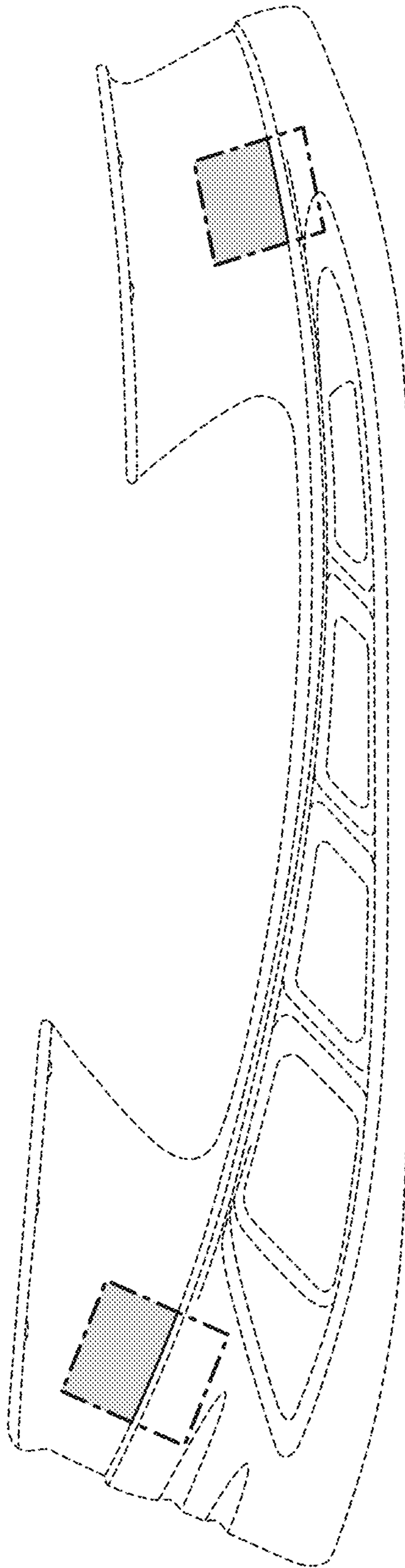

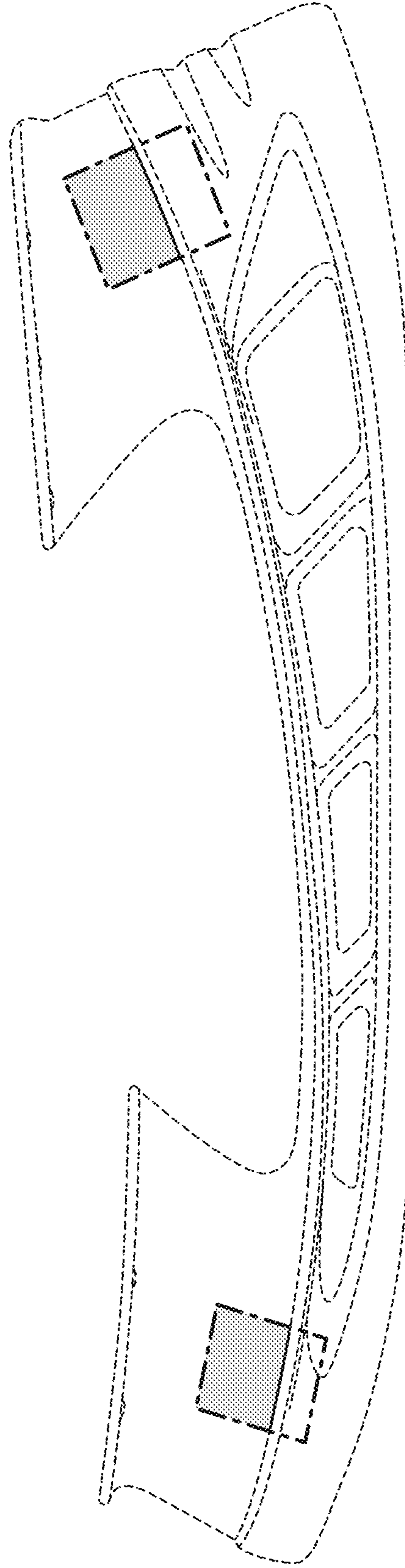

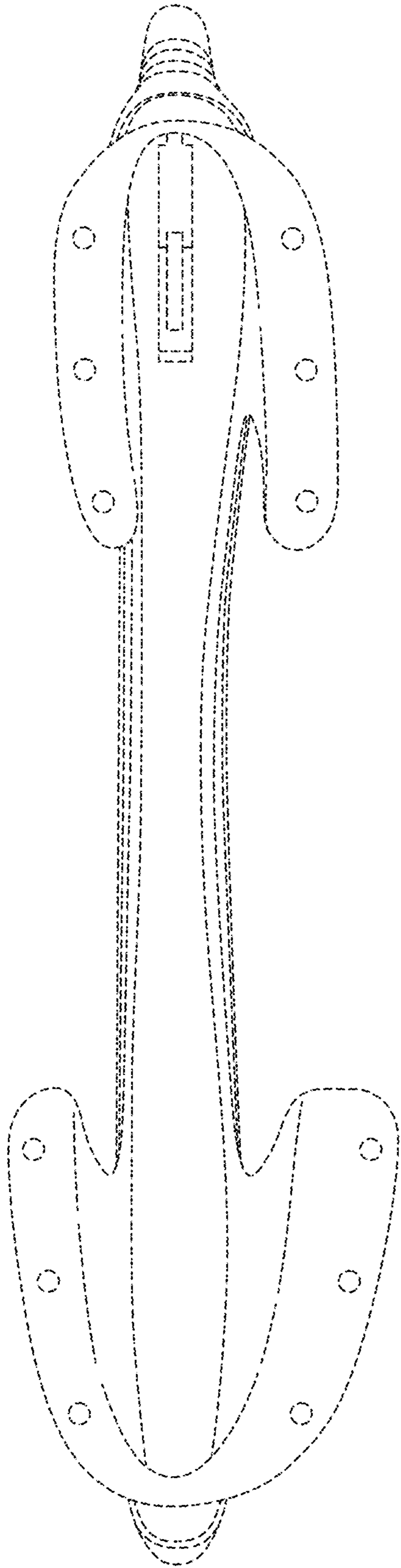

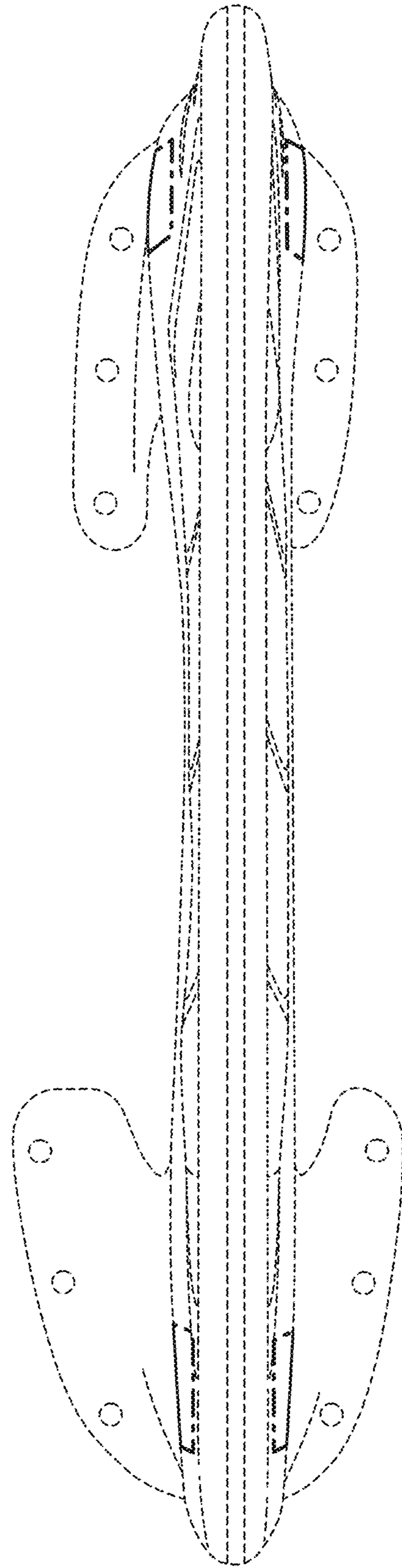

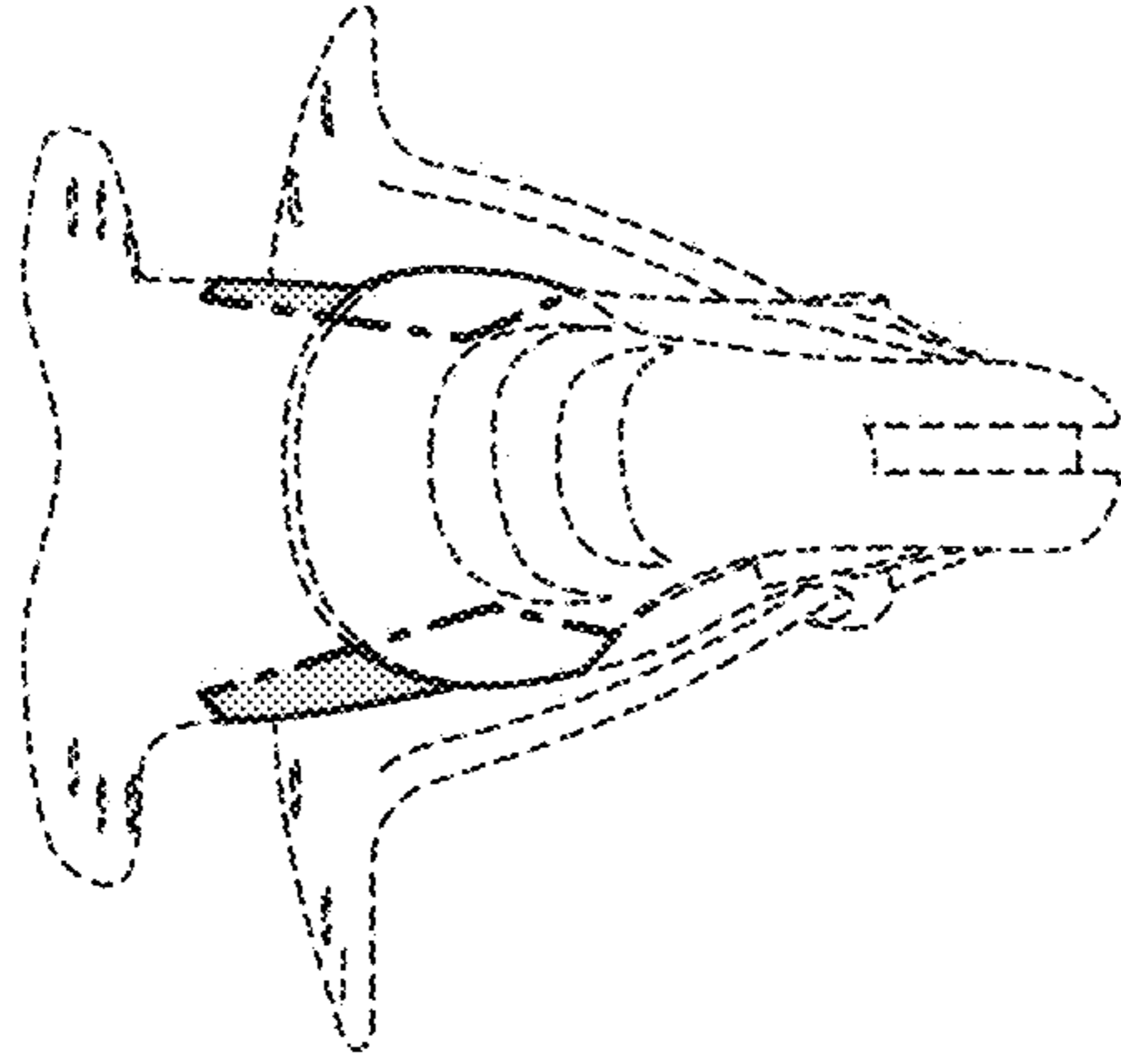

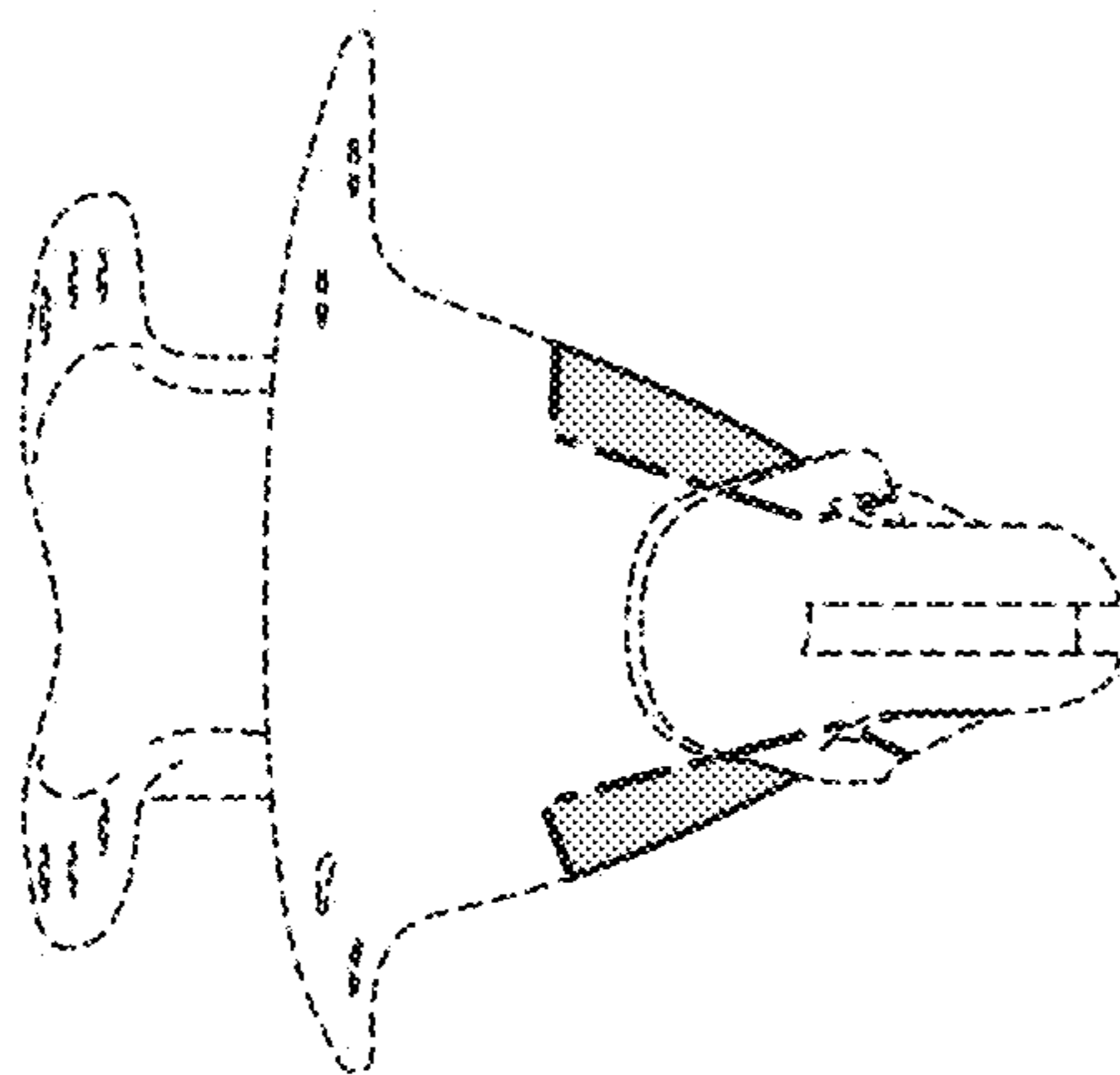
