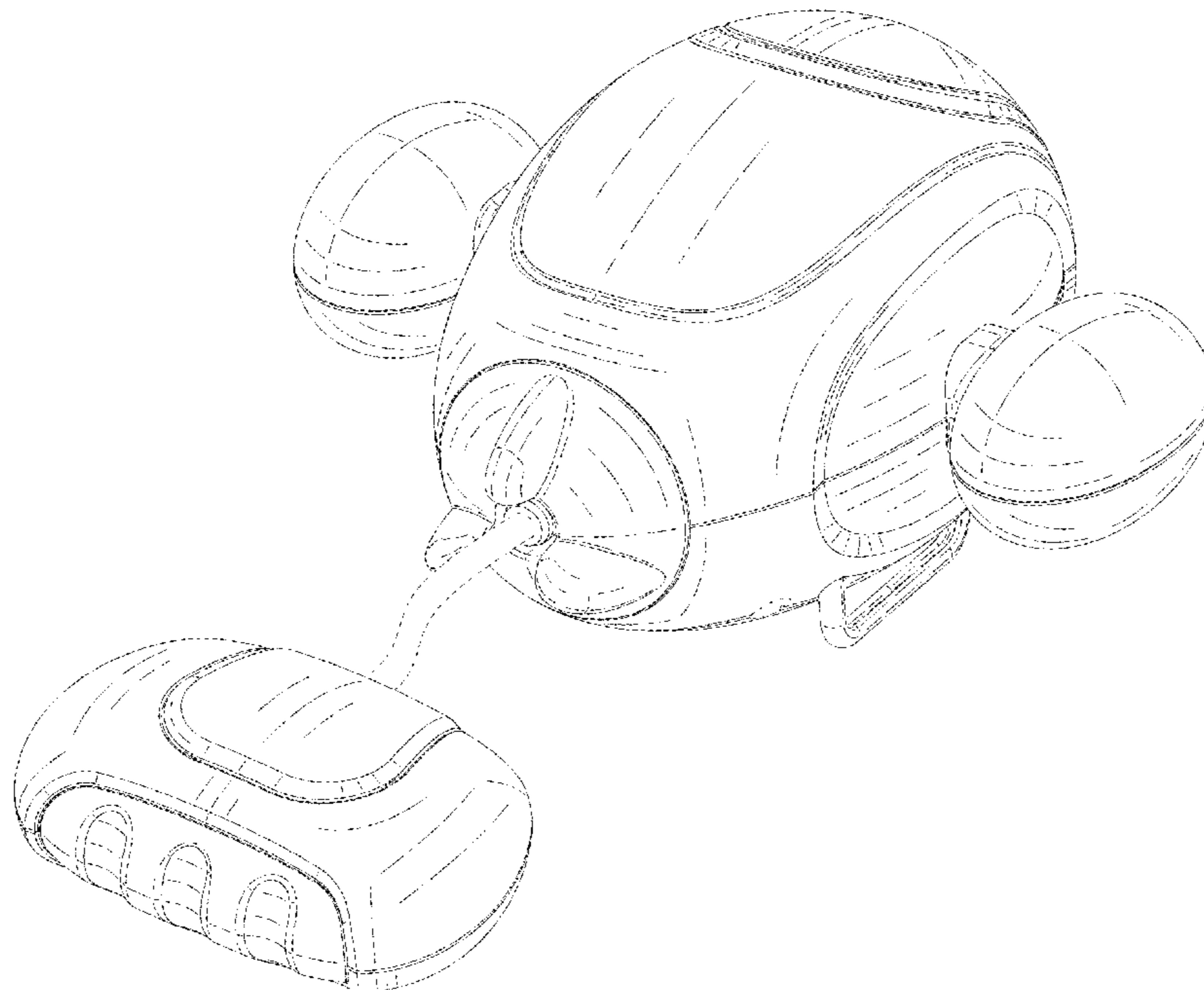
(57) **CLAIM**

The ornamental design for a water spray-type toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a water spray-type toy shown assembled;  
FIG. 2 is a front elevation perspective view of the first part of a water spray-type toy;  
FIG. 3 is a back elevation view thereof;

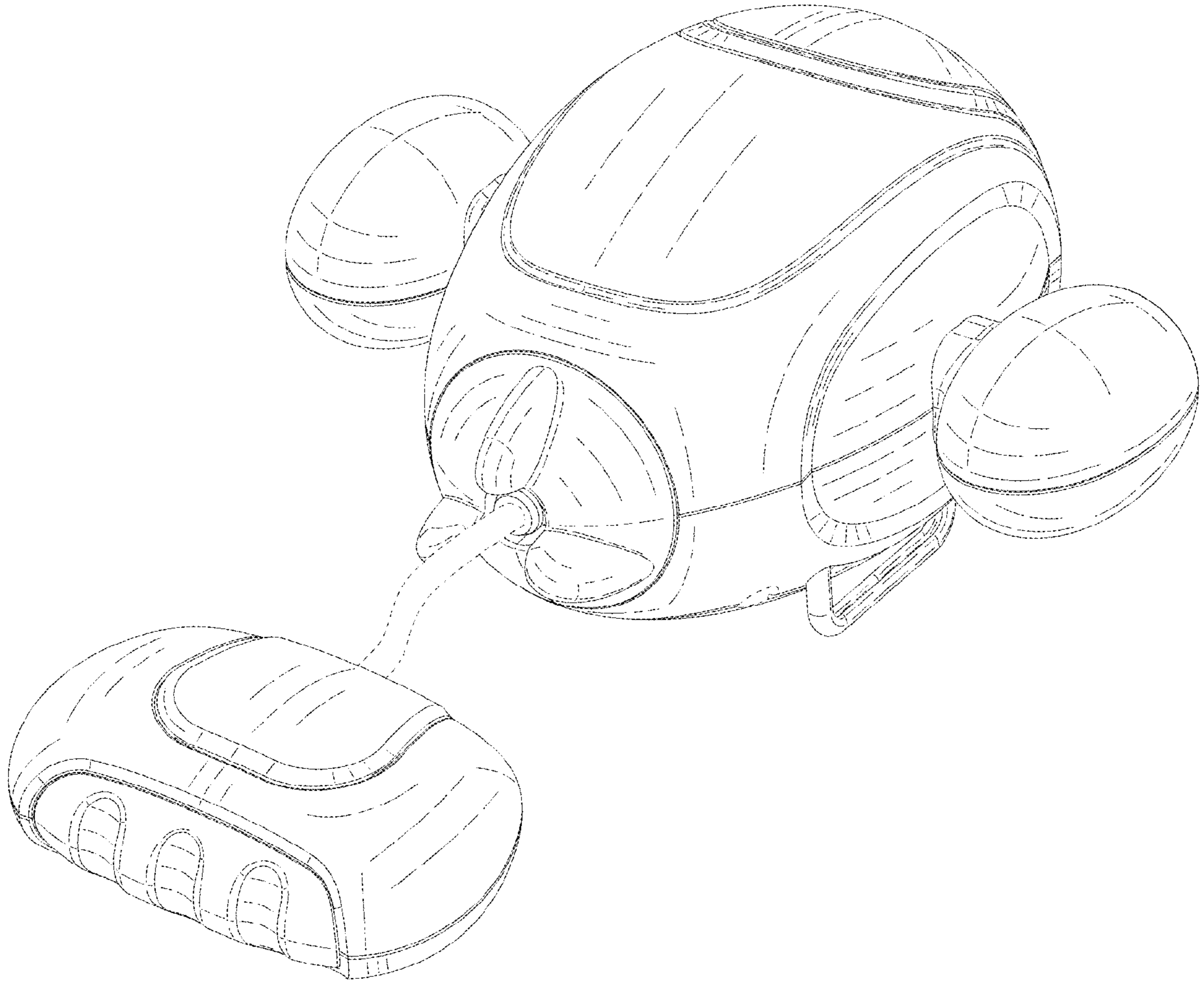

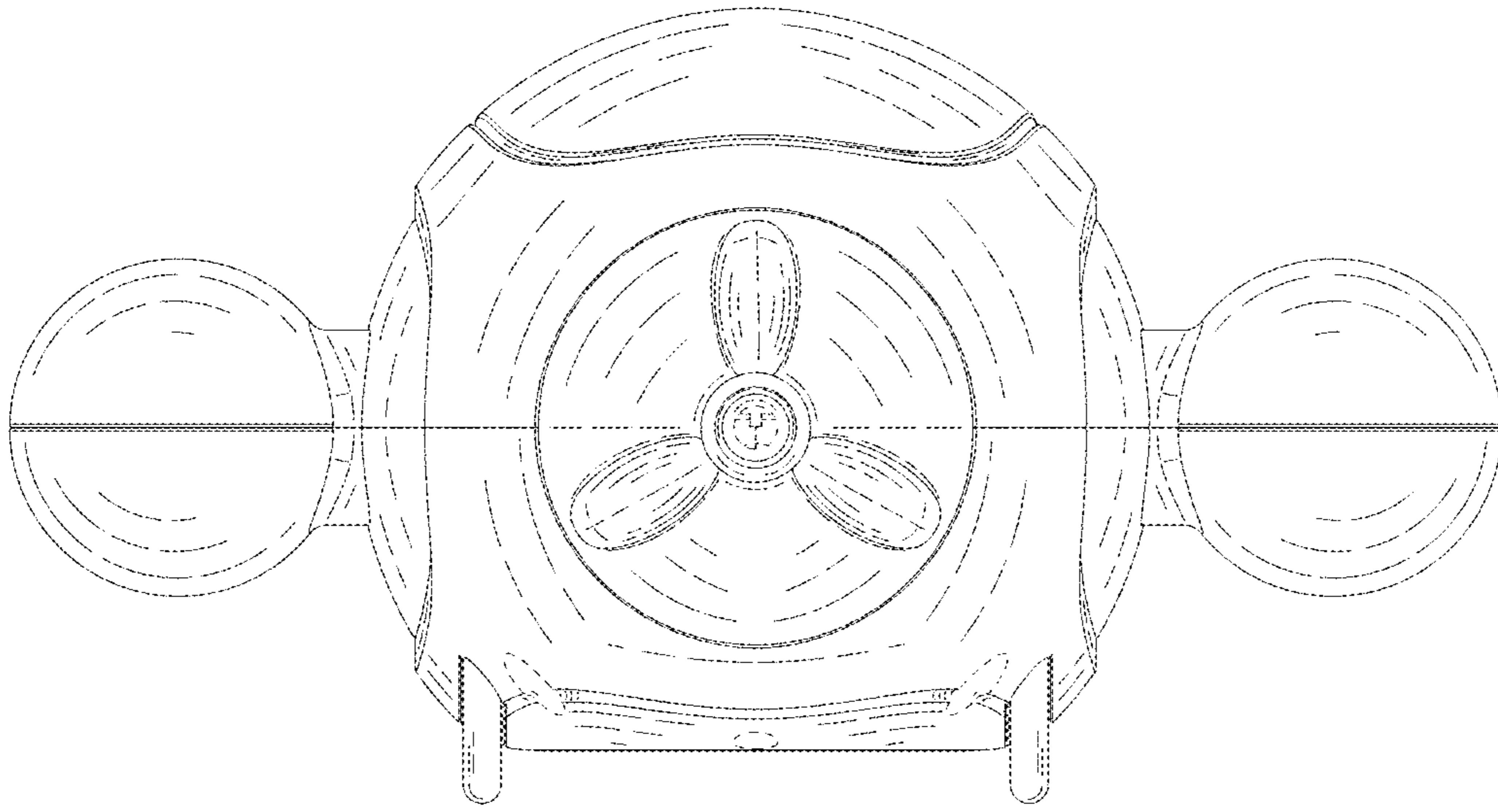

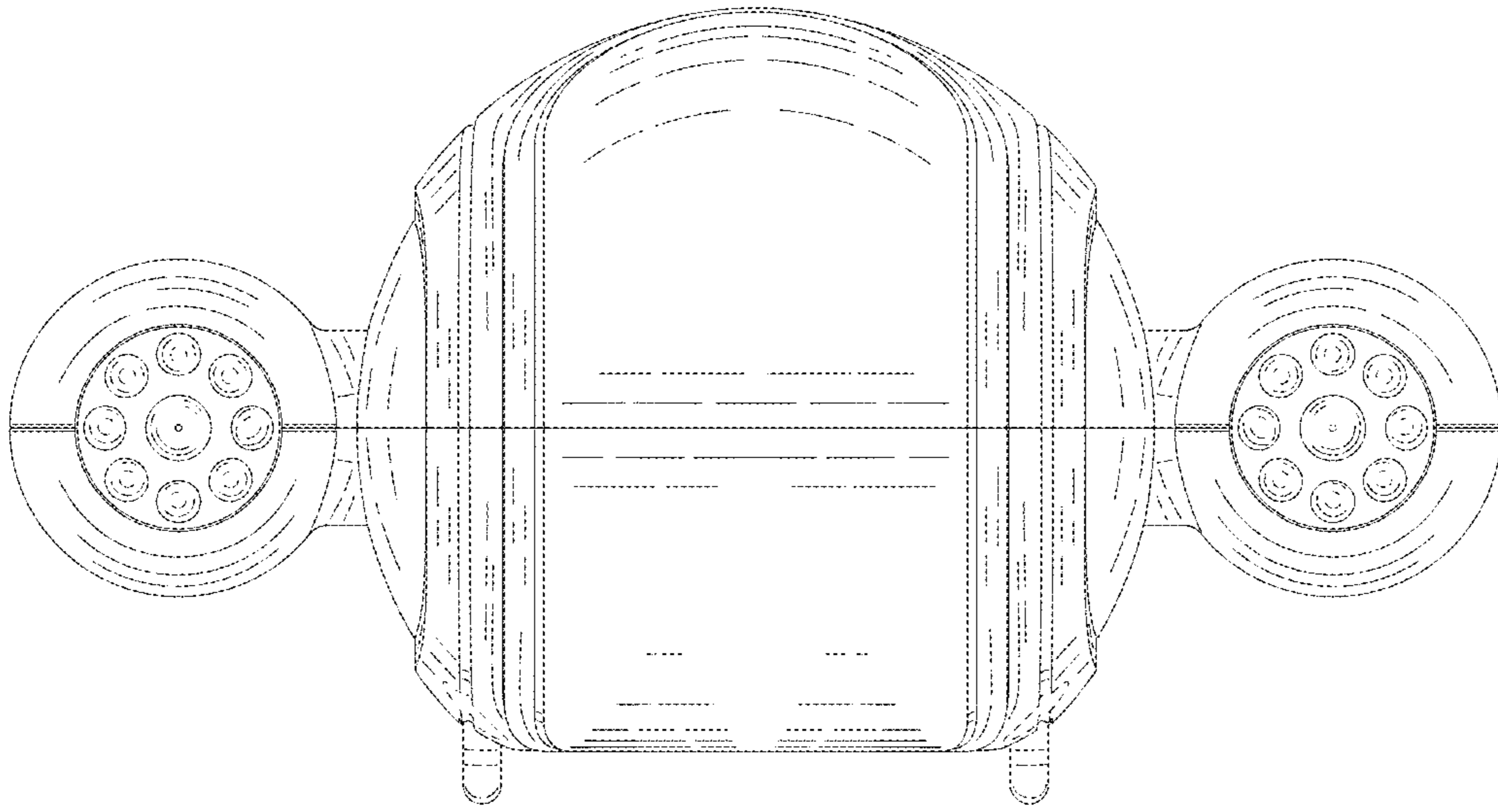

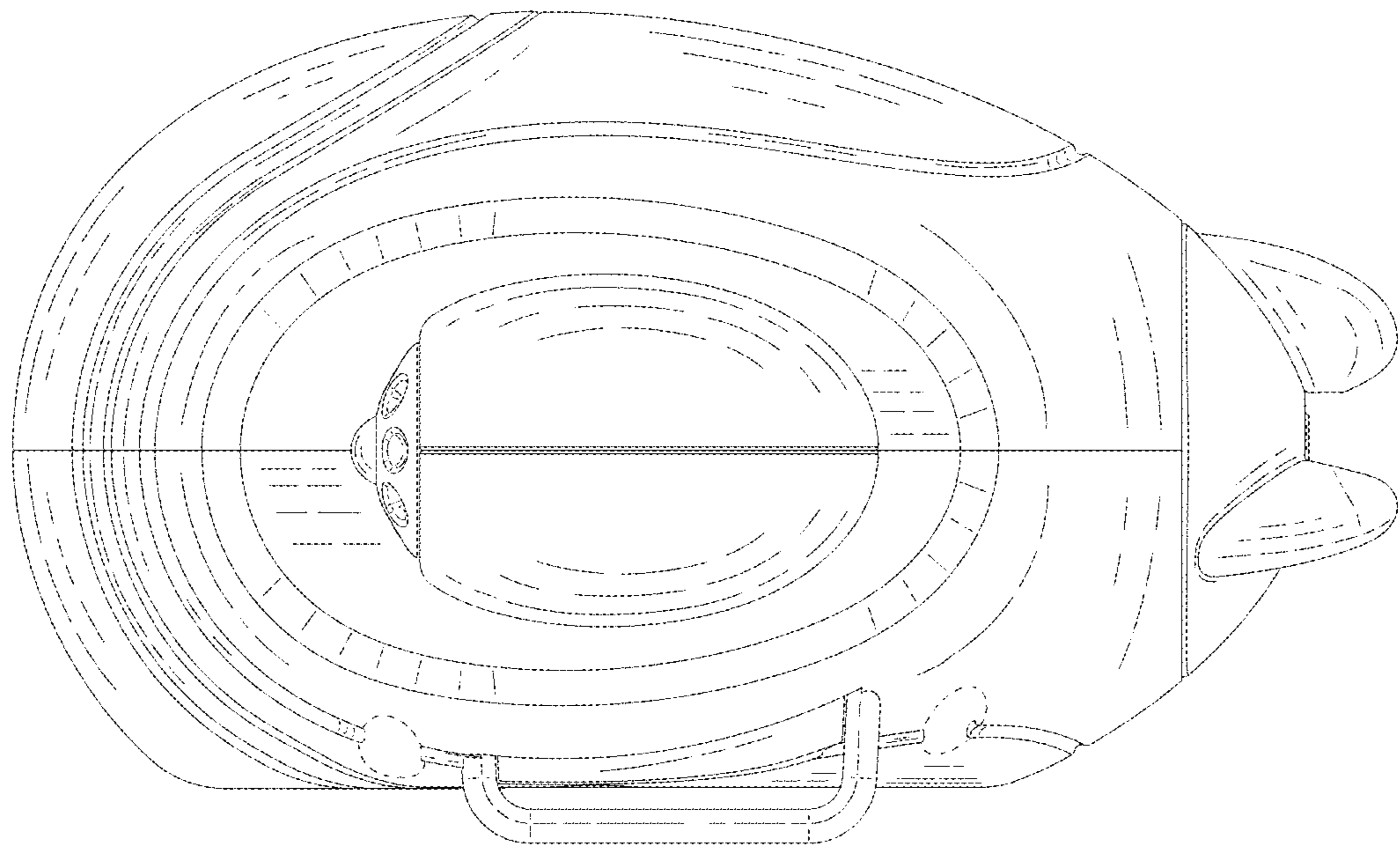

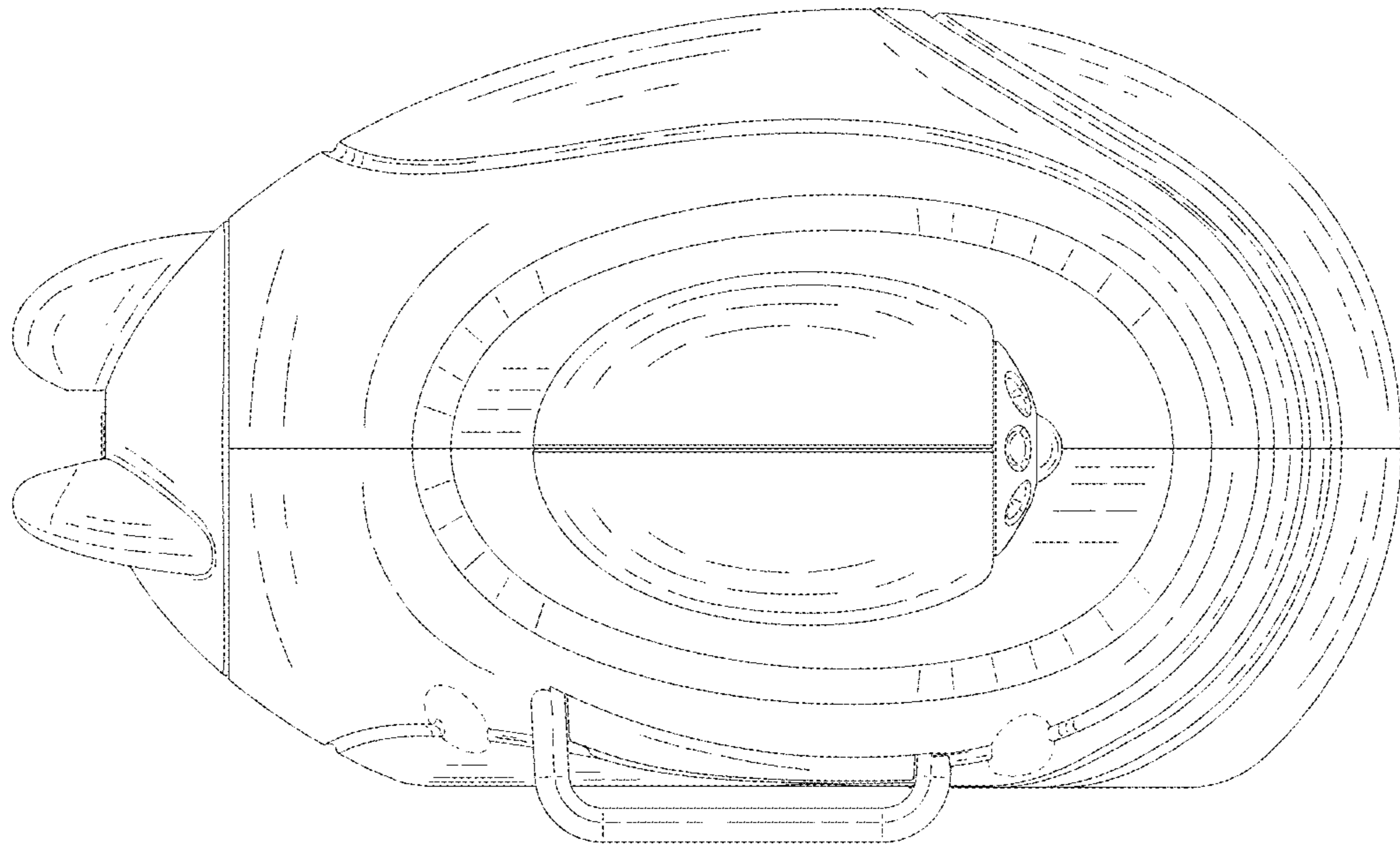

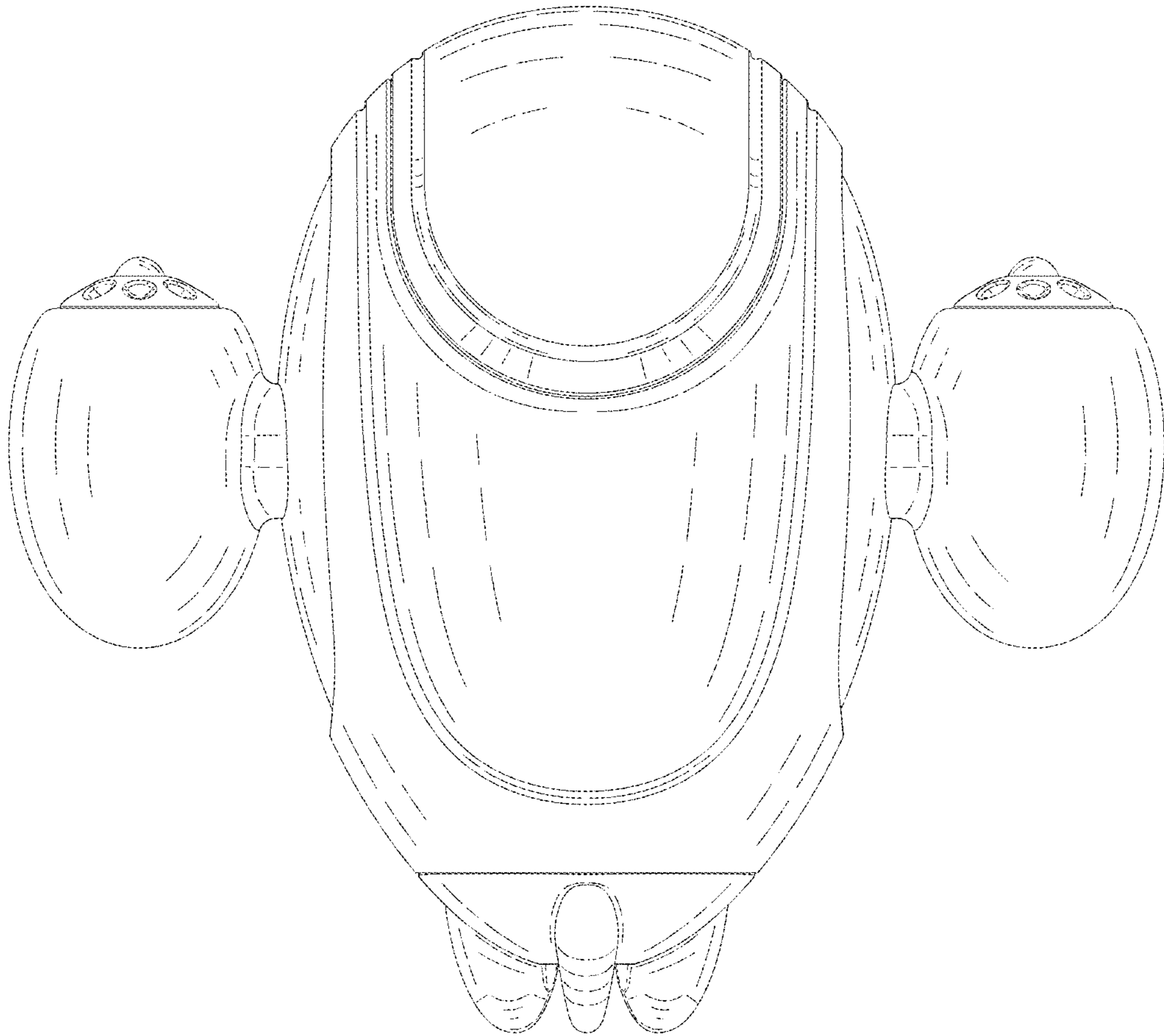

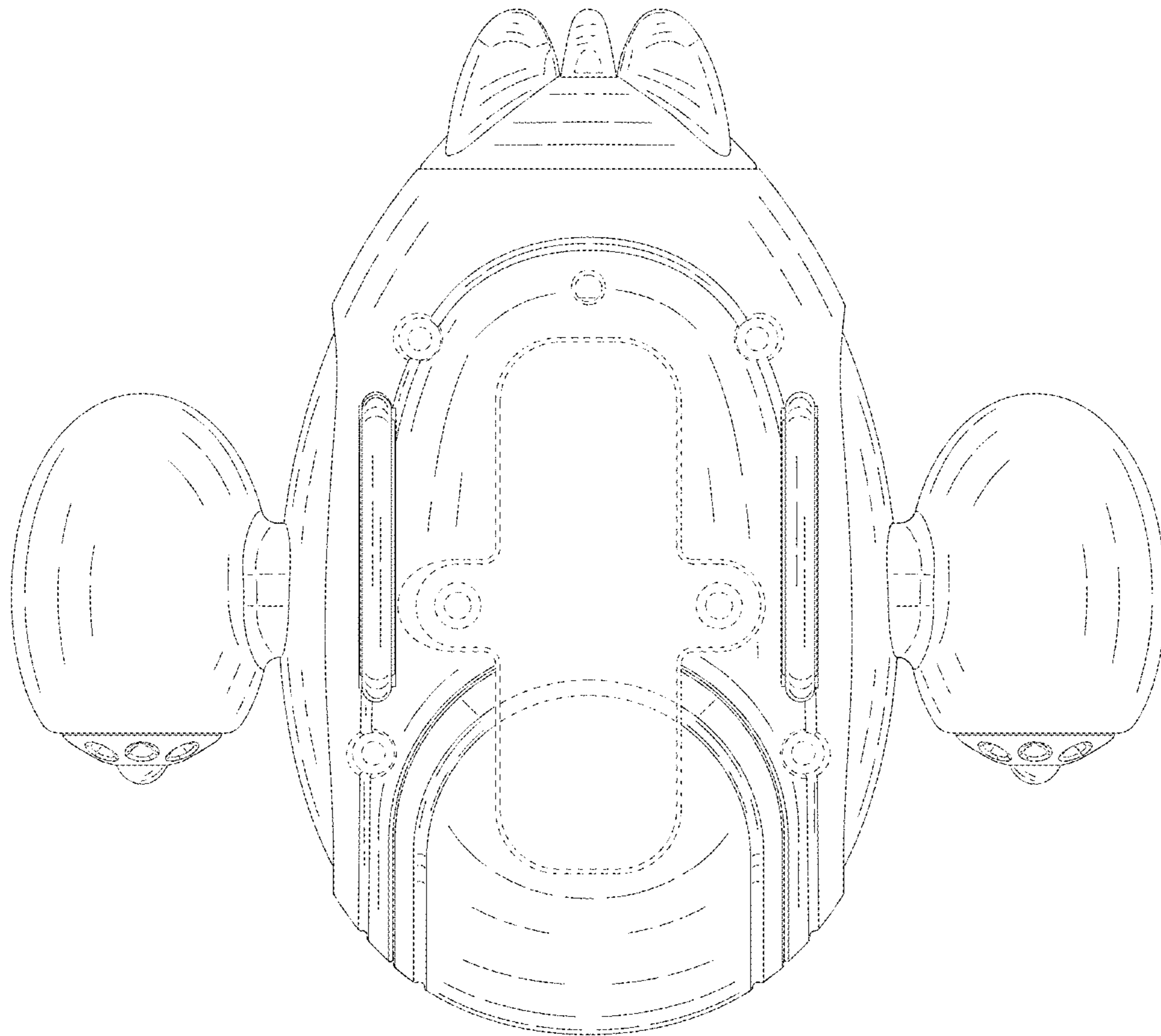

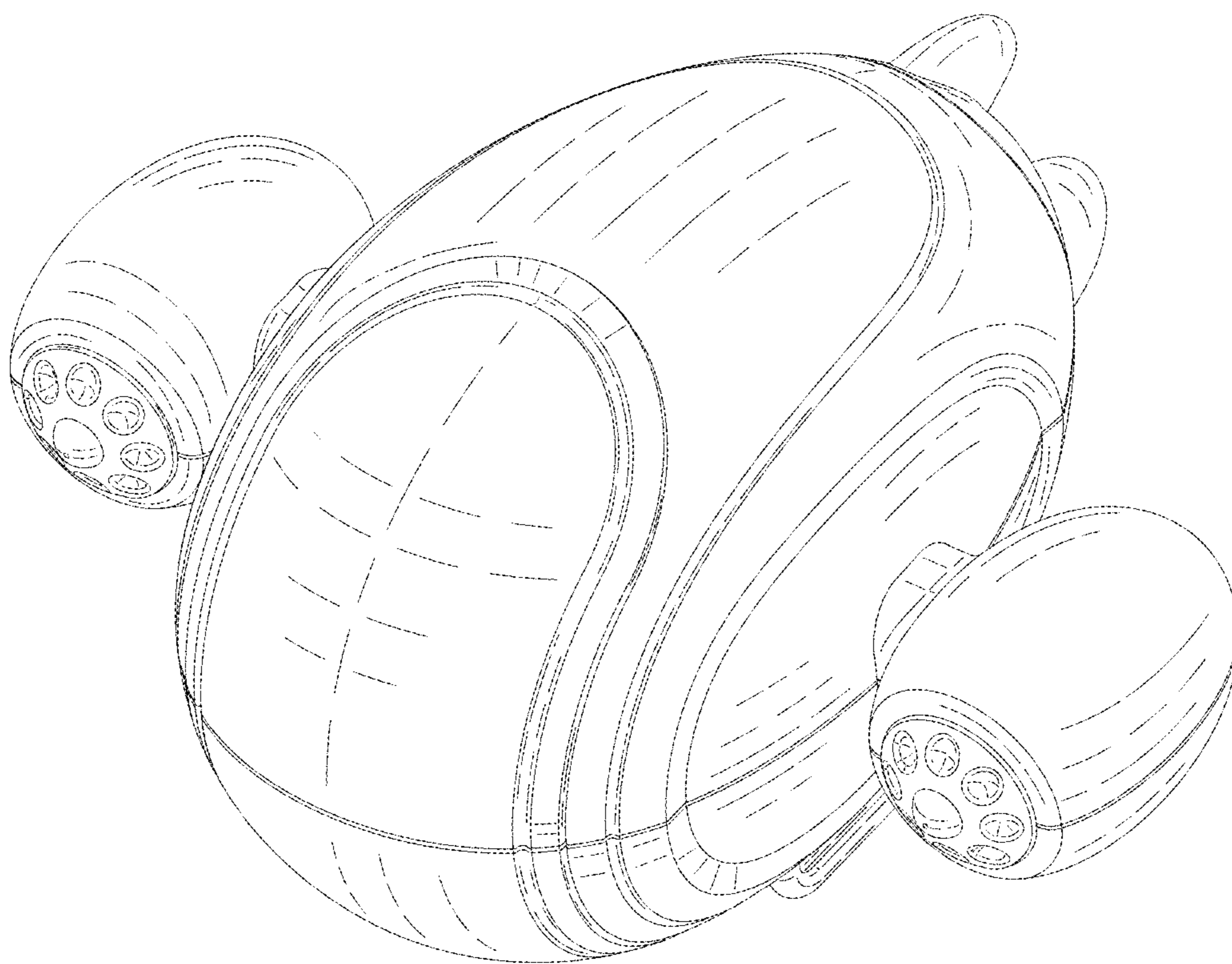

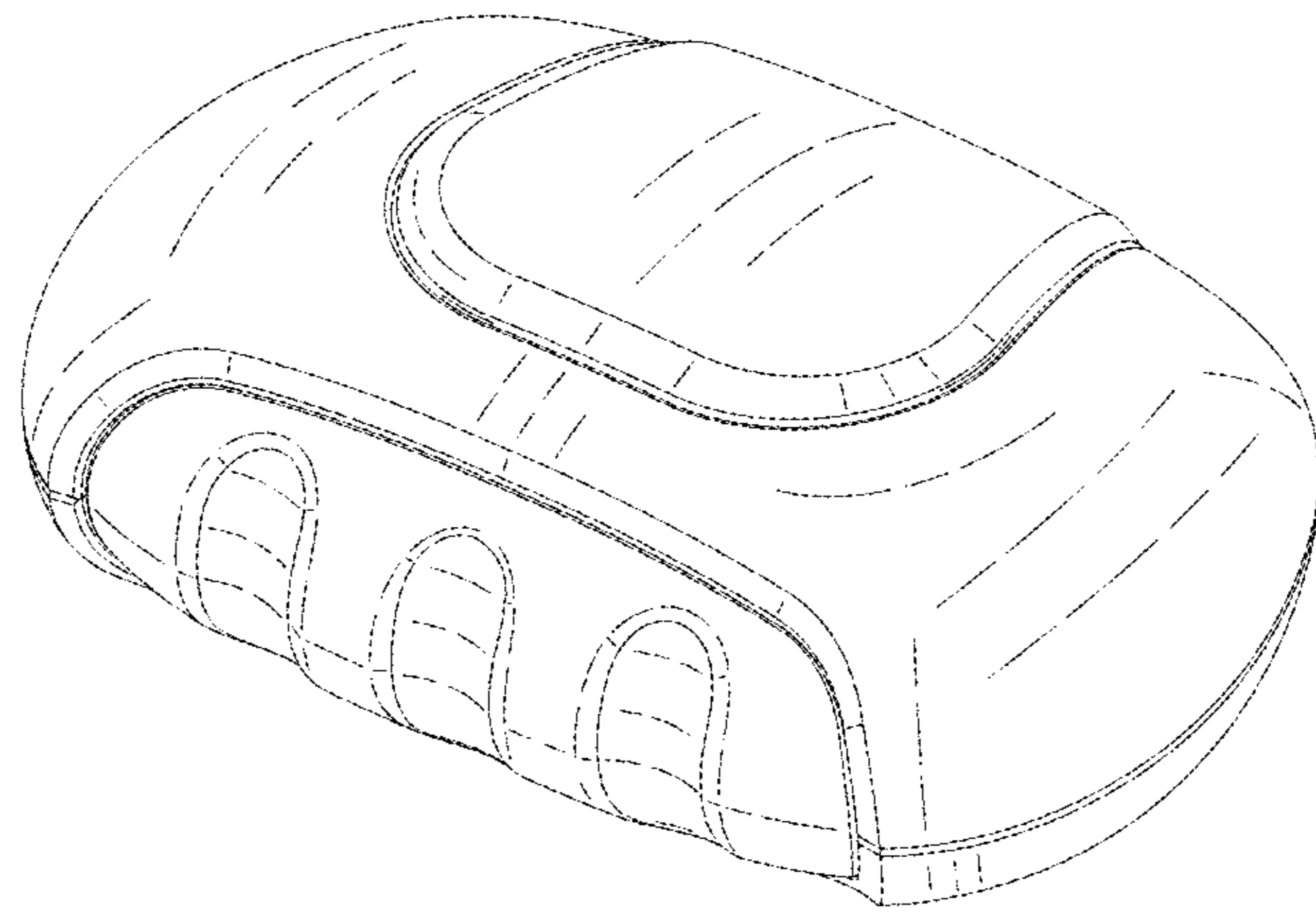

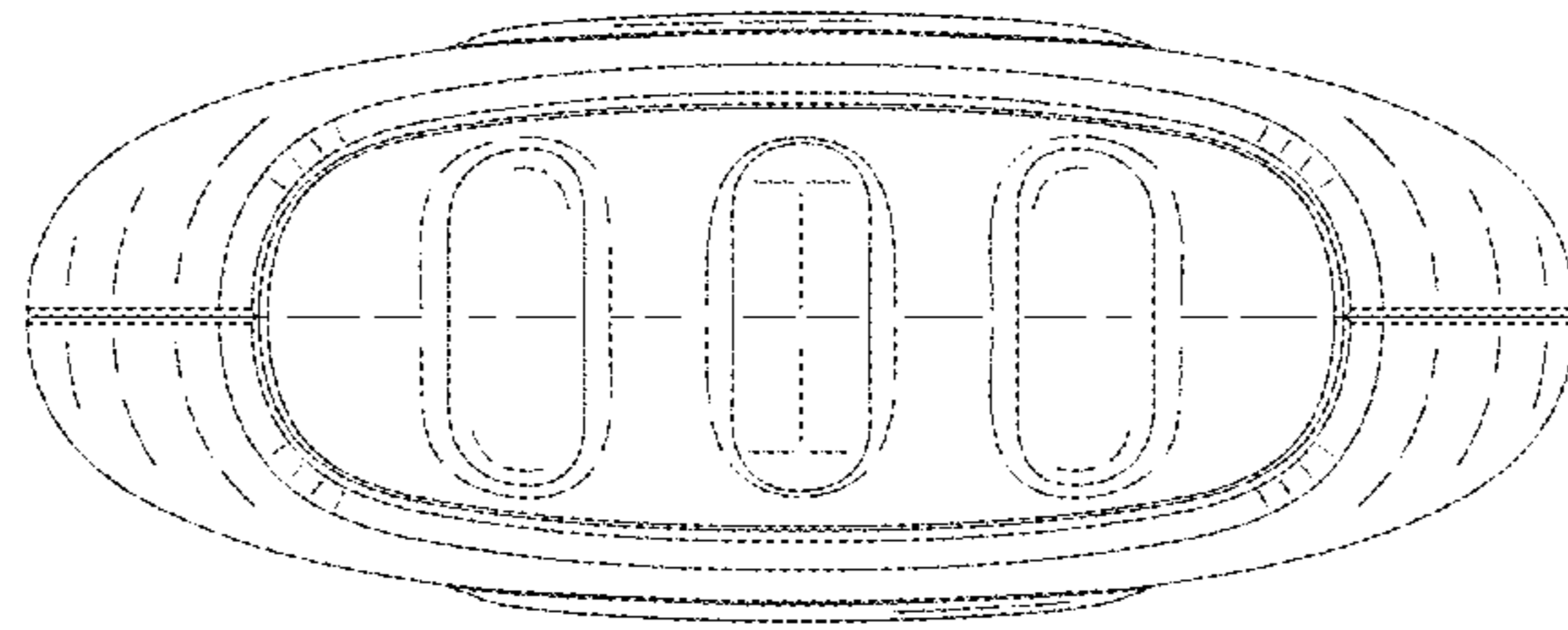

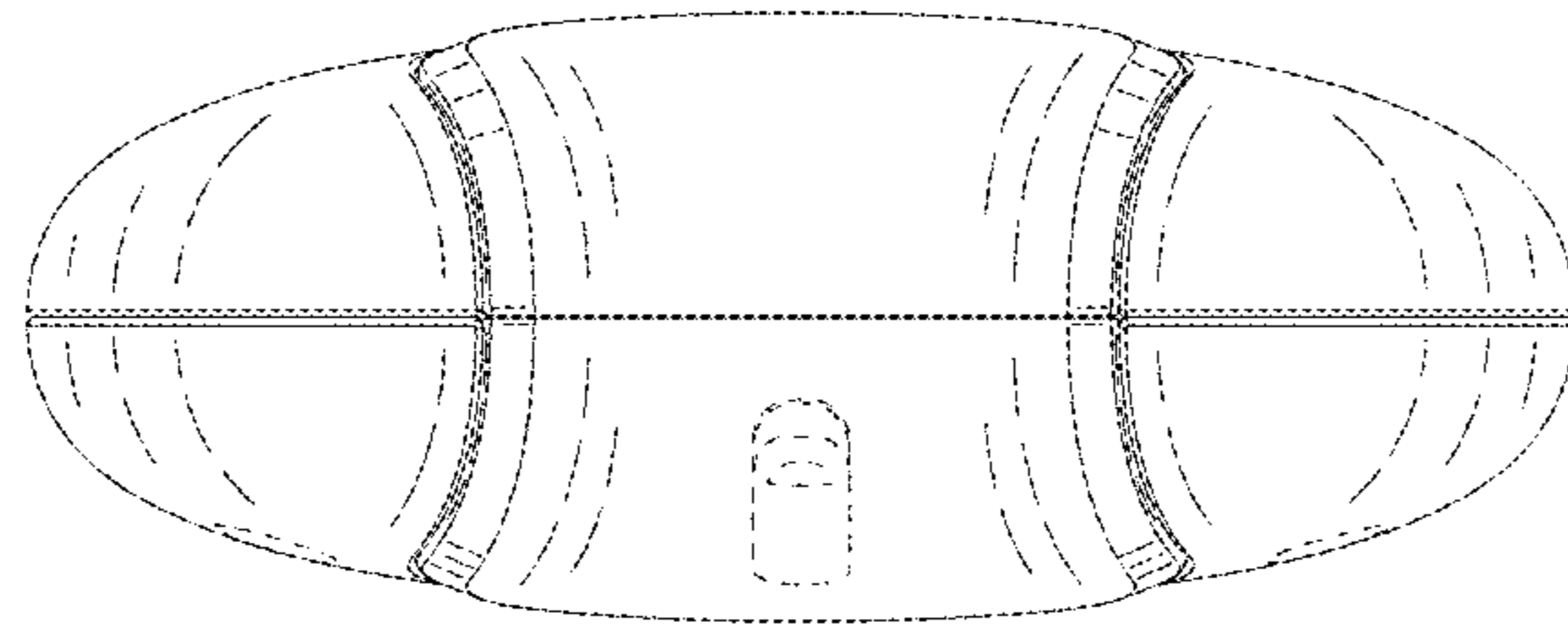

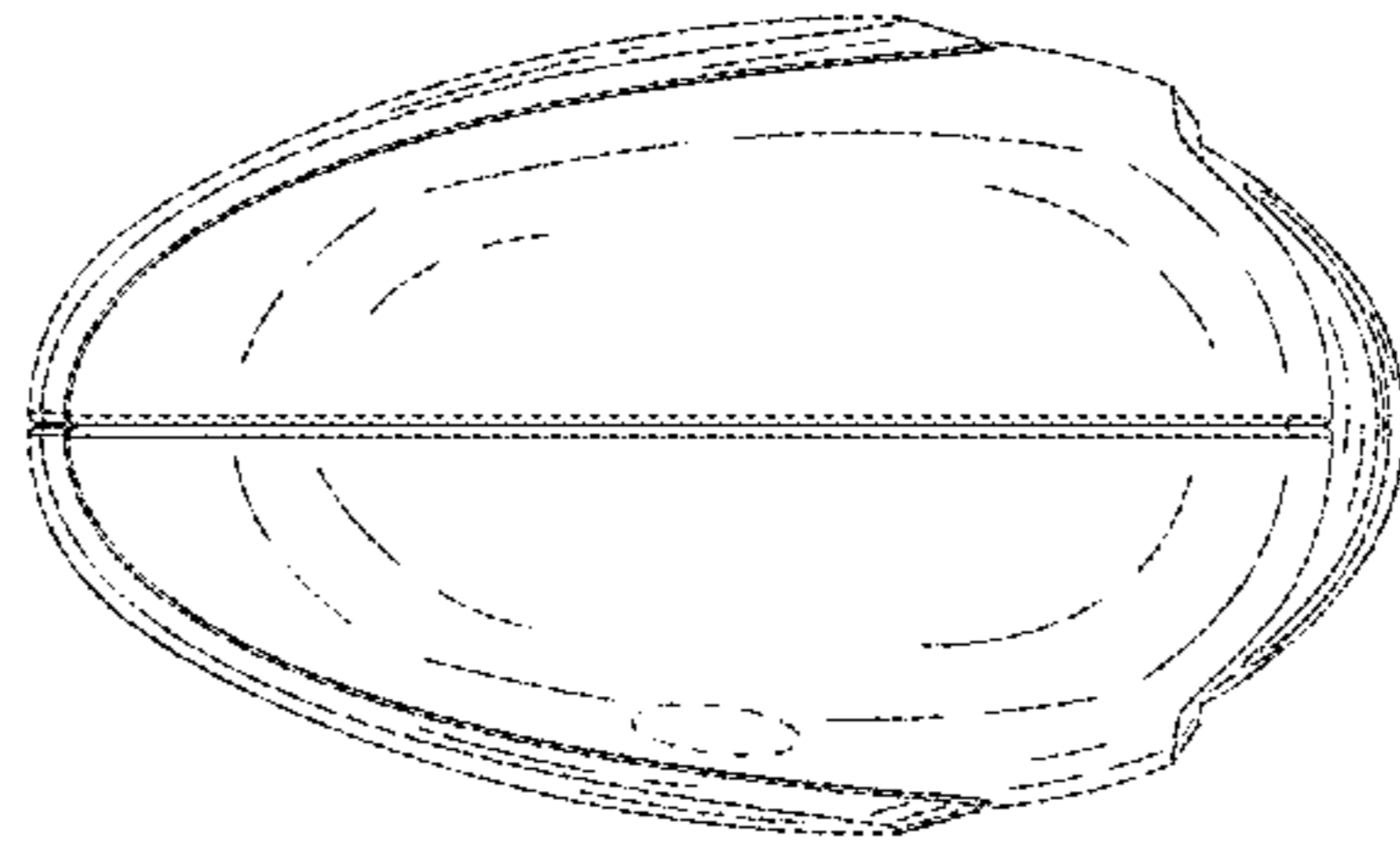

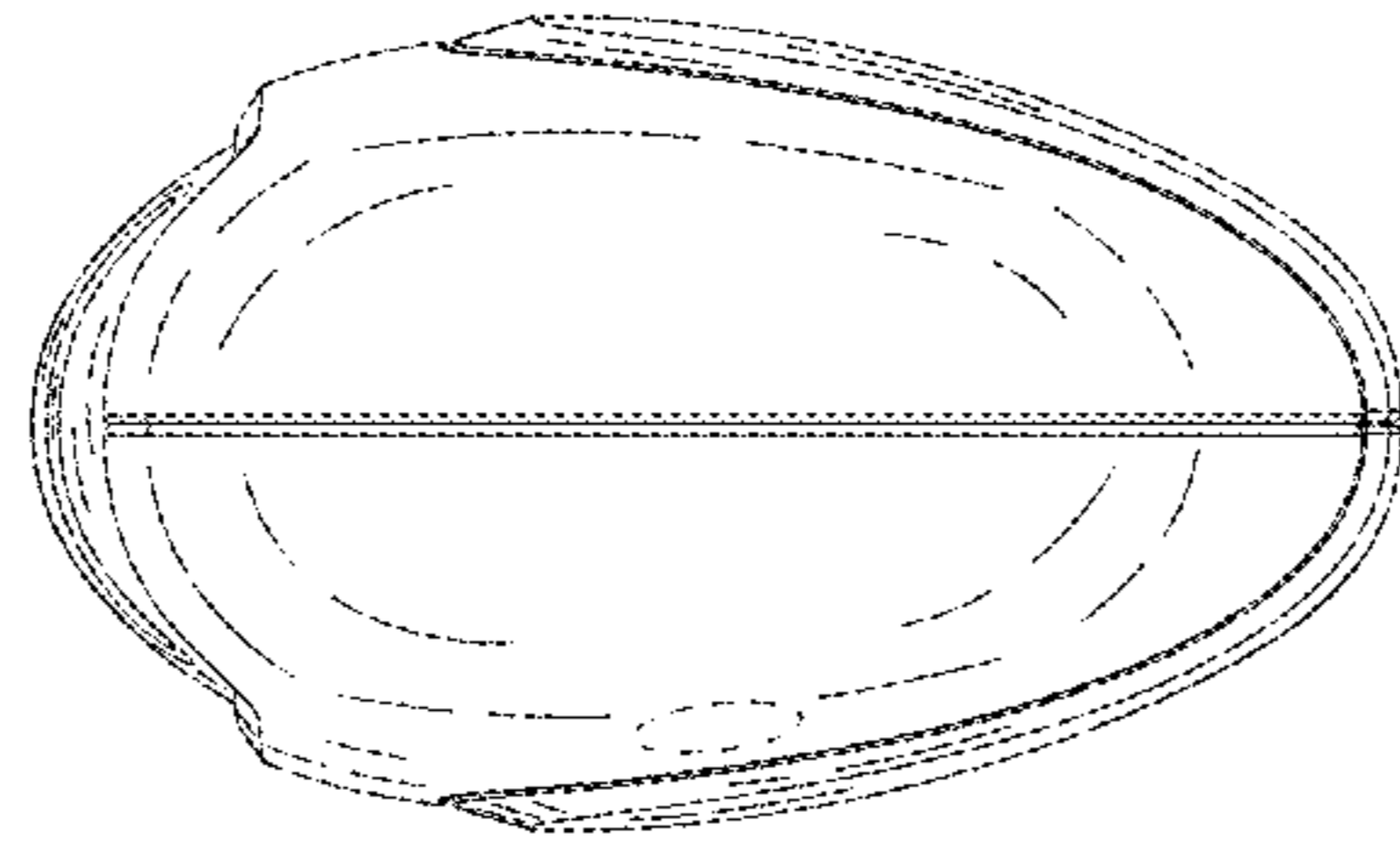

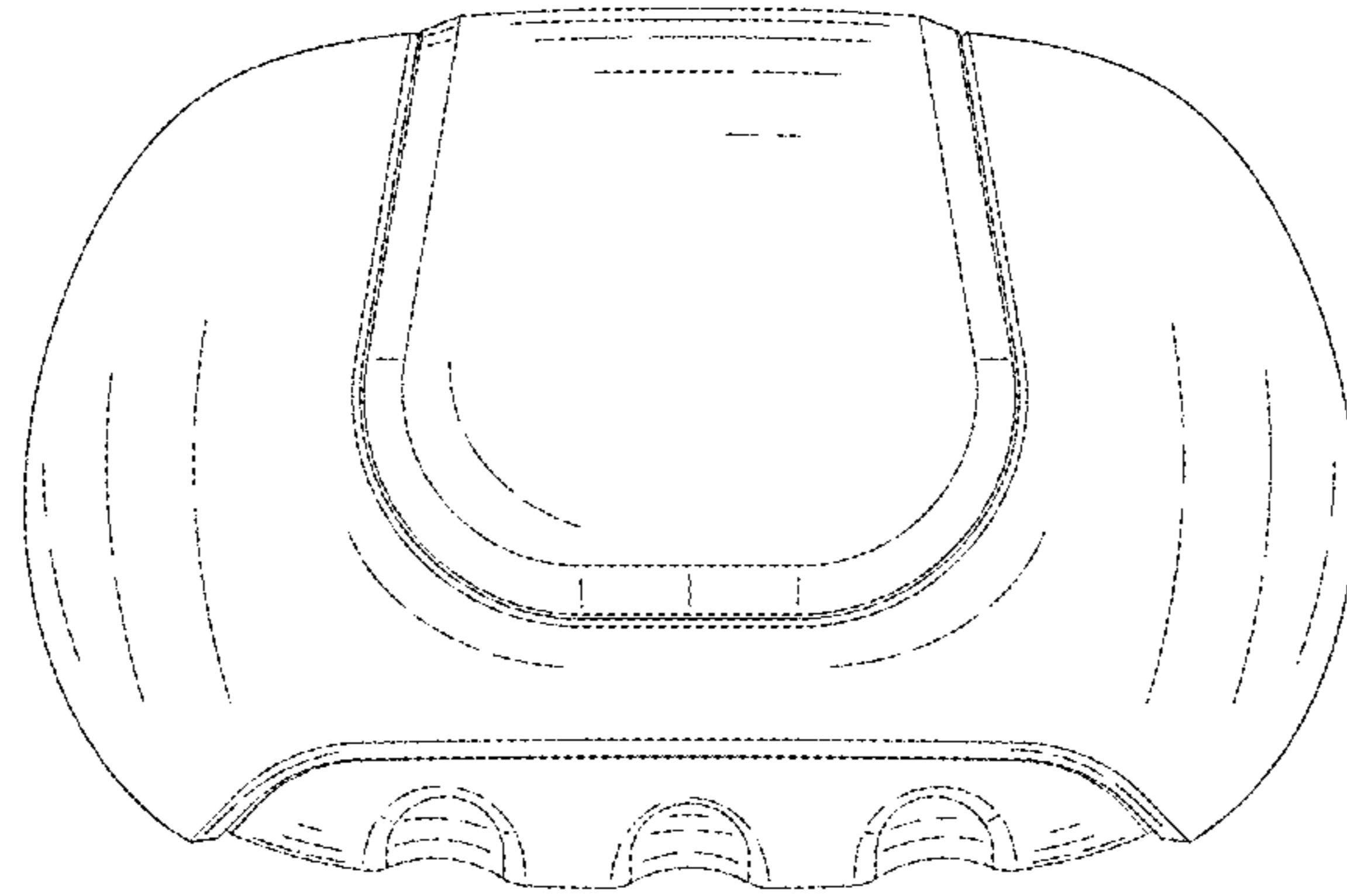

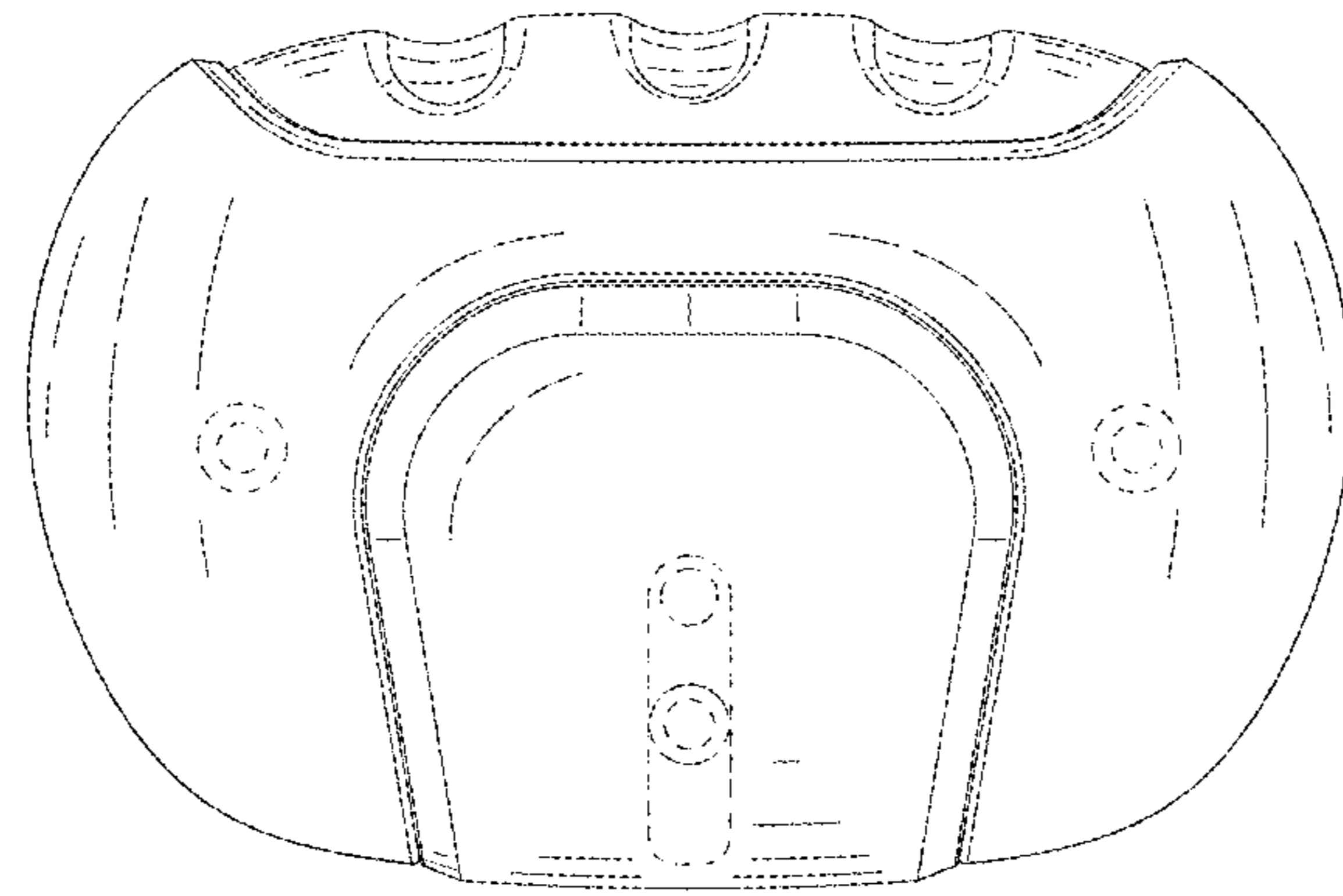
