DESCRIPTION

FIG. 1 is a top and front perspective view of a dehumidifier showing my new design;

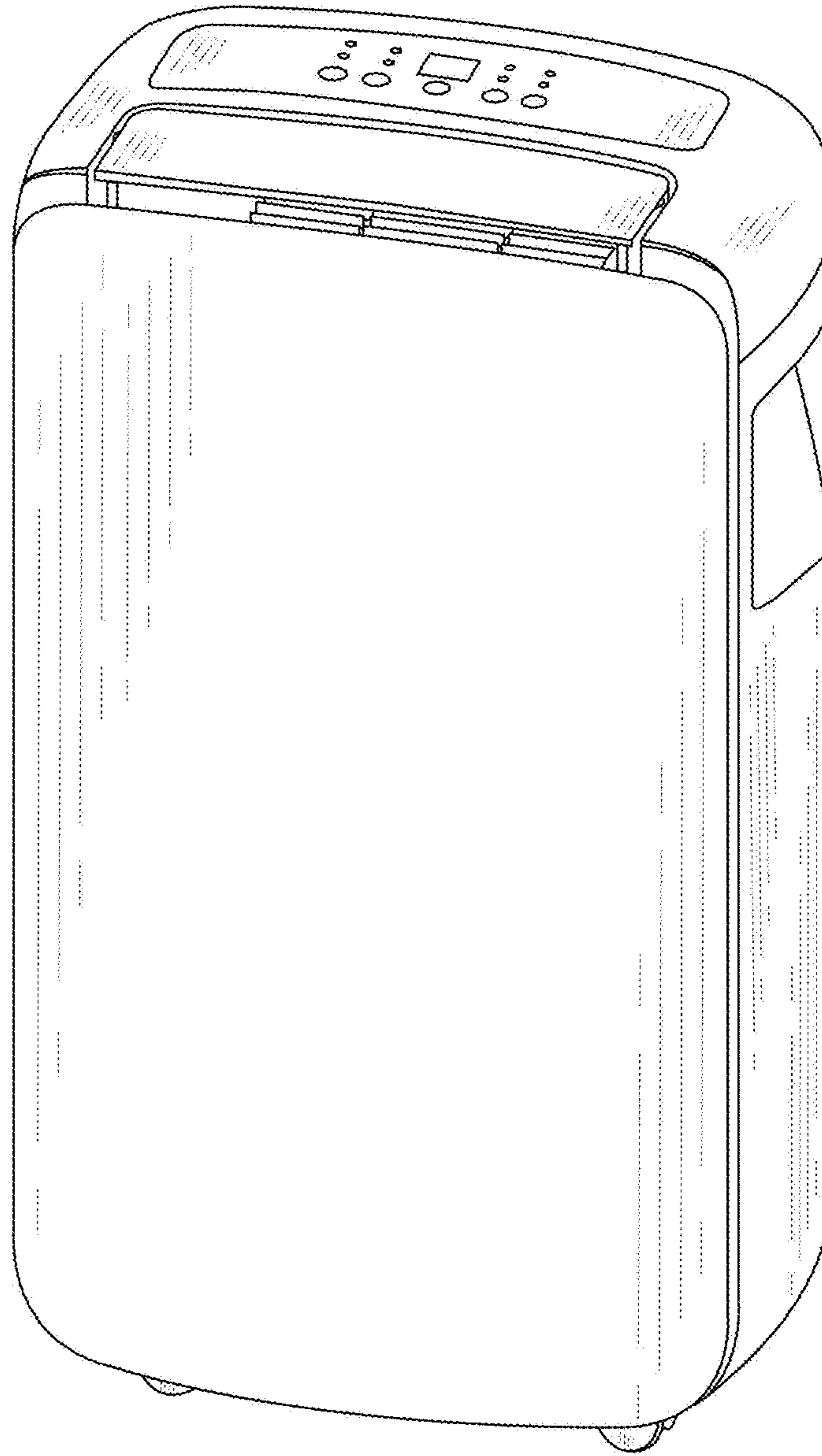

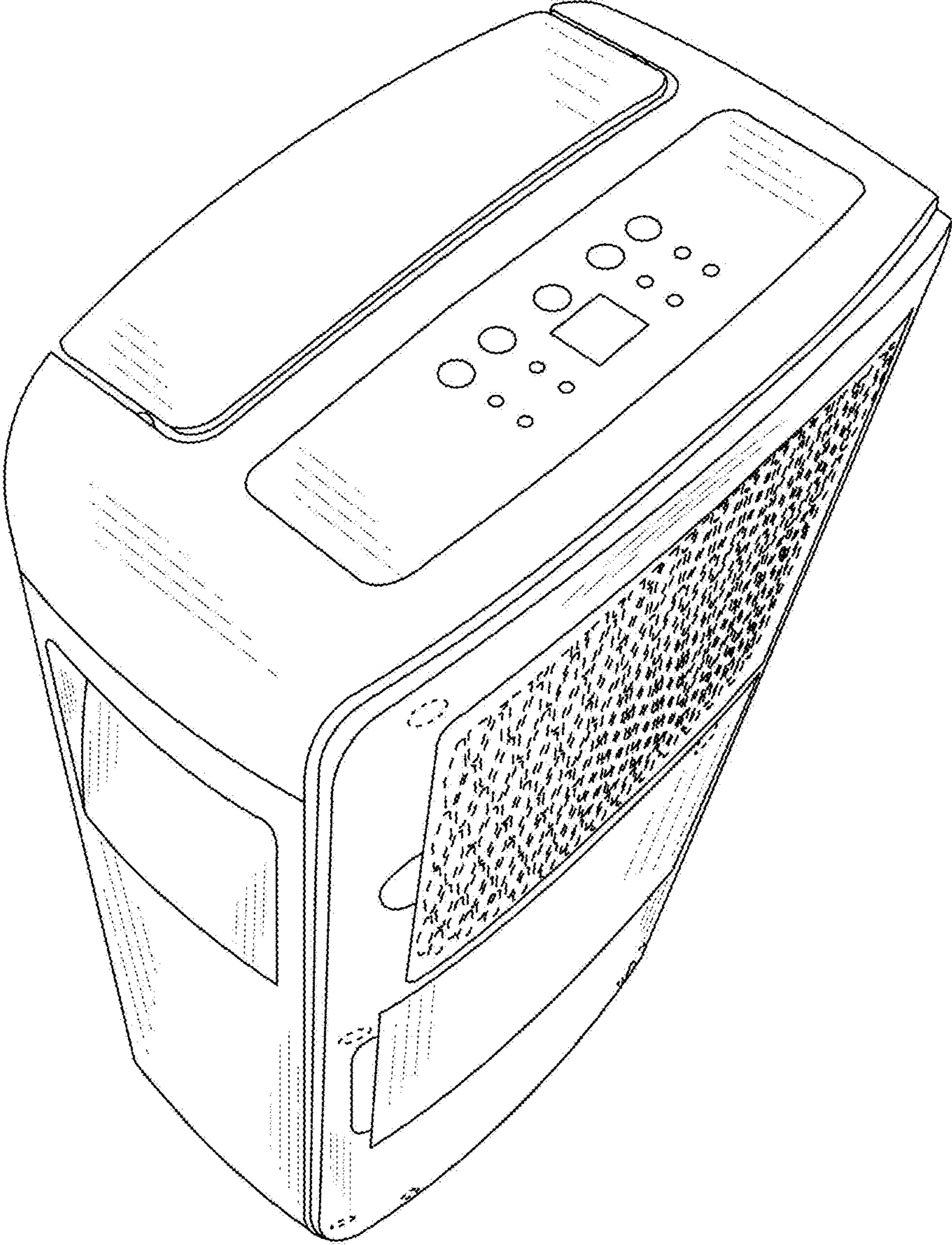

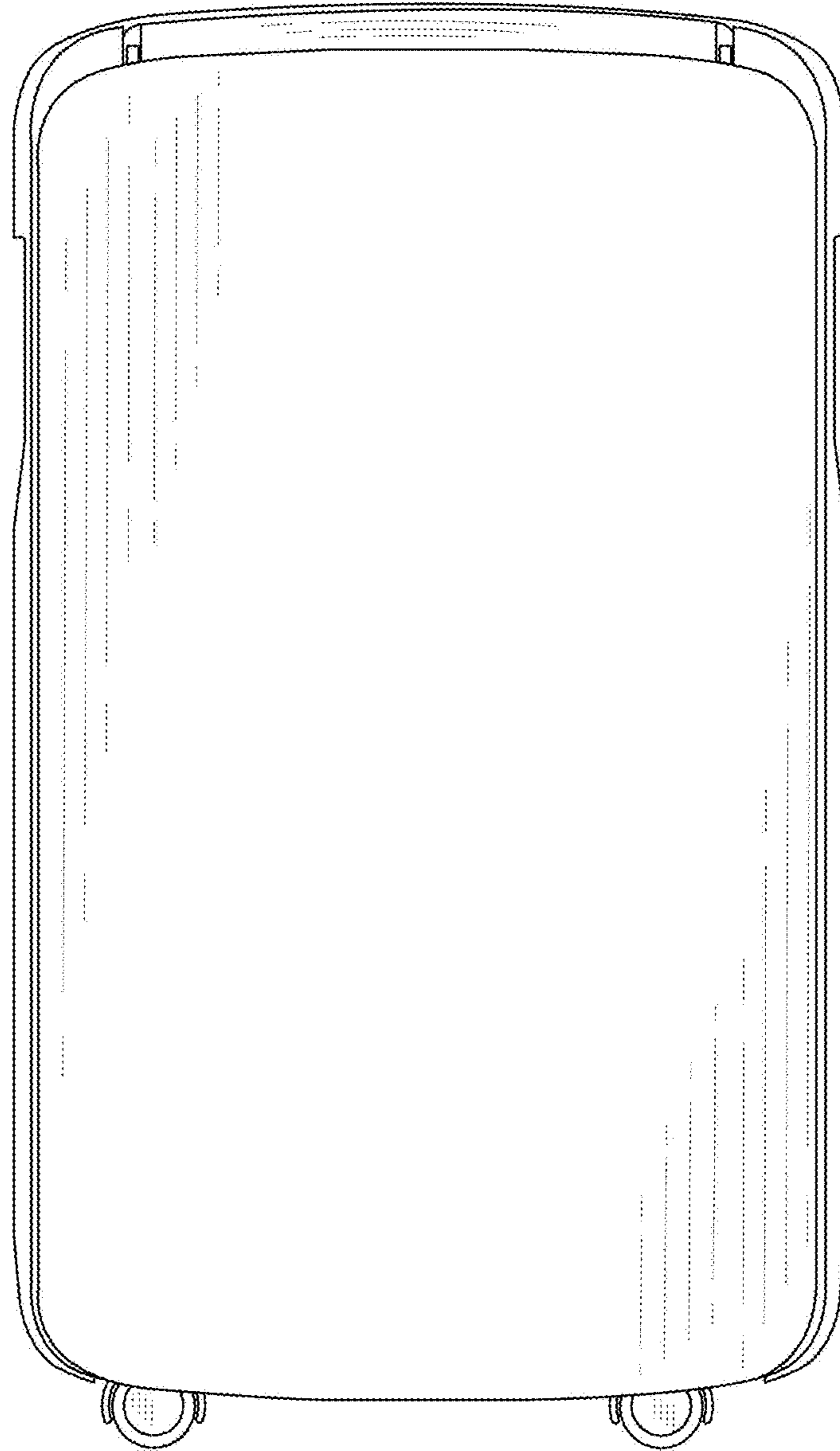

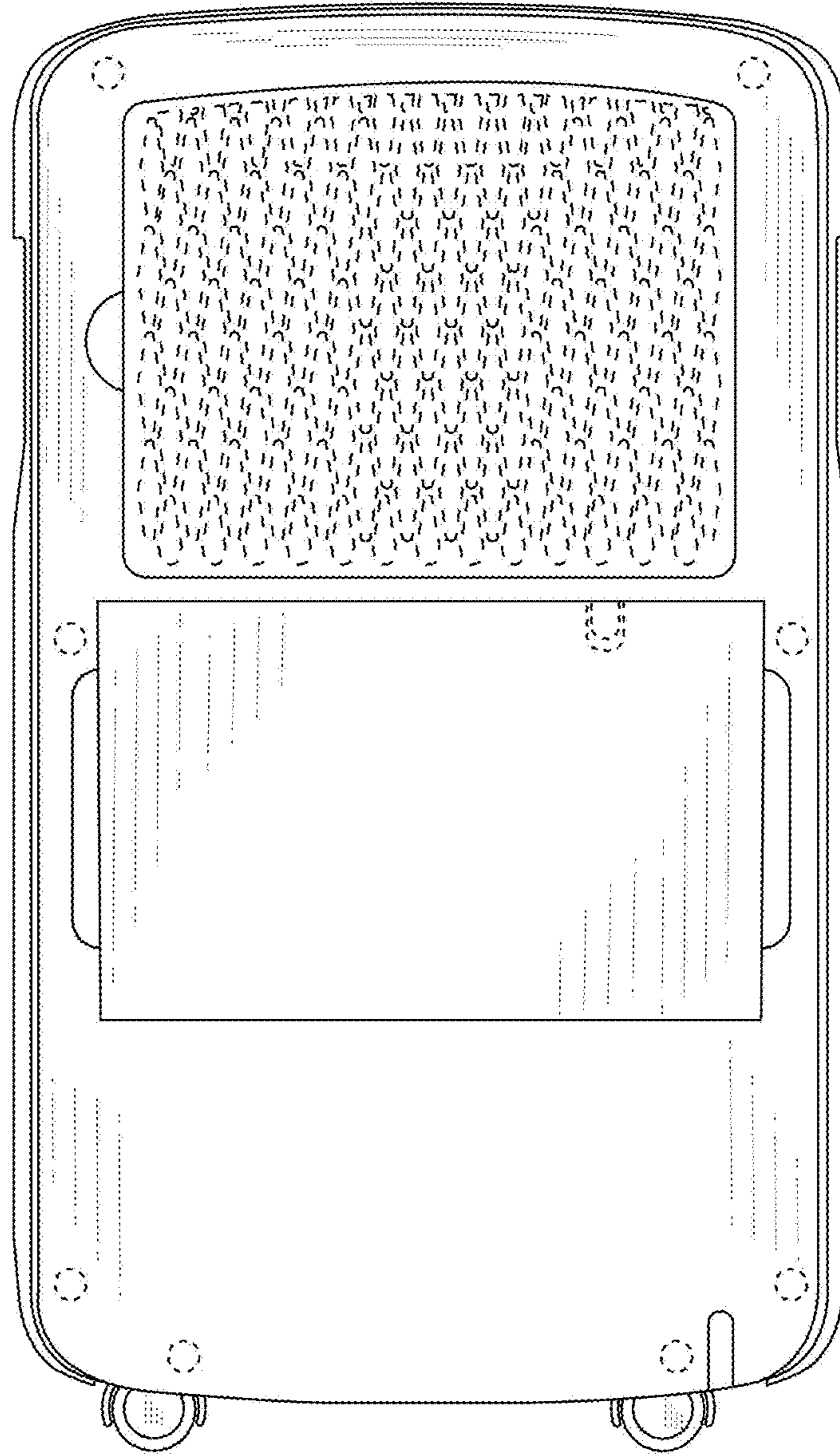

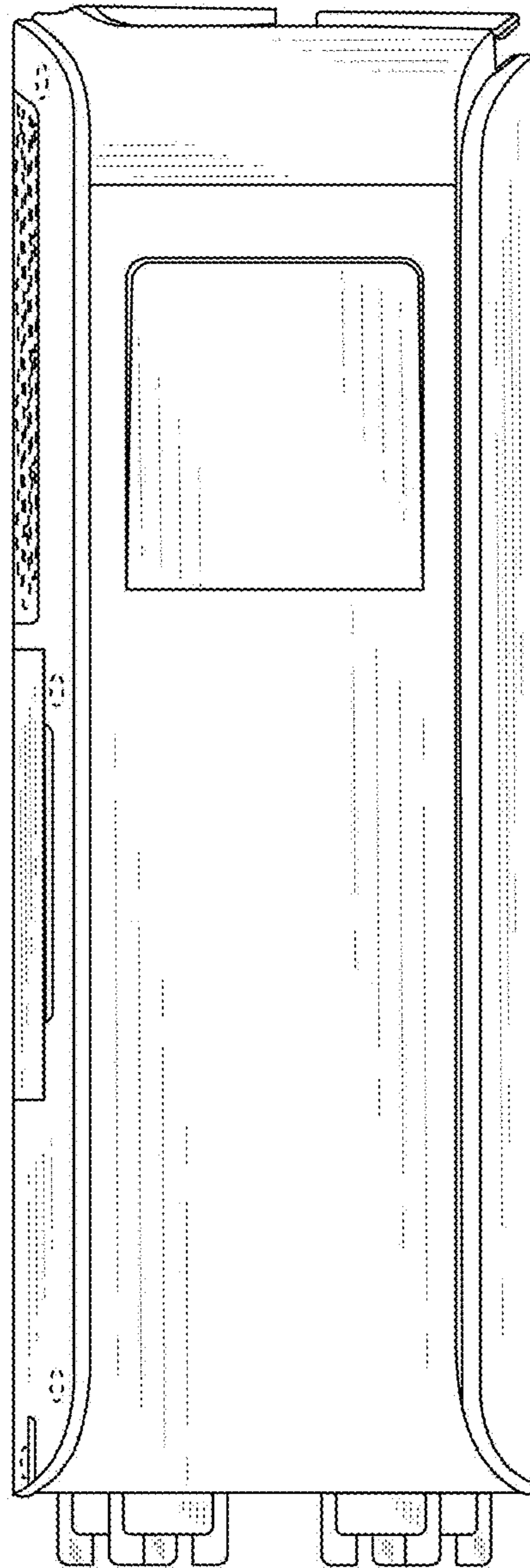

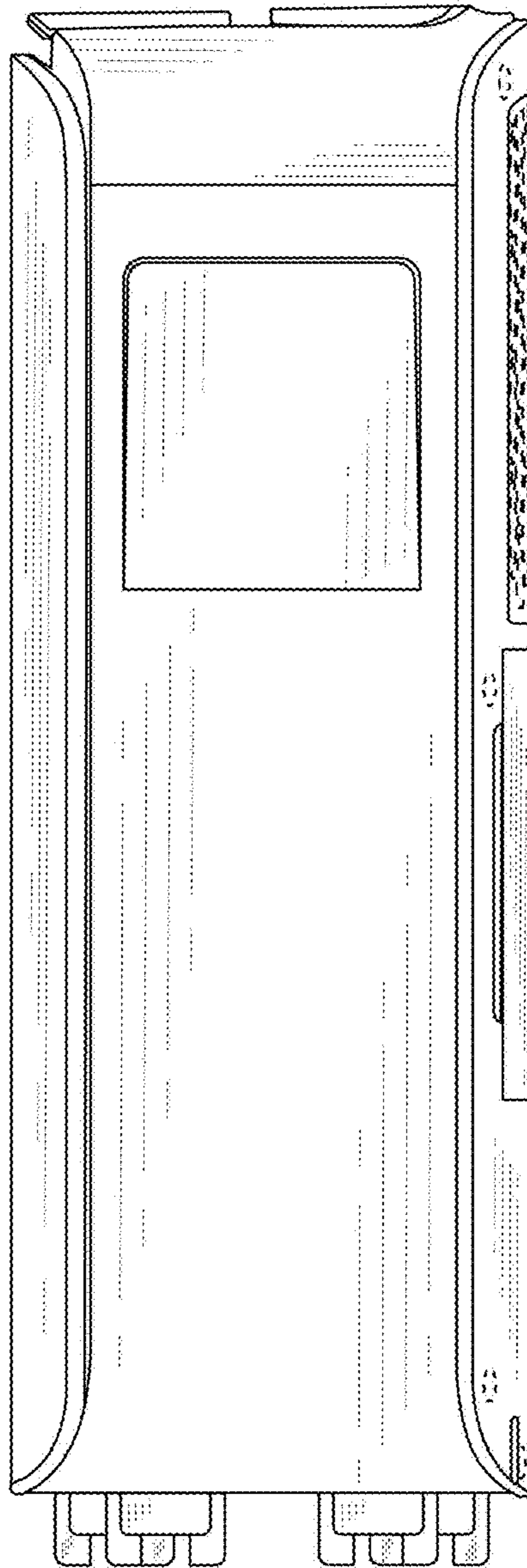

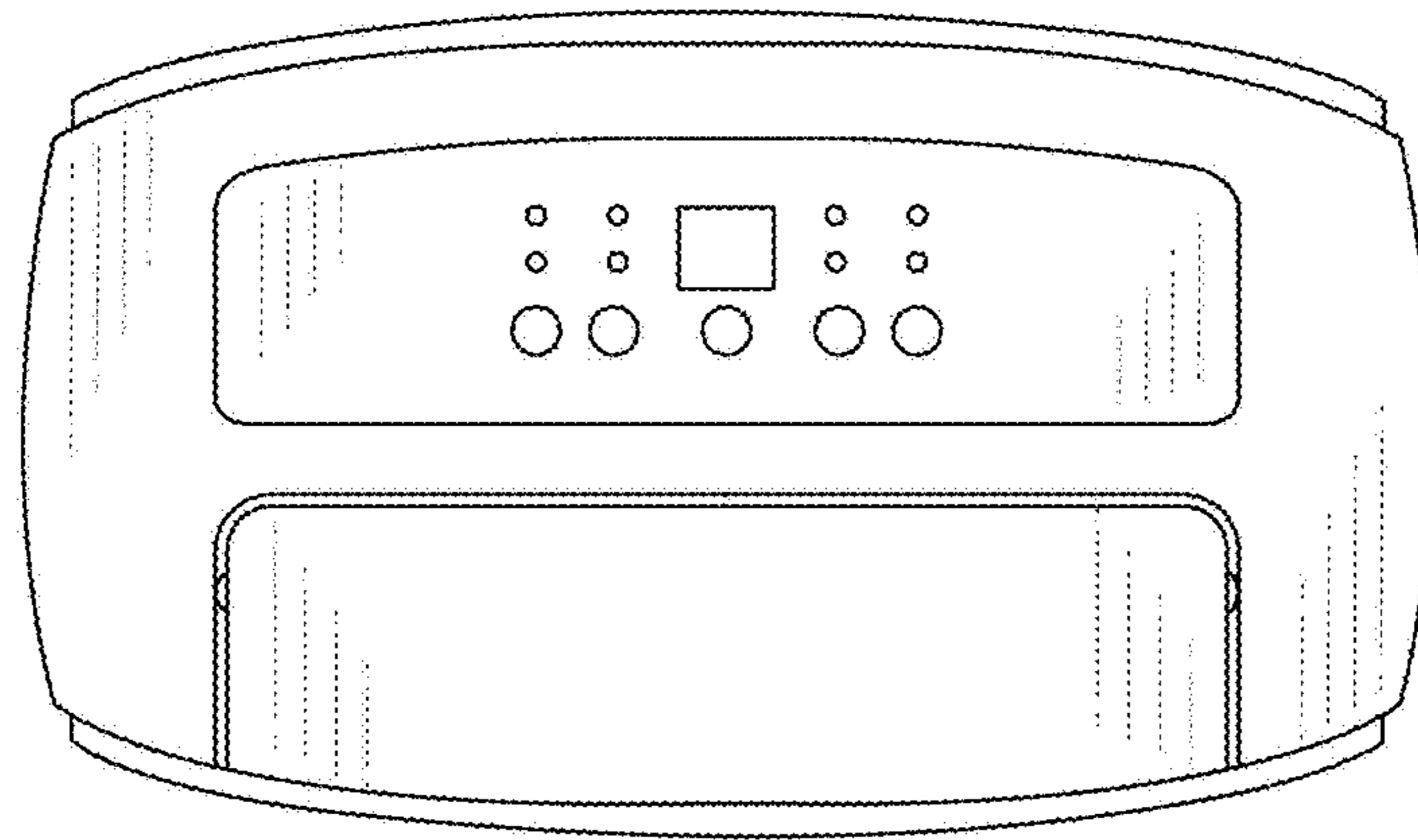

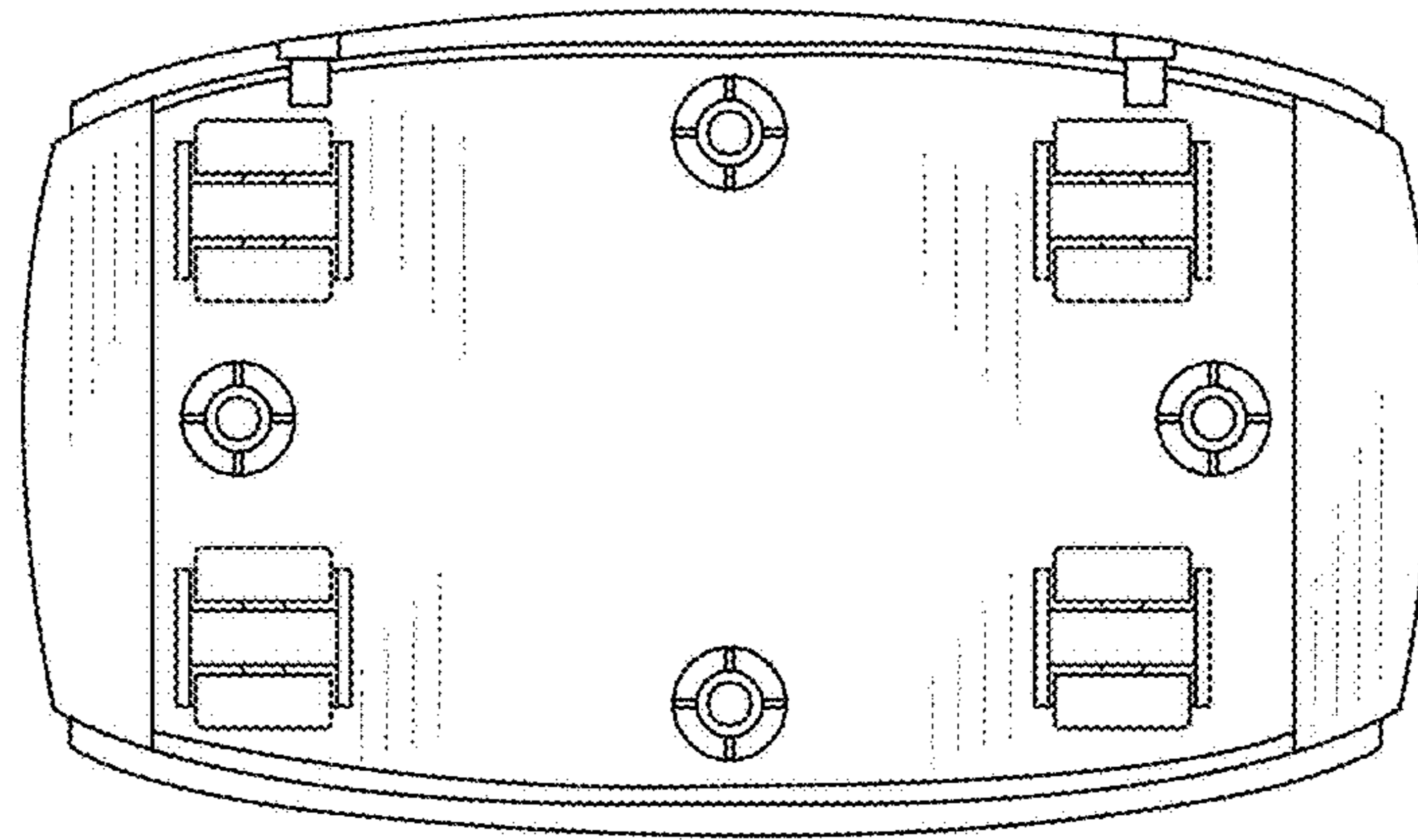

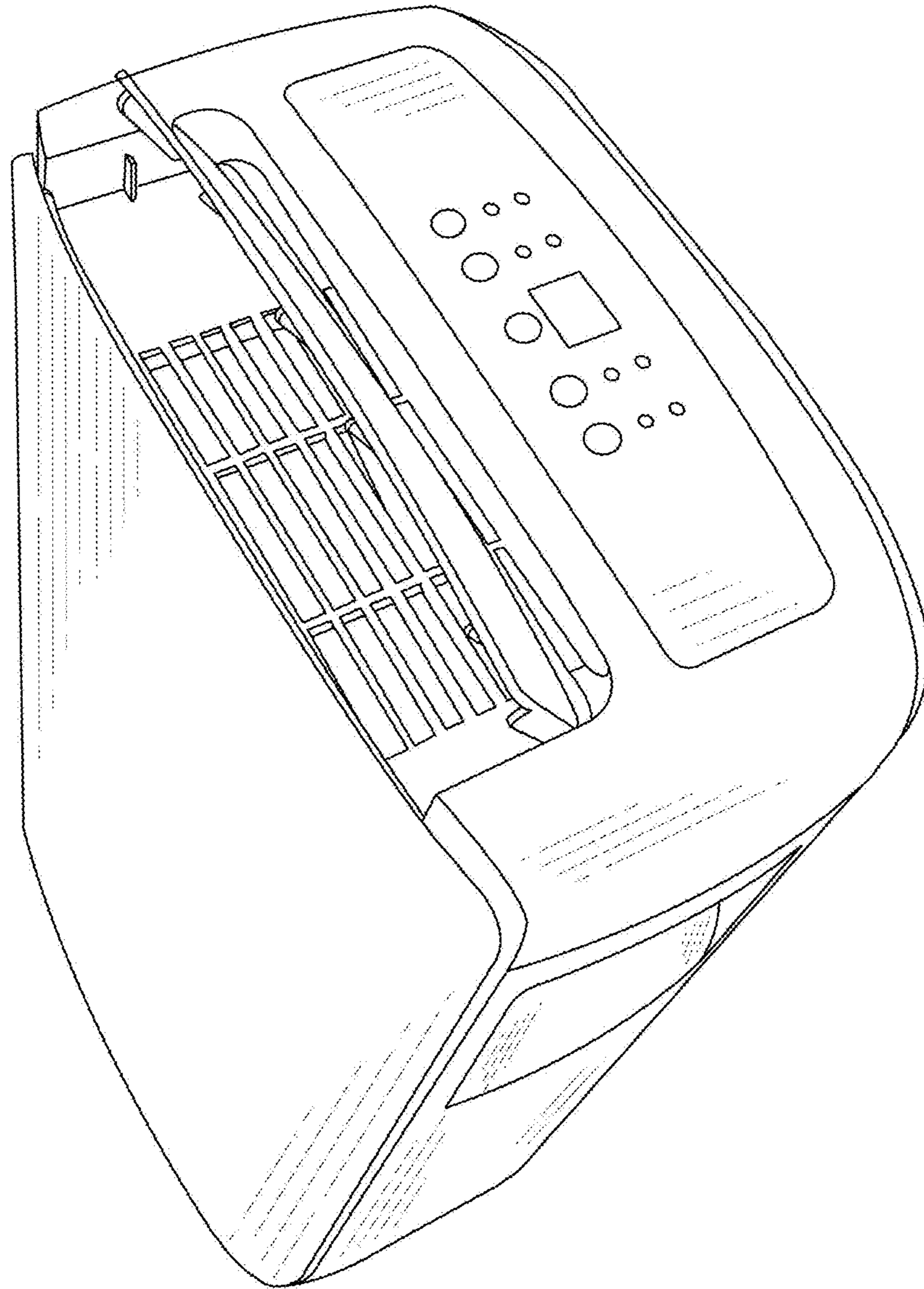
