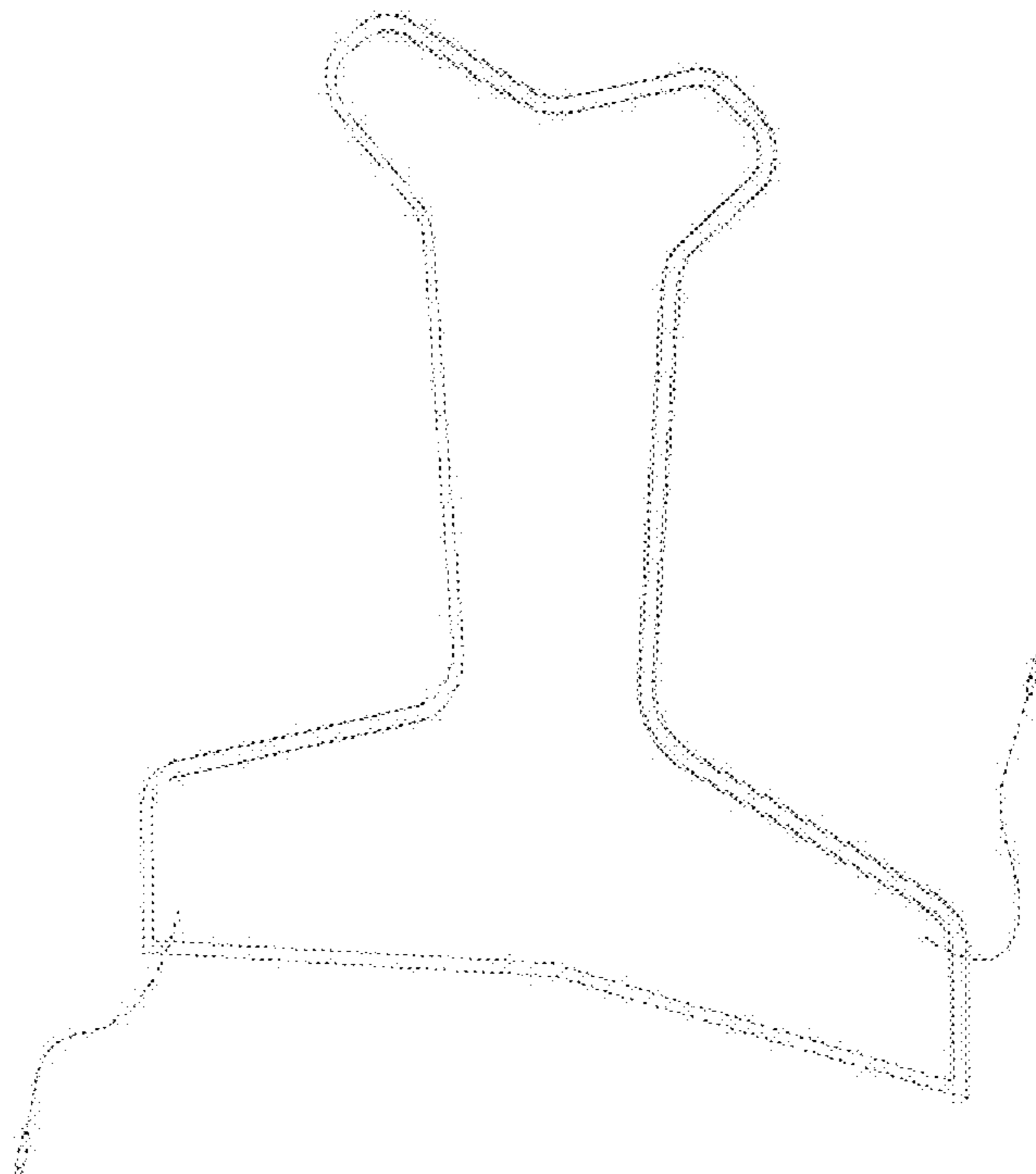
The ornamental design for heating element for garments, as shown and described.

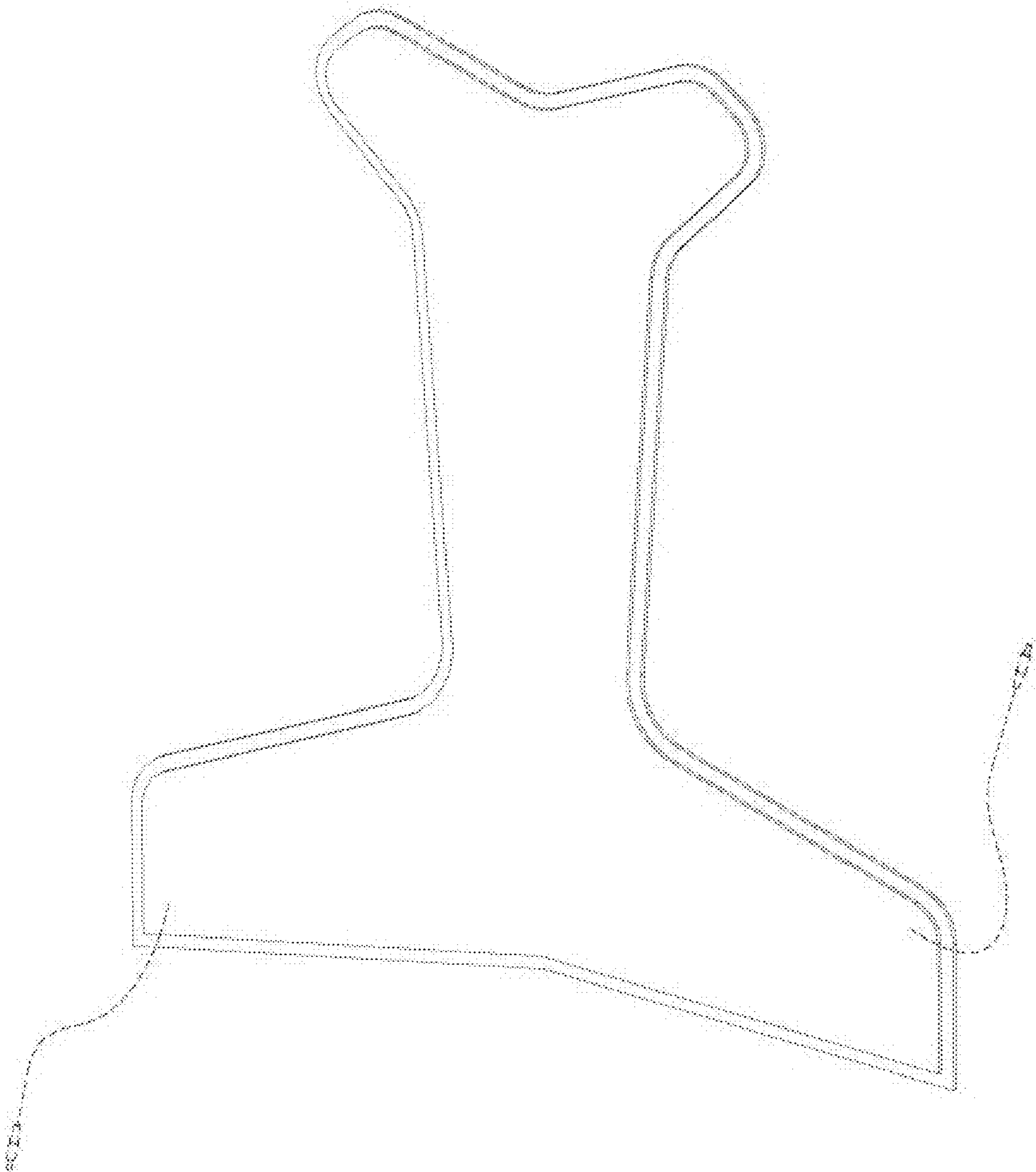
- 1. Heating element for garments

The broken lines in the drawings illustrate portions of the heating element for garments which forms no part of the claimed design.

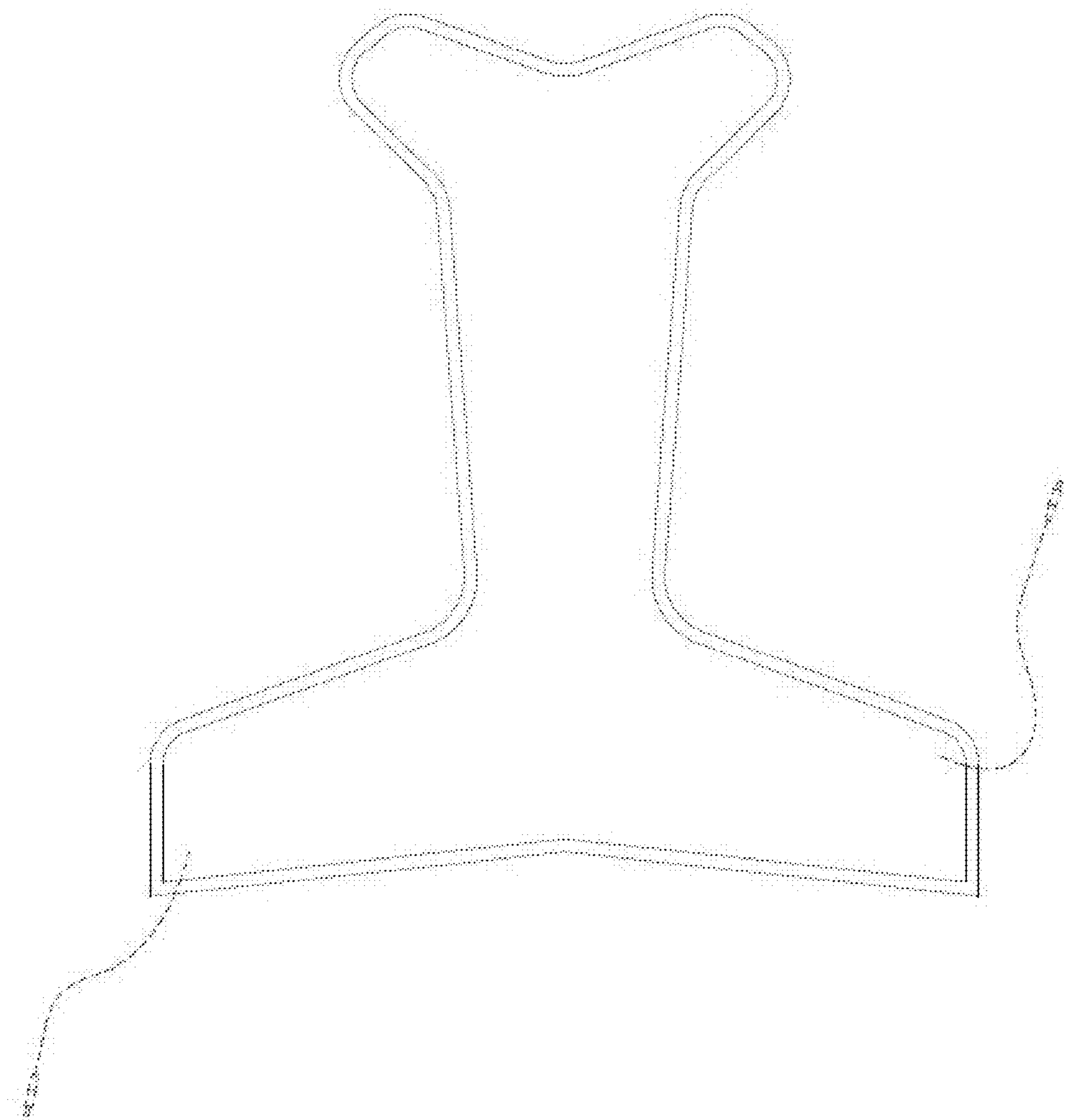

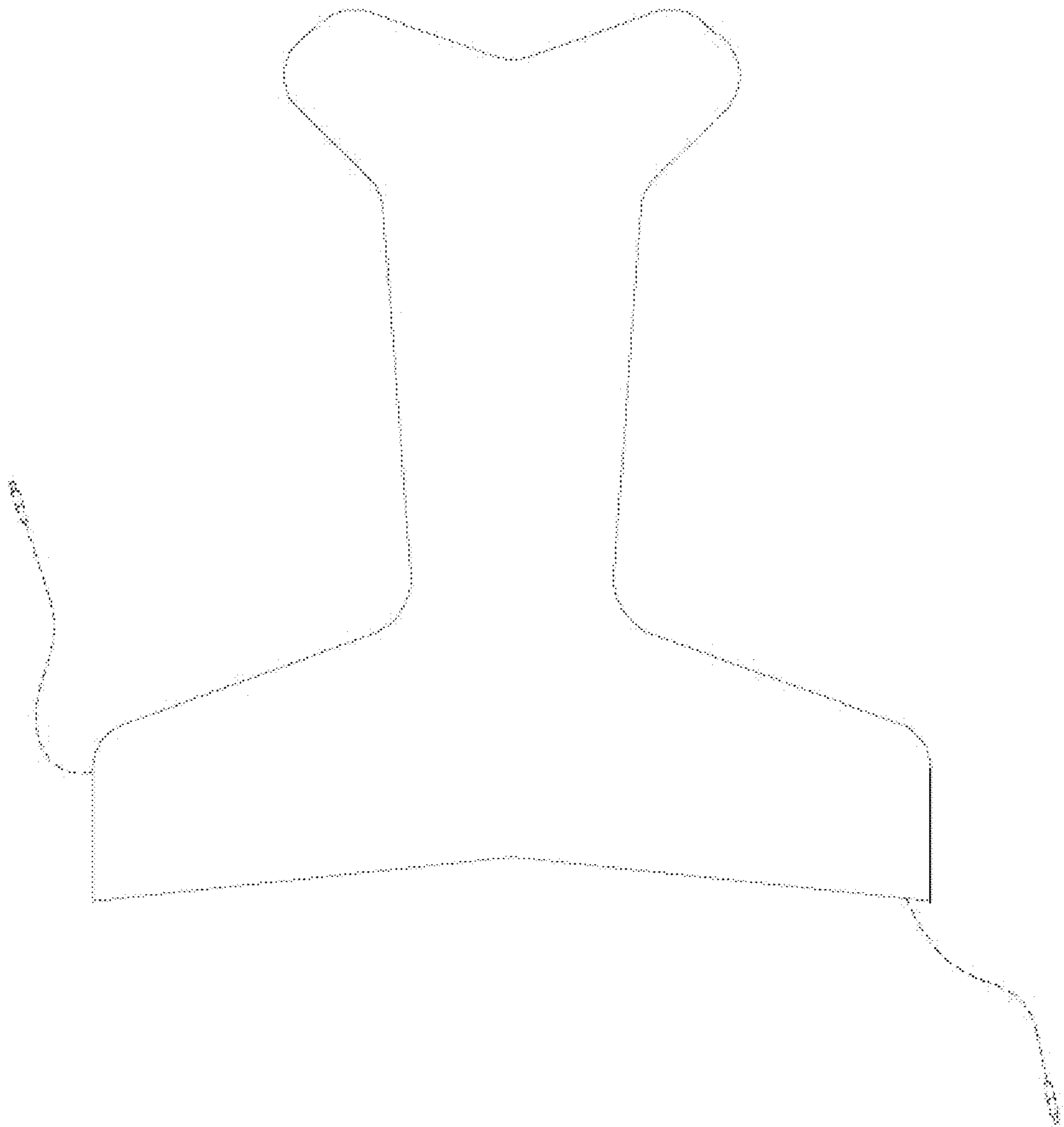

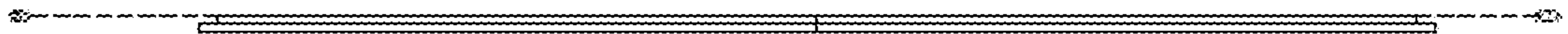

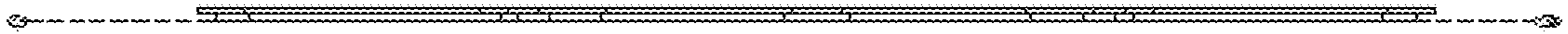
