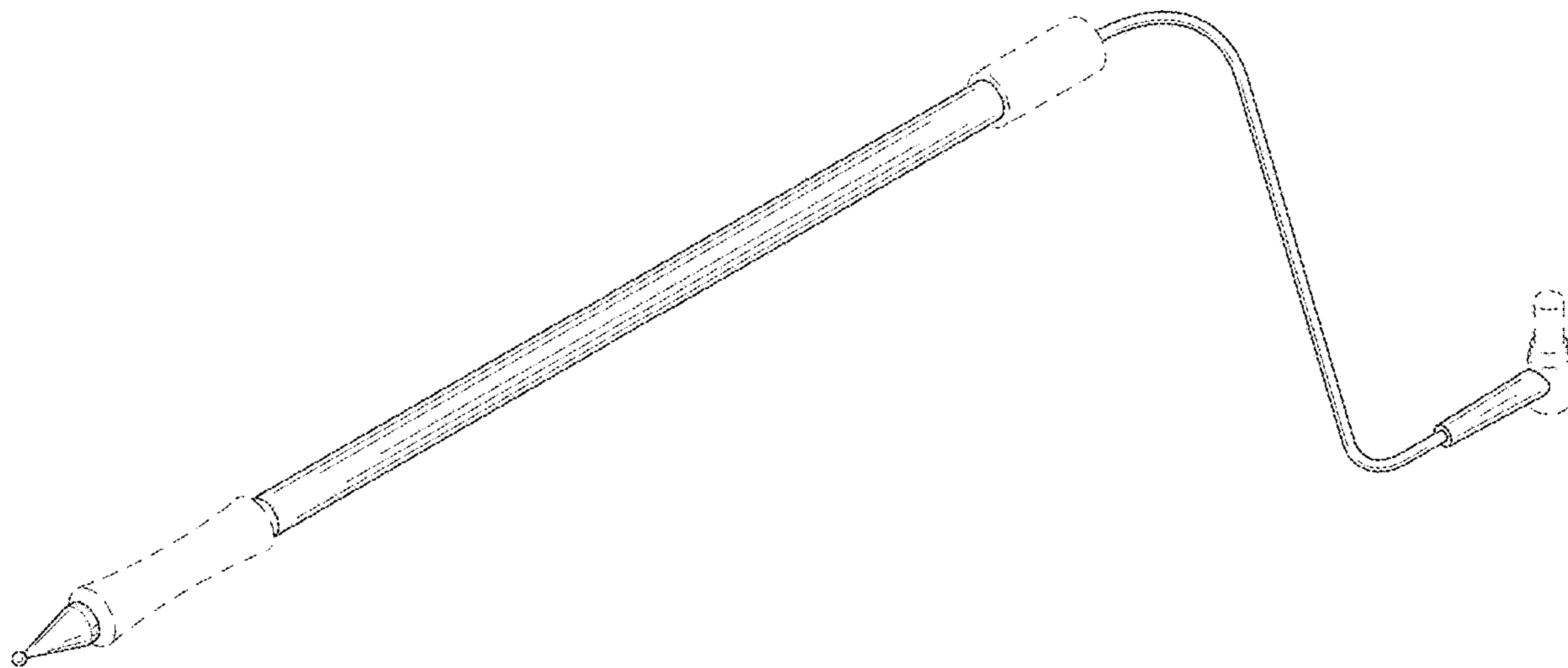
(57) **CLAIM**

The ornamental design for an acupressure probe, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of an acupressure probe, showing my new design;
FIG. 2 is a right elevation view thereof, with the left elevation view being a mirror image thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

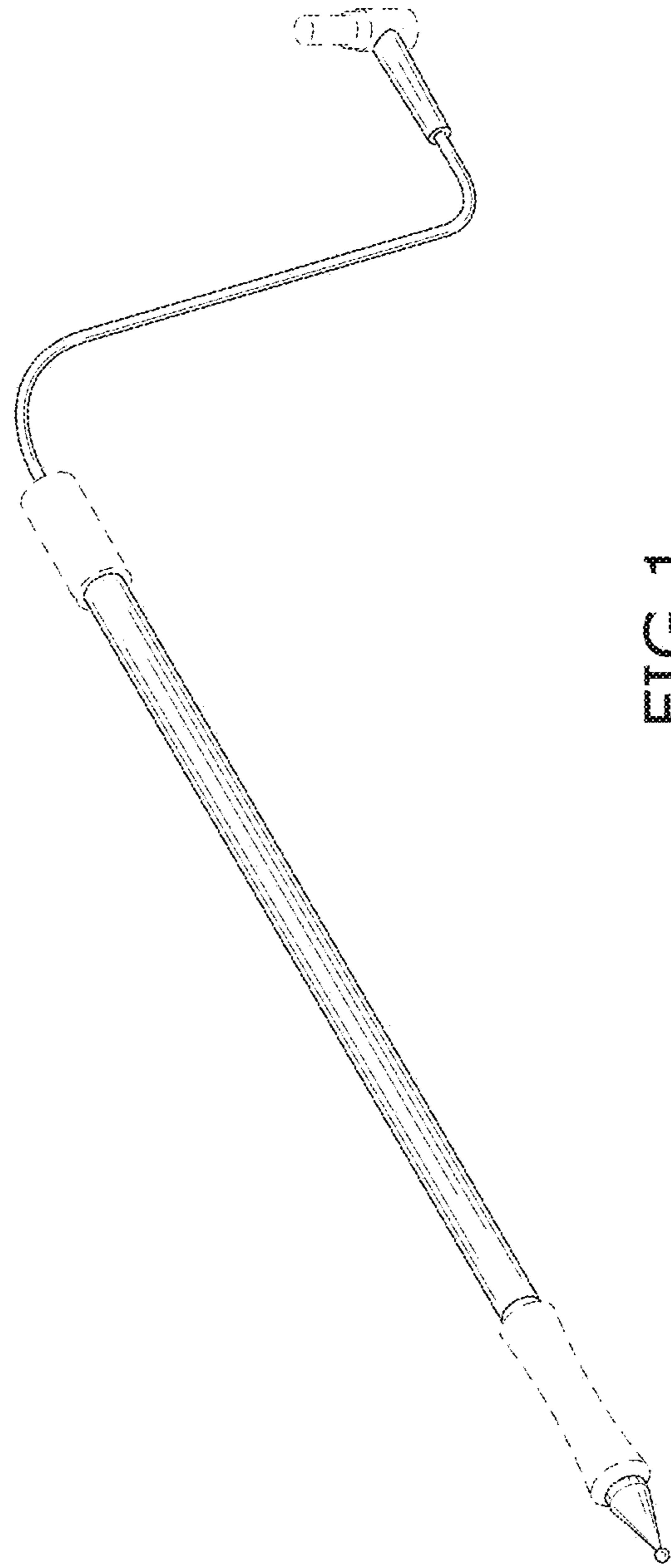

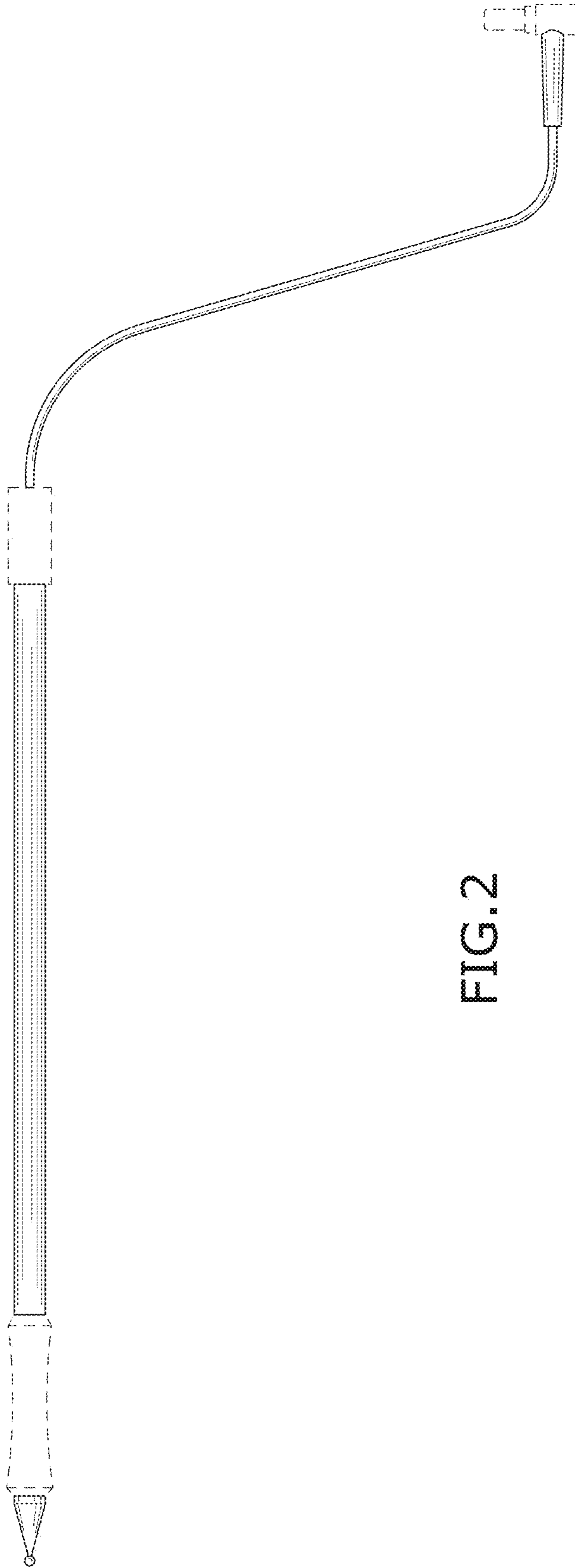

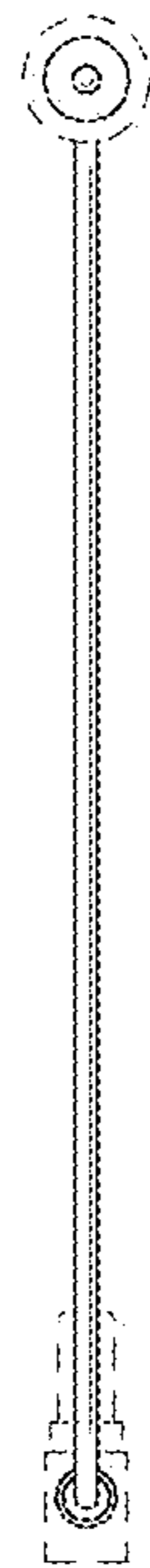

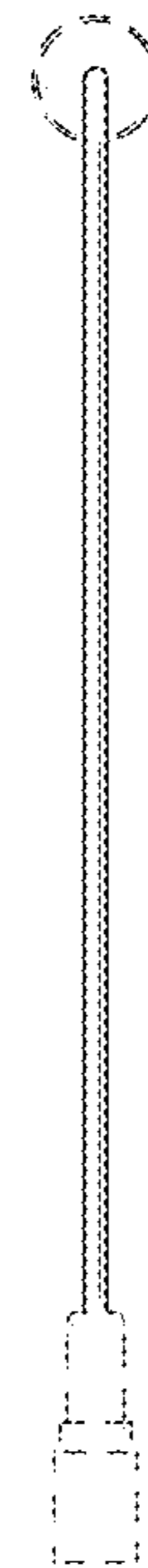

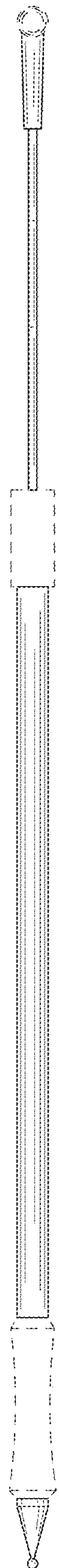

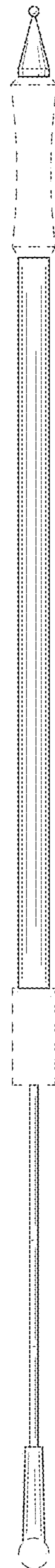
