DESCRIPTION

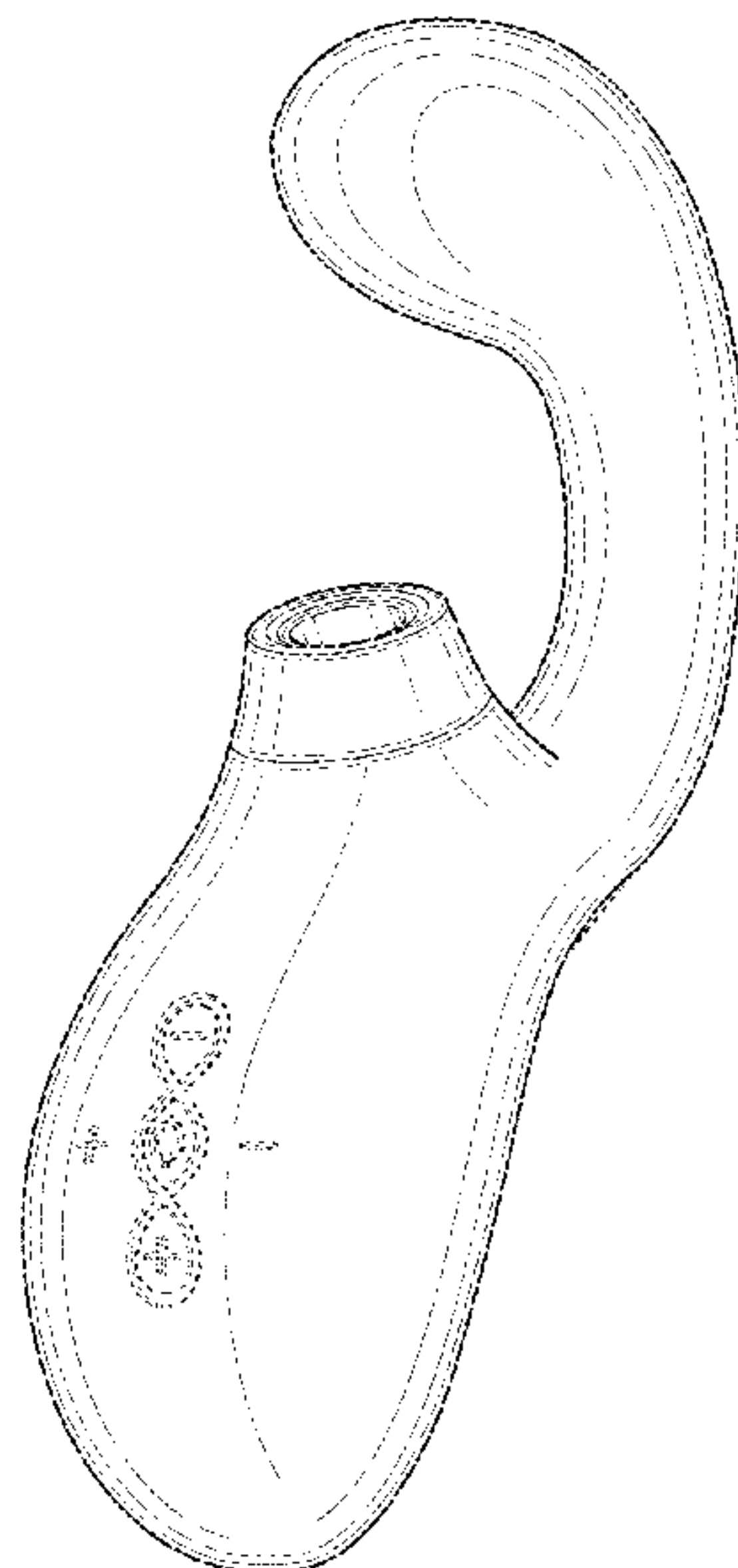
FIG. 1 is a perspective view of a personal massager.

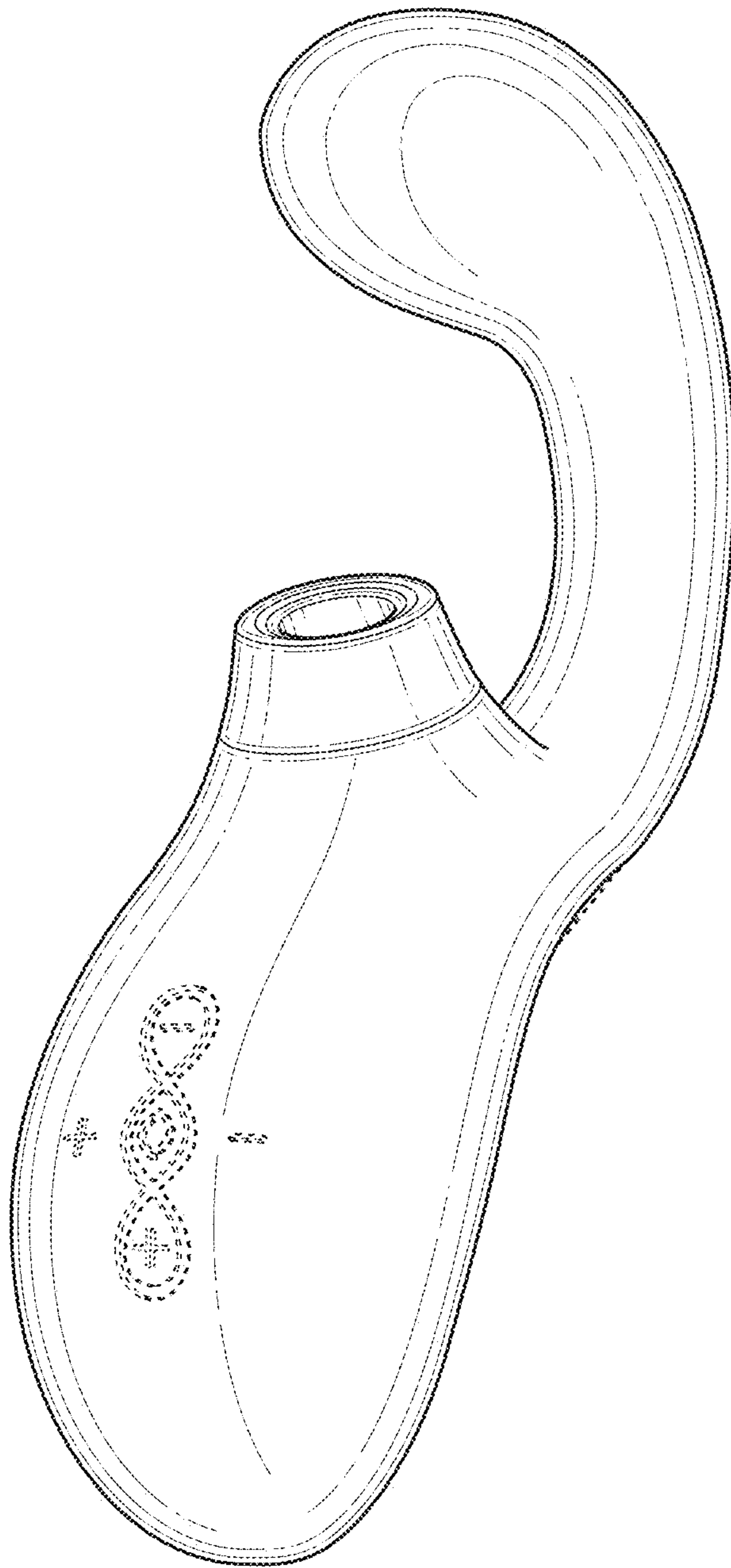

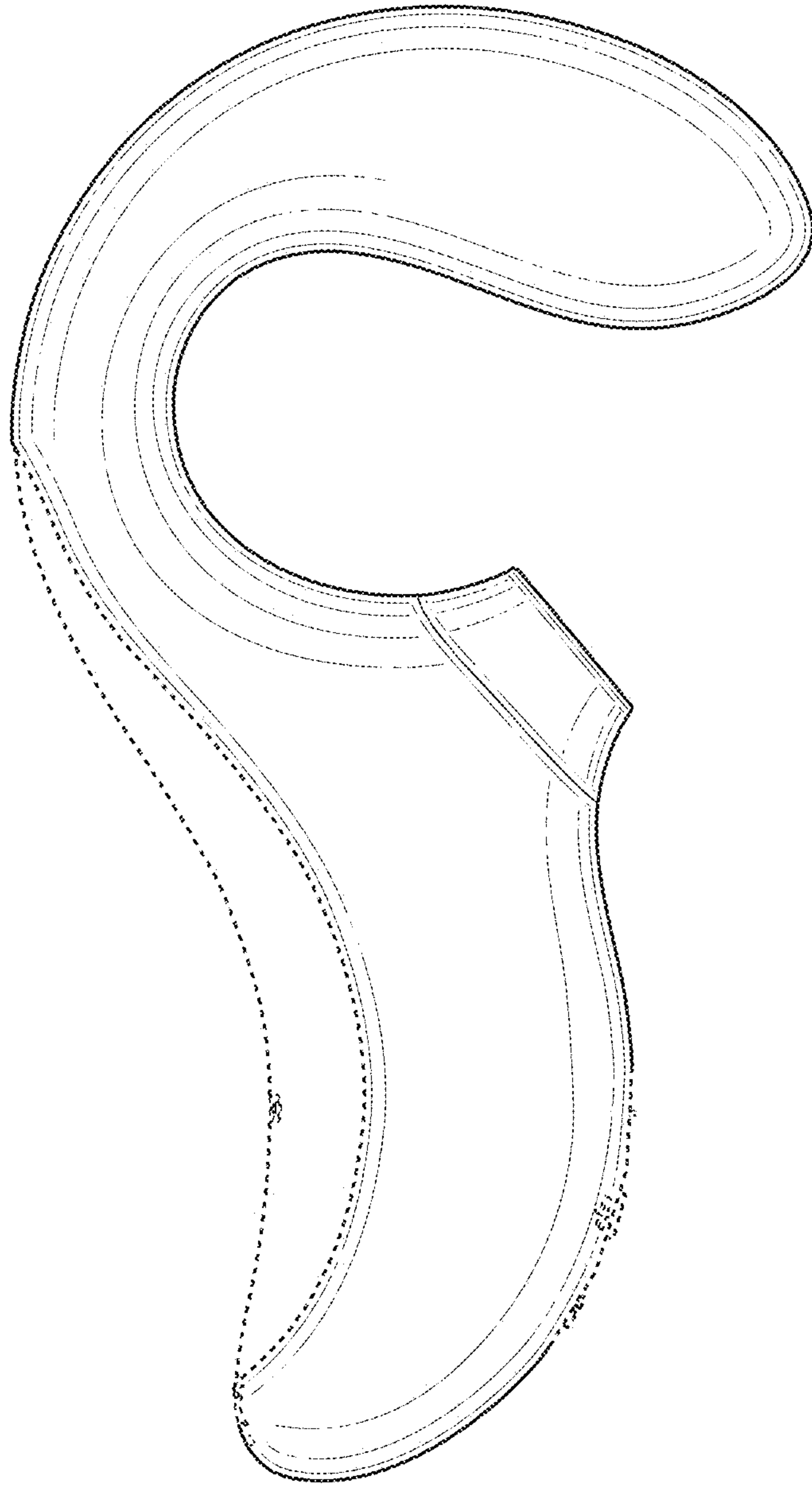

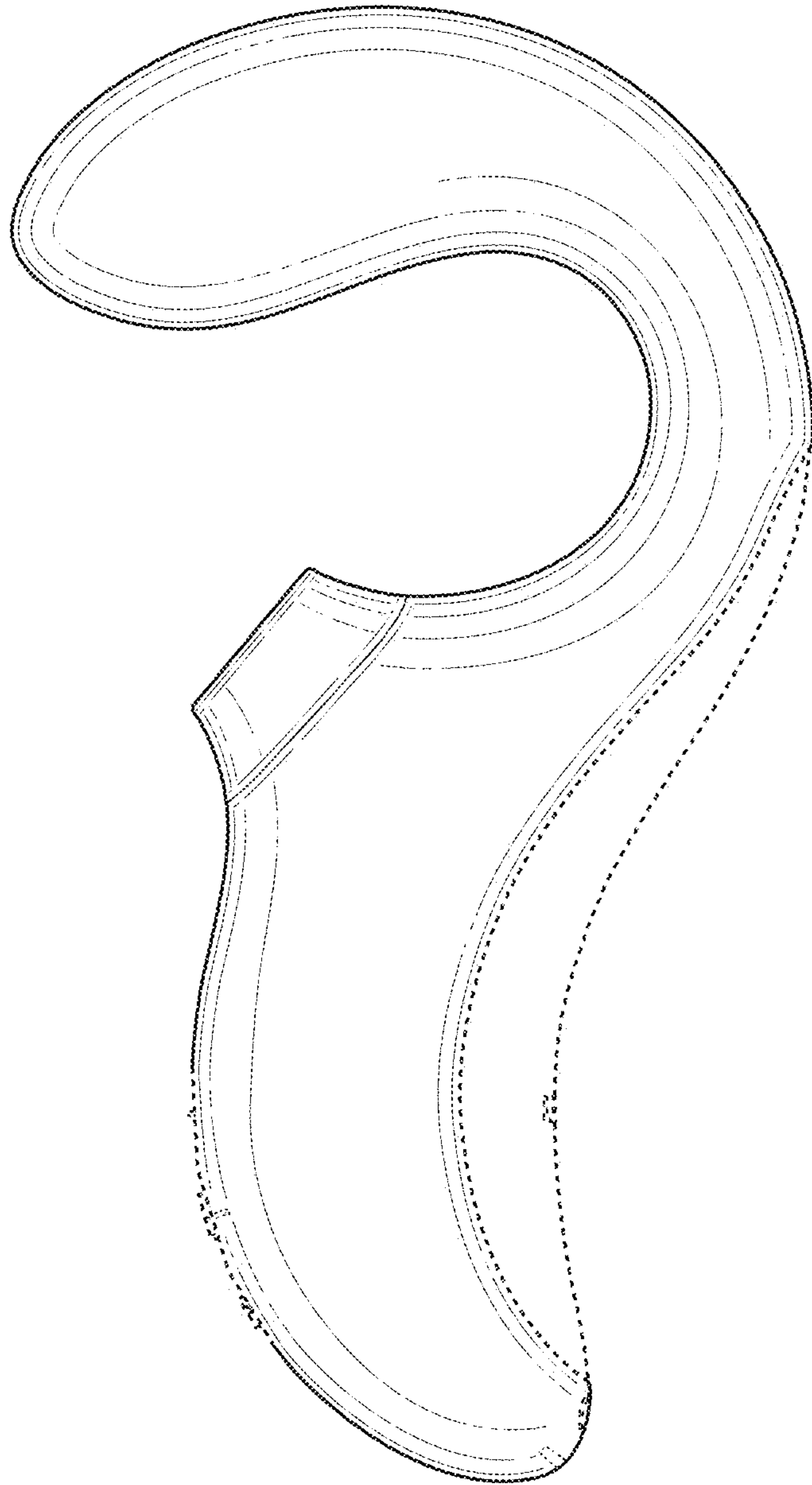

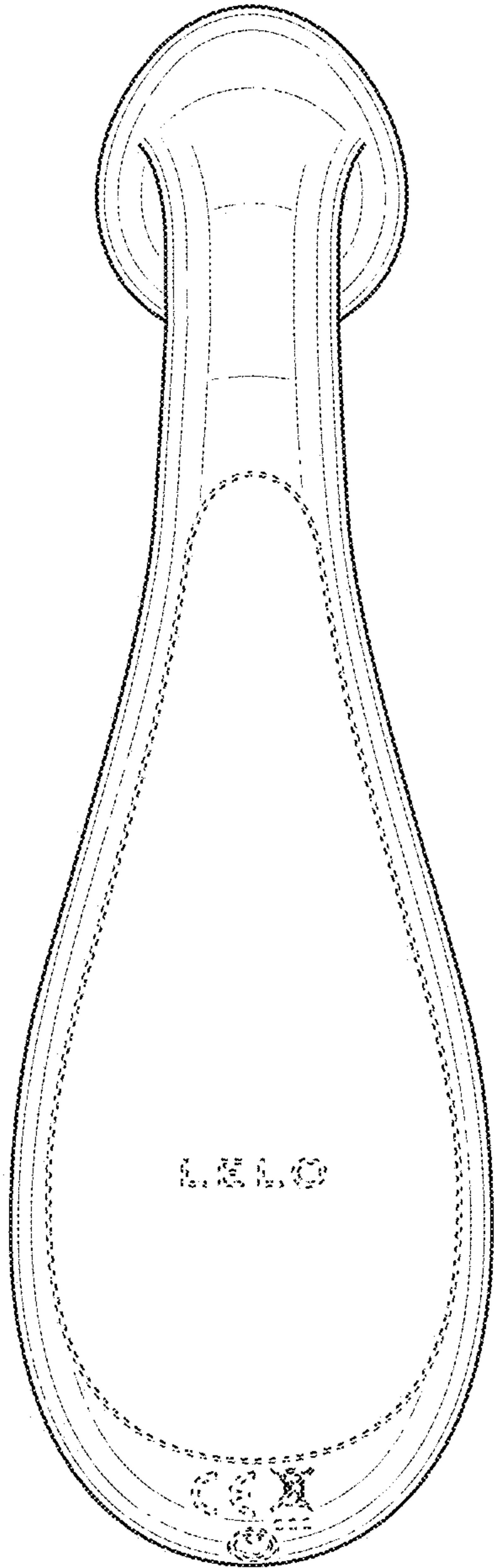

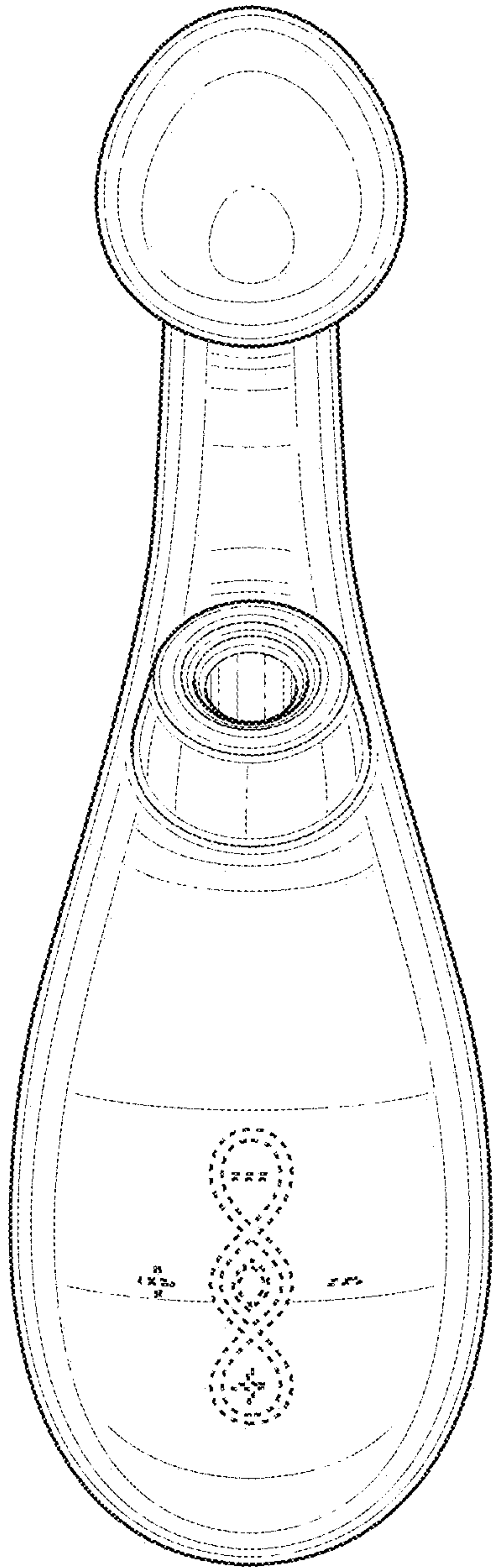

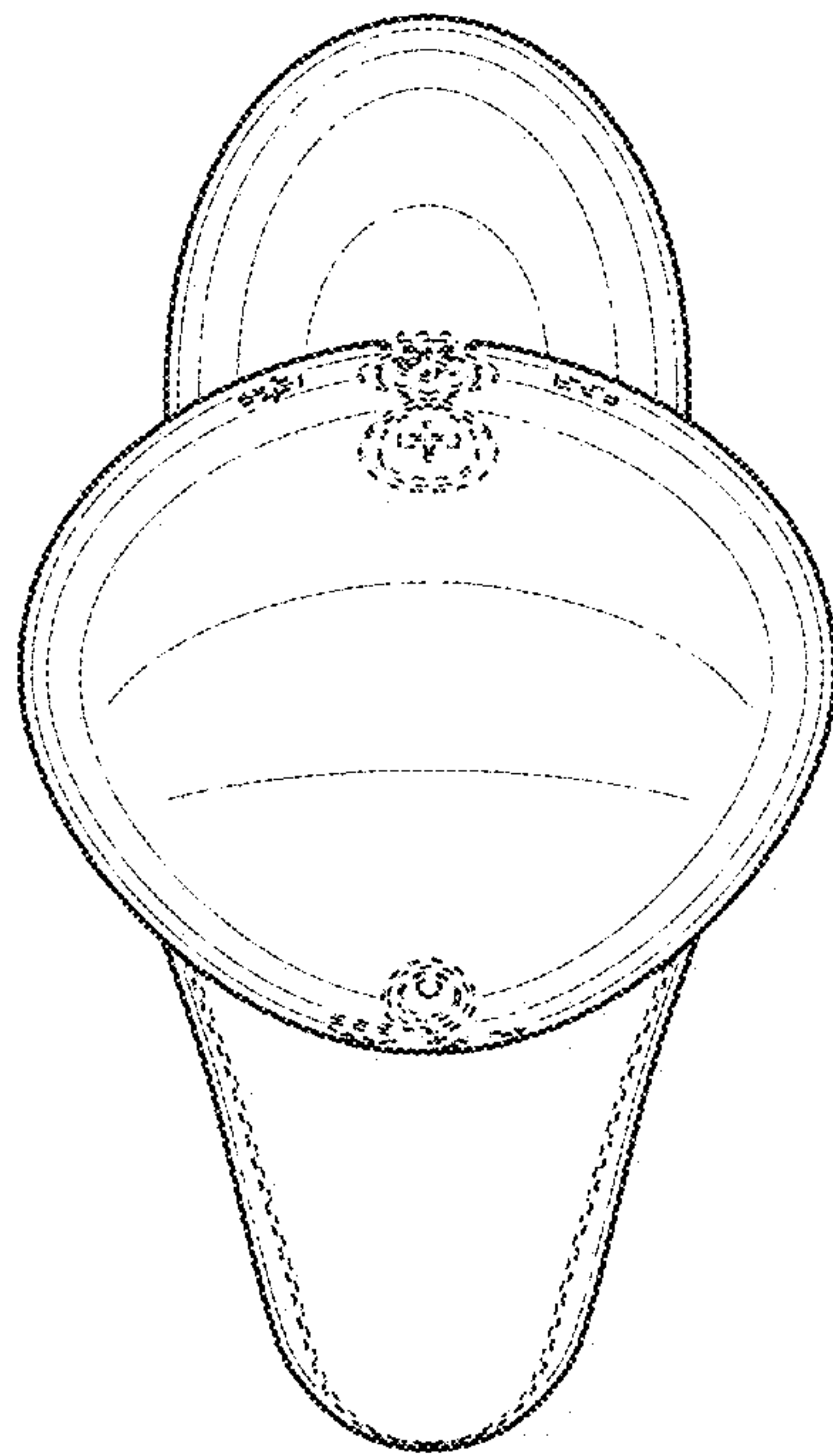

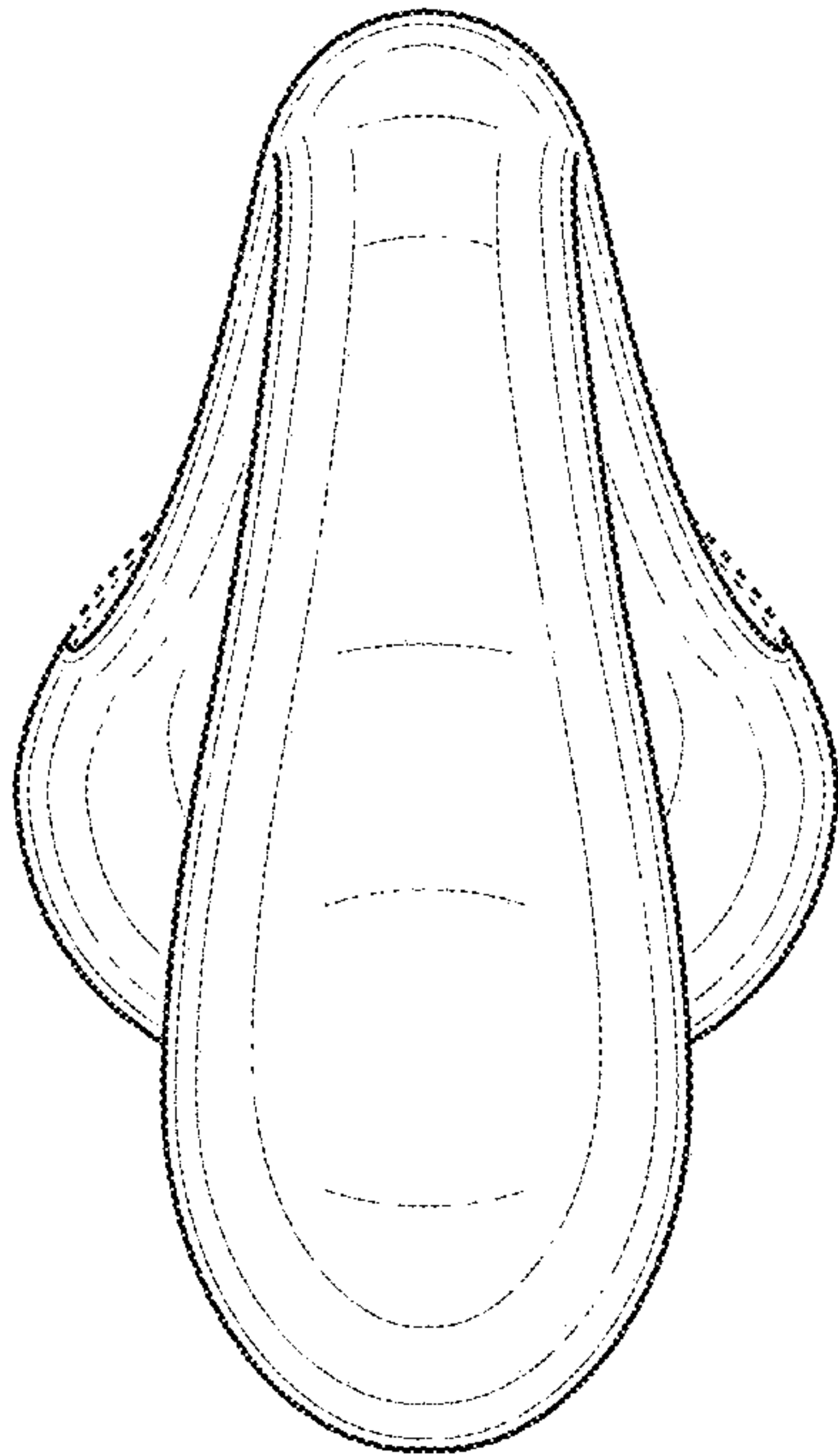
