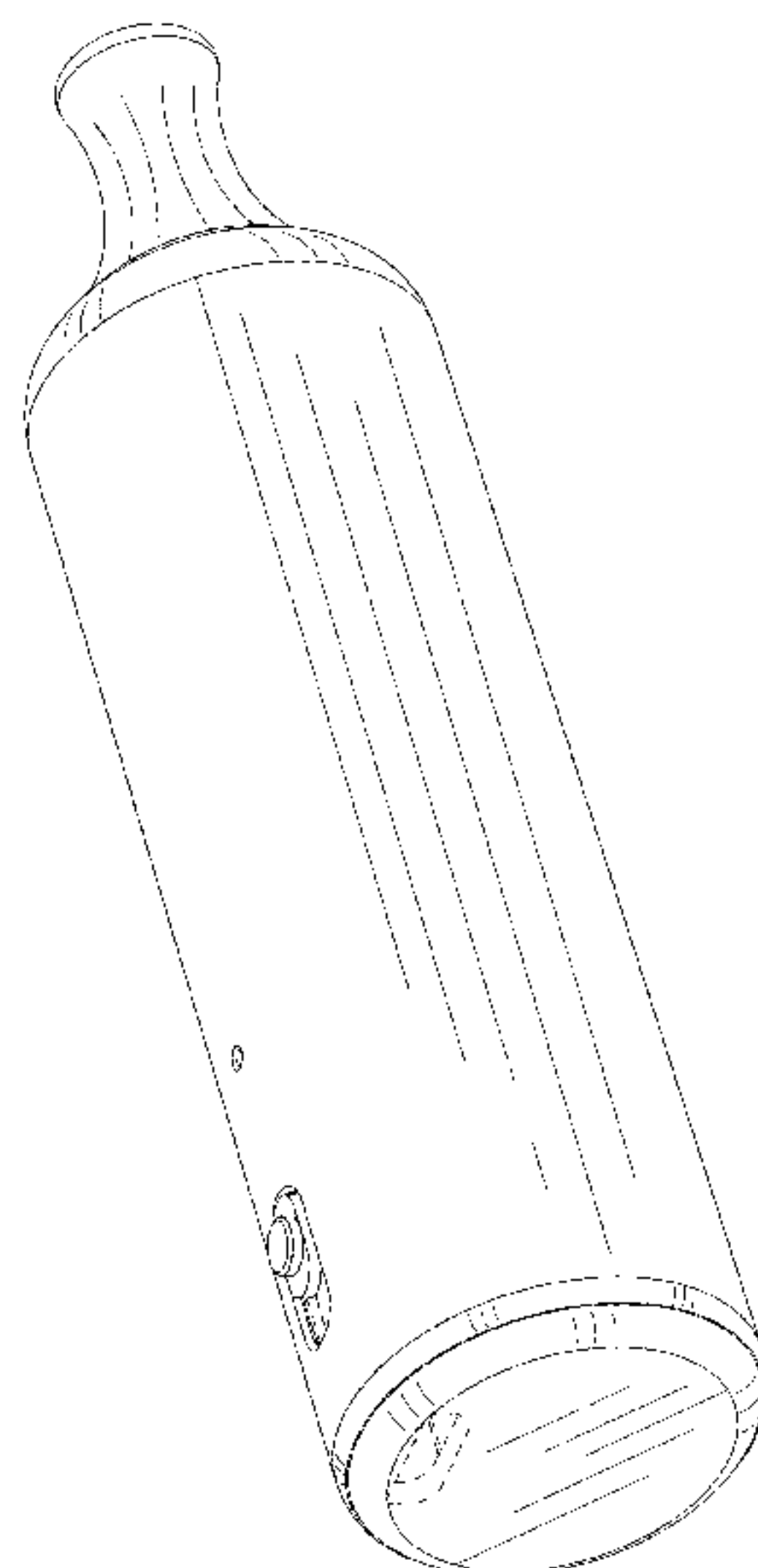
(57) **CLAIM**

The ornamental design for an electronic cigarette, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronic cigarette of the present disclosure;

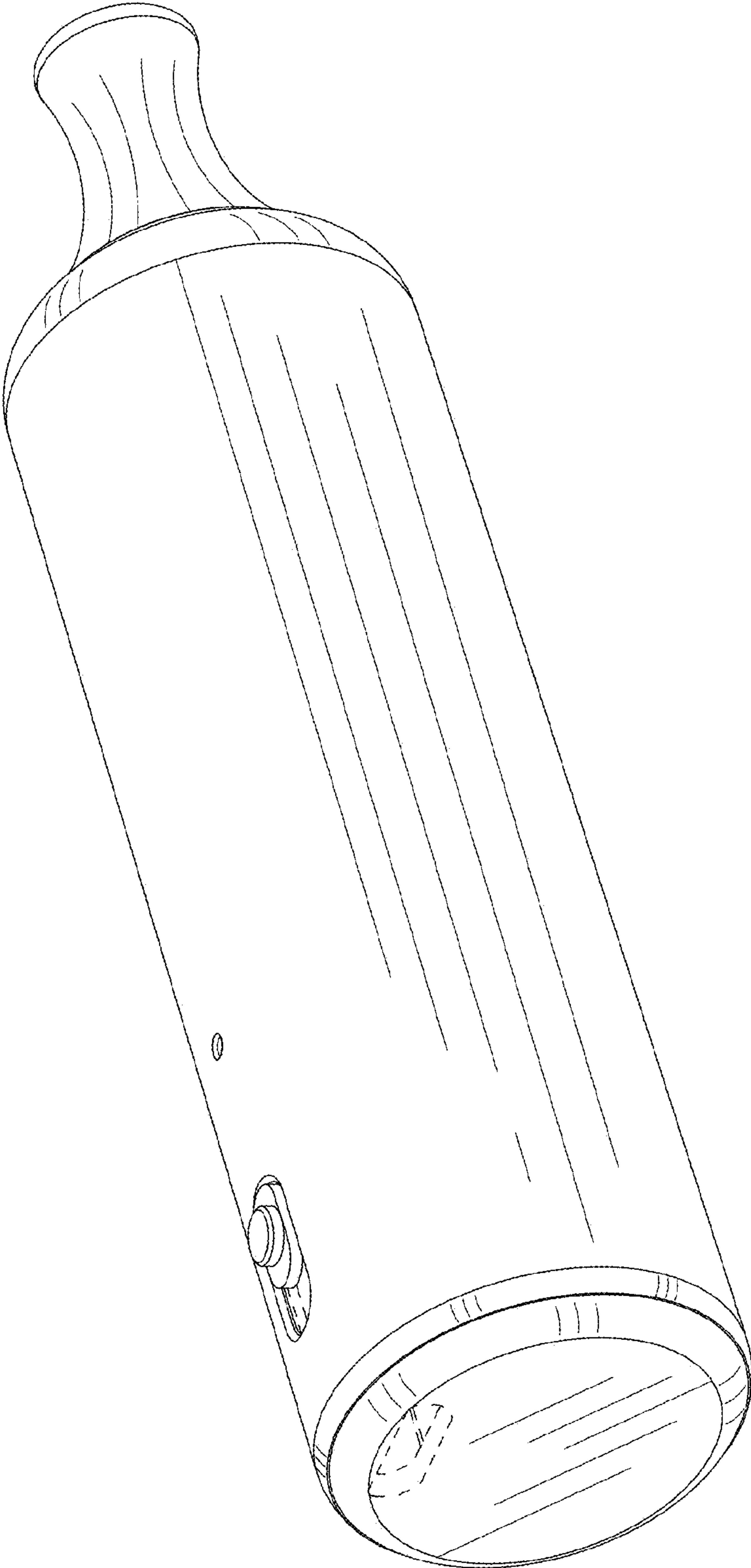

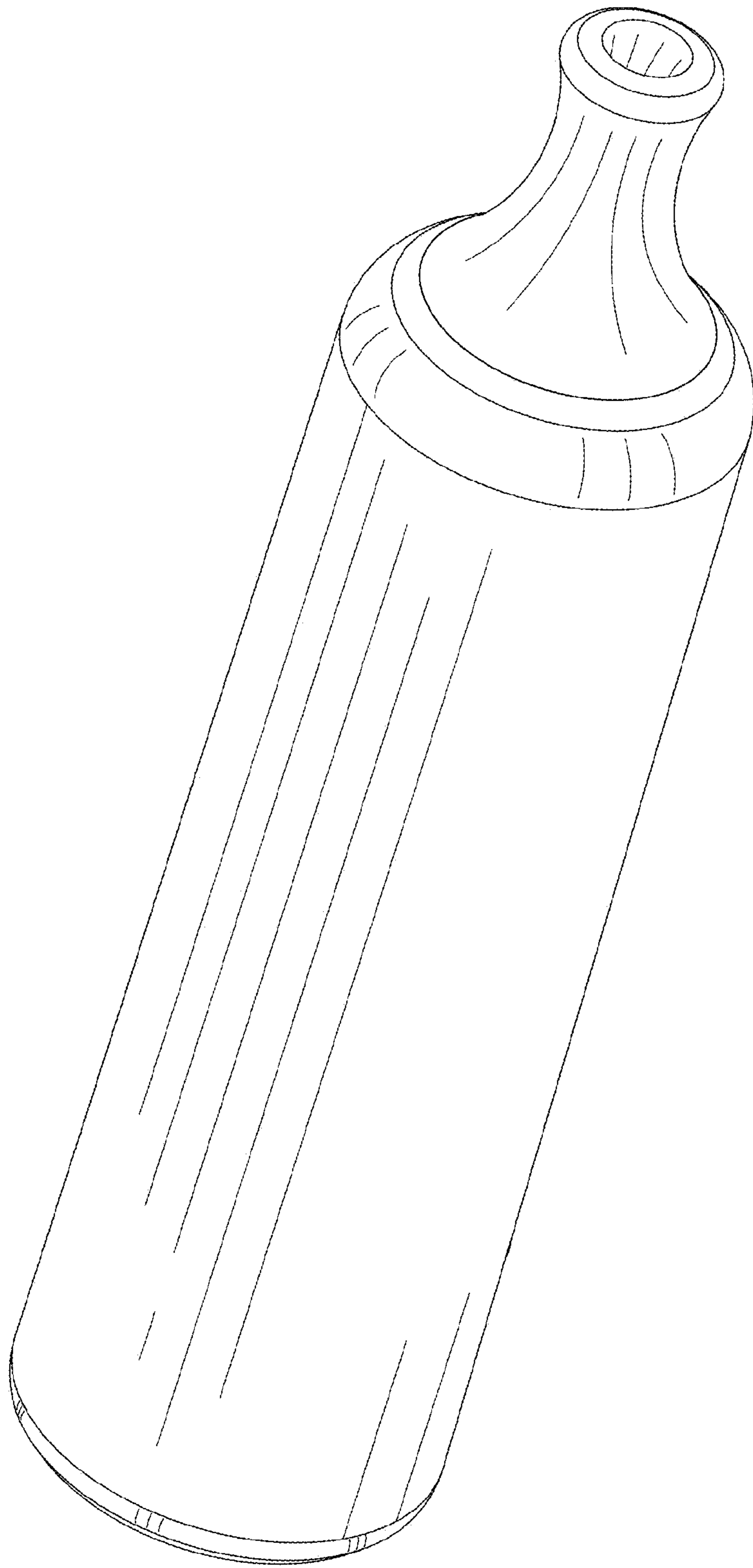

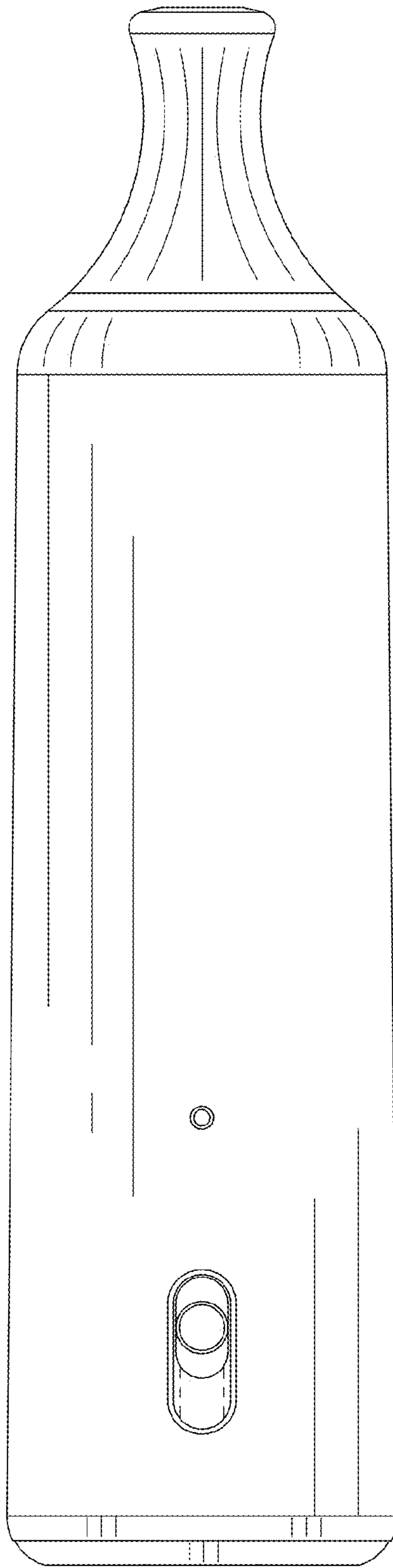

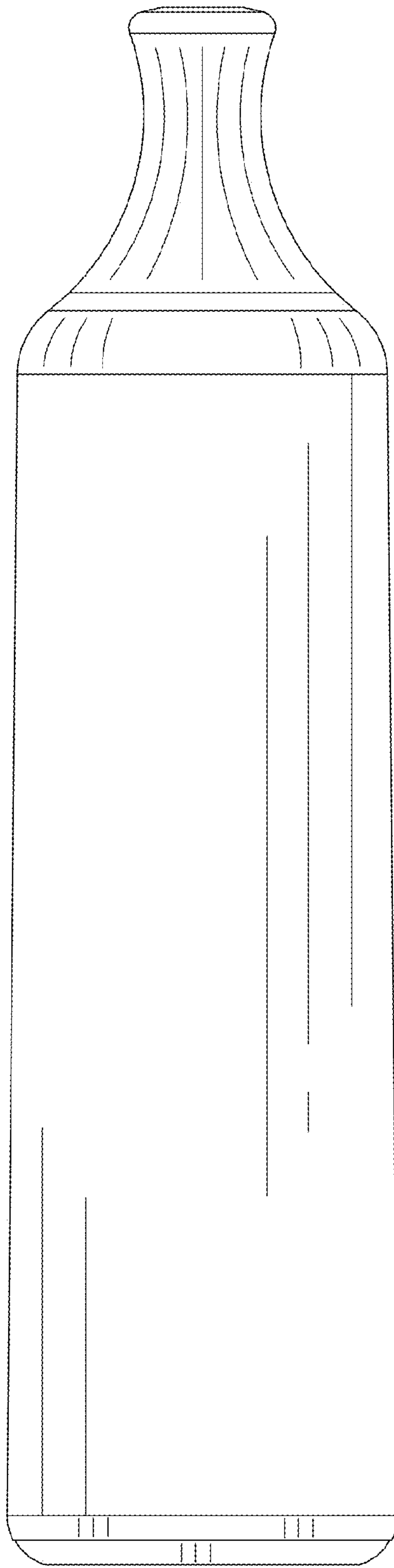

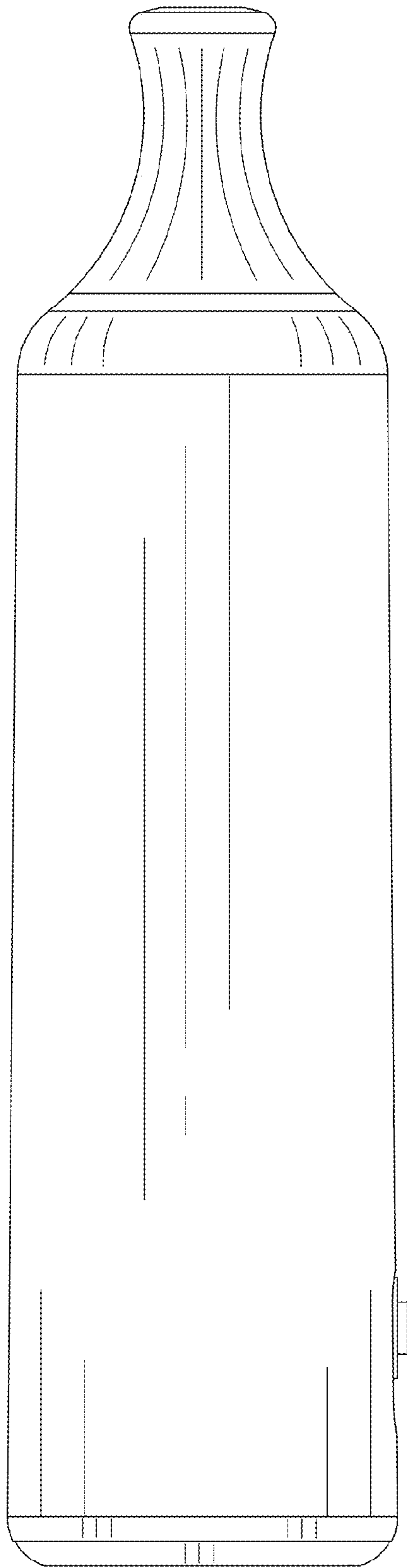

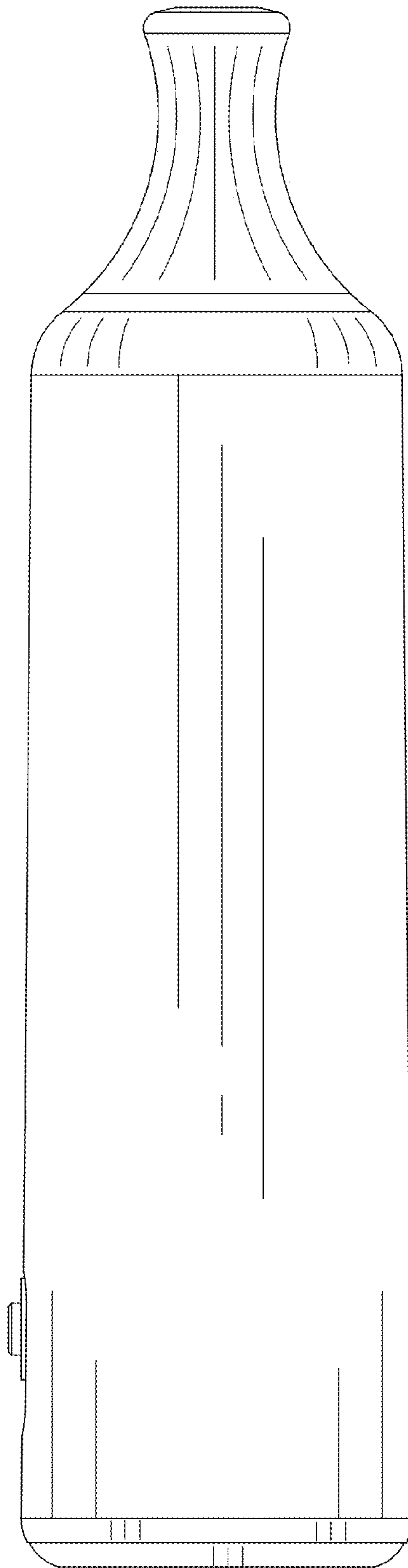

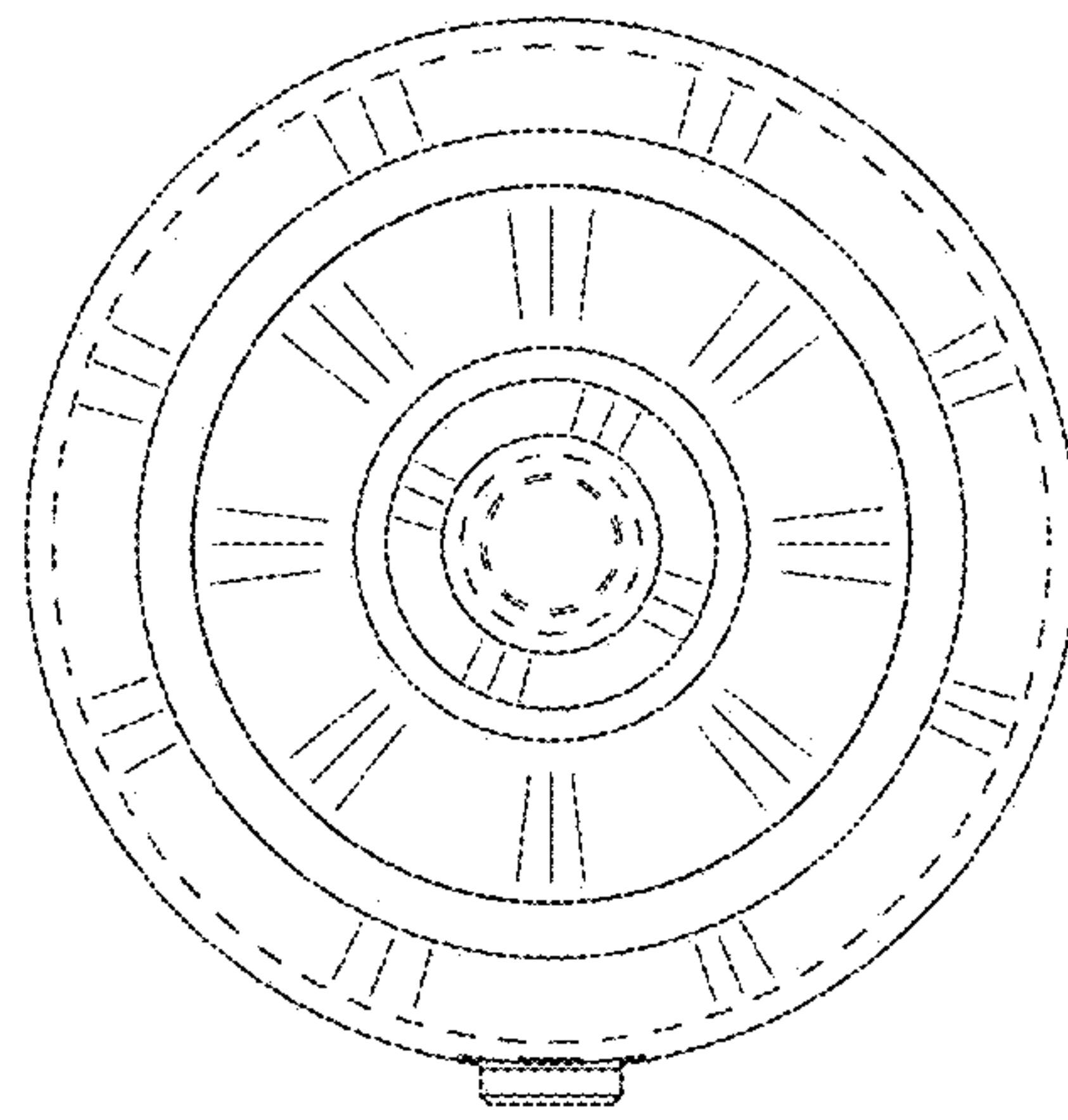

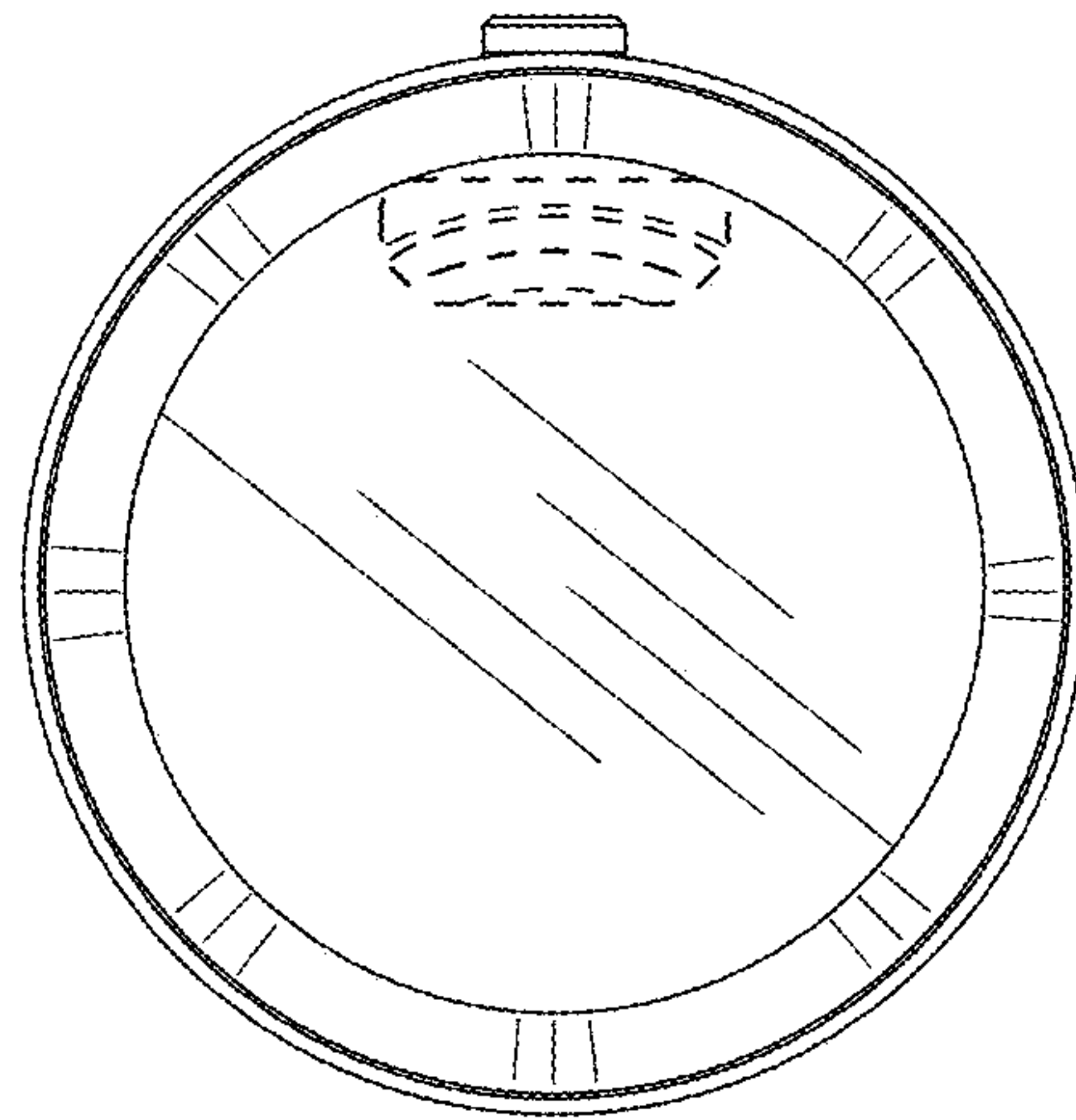
