(57) **CLAIM**

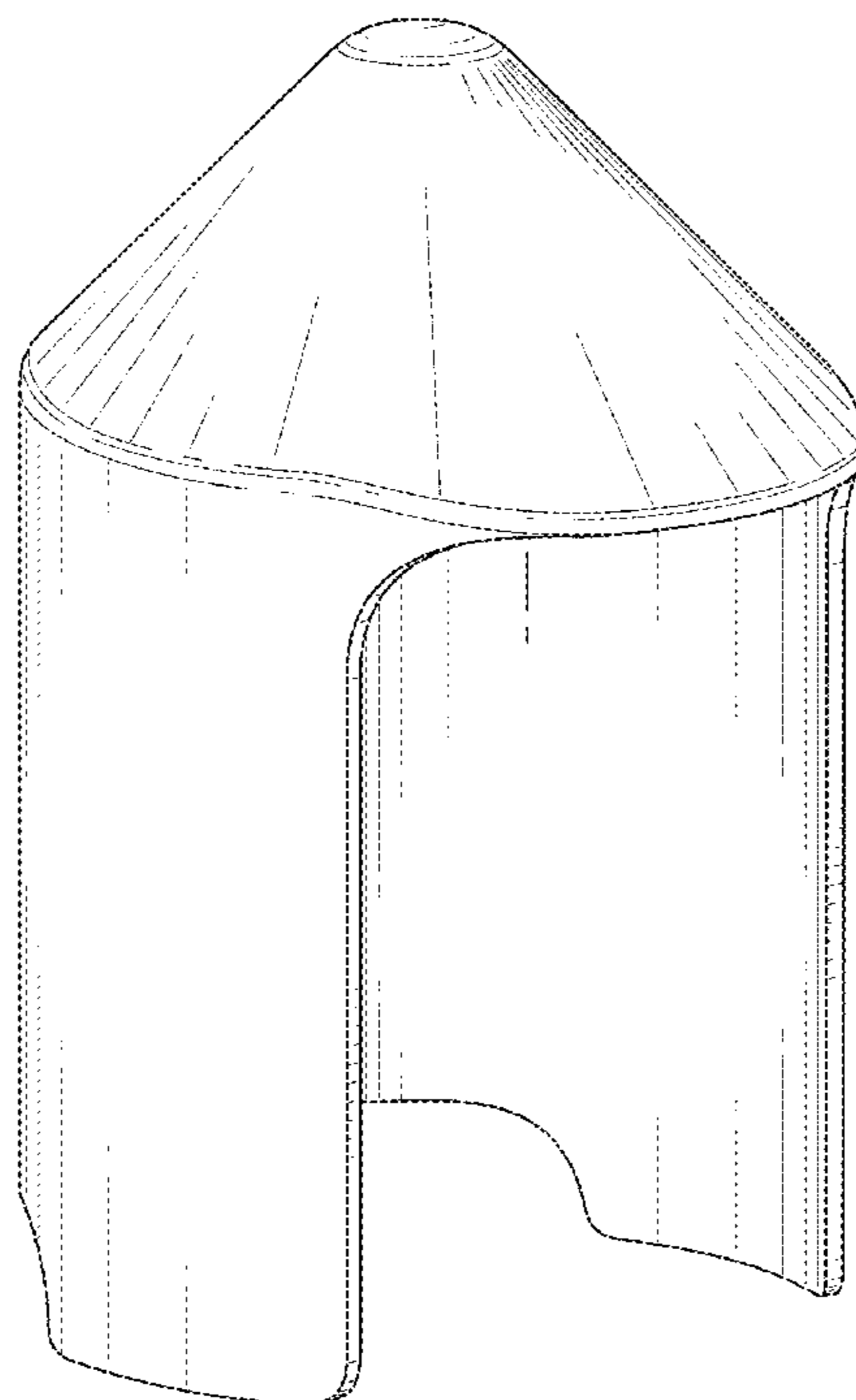
The ornamental design for a cover for watering cup, as shown and described.

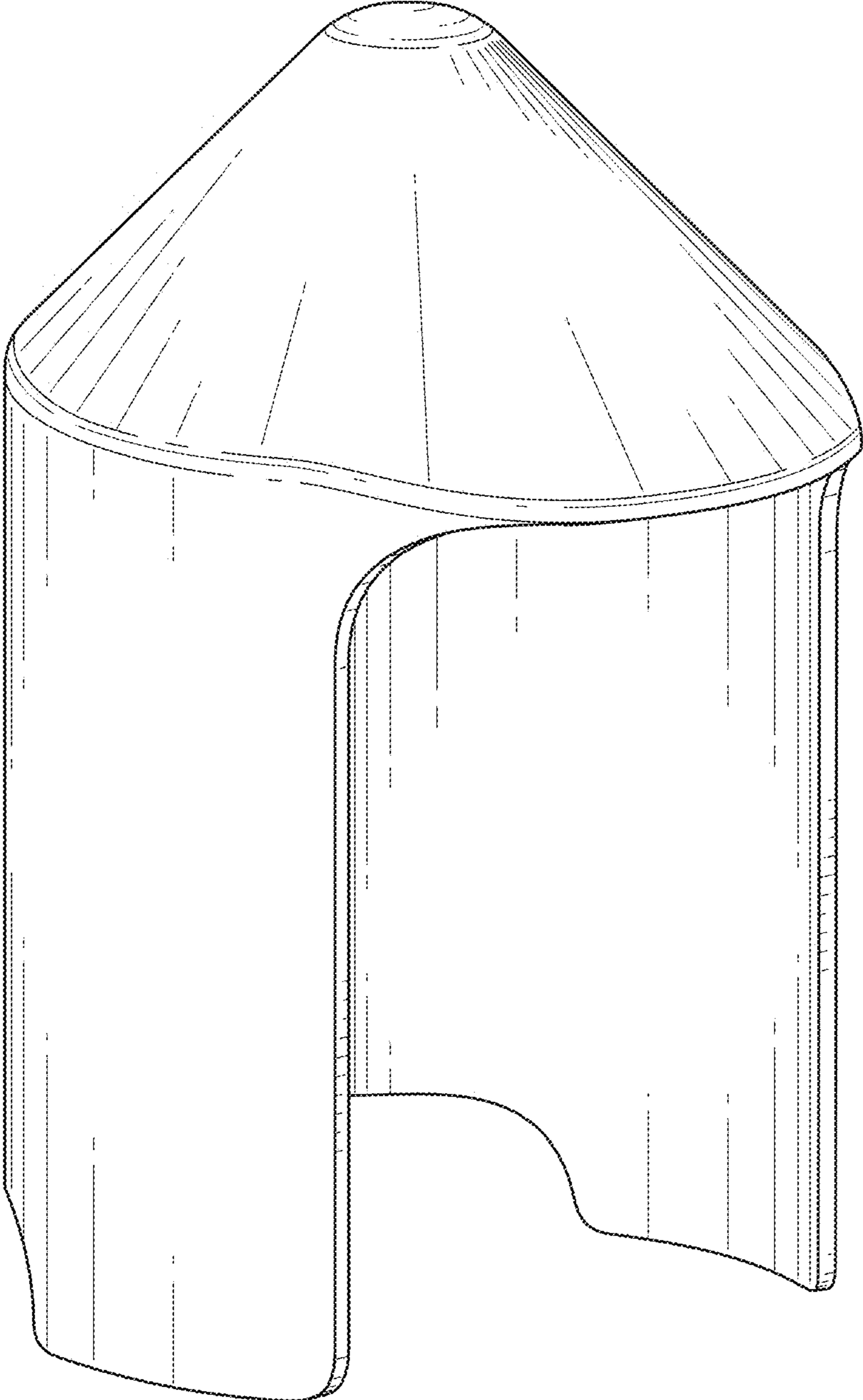

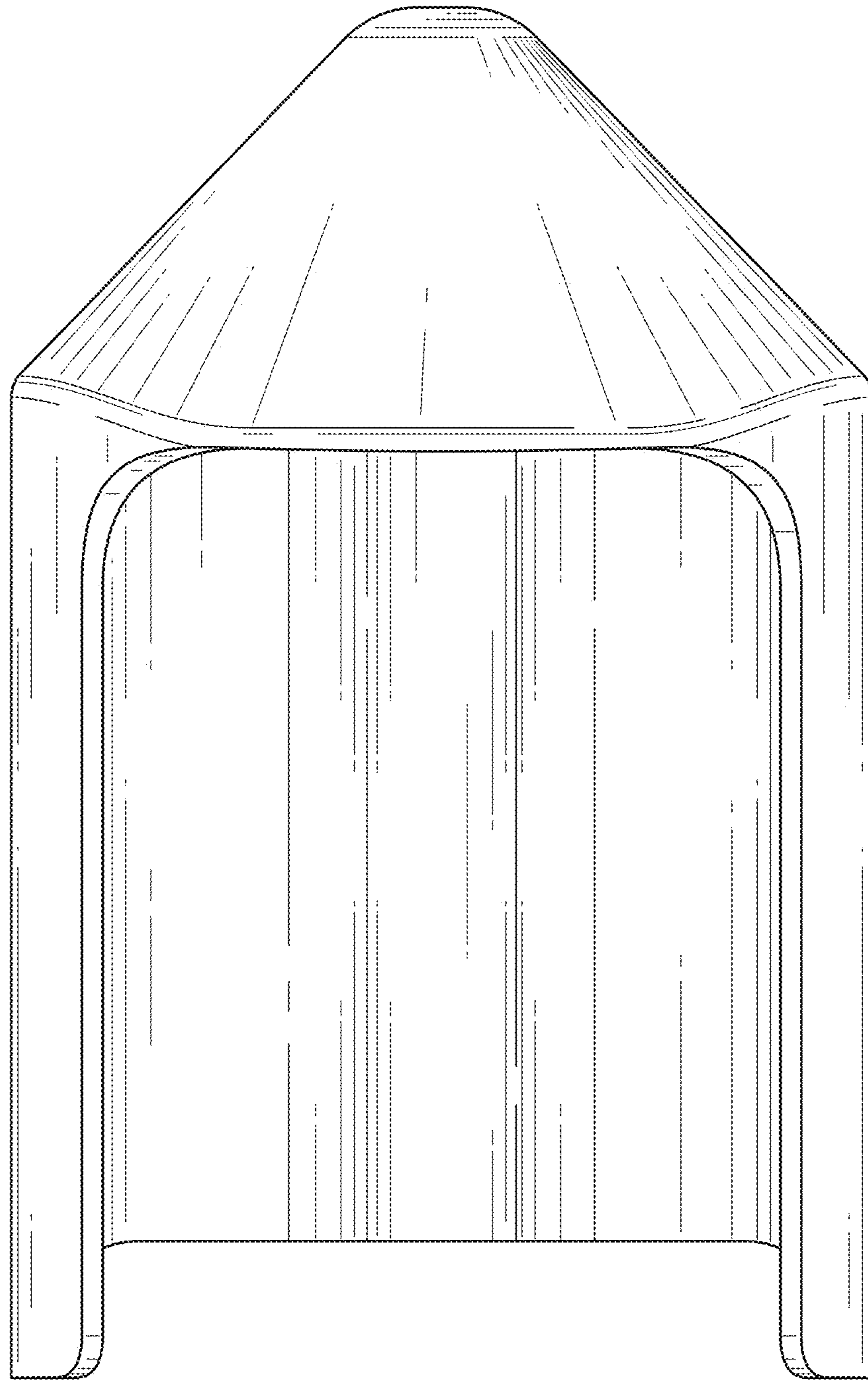

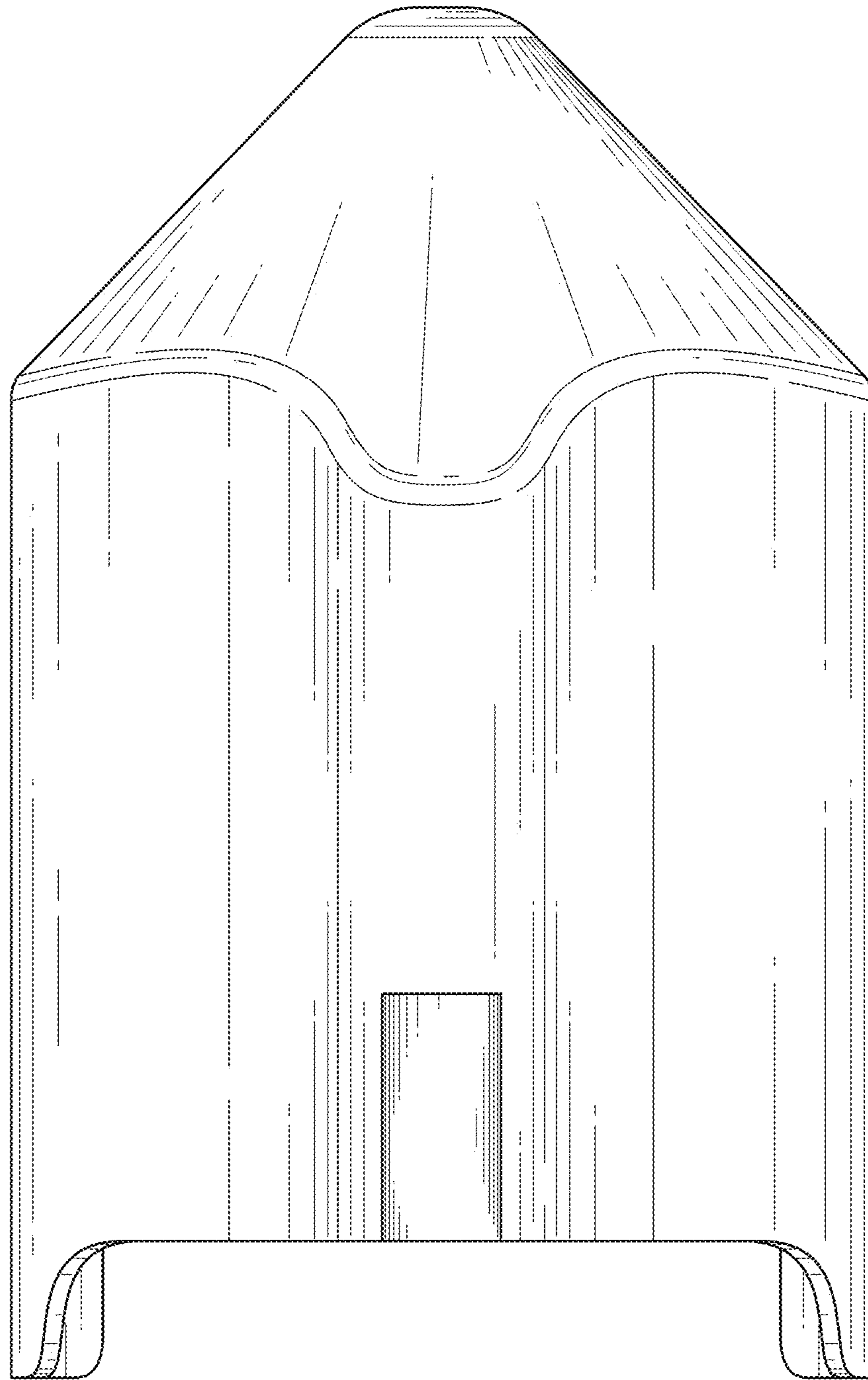

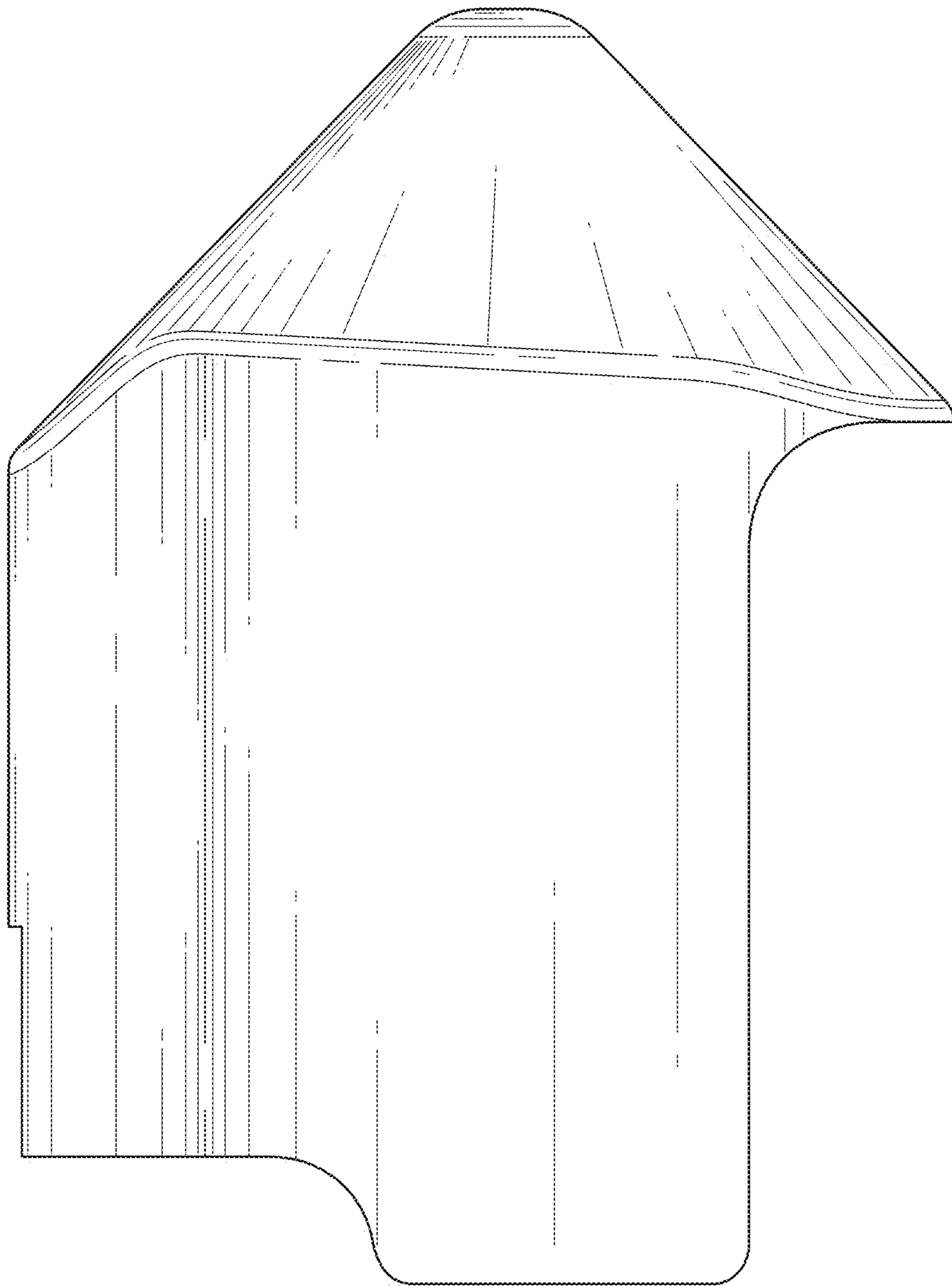

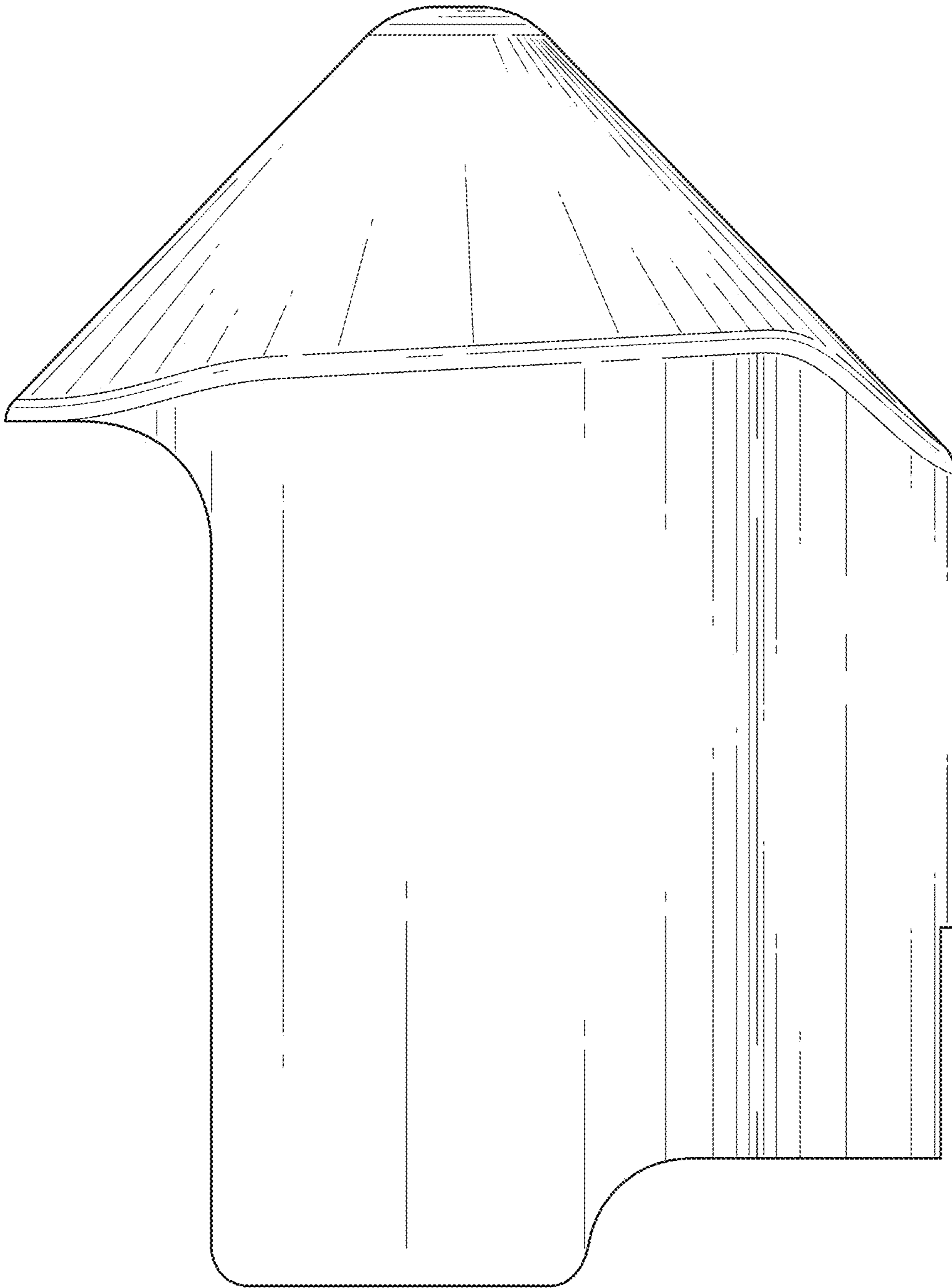

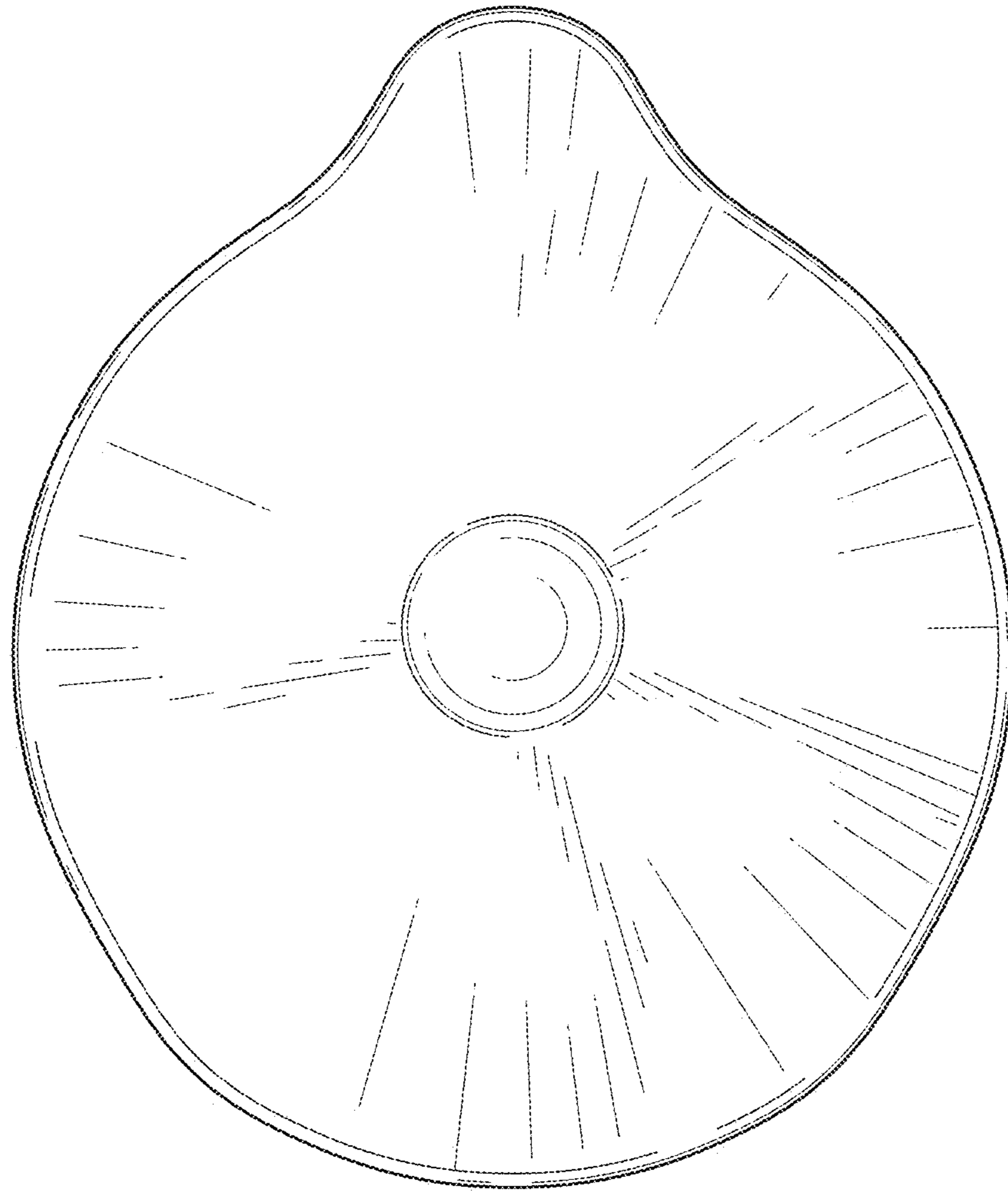

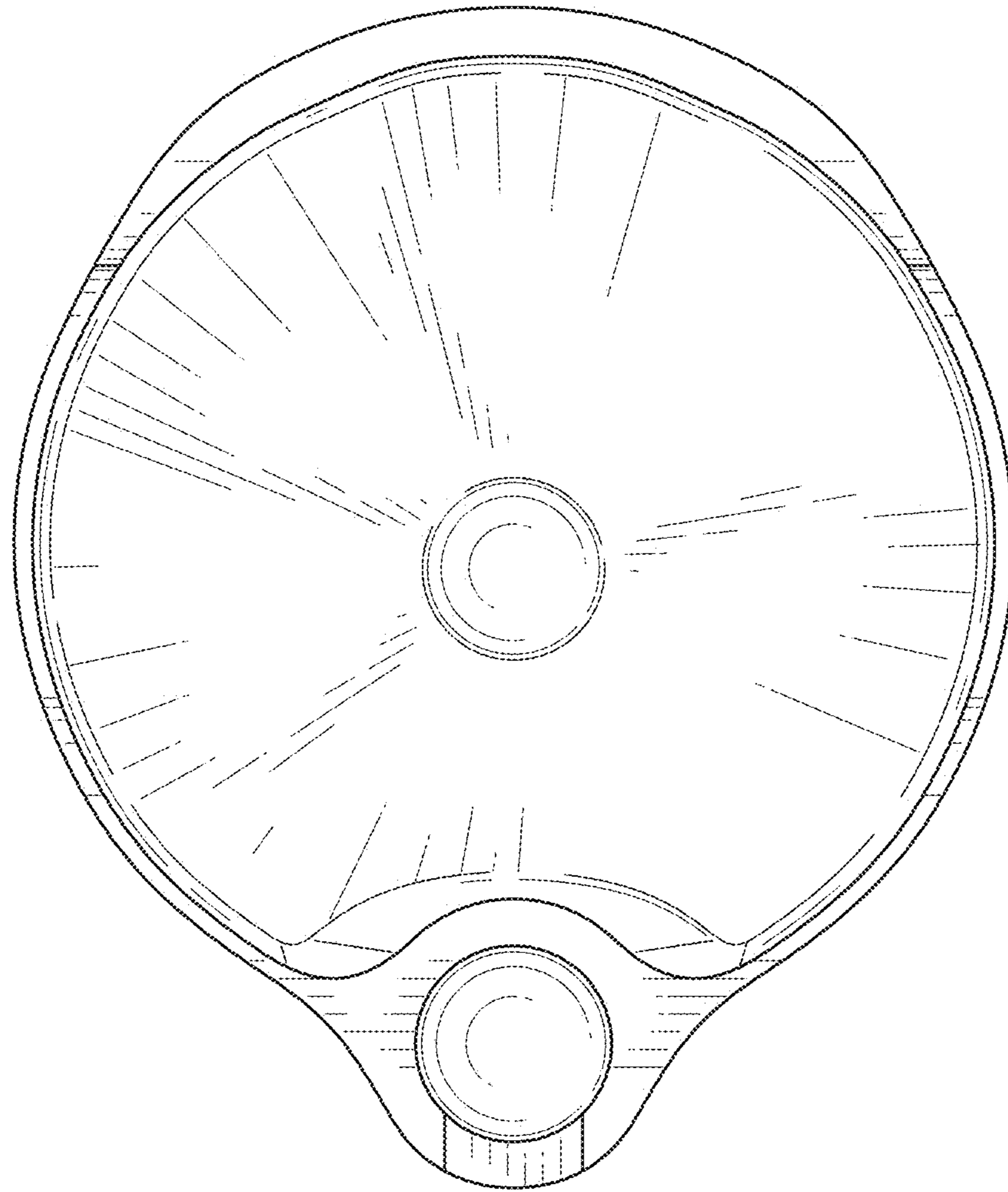

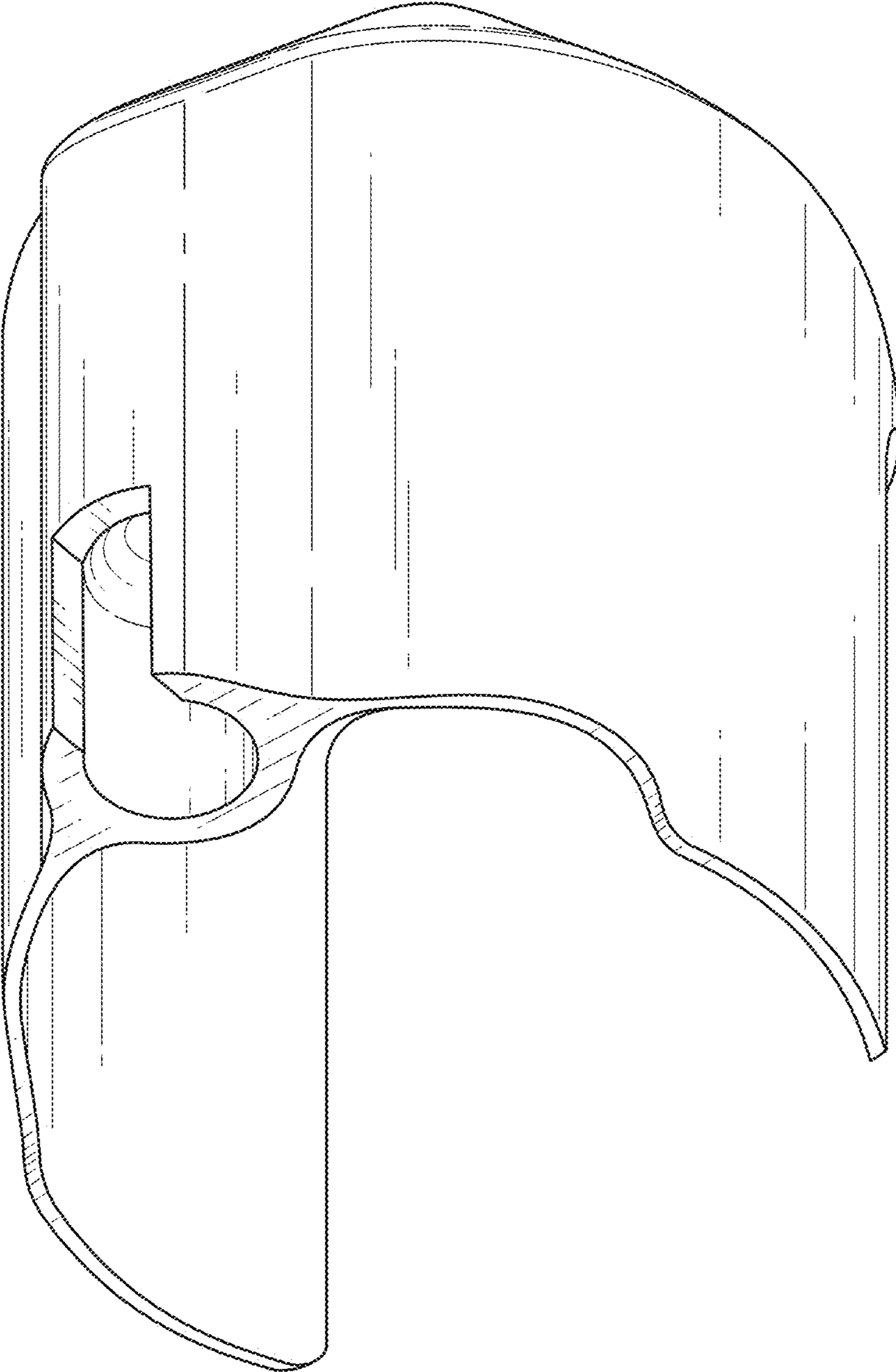
