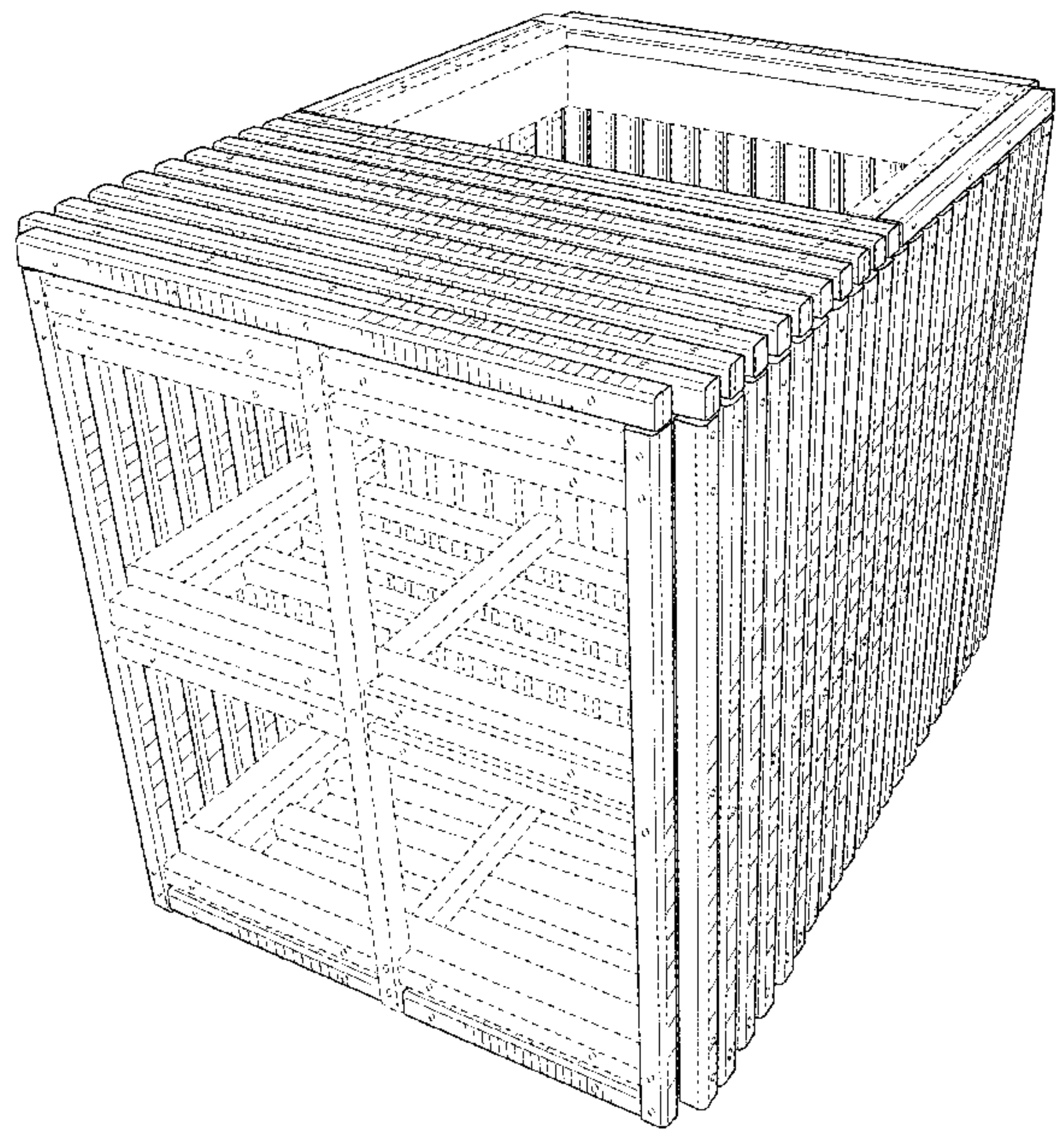

The ornamental design for a beach cleaning station, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of of a beach cleaning station showing the first embodiment of my new design;

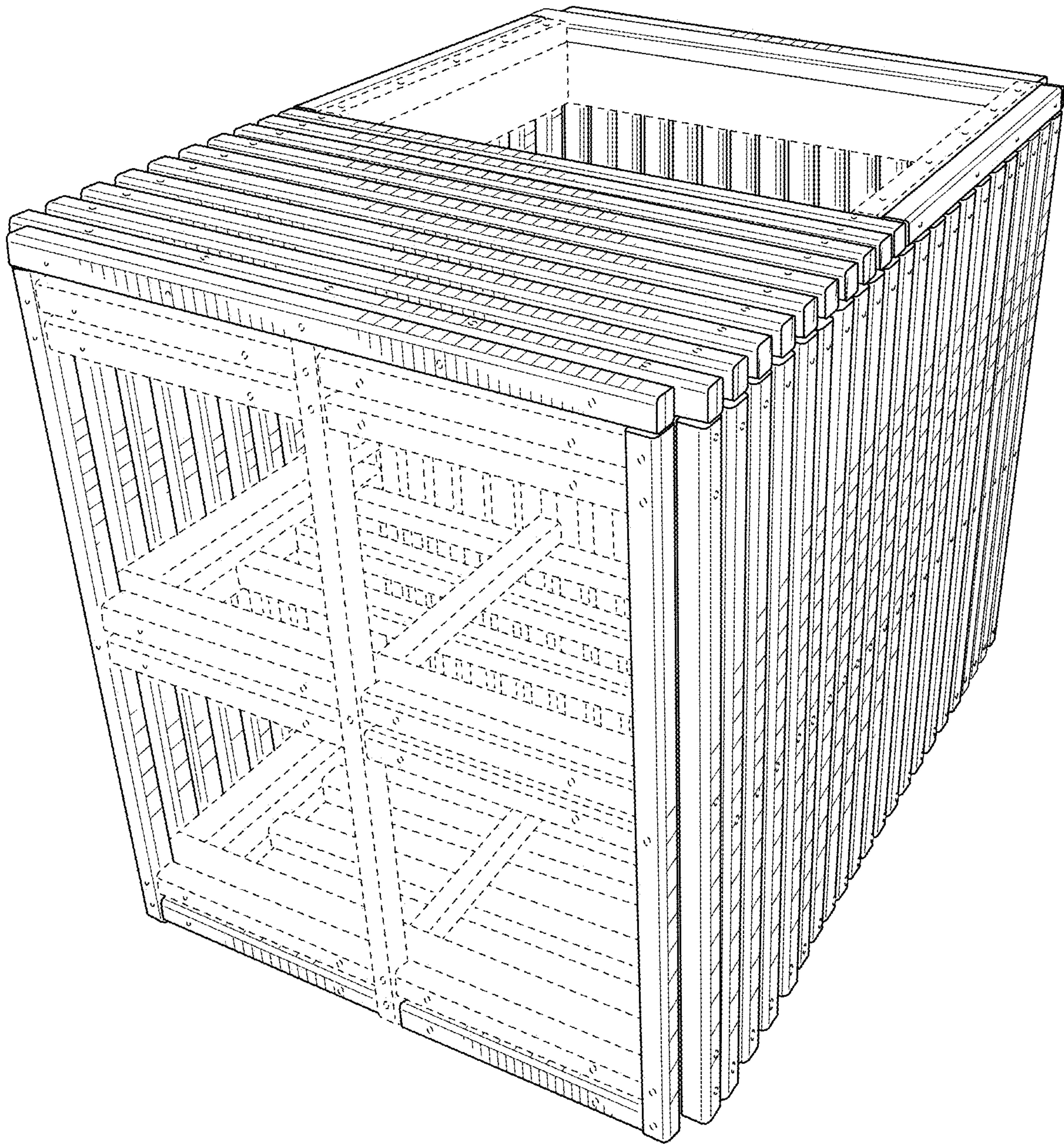

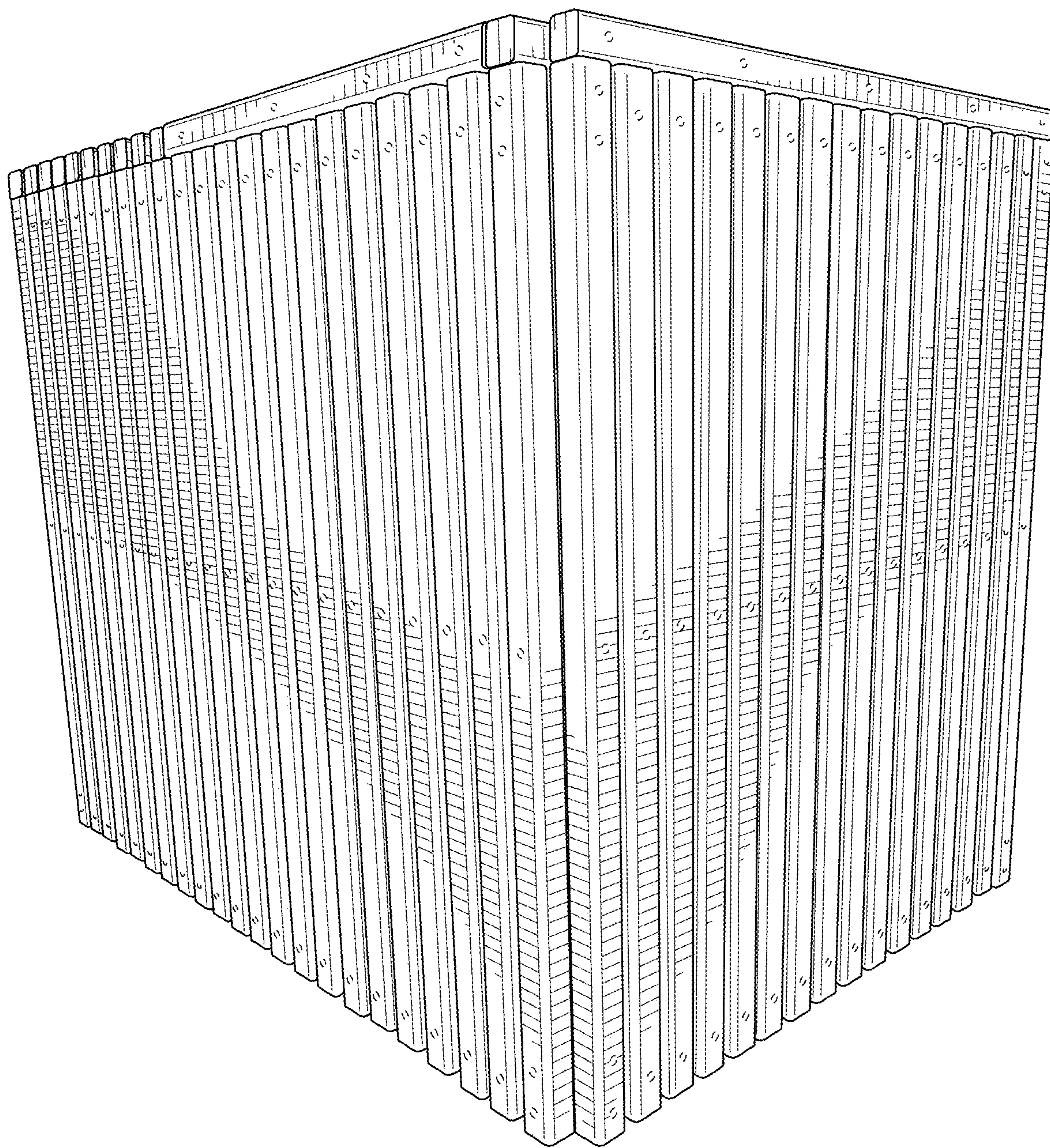

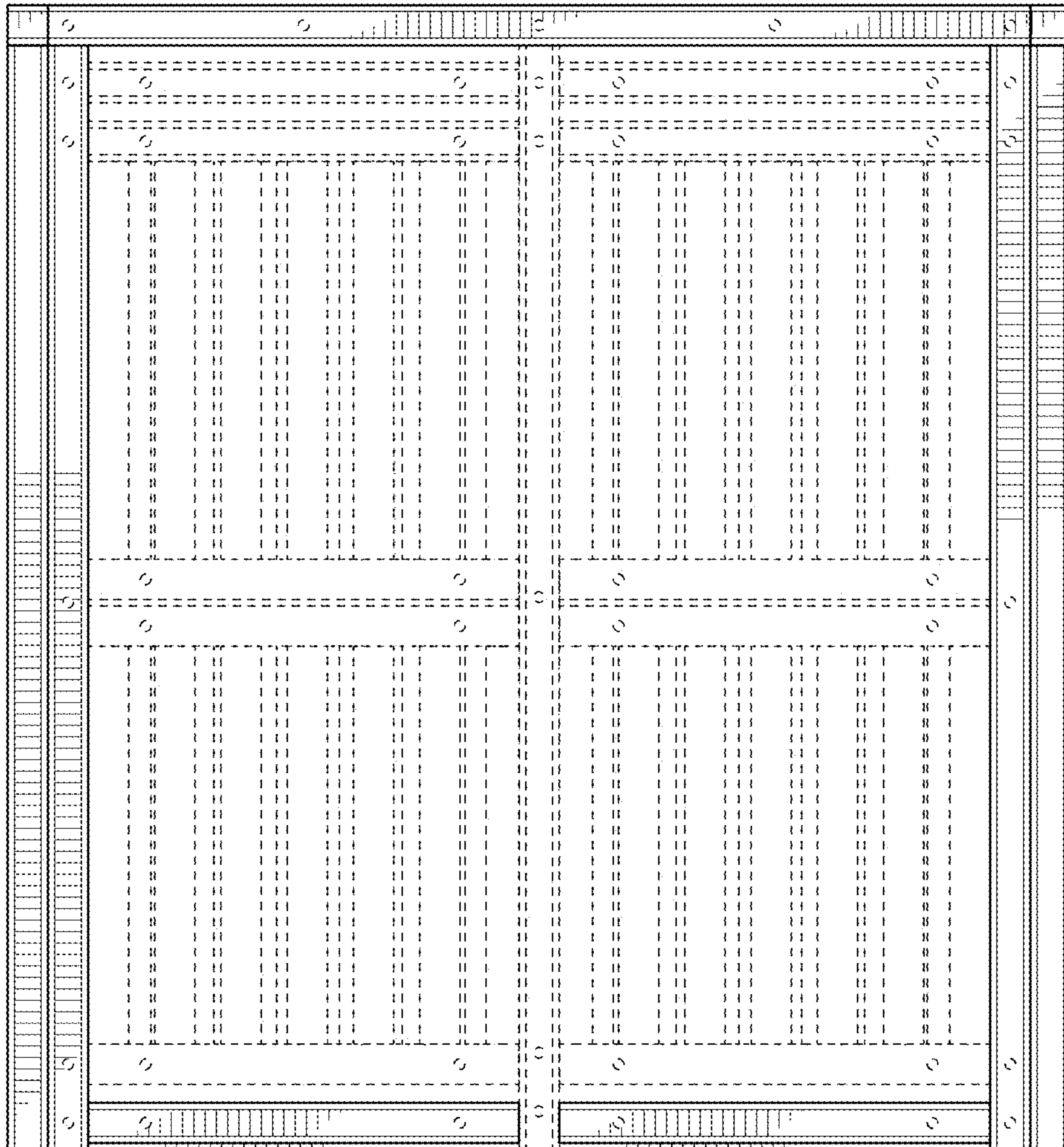

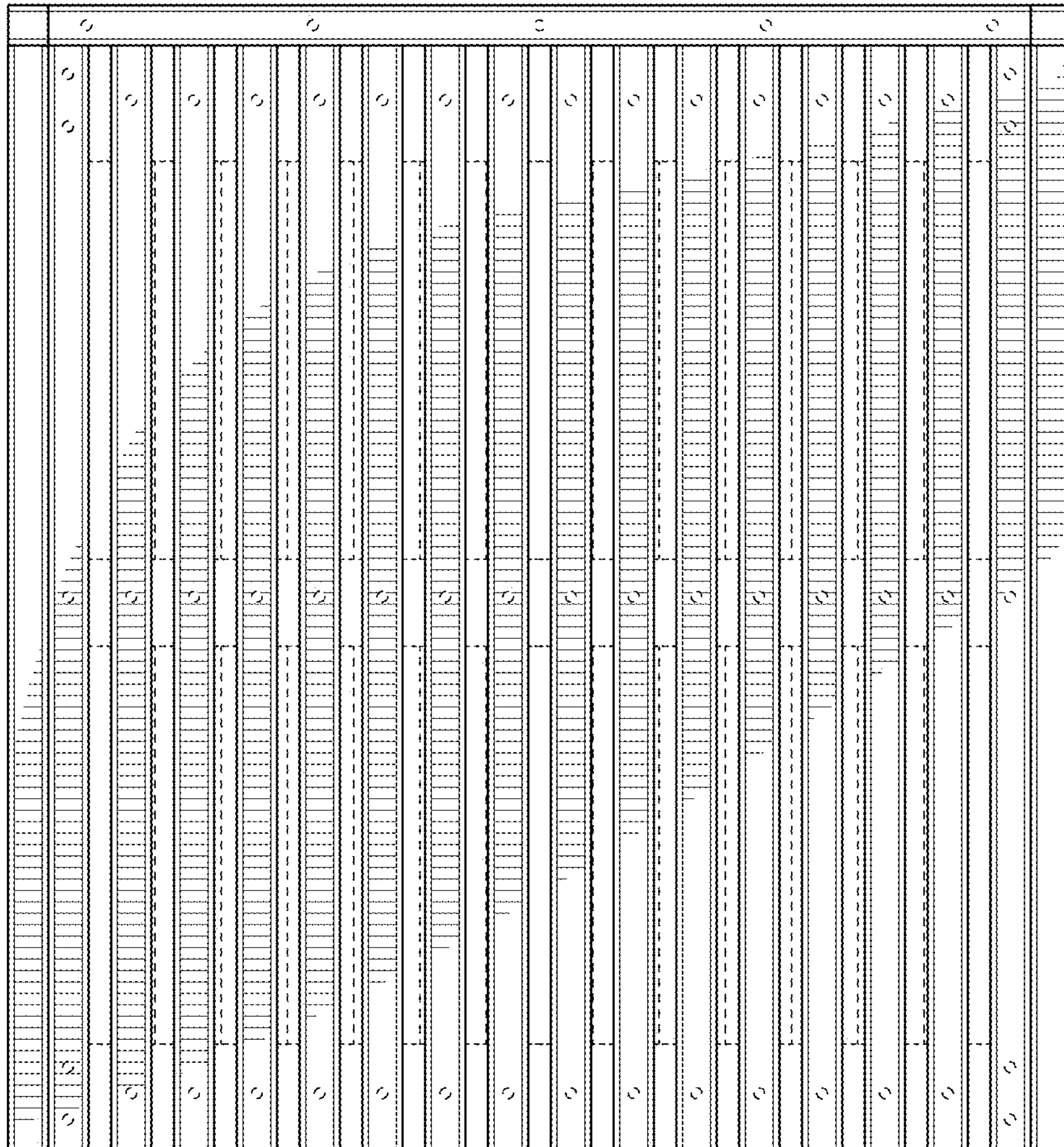

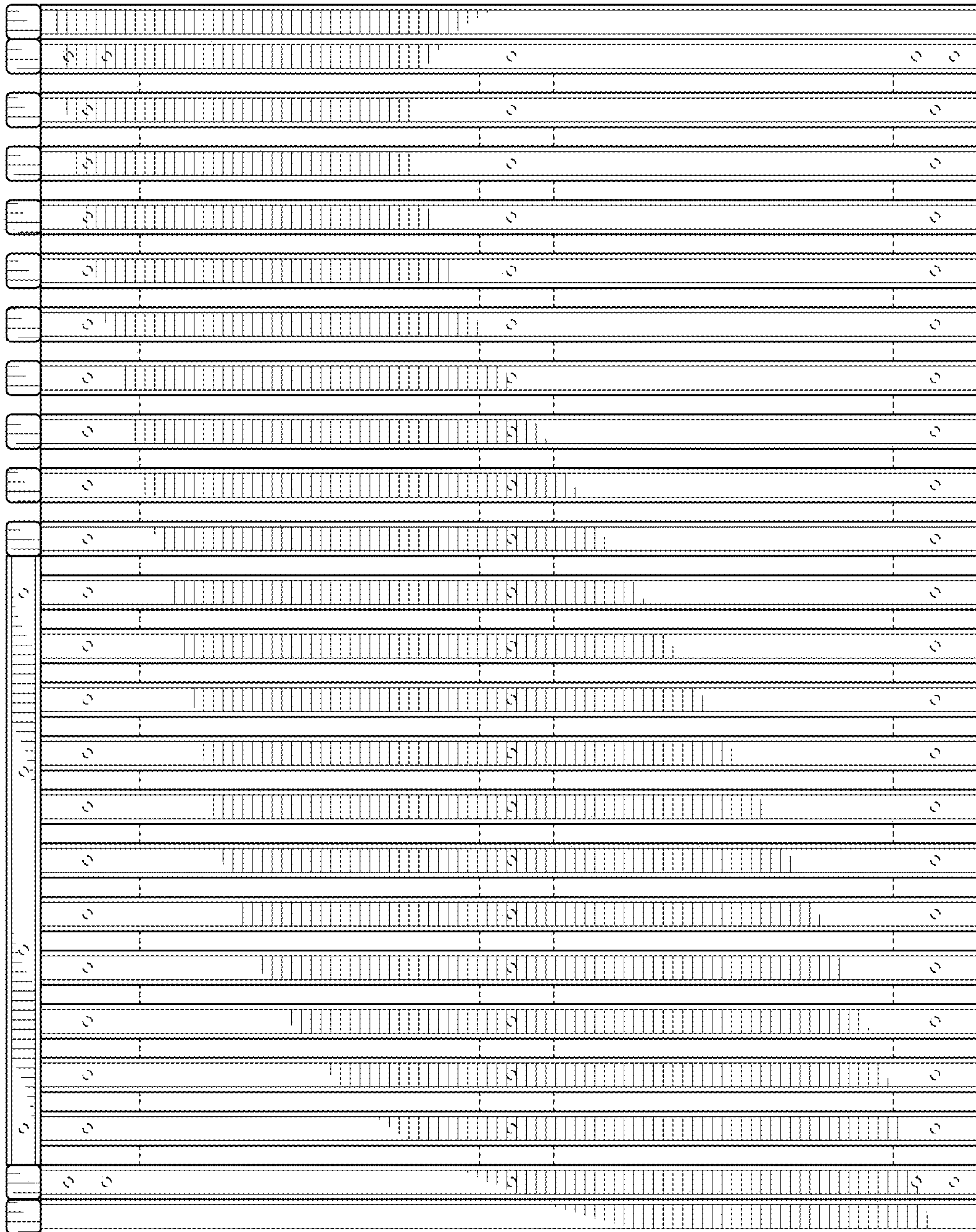

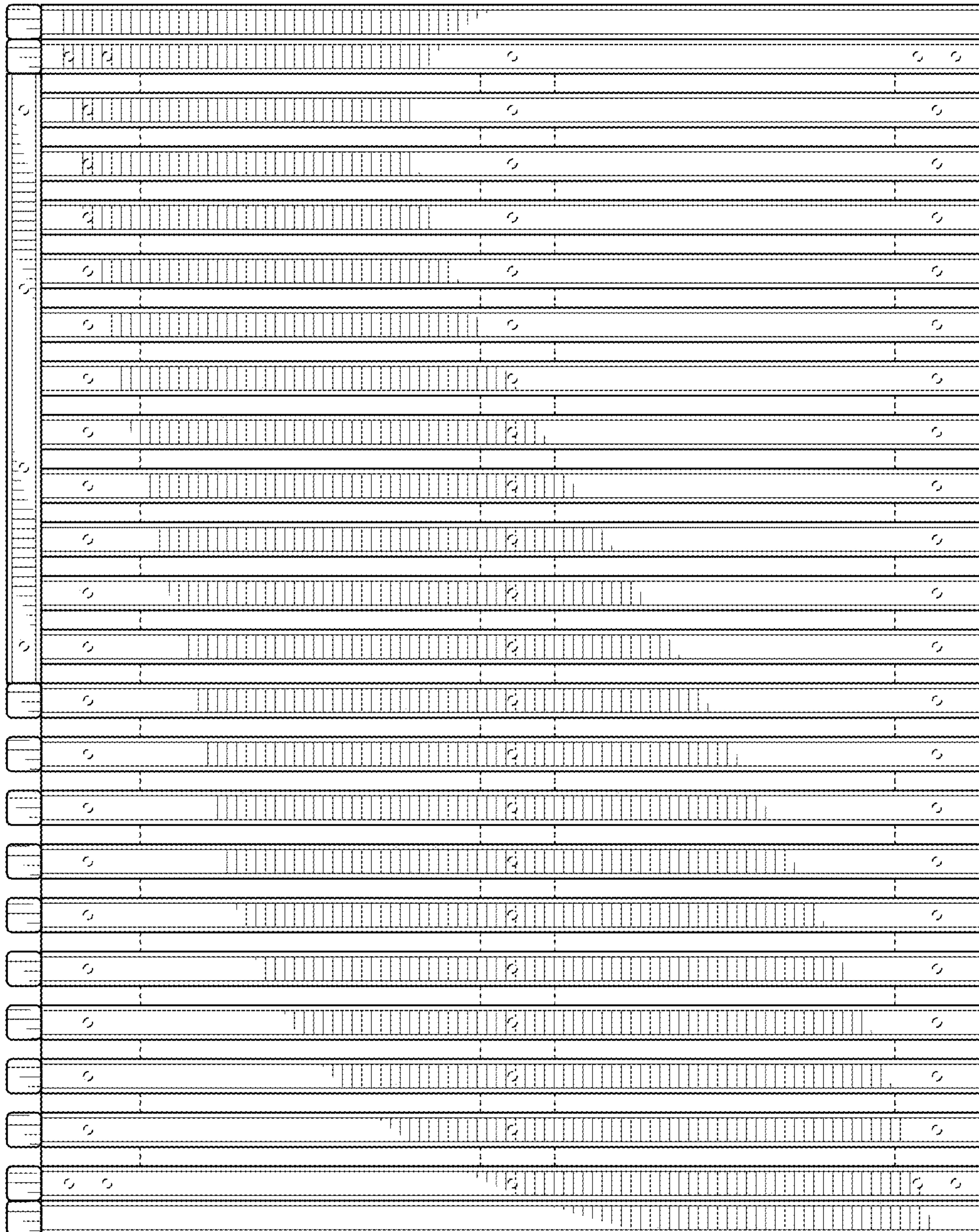

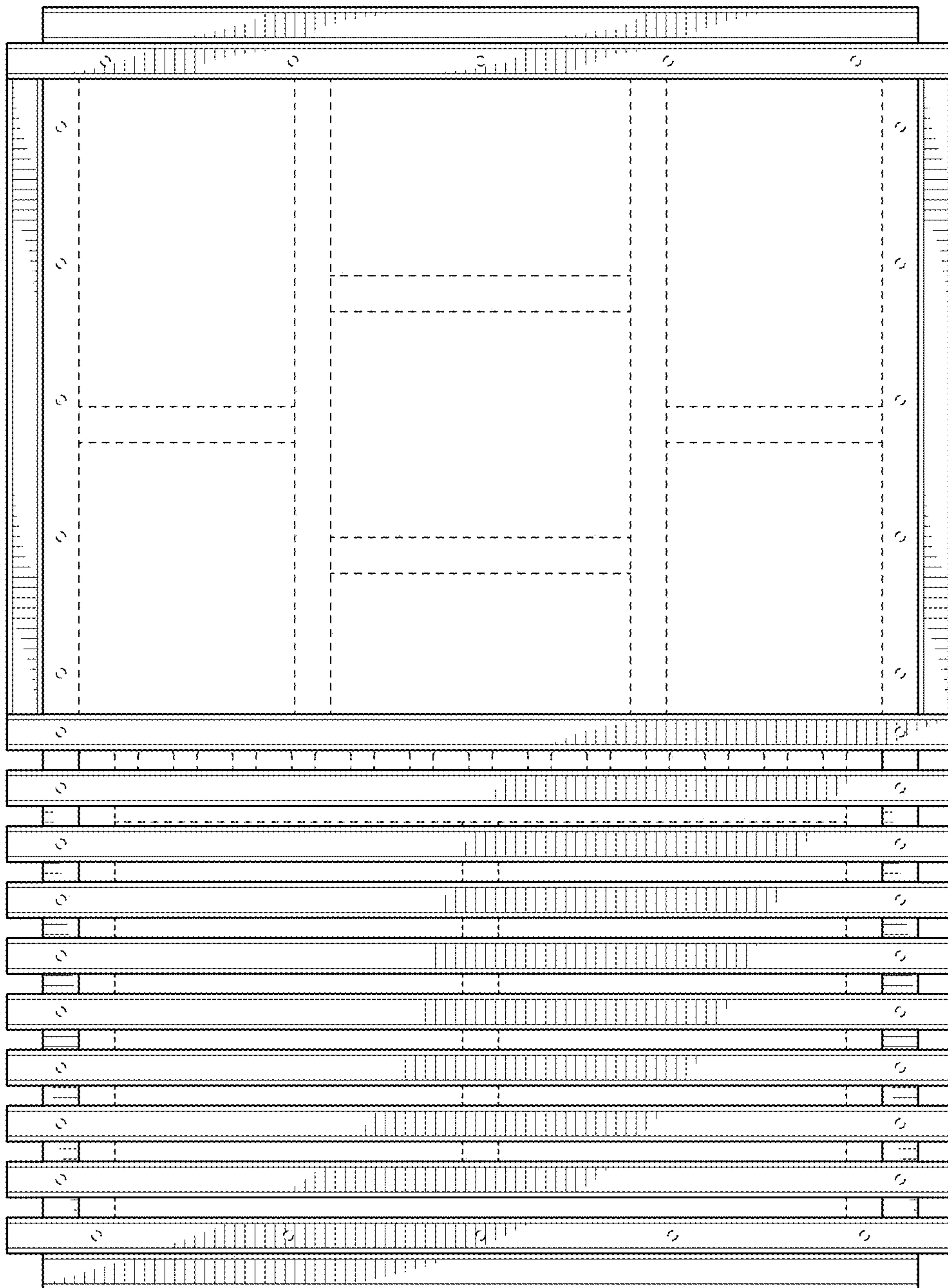

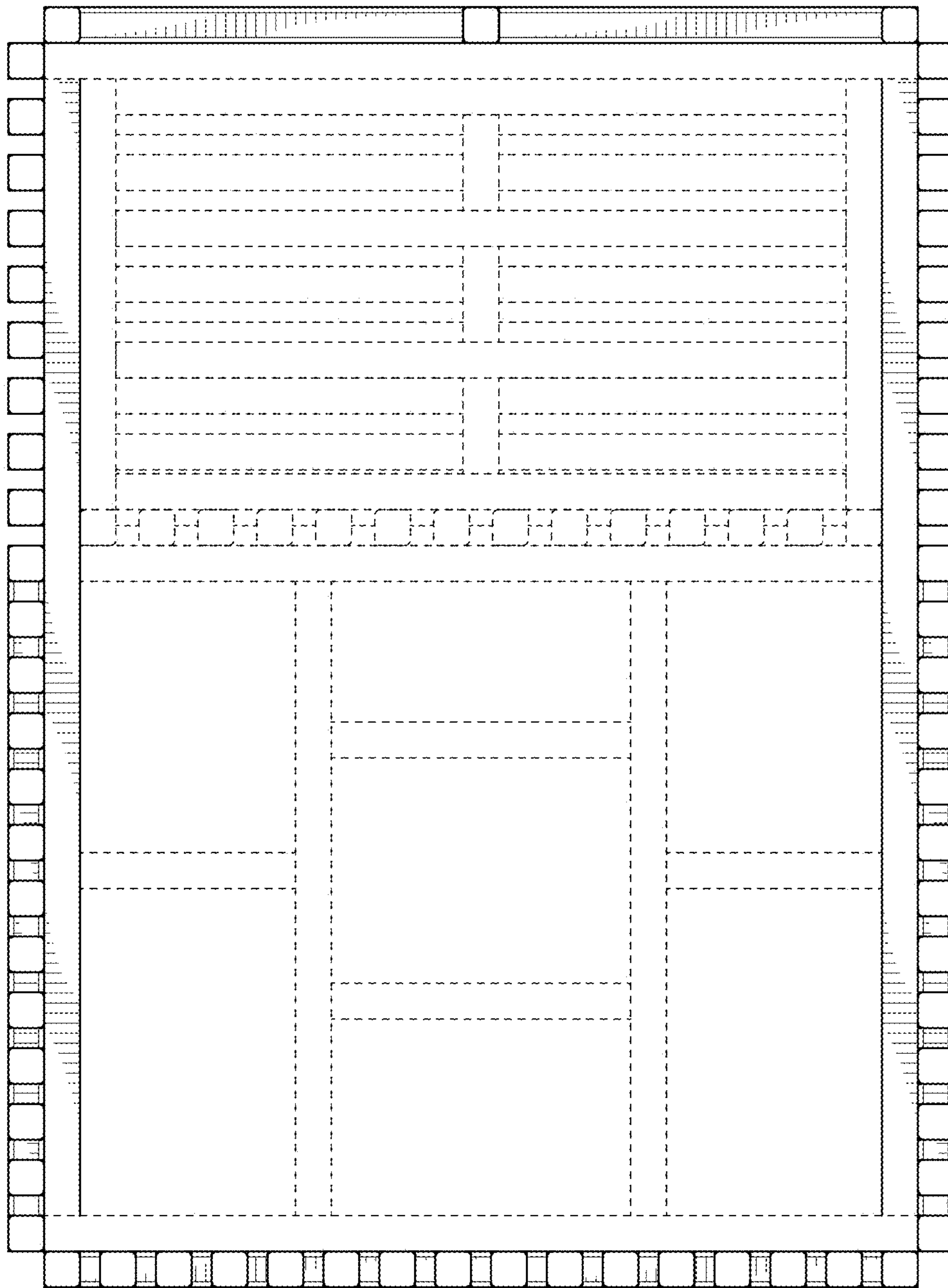

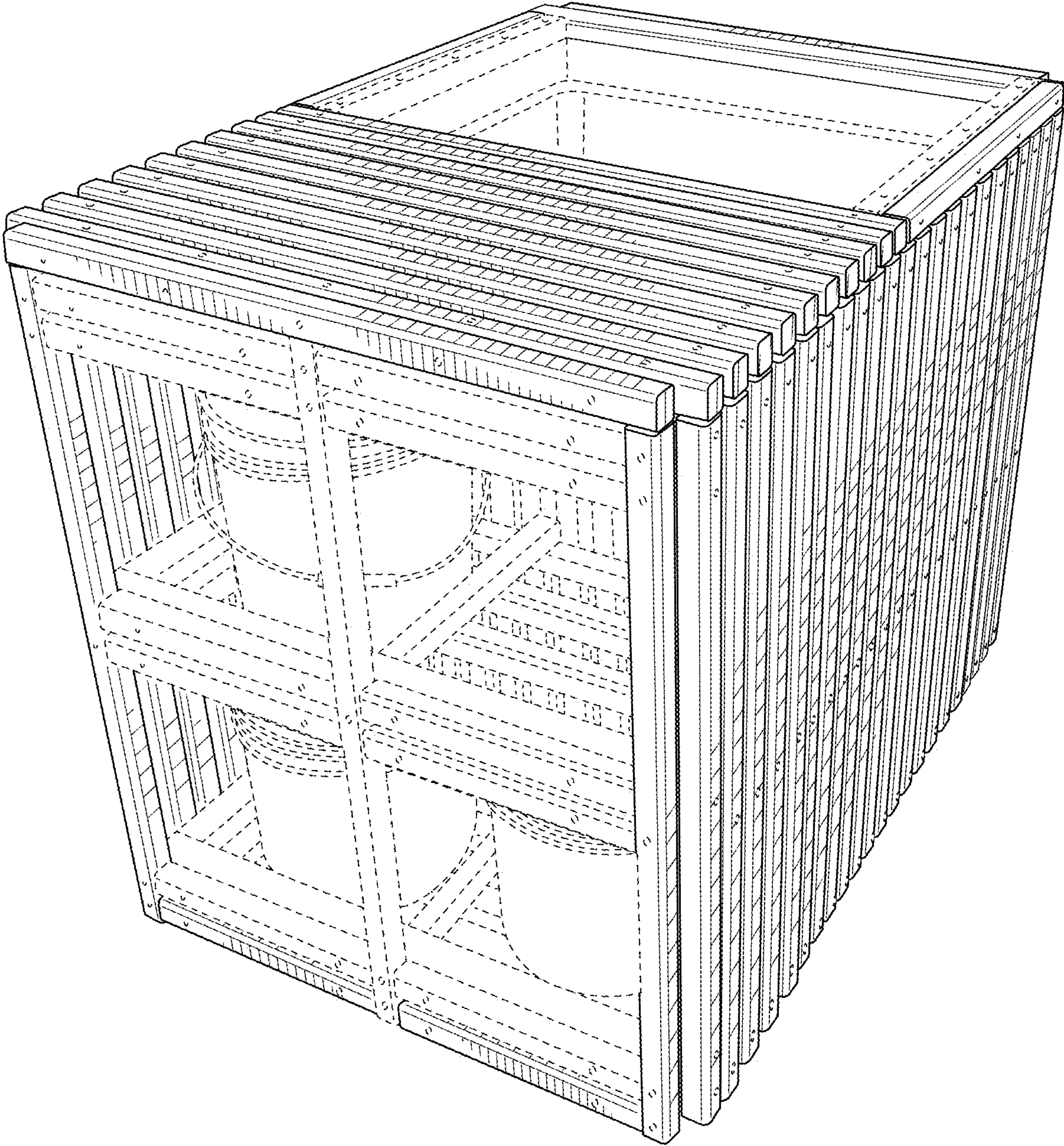

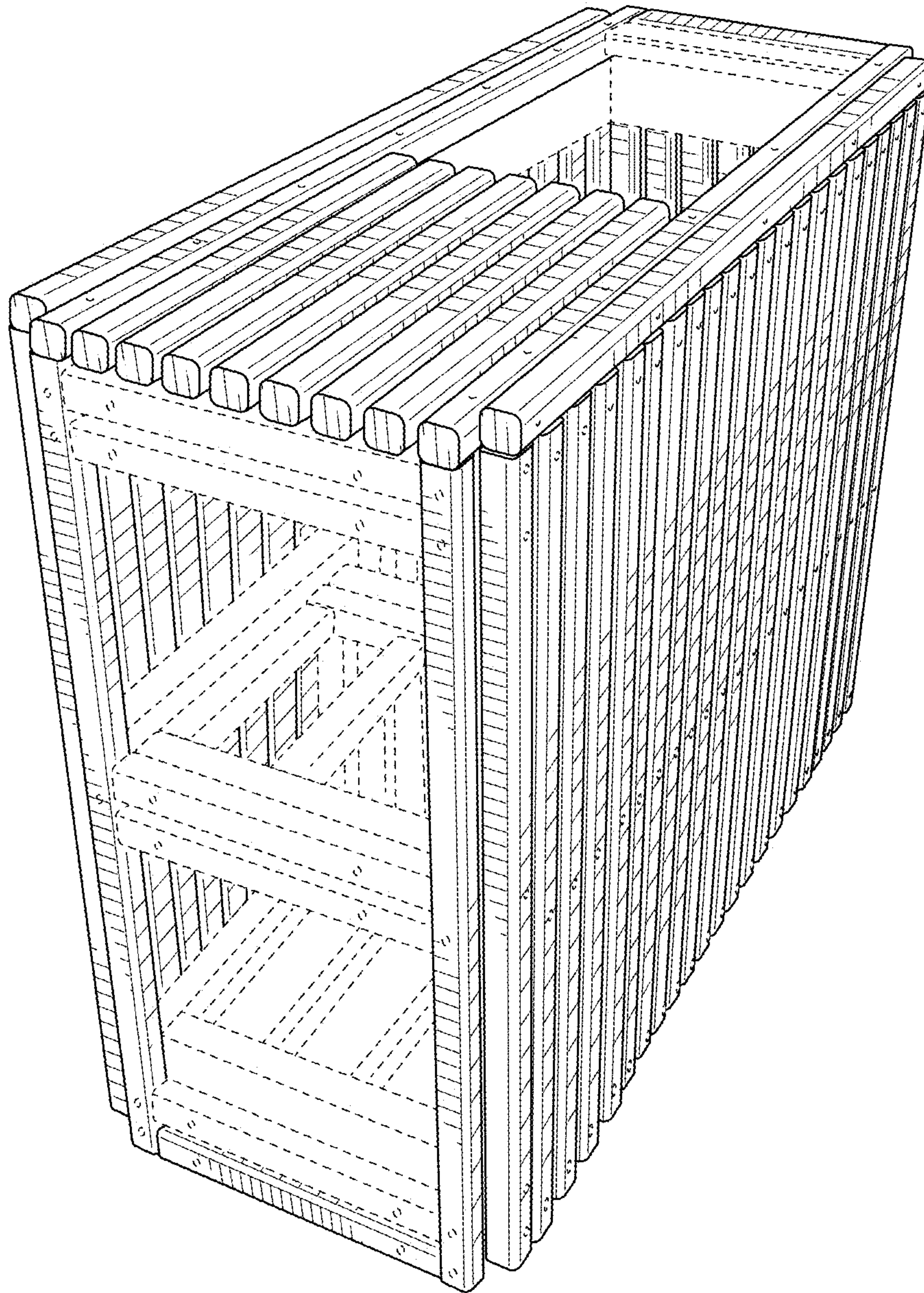

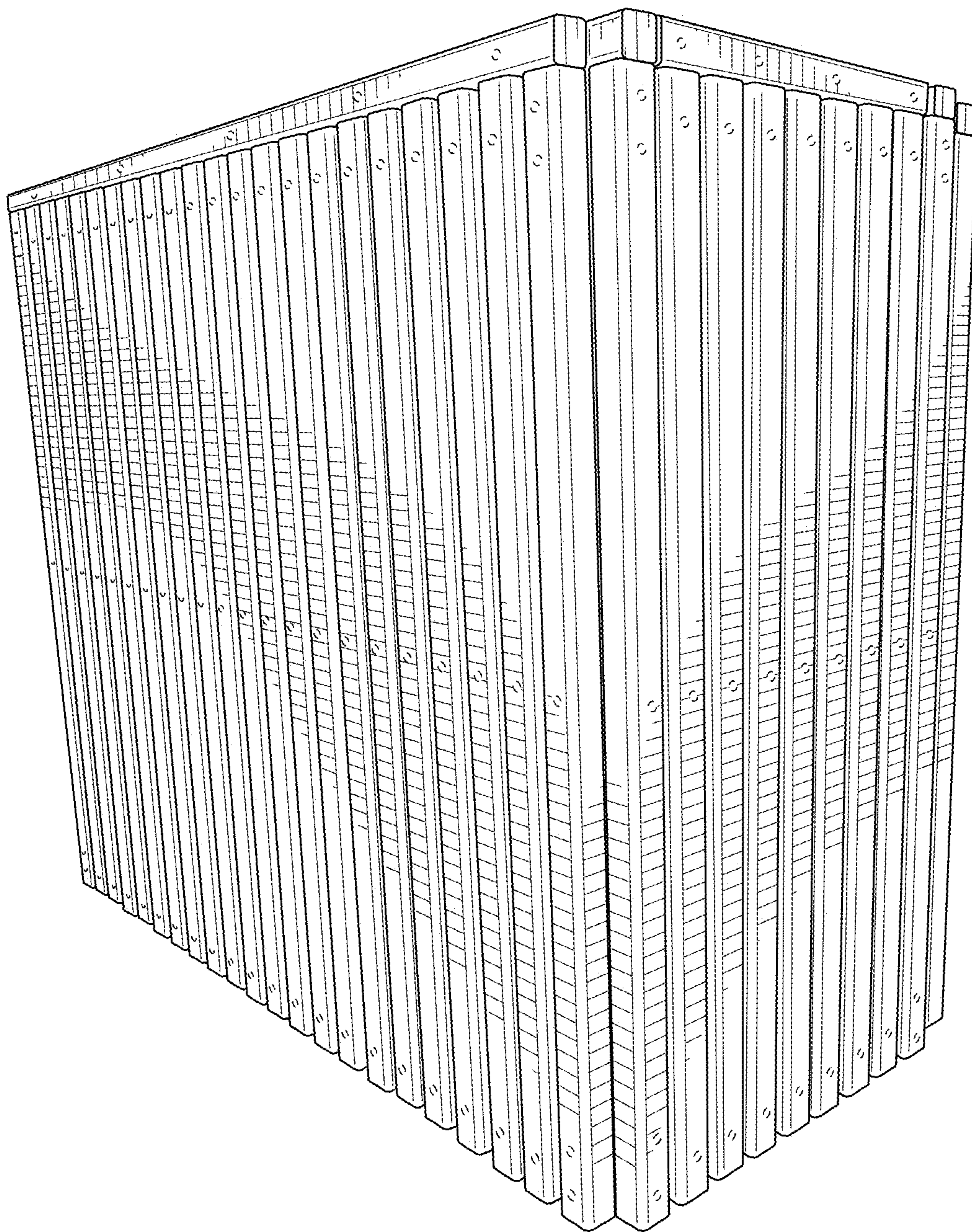

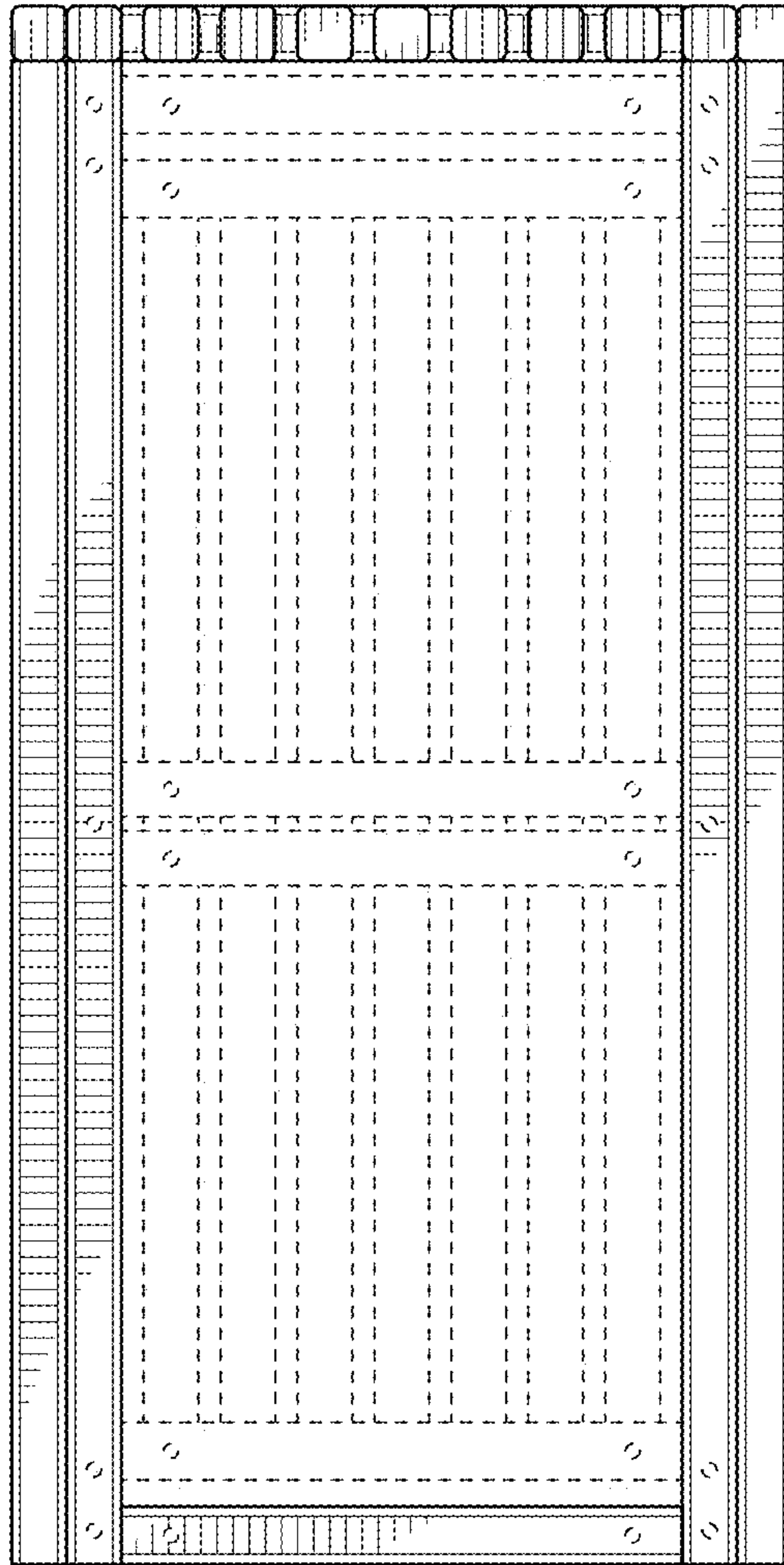

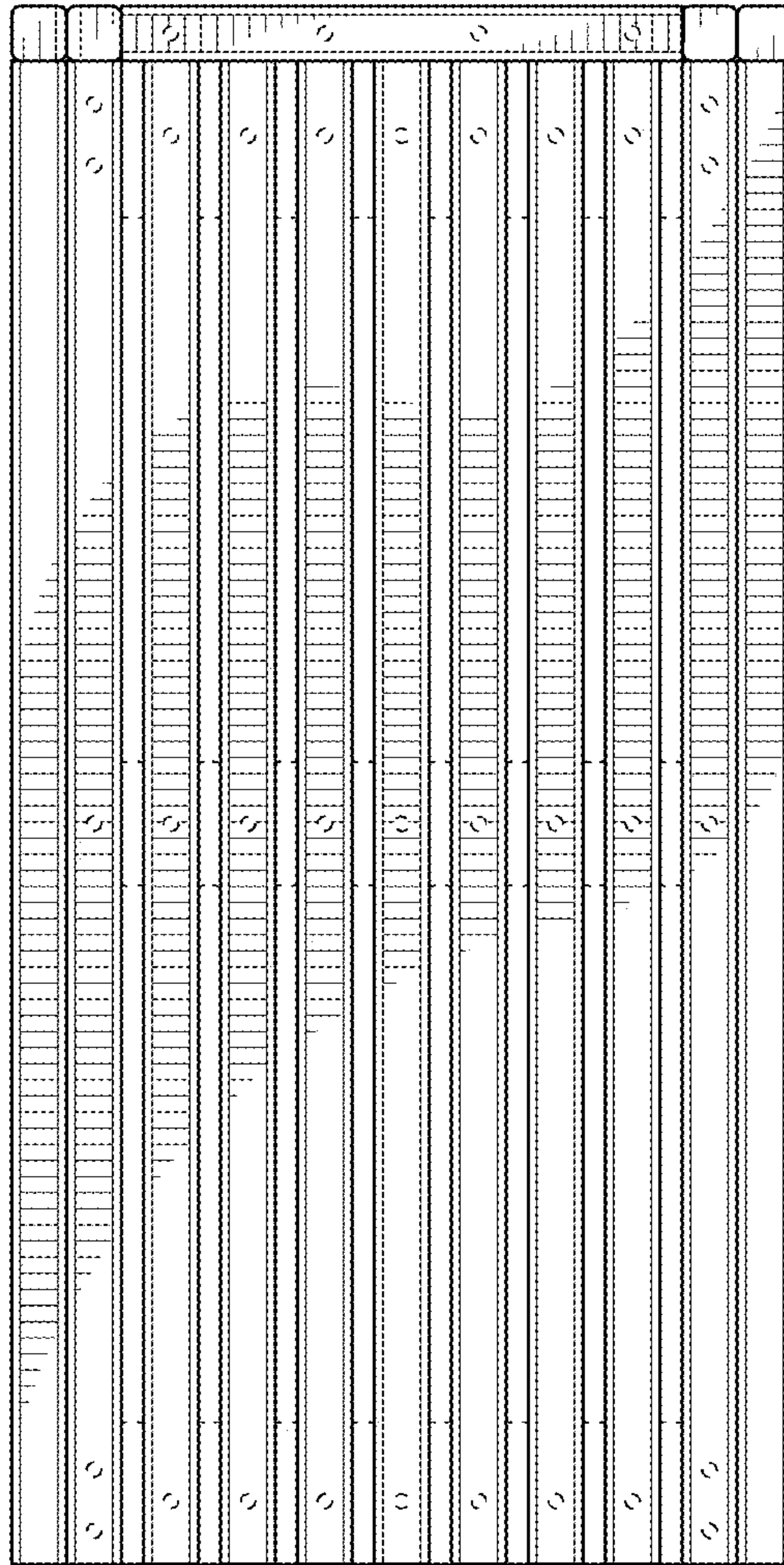

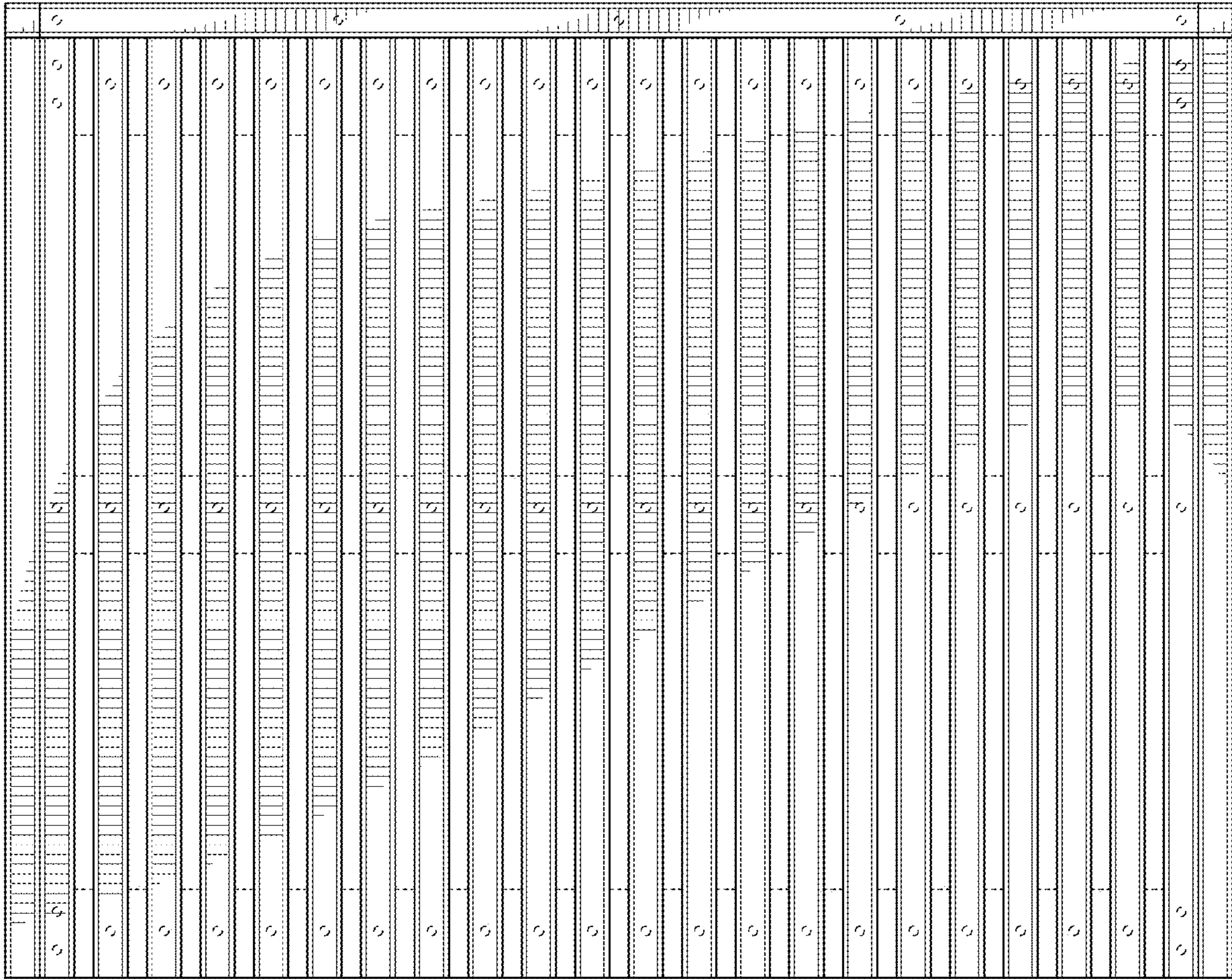

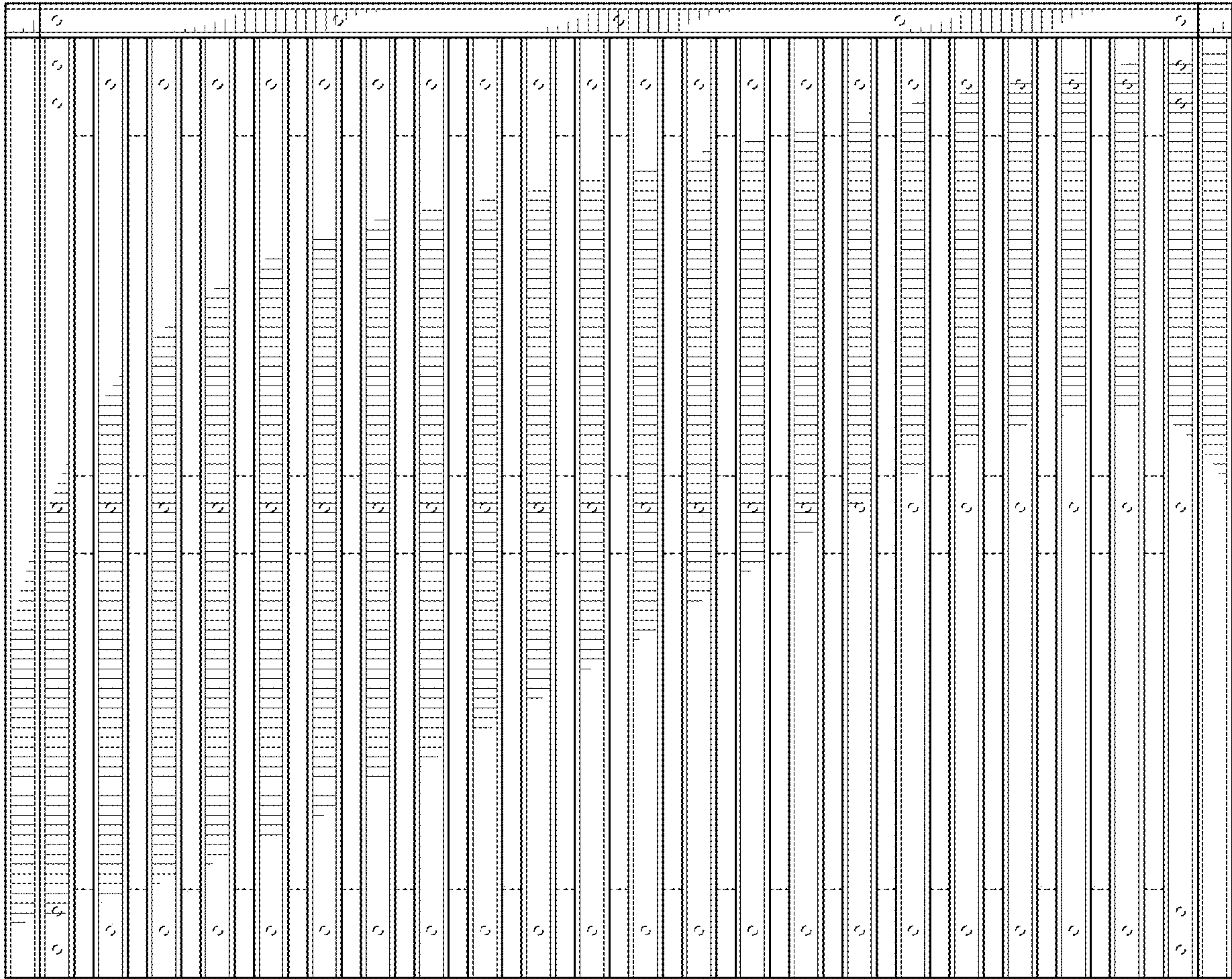

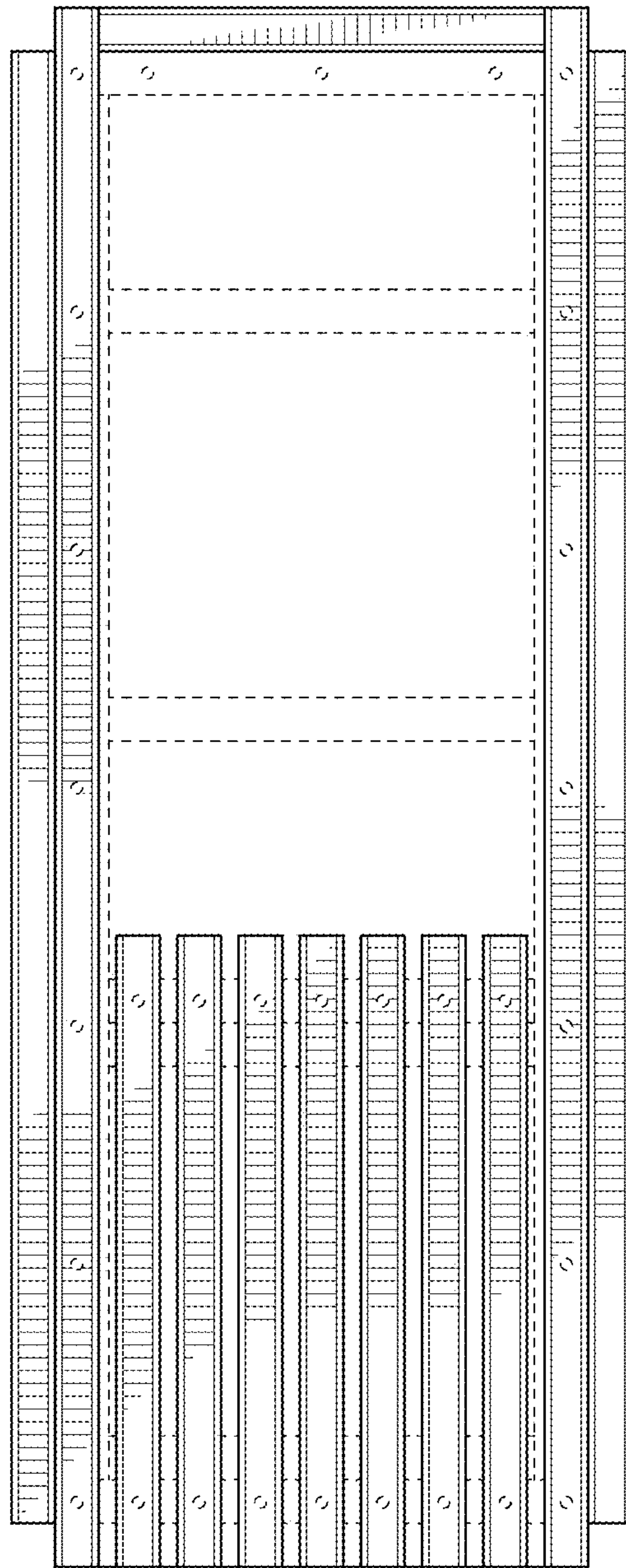

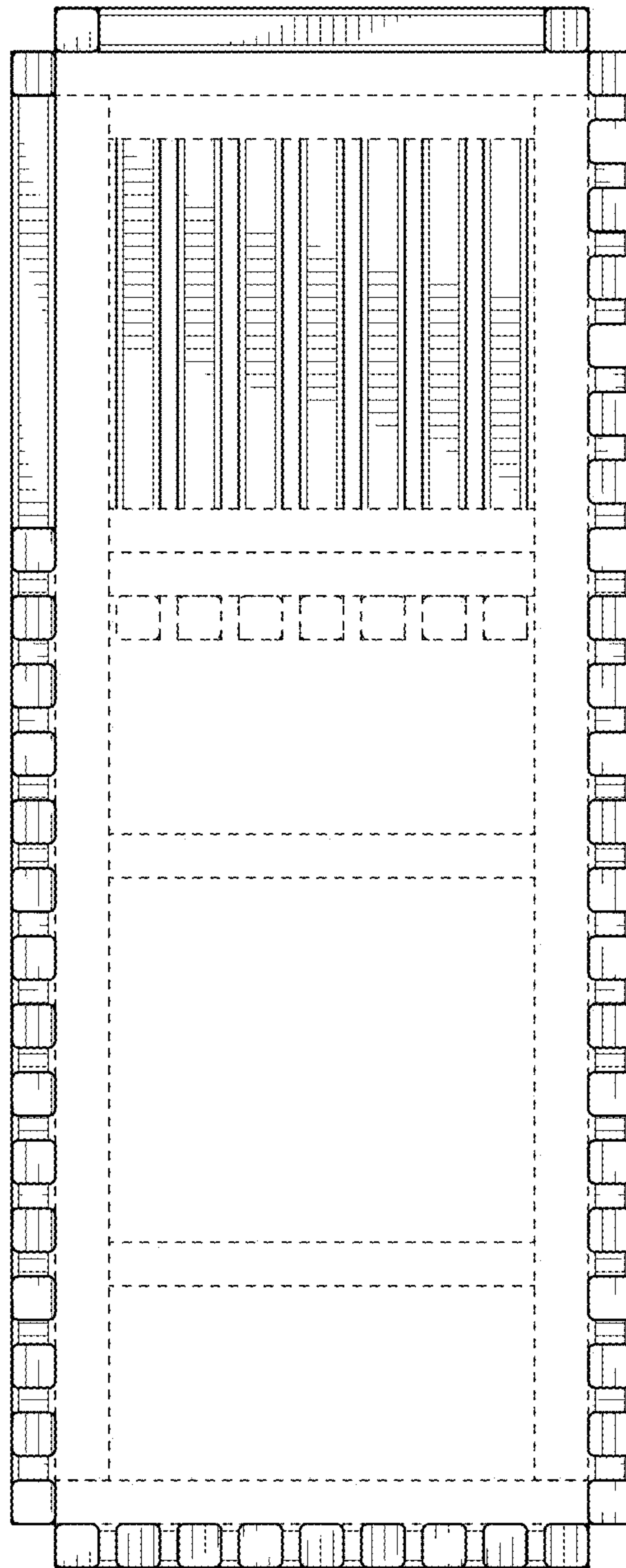

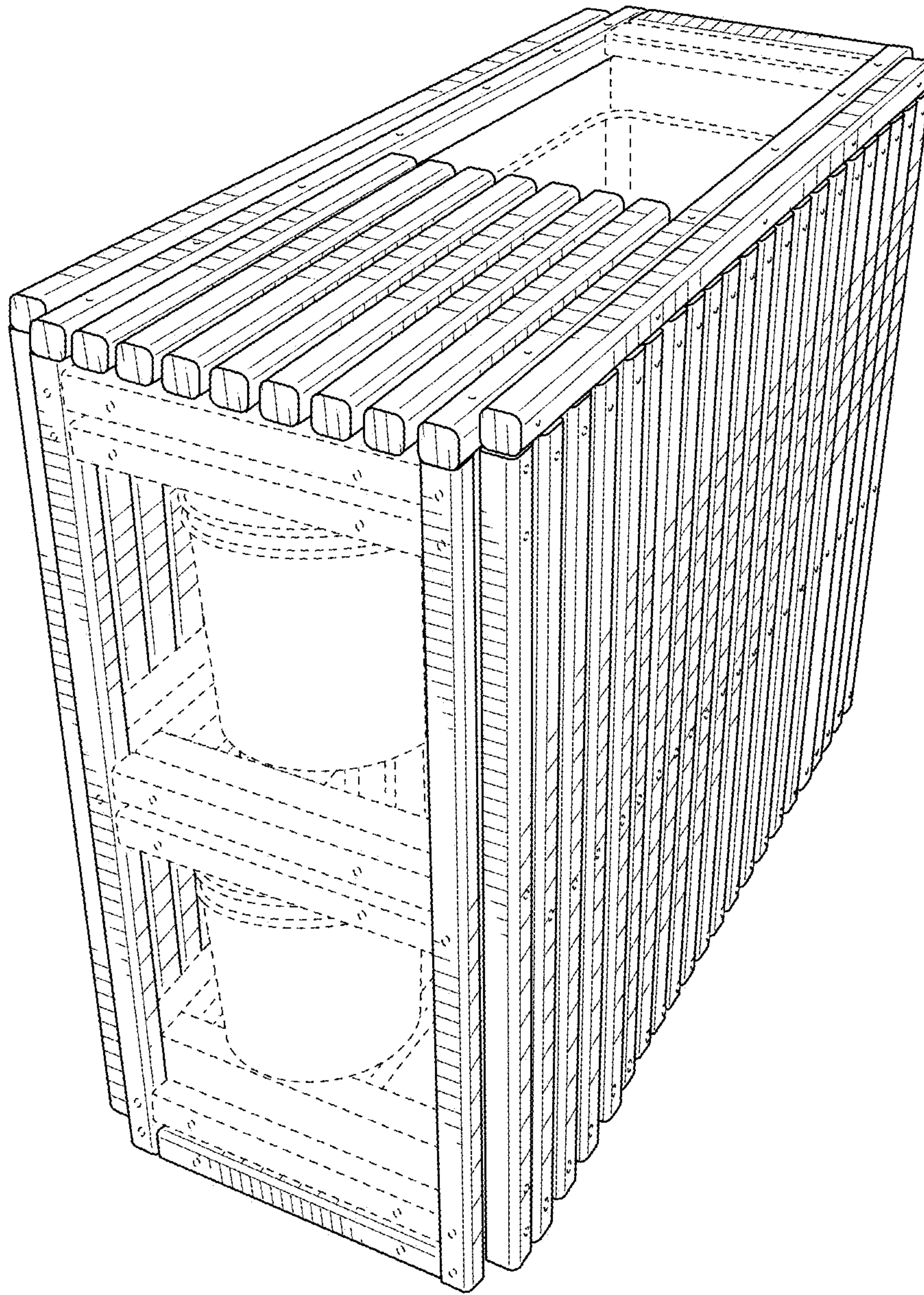
