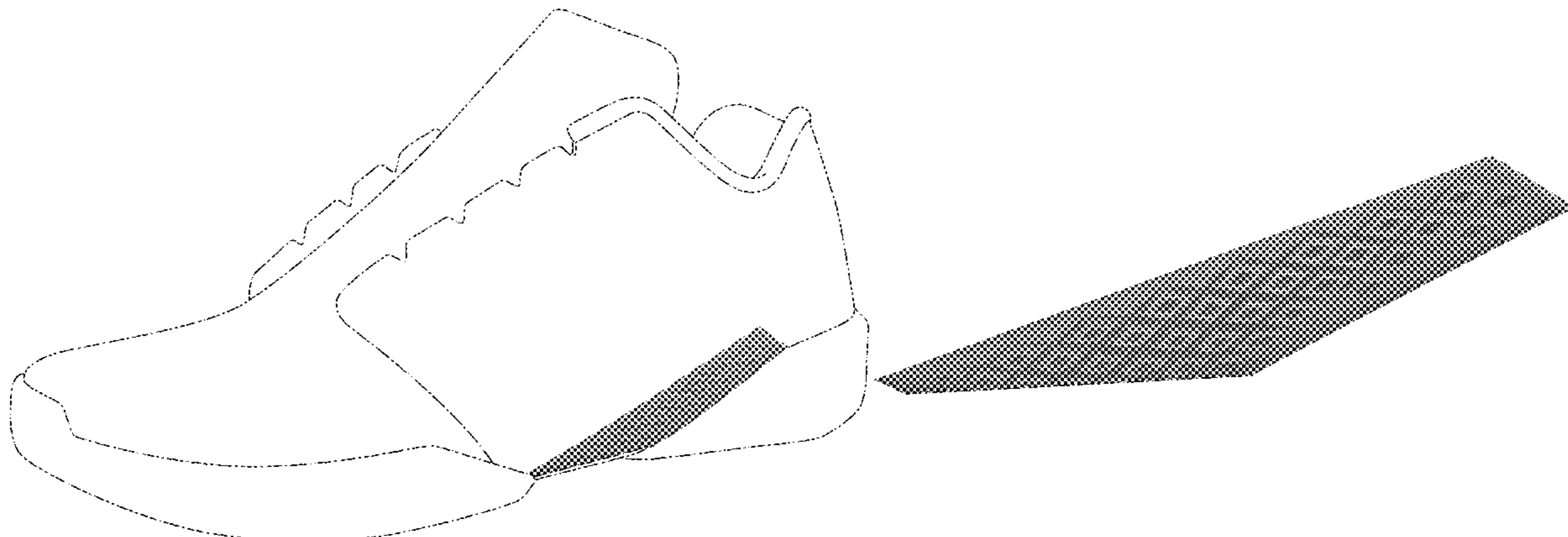

(57) **CLAIM**
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is an enlarged view of the claim as shown in FIG. 2 with environment removed for clarity purposes.
The broken line immediately adjacent to the bottom of the photographic area defines the bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

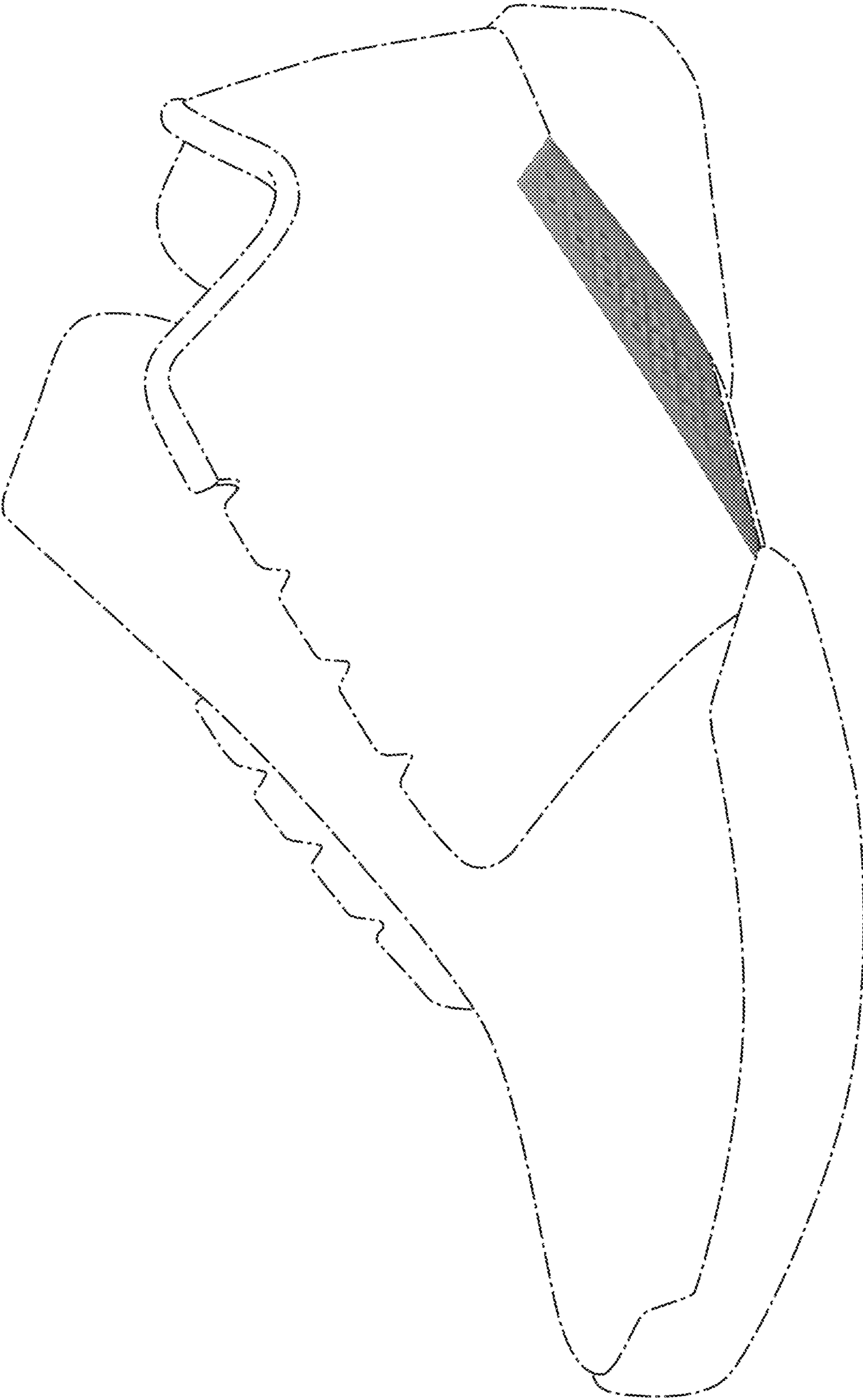

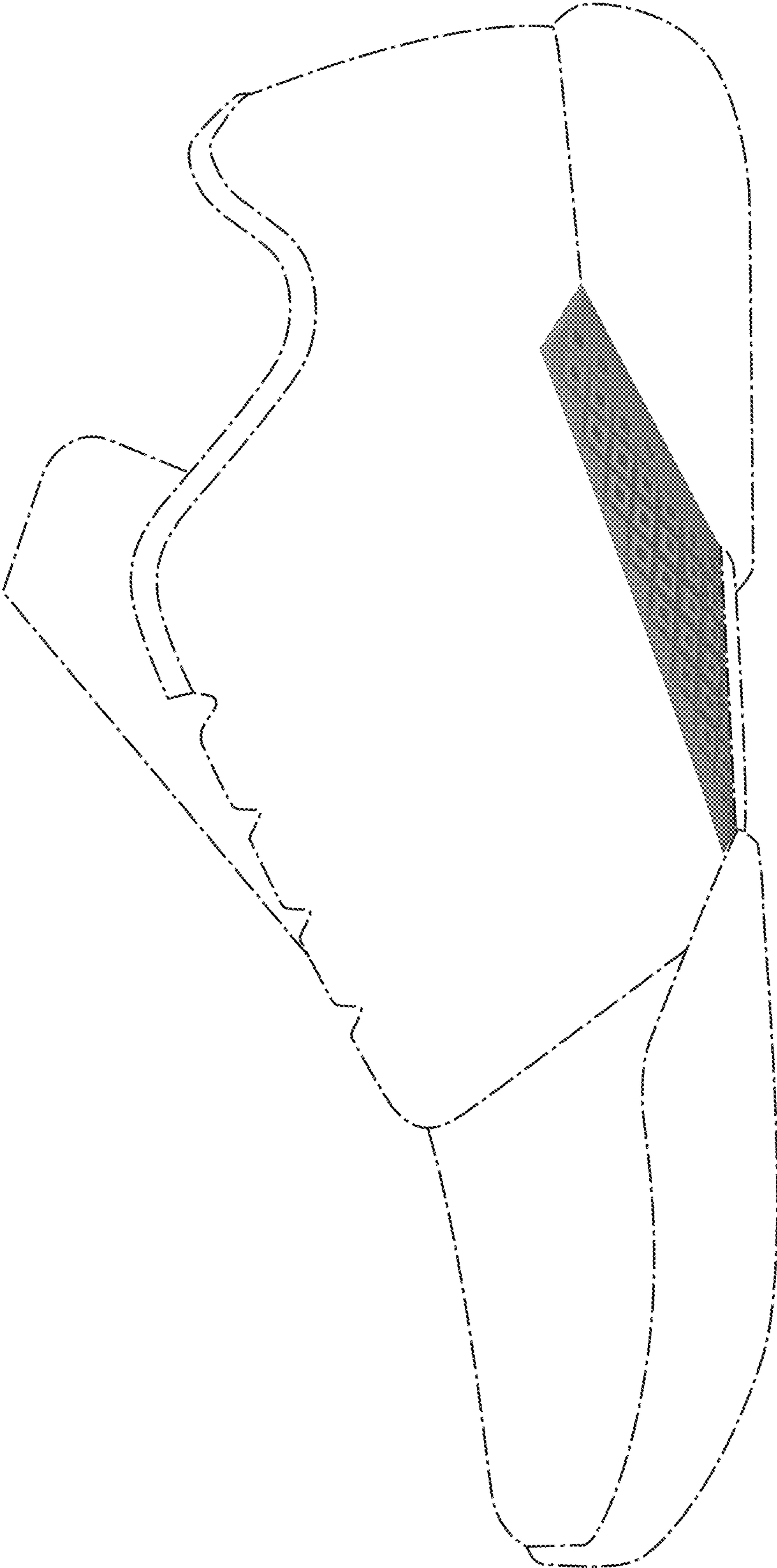

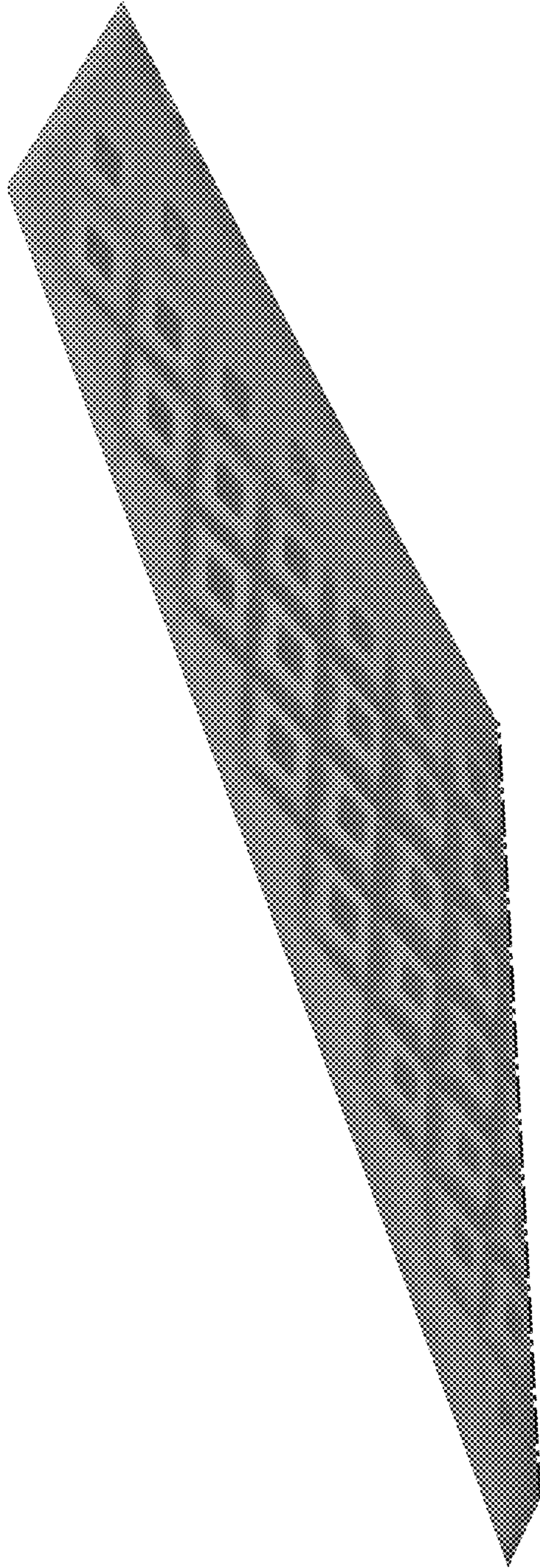
