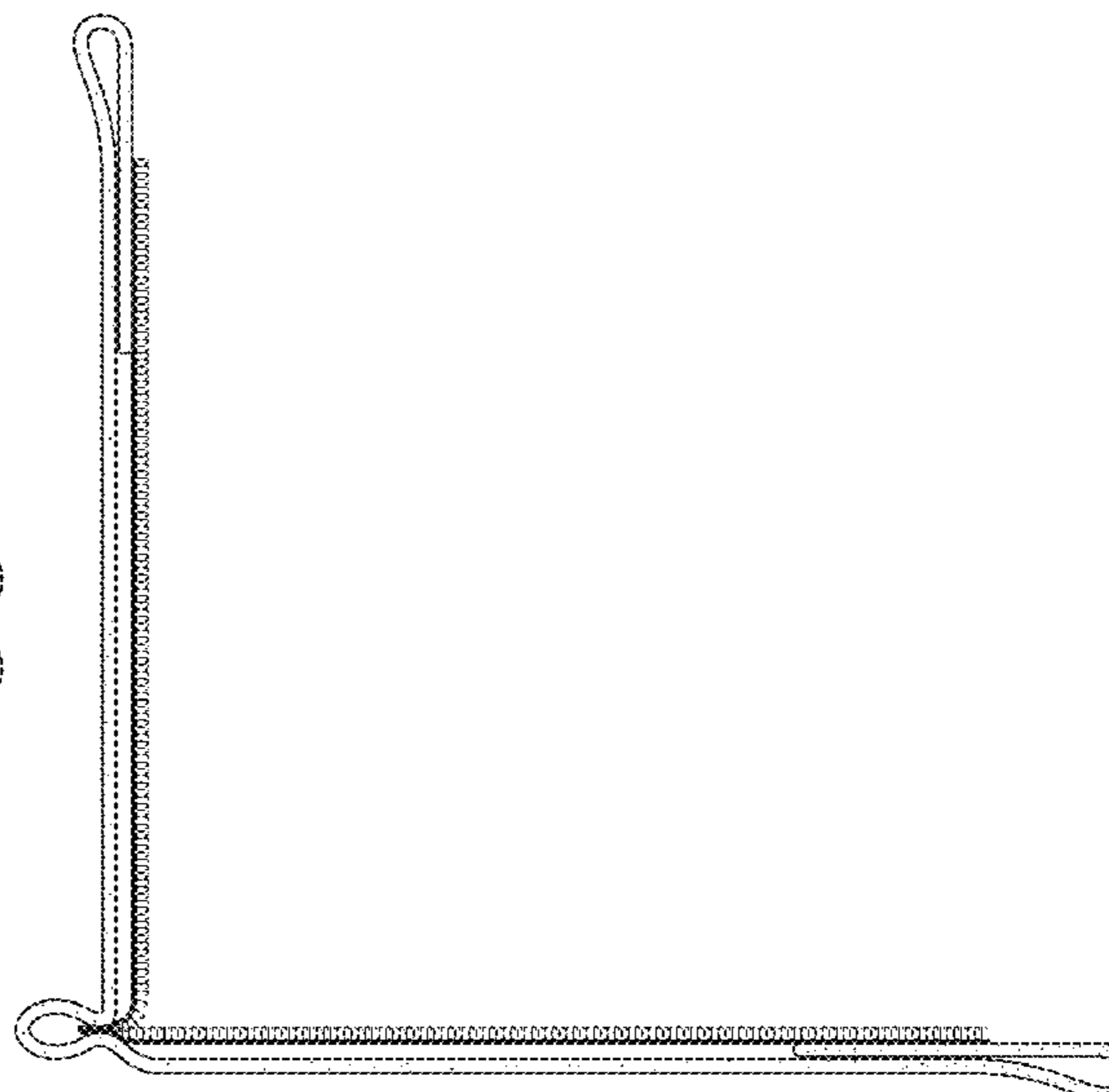
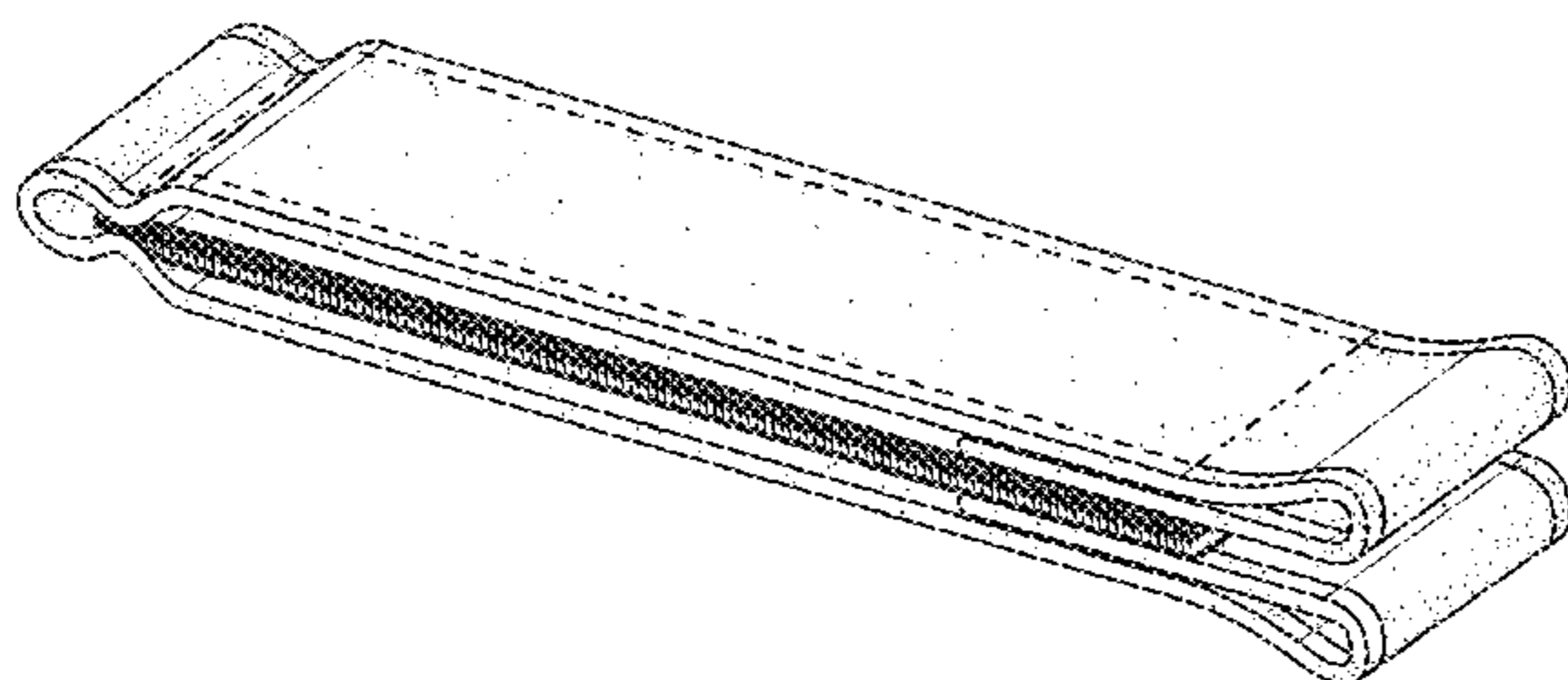
(57) **CLAIM**

The ornamental design for a fastening device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the fastening device showing my new and ornamental design in a closed configuration; FIG. 2 is a front view thereof; FIG. 3 is a rear side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top side view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective view of the fastening device of FIG. 1, showing my new and ornamental design in an open configuration; FIG. 9 is a front view thereof; FIG. 10 is a rear side view thereof; FIG. 11 is a left side view thereof; FIG. 12 is a right side view thereof; FIG. 13 is a top side view thereof; and, FIG. 14 is a bottom view thereof. The broken lines in the drawings illustrate portions of the fastening device and form no part of the claimed design.

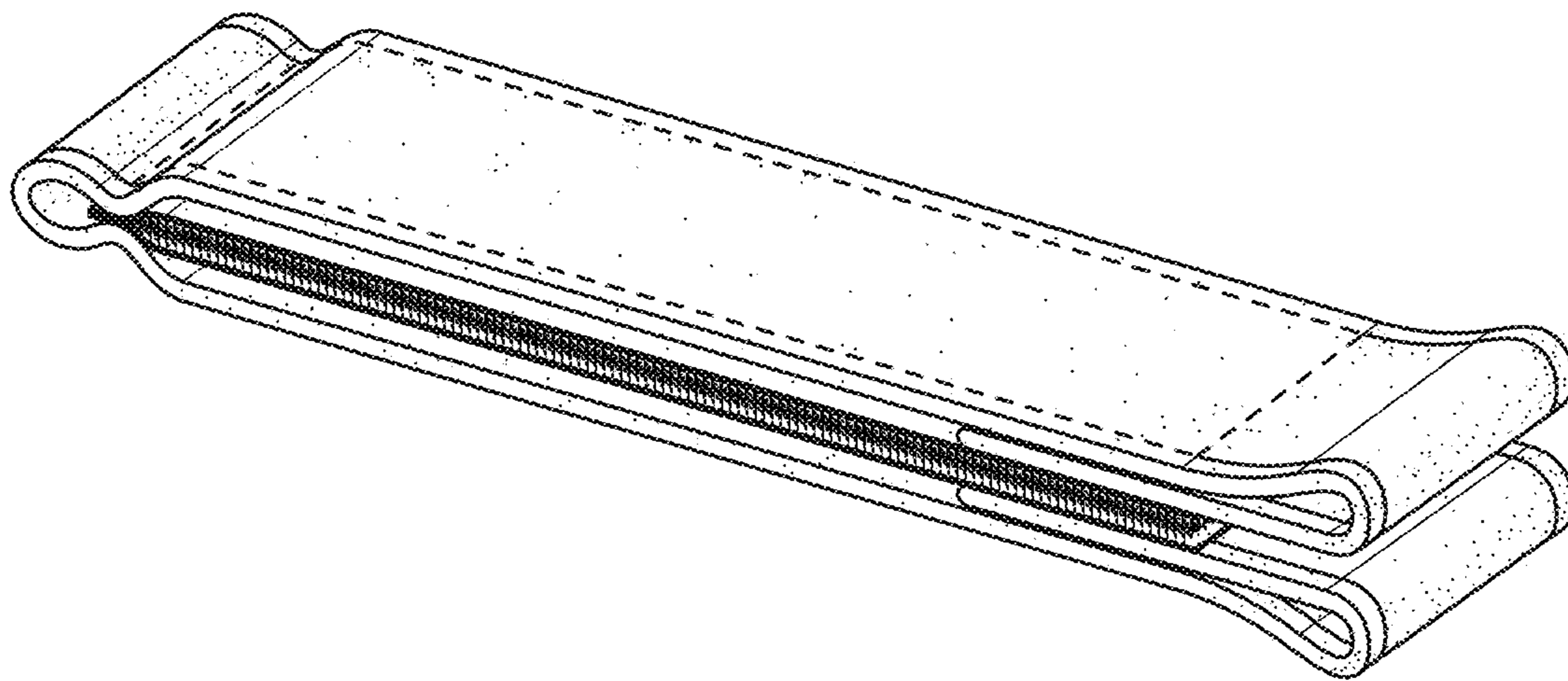

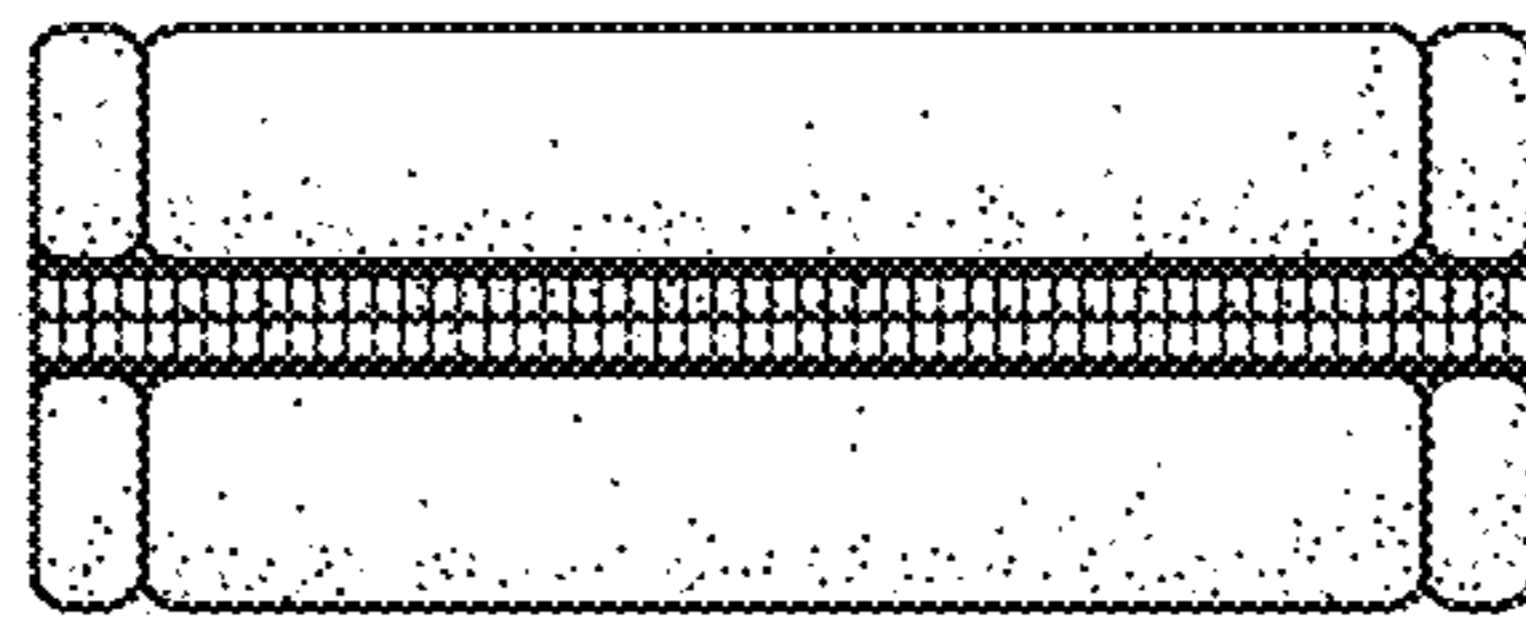

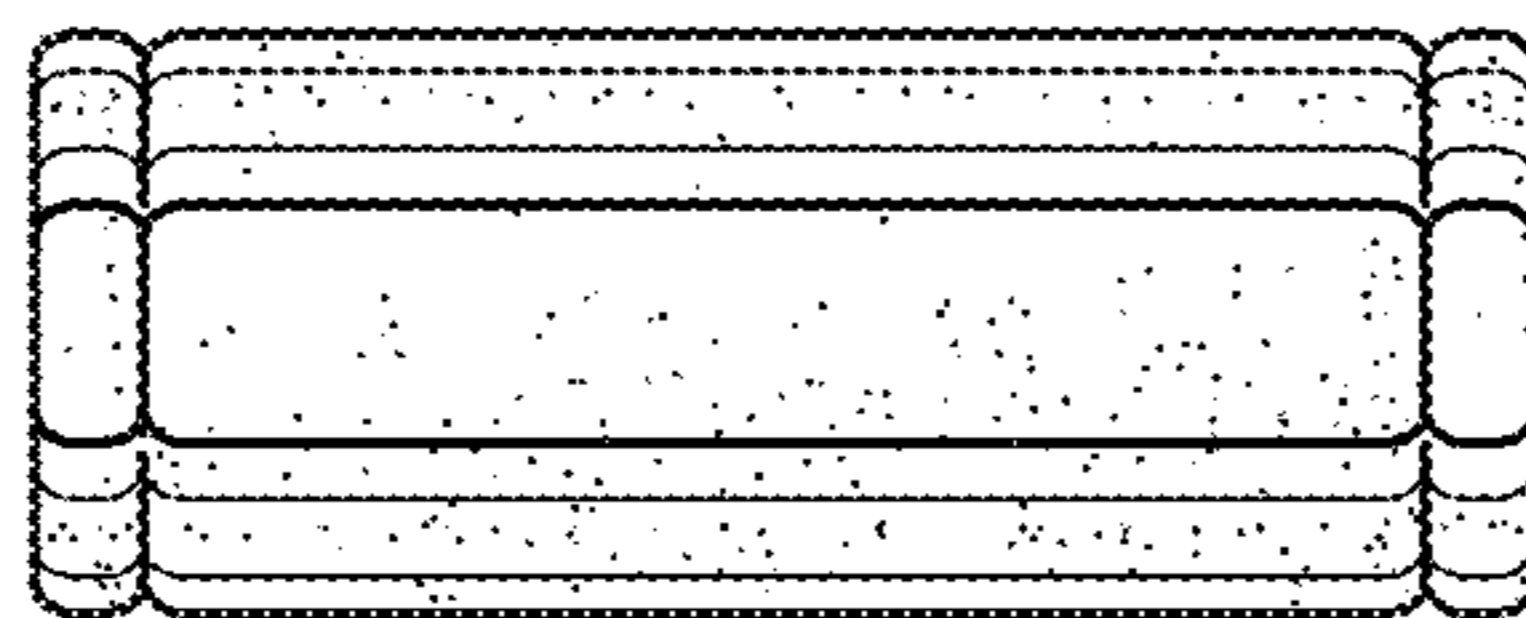

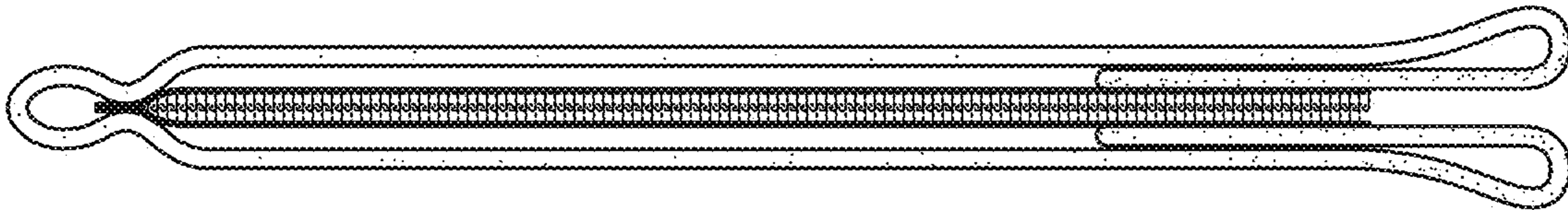

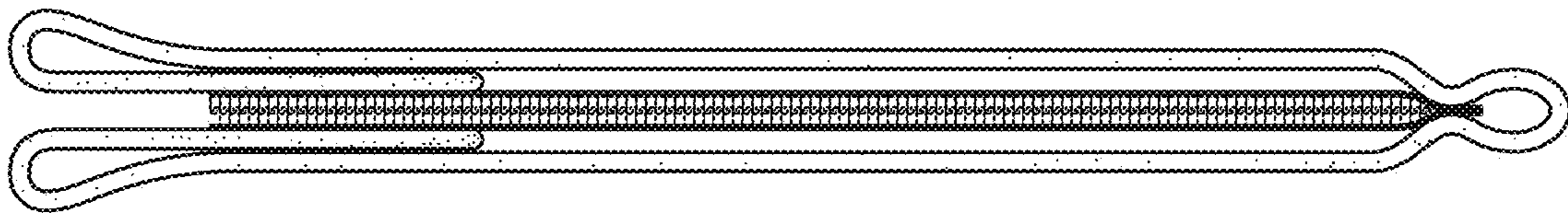

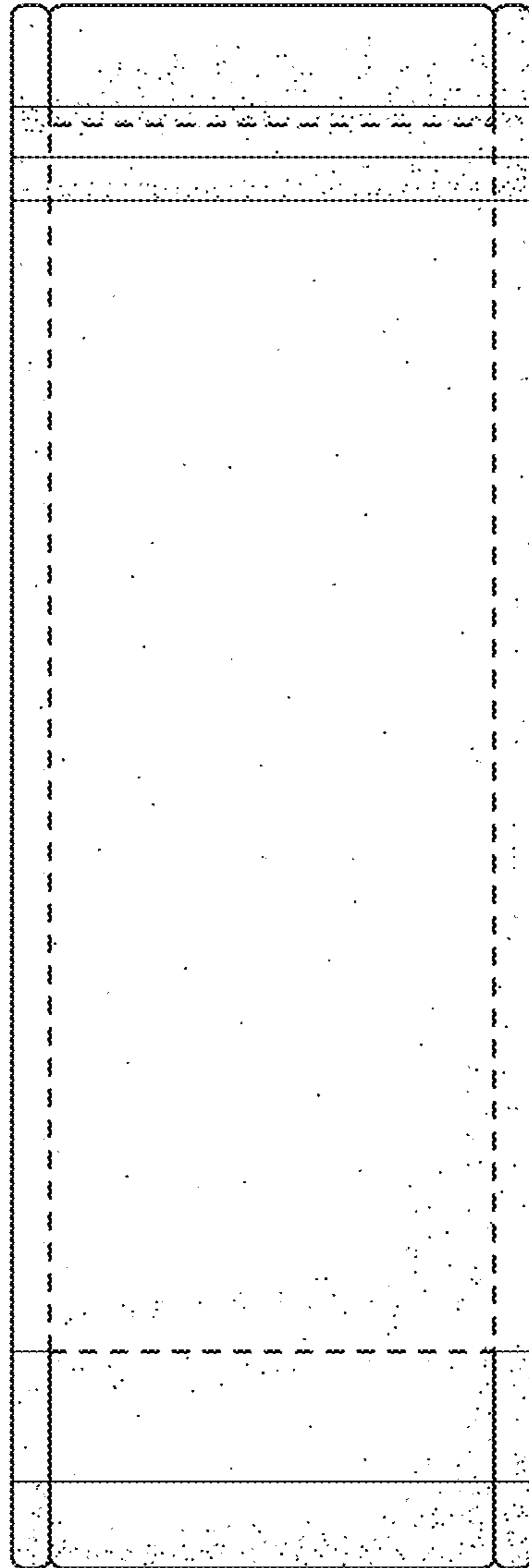

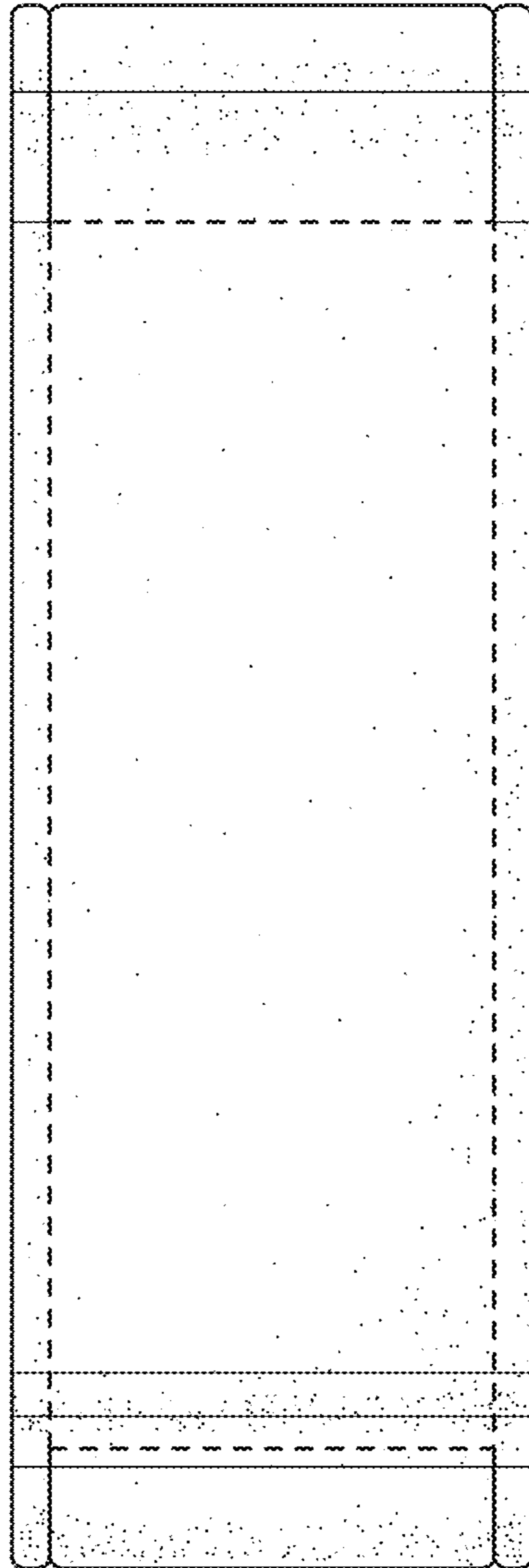

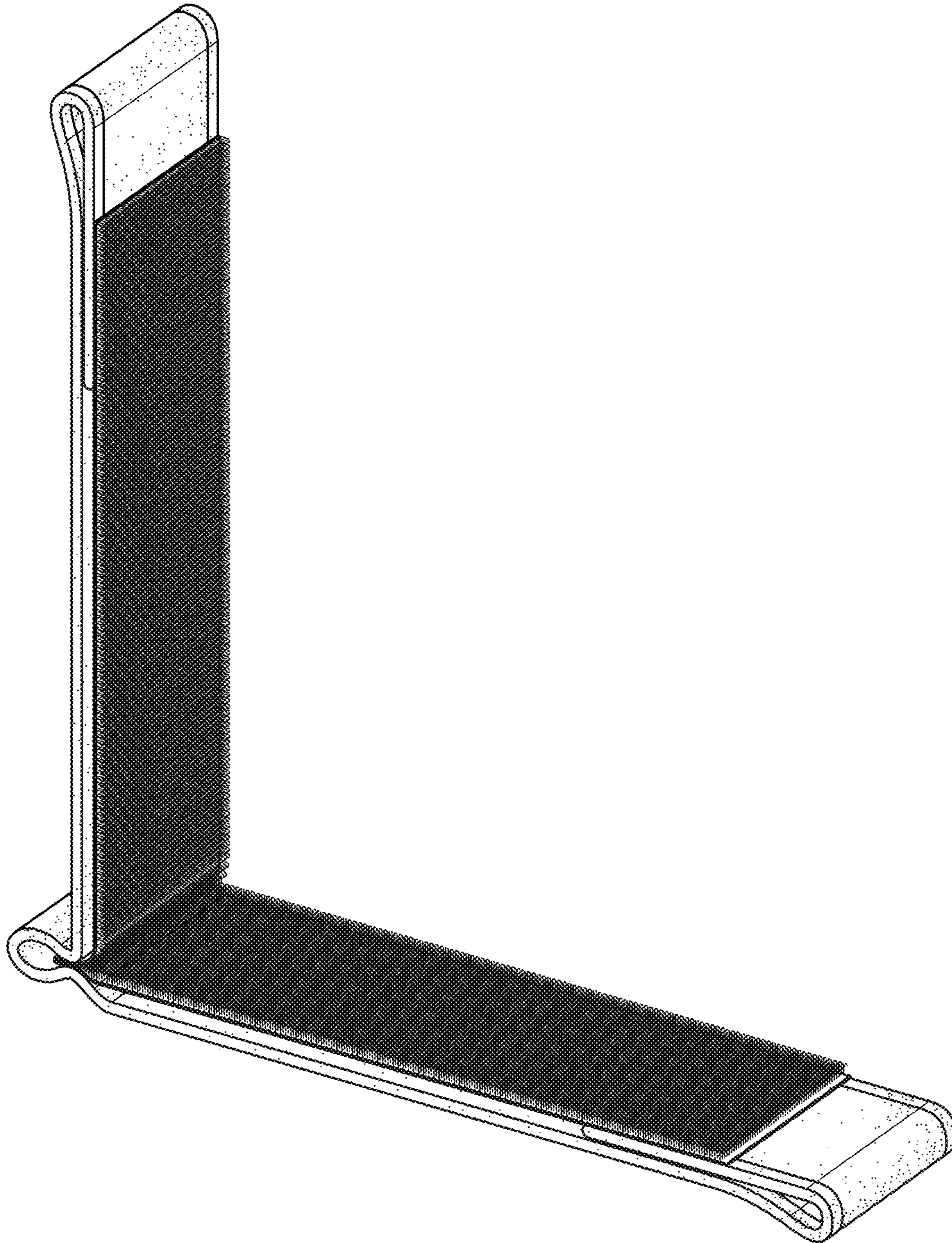

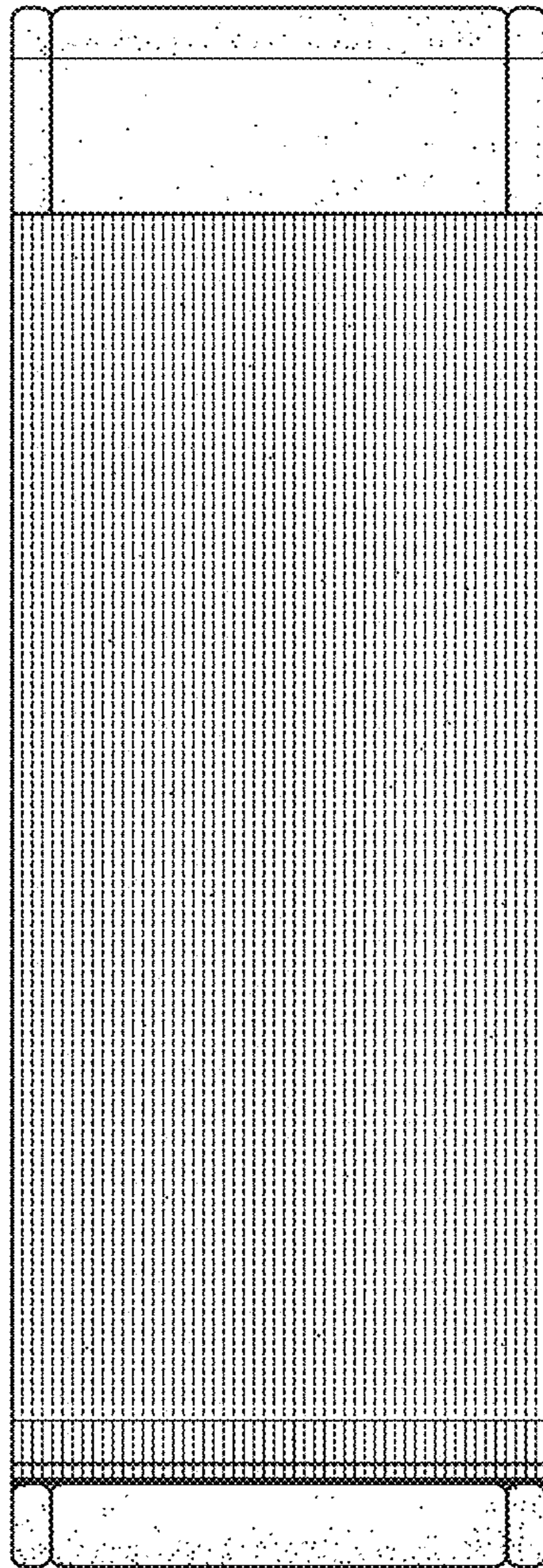

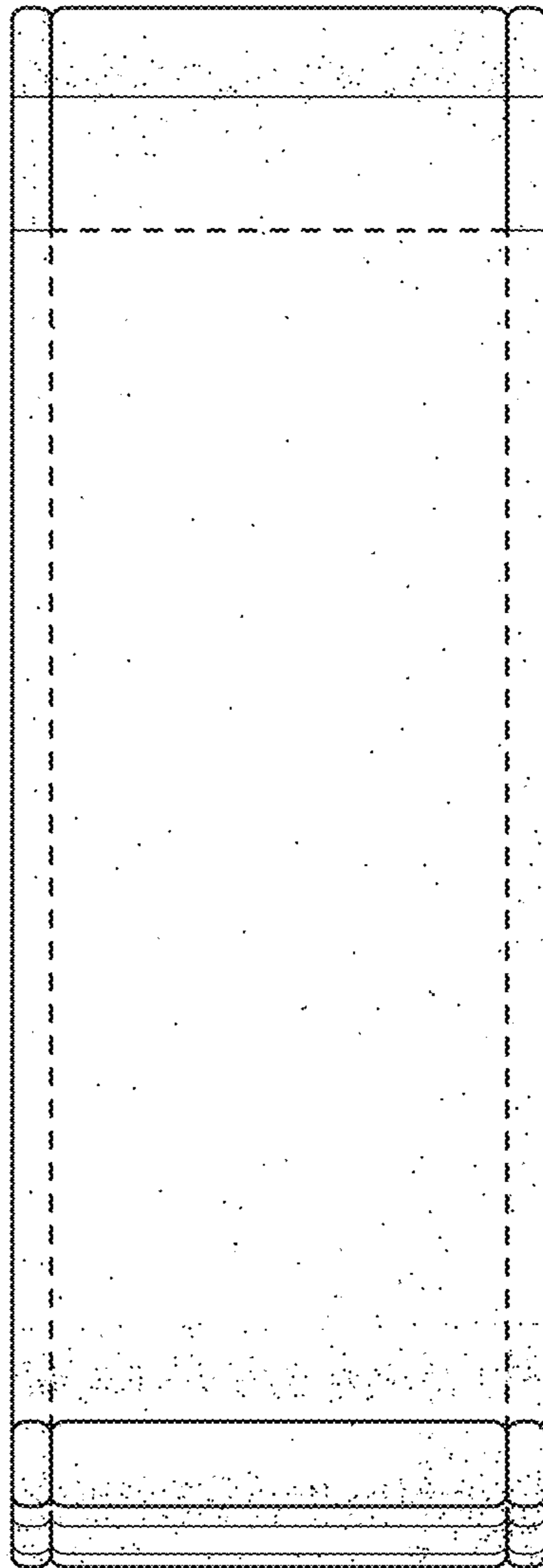

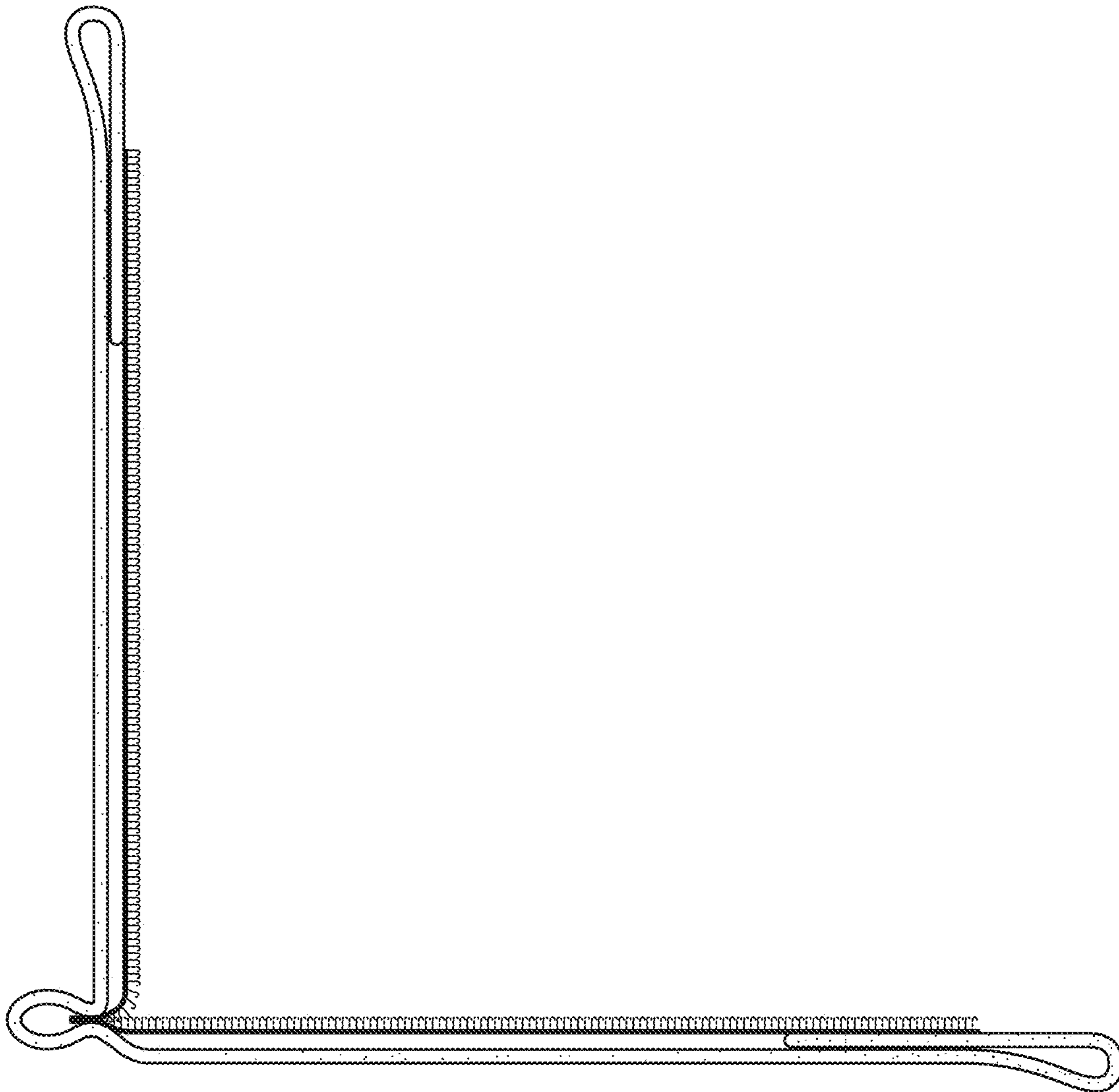

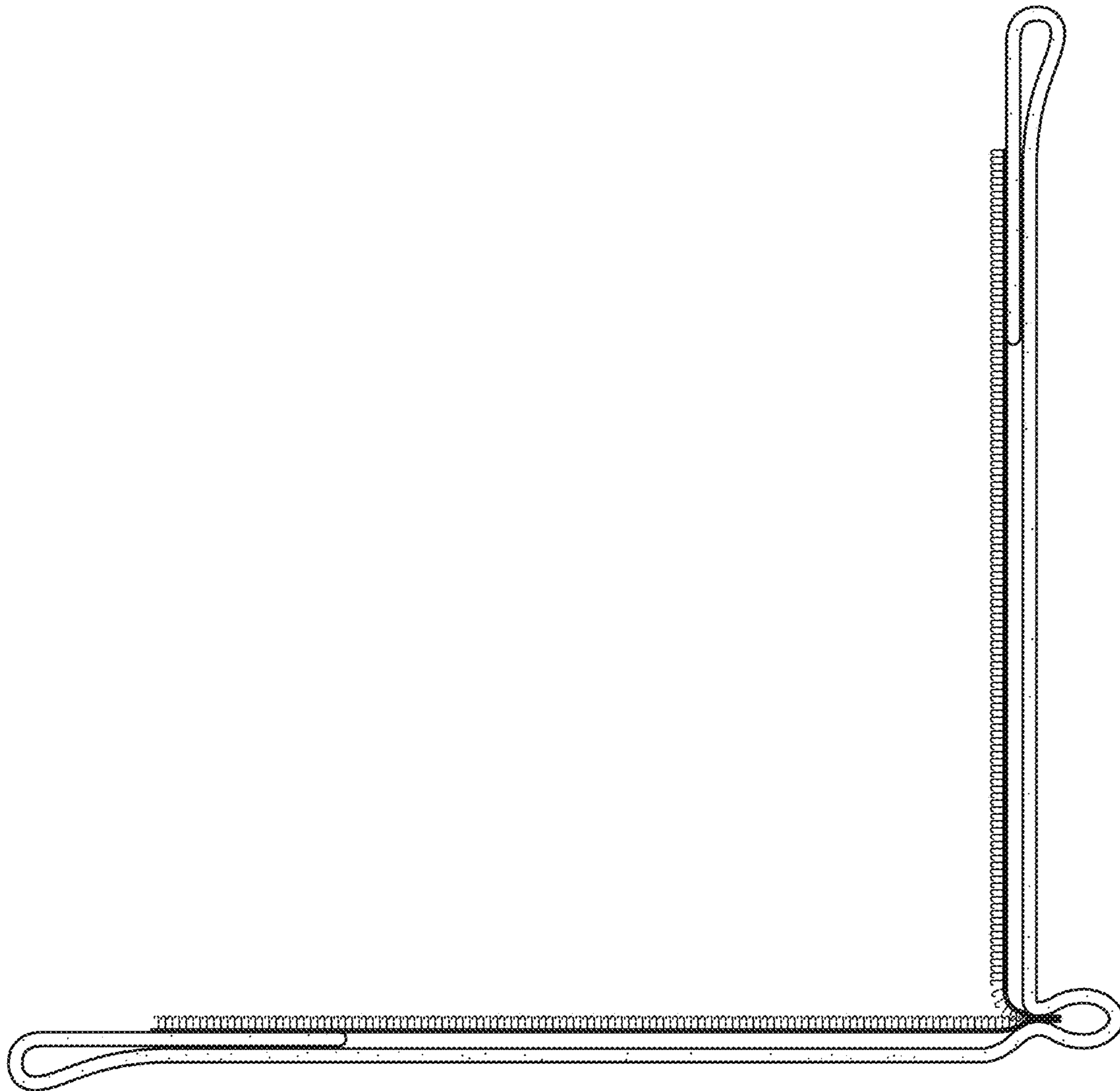

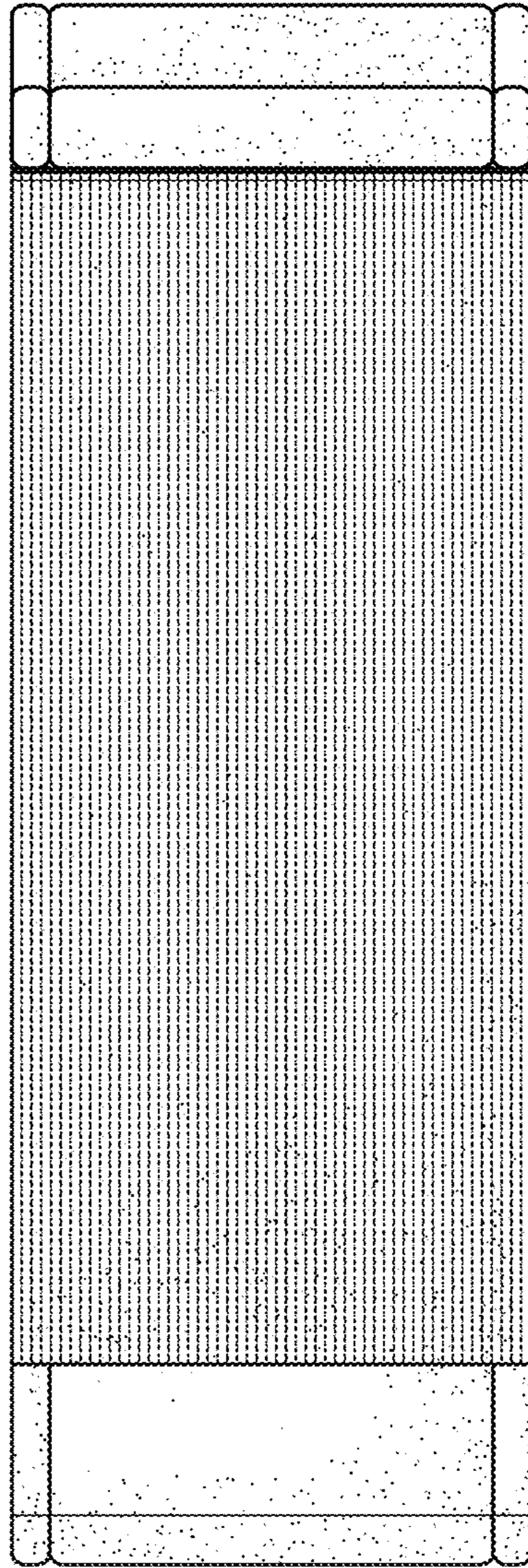

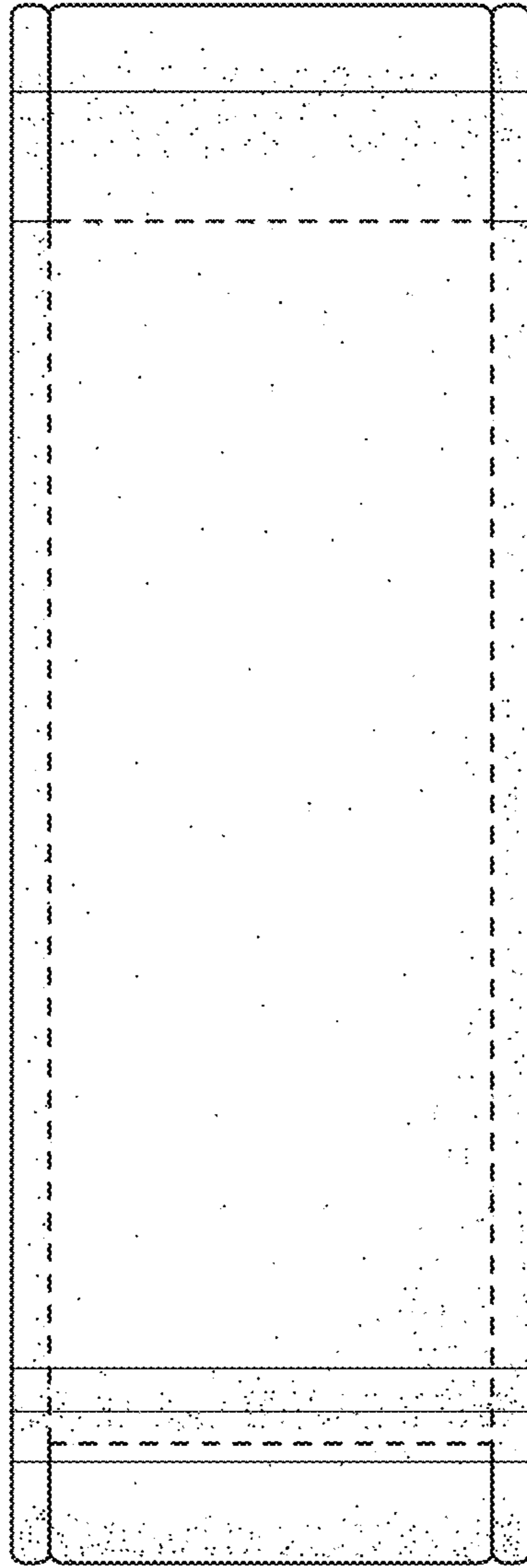
