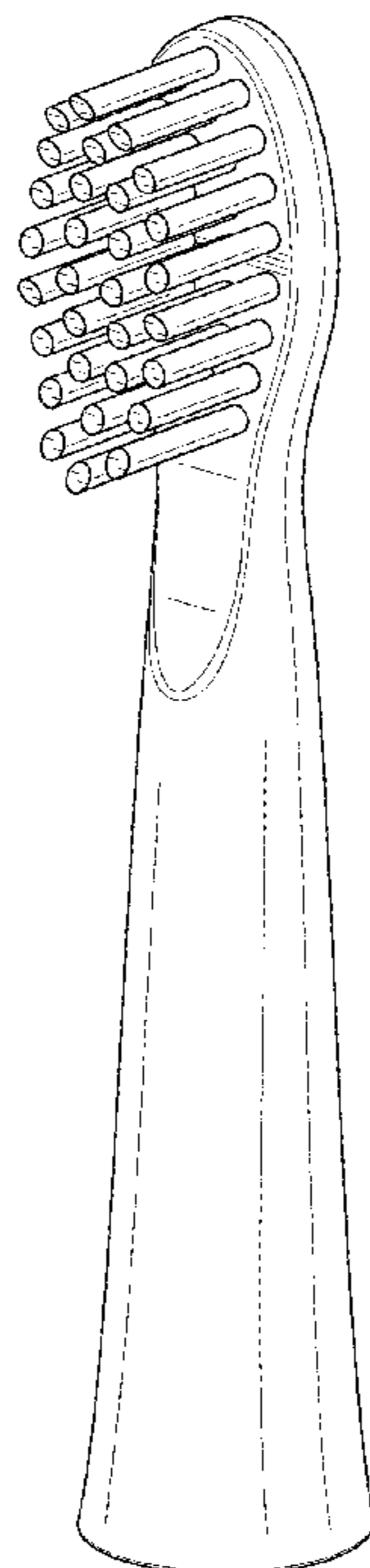
FIG. 1 is a front perspective view of a brush head, showing my design.

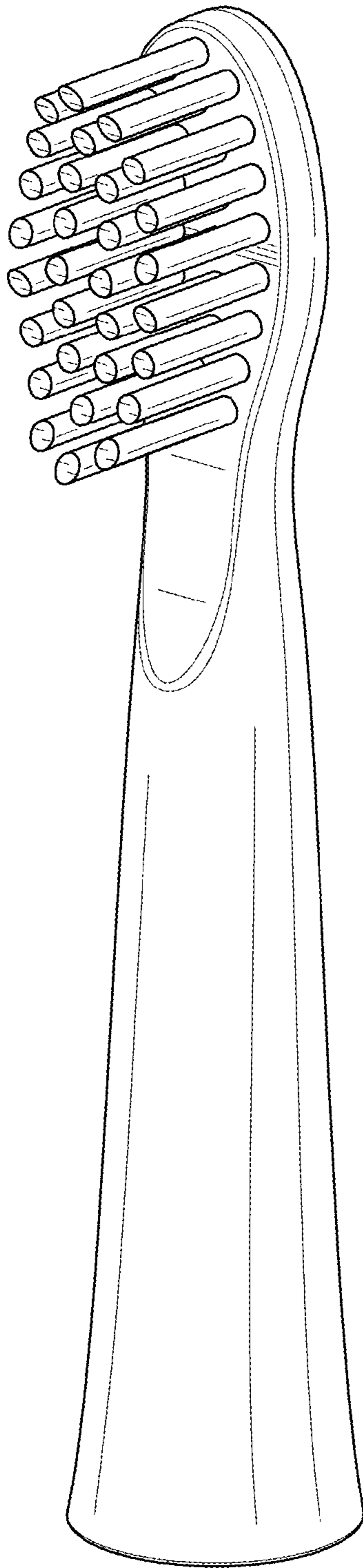

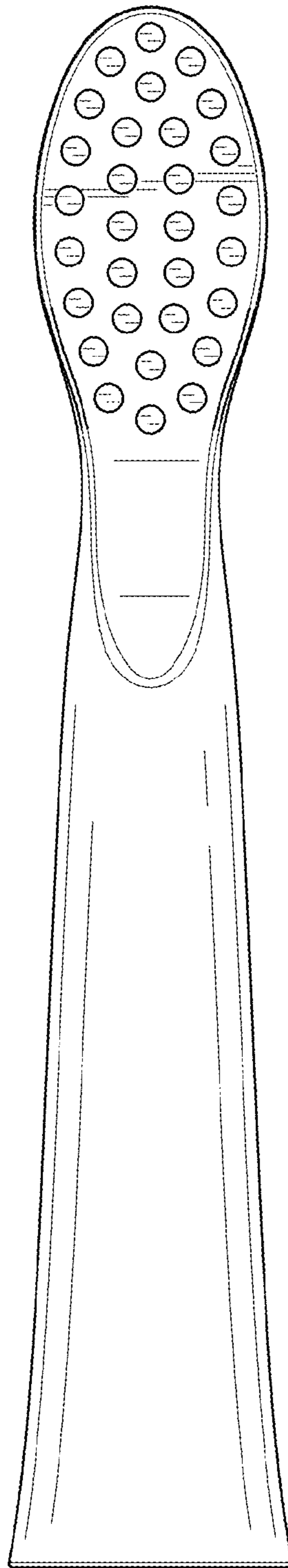

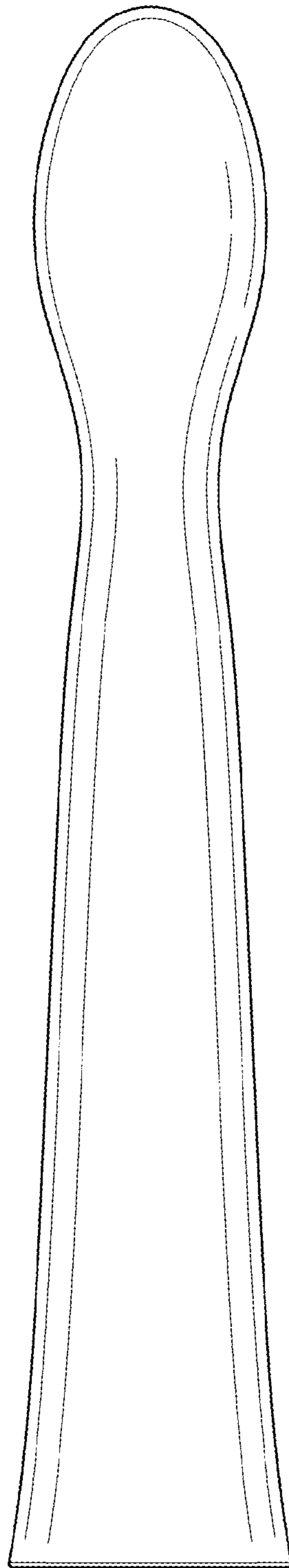

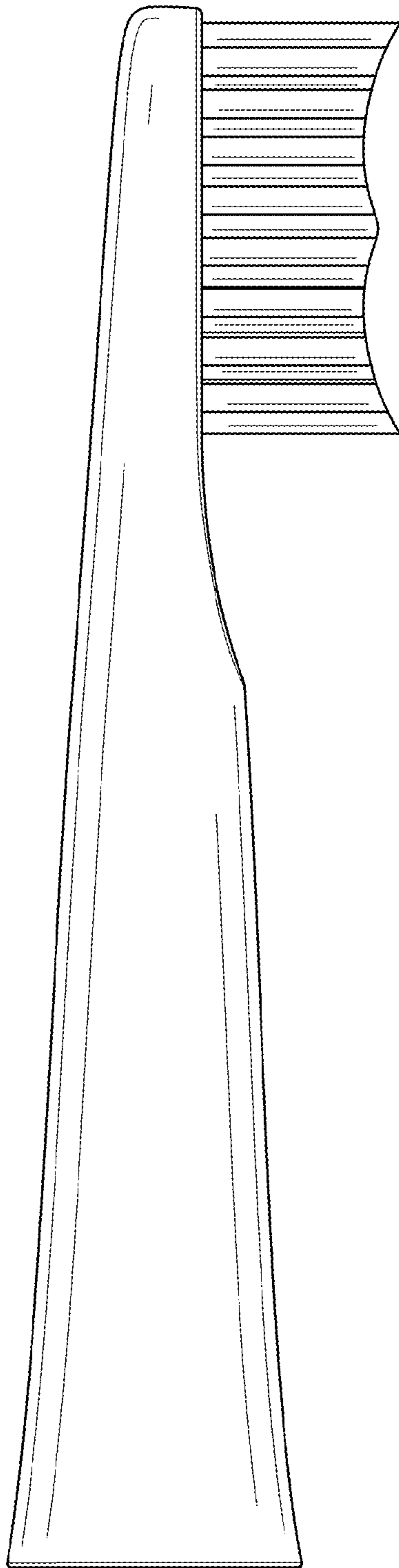

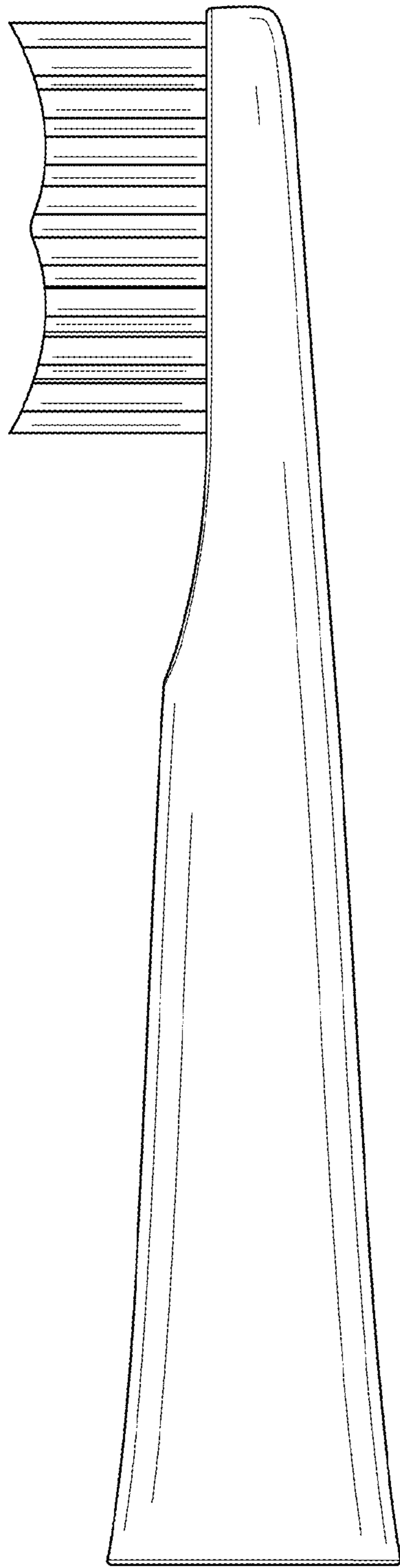

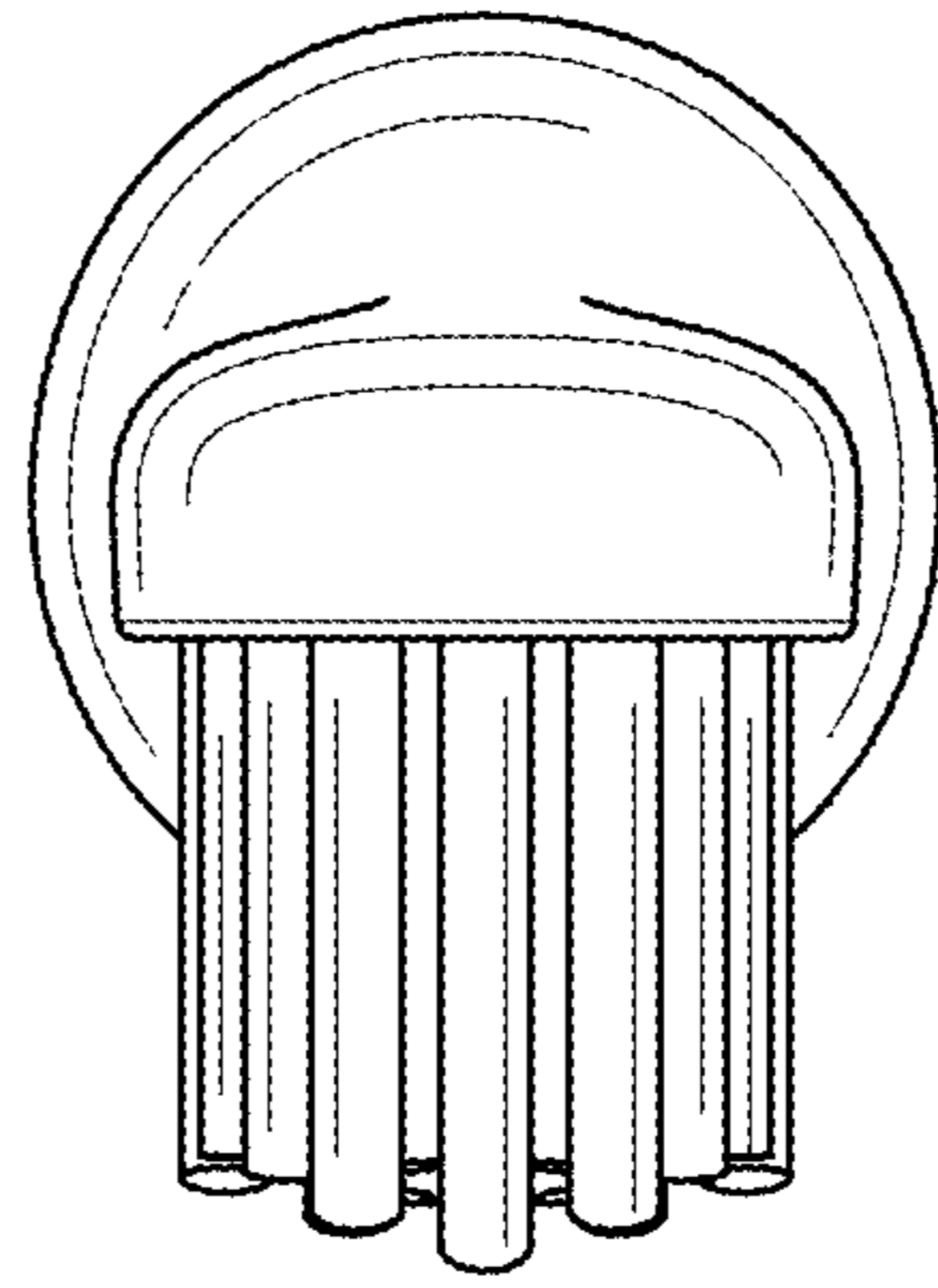

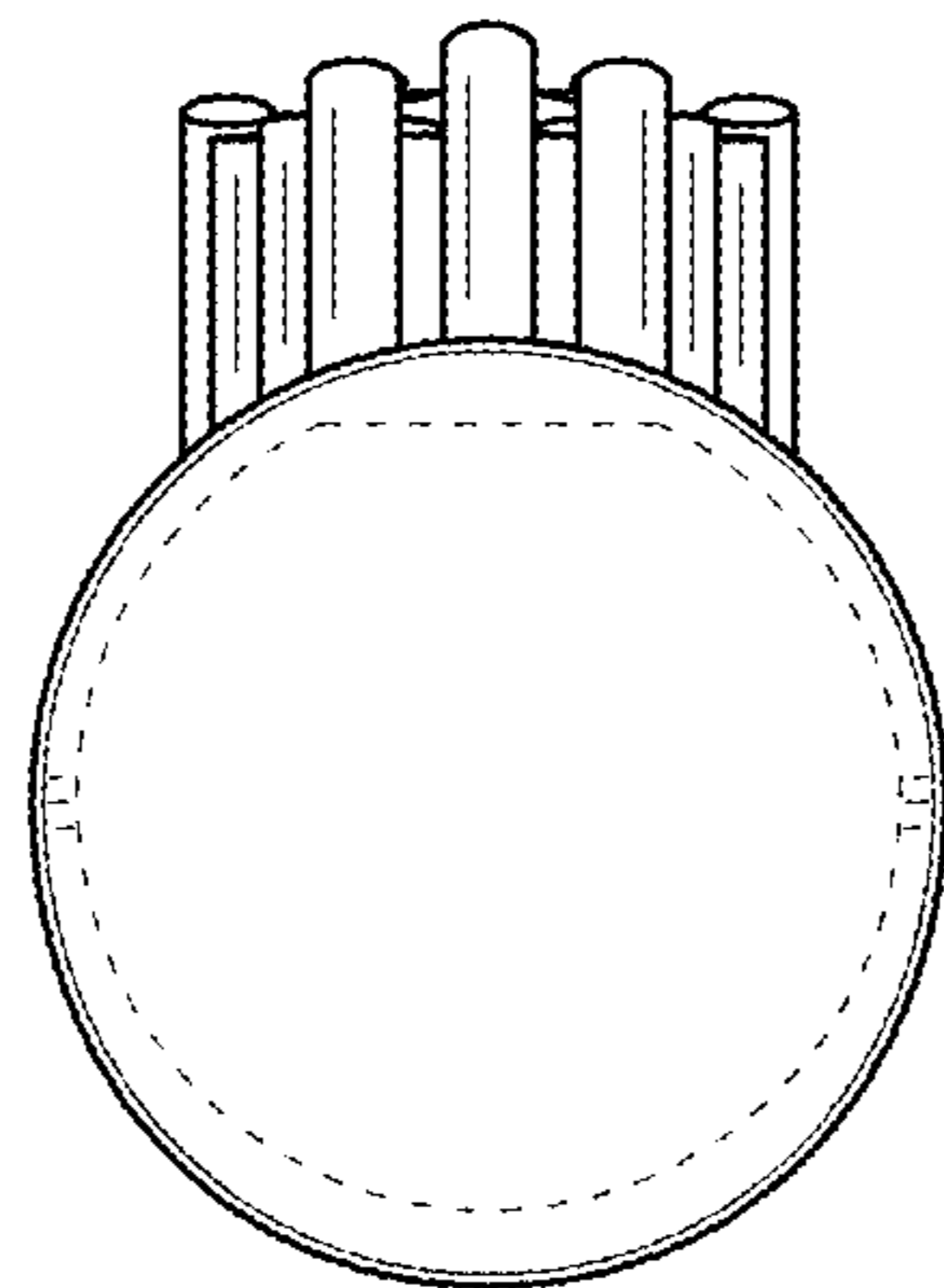
