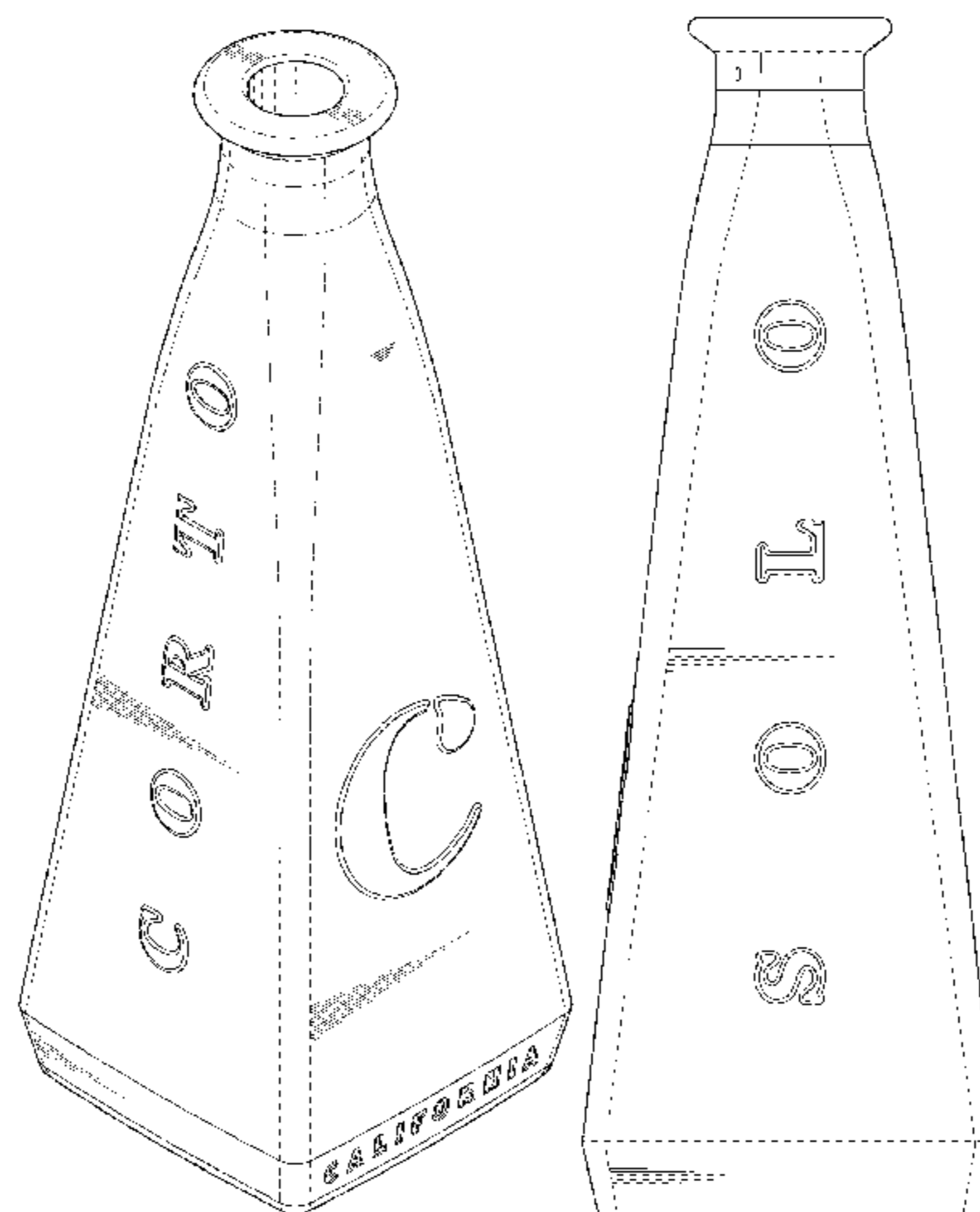
(57) **CLAIM**

The ornamental design for a bottle for olive oil, as shown and described.

**DESCRIPTION**

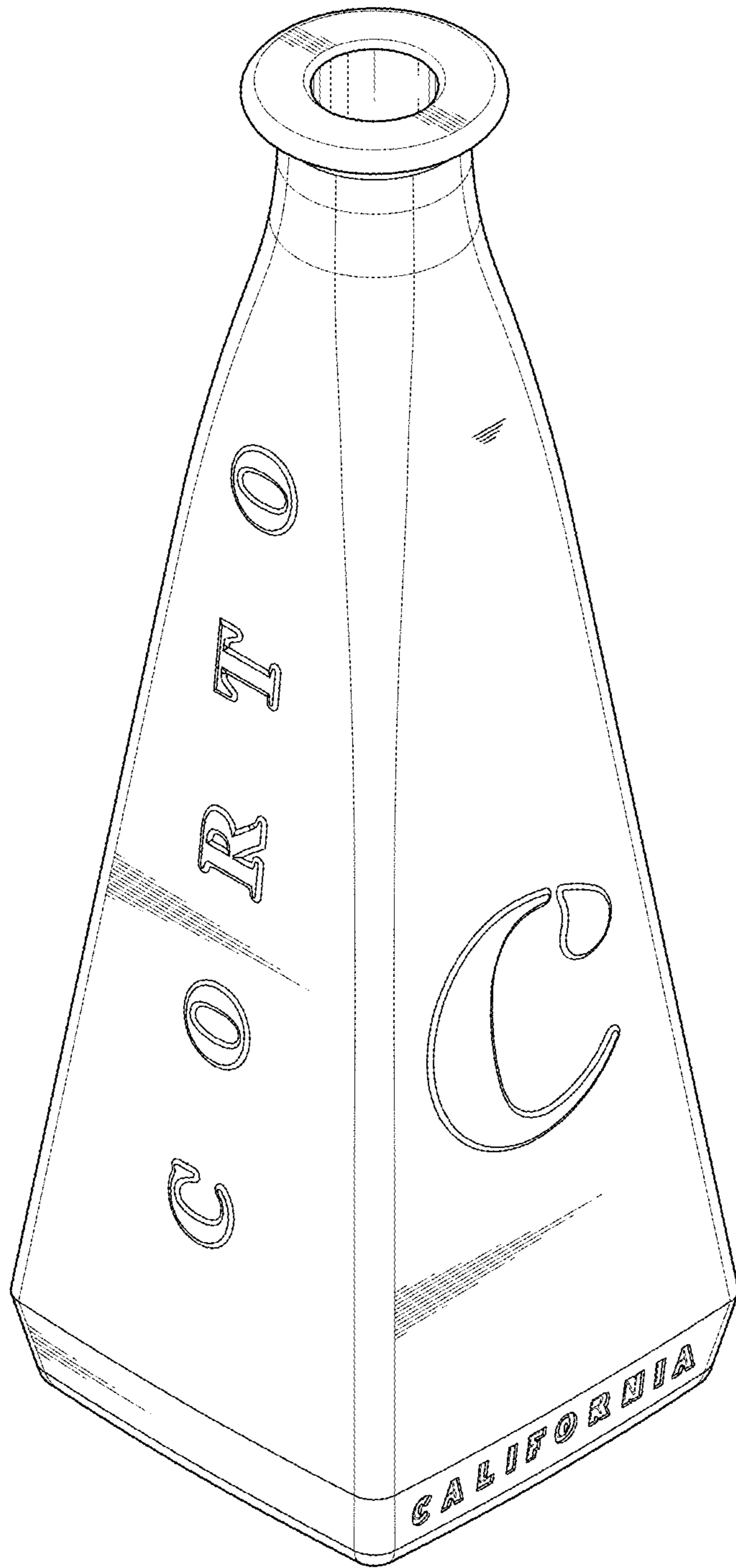
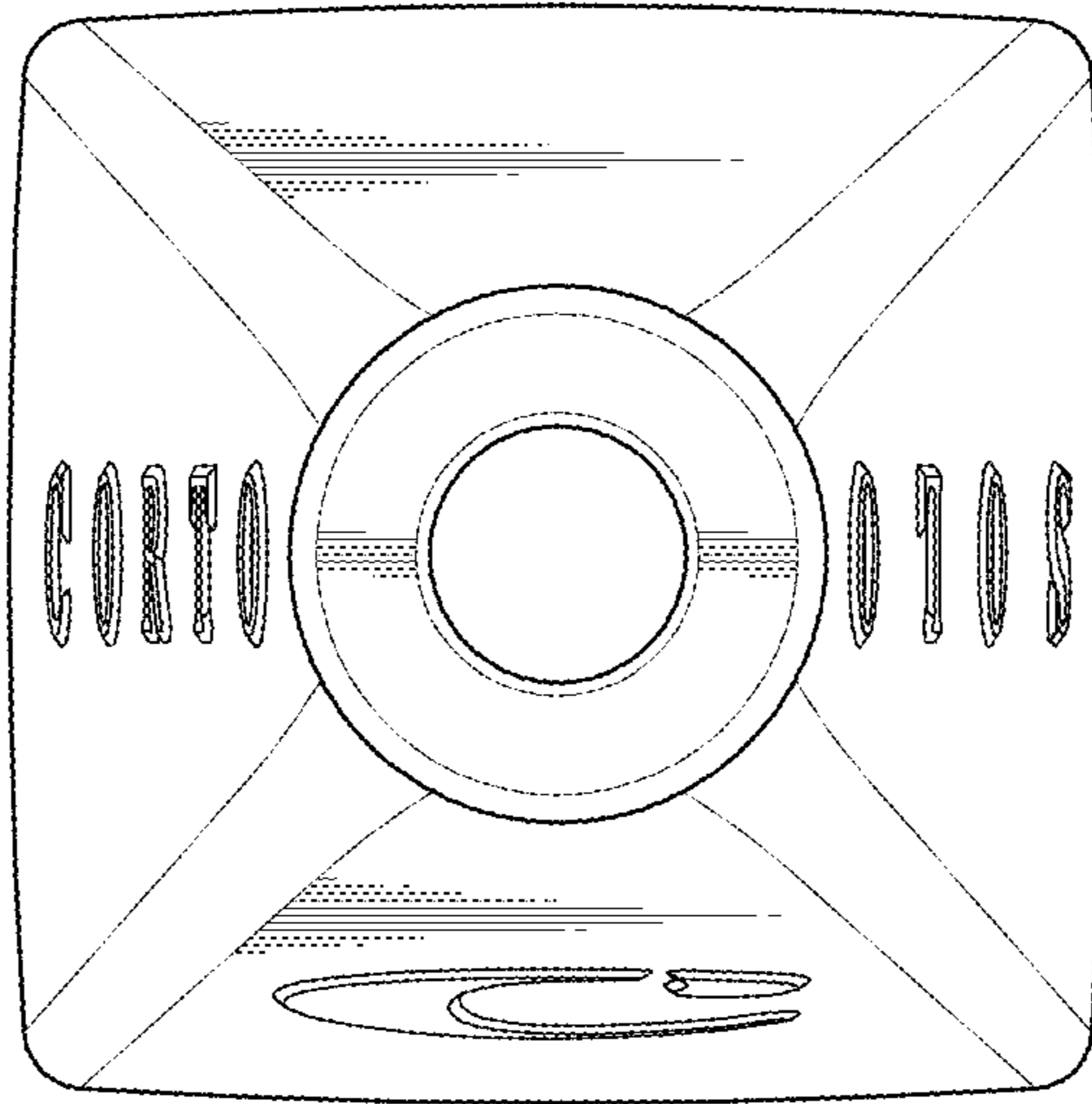
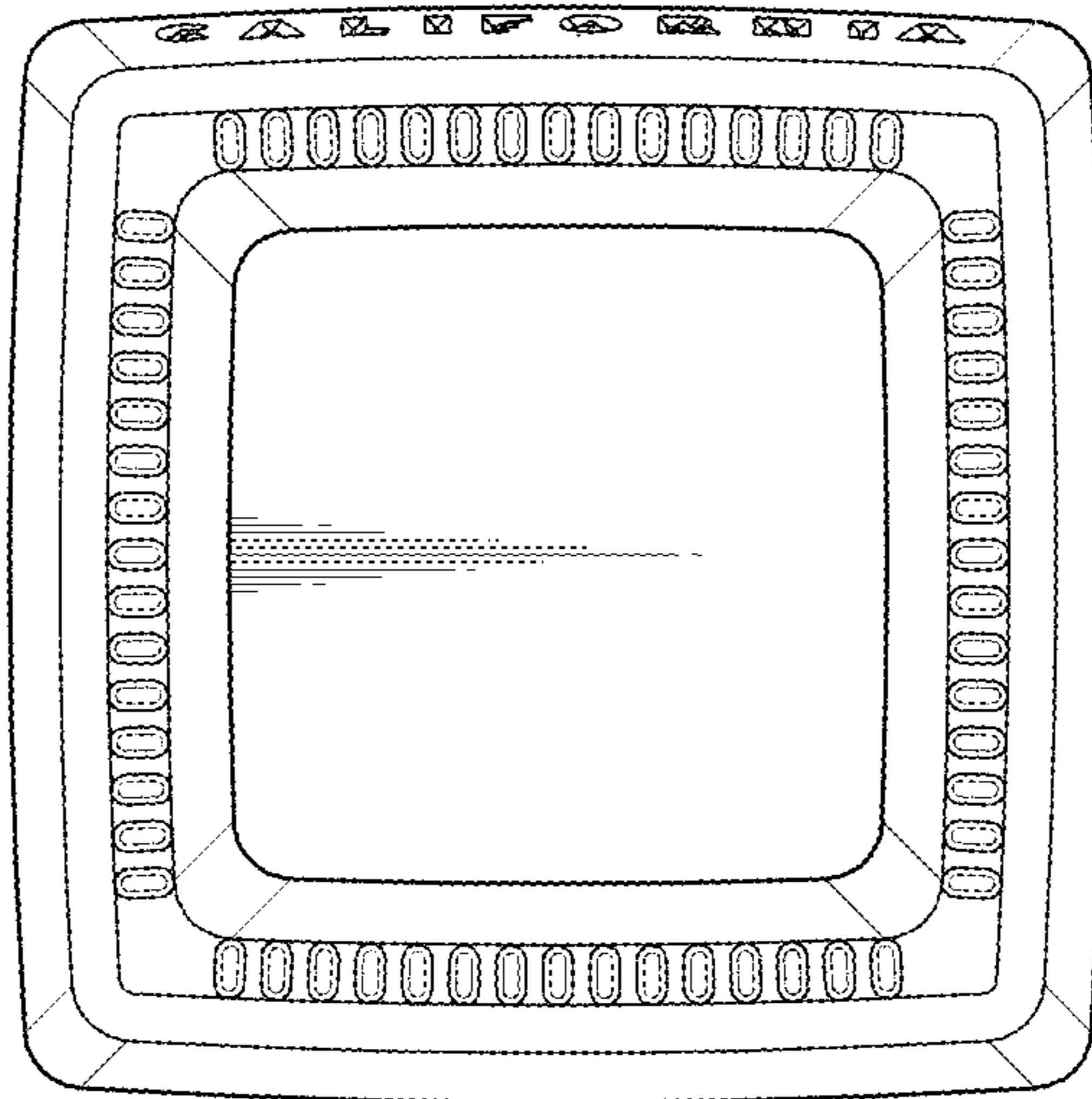

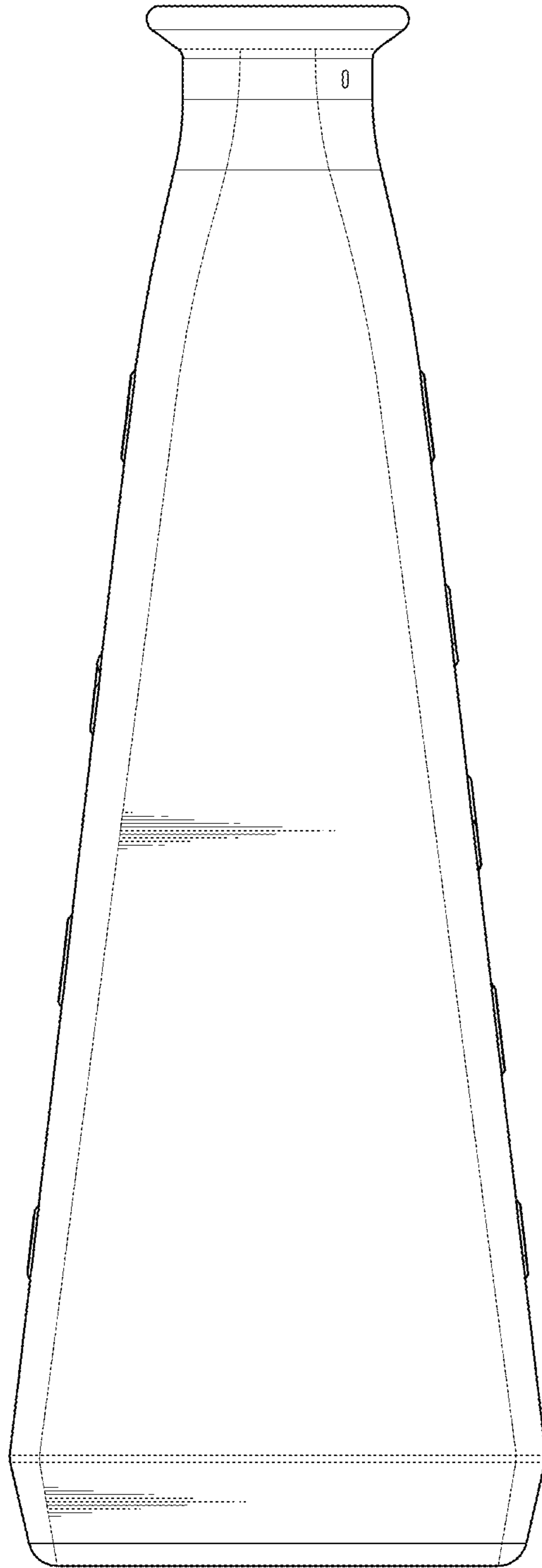

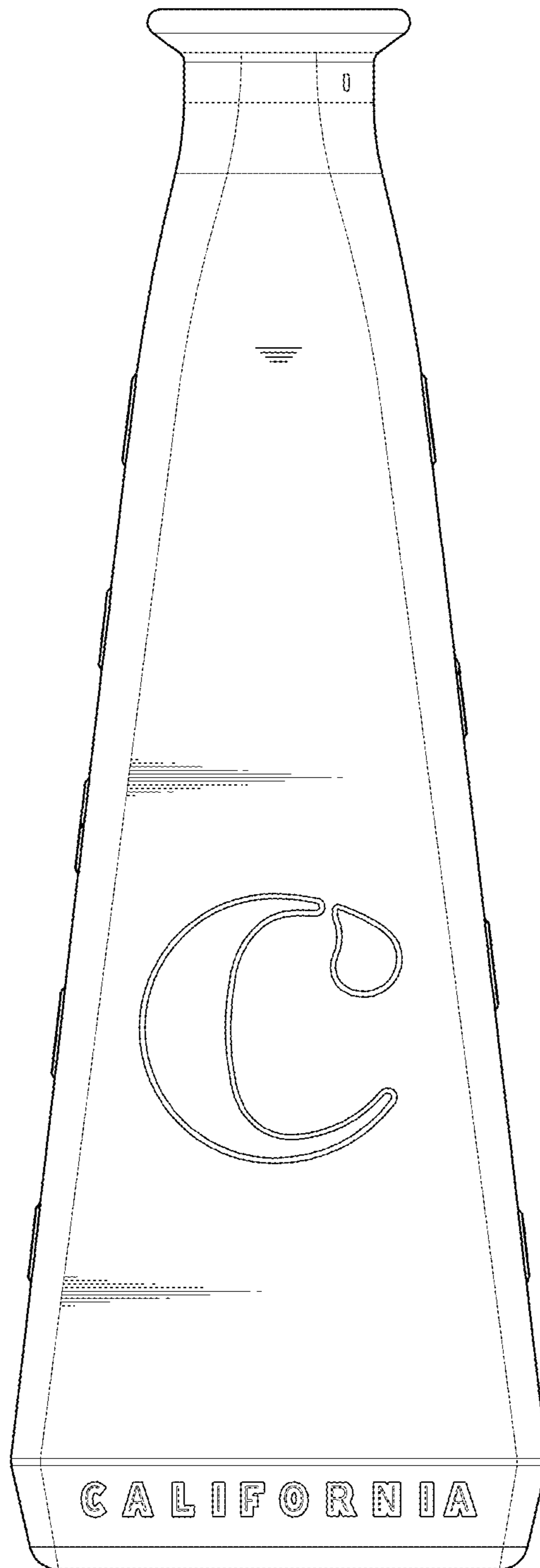
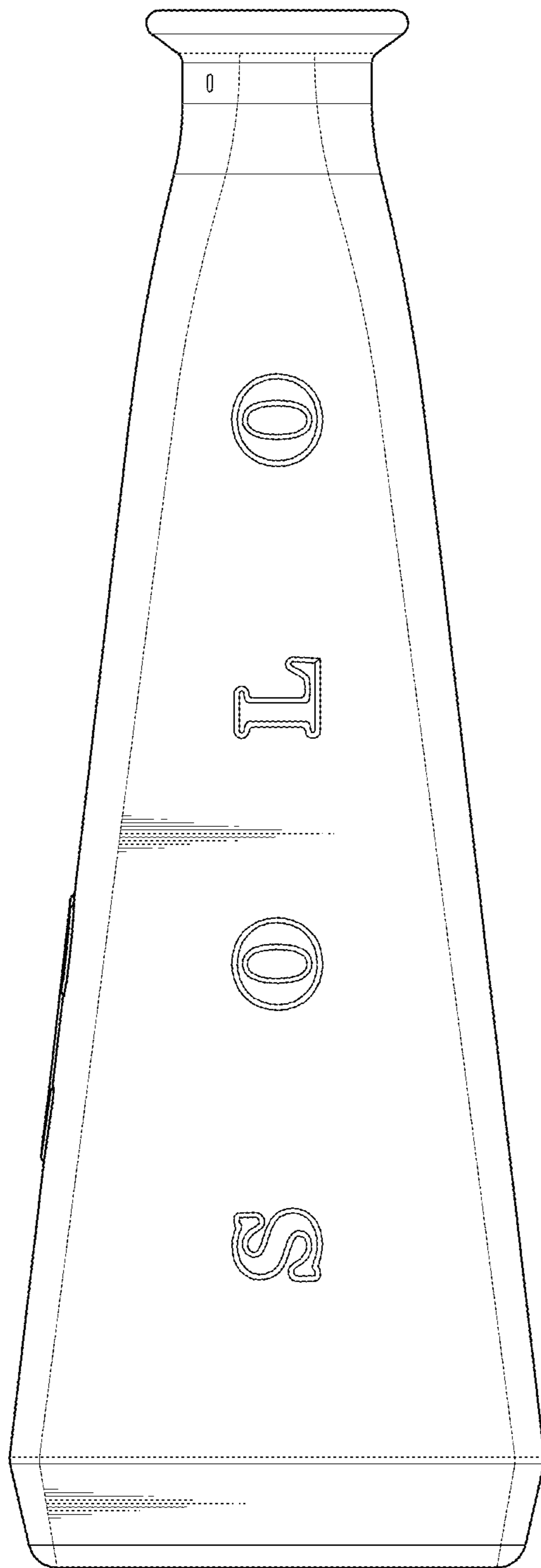
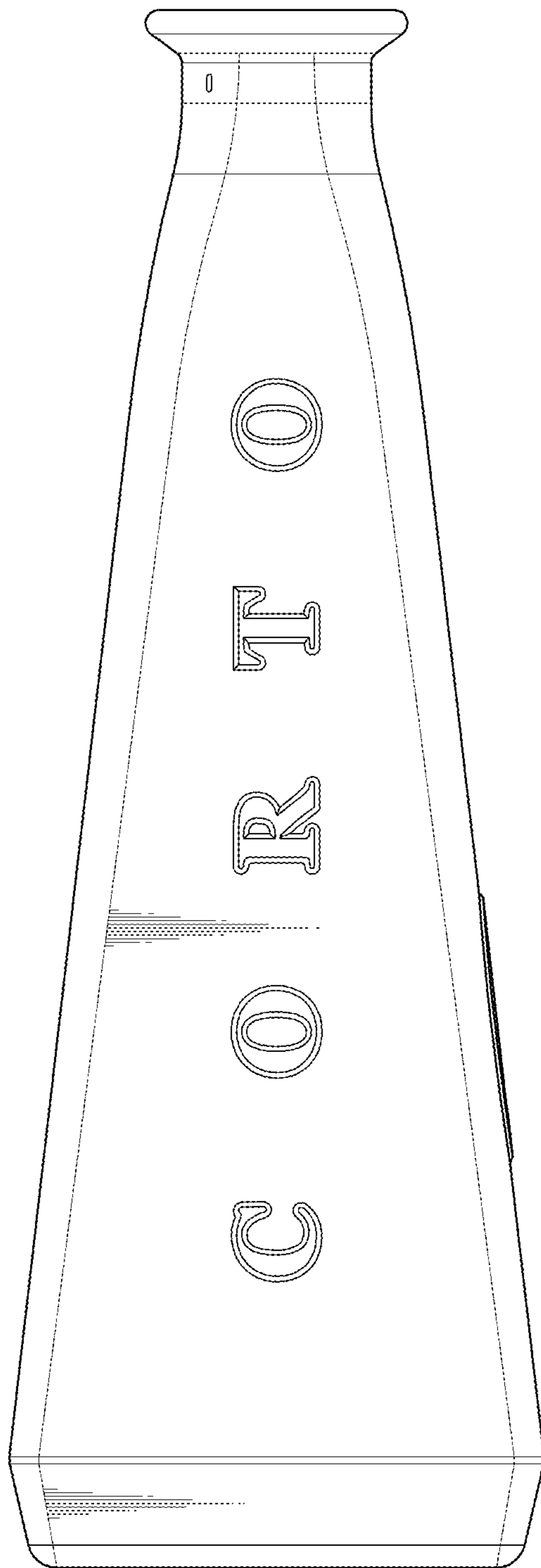

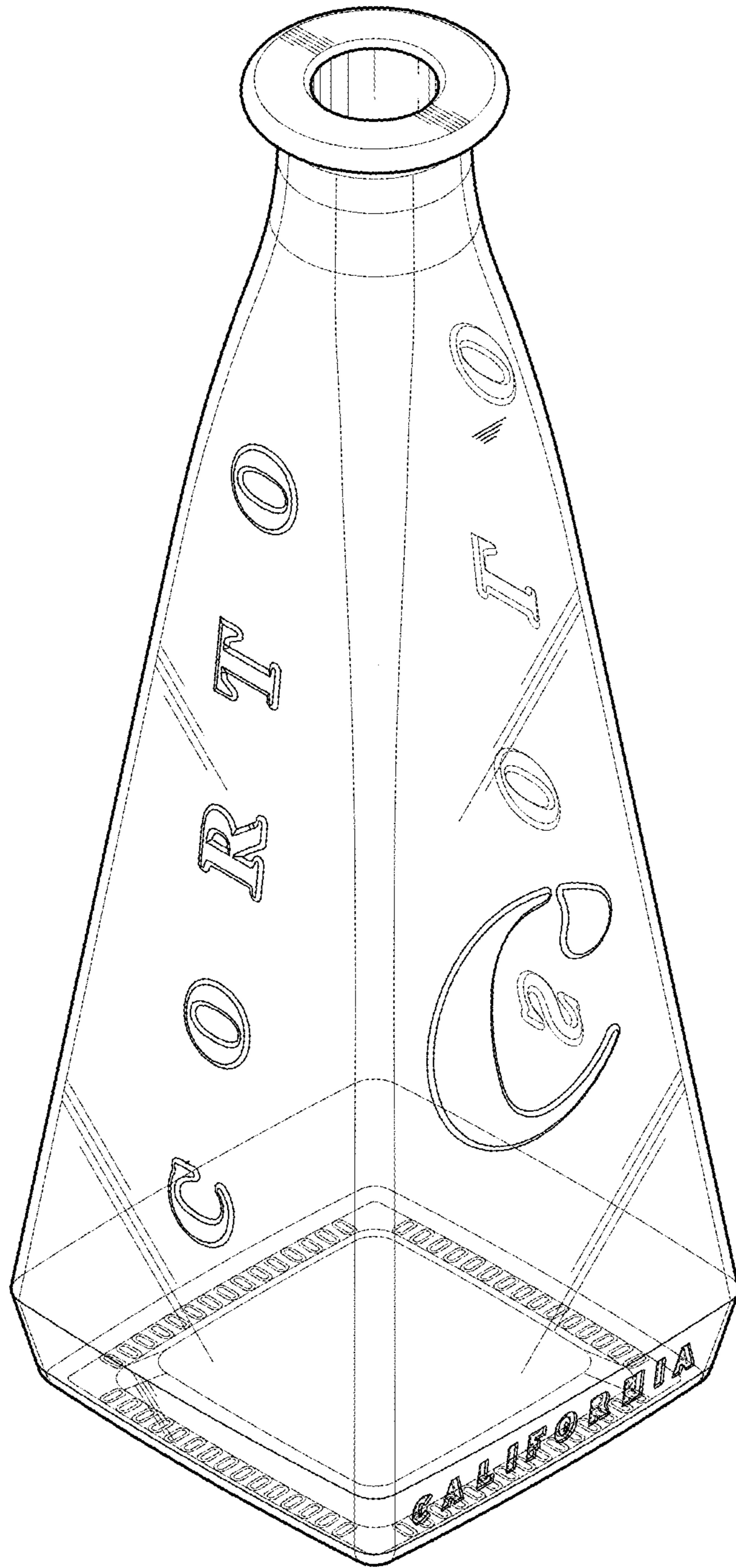
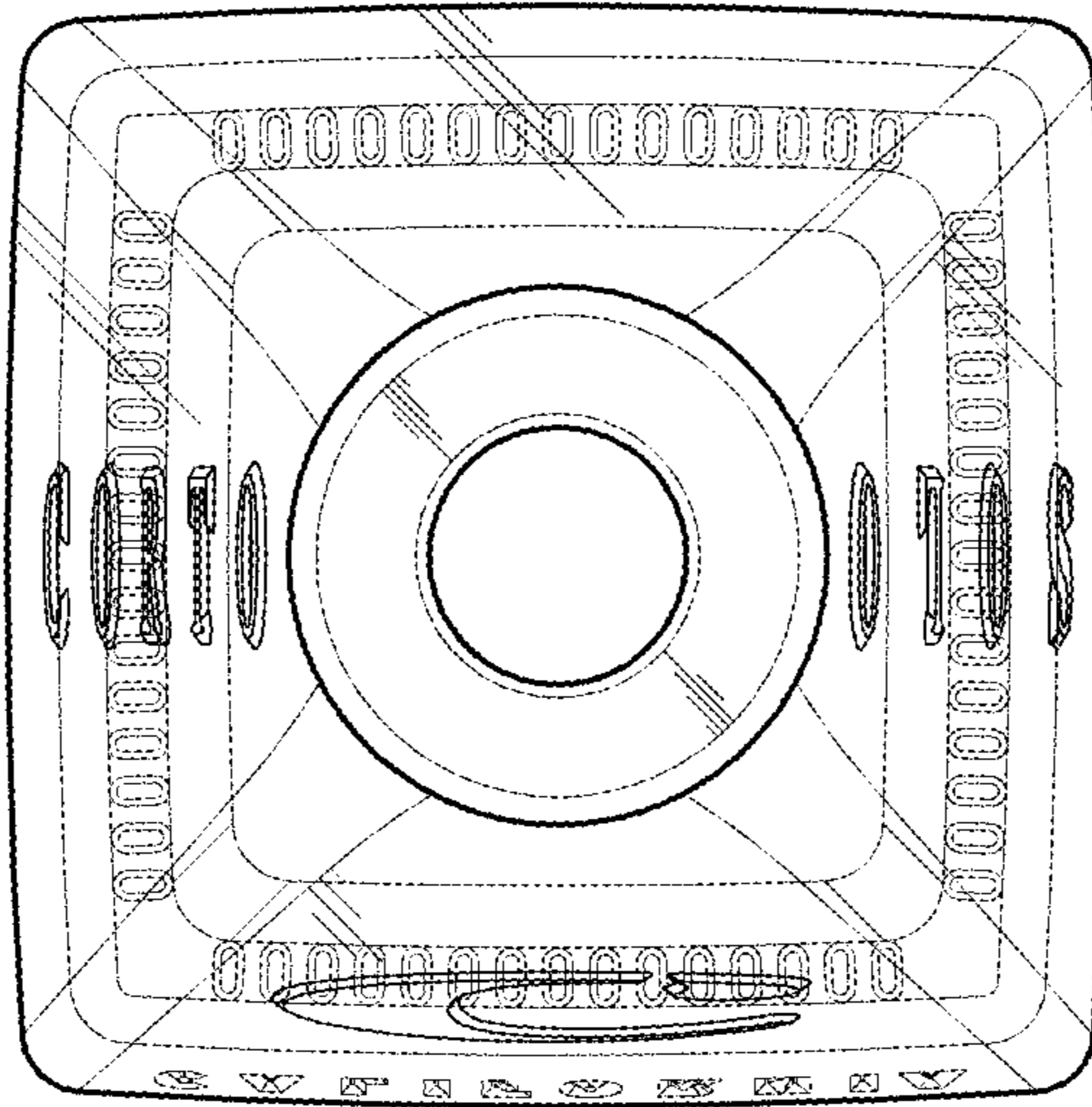
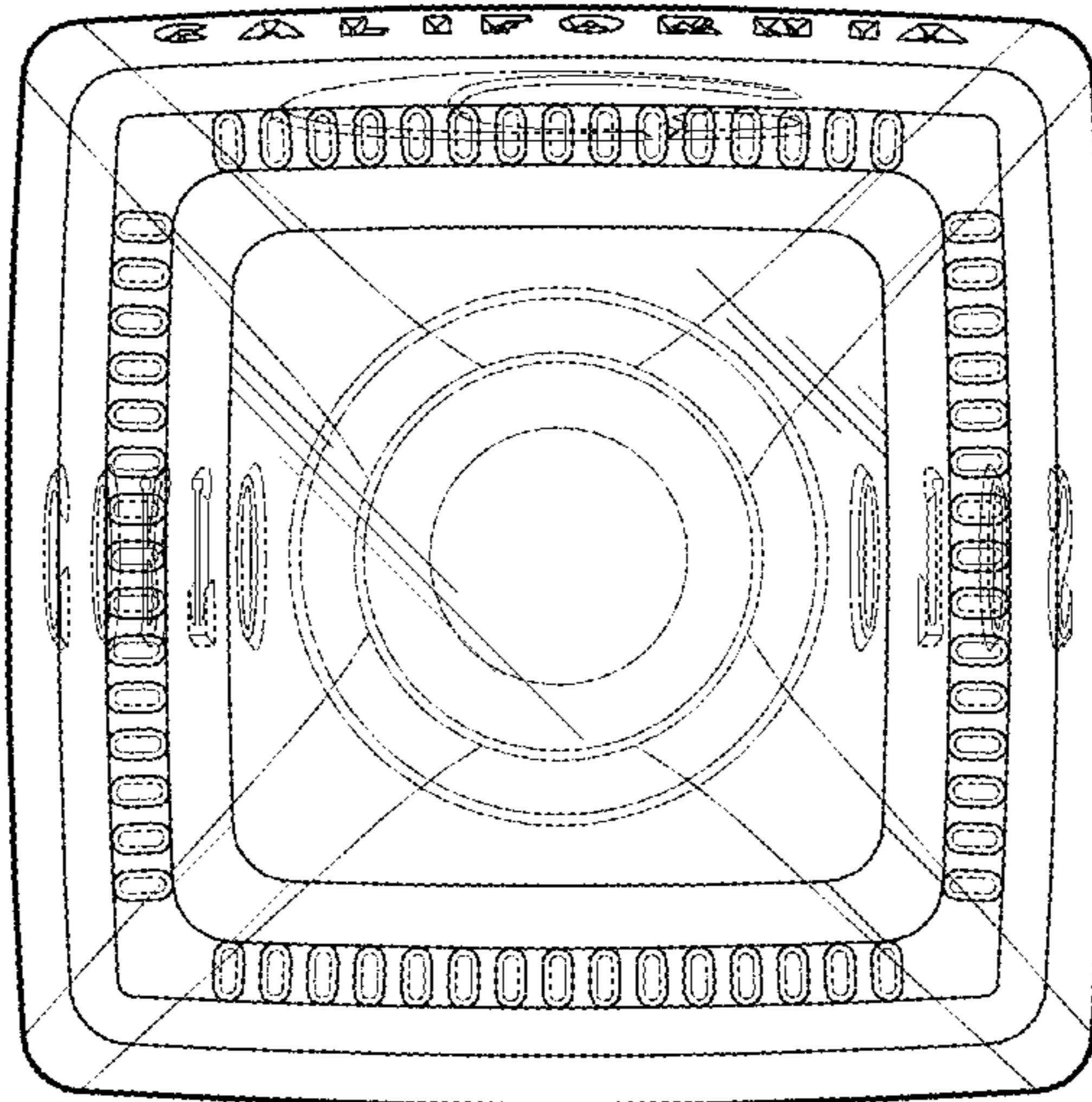

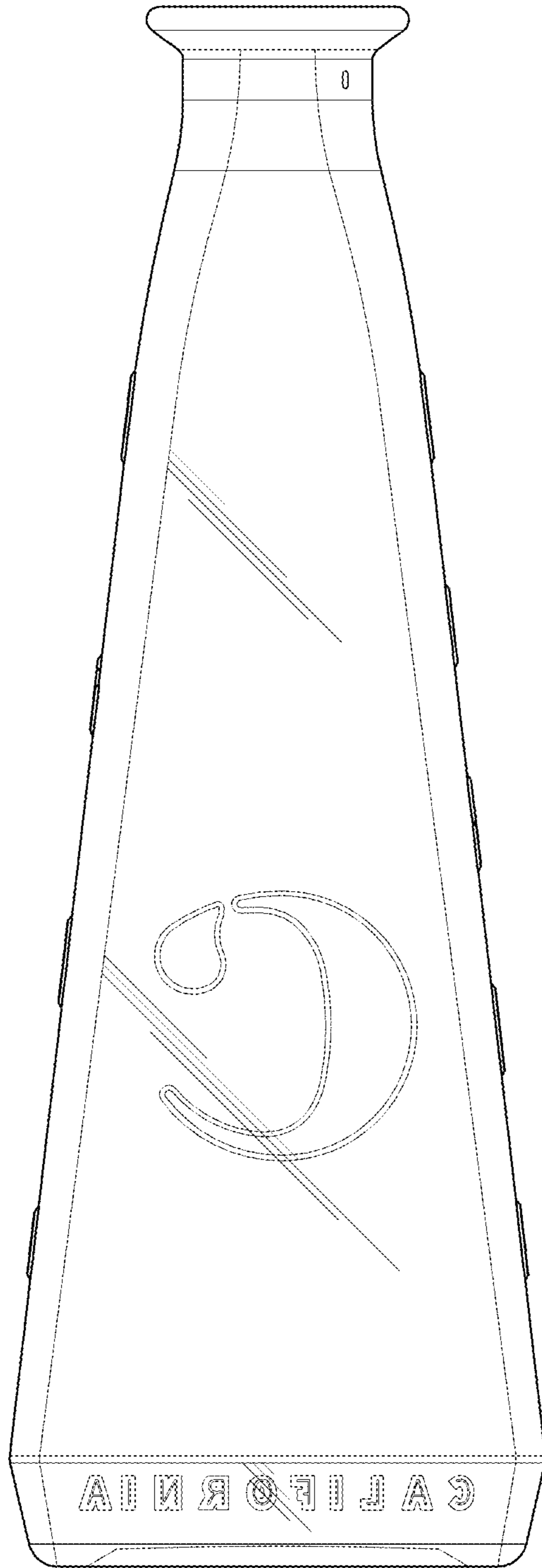

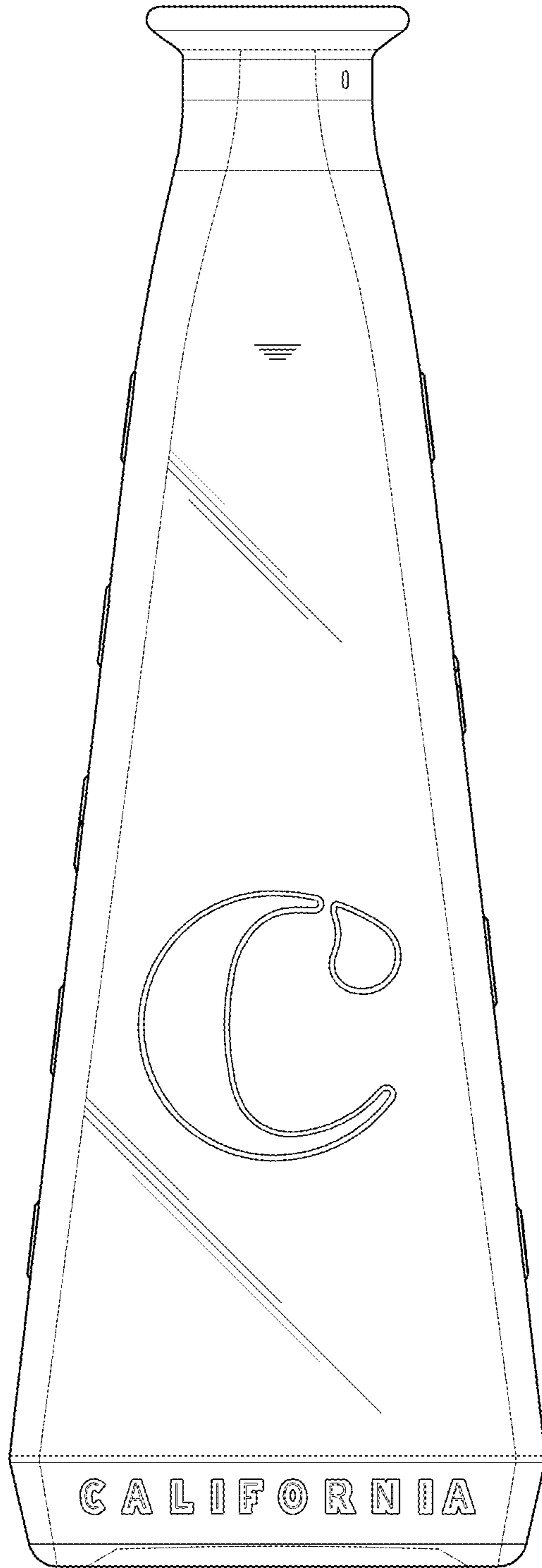
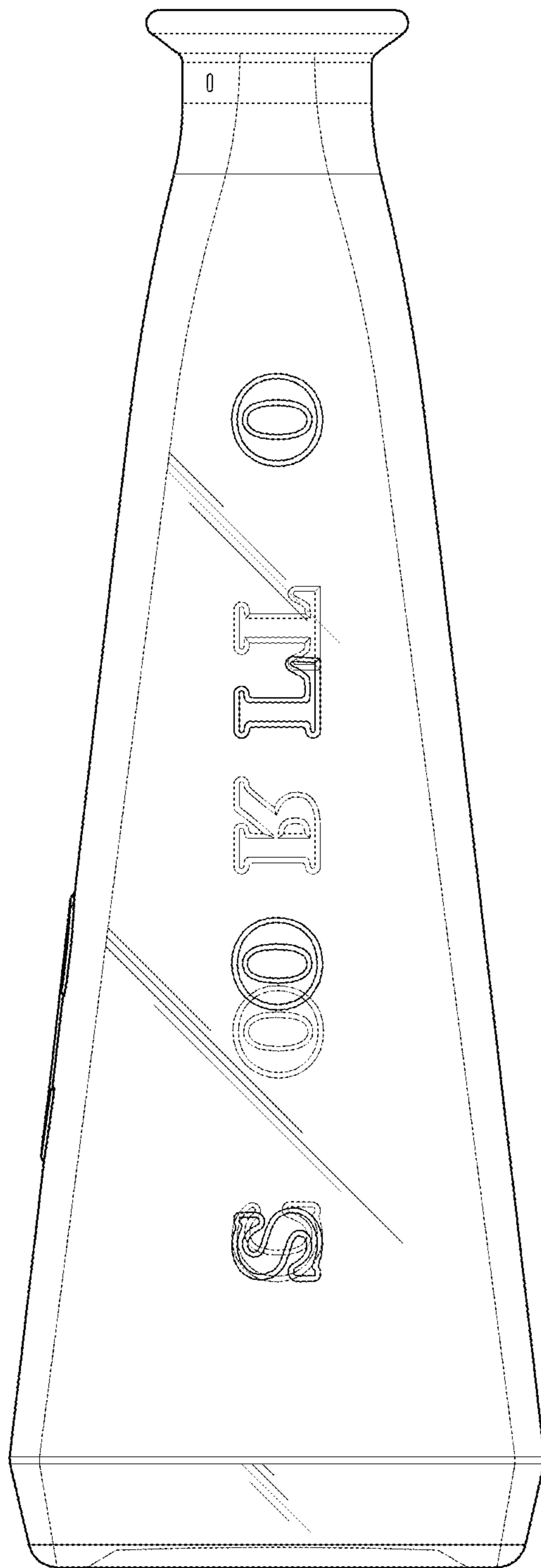
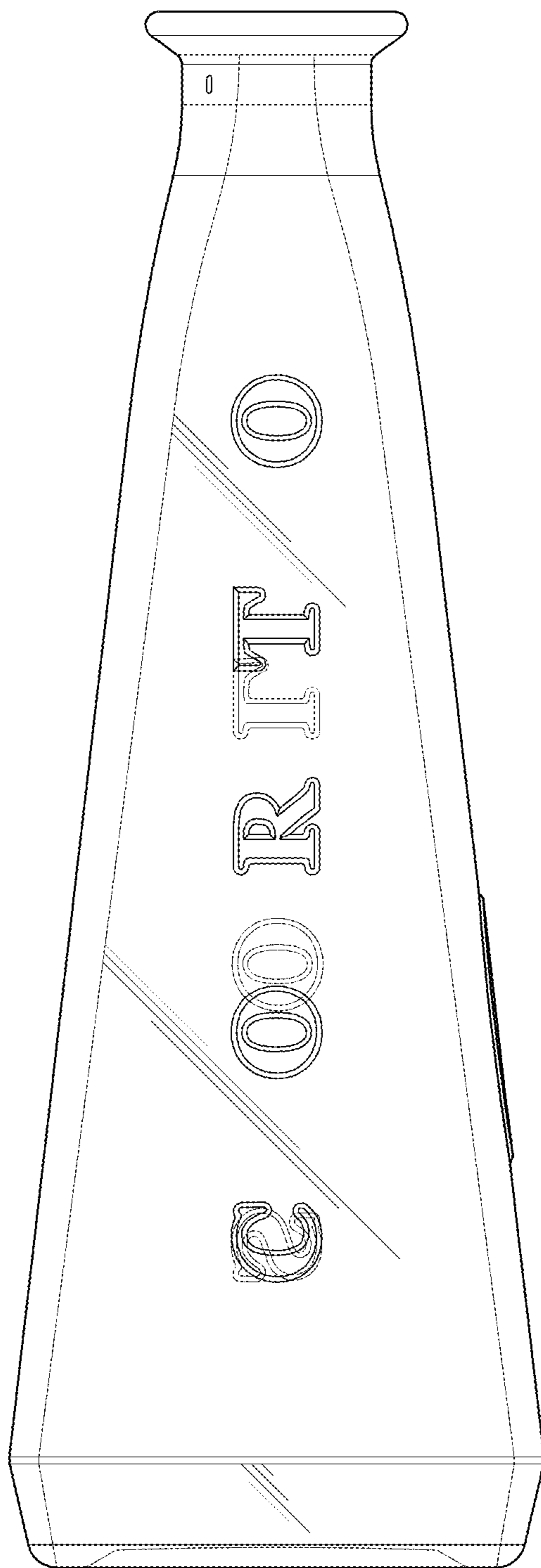
