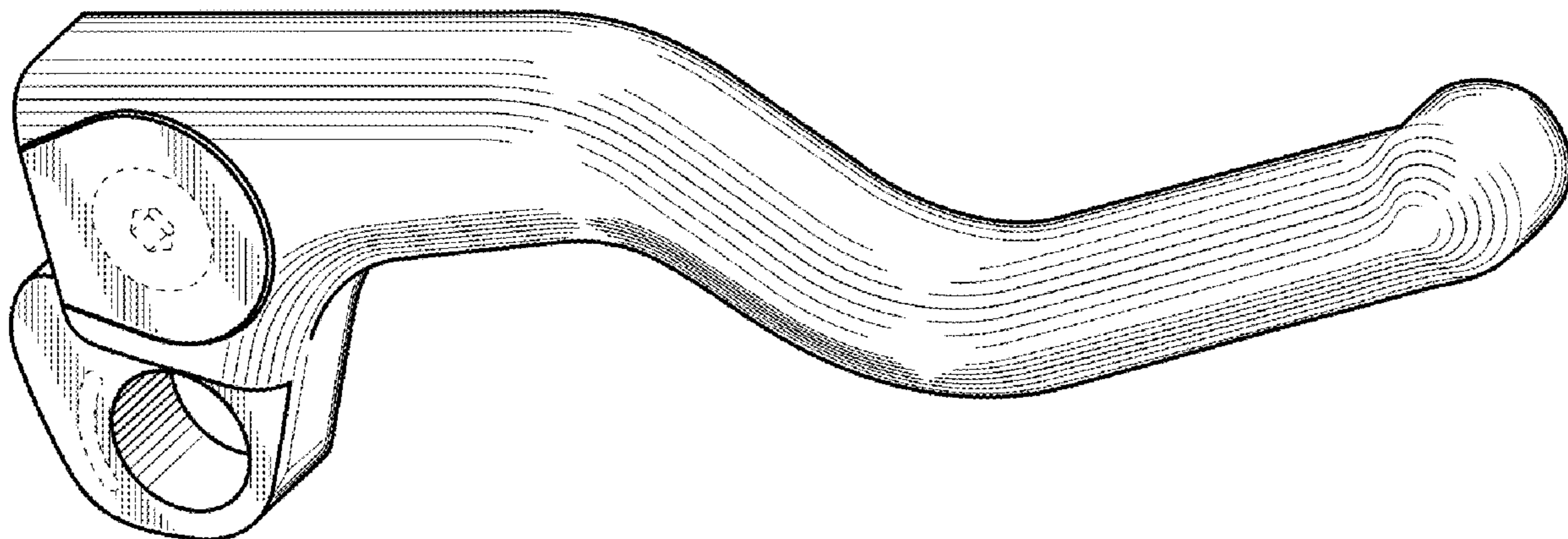

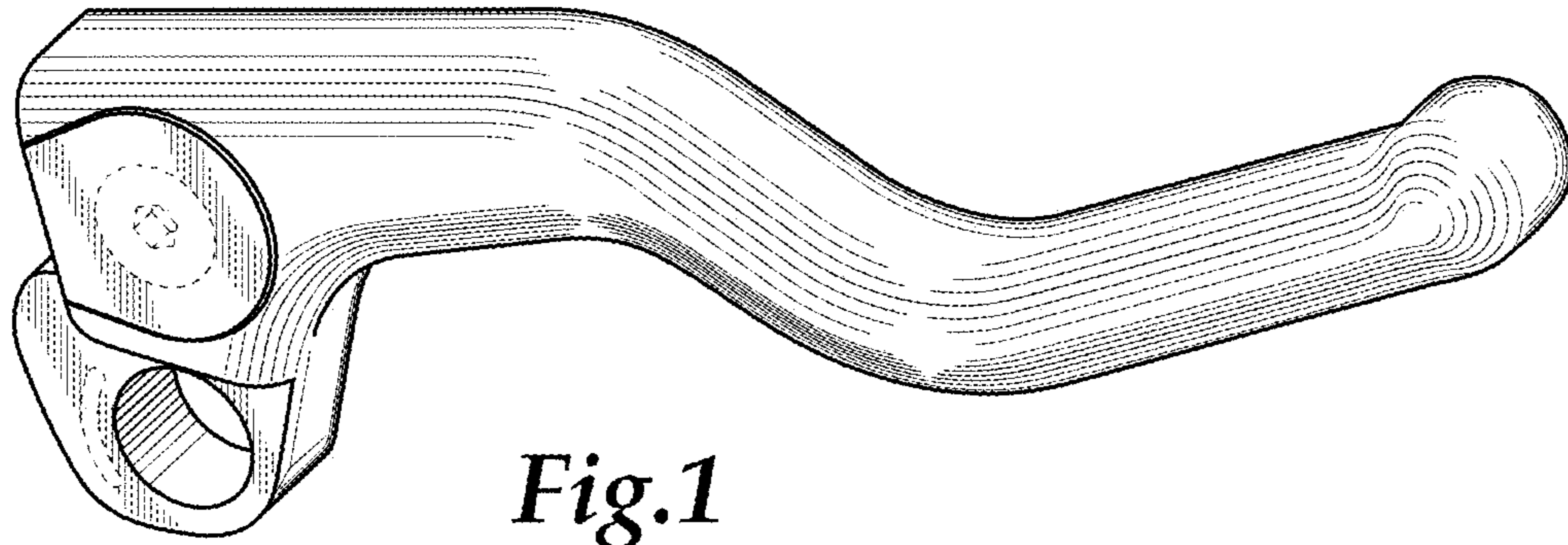
The ornamental design for a clutch lever for motorcycle, as shown and described.

**DESCRIPTION**

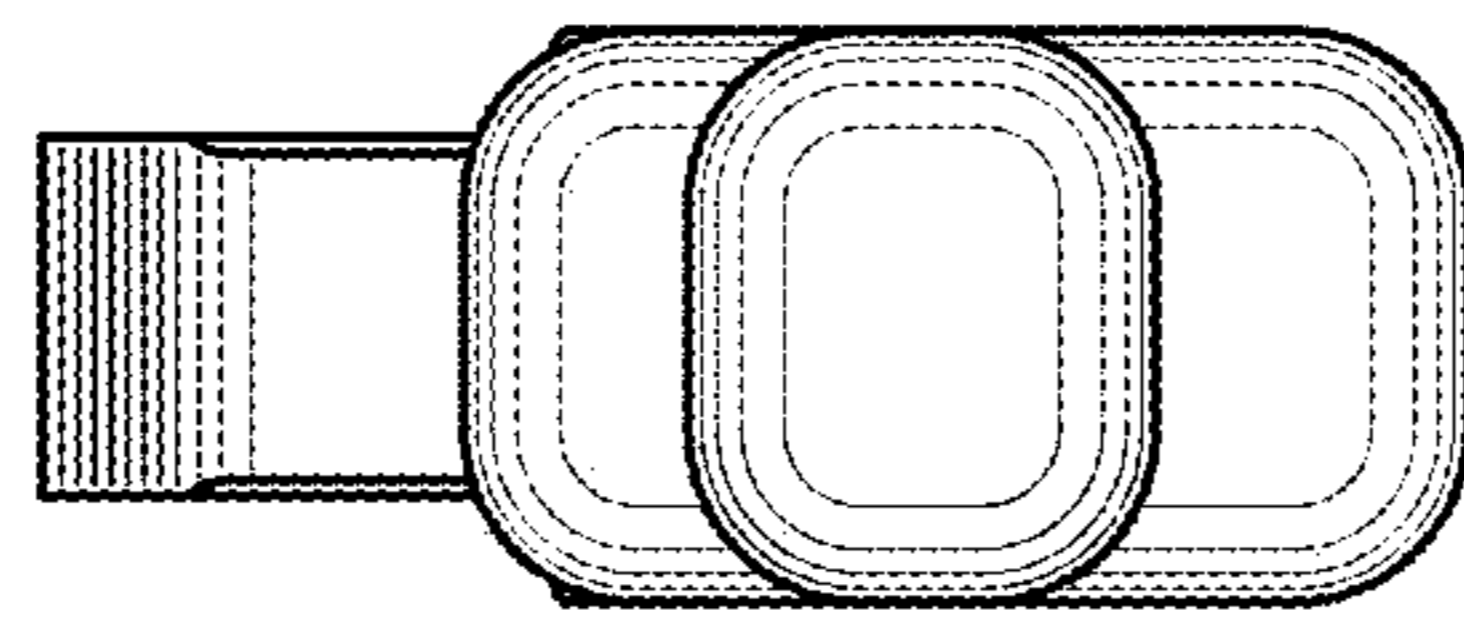
FIG. 1 is a bottom perspective view of the clutch lever for motorcycle, showing my new design;

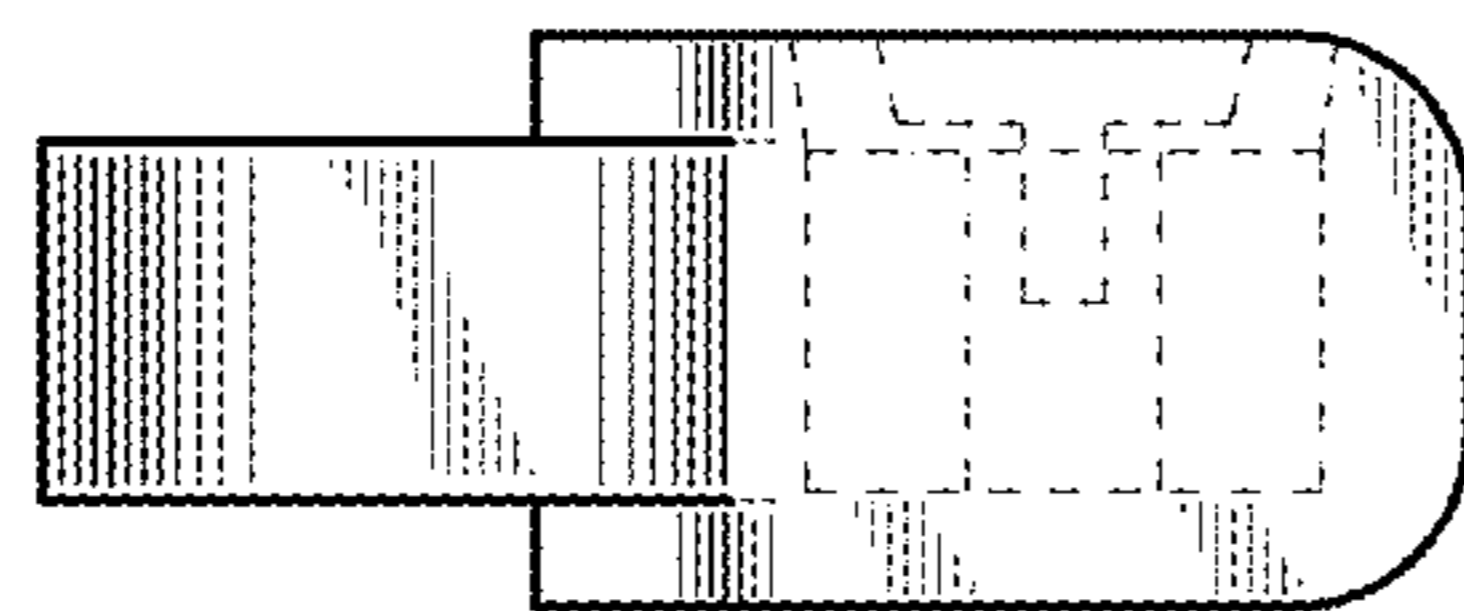




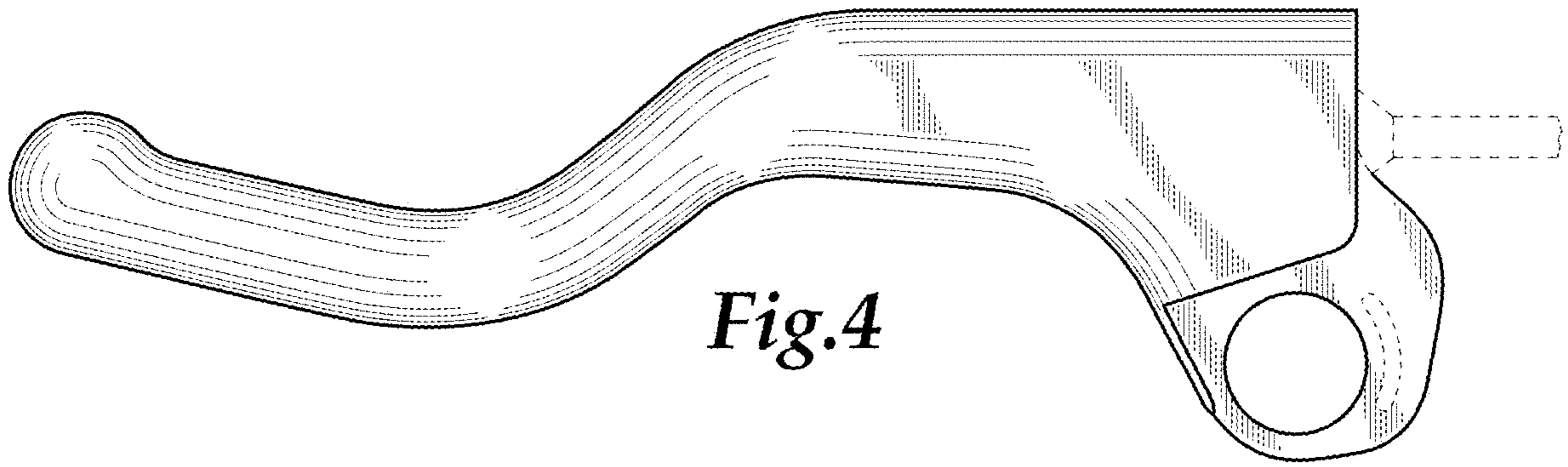

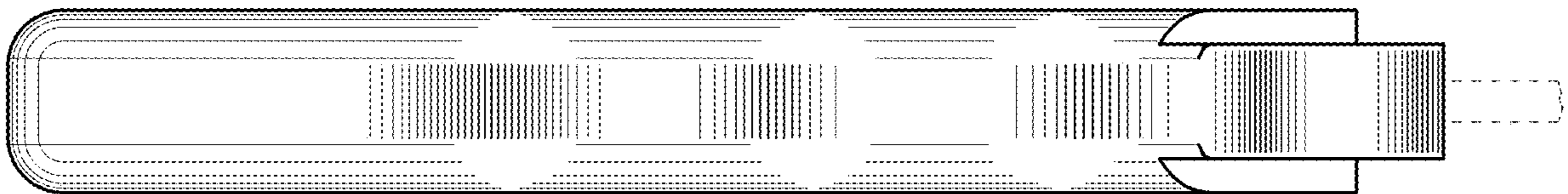

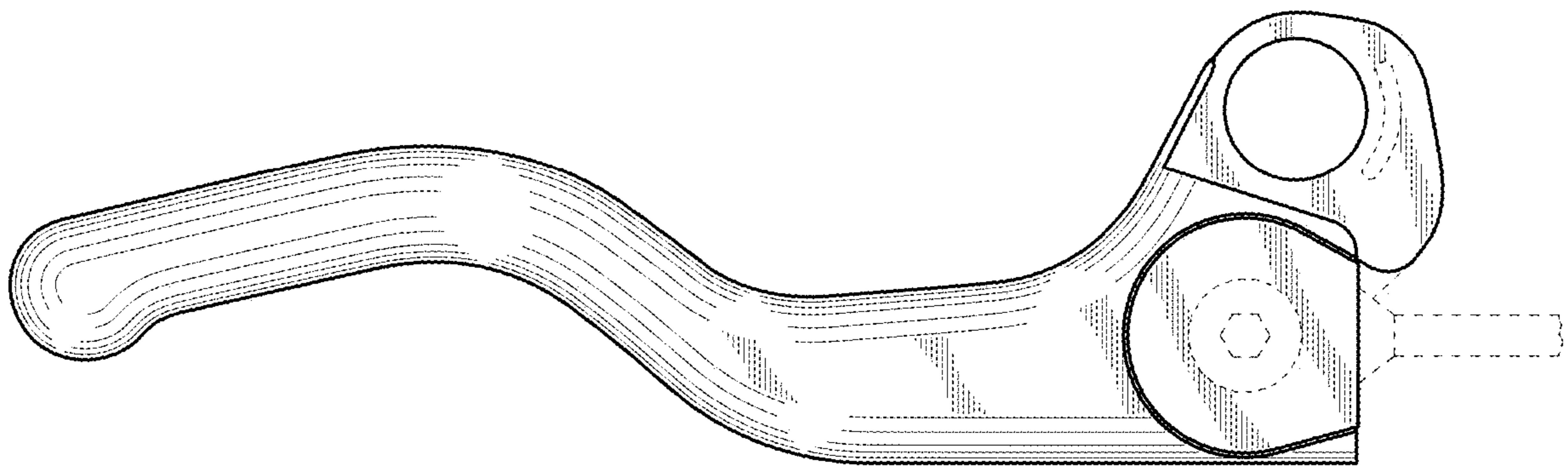

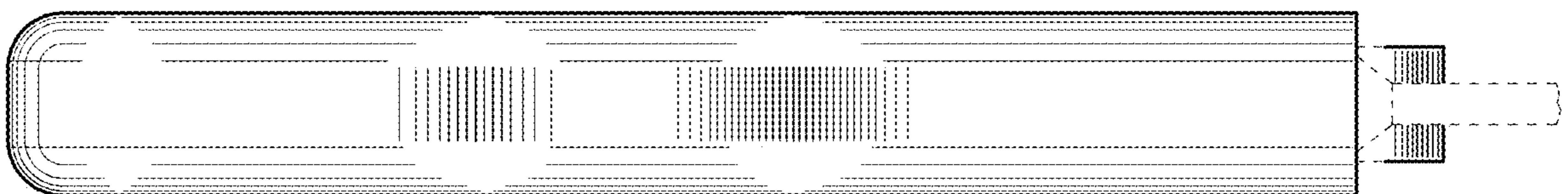
