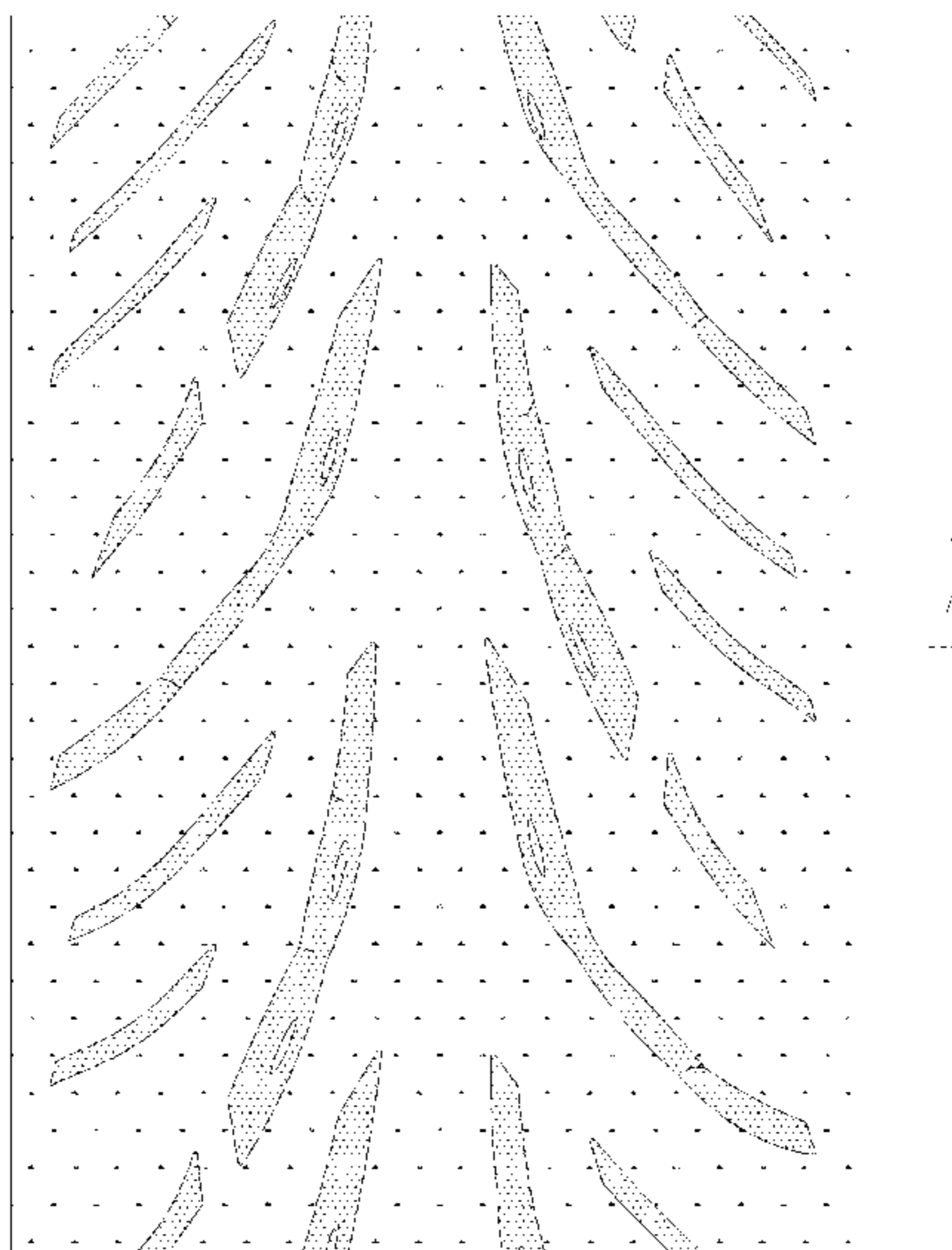
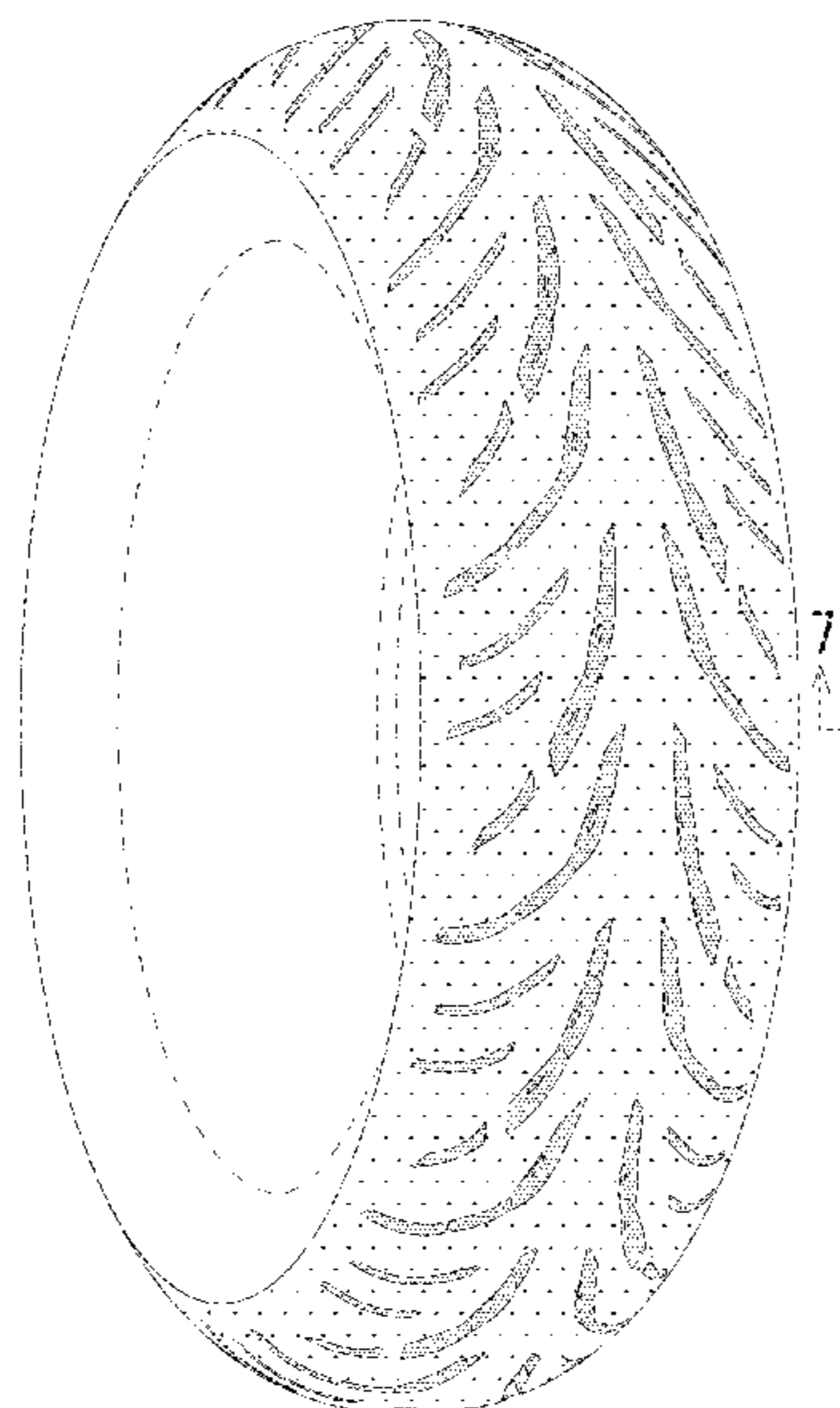
(57) **CLAIM**

The ornamental design for a motorcycle tire, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a motorcycle tire showing my
new design;
FIG. 2 is a front view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a fragmentary enlarged front view; and,
FIG. 7 is an end view taken along line 7-7 in FIG. 6.
Broken lines shown in the drawings are intended to show
portions of the motorcycle tire that are not being claimed,
and thus illustrative purpose only and form no part of the
claimed design. The light stippled surface shading repre-
sents the surface of the tire tread, and the dark stippled
surface shading represents the recessed portion of the tread
grooves, having the depth as shown in FIG. 7.

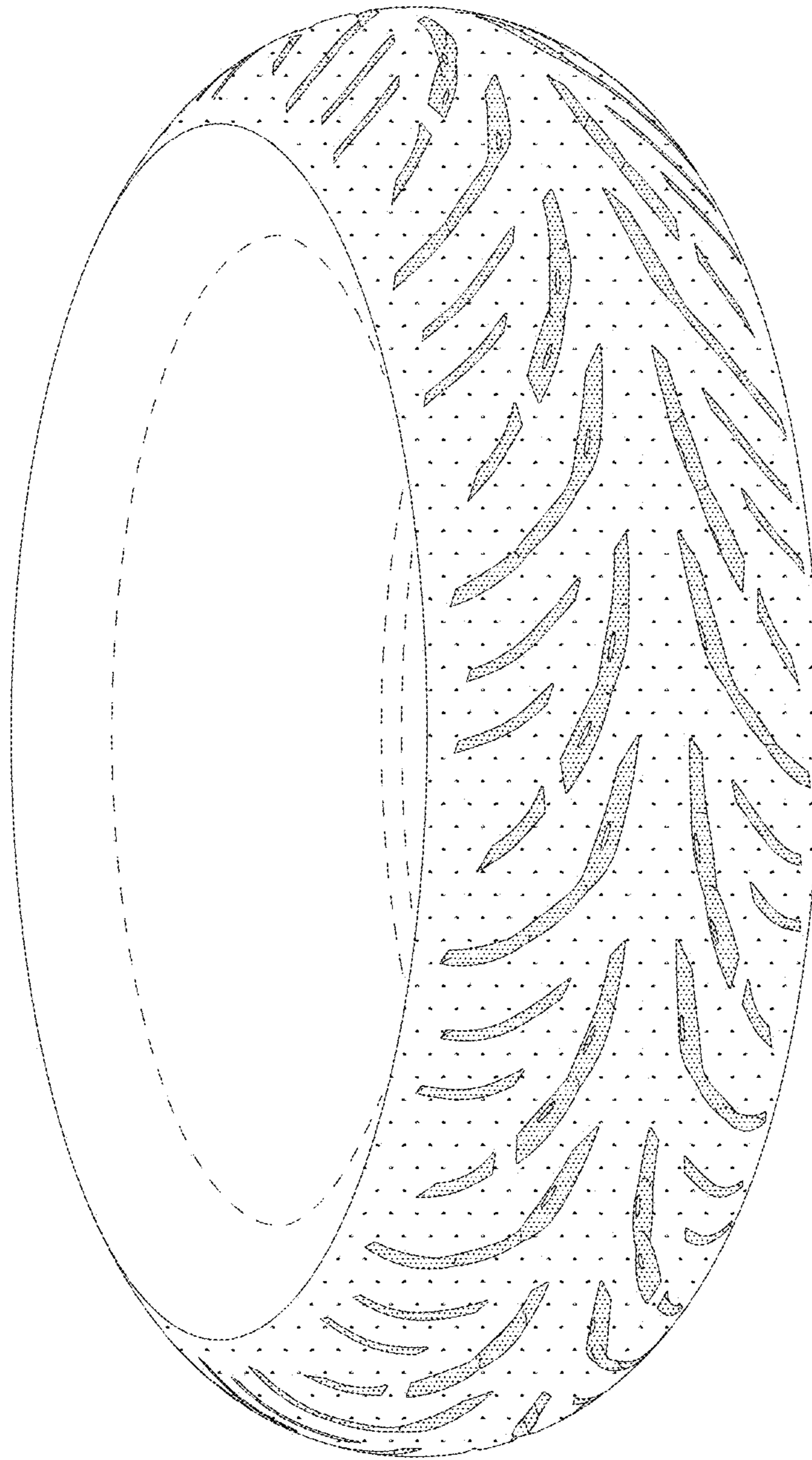

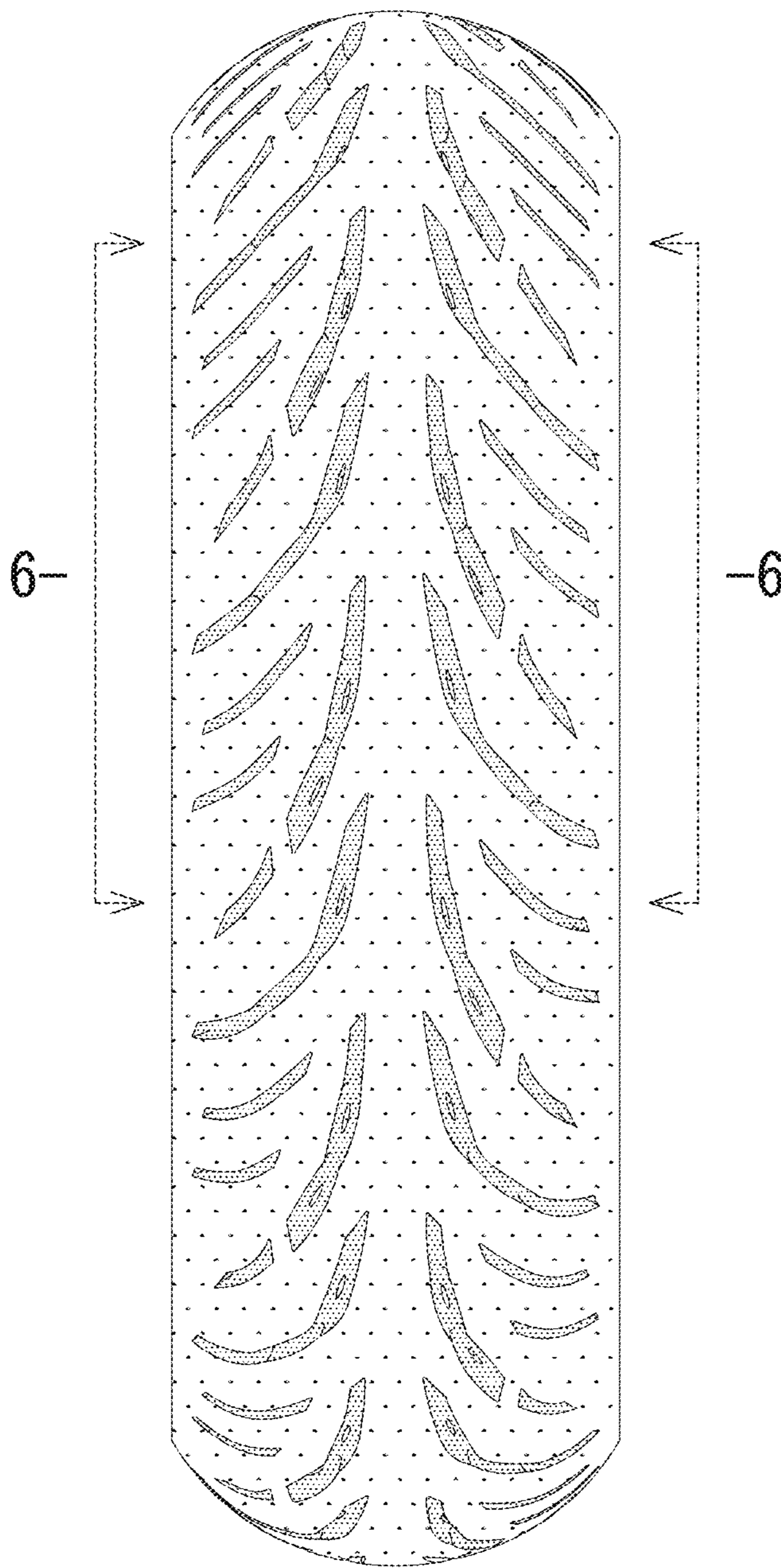

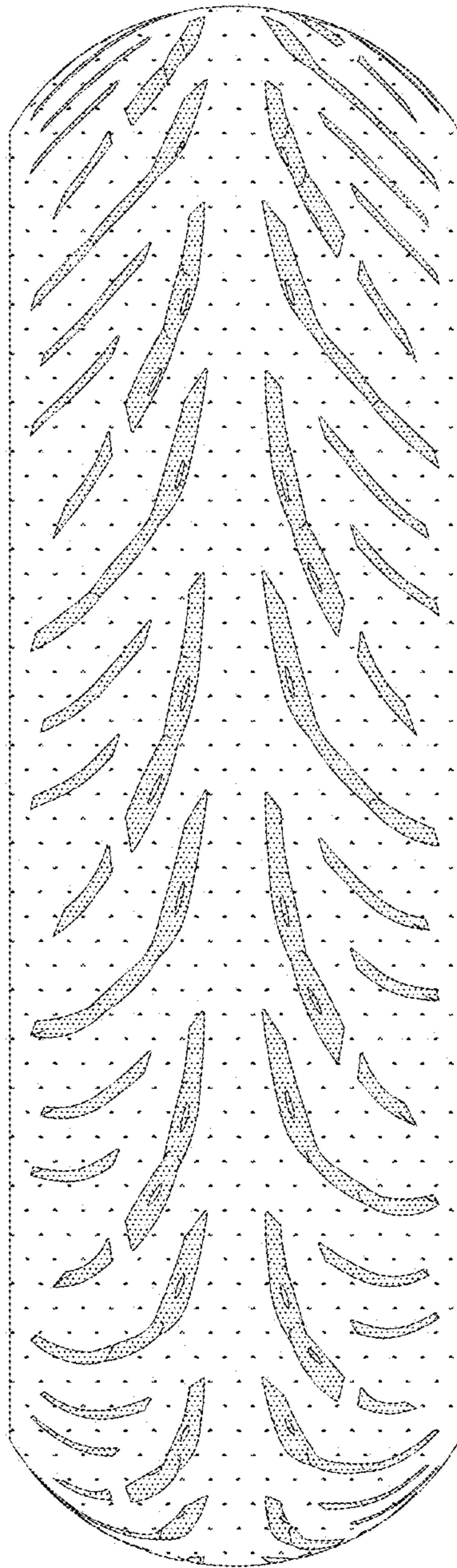

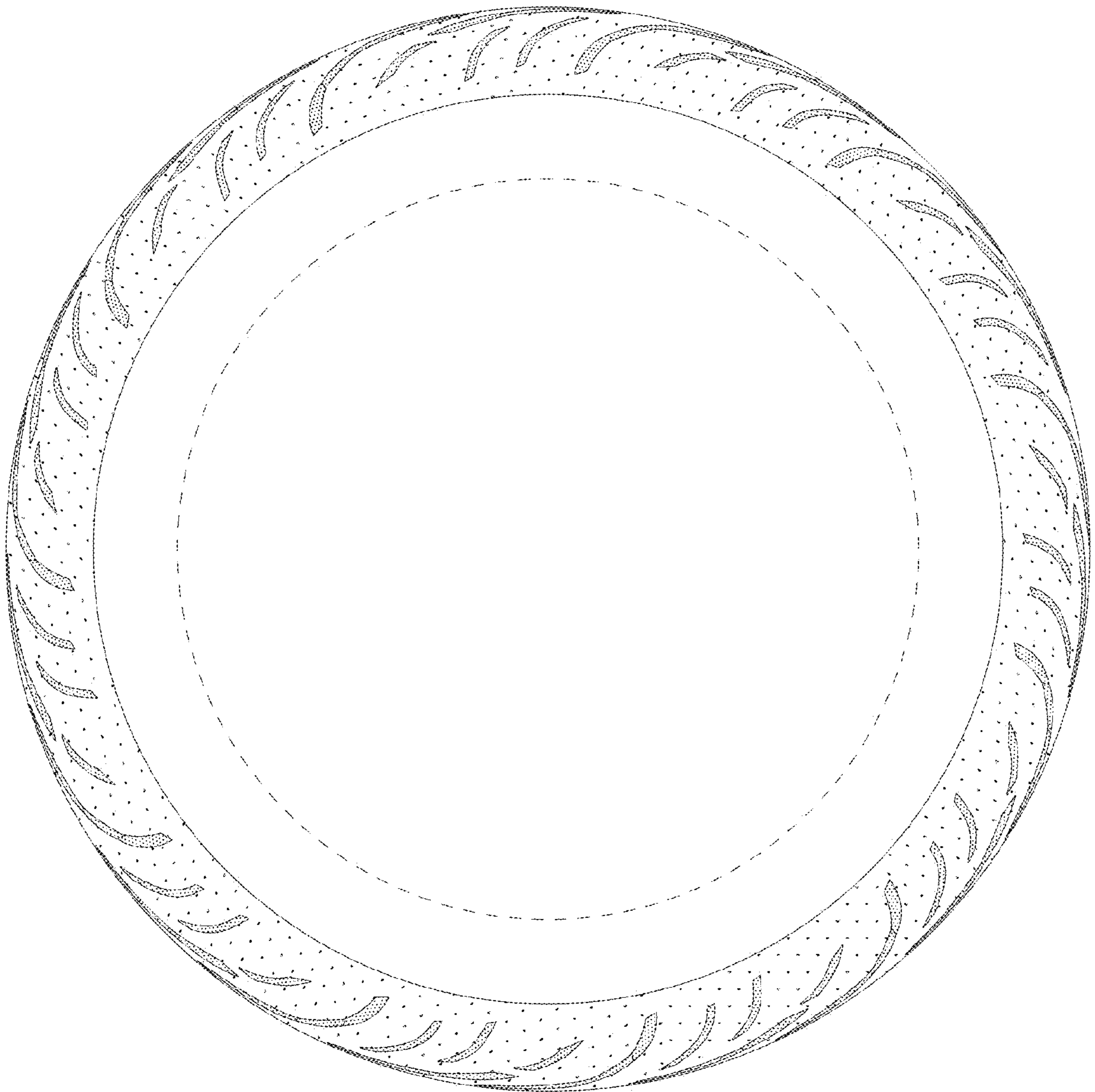

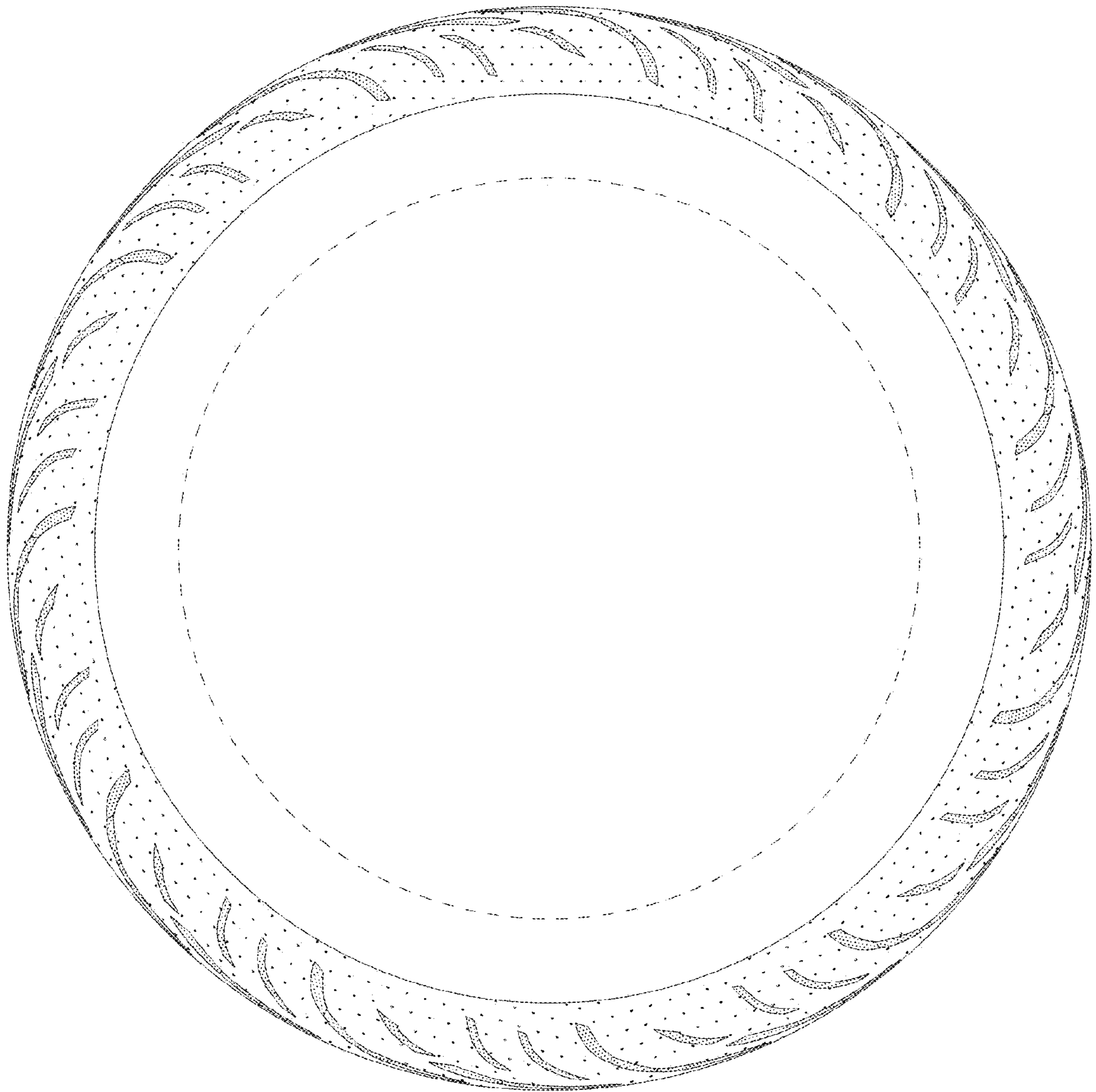

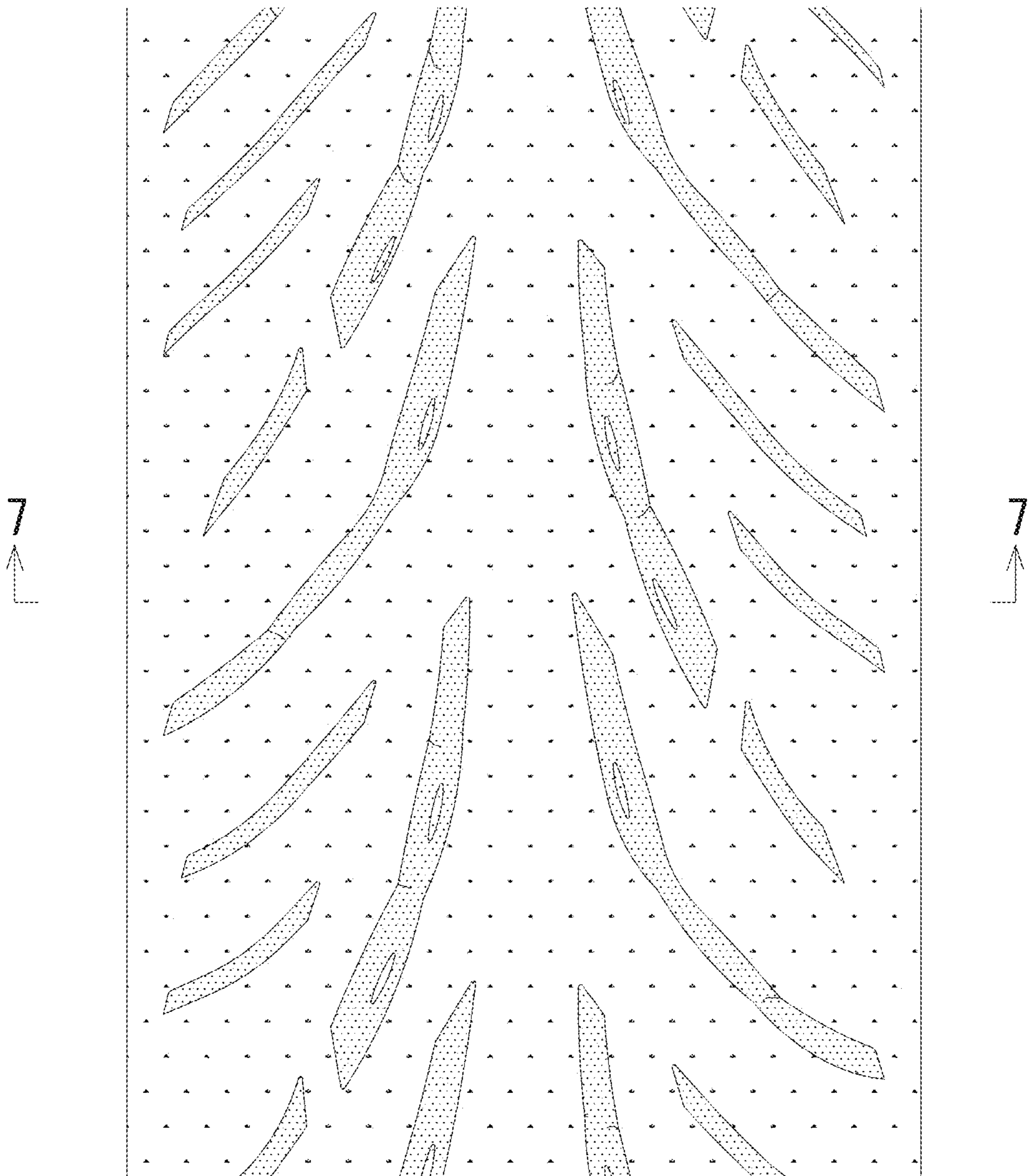
