DESCRIPTION

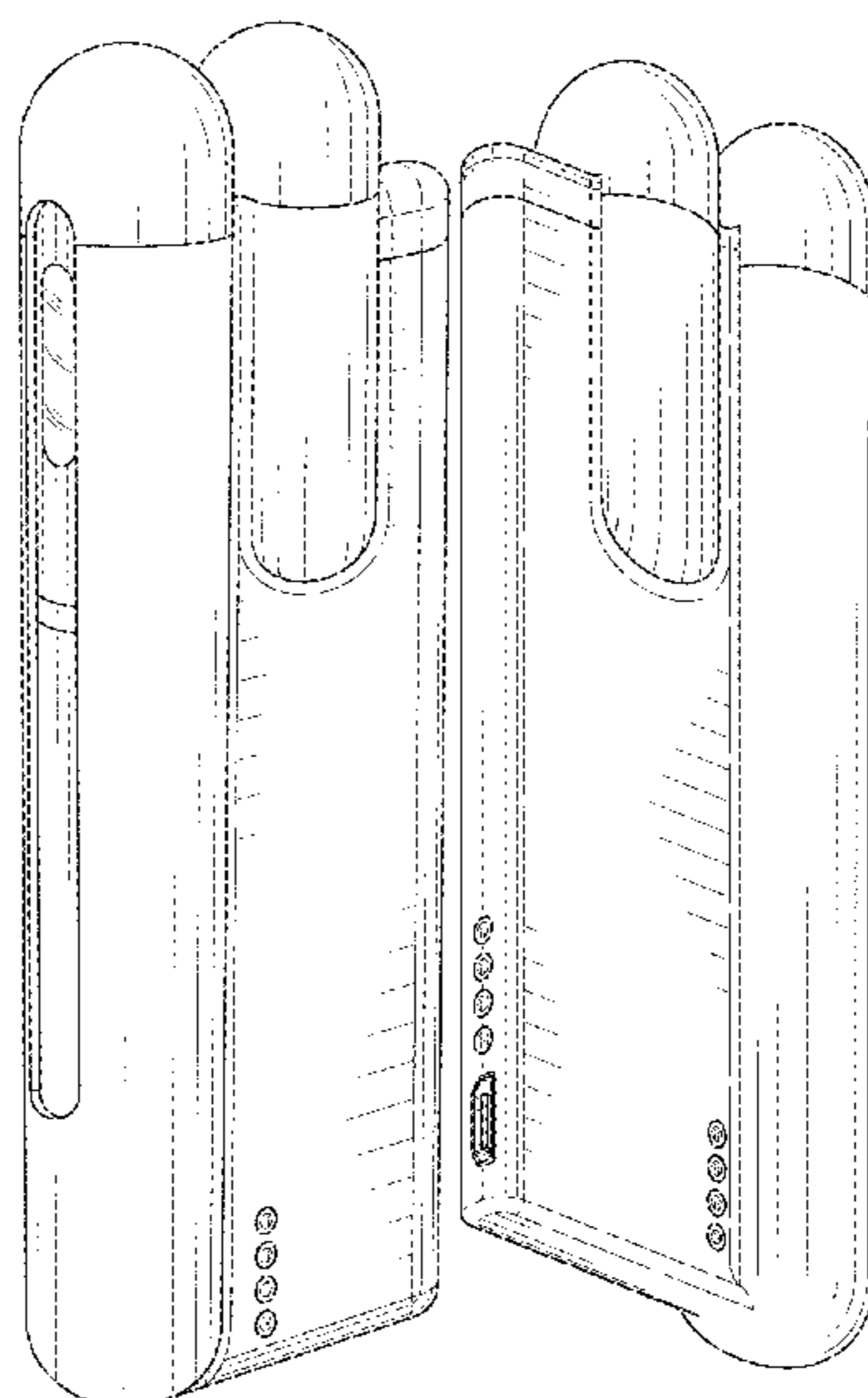

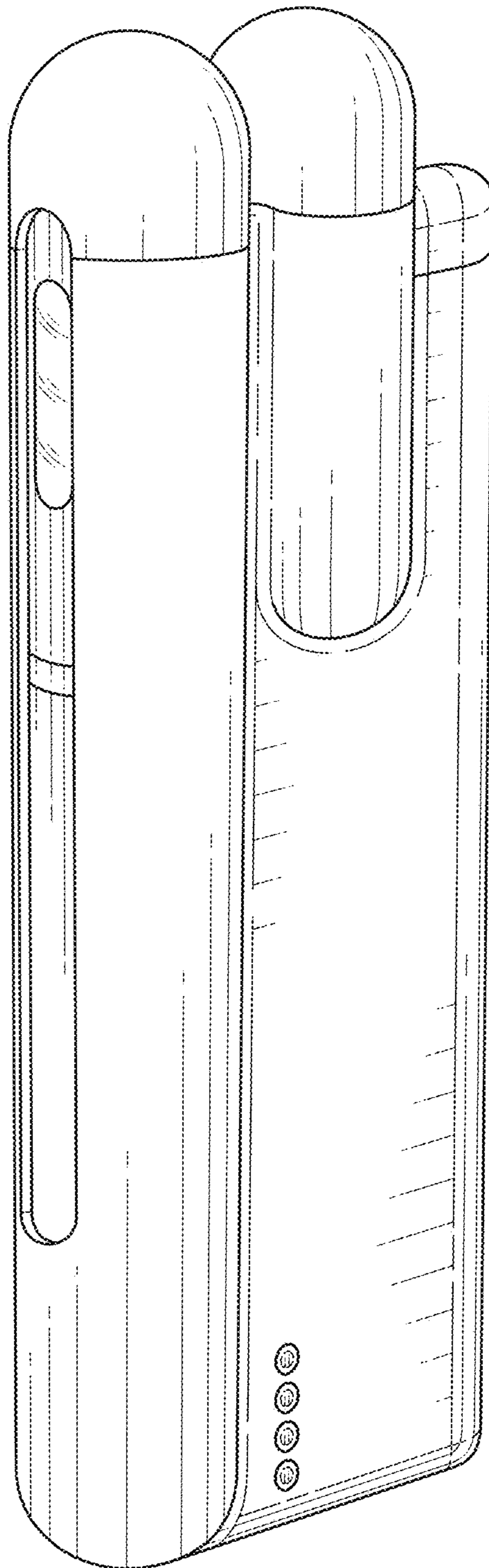

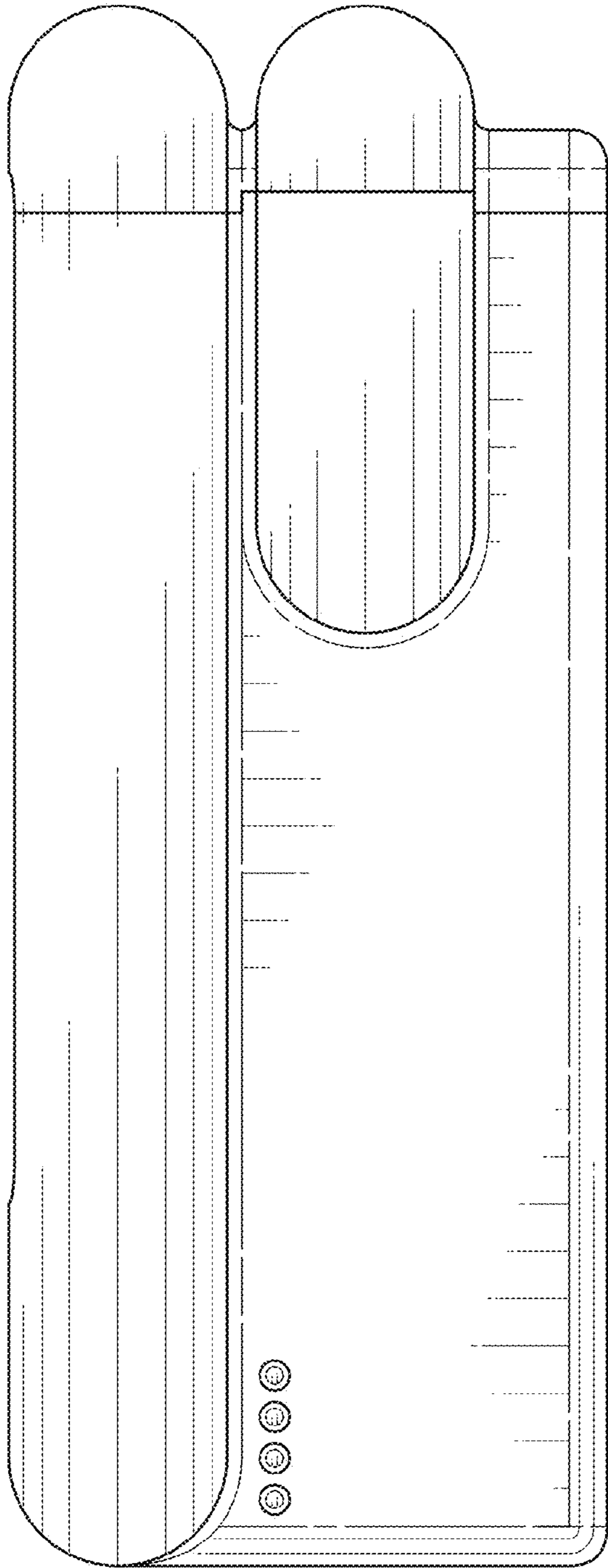

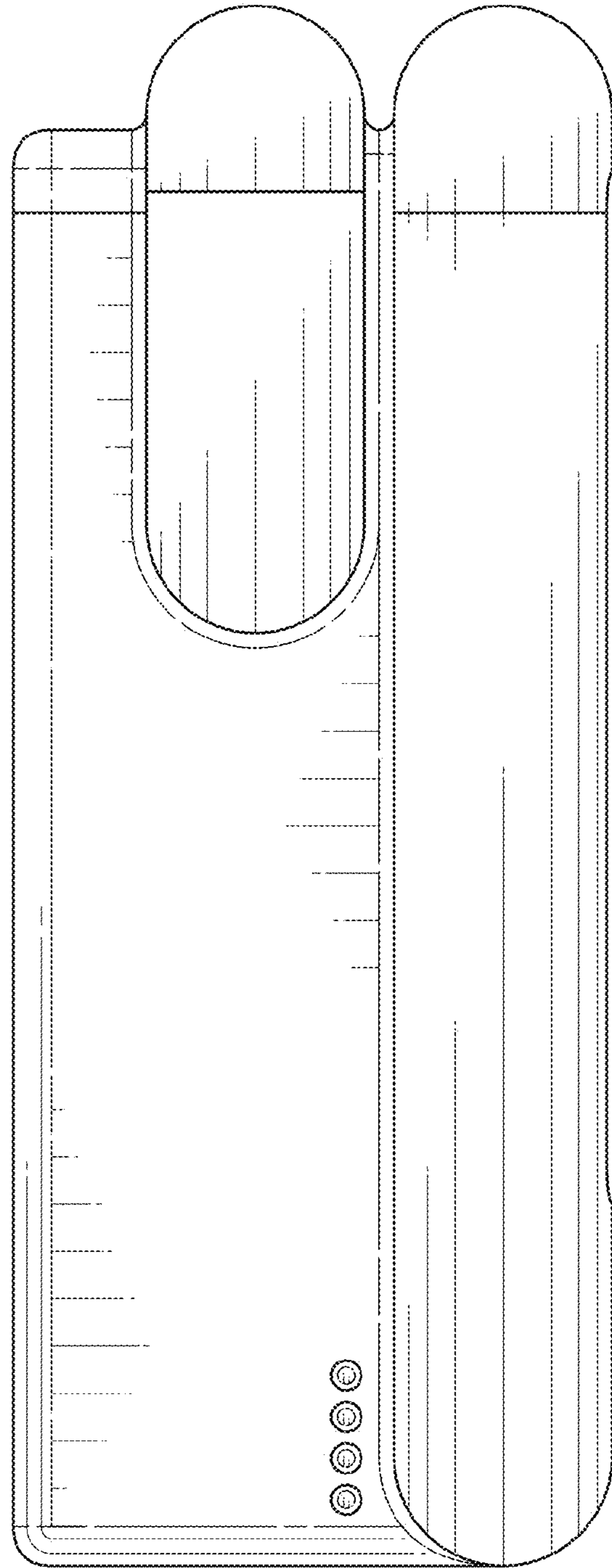

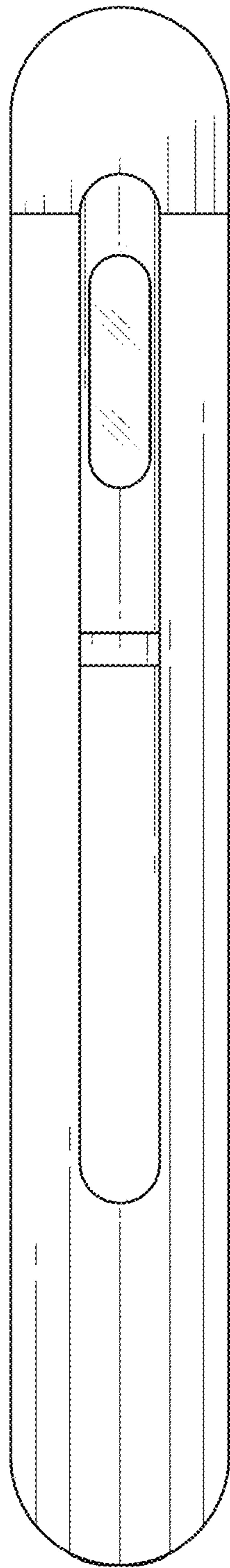

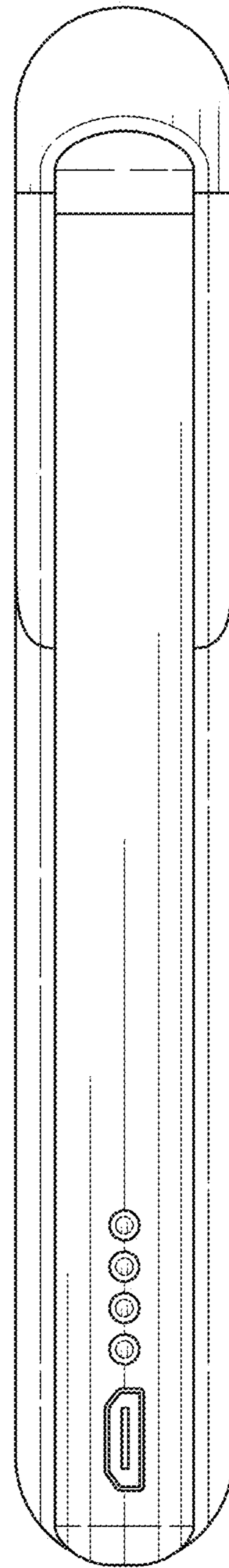

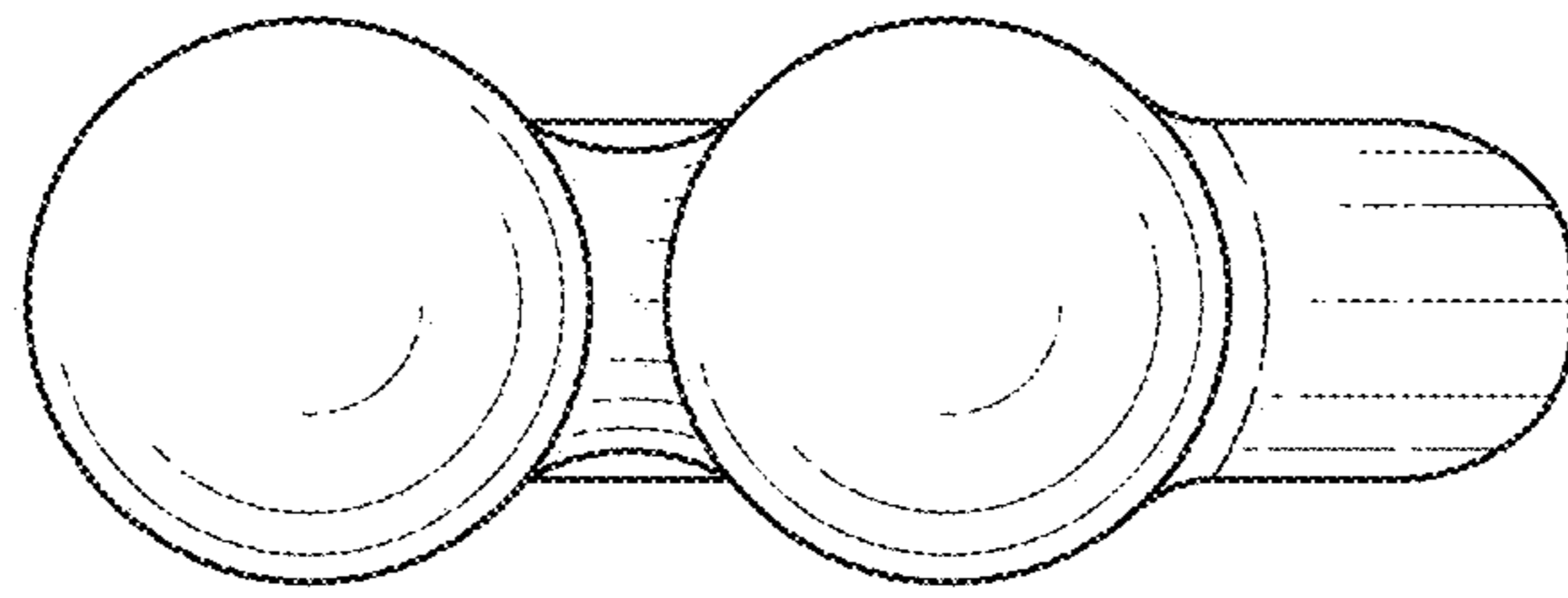

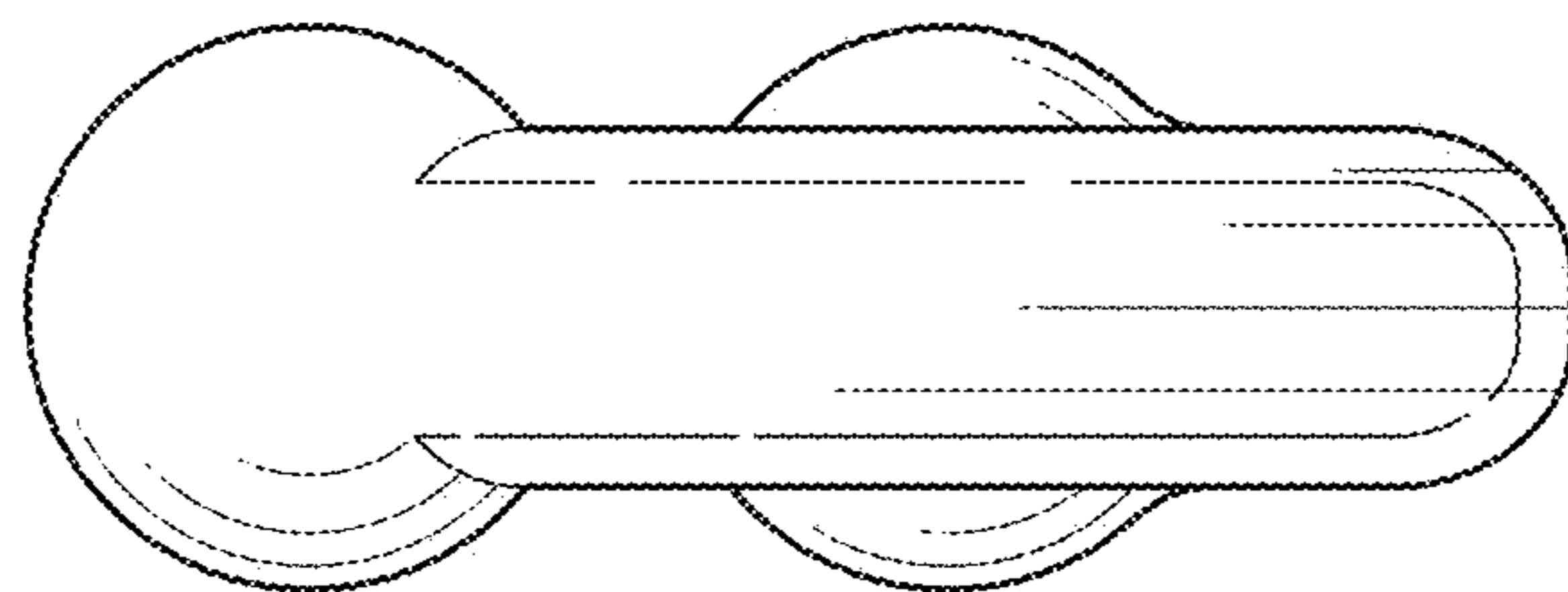

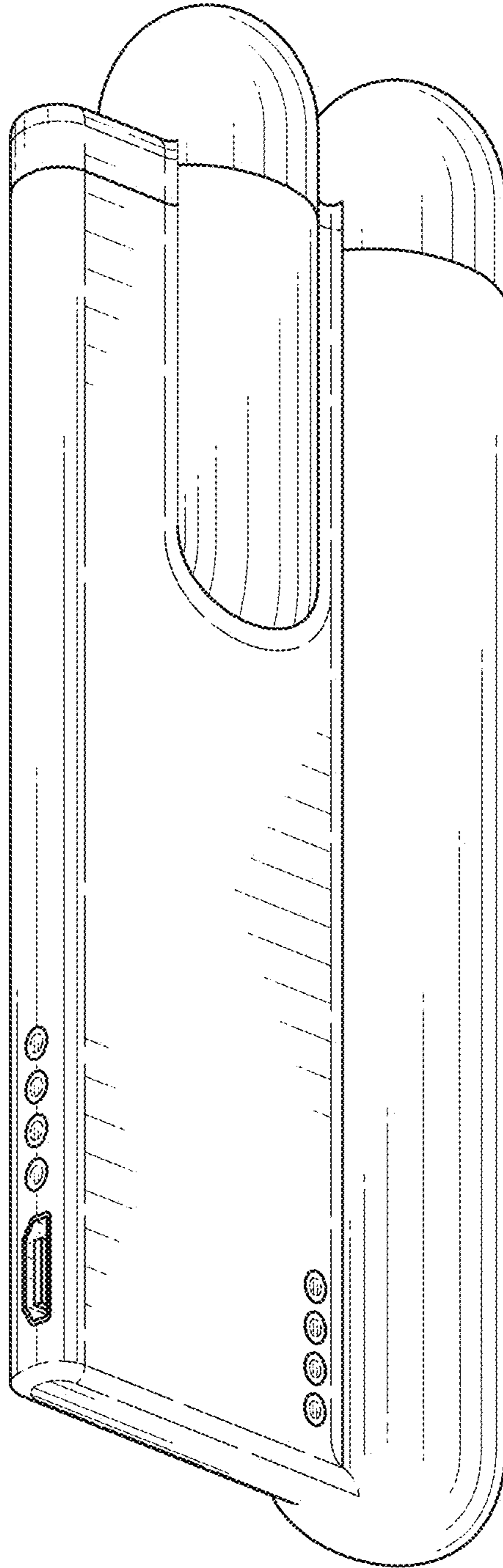

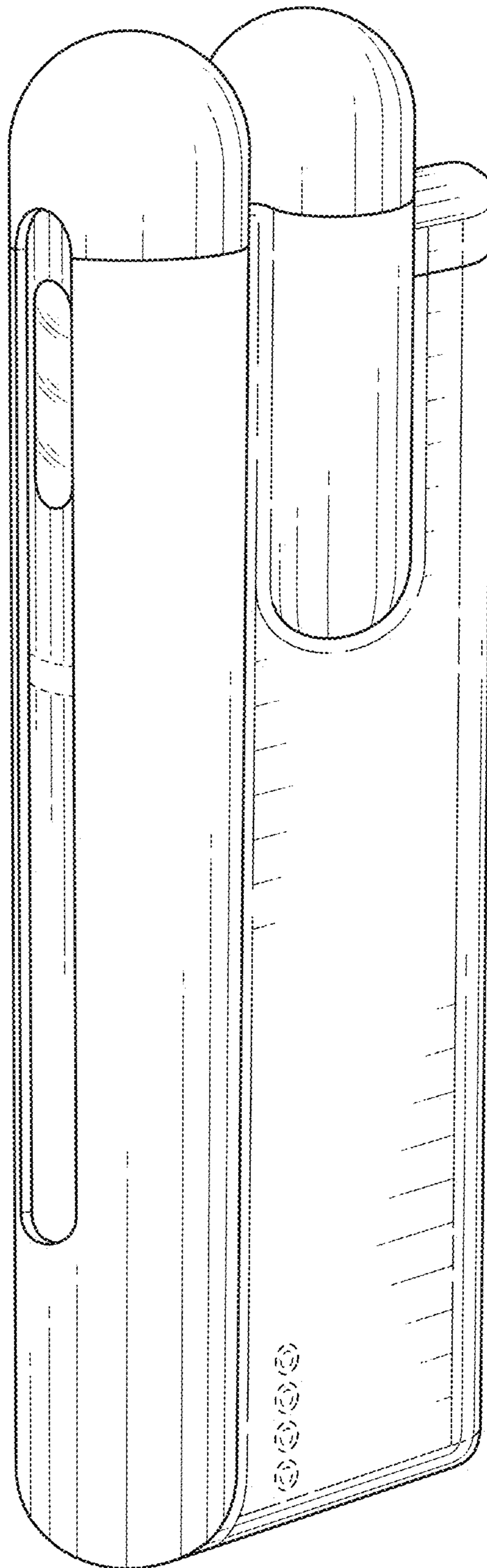

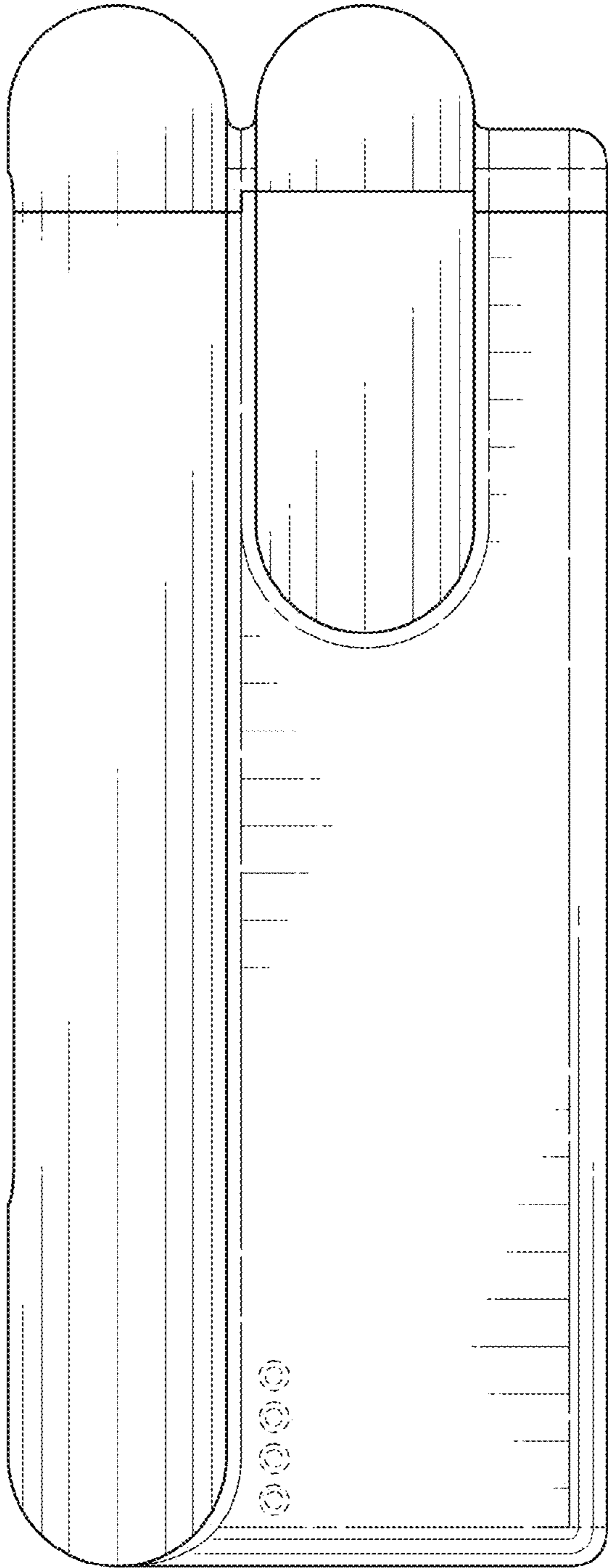

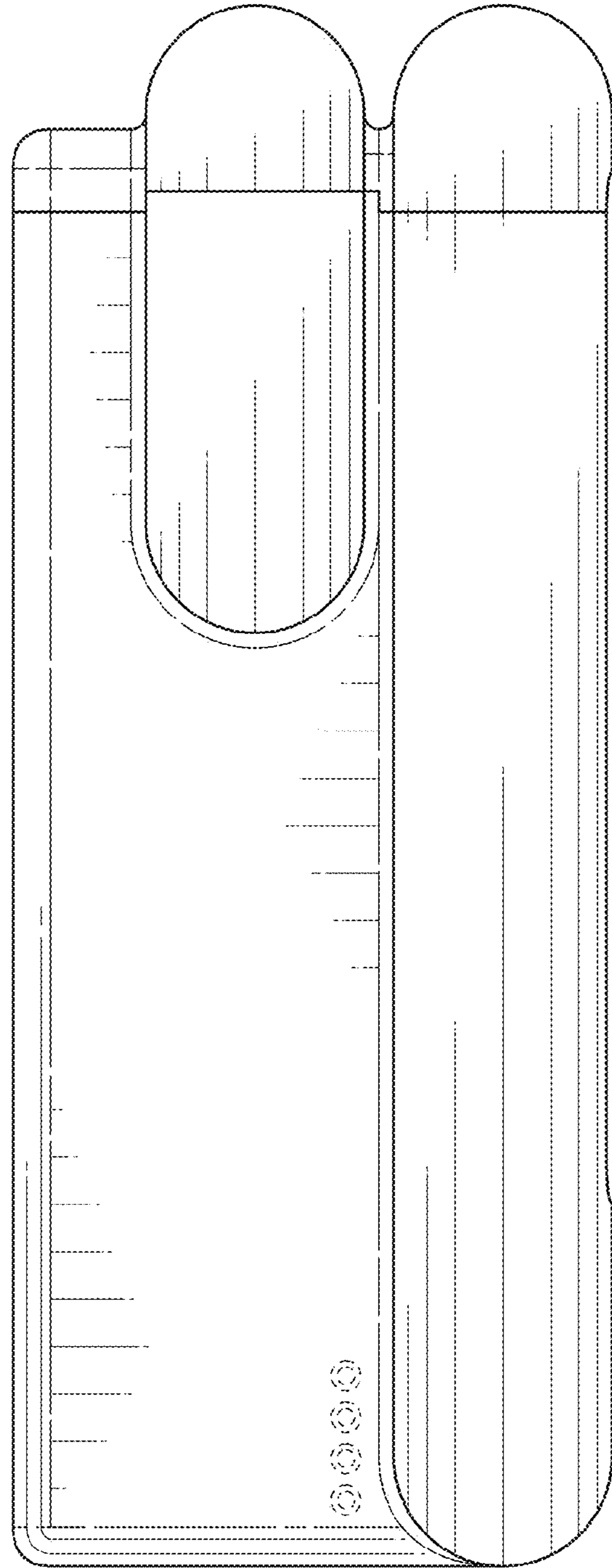

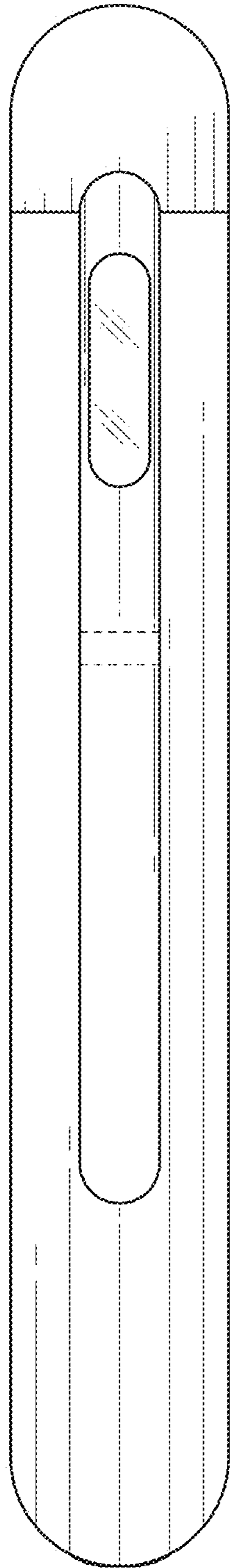

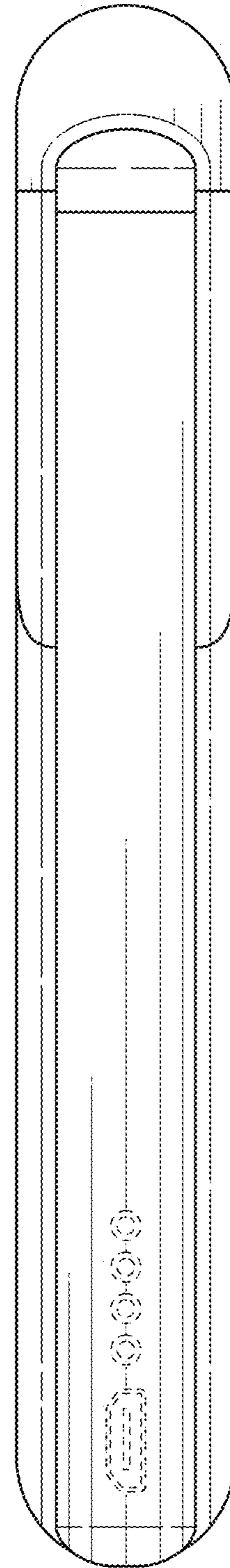

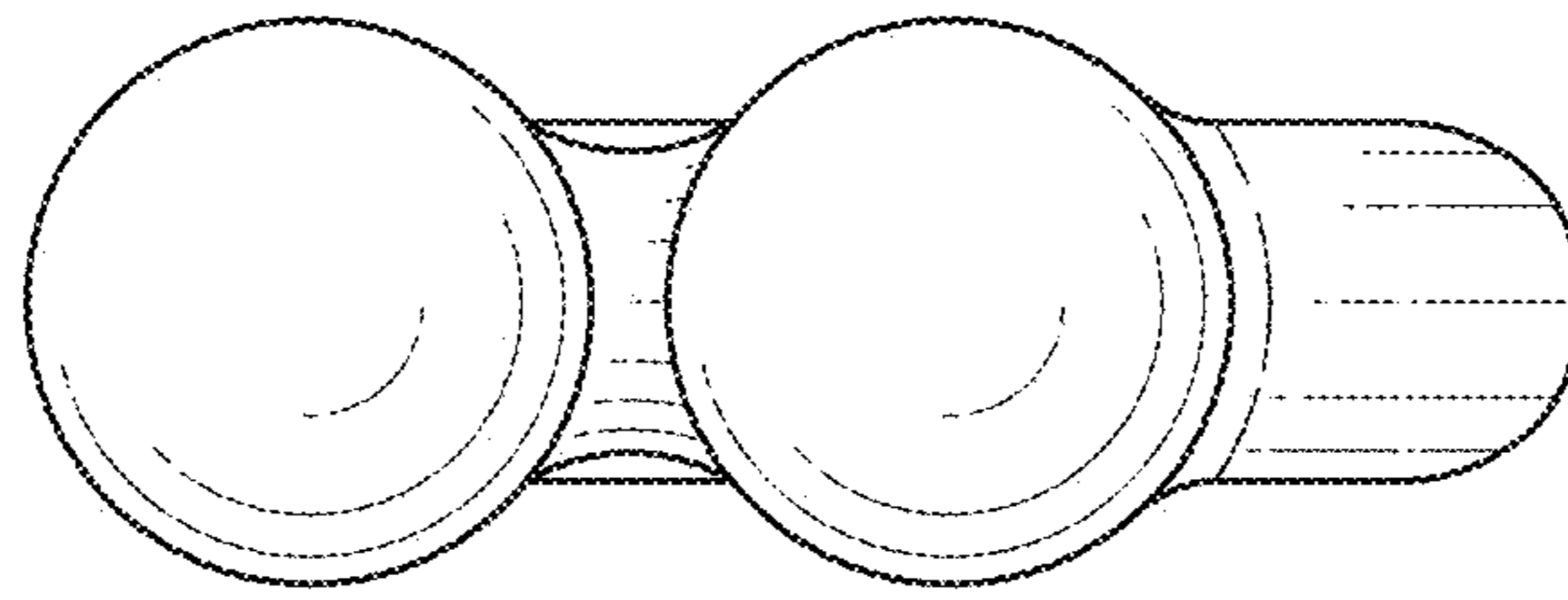

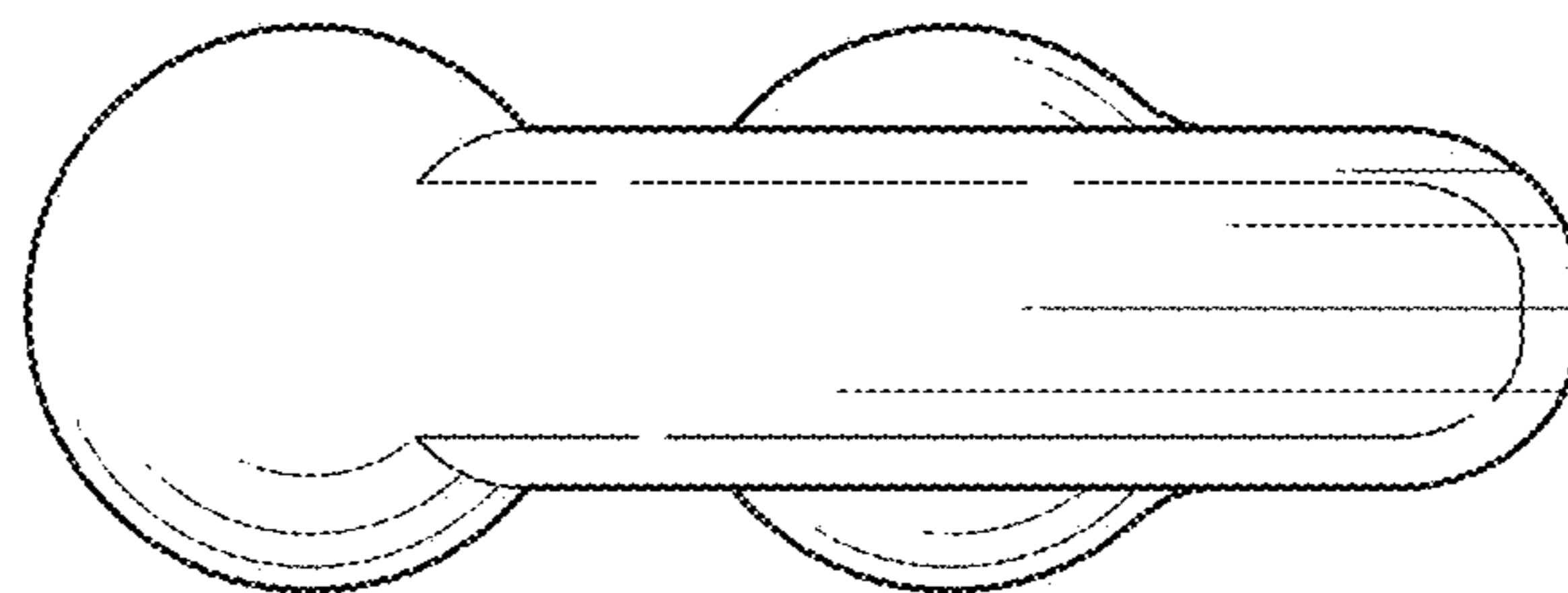

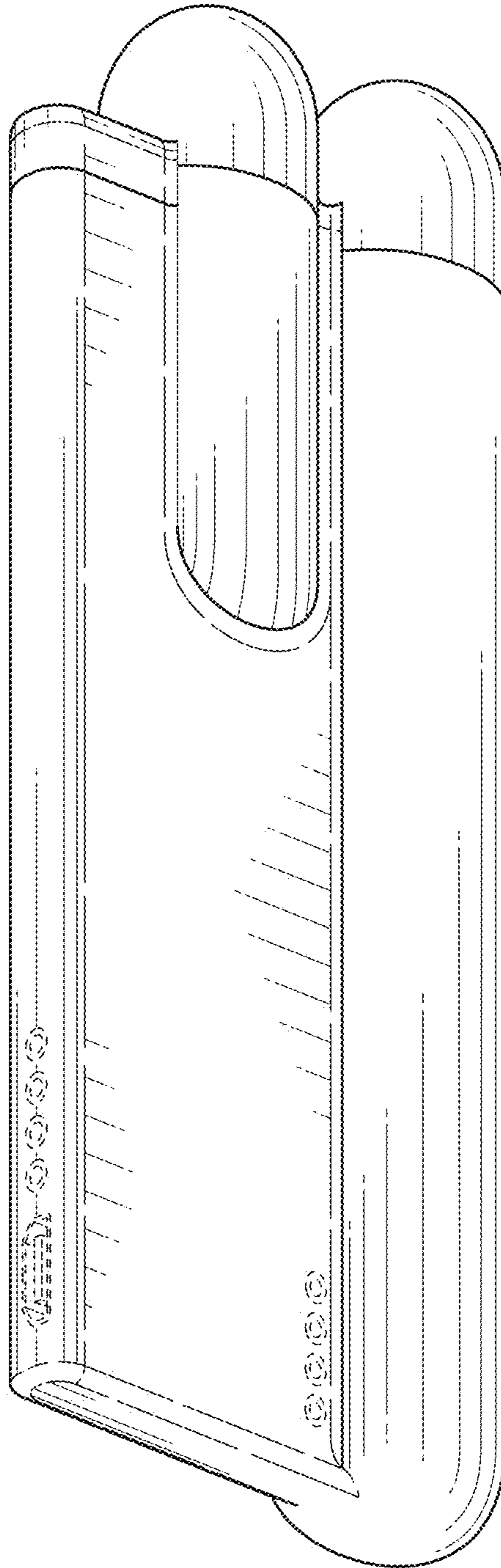
