(57) **CLAIM**

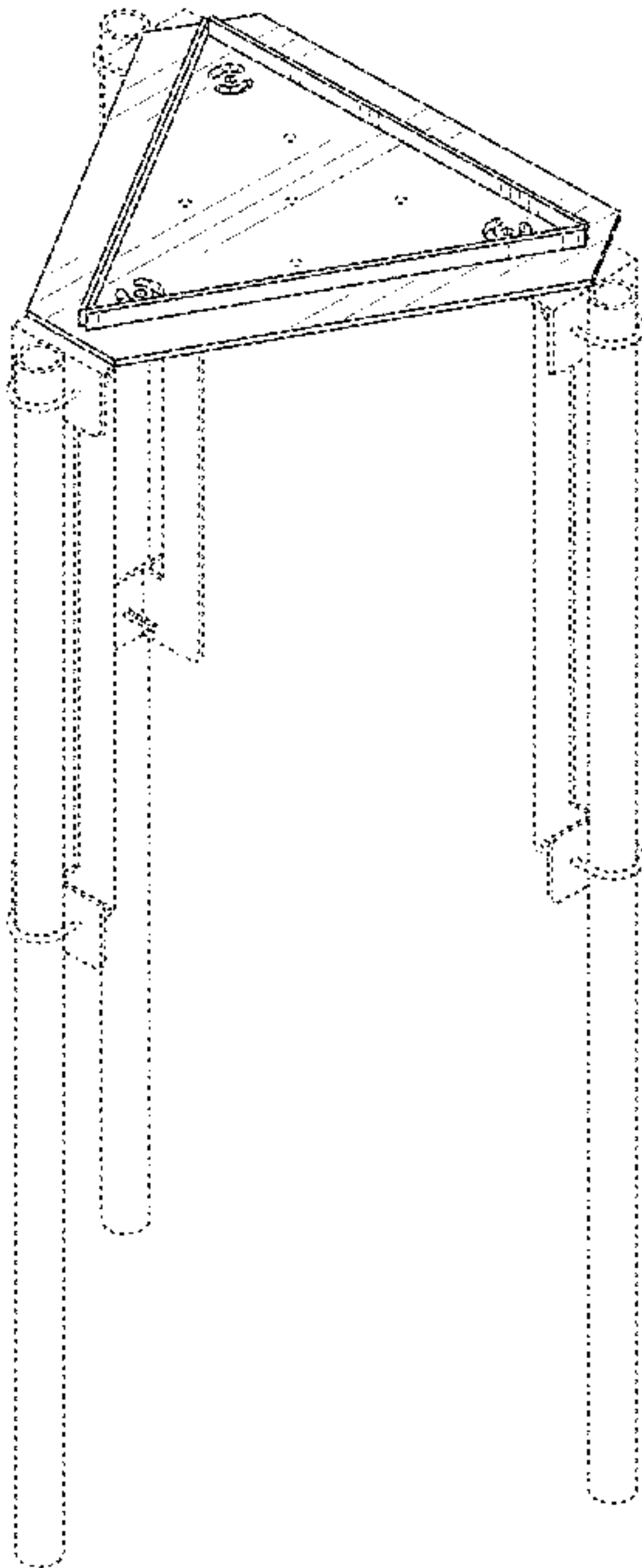
The ornamental design for an antenna mount, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of an antenna mount; FIG. 2 is a back, bottom perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a left-side view thereof; FIG. 6 is a right-side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; and, FIG. 9 is a front, top perspective view showing unclaimed environment of the antenna mount according to the claimed design.

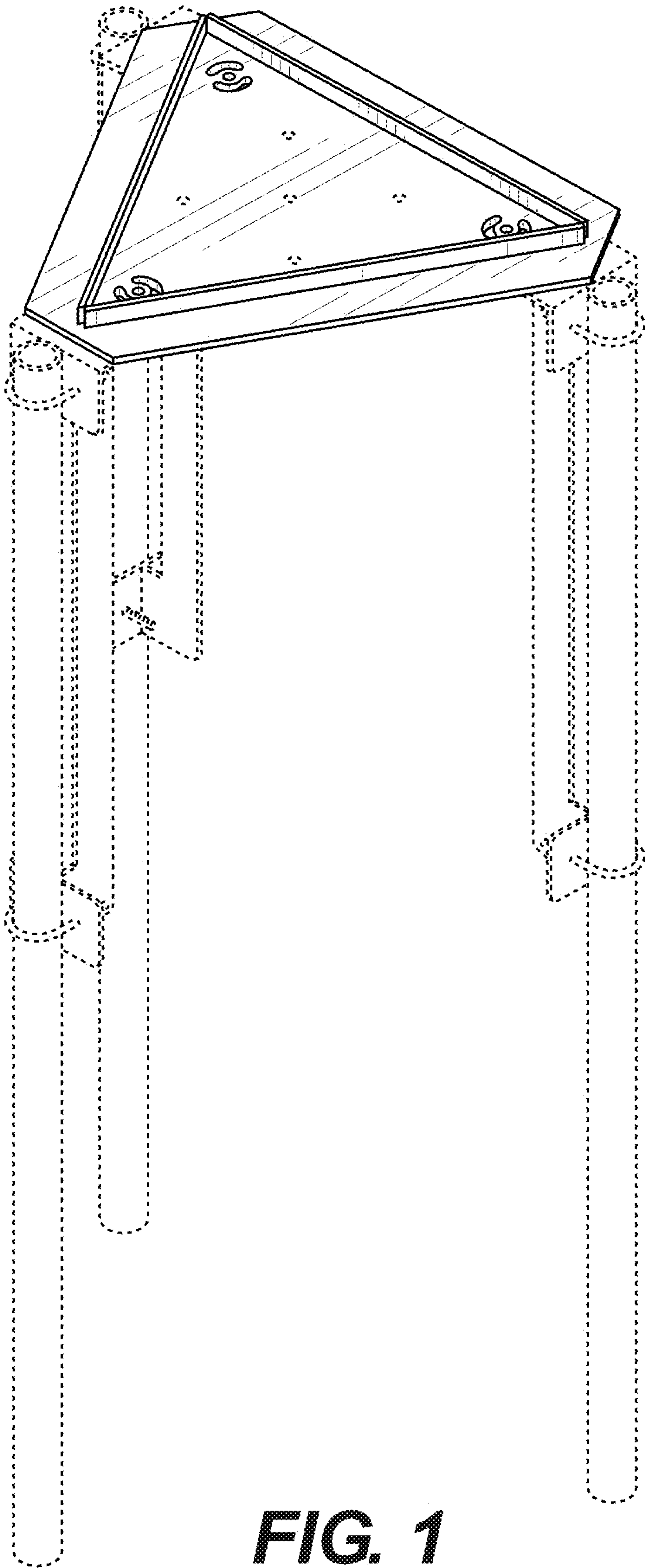

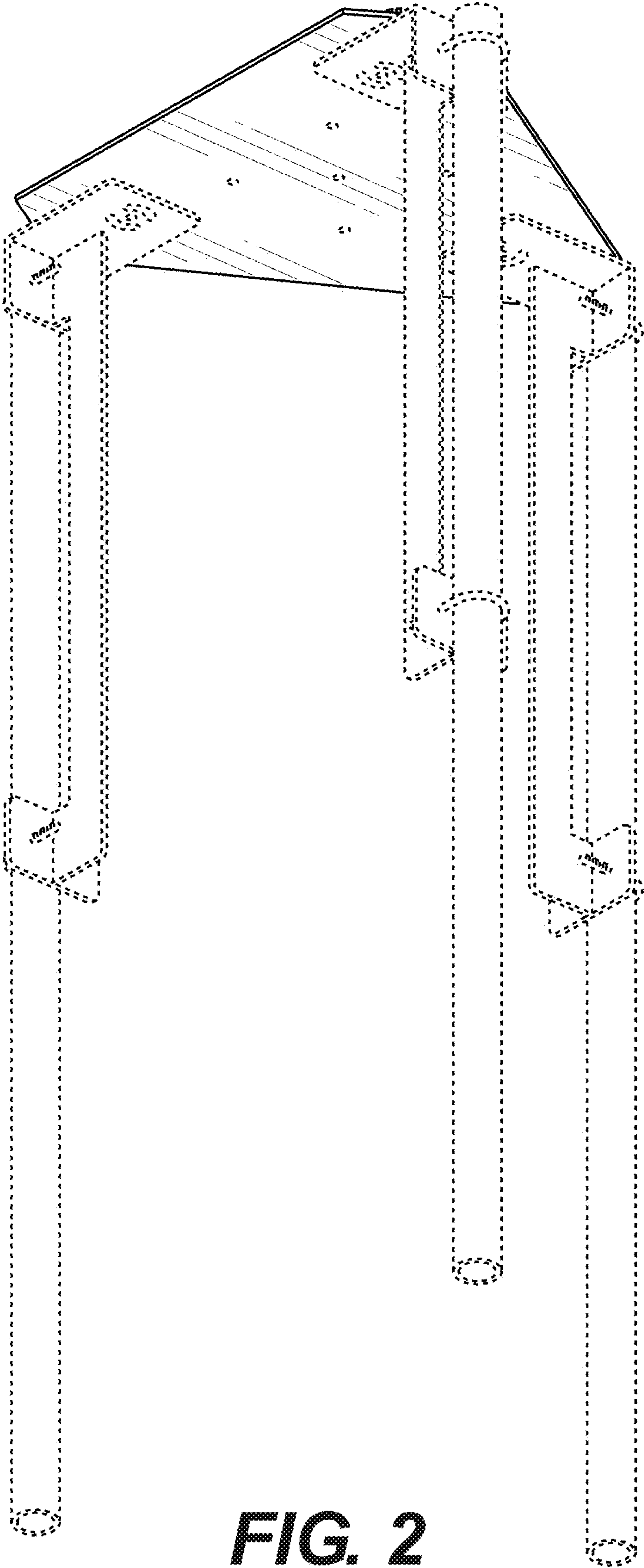

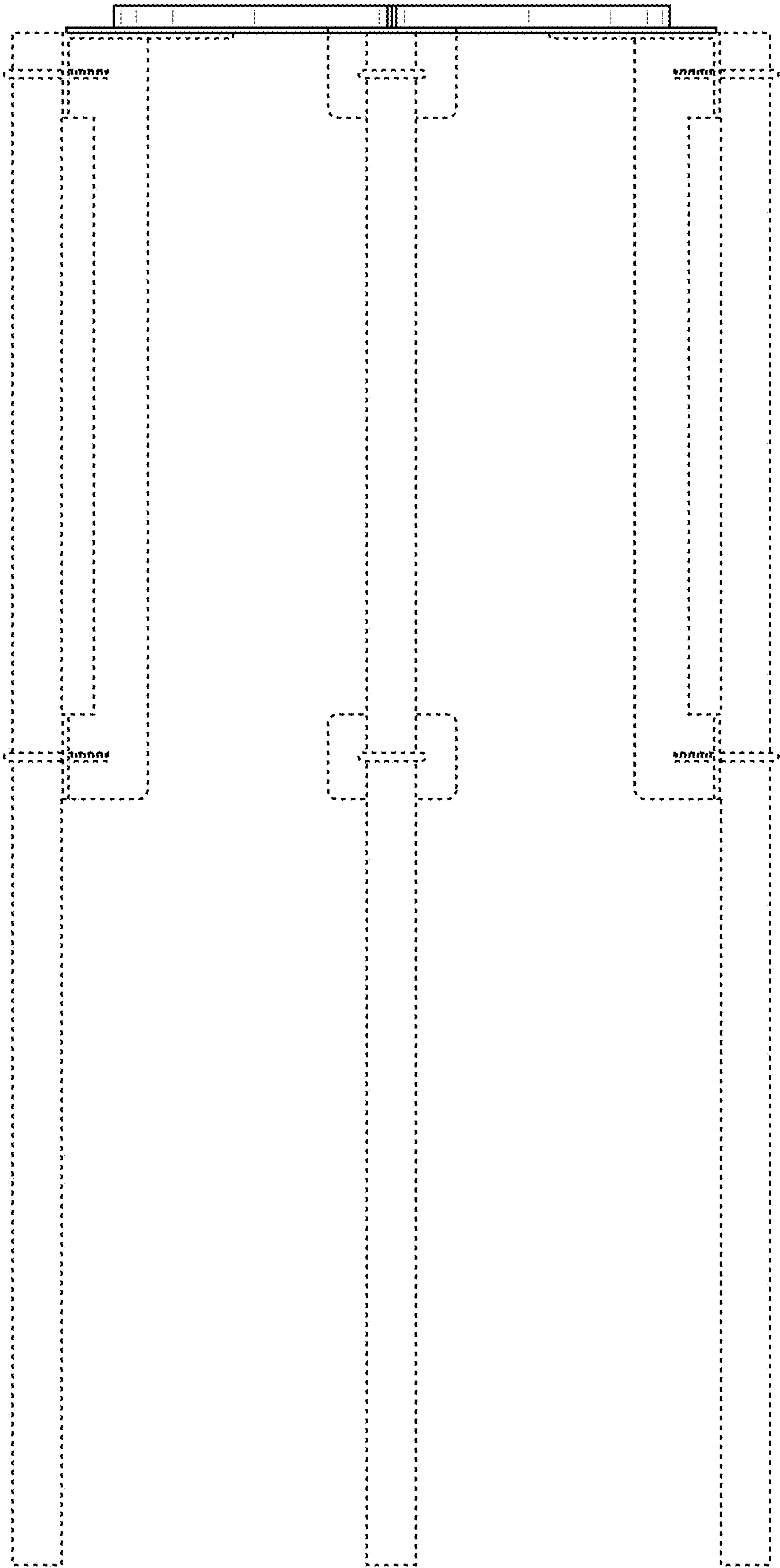

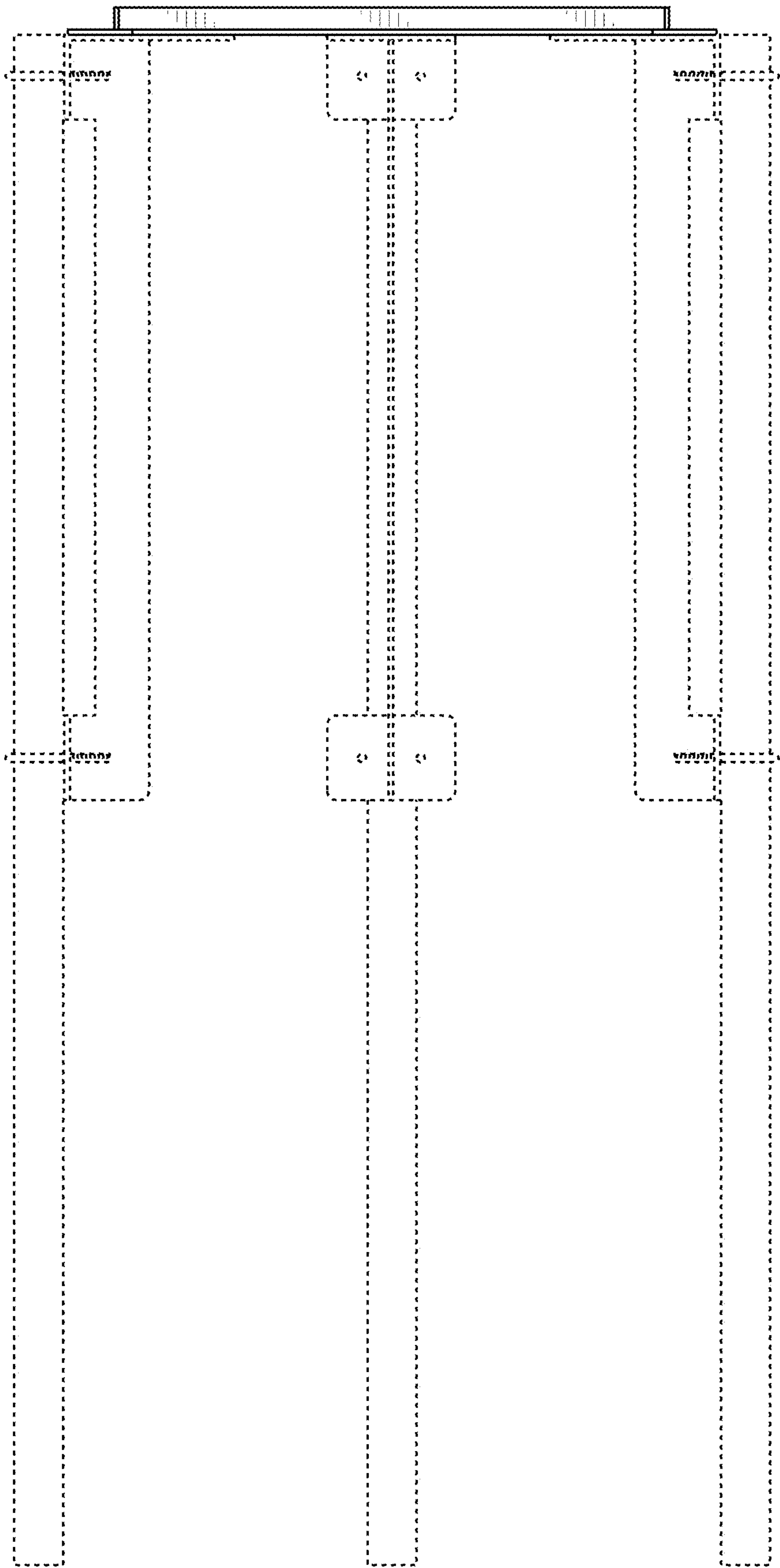

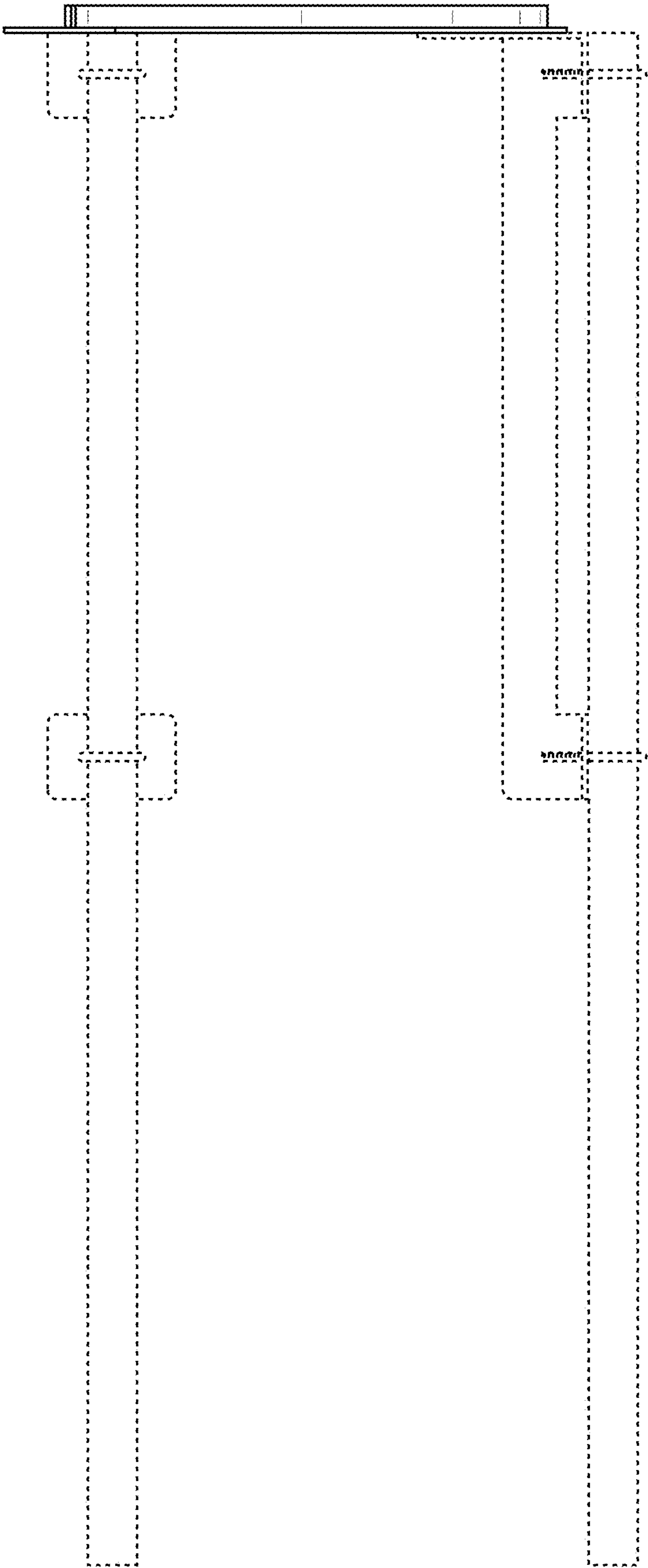

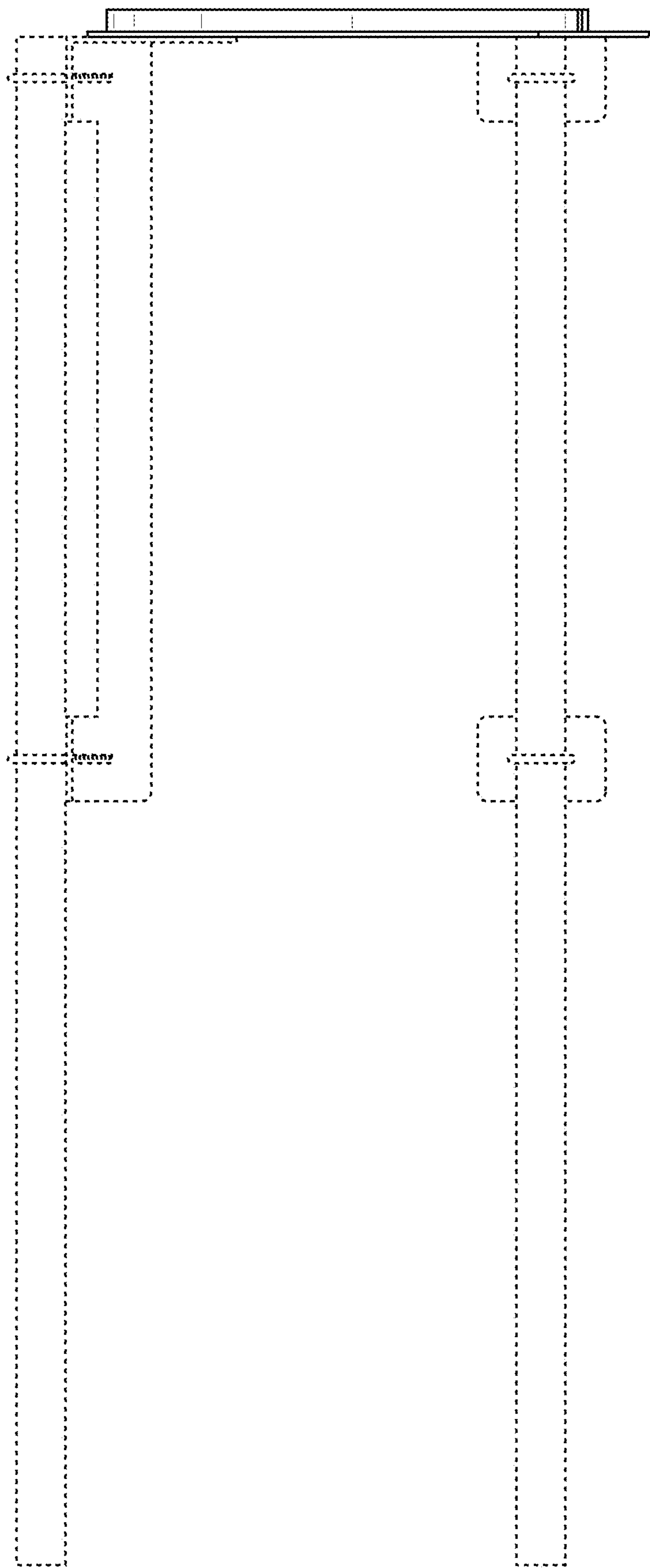

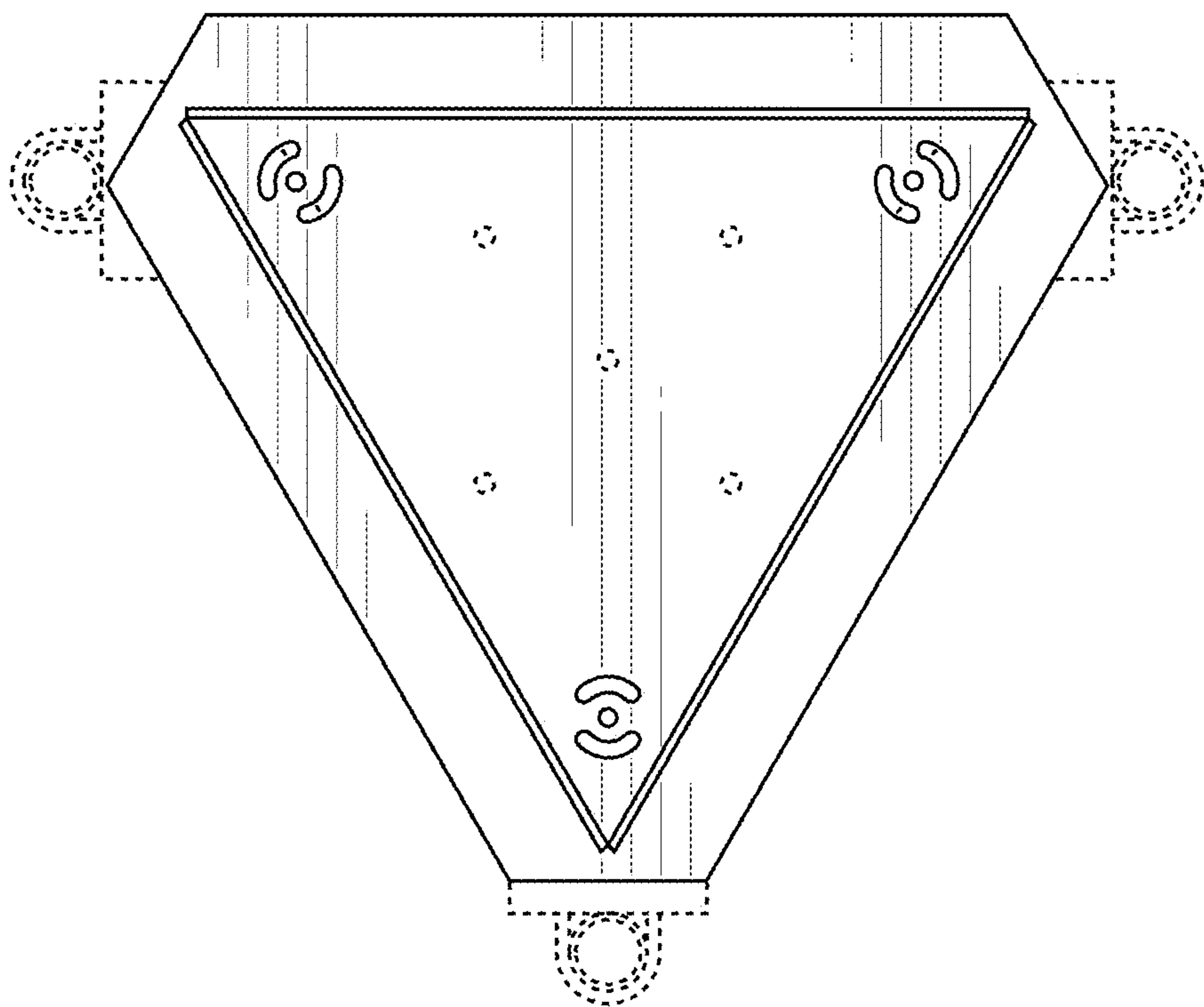

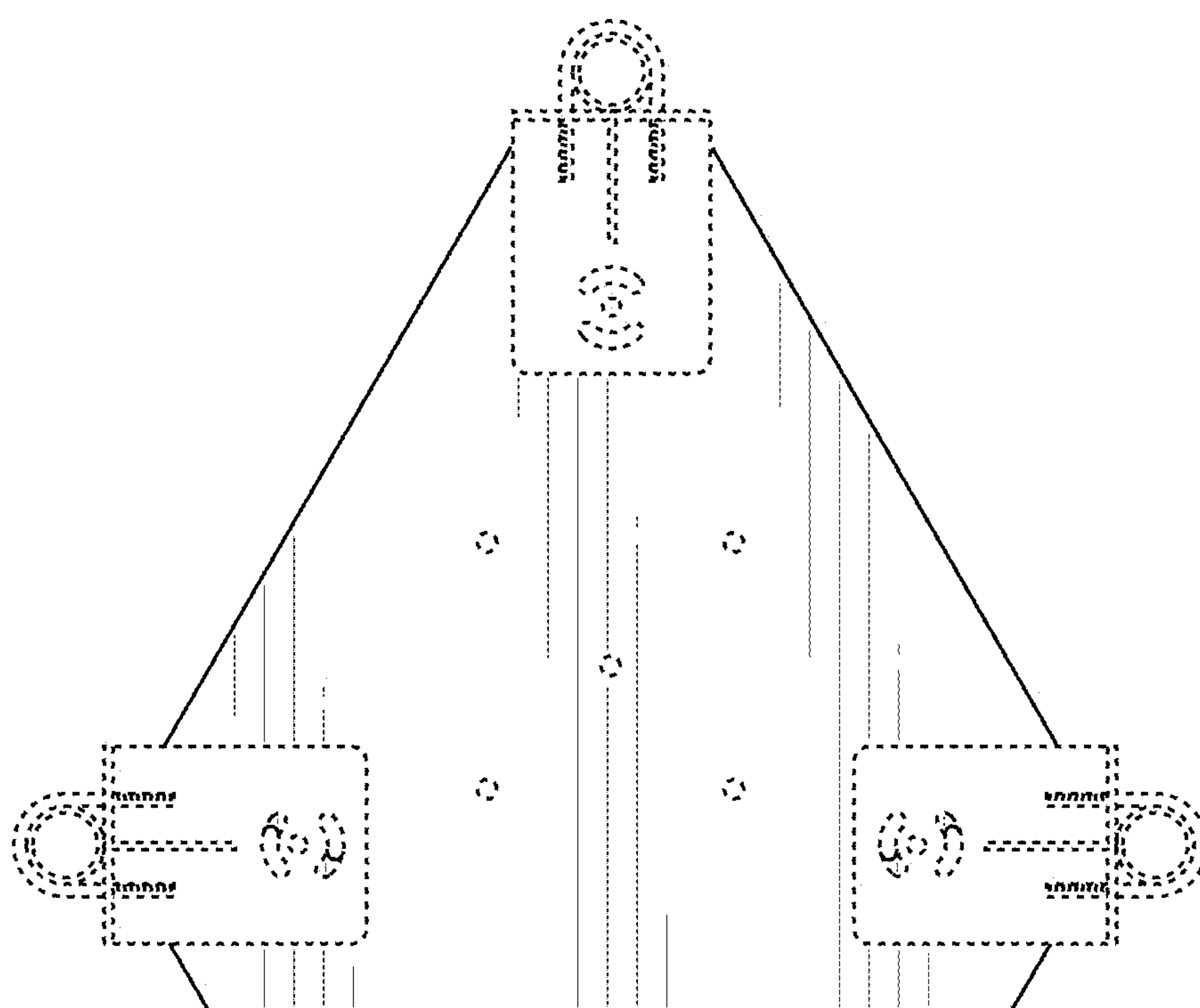

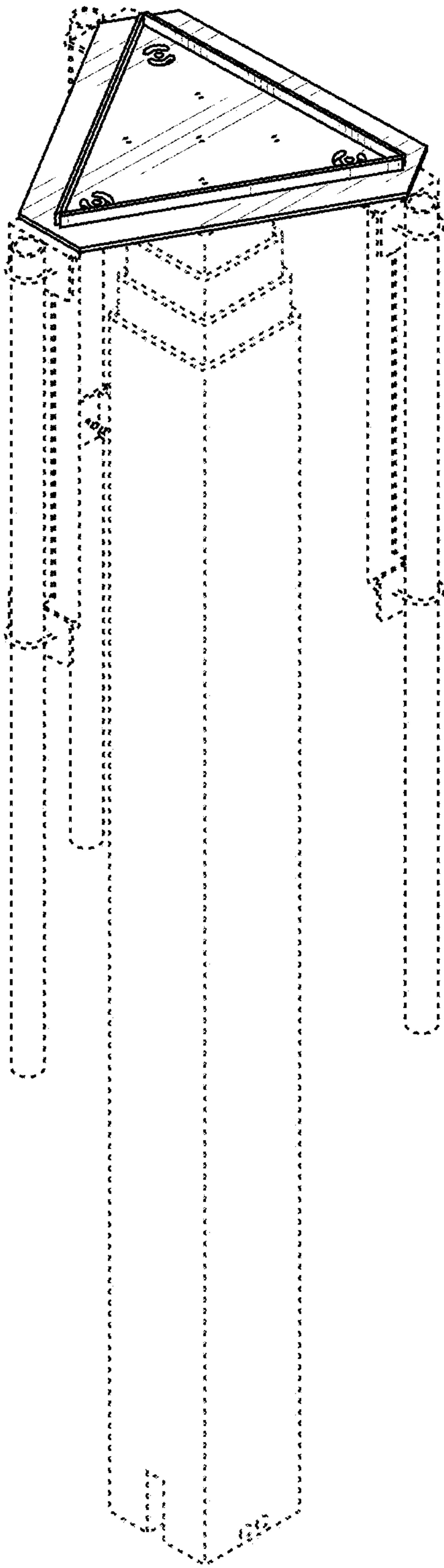
