The ornamental design for a mobile phone case, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mobile phone case showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left-side elevational view thereof;
FIG. 4 is a right-side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a front, right-side, and top perspective view thereof;
FIG. 8 is a rear, left-side, and bottom perspective view thereof; and,
FIG. 9 is a rear, right-side, and top perspective view thereof showing the support stand in an extended position.

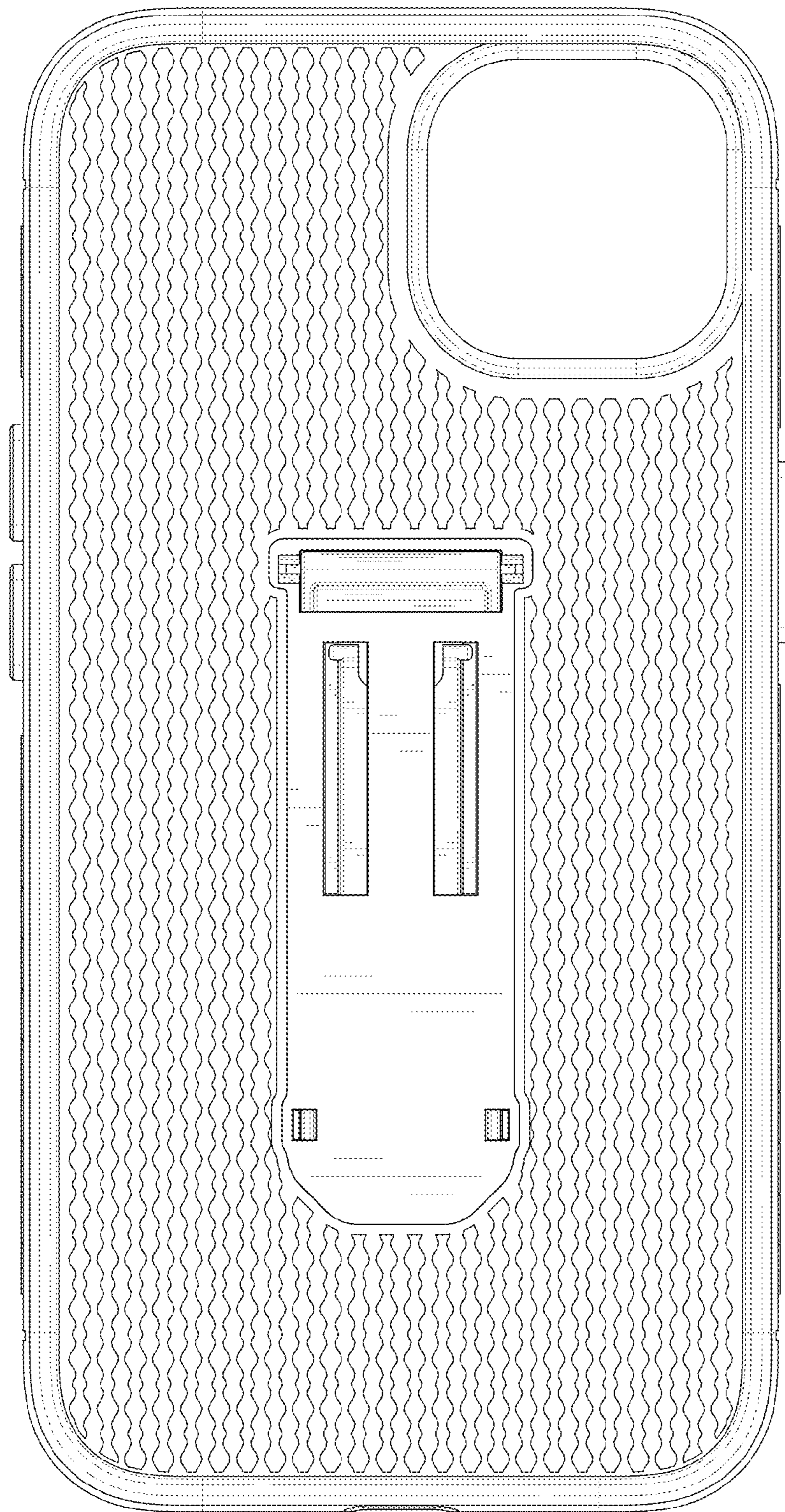

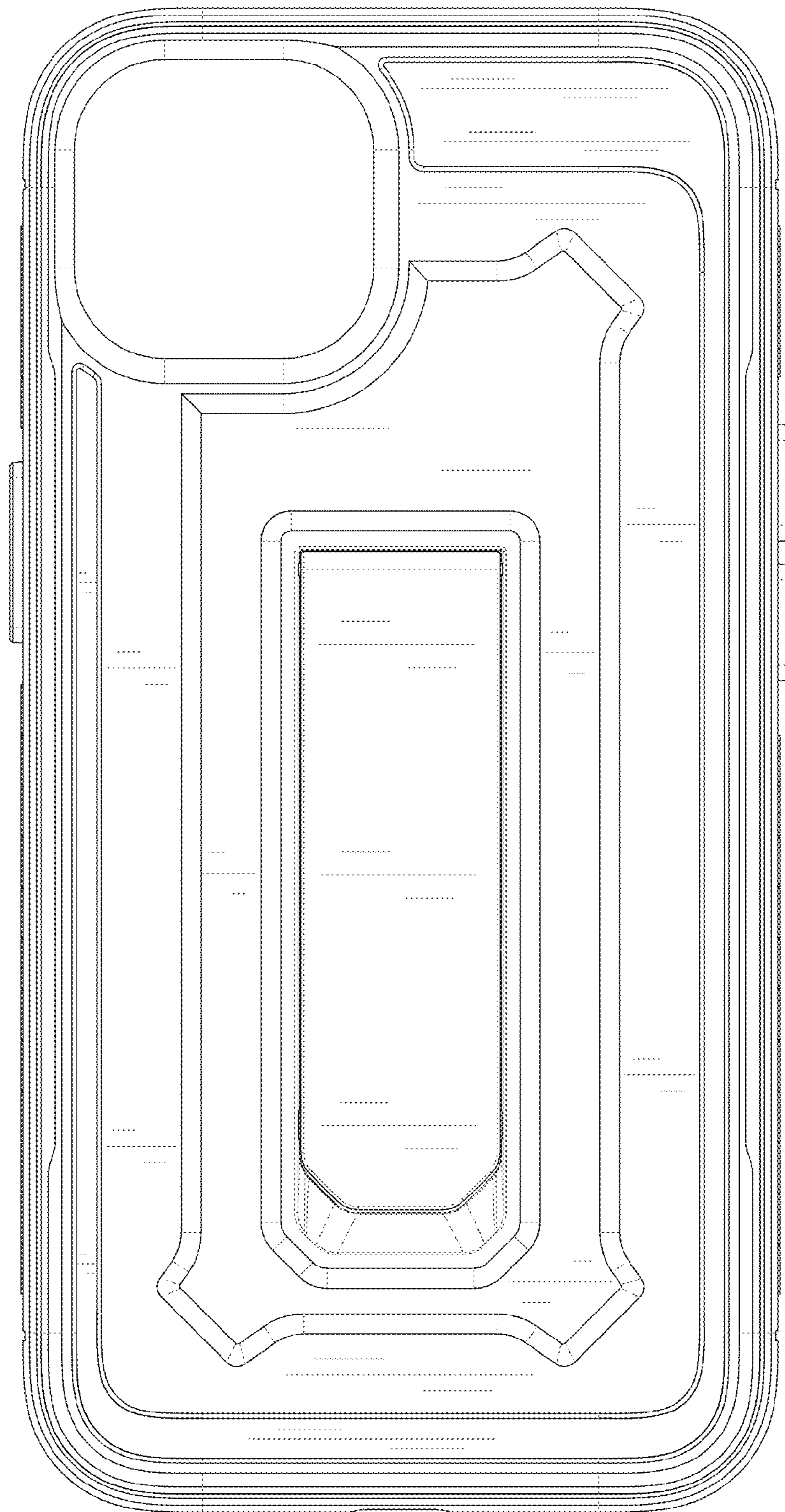

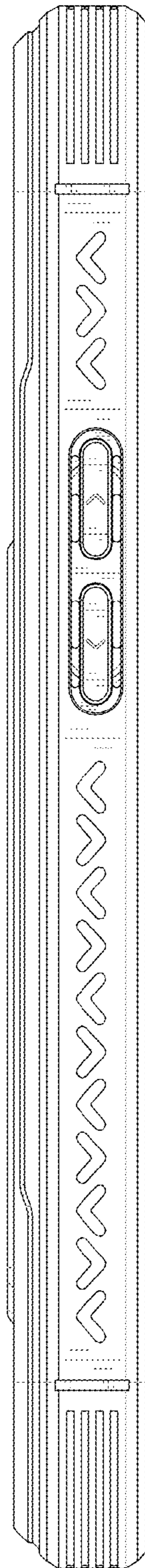

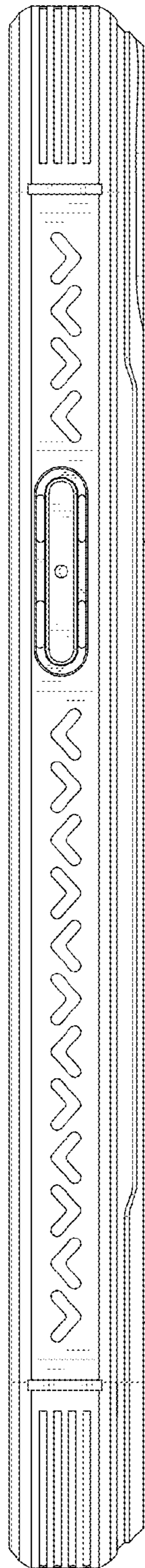

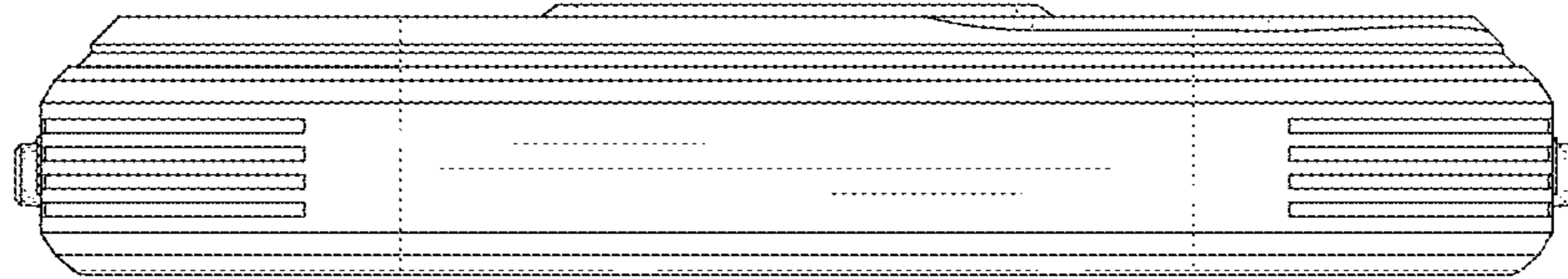

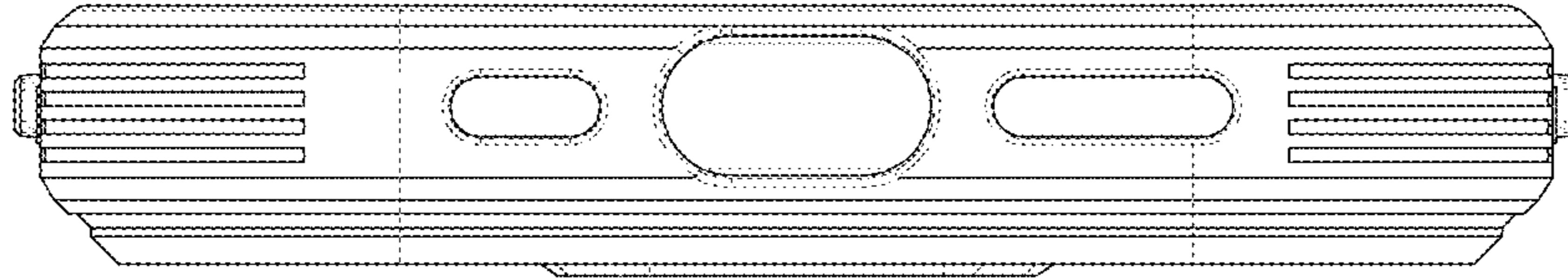

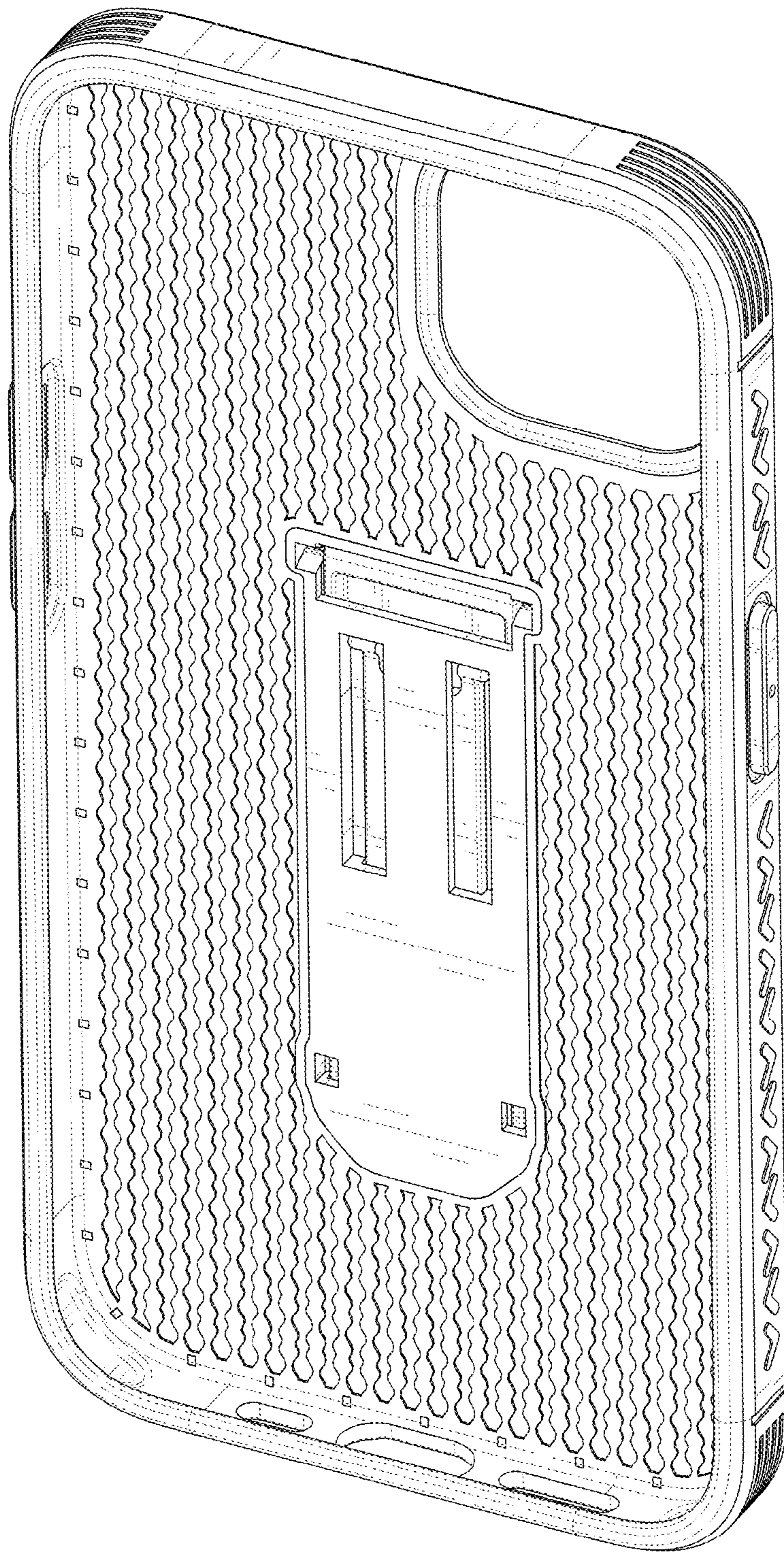

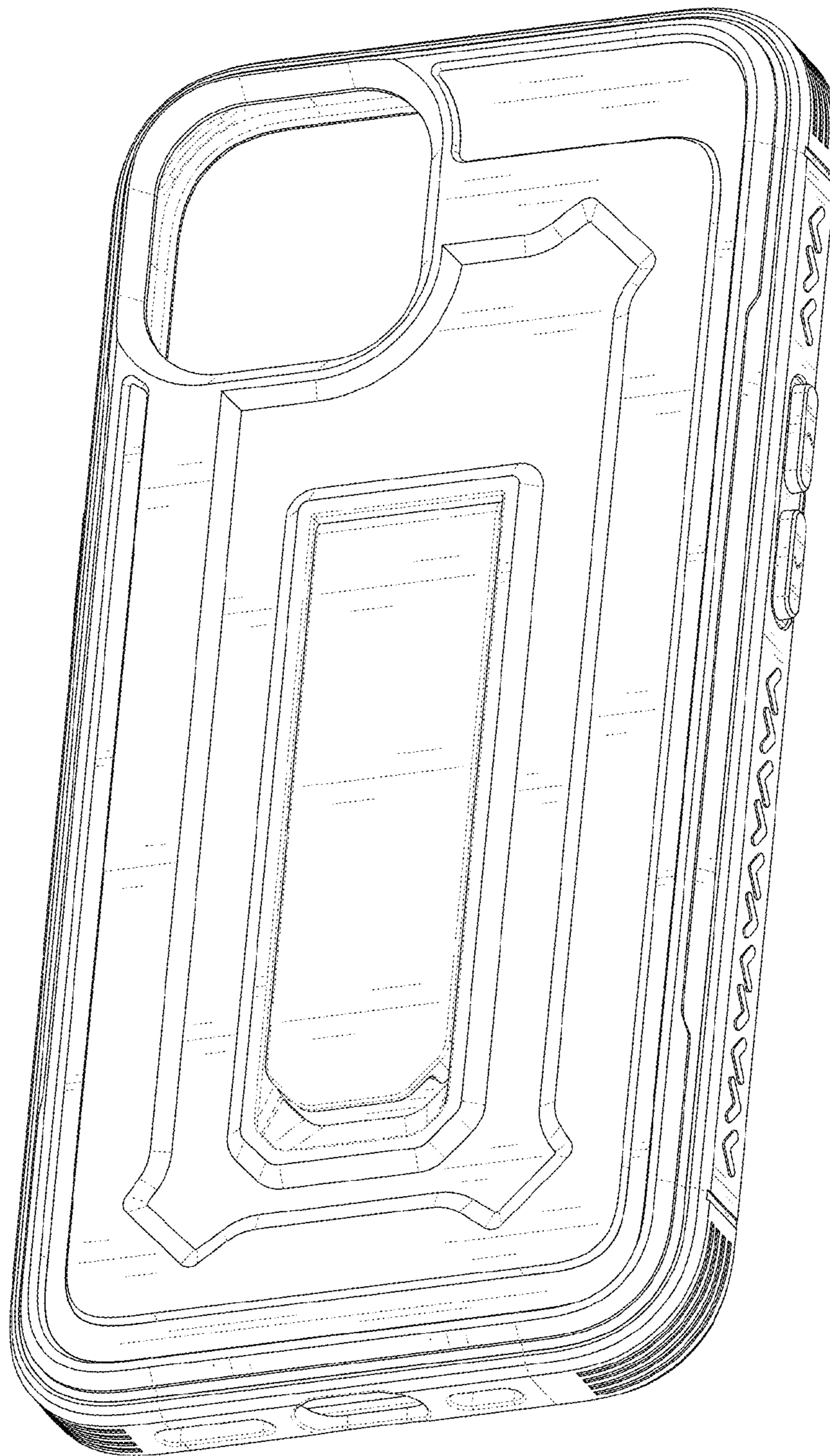

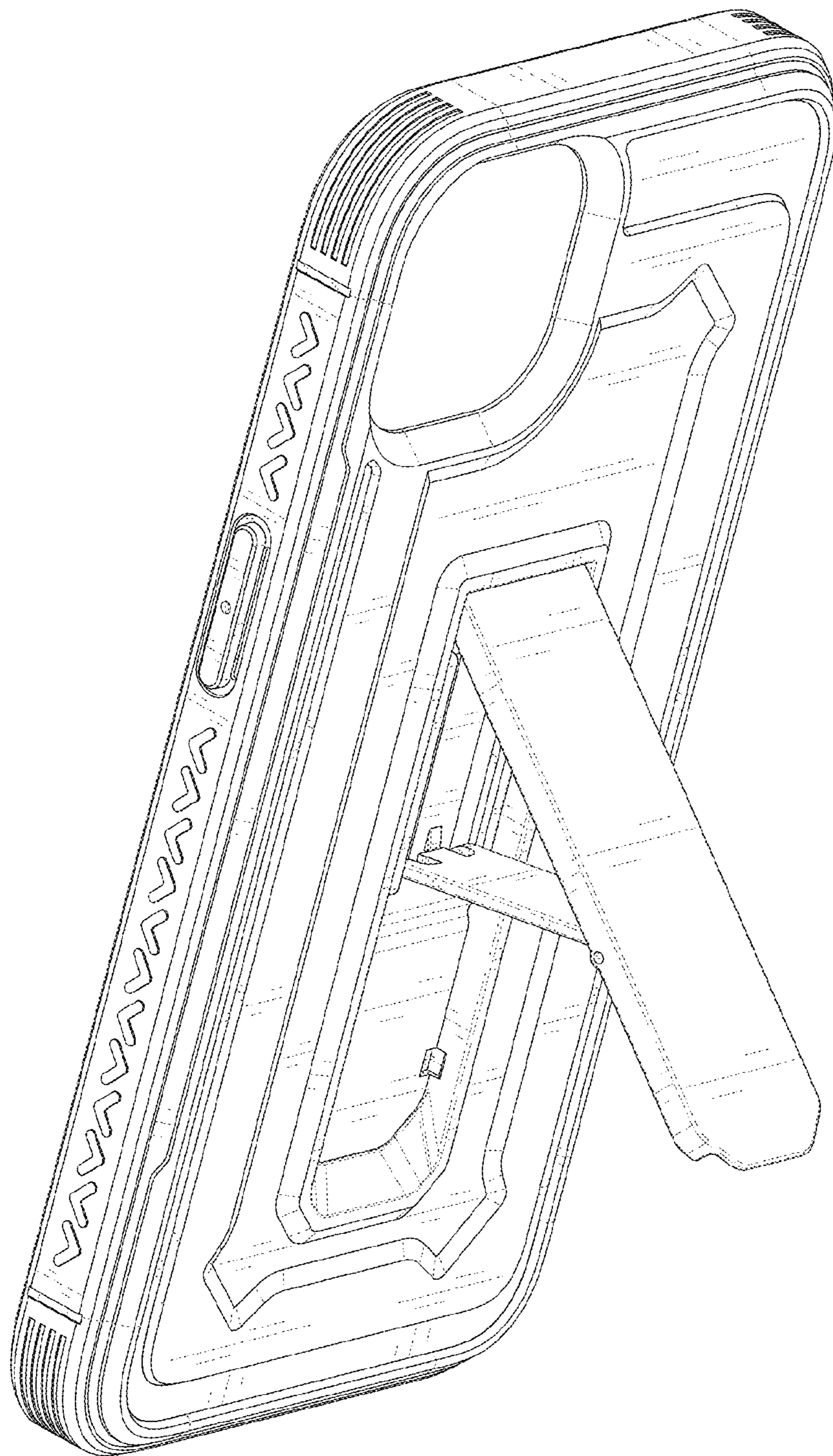
