(57) **CLAIM**

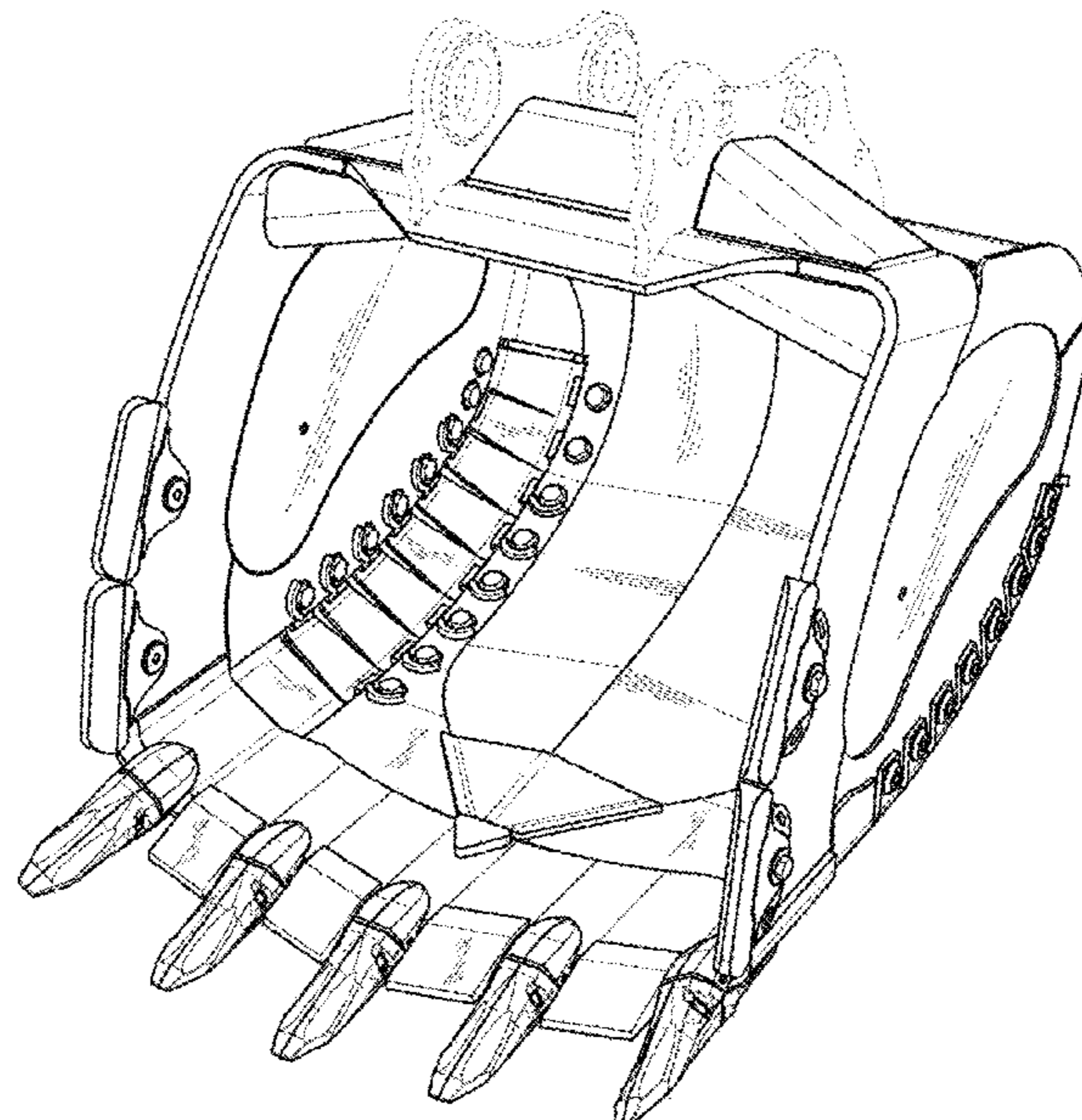
The ornamental design for an excavator bucket, as shown and described.

DESCRIPTION

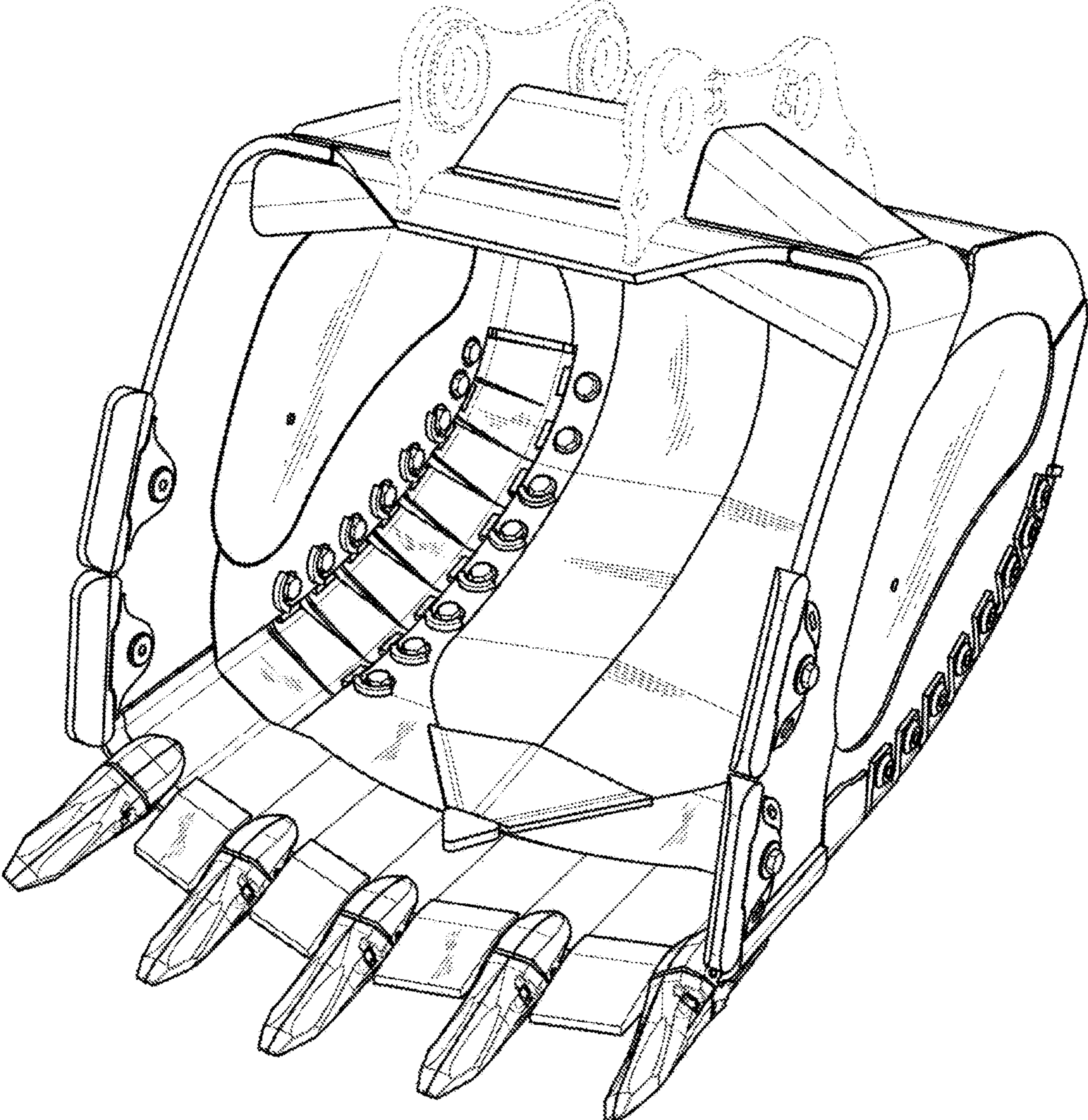

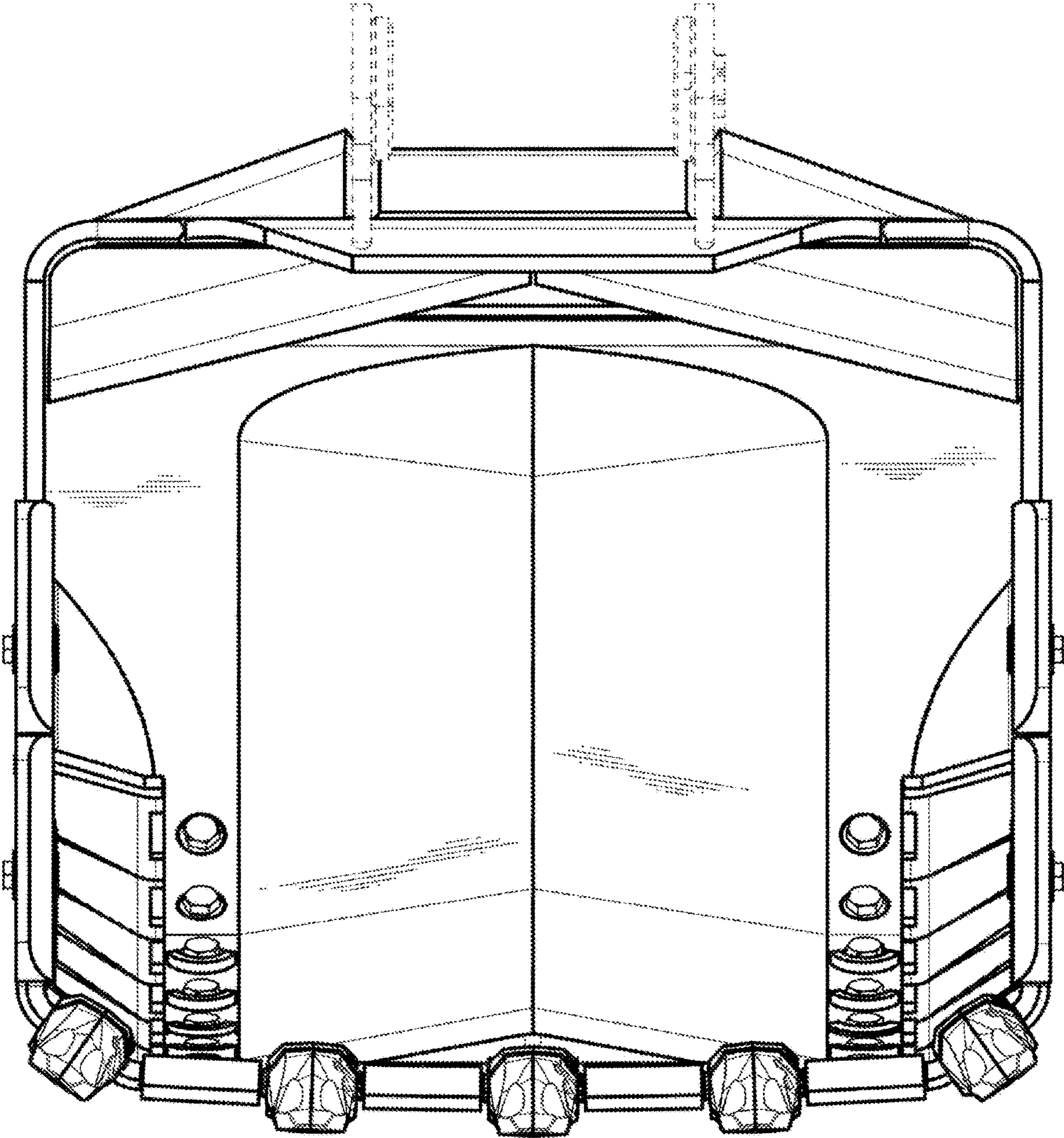

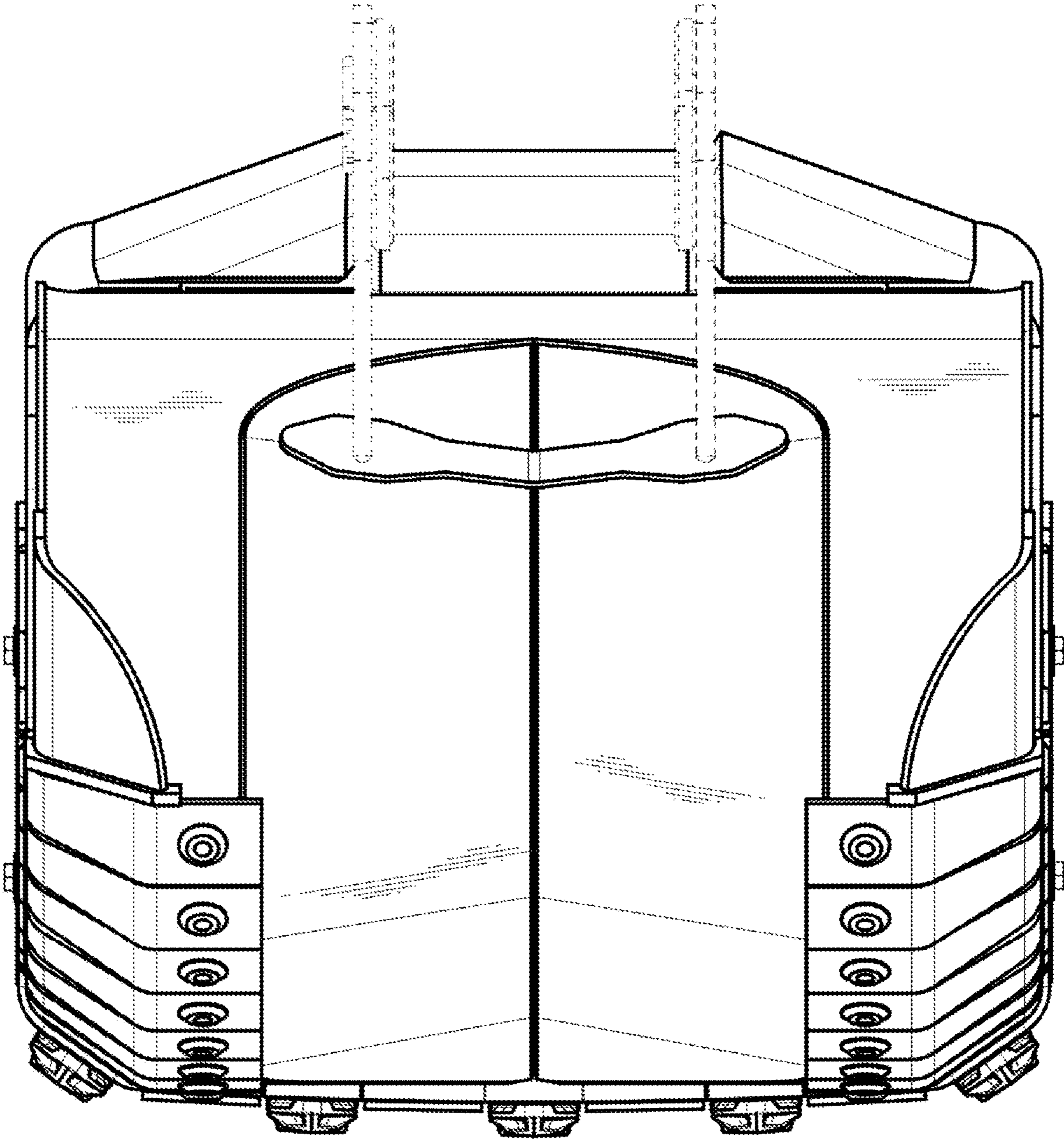

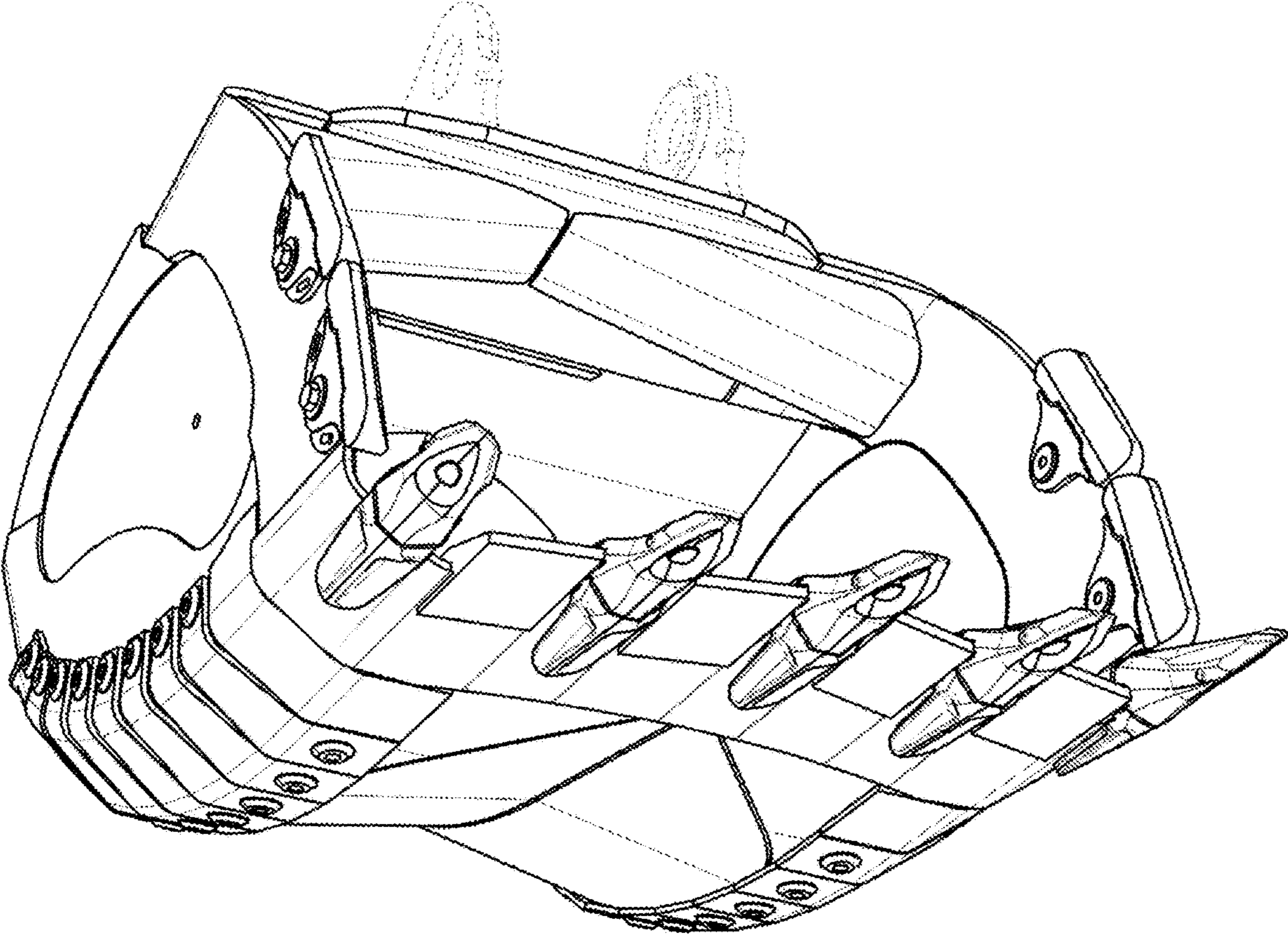

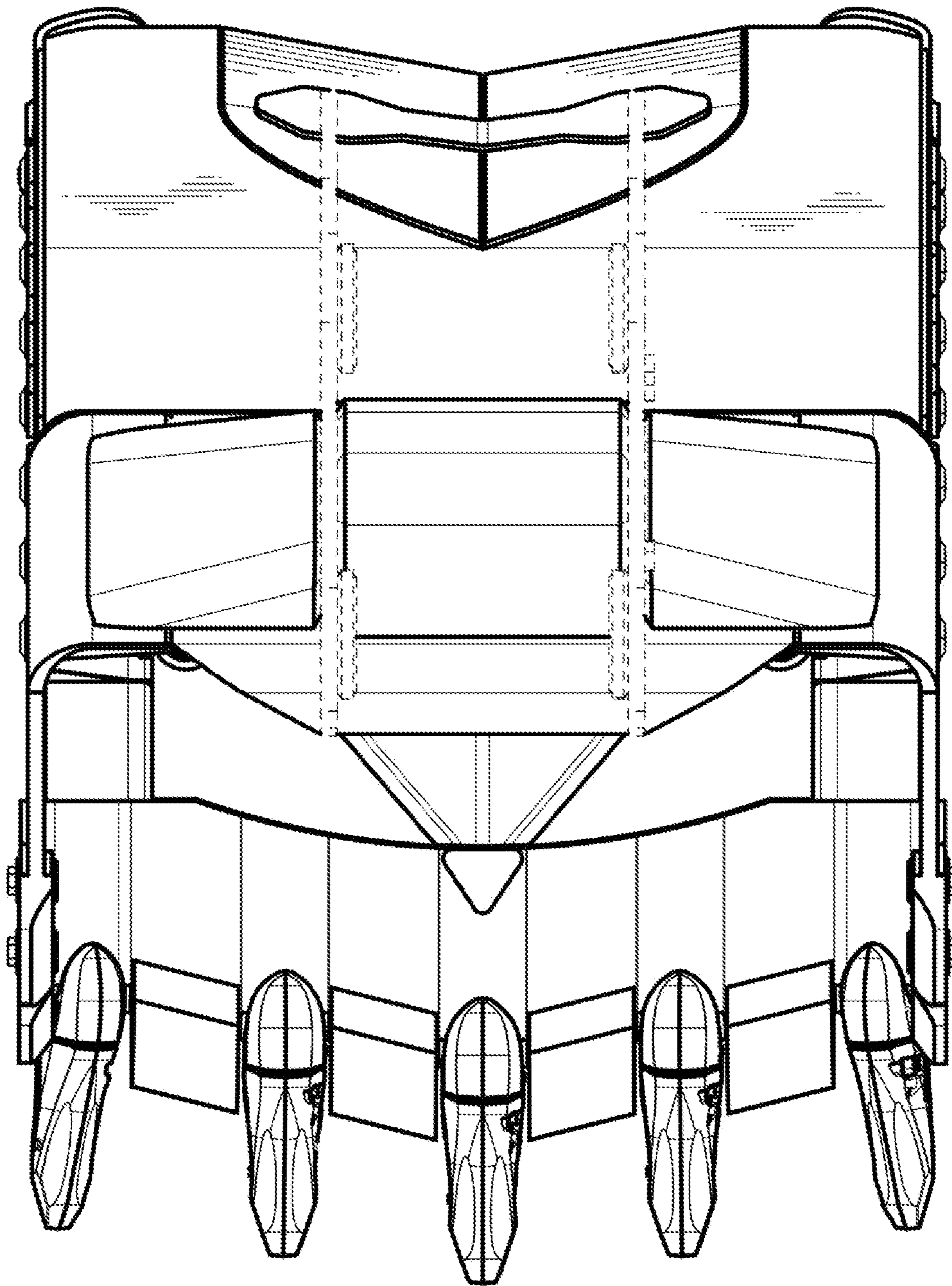

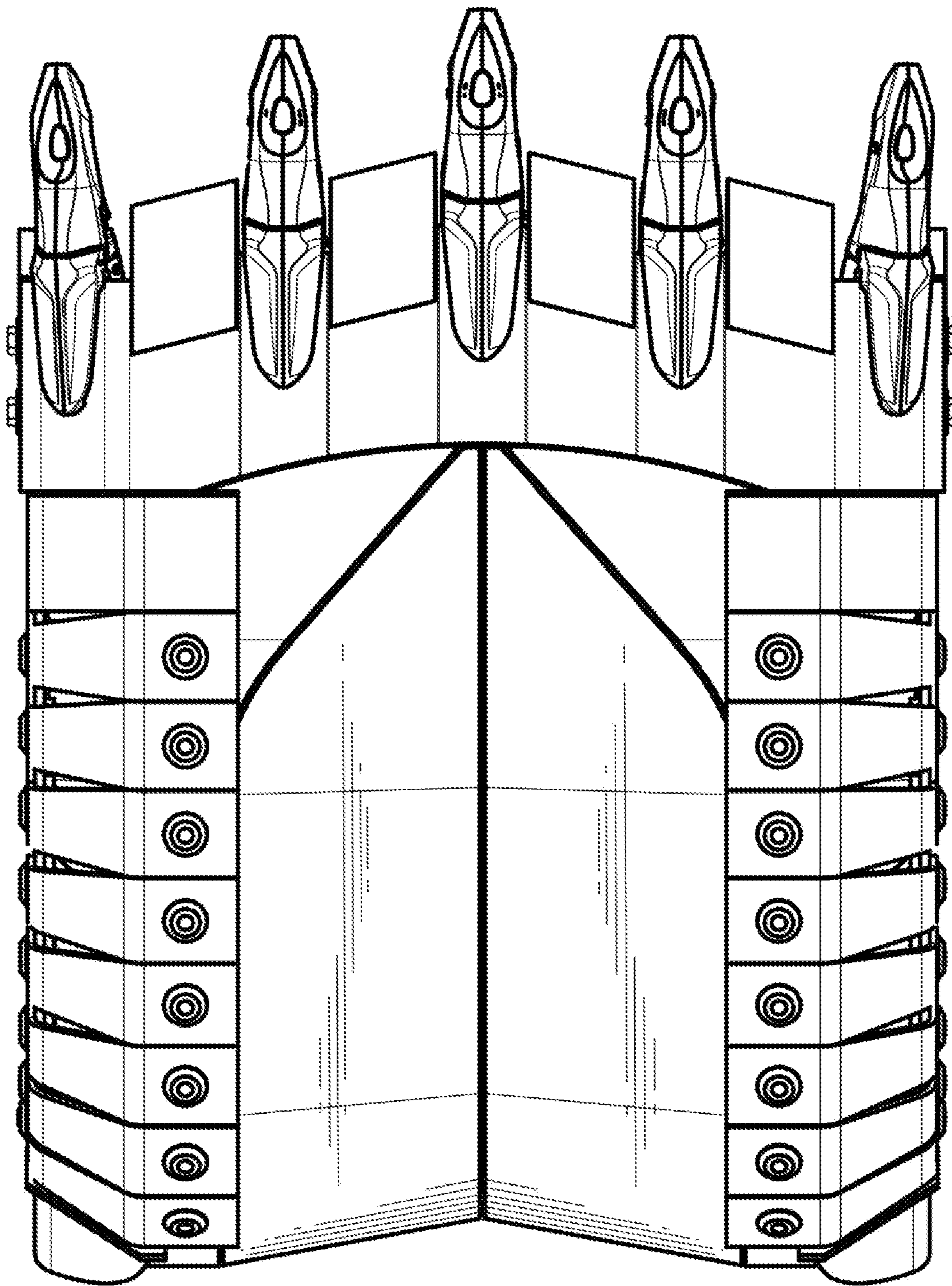

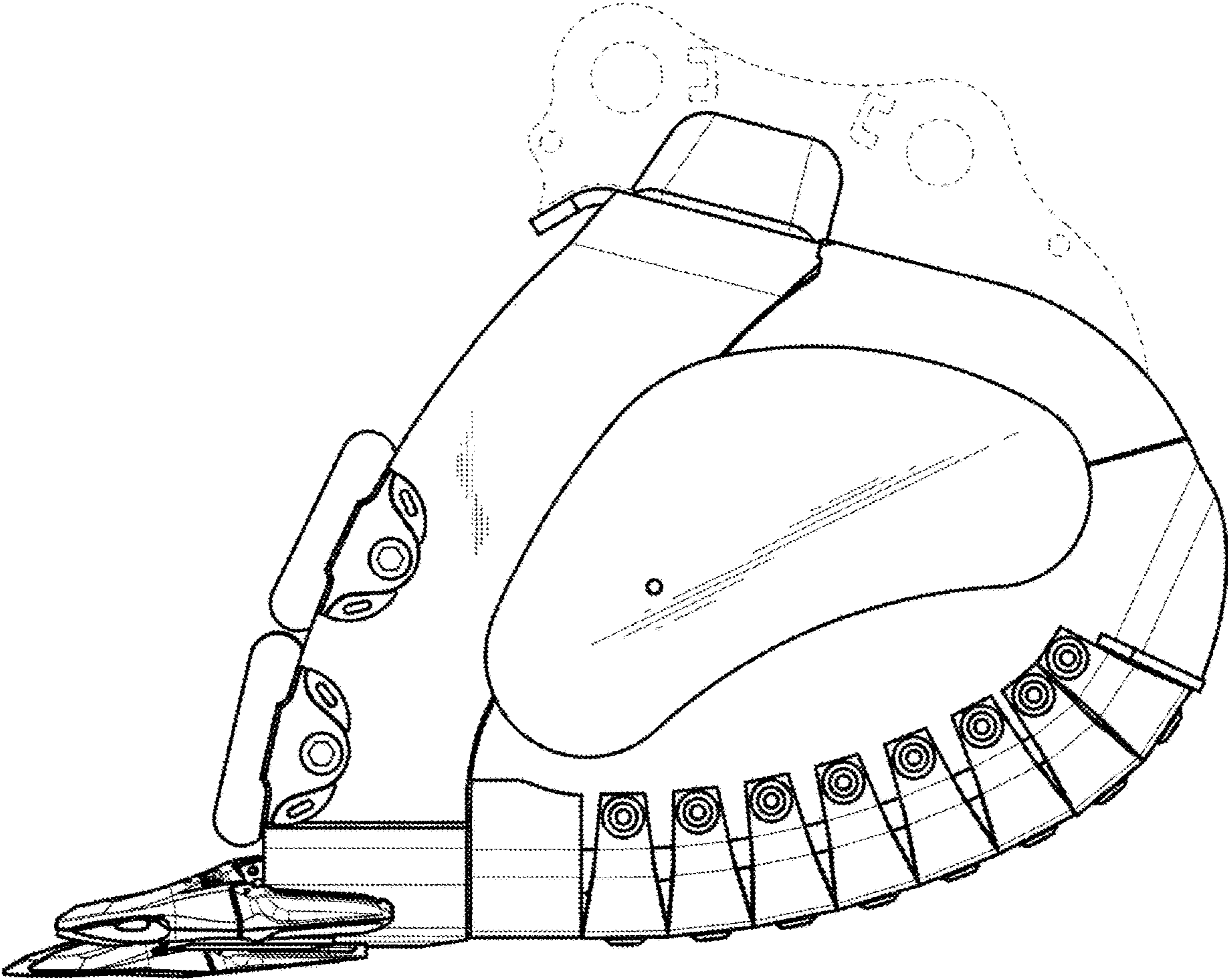

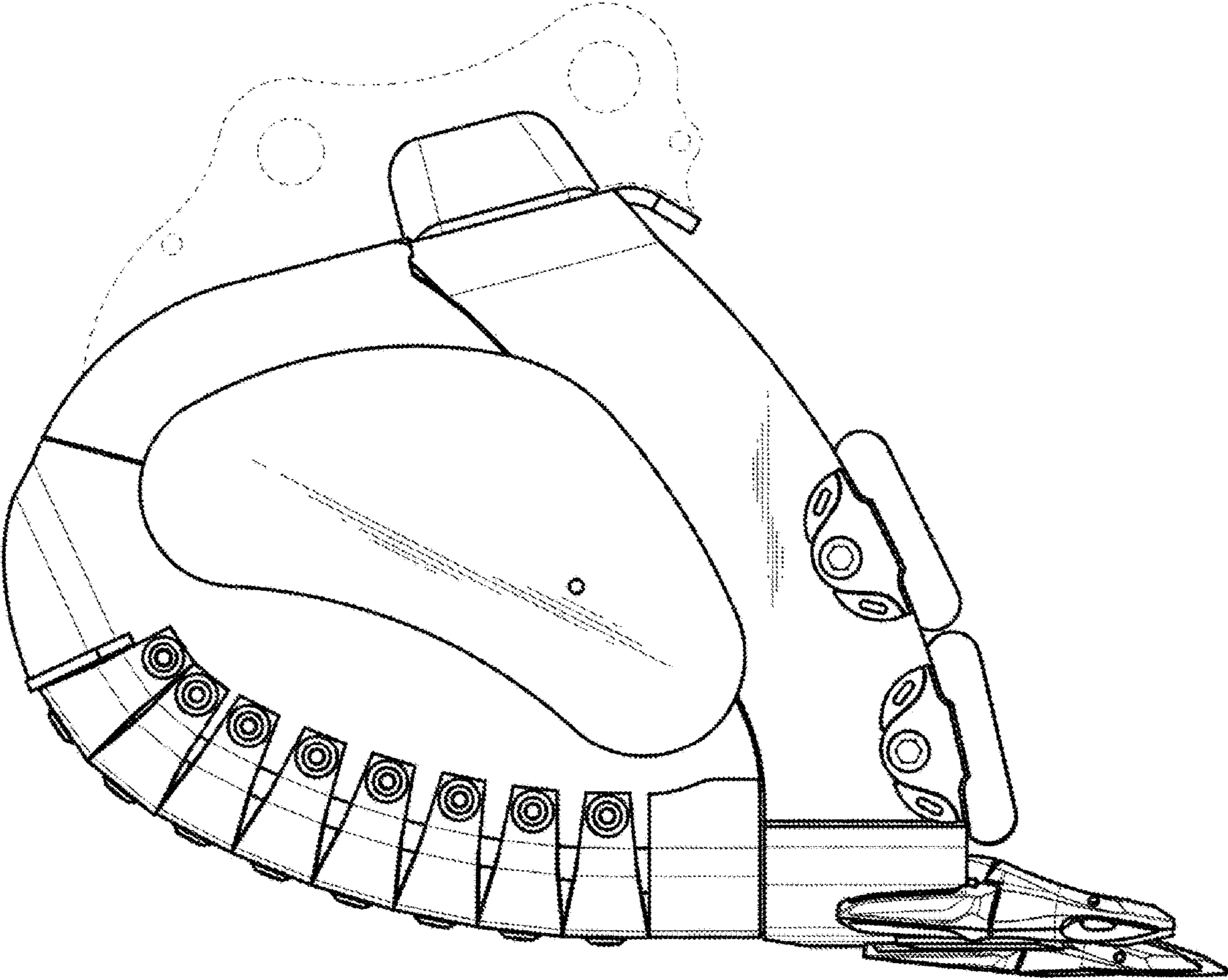
