The ornamental design for a printer housing, as shown and described.

DESCRIPTION

FIG. 1 is a front-left isometric view of a printer housing, showing my new design;

FIG. 2 is a front-right isometric view of the printer housing of FIG. 1;

FIG. 3 is a front view of the printer housing of FIG. 1;

FIG. 4 is a rear view of the printer housing of FIG. 1;

FIG. 5 is a left side view of the printer housing of FIG. 1;

FIG. 6 is a right side view of the printer housing of FIG. 1;

FIG. 7 is a top view of the printer housing of FIG. 1;

FIG. 8 is a bottom view of the printer housing of FIG. 1;

FIG. 17 is a top view of the printer housing of FIG. 11;

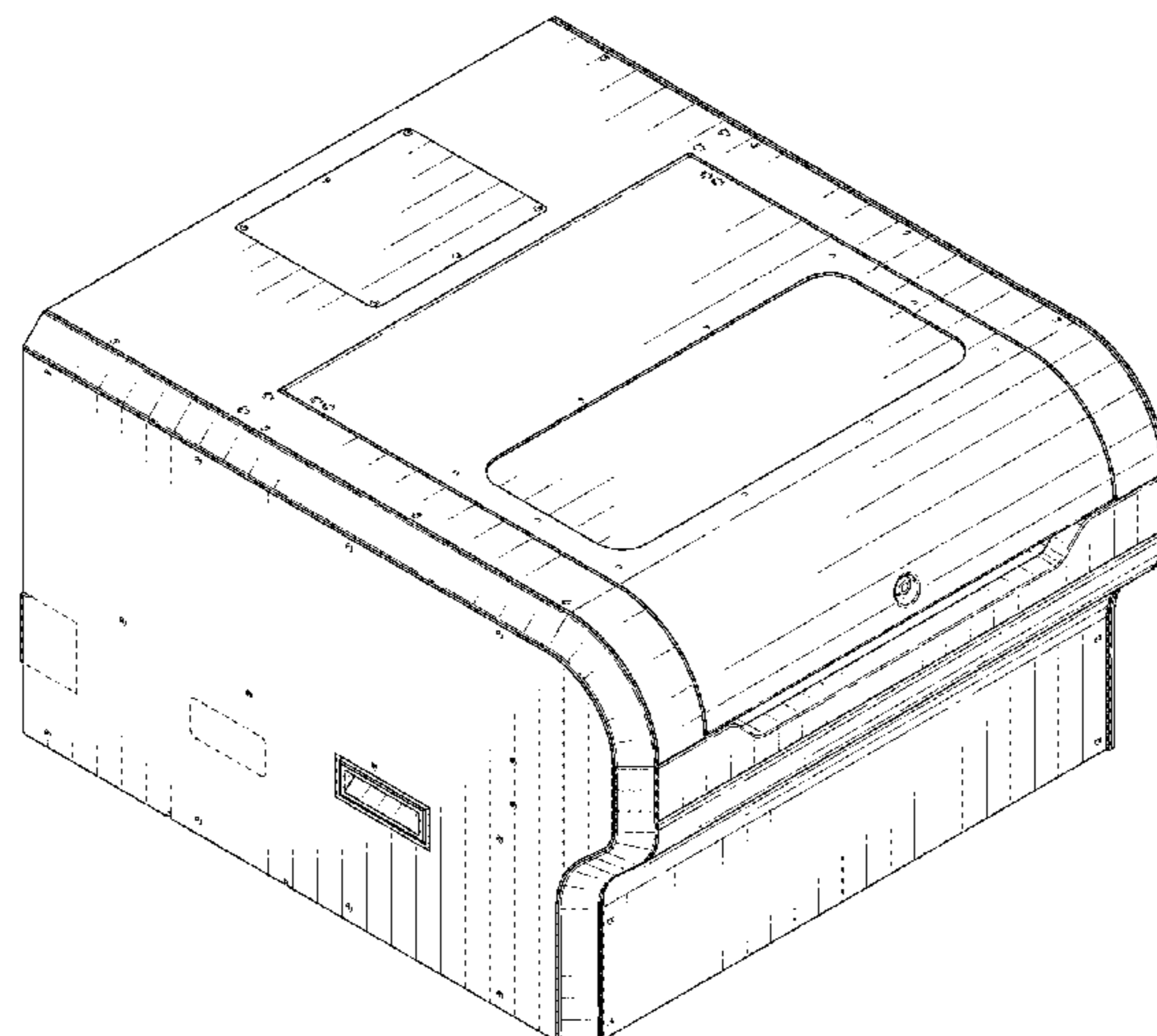
FIG. 18 is a bottom view of the printer housing of FIG. 11;

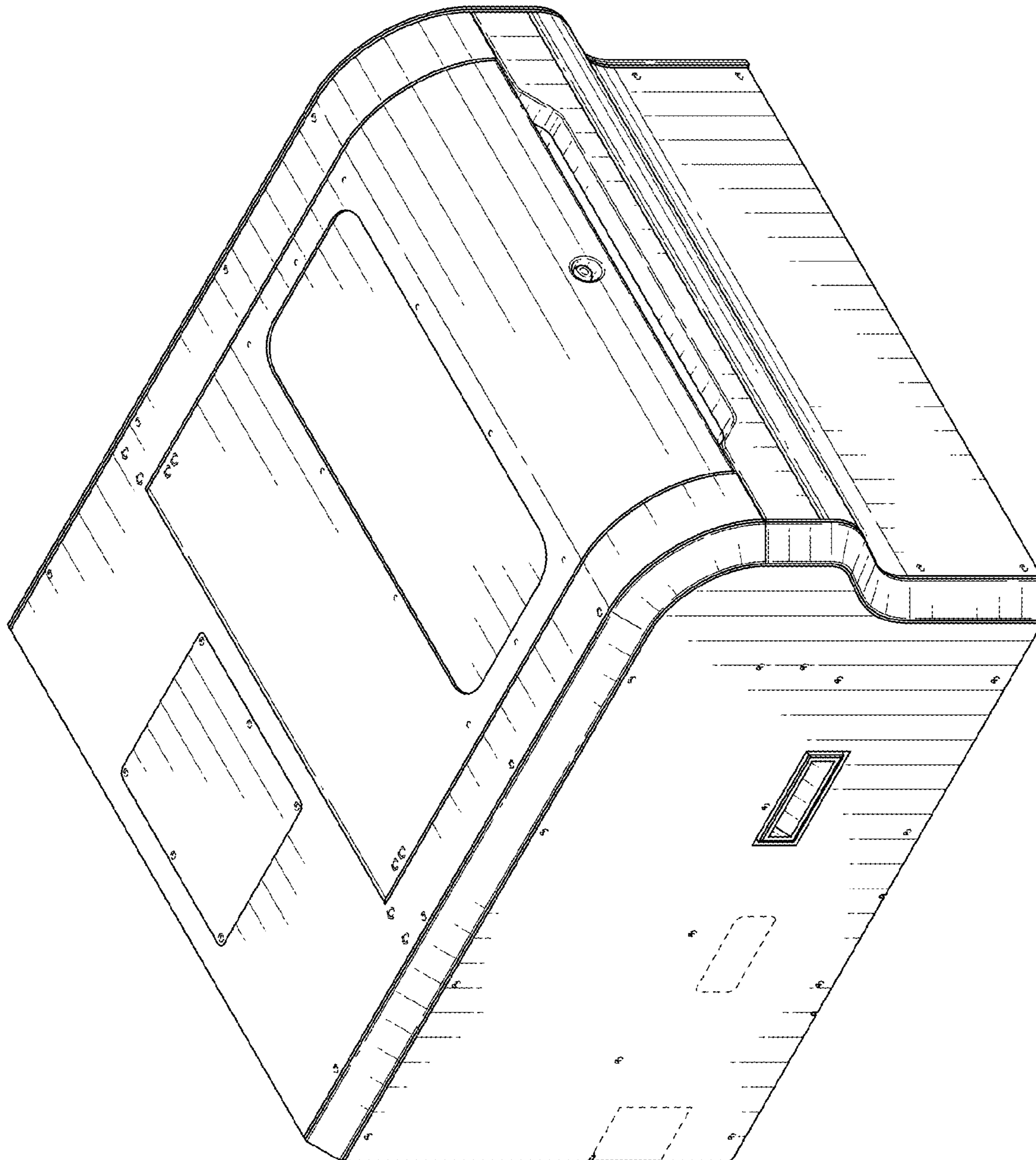

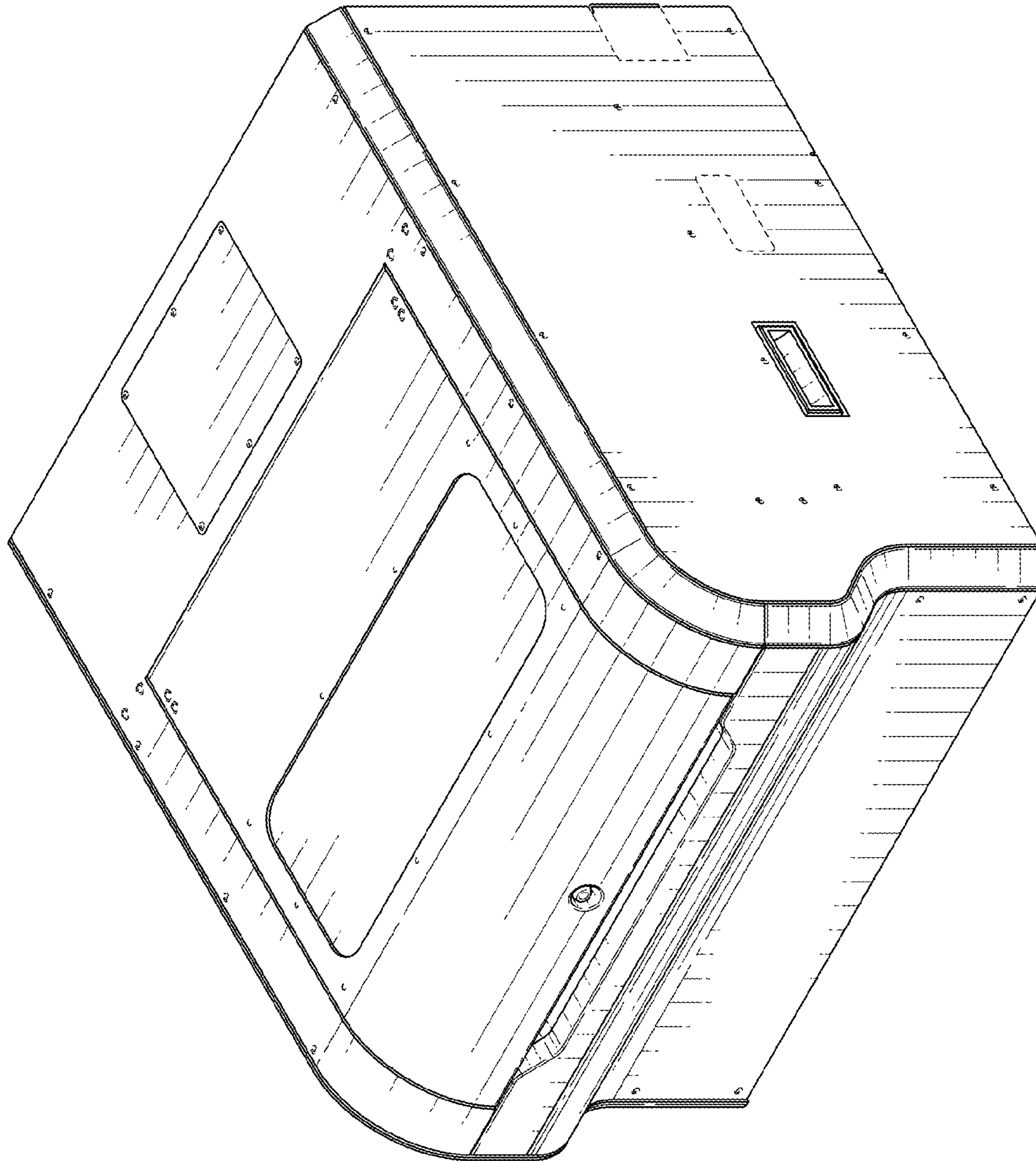

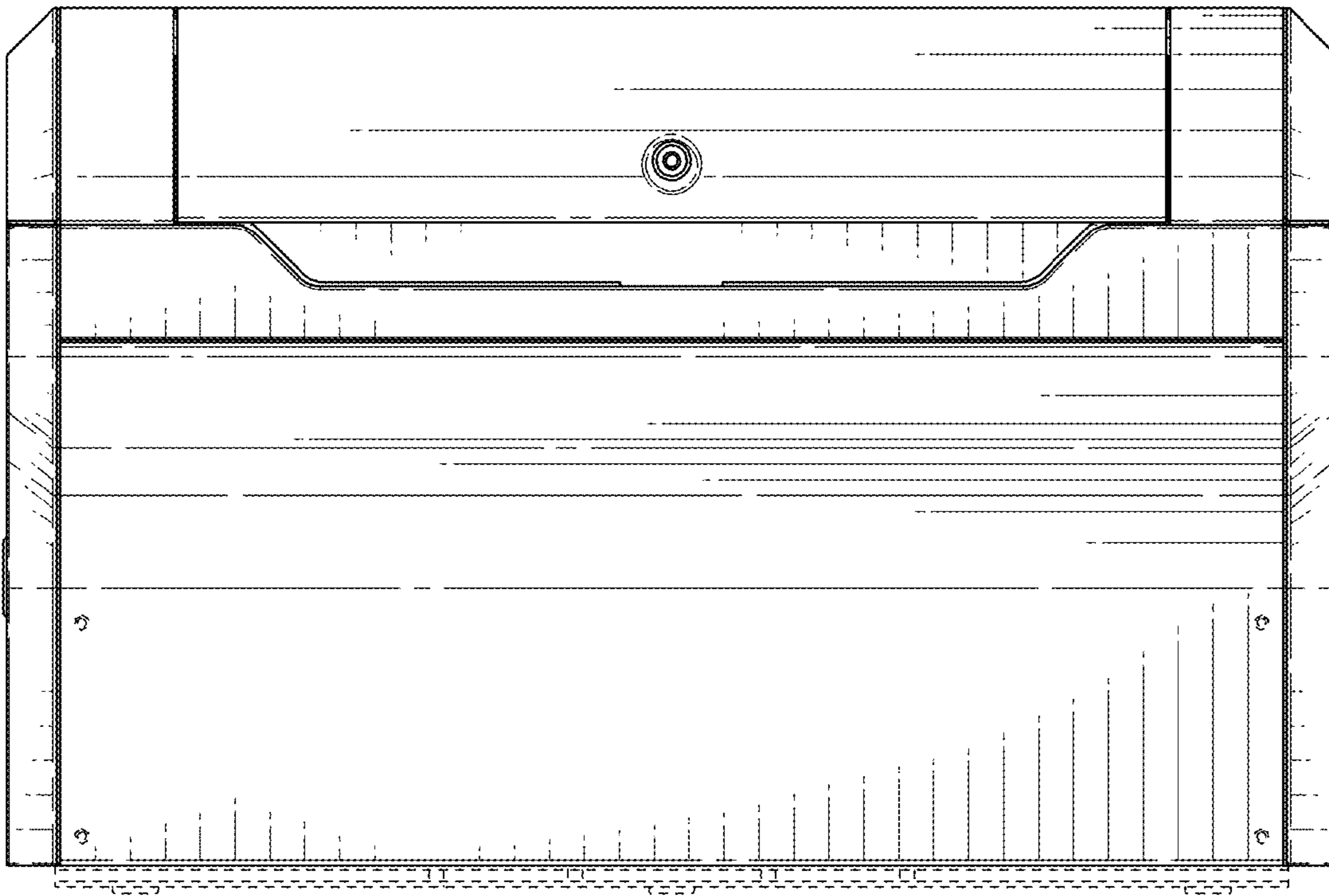

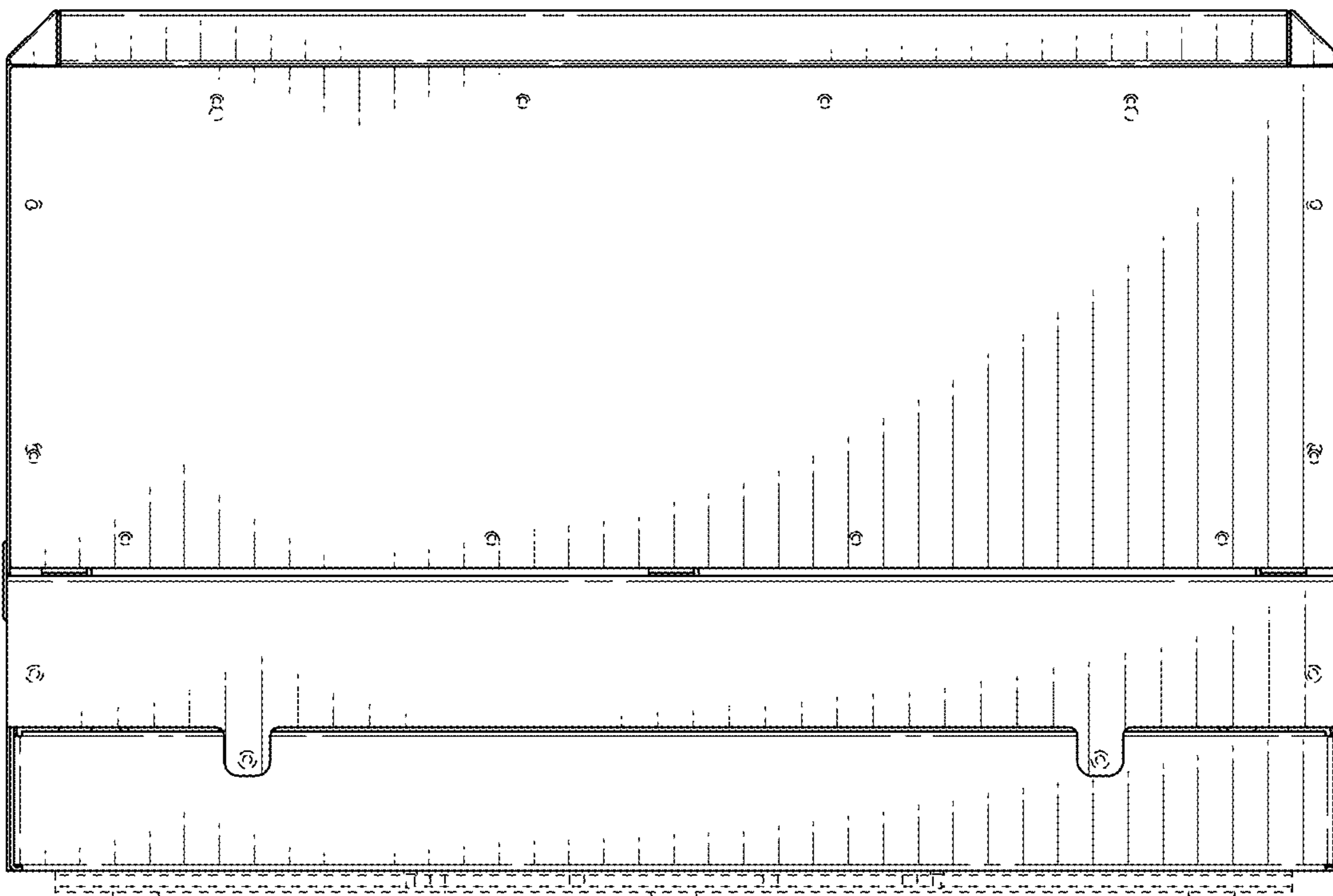

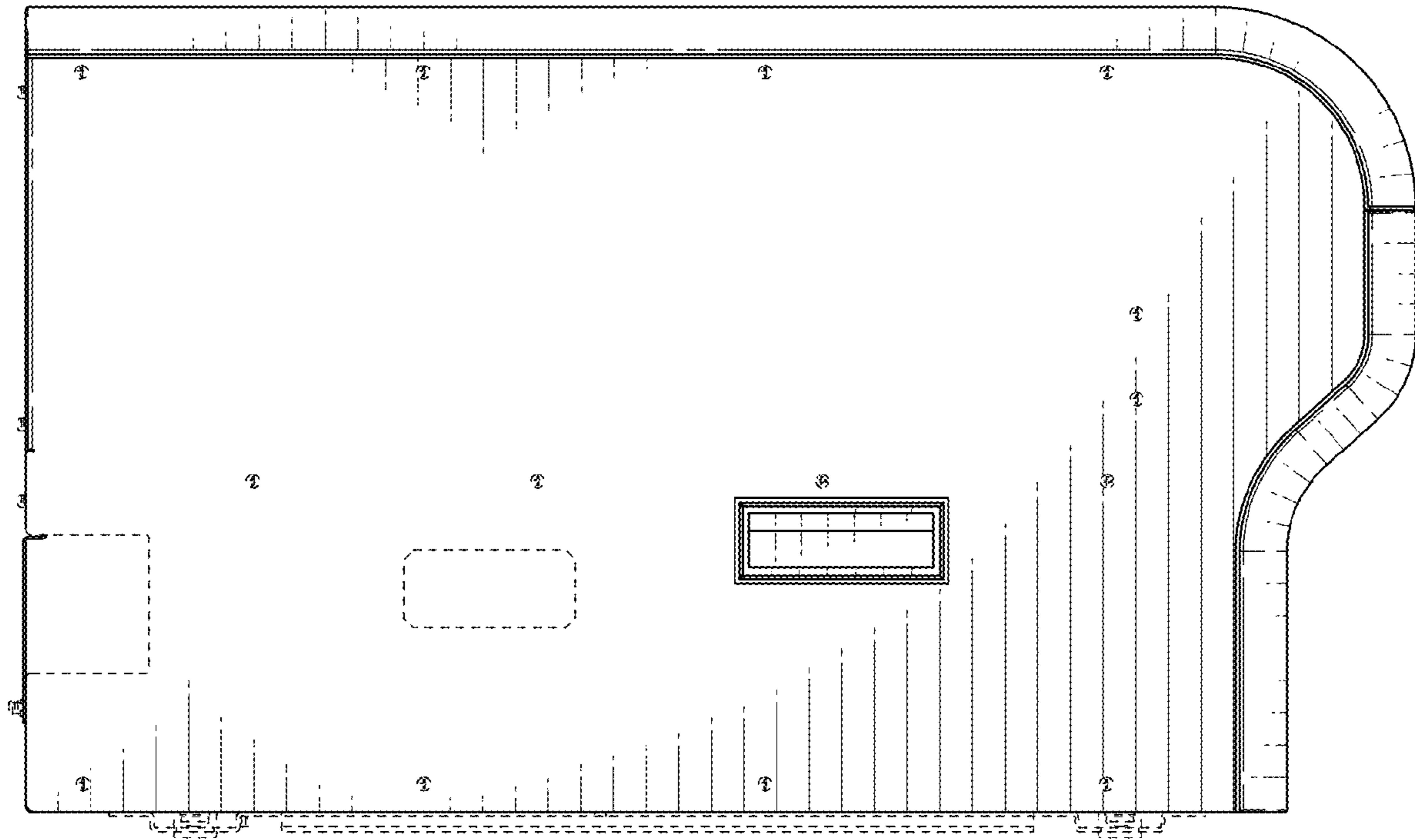

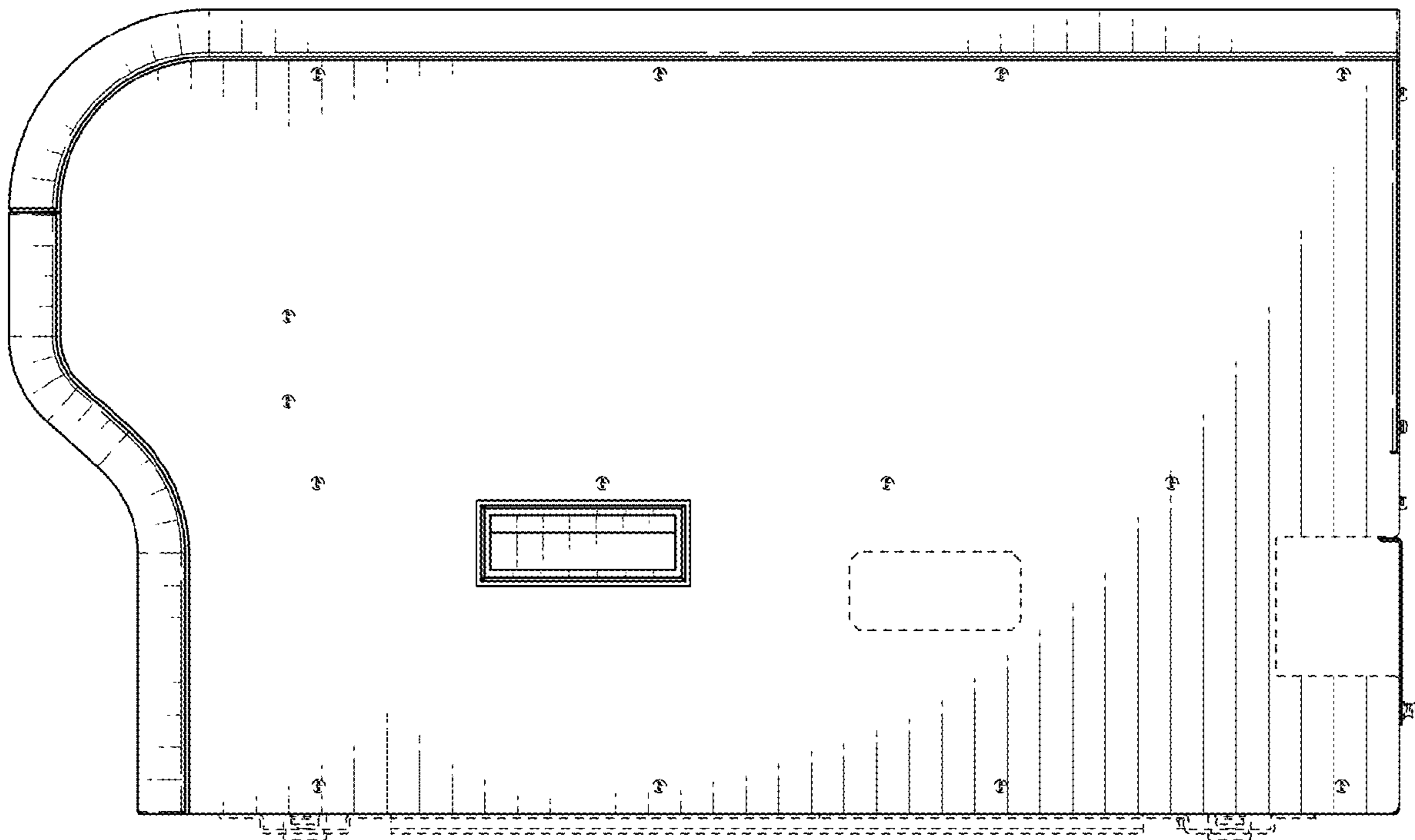

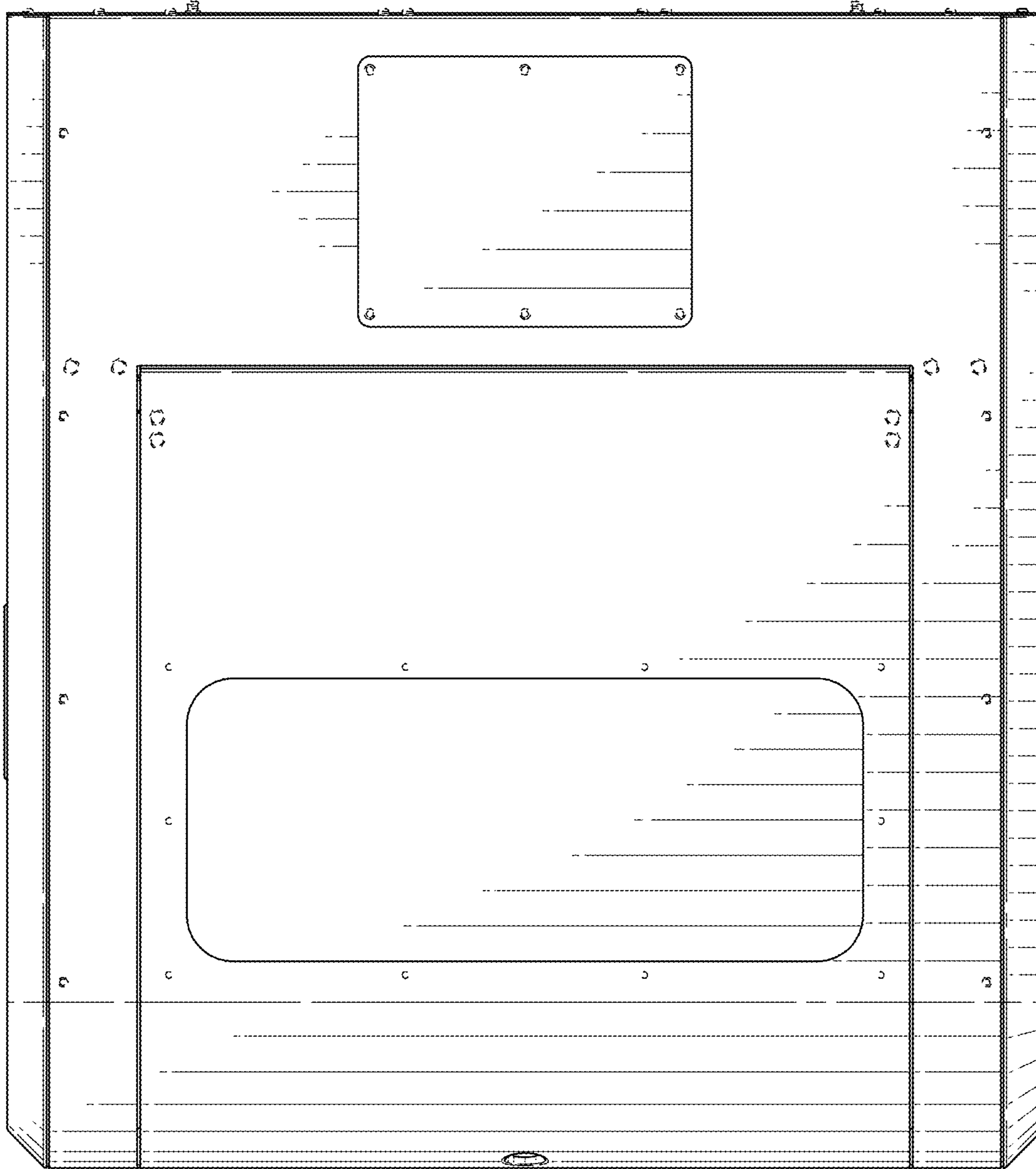

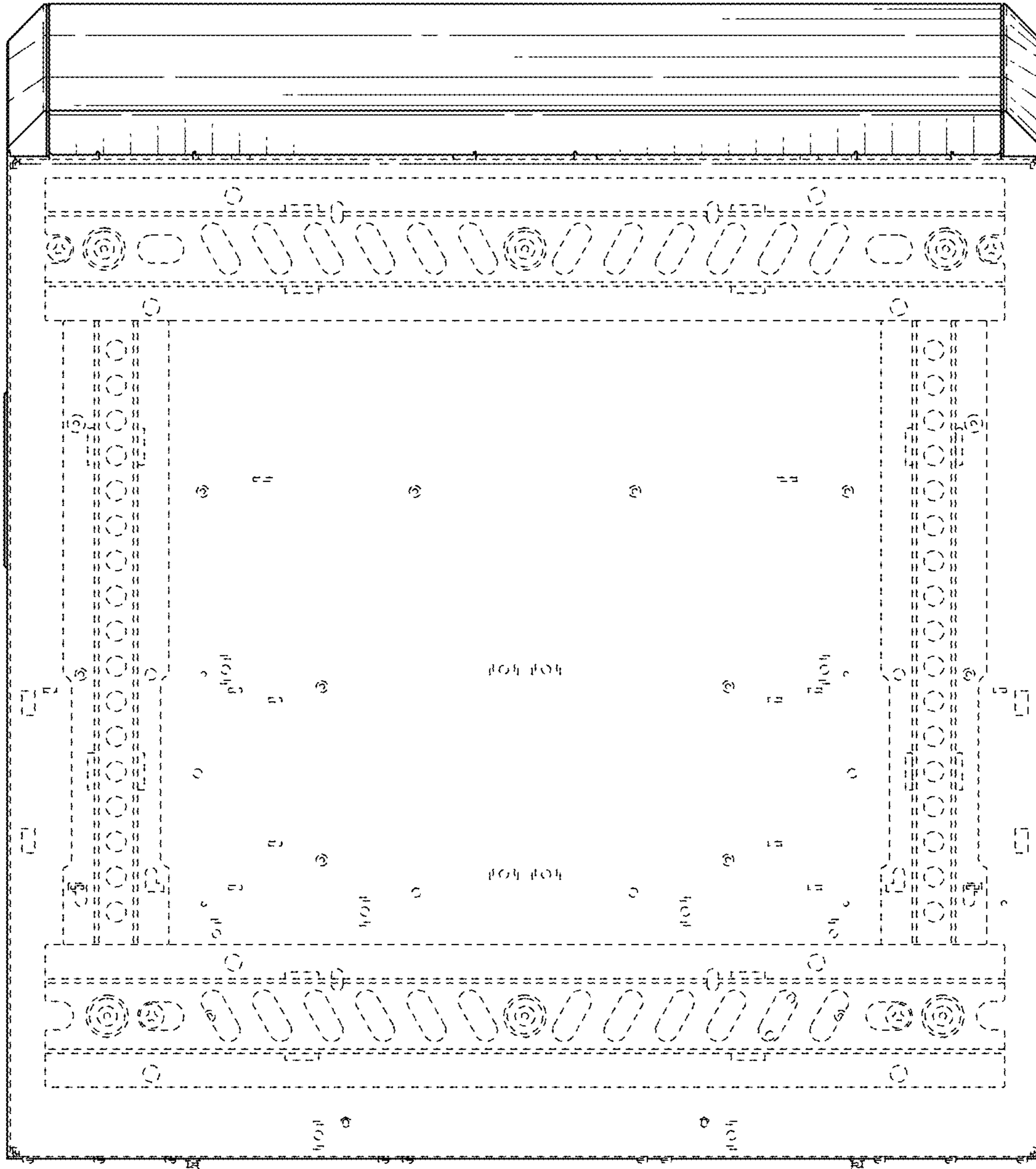

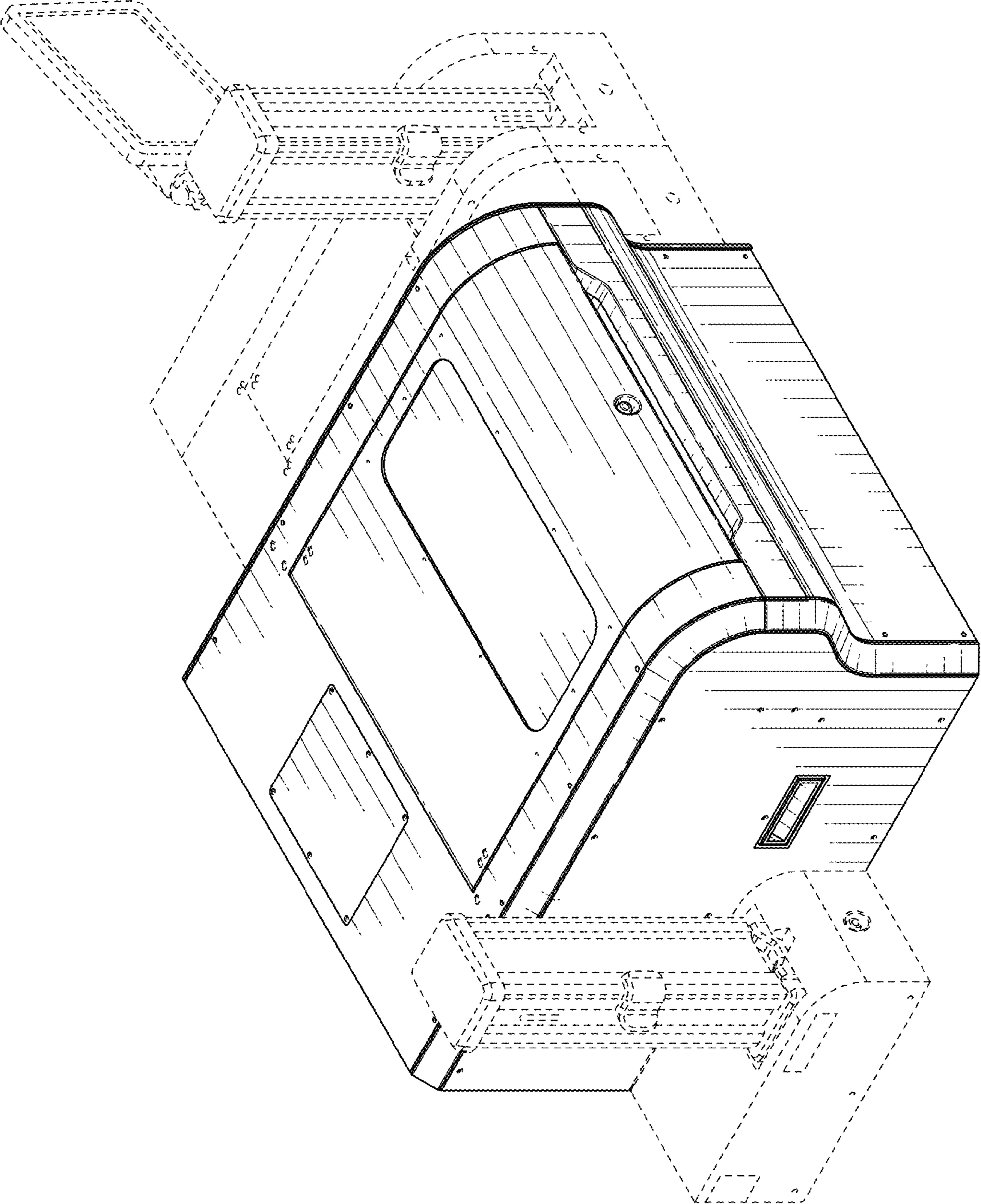

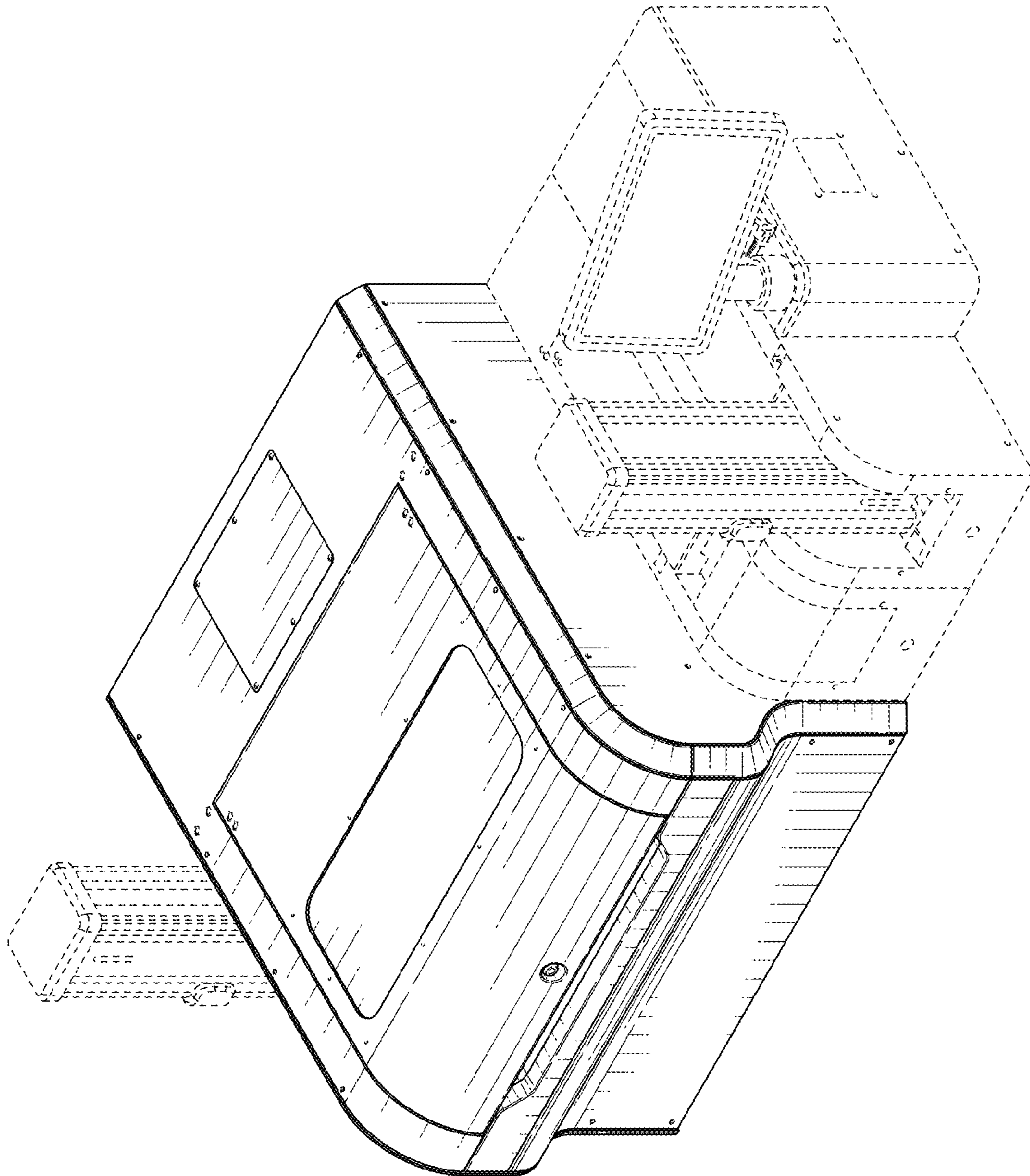

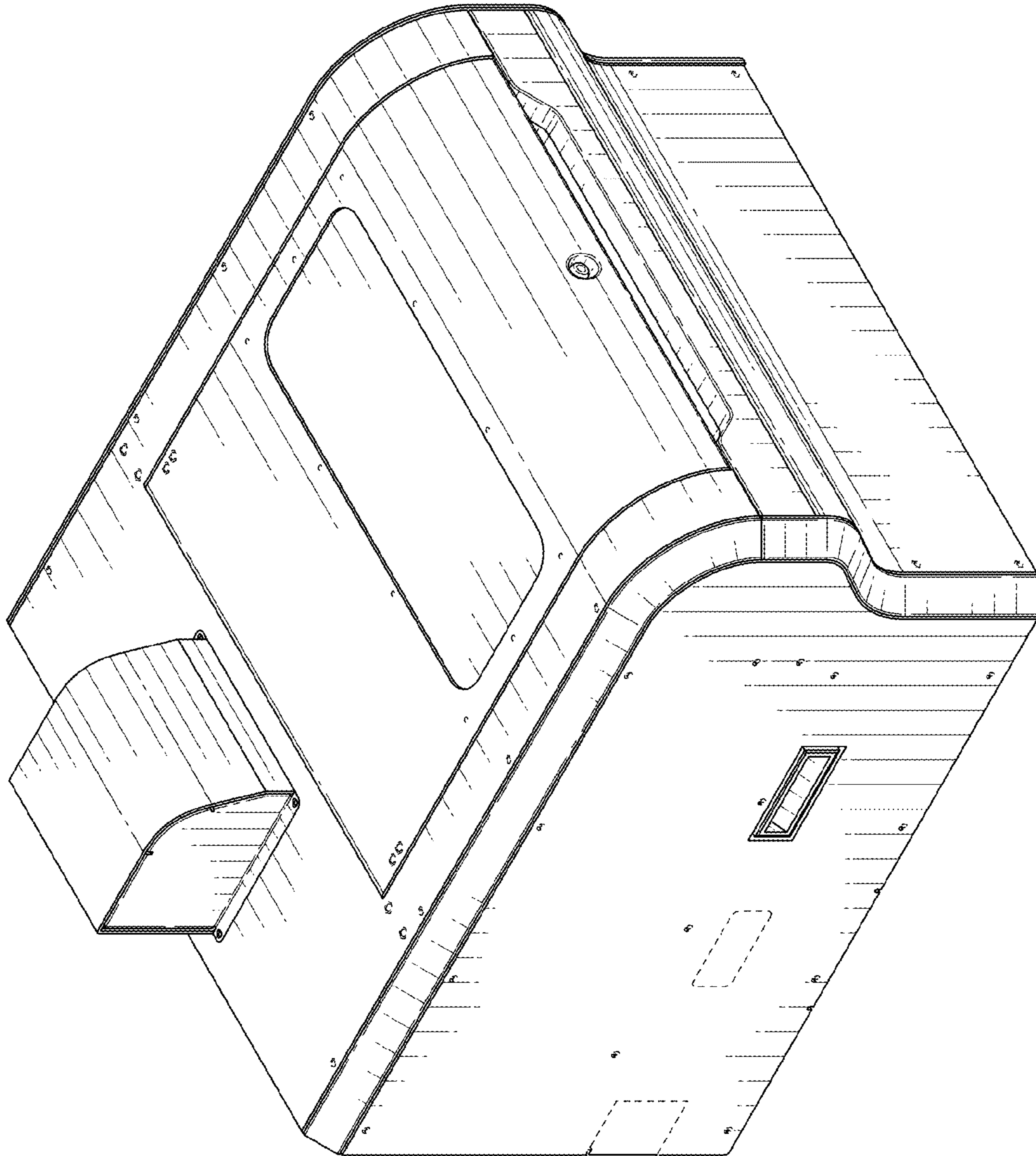

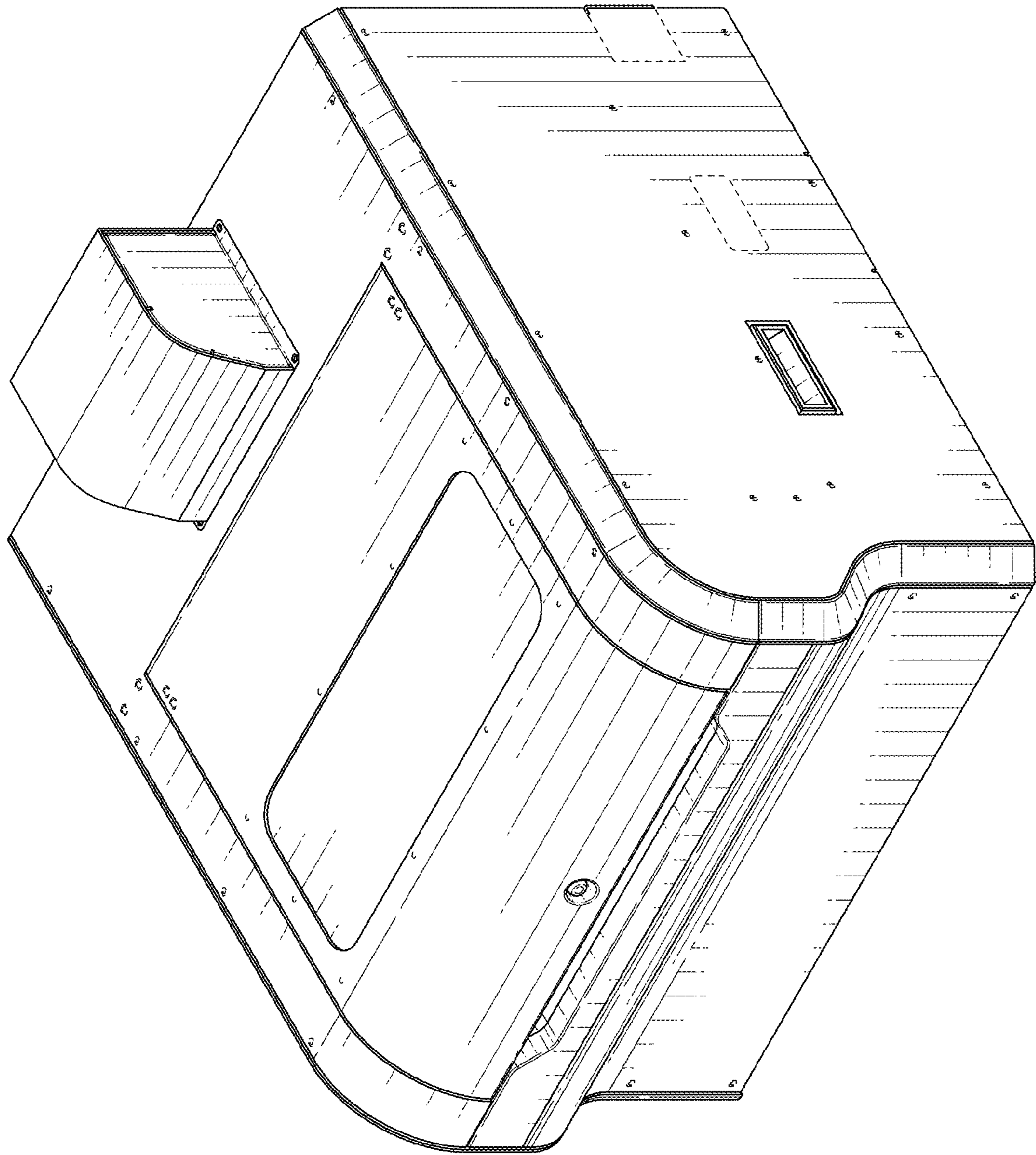

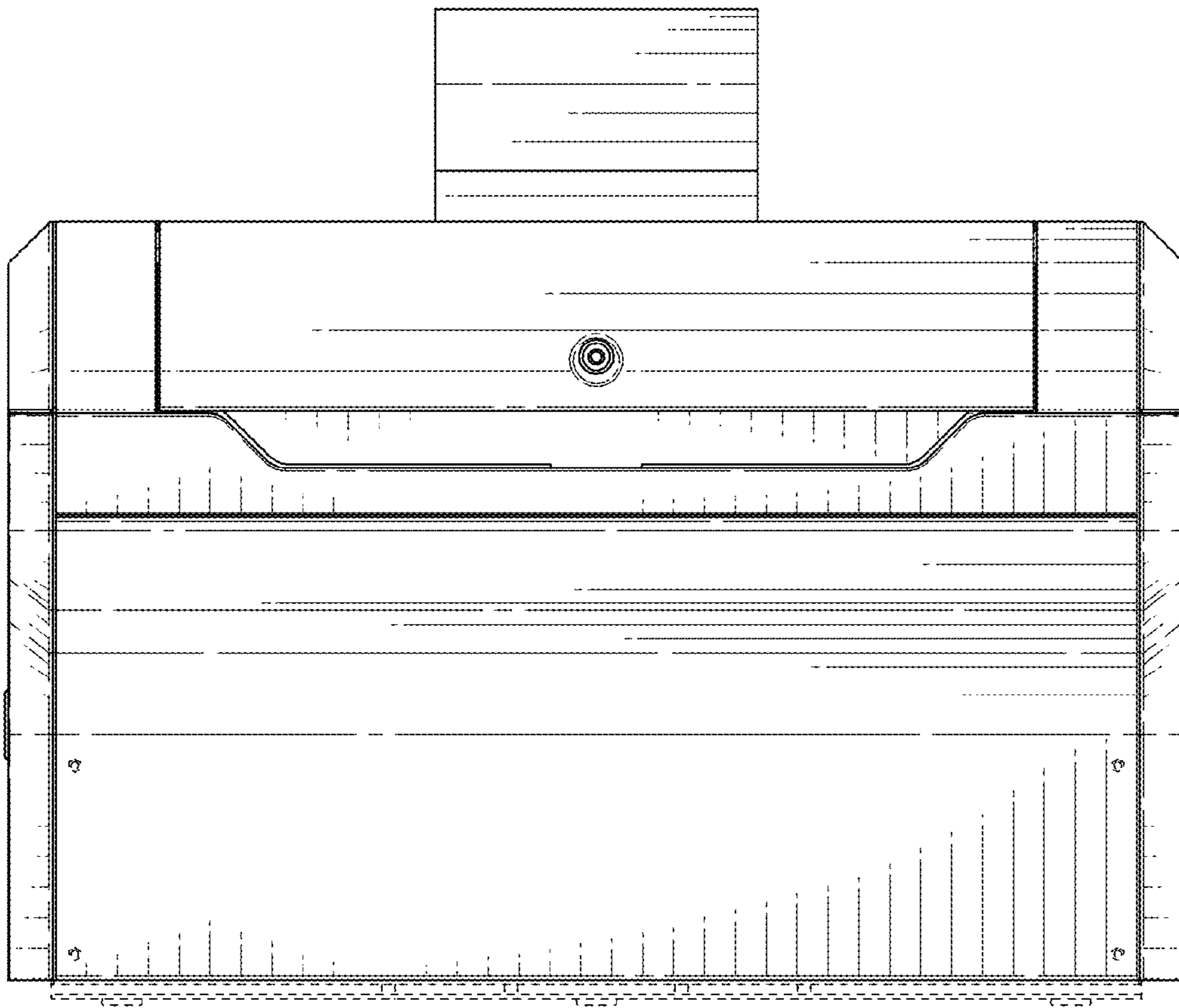

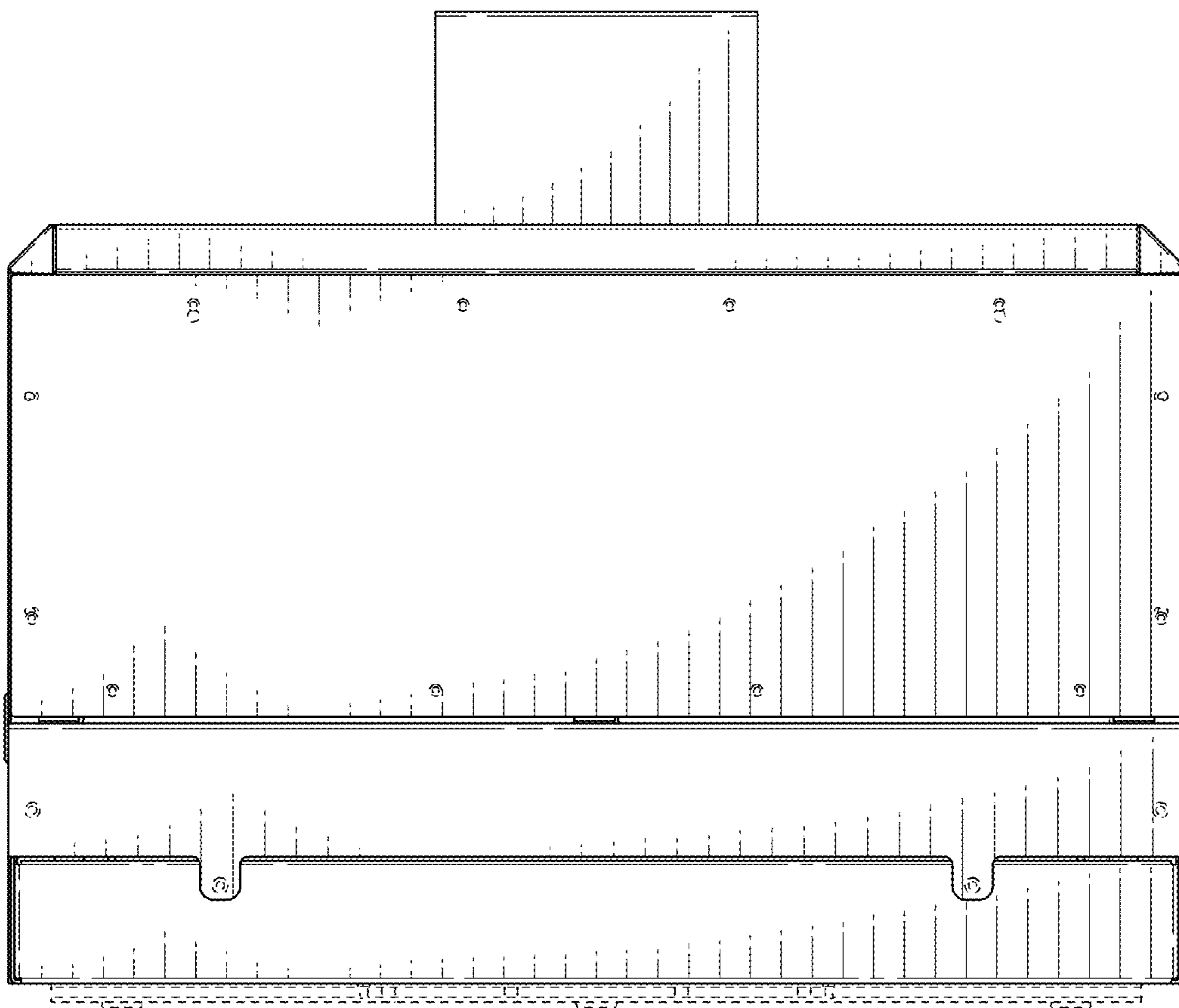

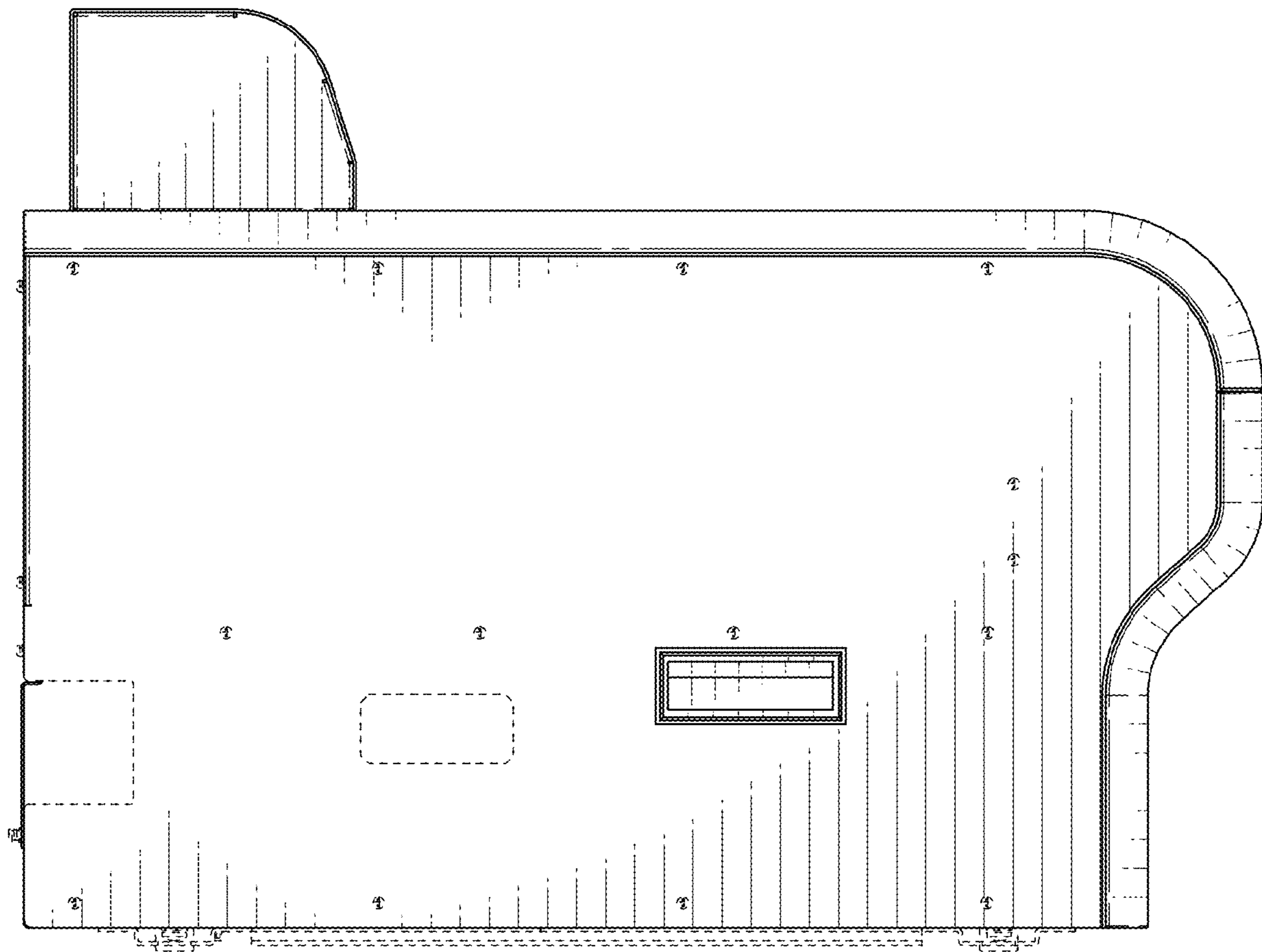

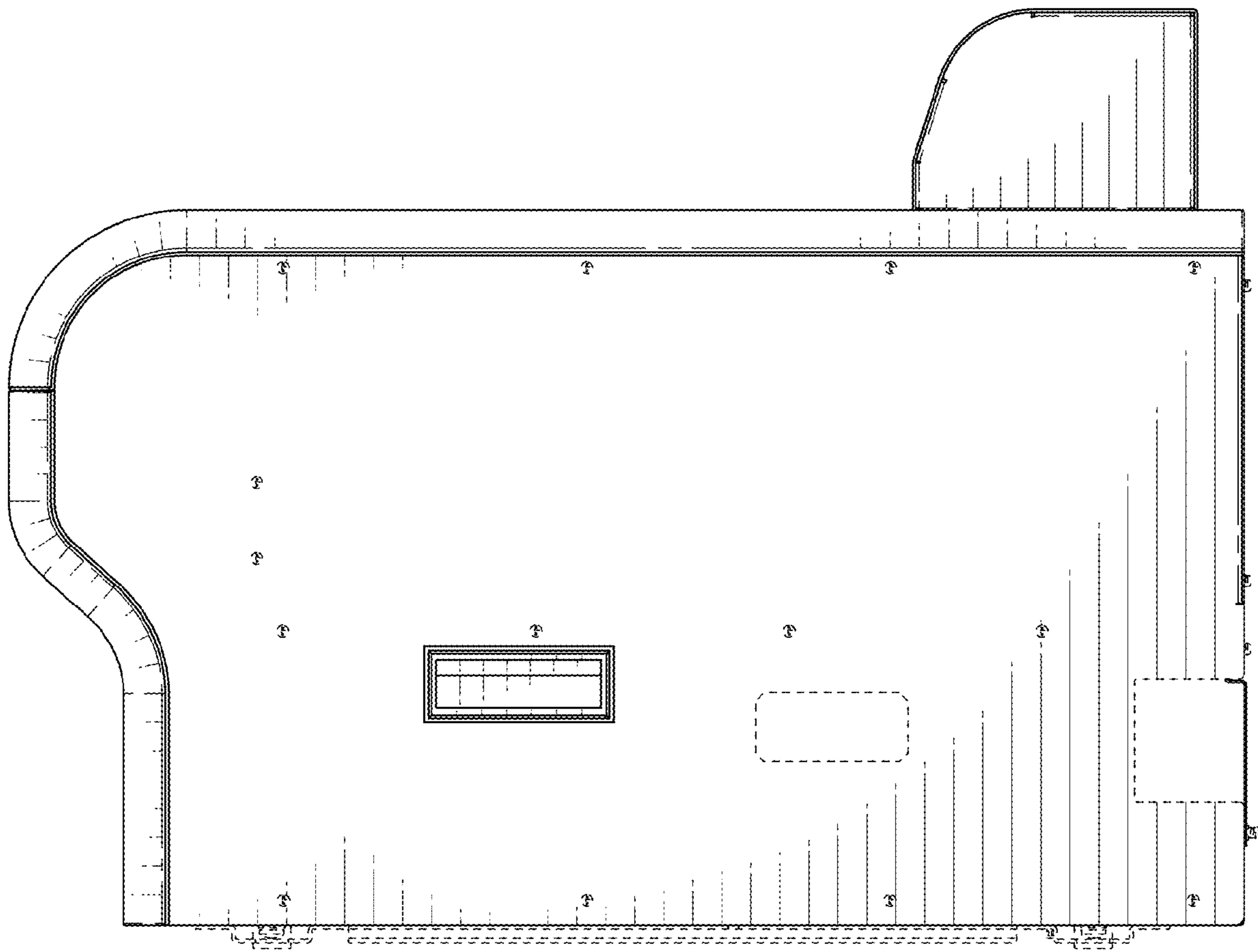

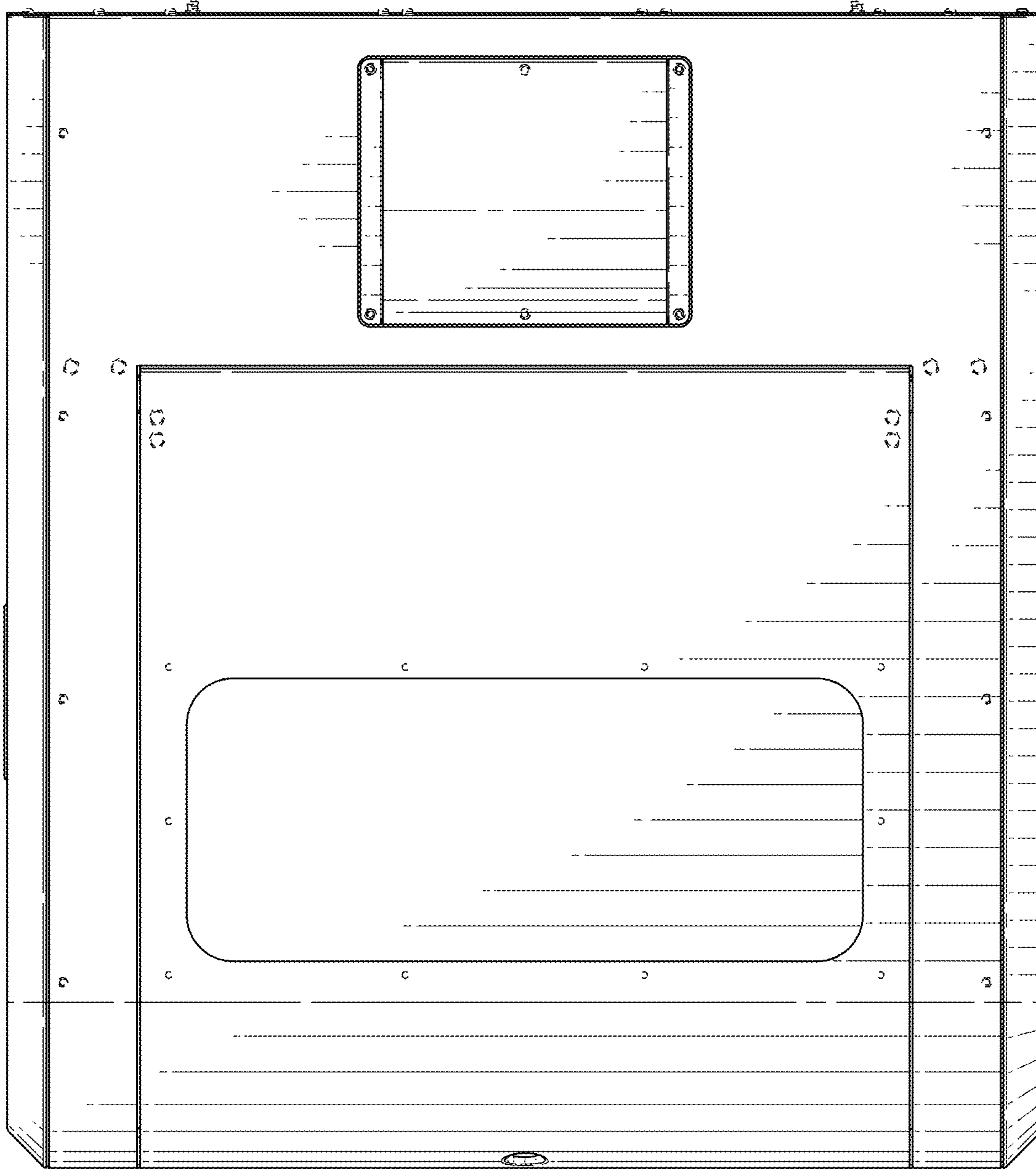

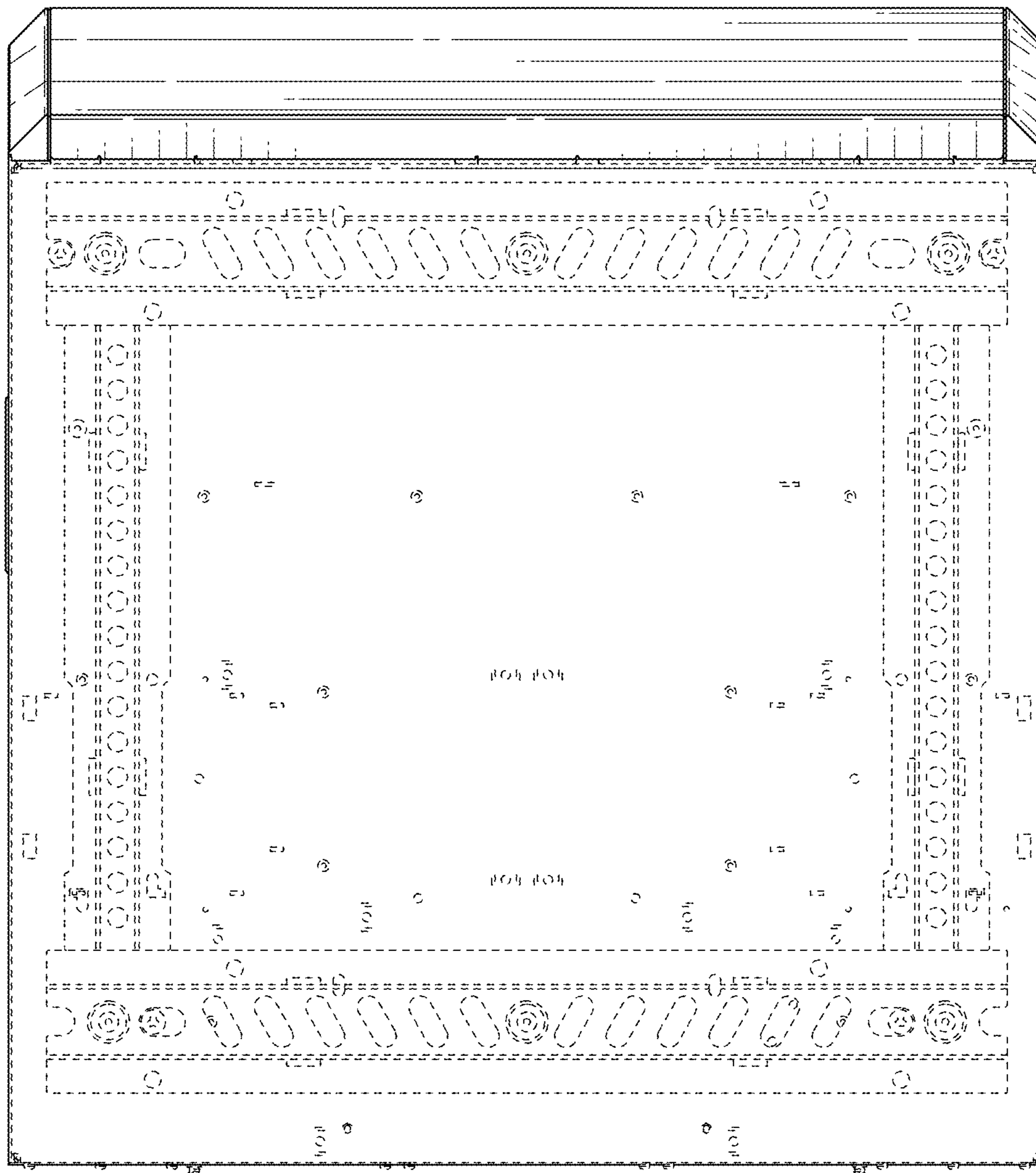

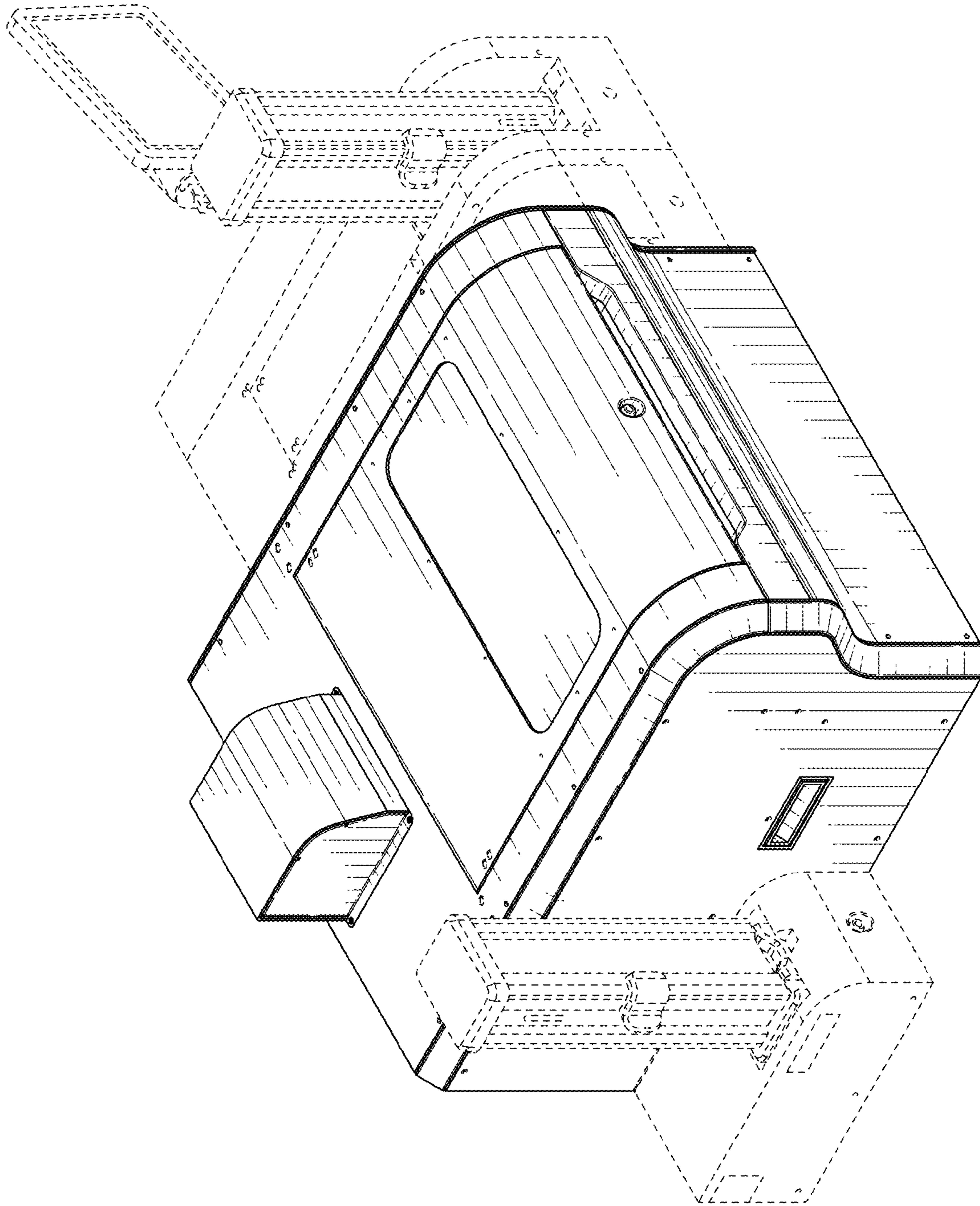

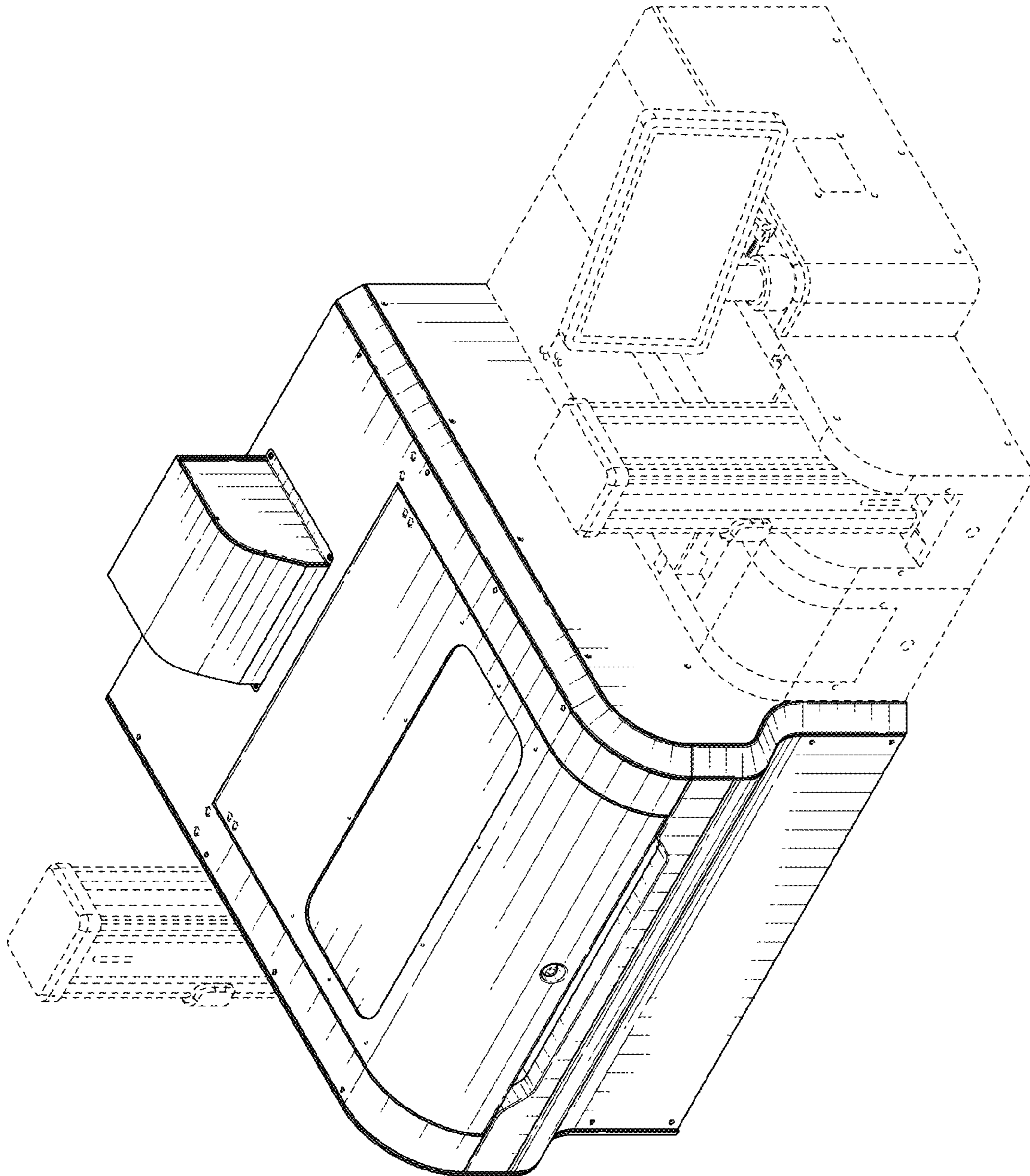
