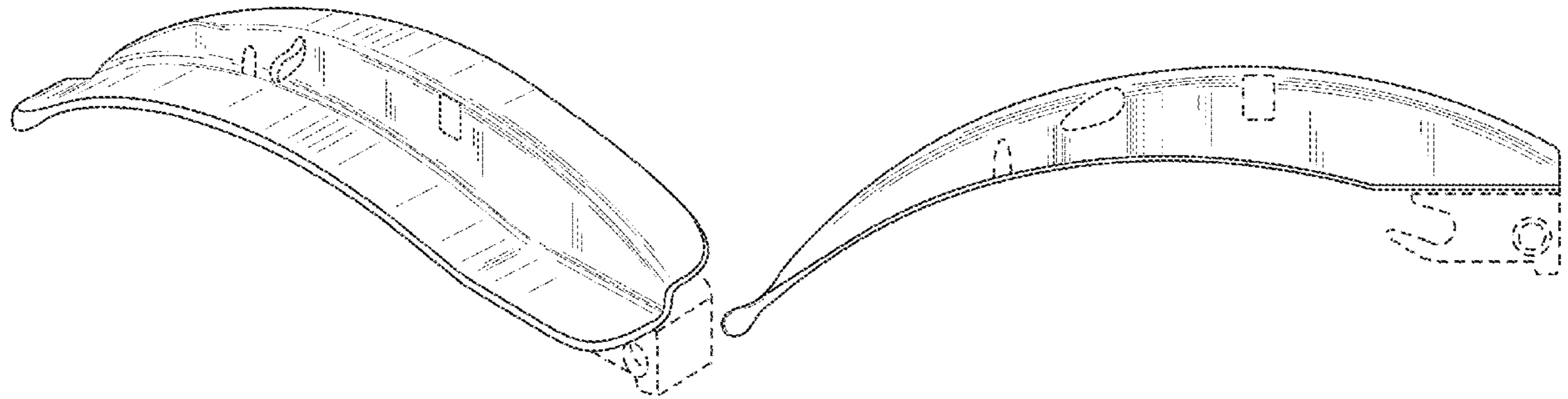

**CLAIM**

The ornamental design for a laryngoscope blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear, right, top perspective view showing our new design;

FIG. 2 is a rear, left, top perspective view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a front elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a rear elevation view thereof.

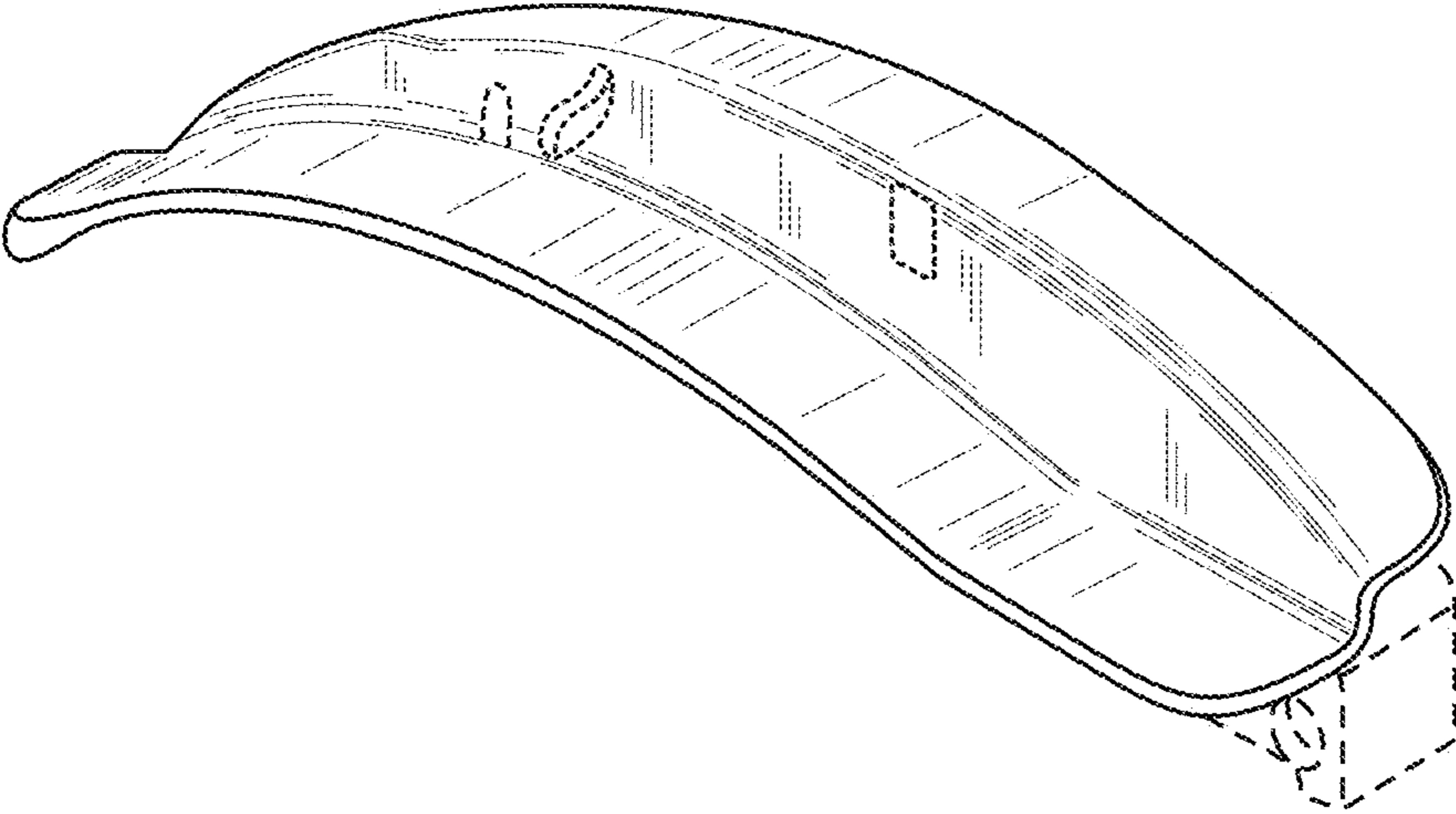

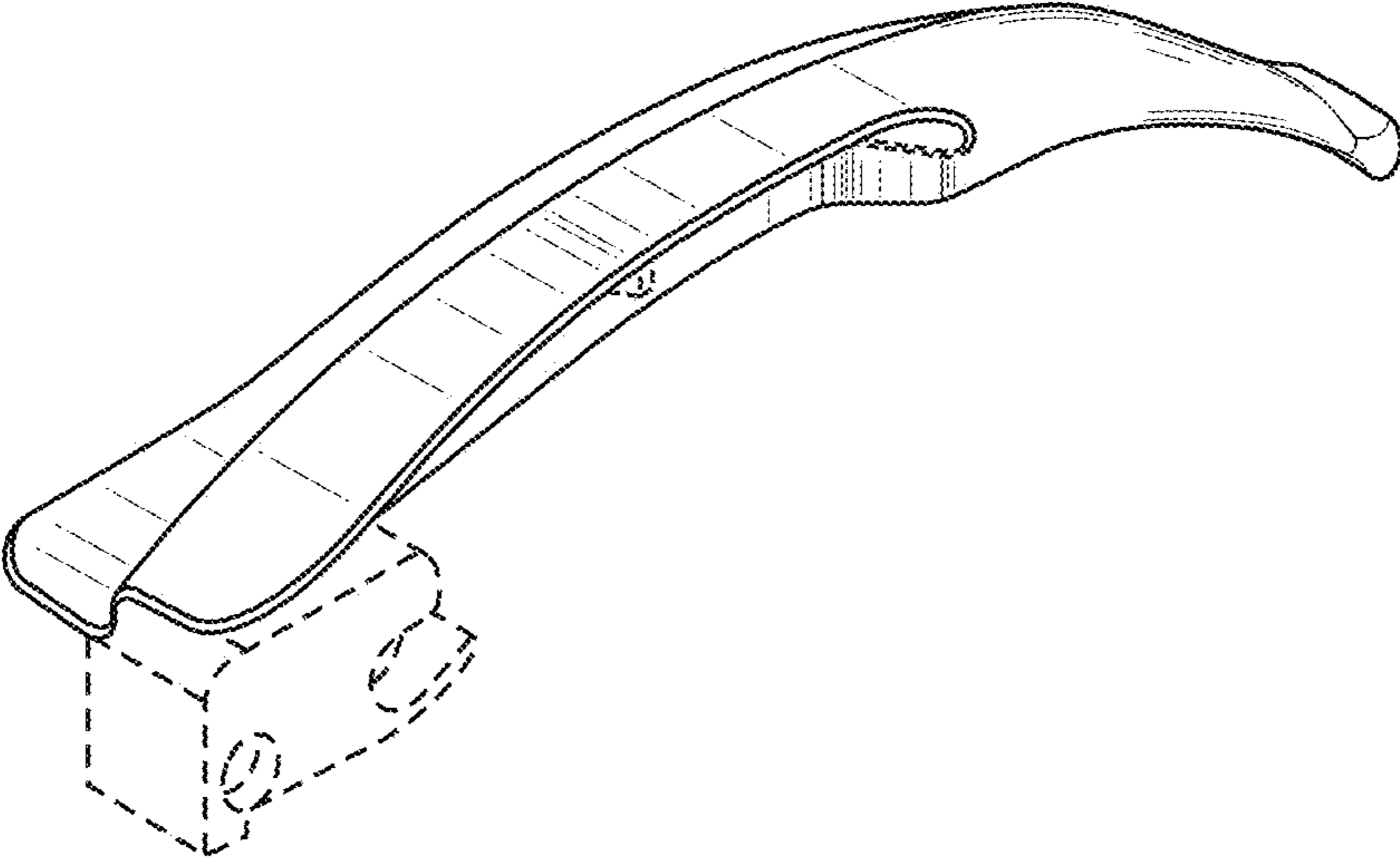

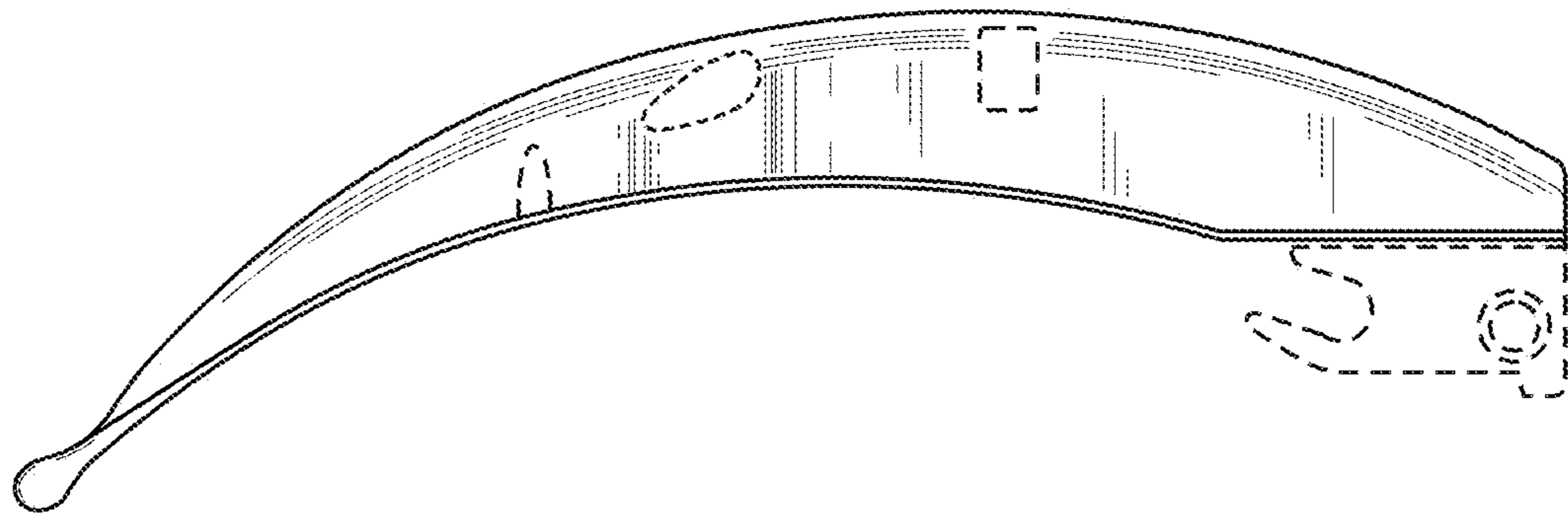

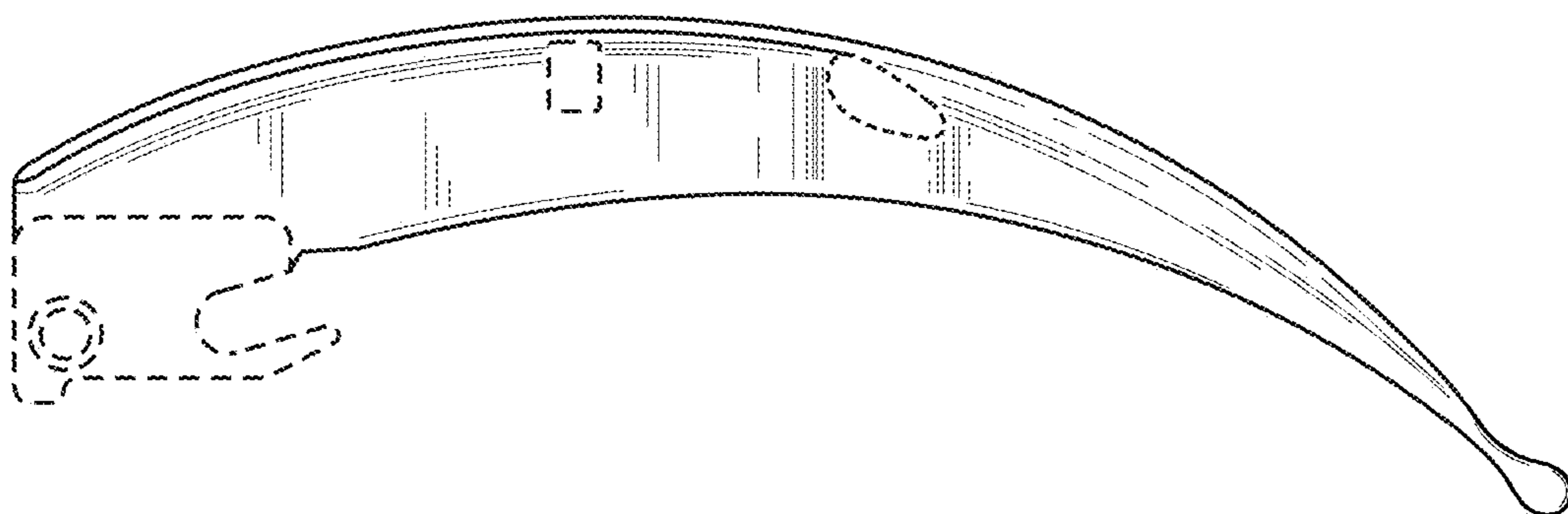

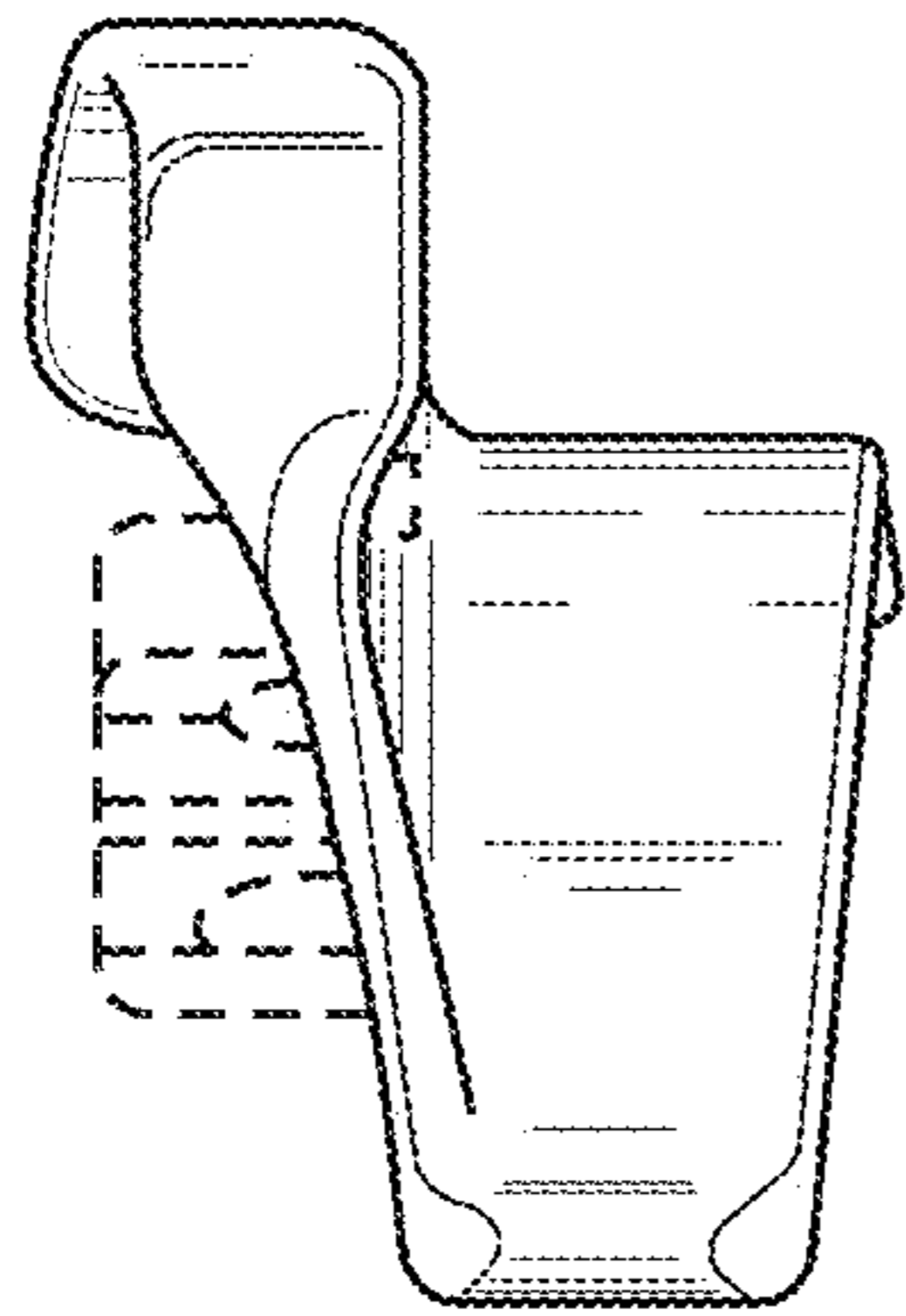

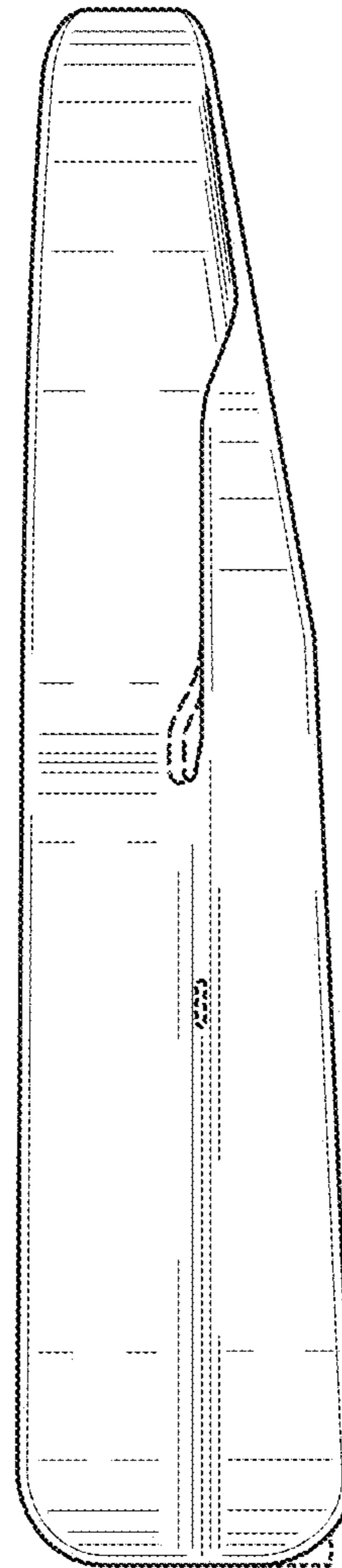

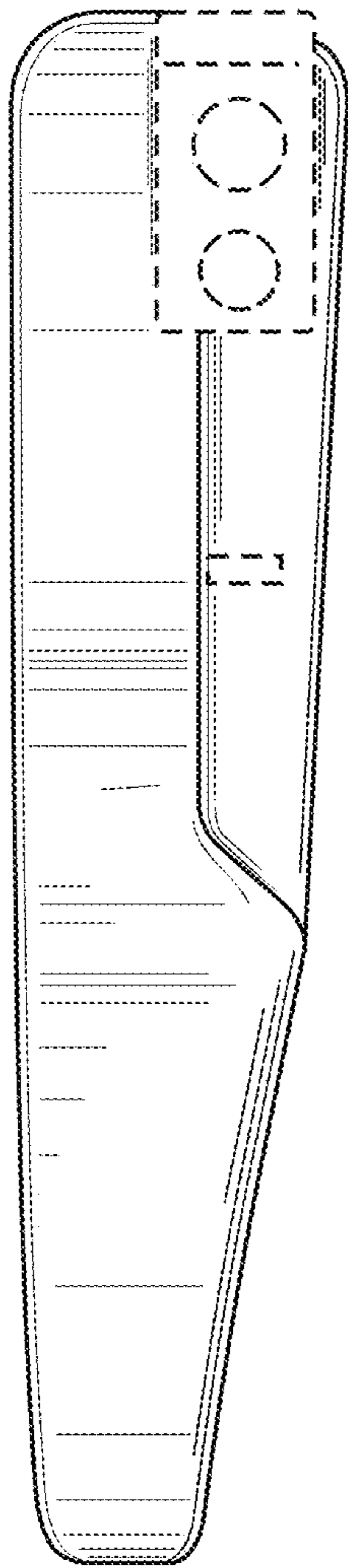

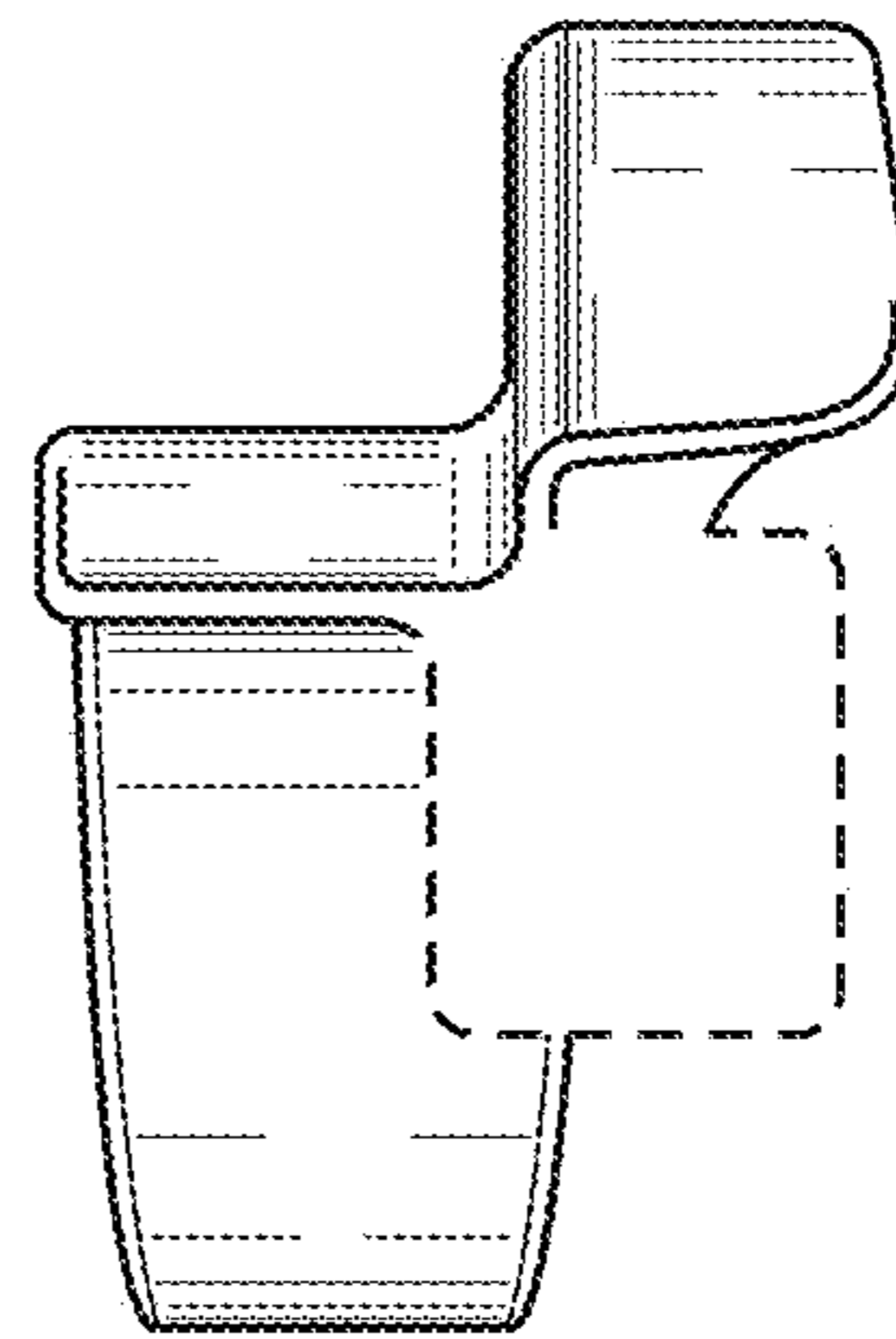
