The ornamental design for a disposable nipper, as shown and described.

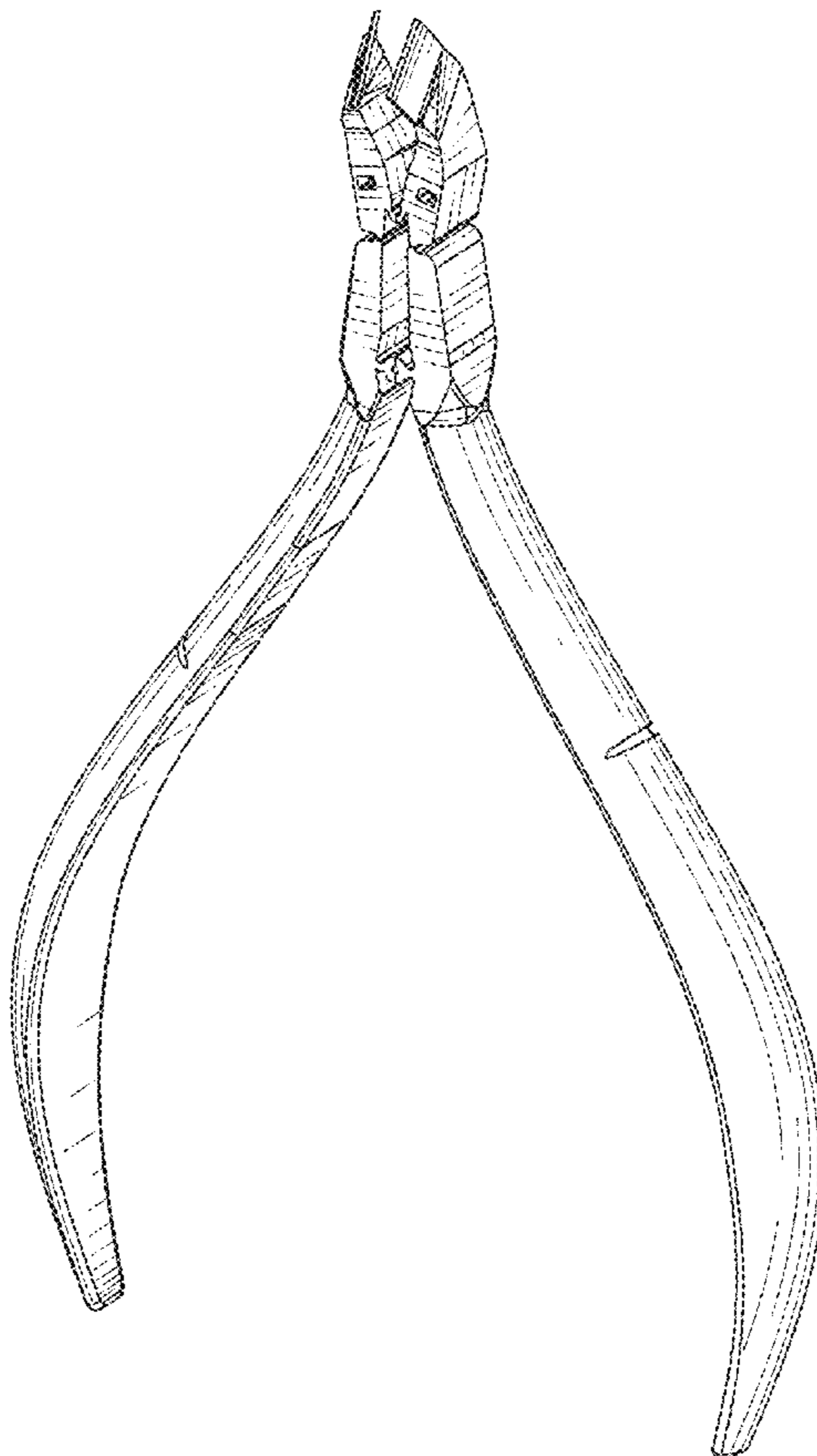
DESCRIPTION

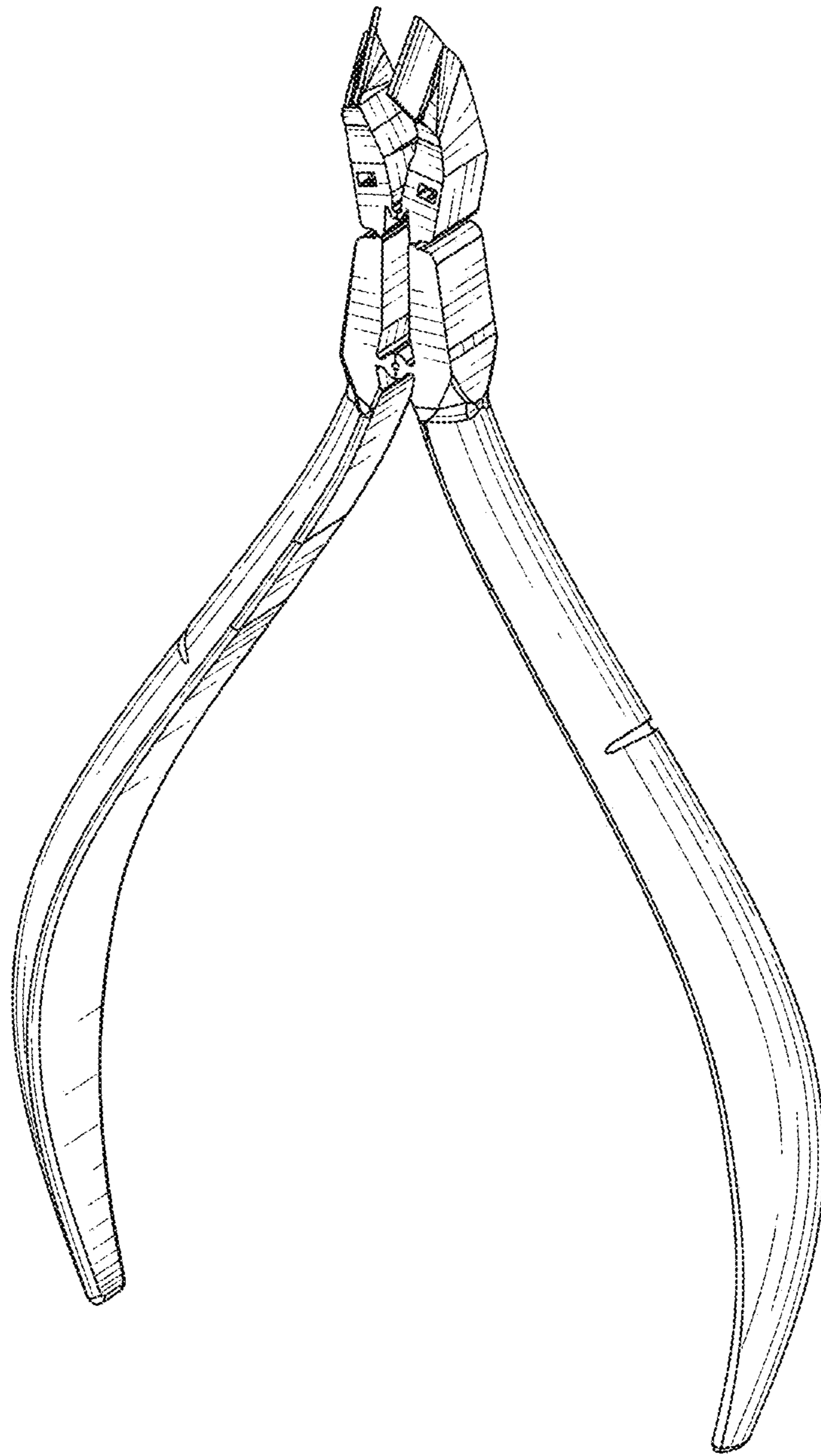

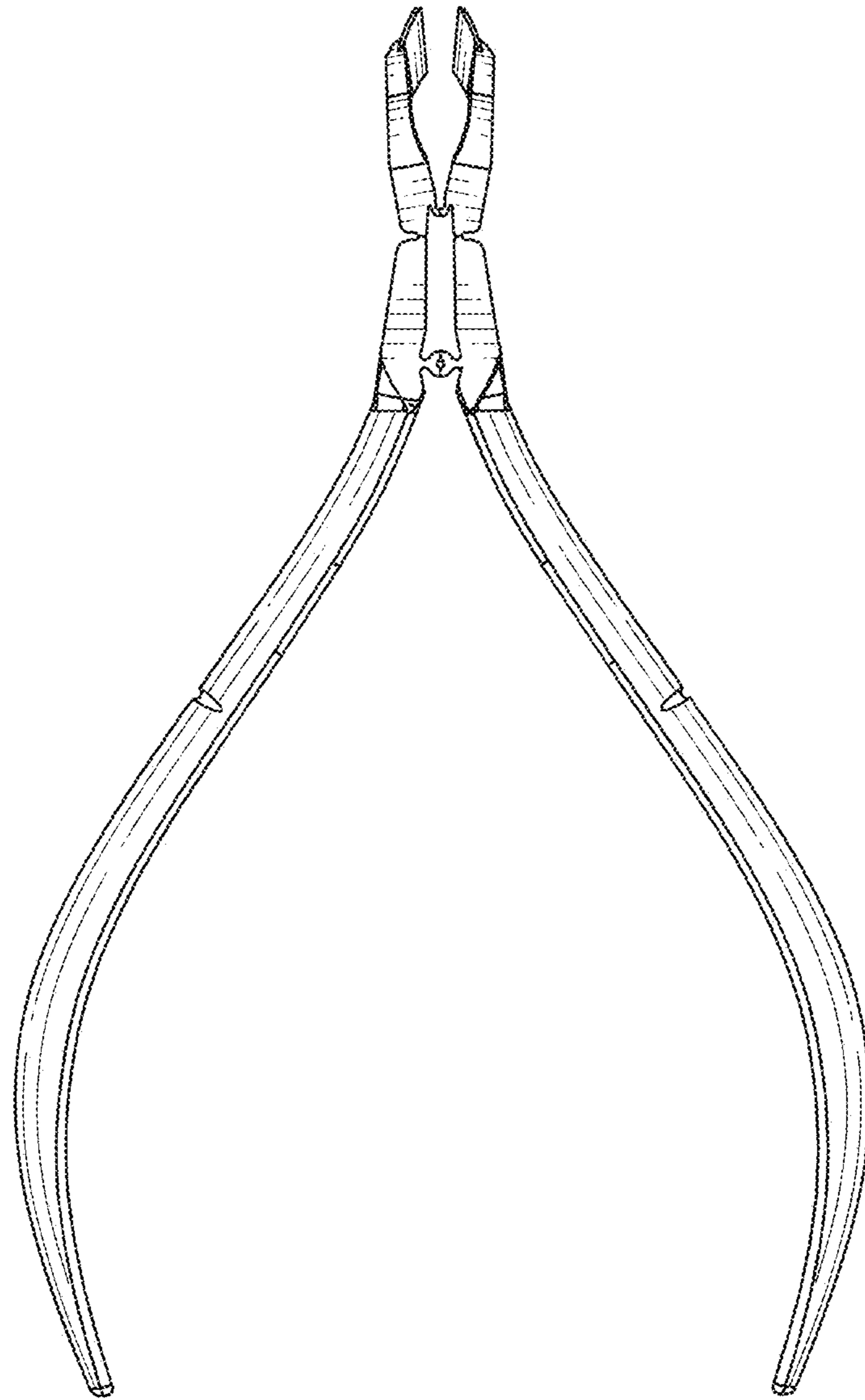

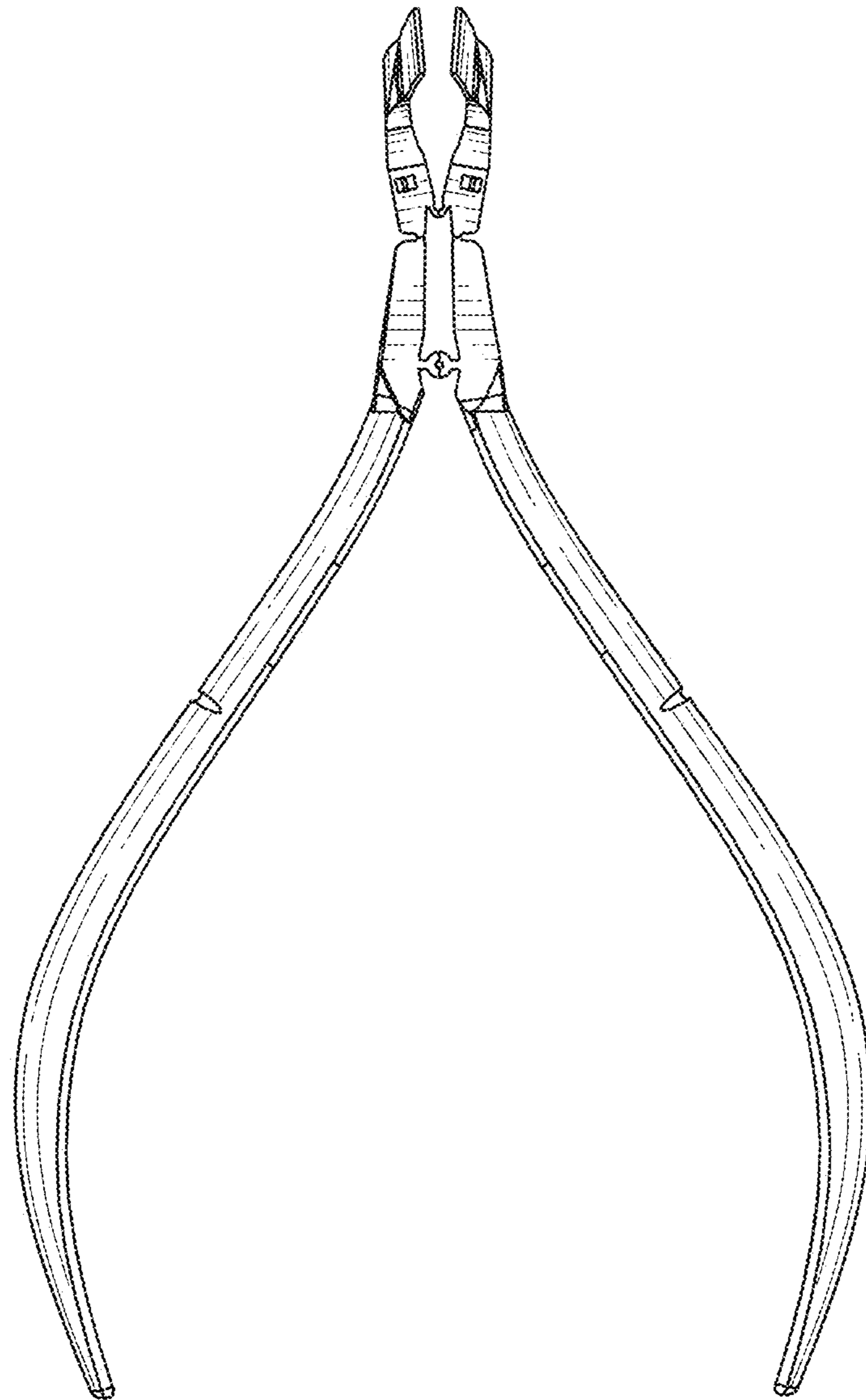

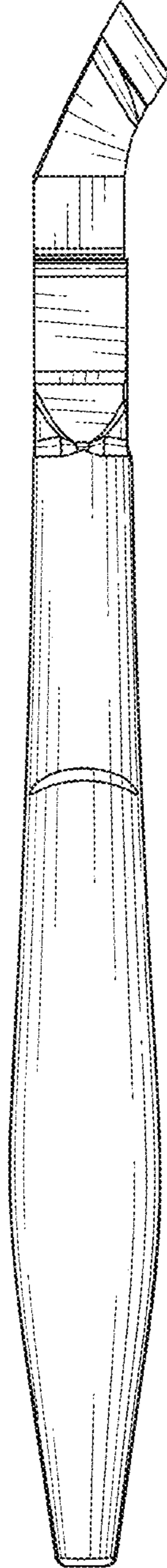

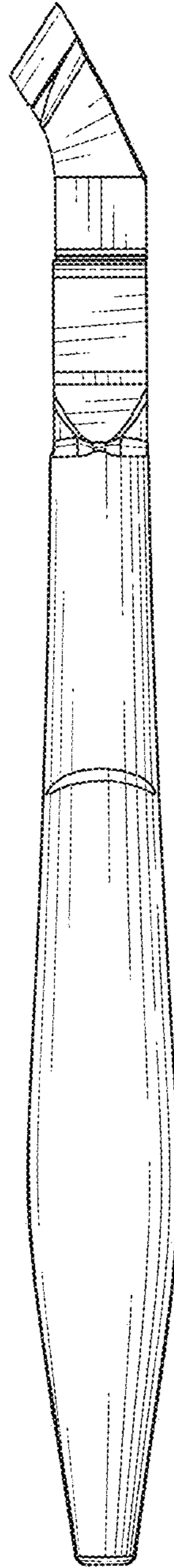

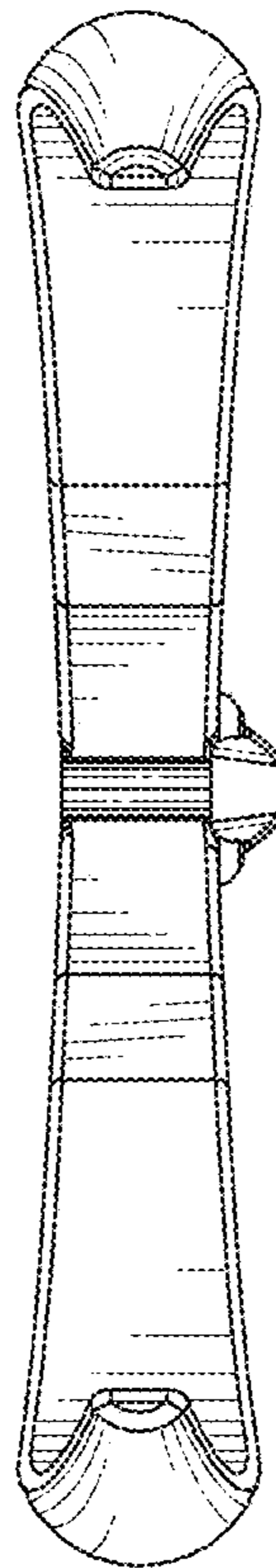

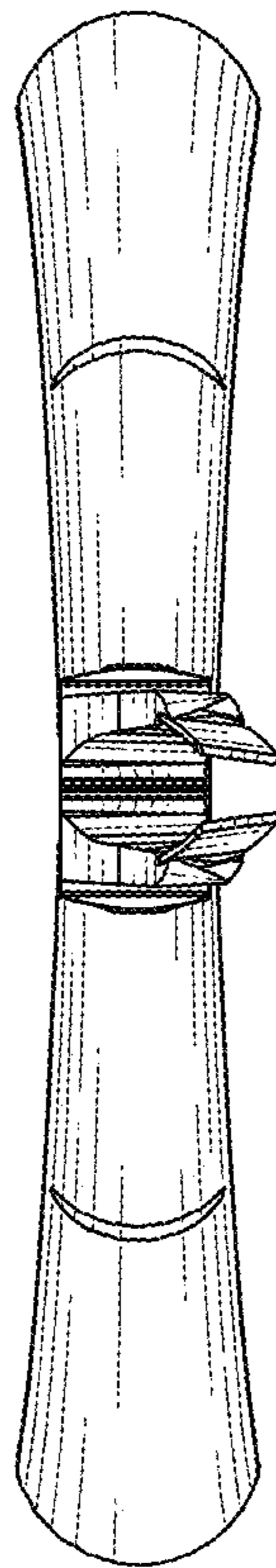
