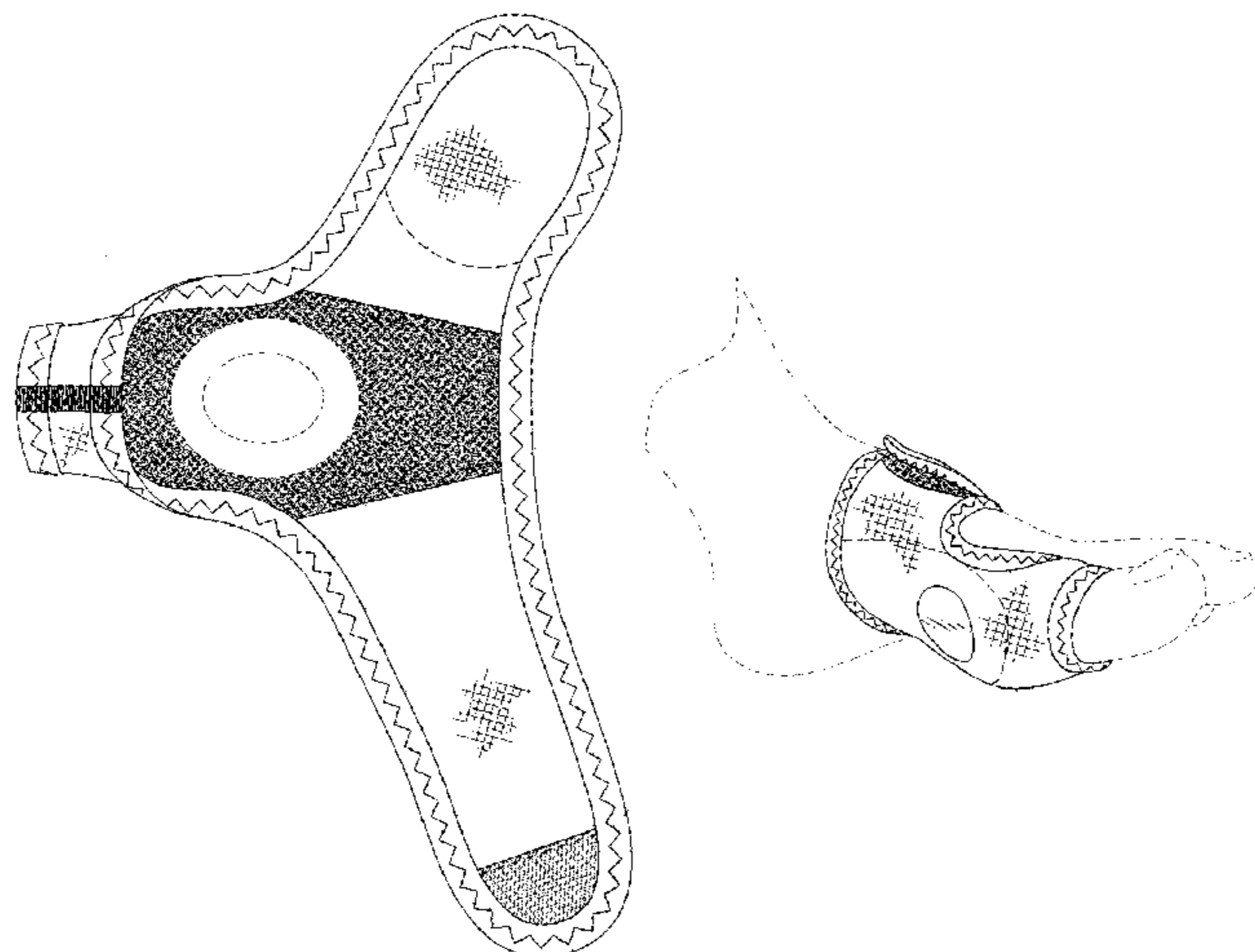
(57) **CLAIM**

The ornamental design for a customizable bunion splint, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the present design for a customizable bunion splint;
FIG. 2 is a bottom view of the customizable bunion splint of the design of FIG. 1;
FIG. 3 is a right side view of the customizable bunion splint of the design of FIG. 1;
FIG. 4 is a left view of the customizable bunion splint of the design of FIG. 1;

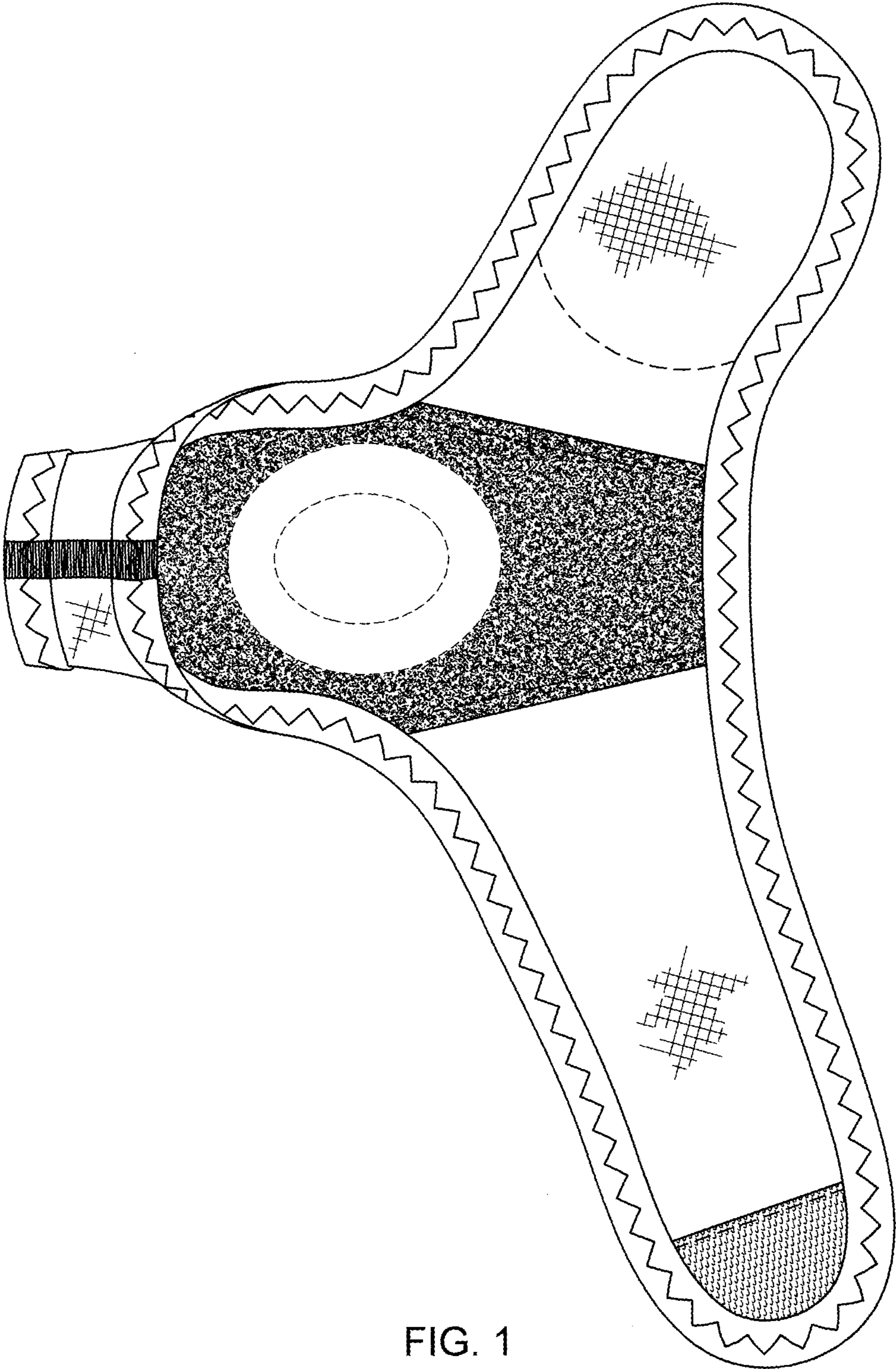

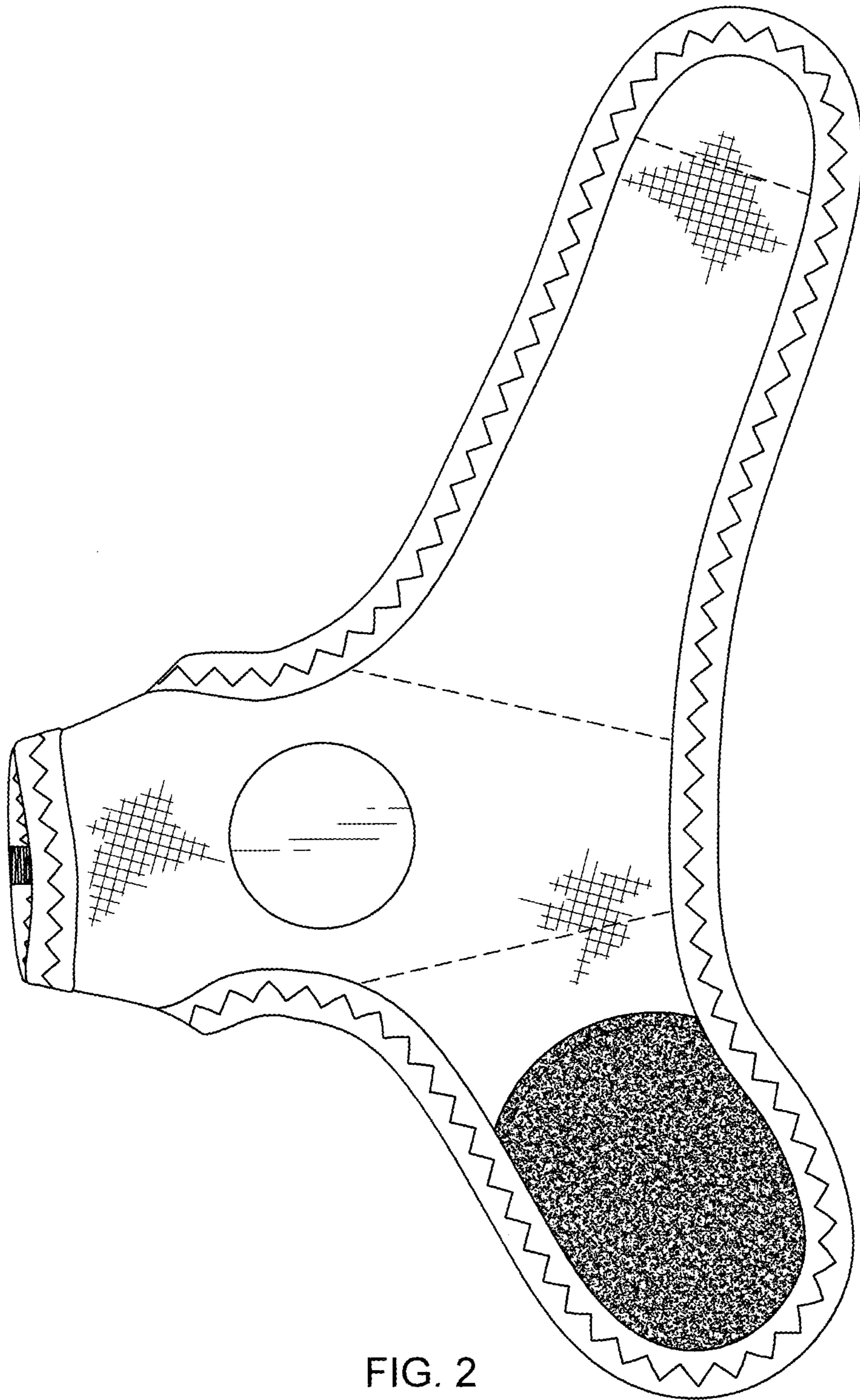

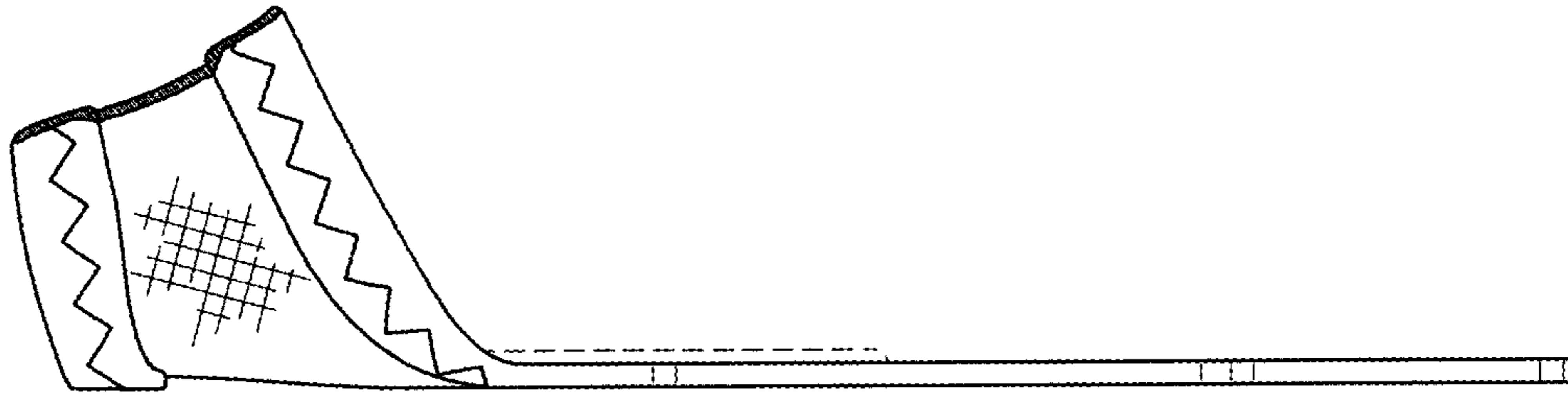

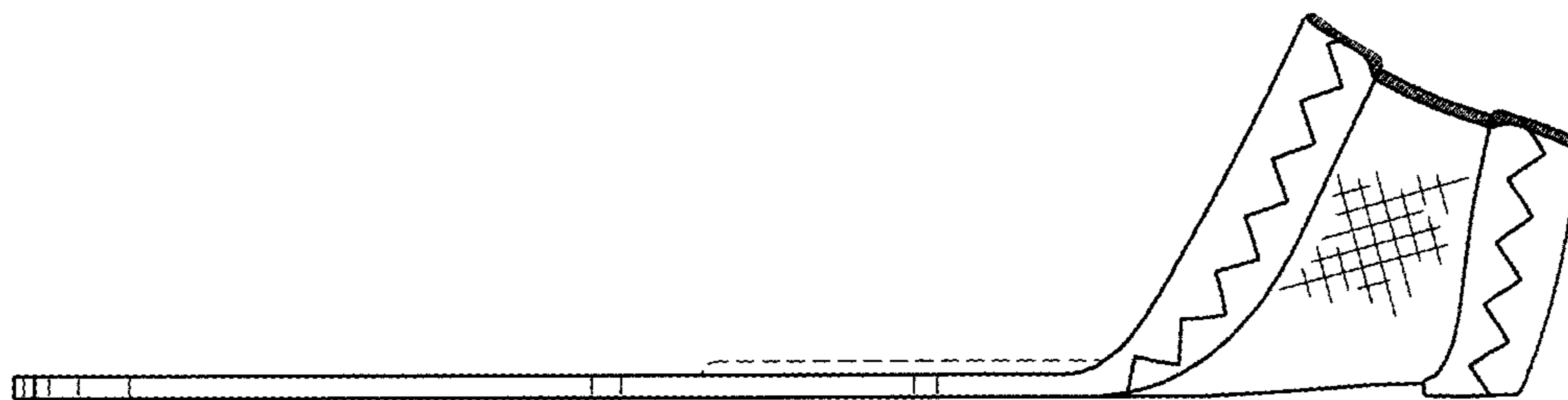

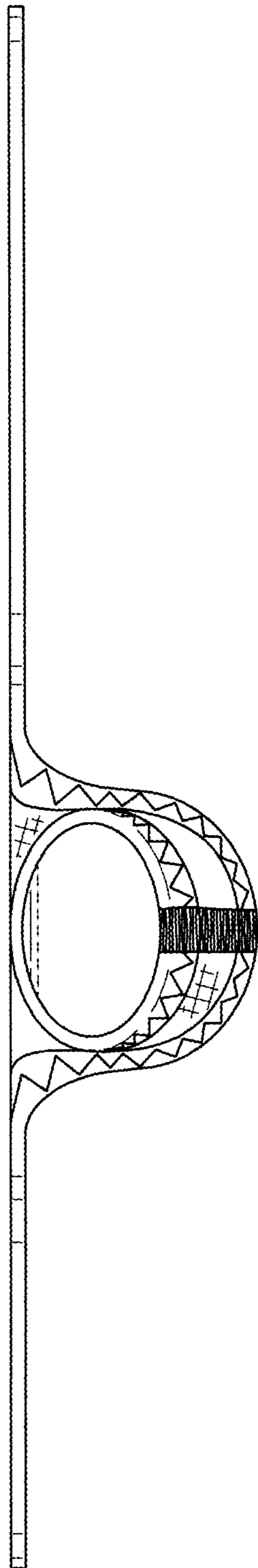

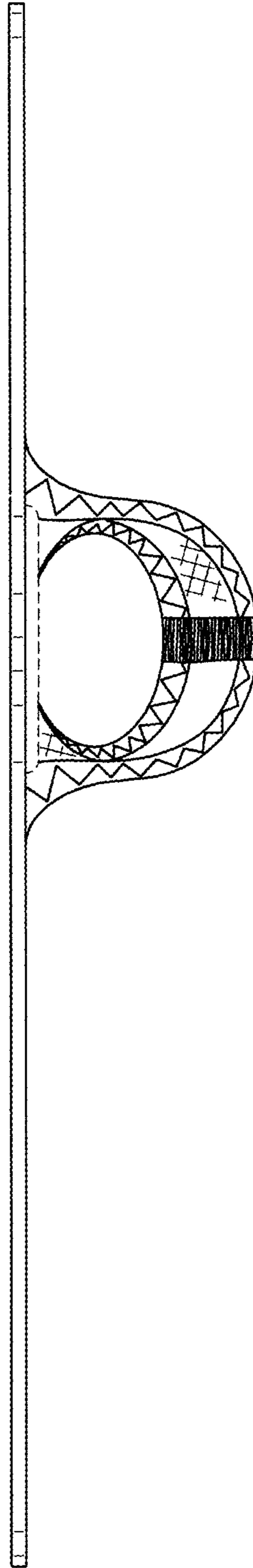

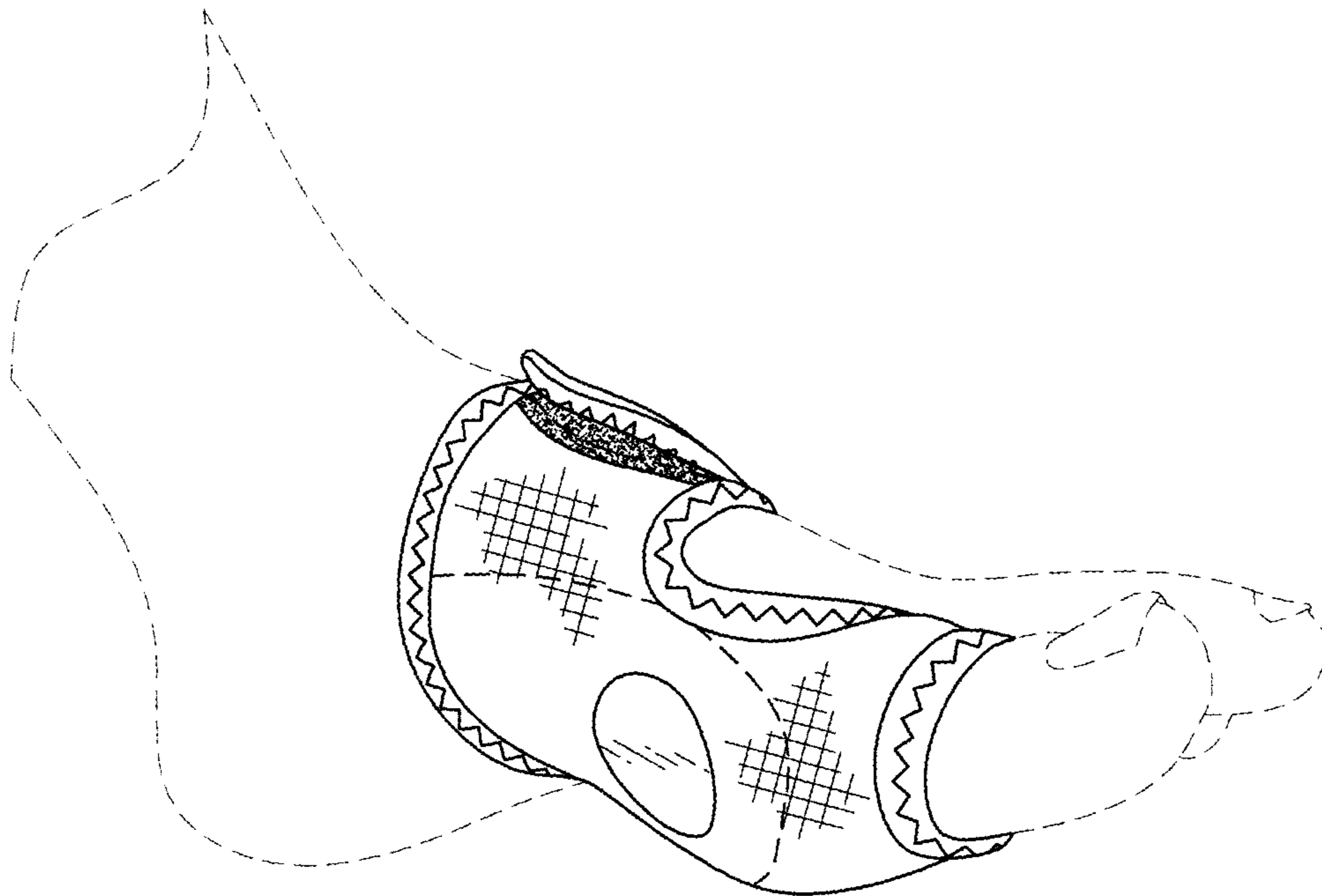
