The ornamental design for a roofing deck, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a roofing deck showing my new design in accordance with a first embodiment of the present invention;

FIG. 2 is a rear view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a lower right front perspective view thereof;

FIG. 8 is a lower right front perspective view of the roofing deck of FIG. 1, show in an alternate configuration;

FIG. 9 is a front view of a roofing deck showing my new design in accordance with a second embodiment of the present invention;

FIG. 10 is a rear view thereof;

FIG. 11 is a right side view thereof;

FIG. 12 is a left side view thereof;

FIG. 13 is a bottom view thereof;

FIG. 14 is a top view thereof;

FIG. 15 is a lower right front perspective view thereof;

FIG. 20 is a bottom view thereof;

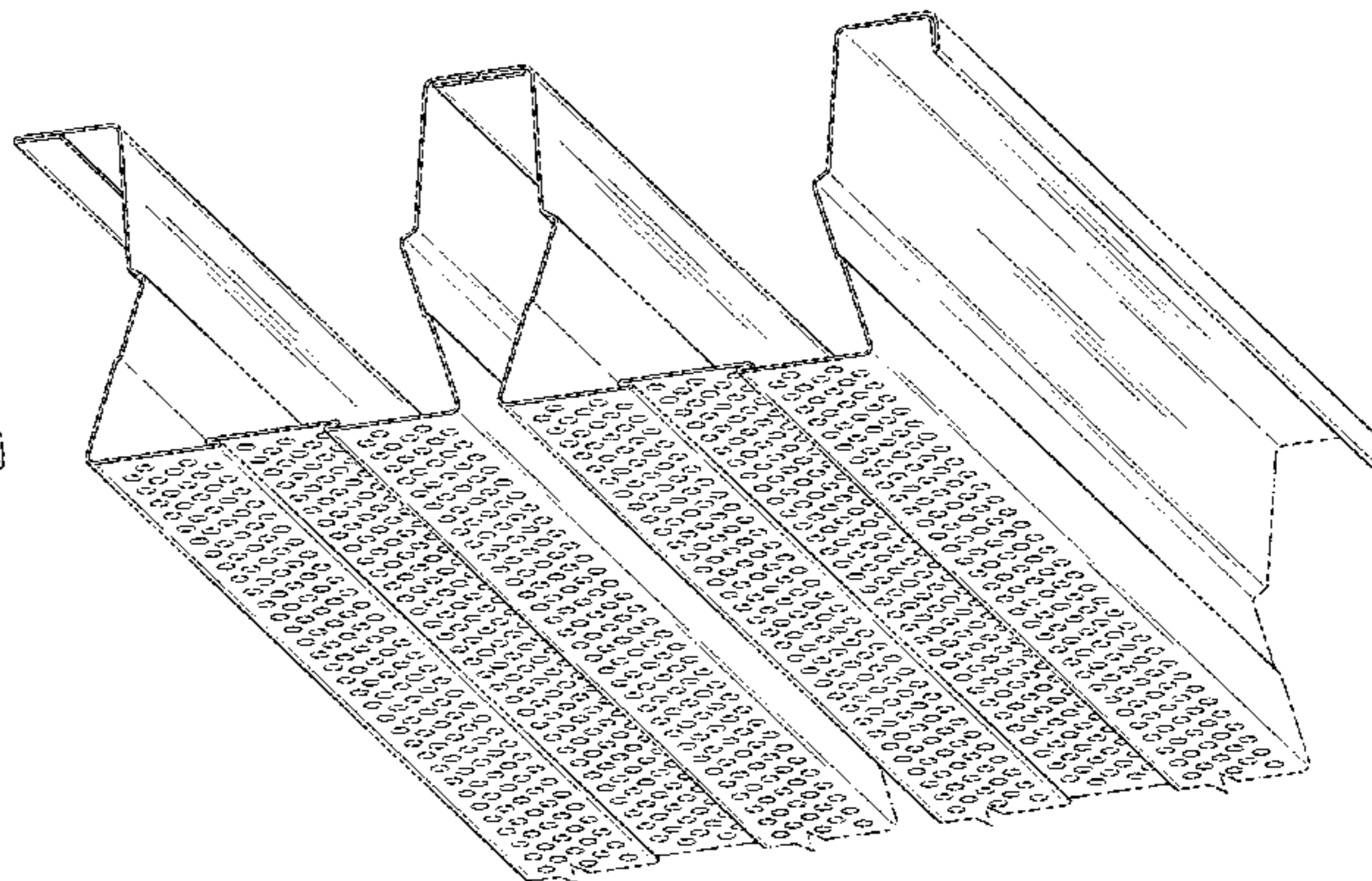
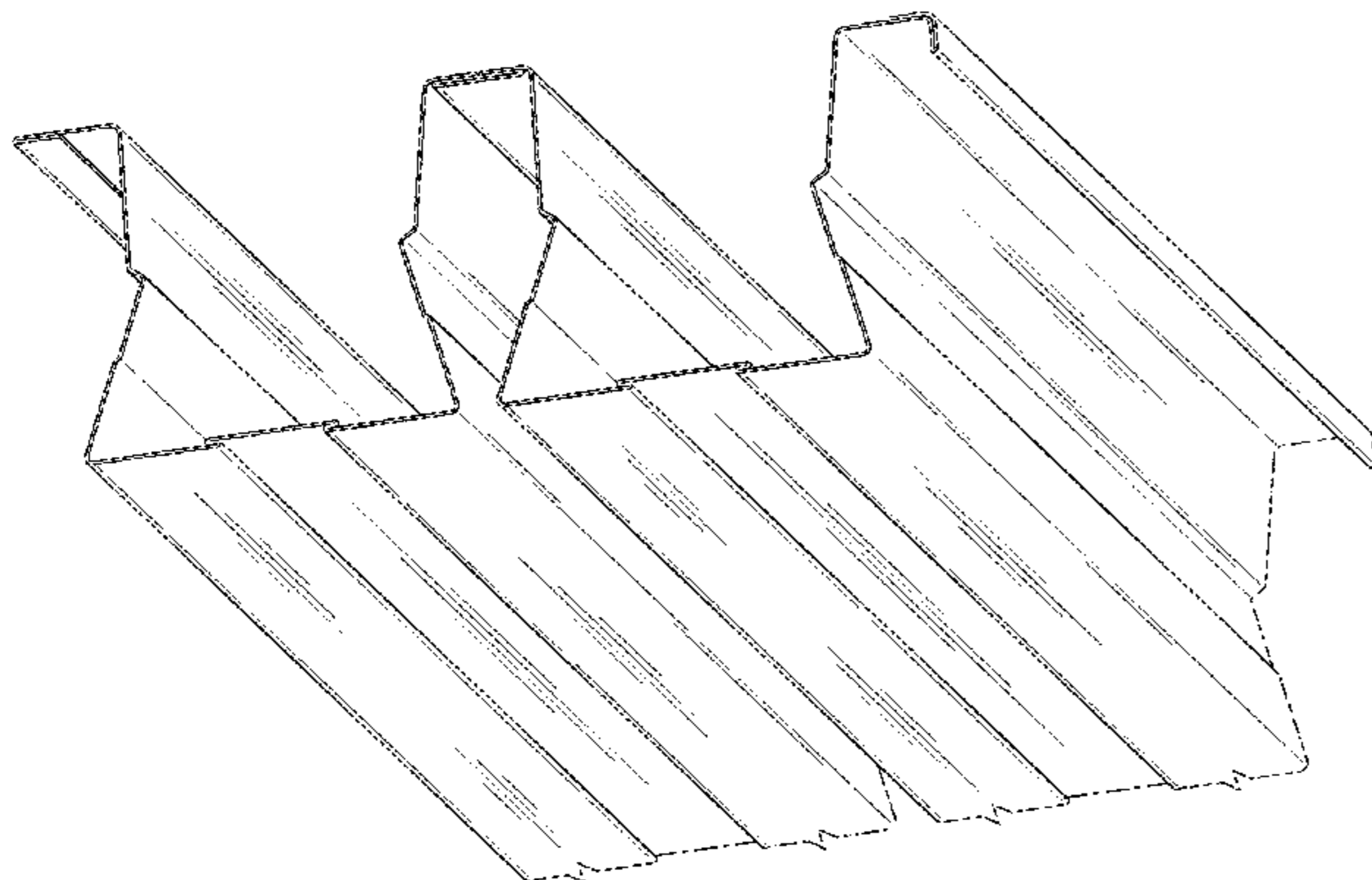
FIG. 21 is a top view thereof;

The broken line showings of FIGS. 9-15 represent portions of the roofing deck that form no part of the claimed design. In FIGS. 3-8, 11-15, and 18-23, the roofing deck is shown with a symbolic break in its length, the appearance of any portion of the roofing deck extending beyond the symbolic break forming no part of the claimed design. The other broken lines in FIGS. 8 and 23 showing a roofing deck assembly represent environmental subject matter only and form no part of the claimed design.

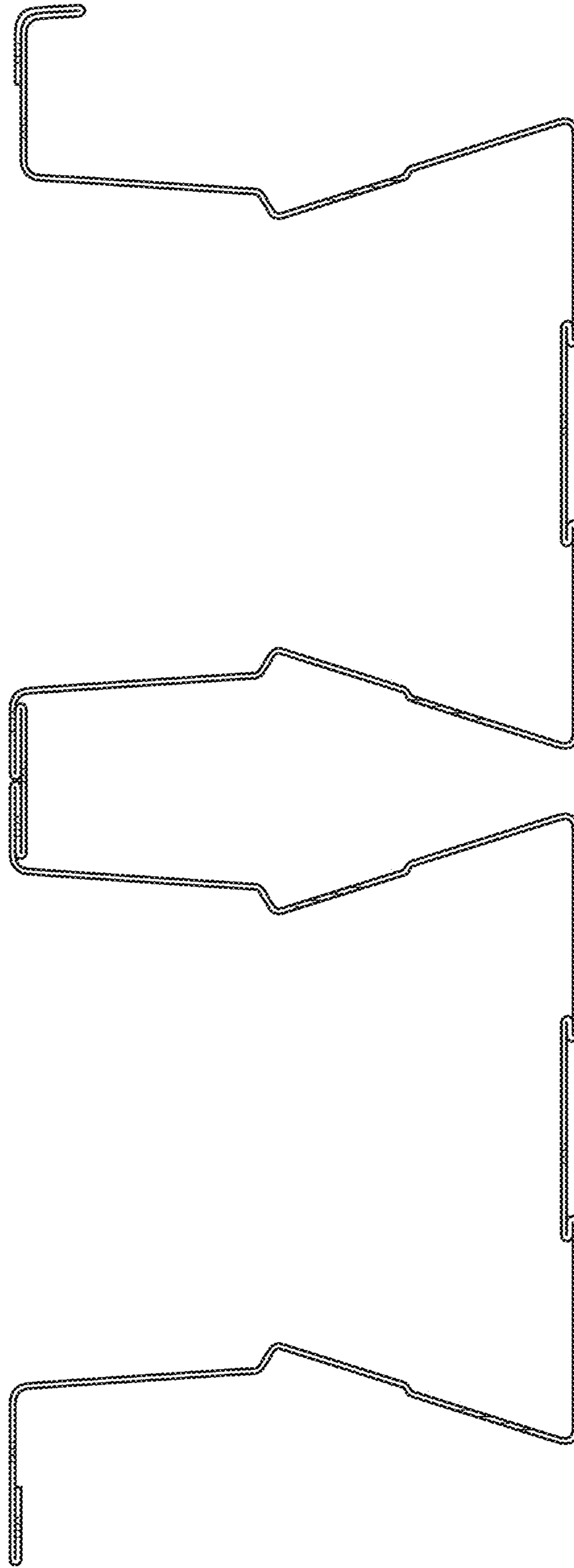

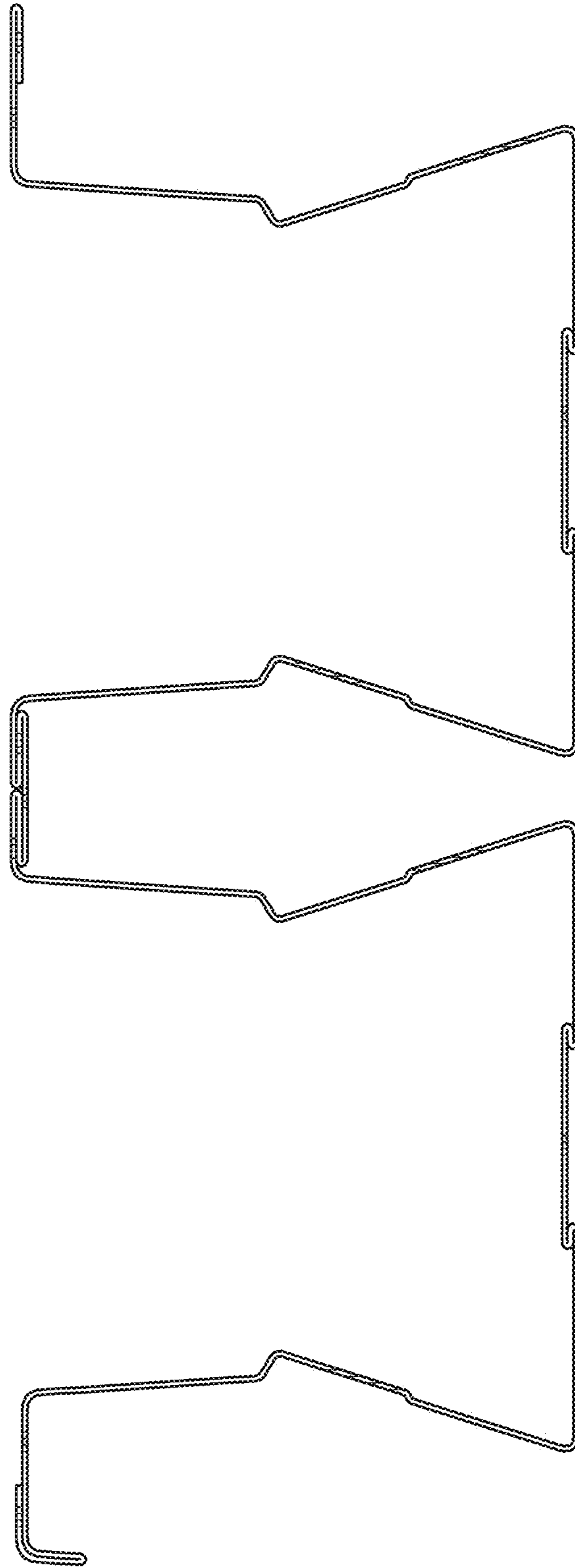

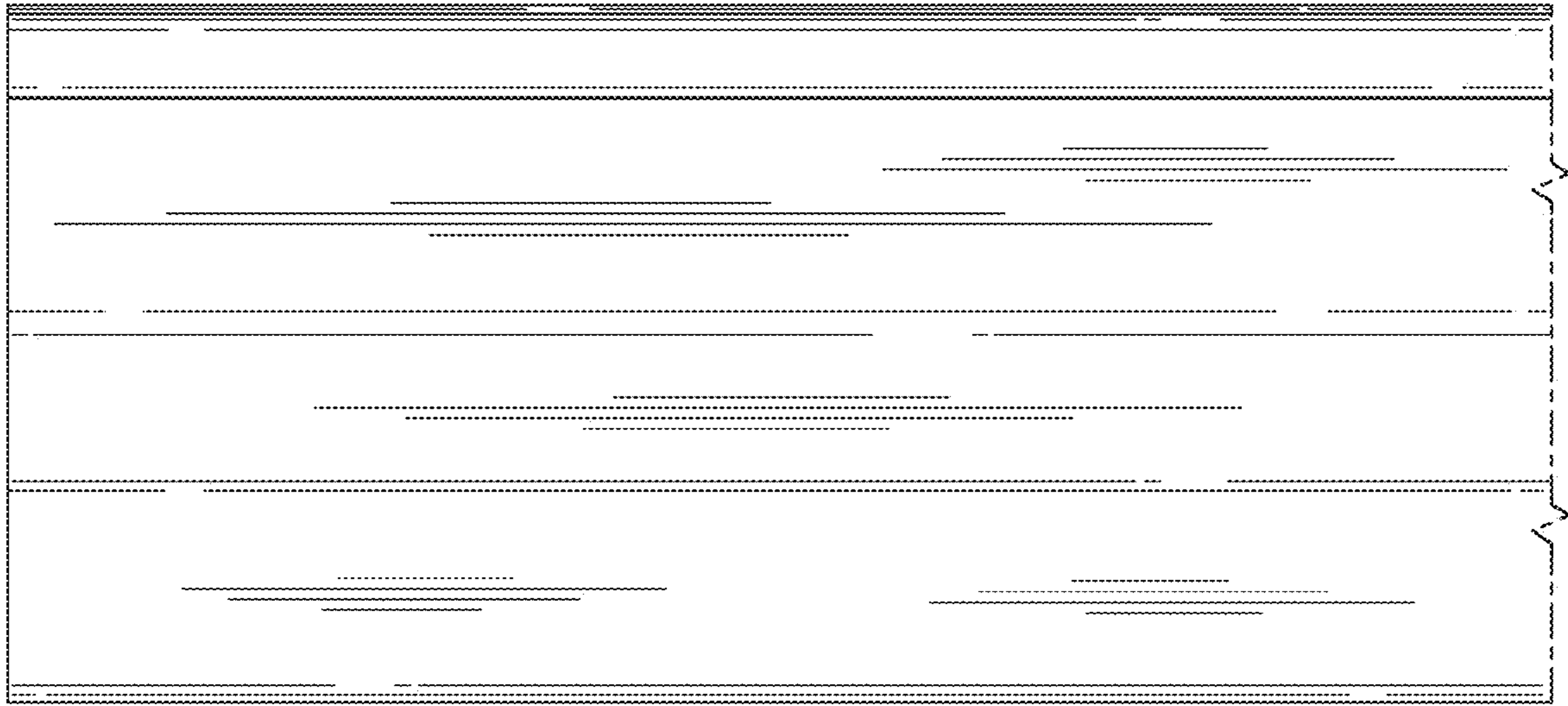

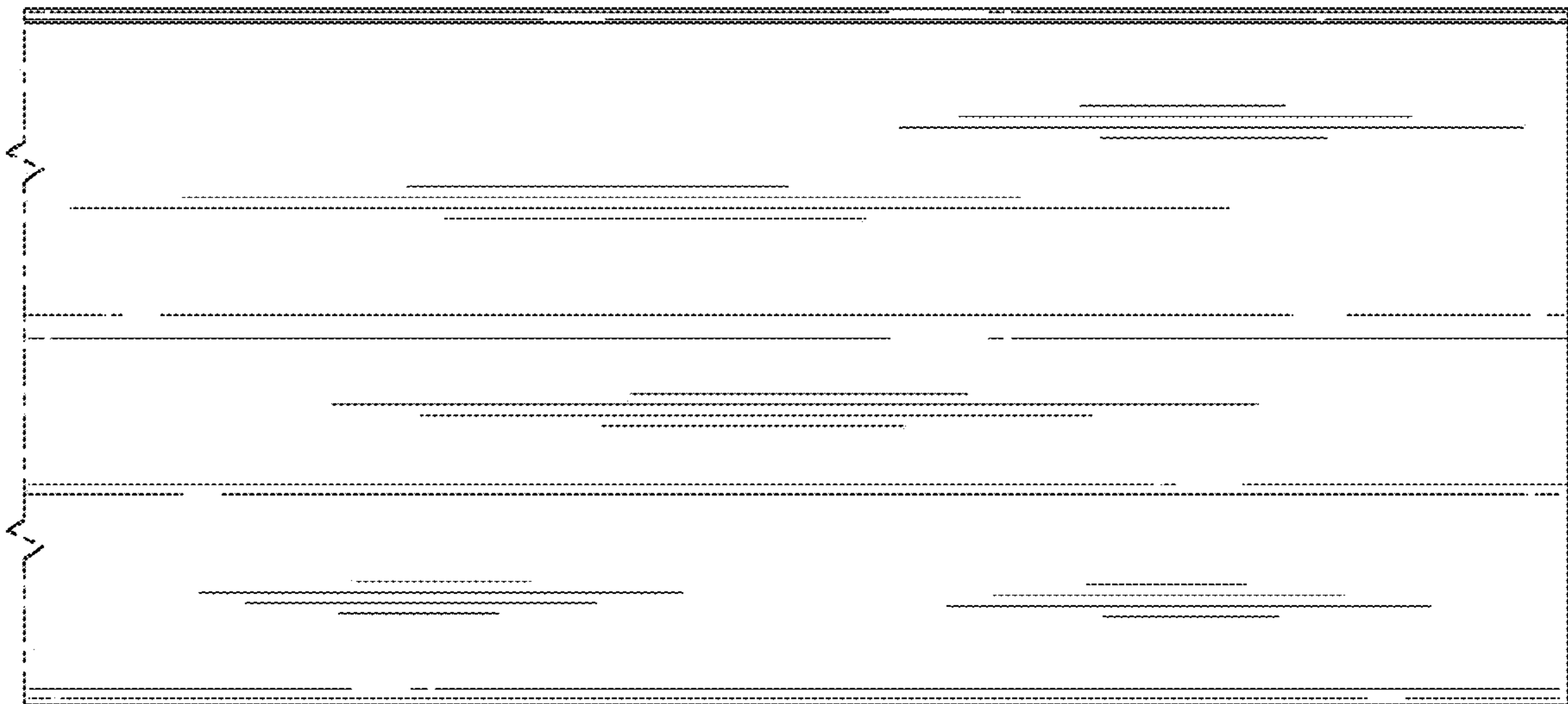

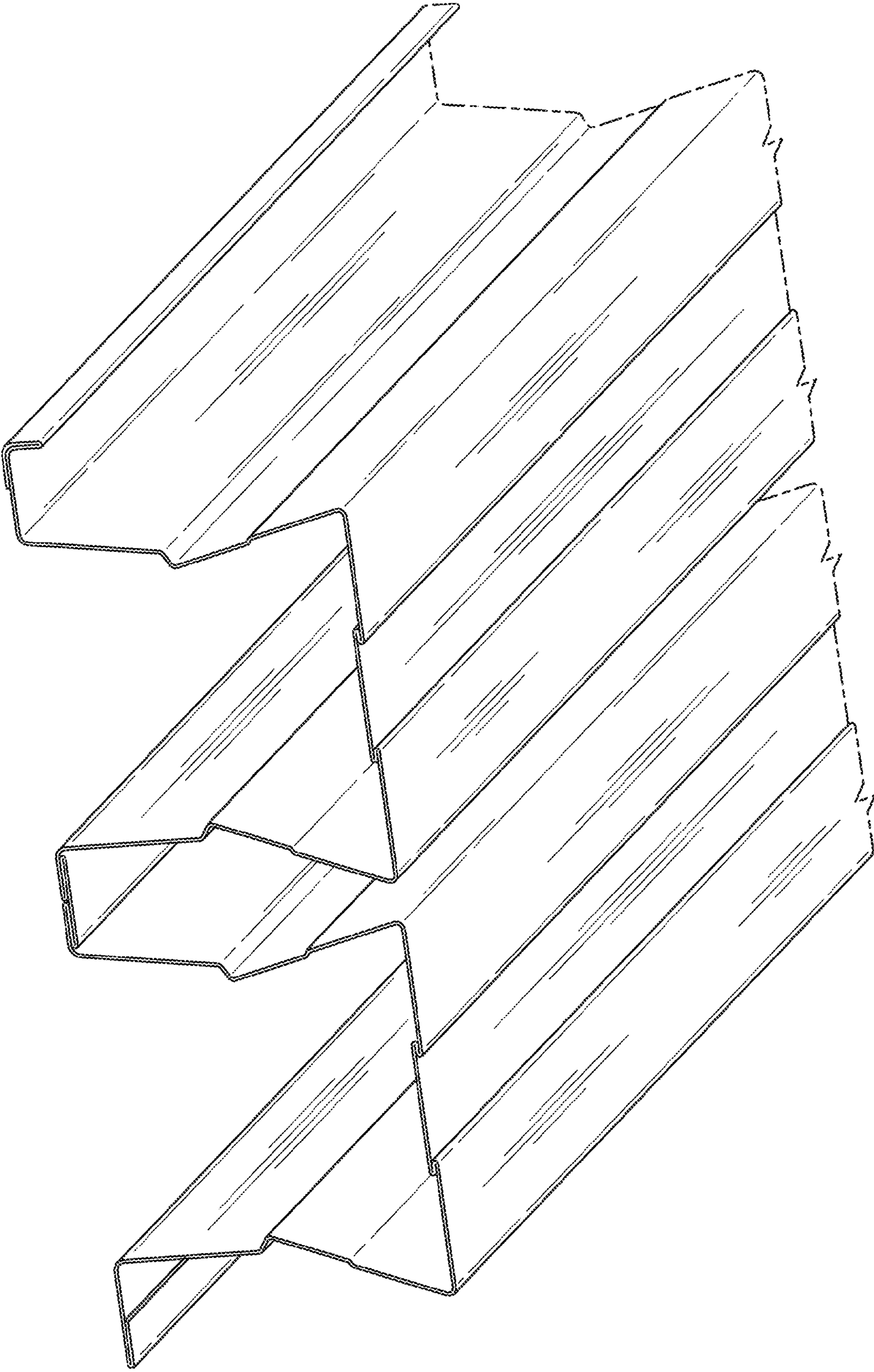

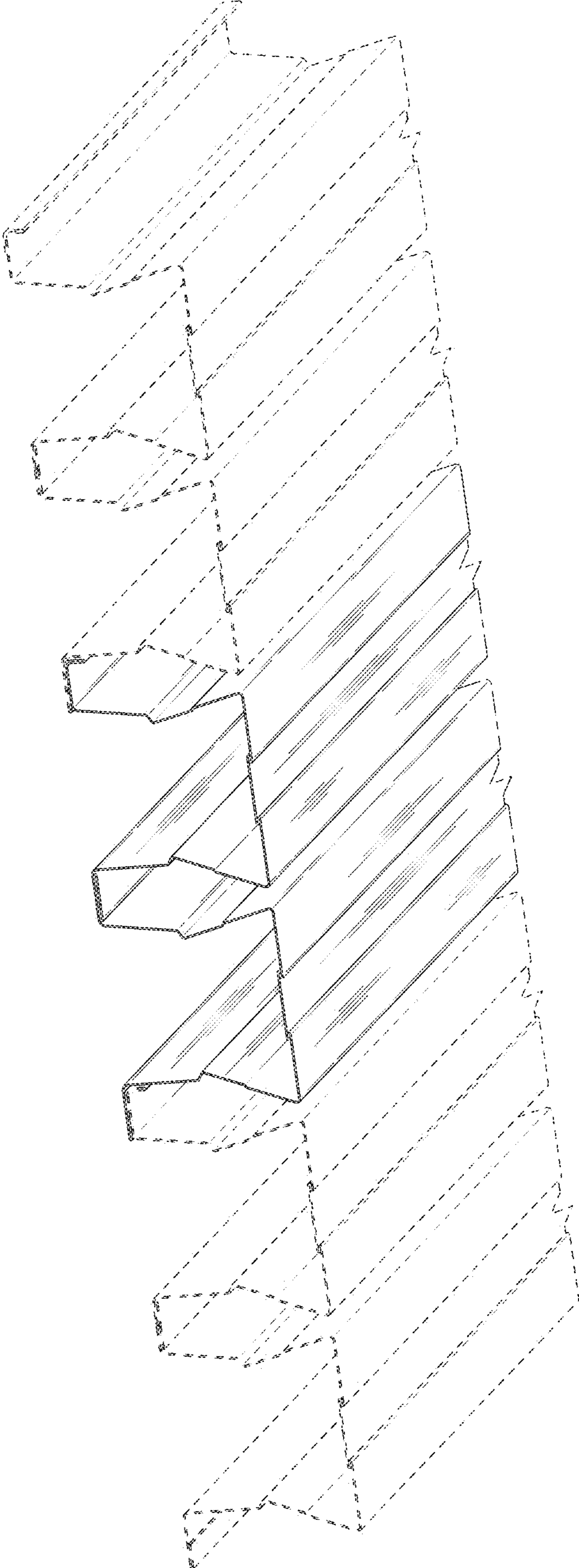

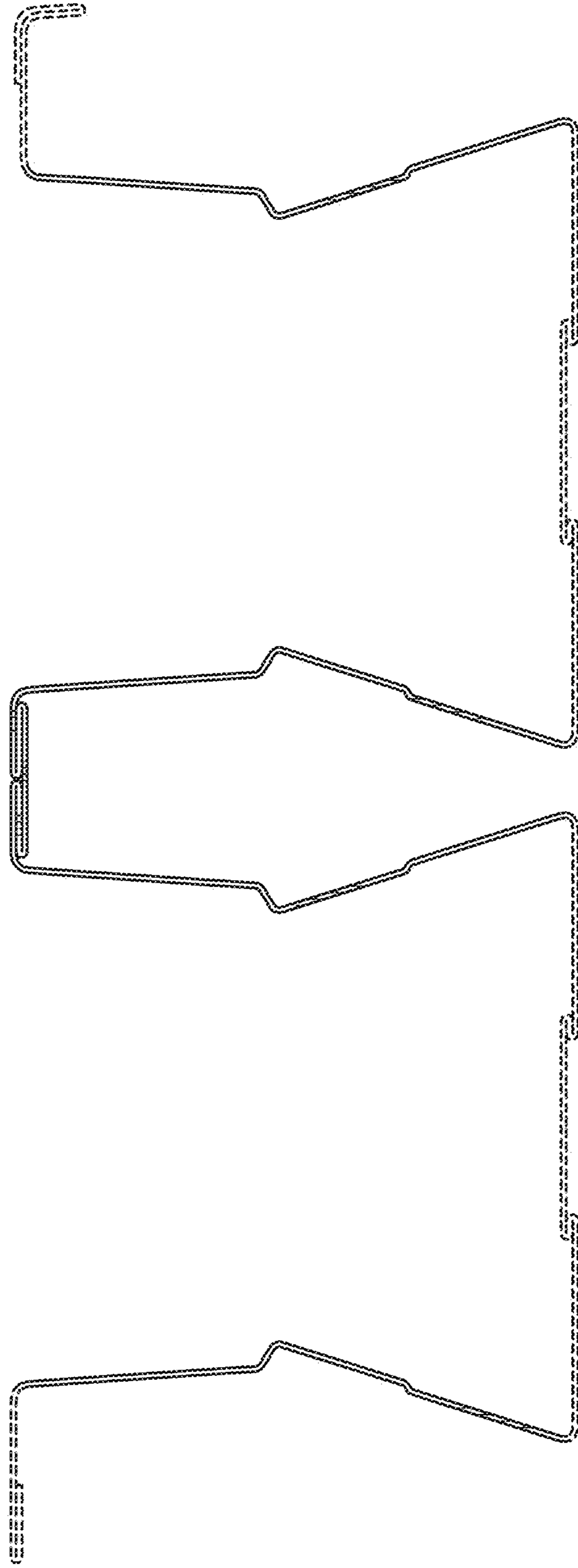

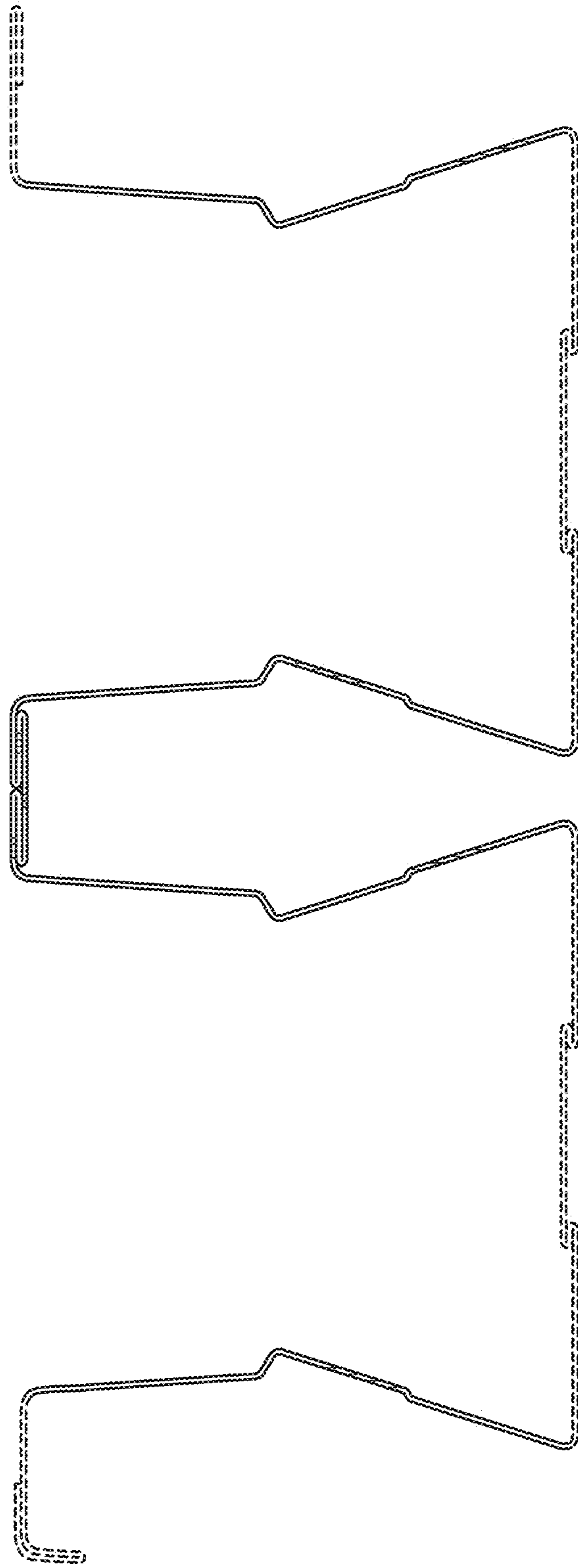

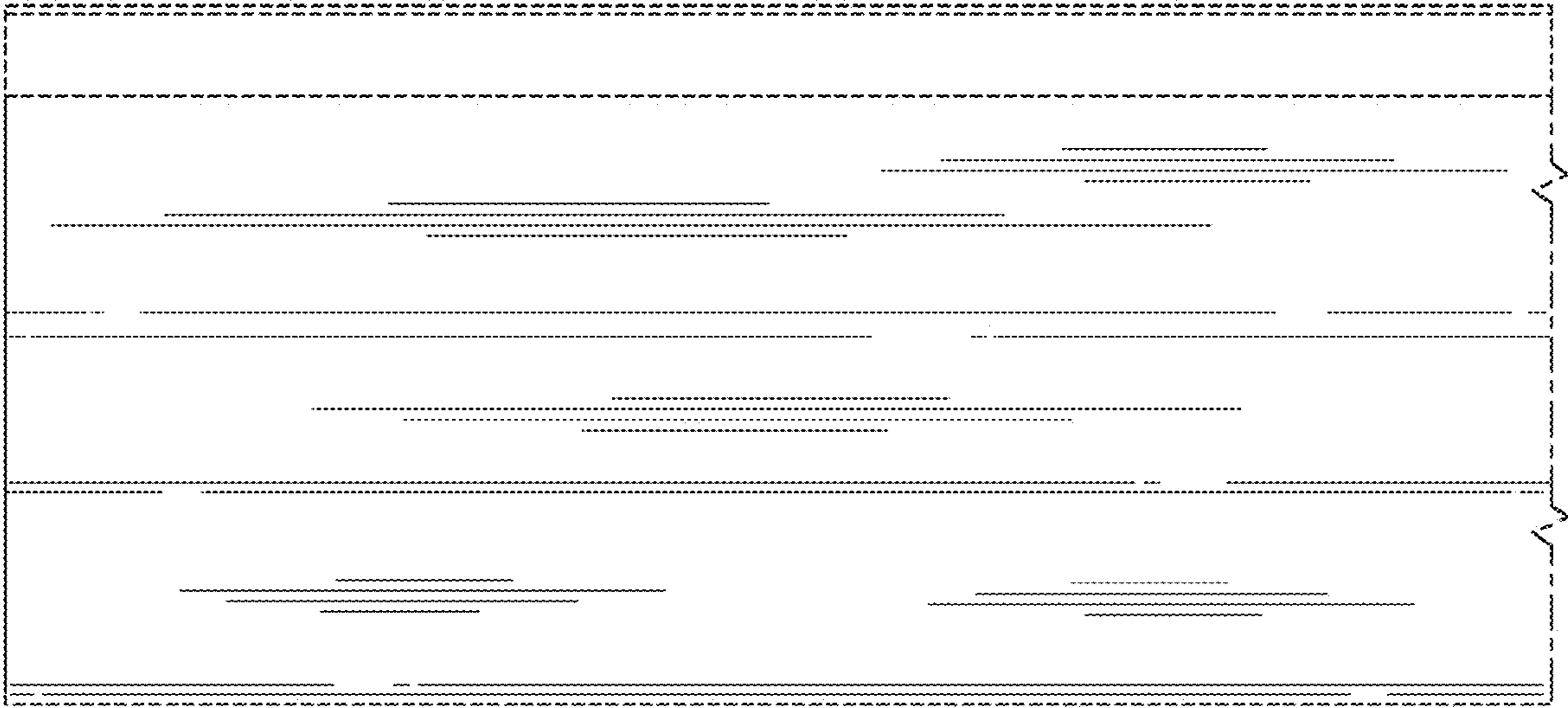

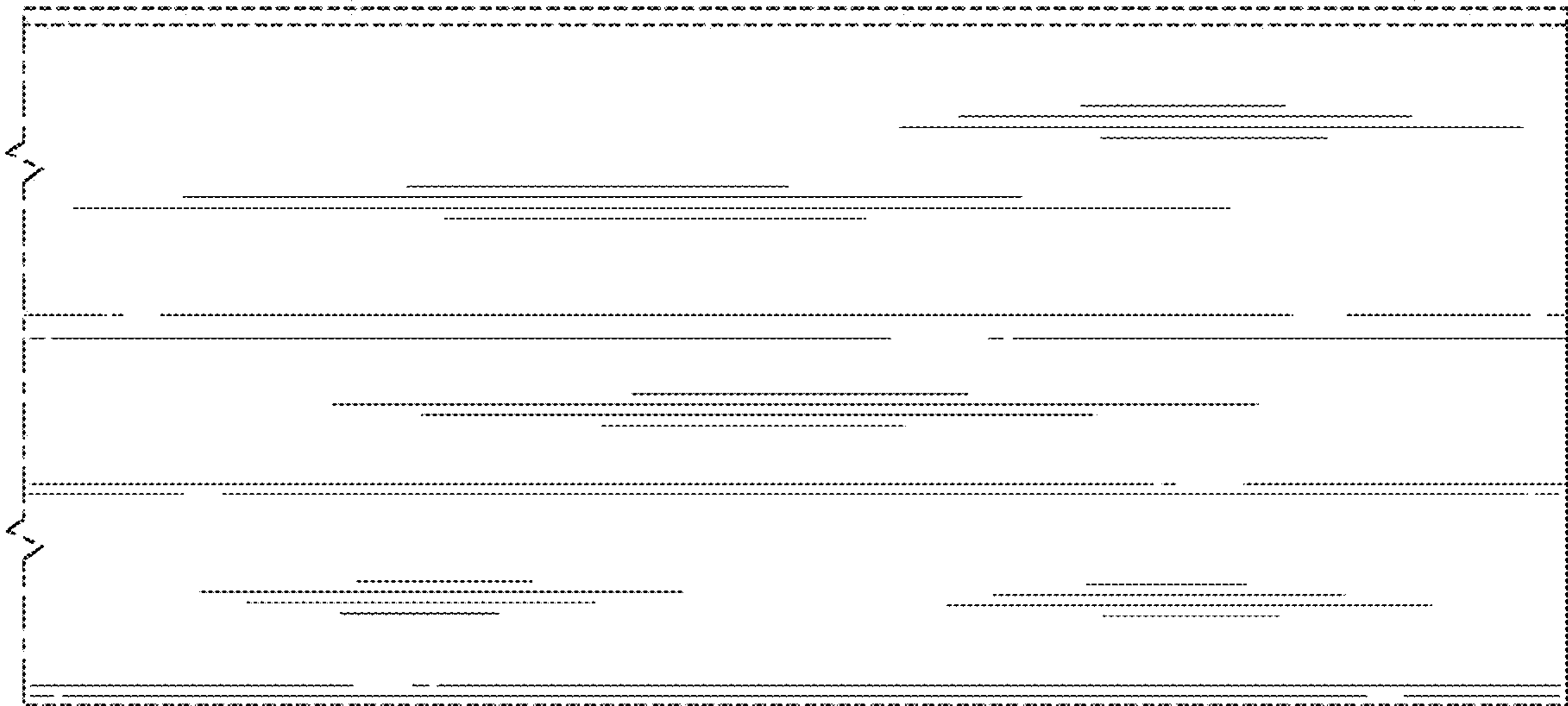

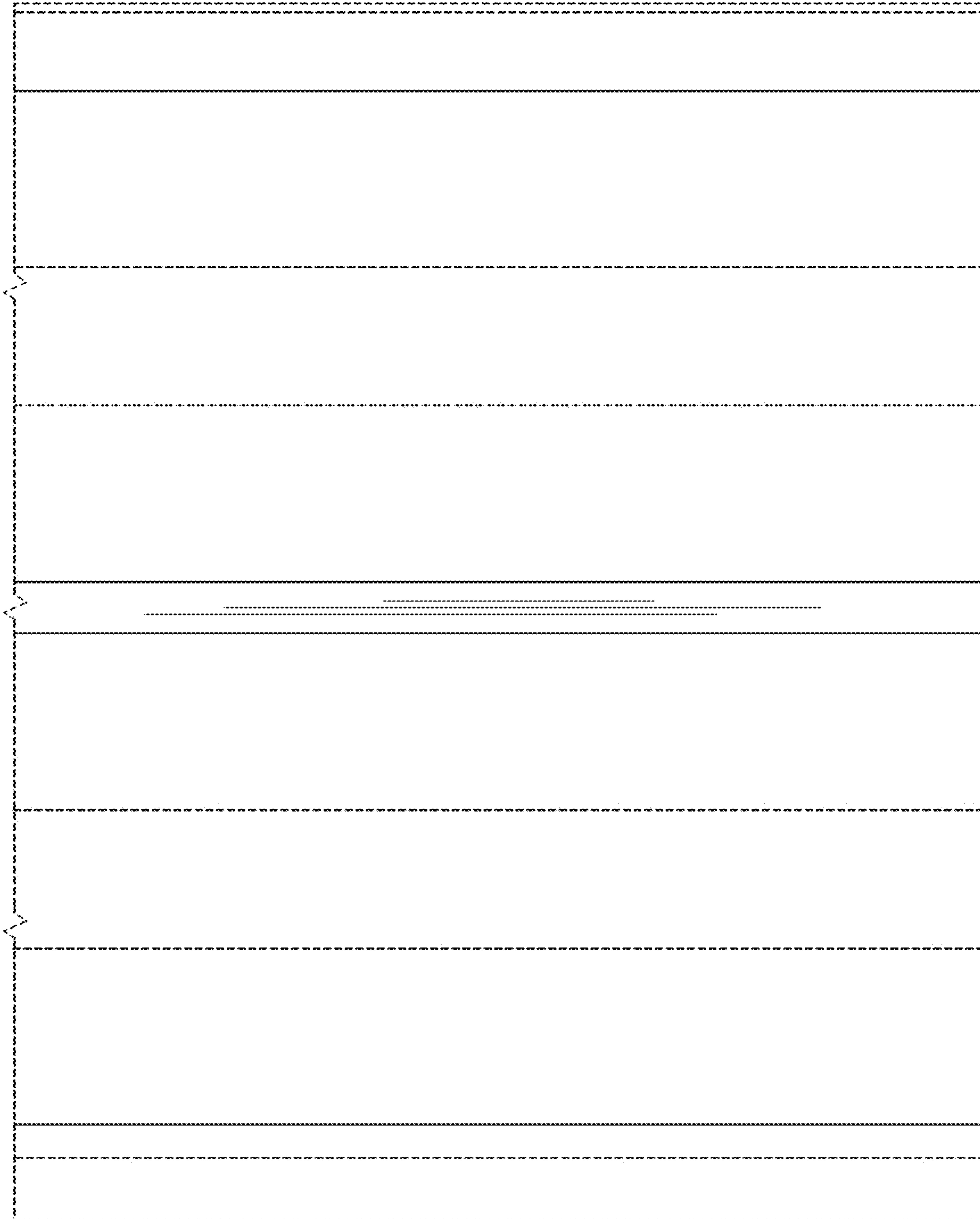

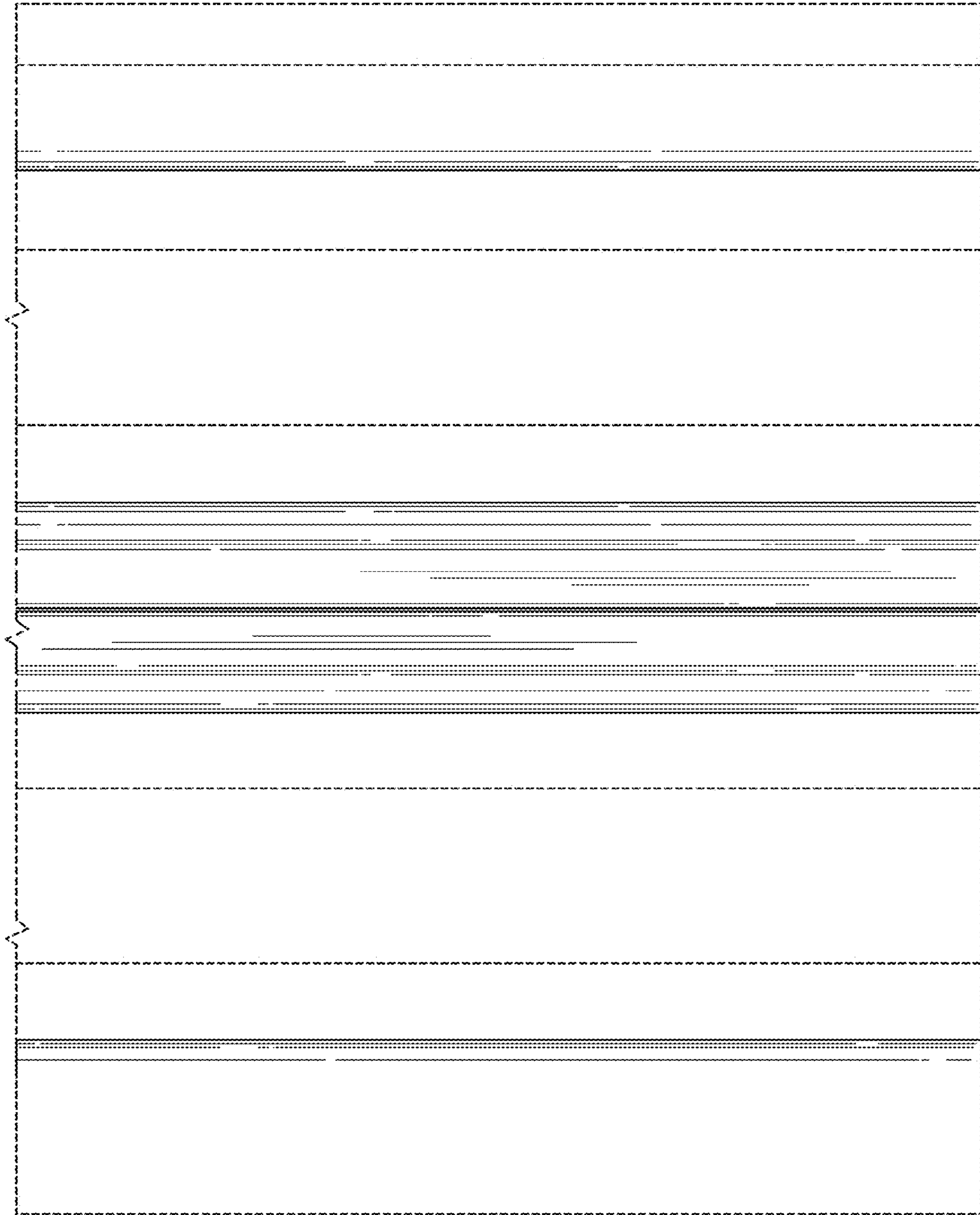

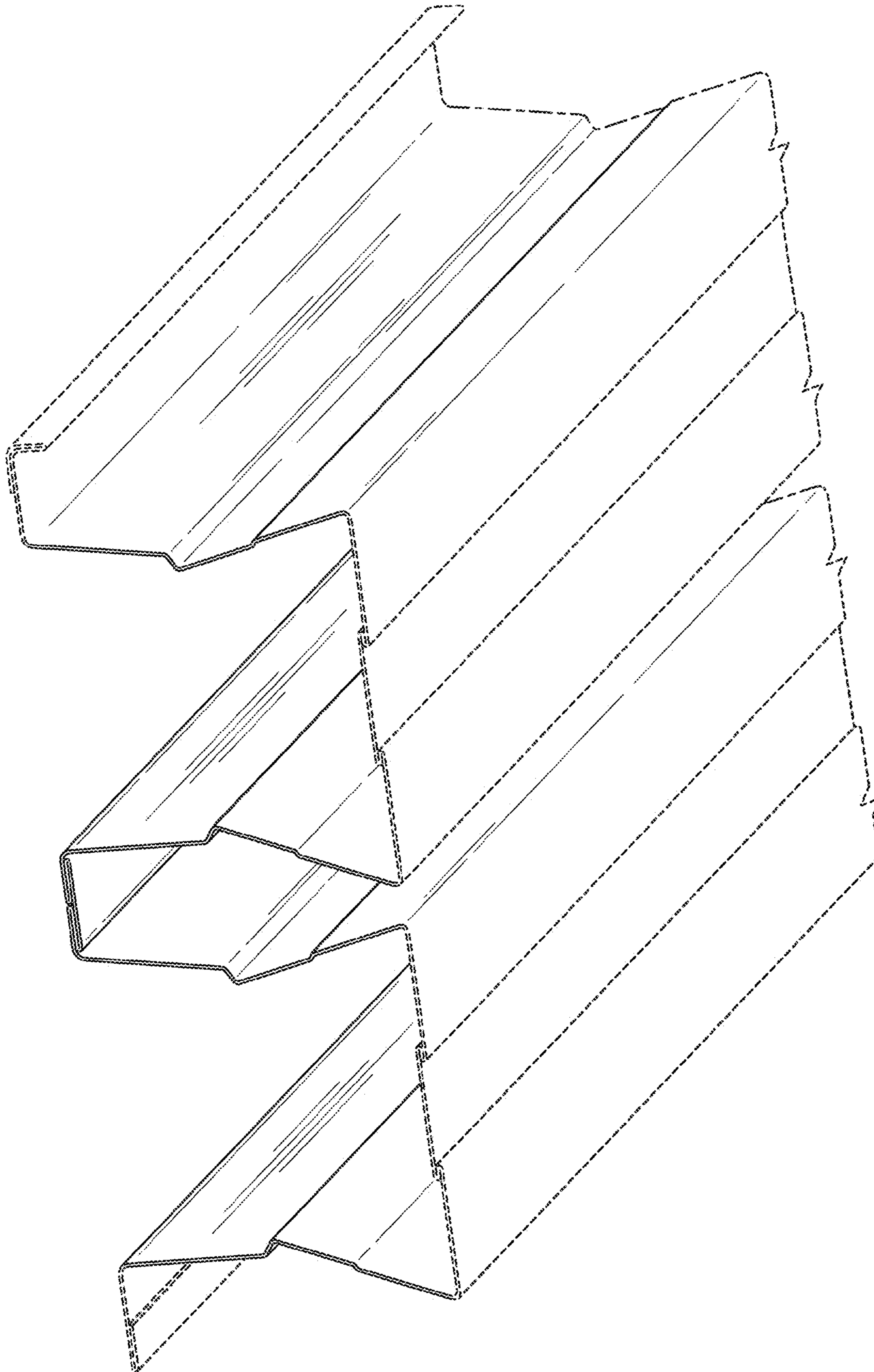

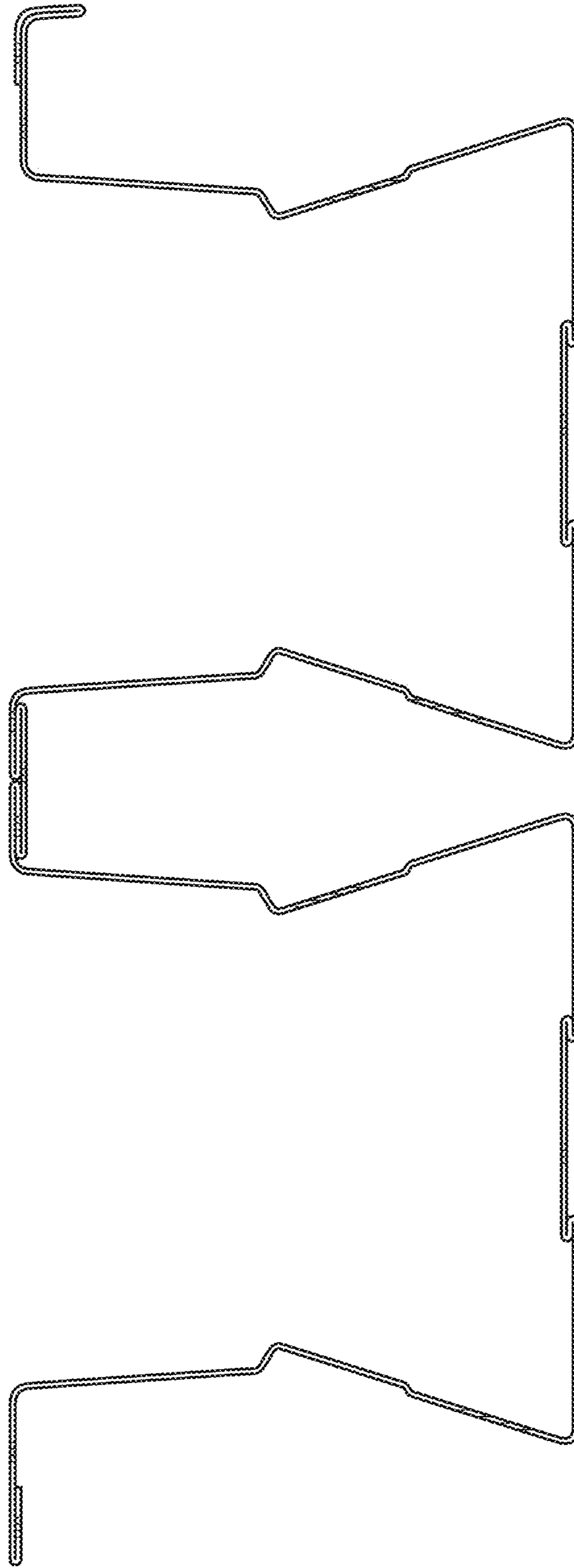

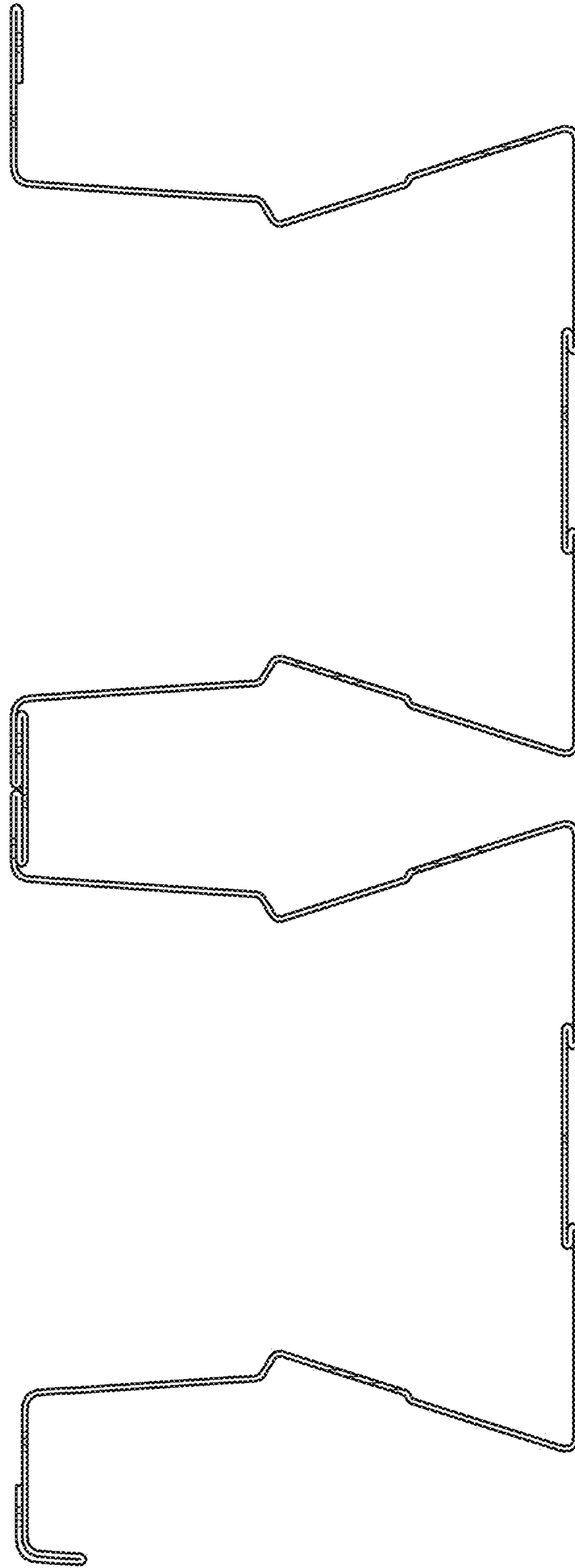

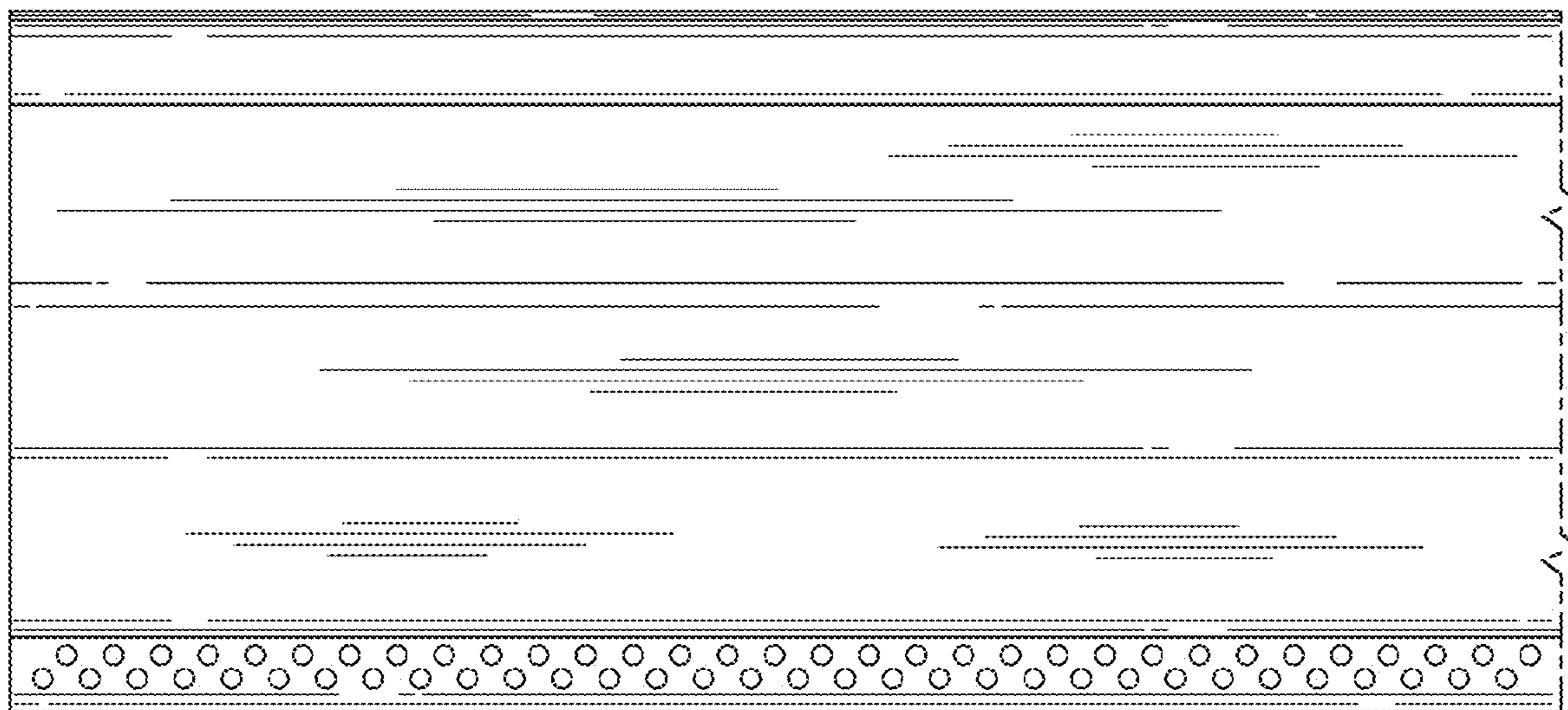

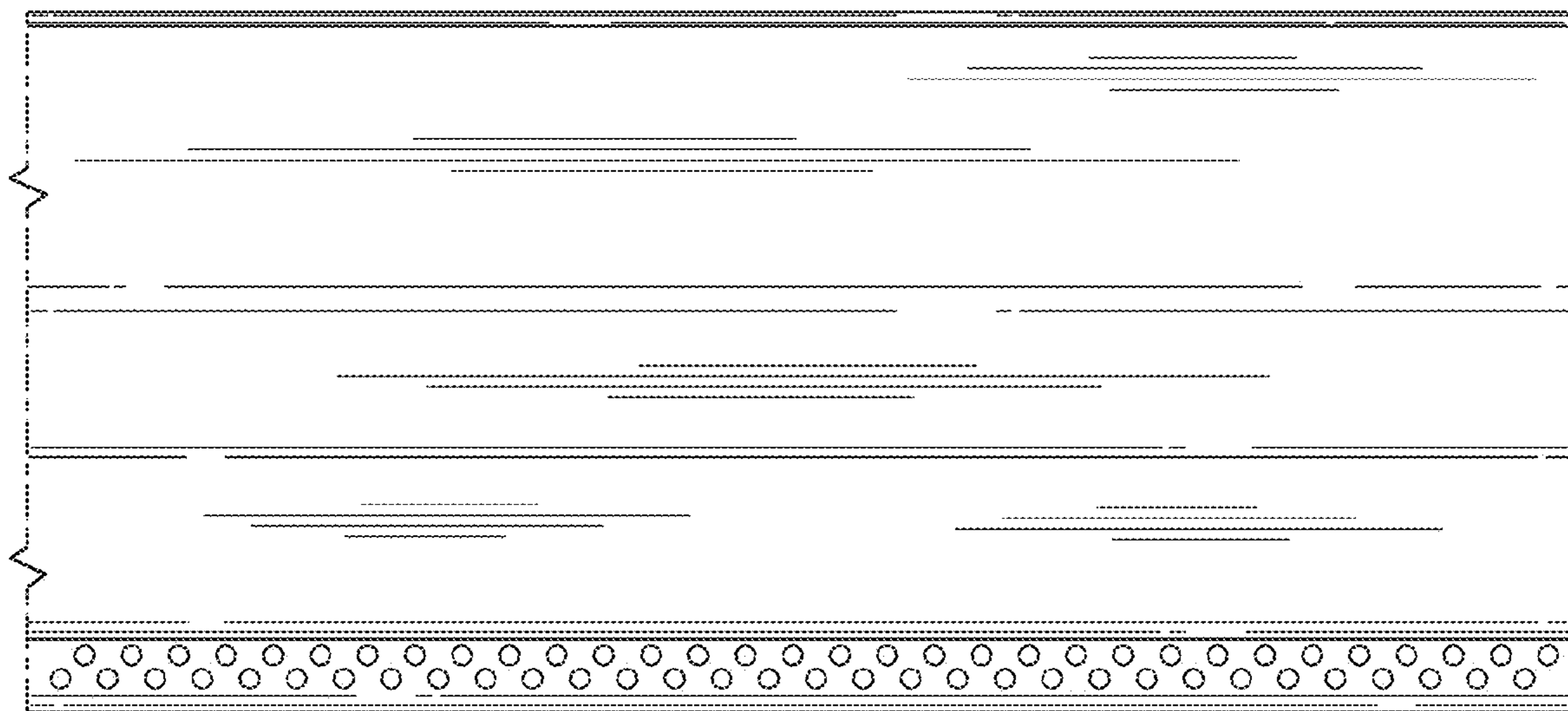

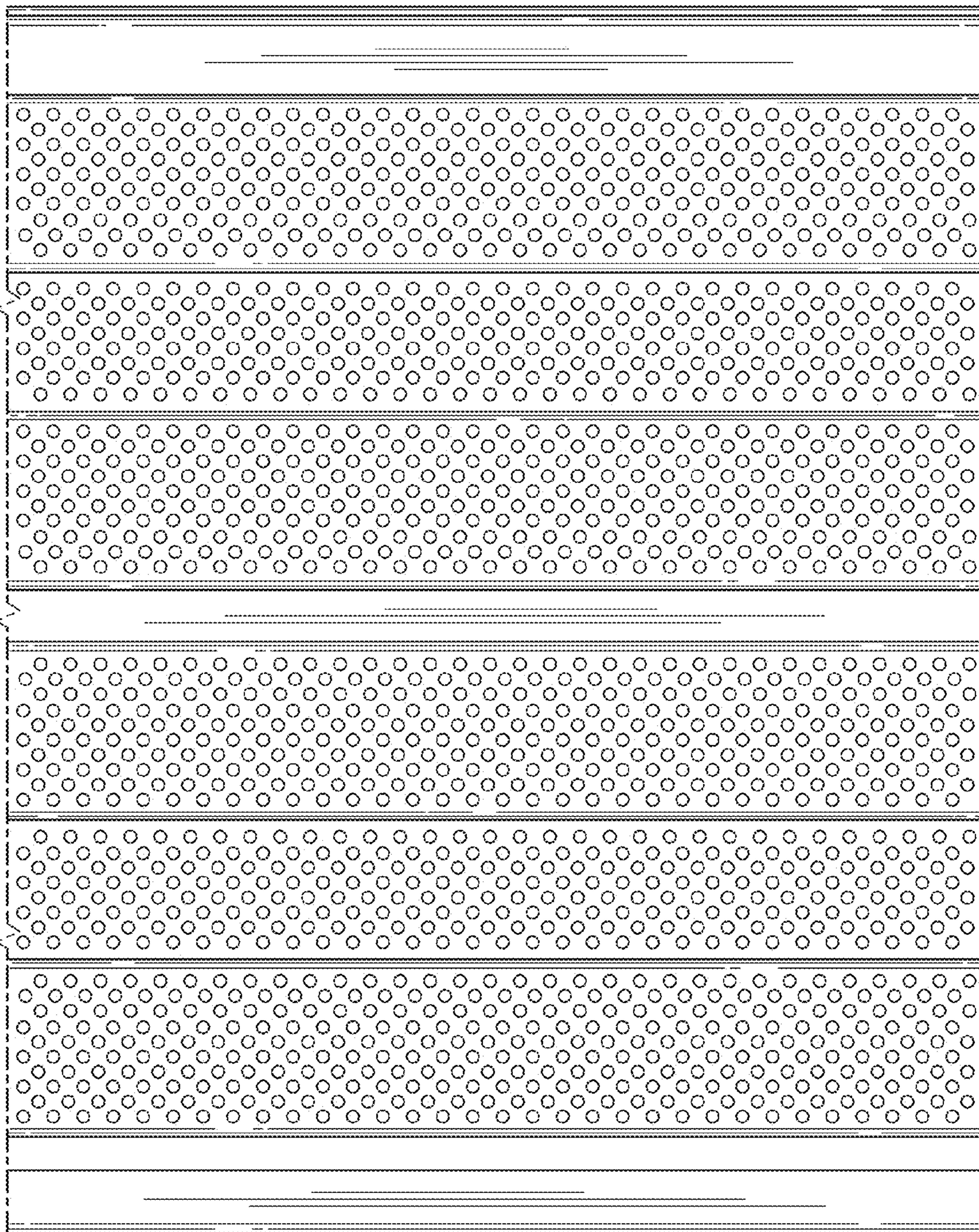

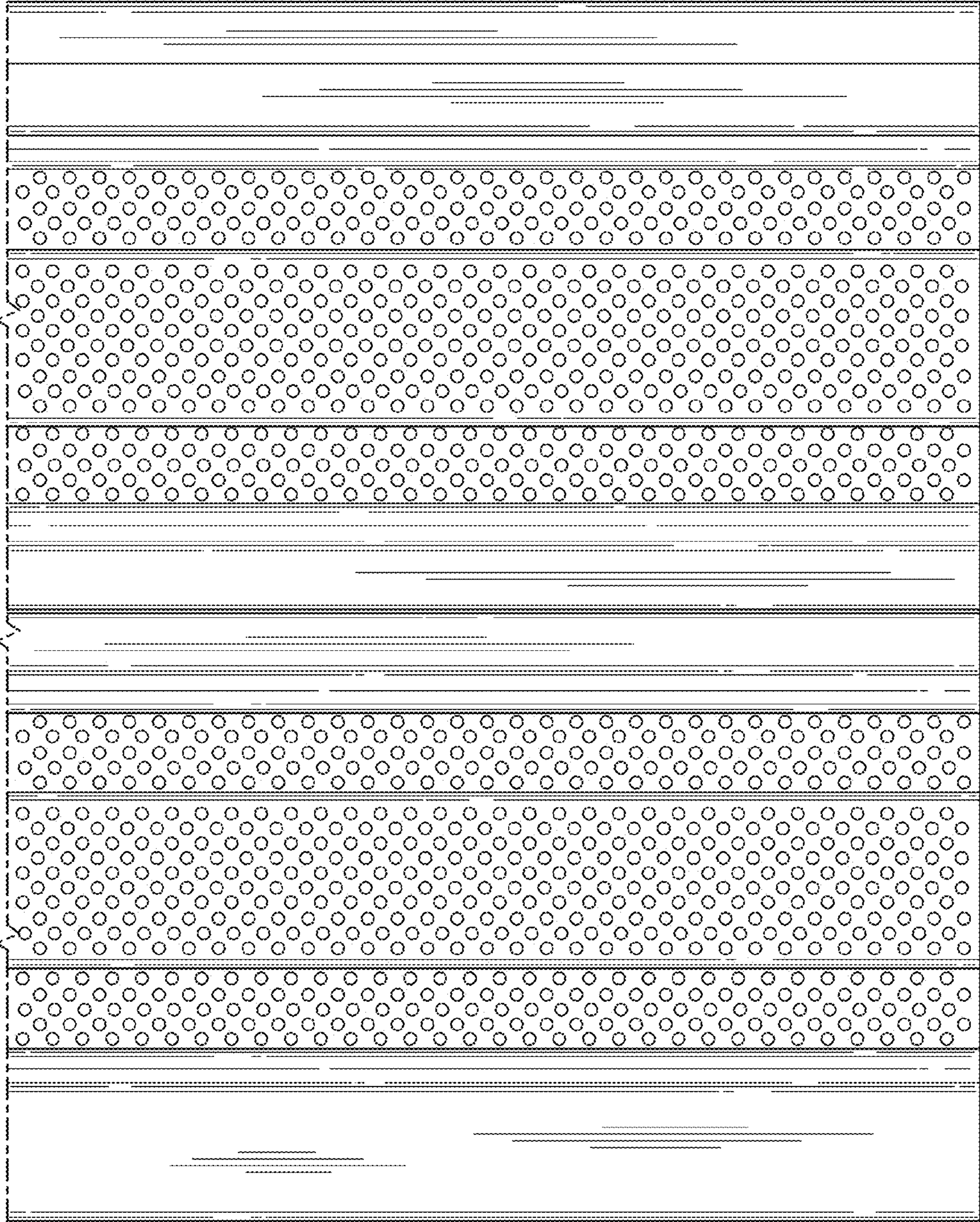

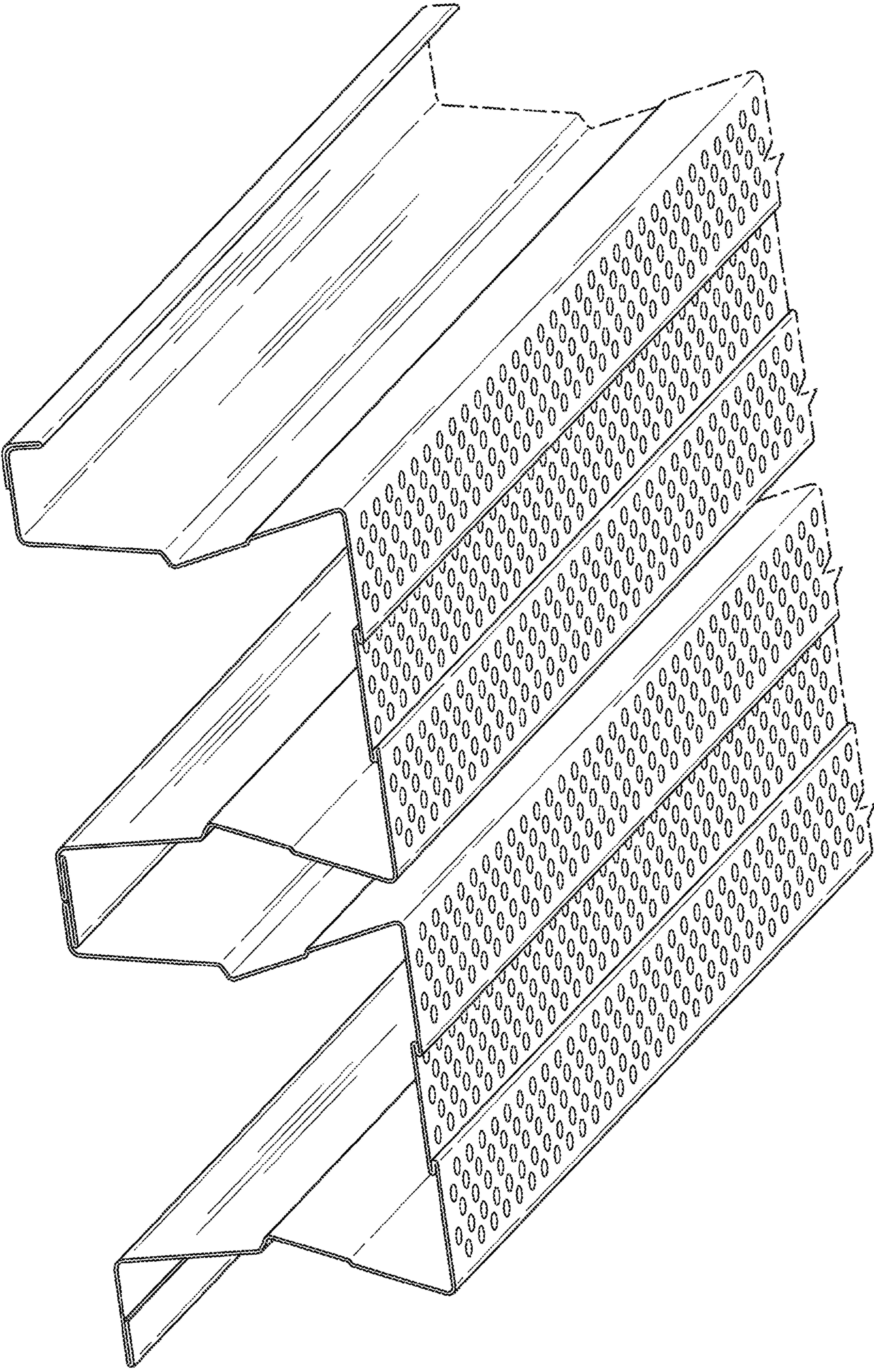

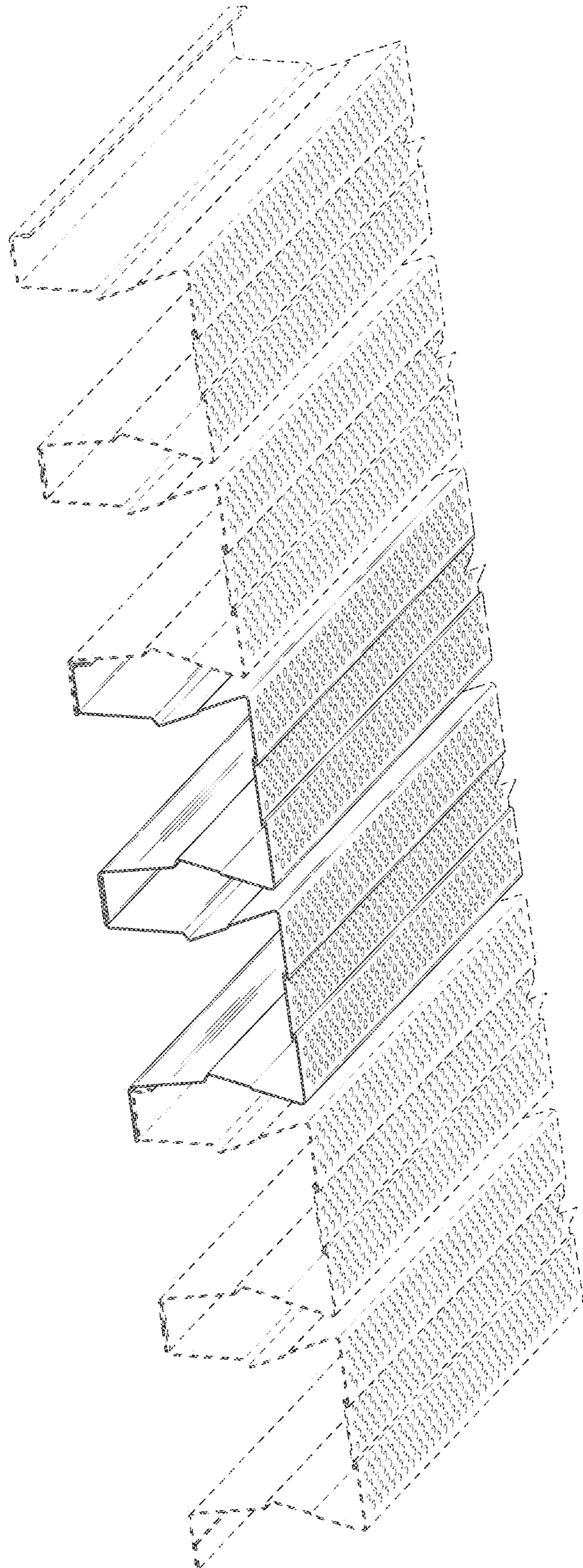
